FIG. 8 is a top, front, left side perspective view thereof, shown mounted in an automobile;

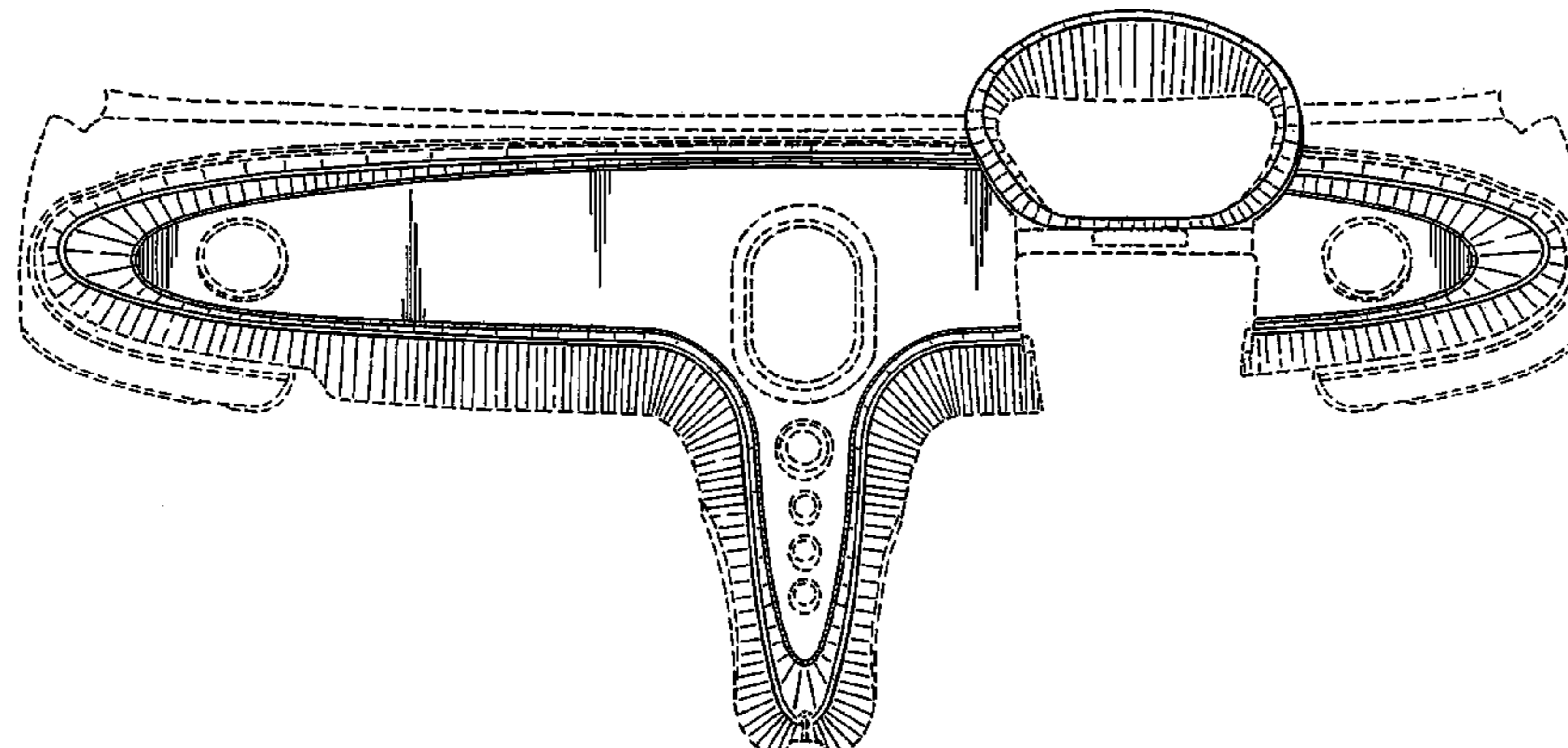
FIG. 9 is a top, front, right side perspective view thereof, shown mounted in an automobile; and,

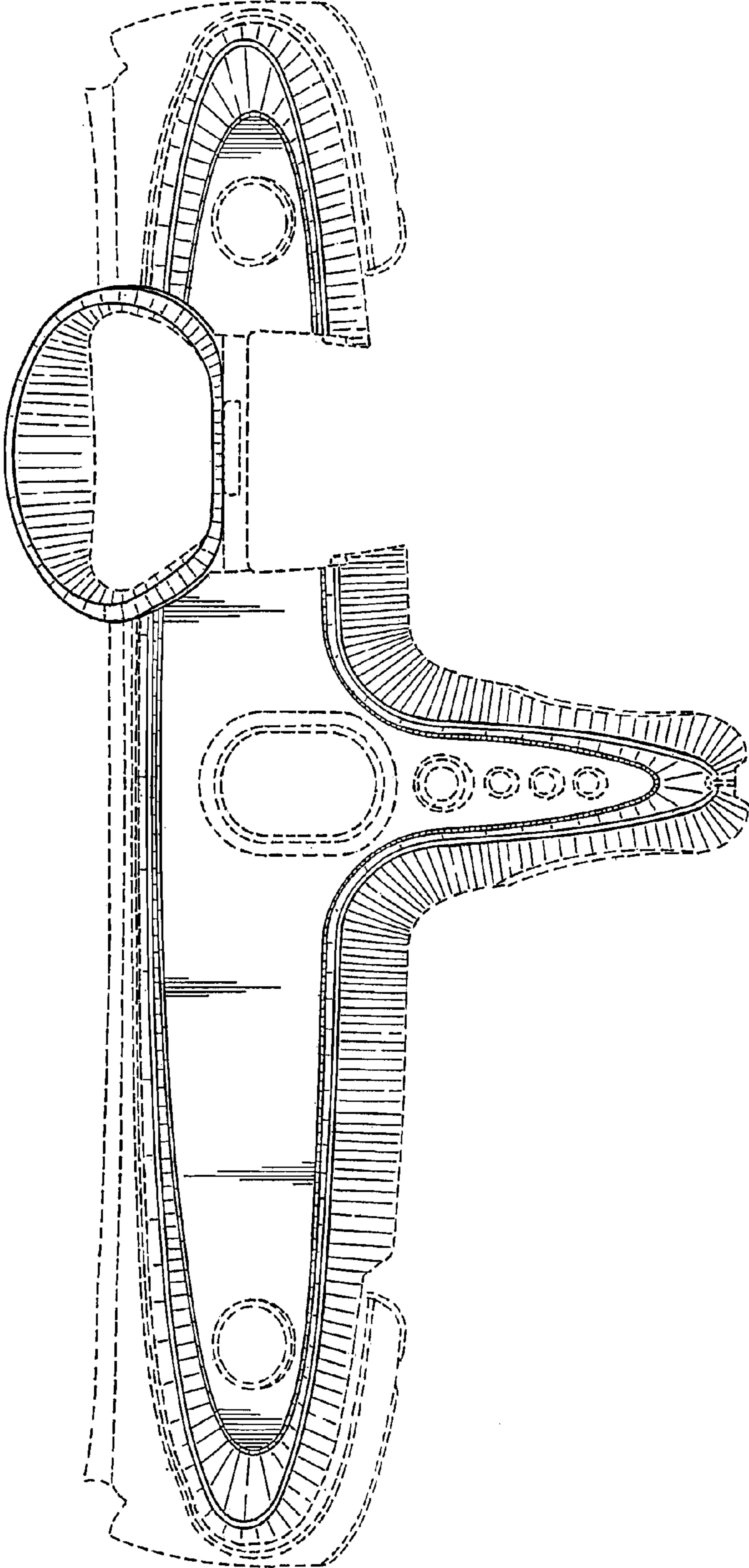

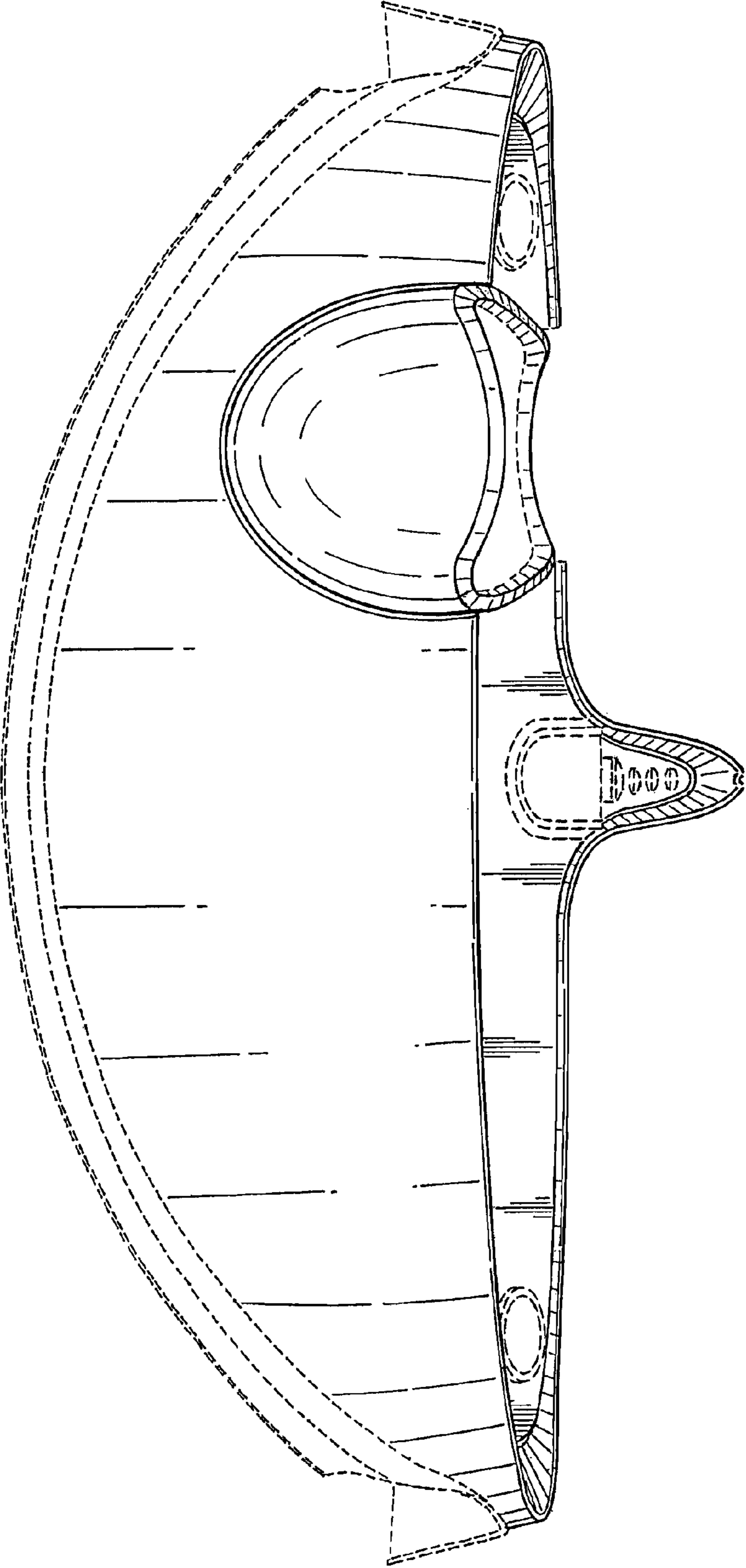
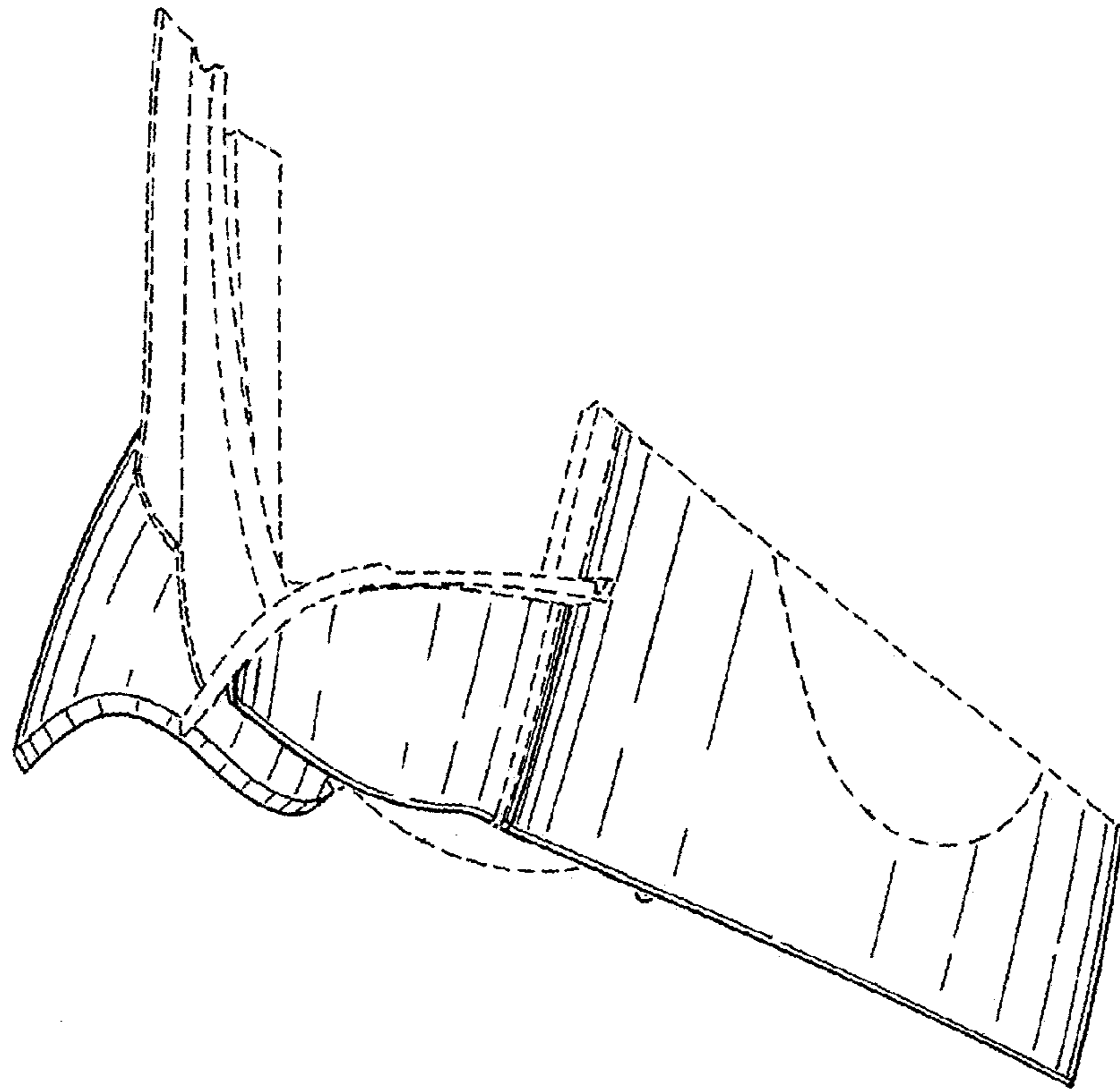
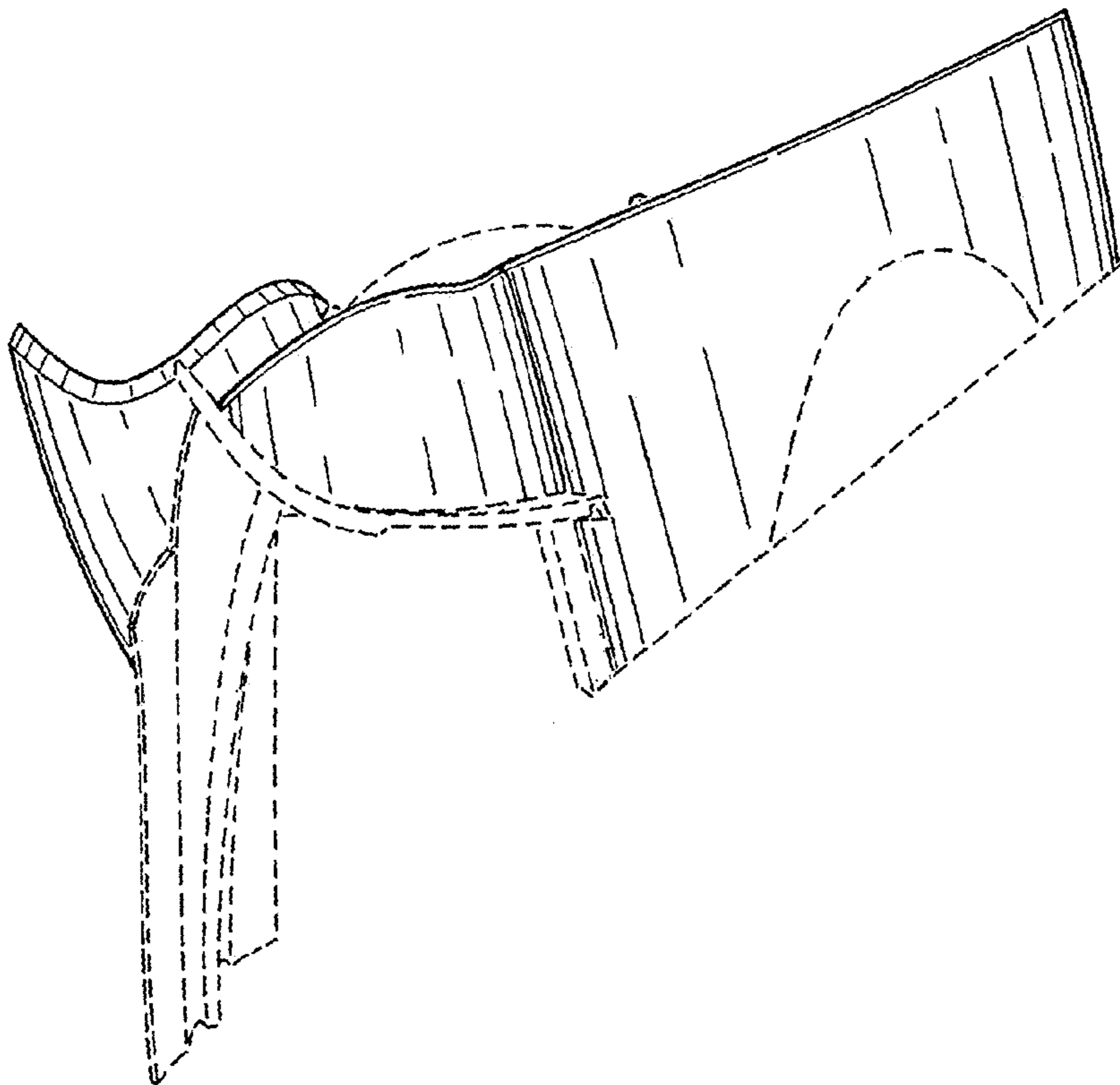

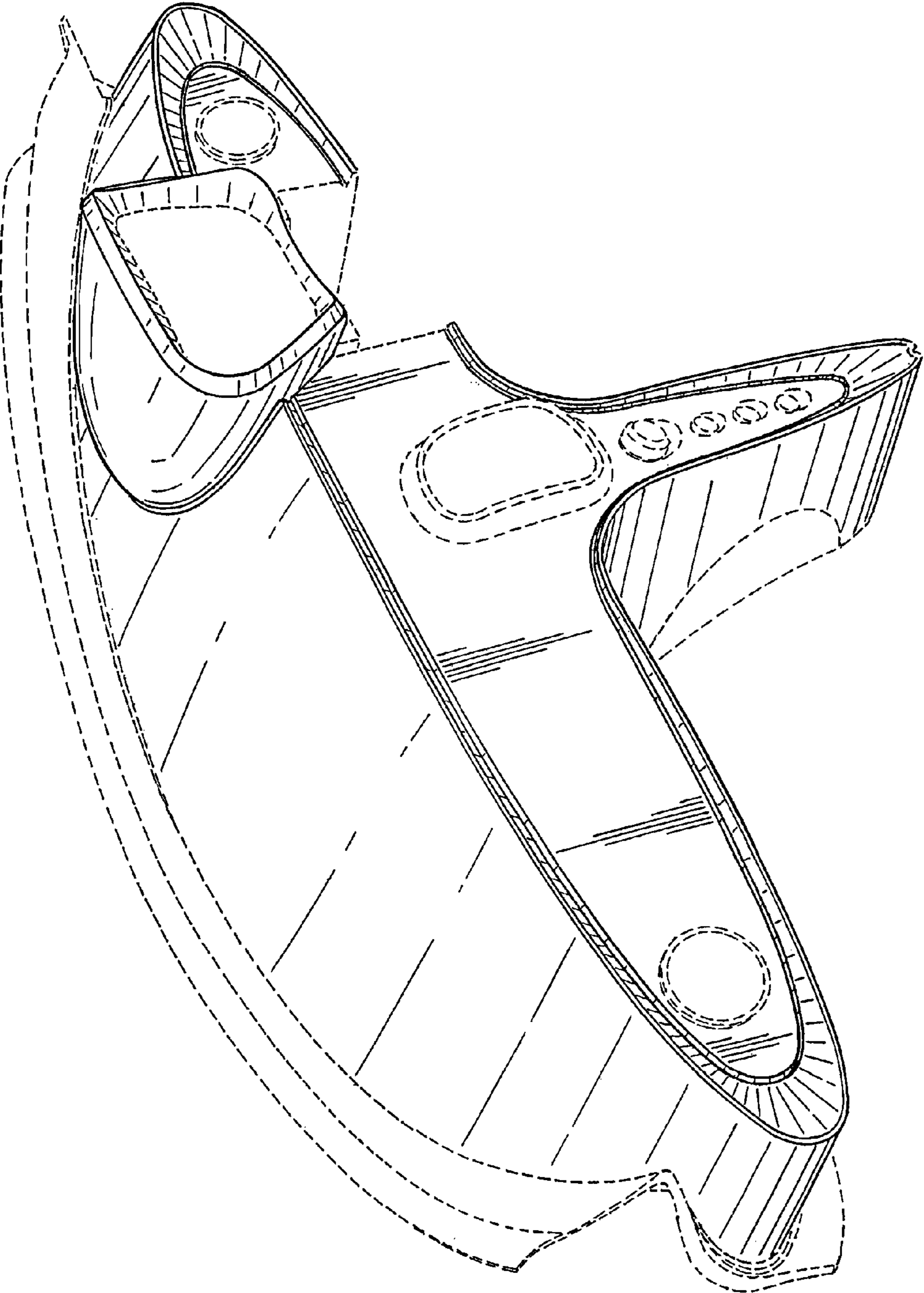

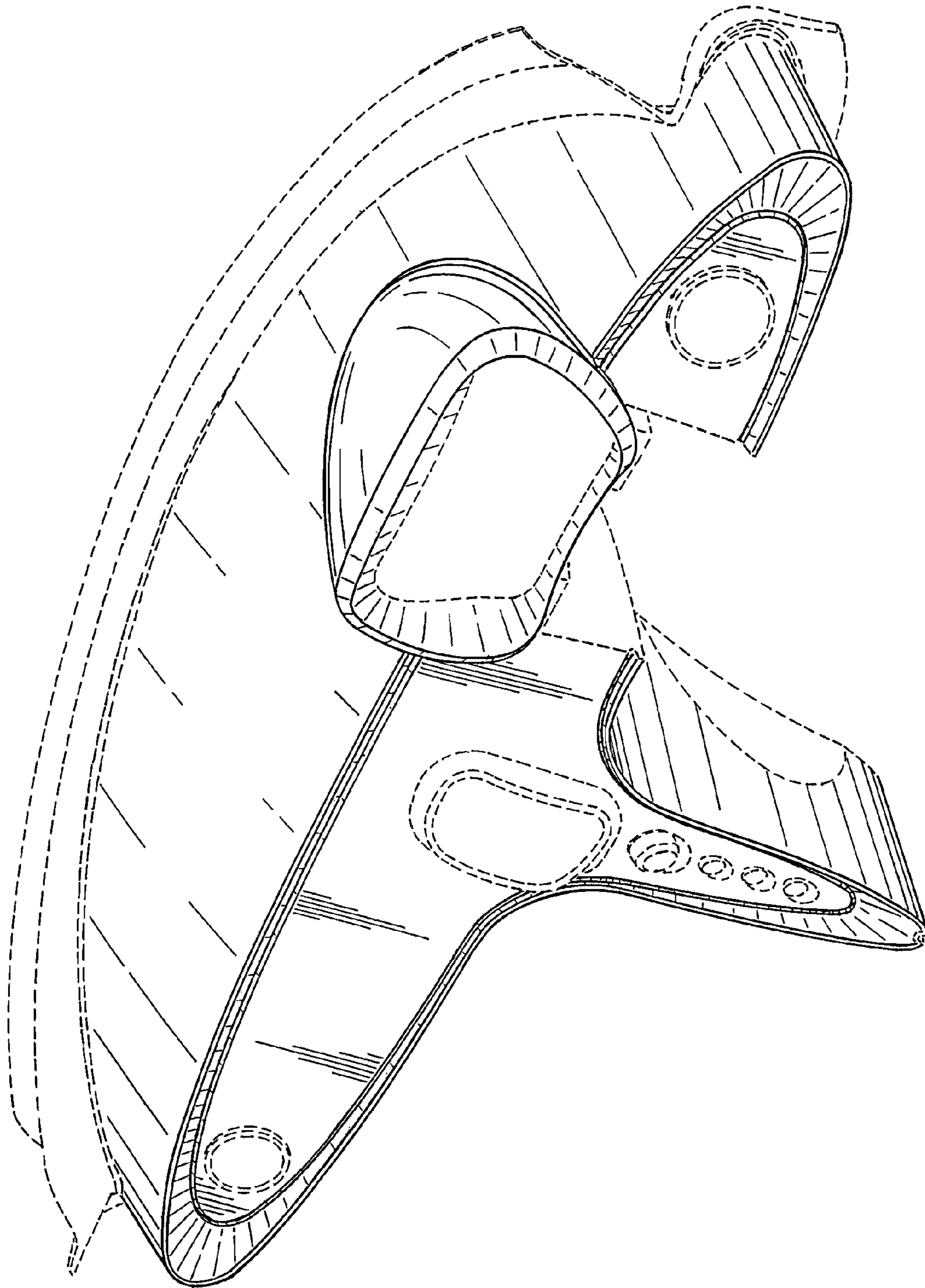
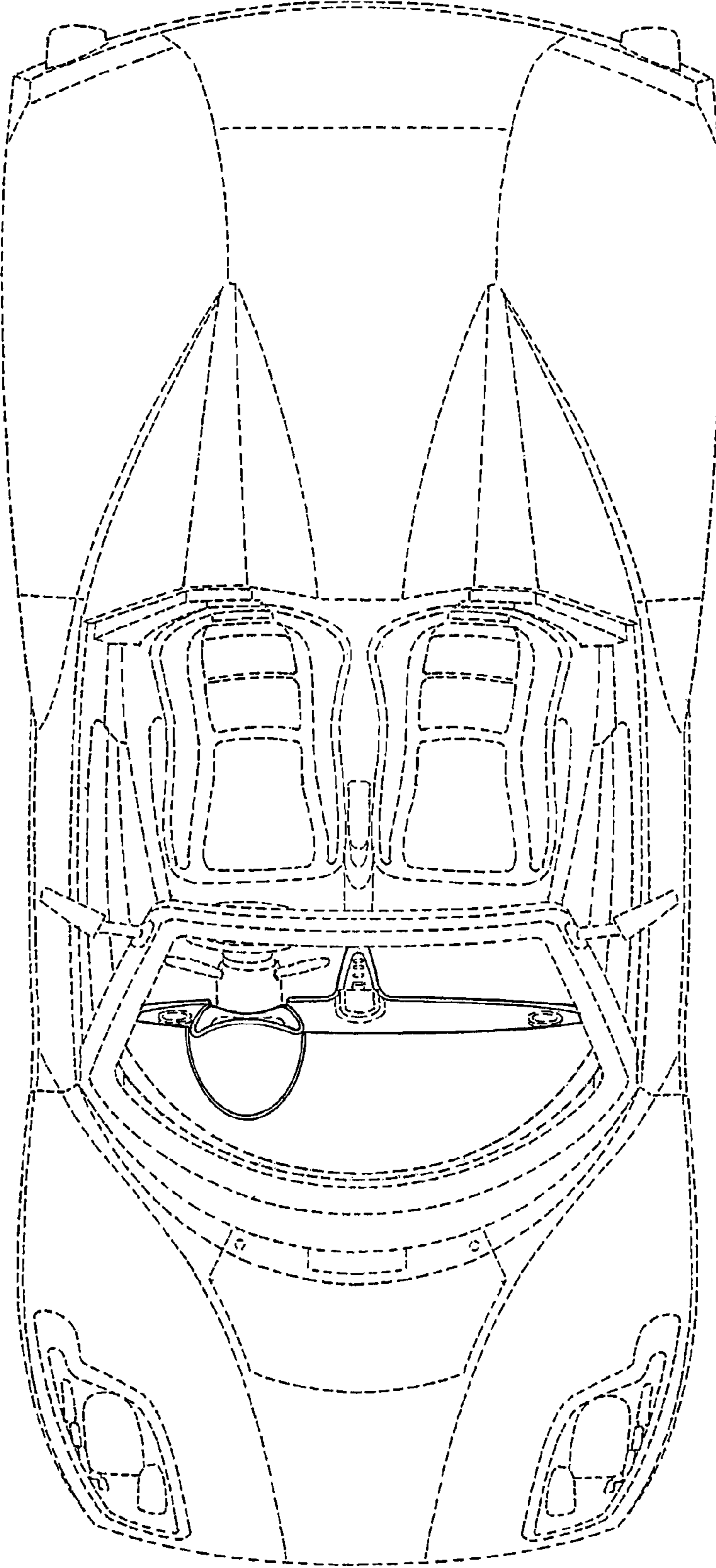
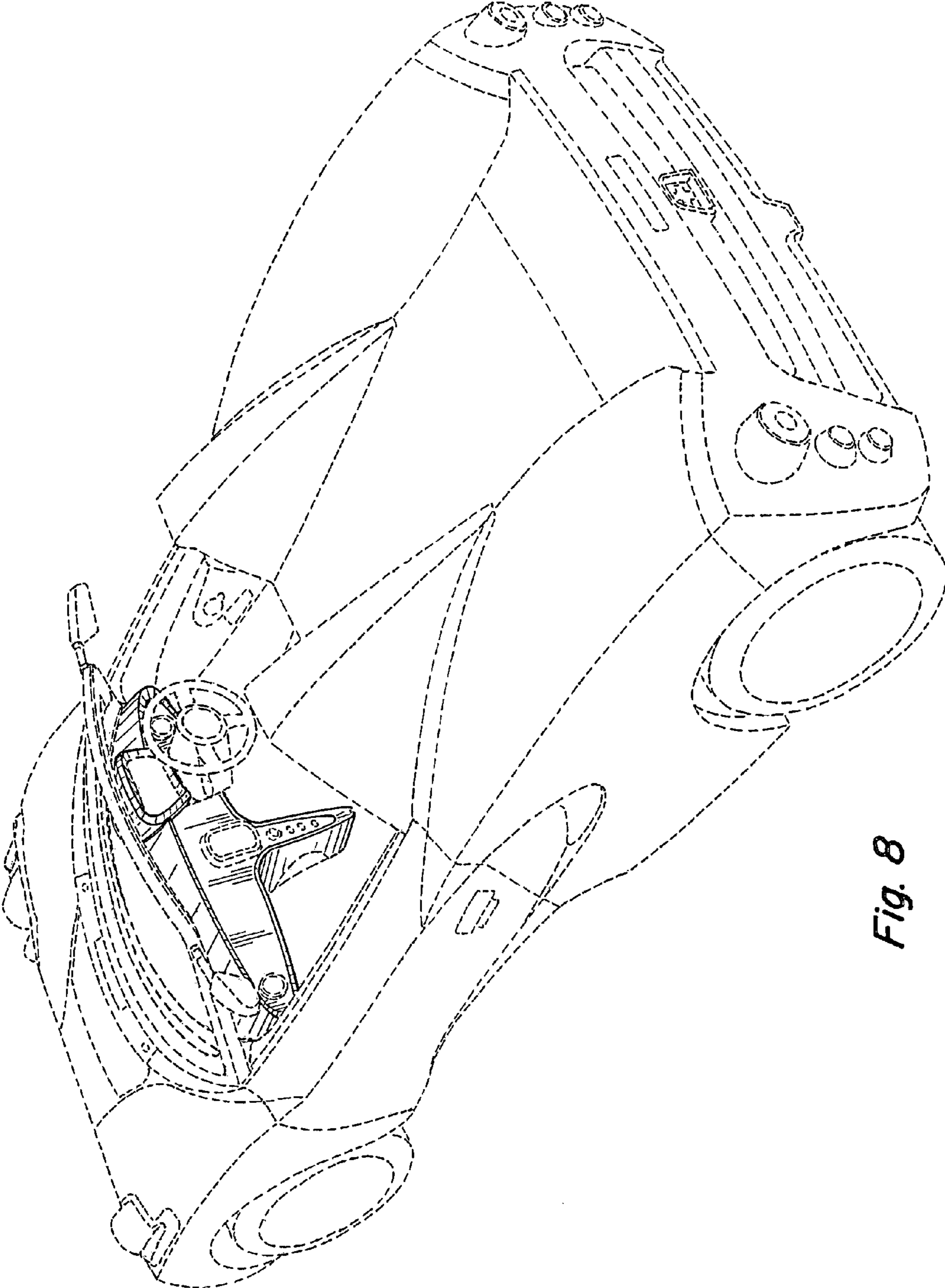

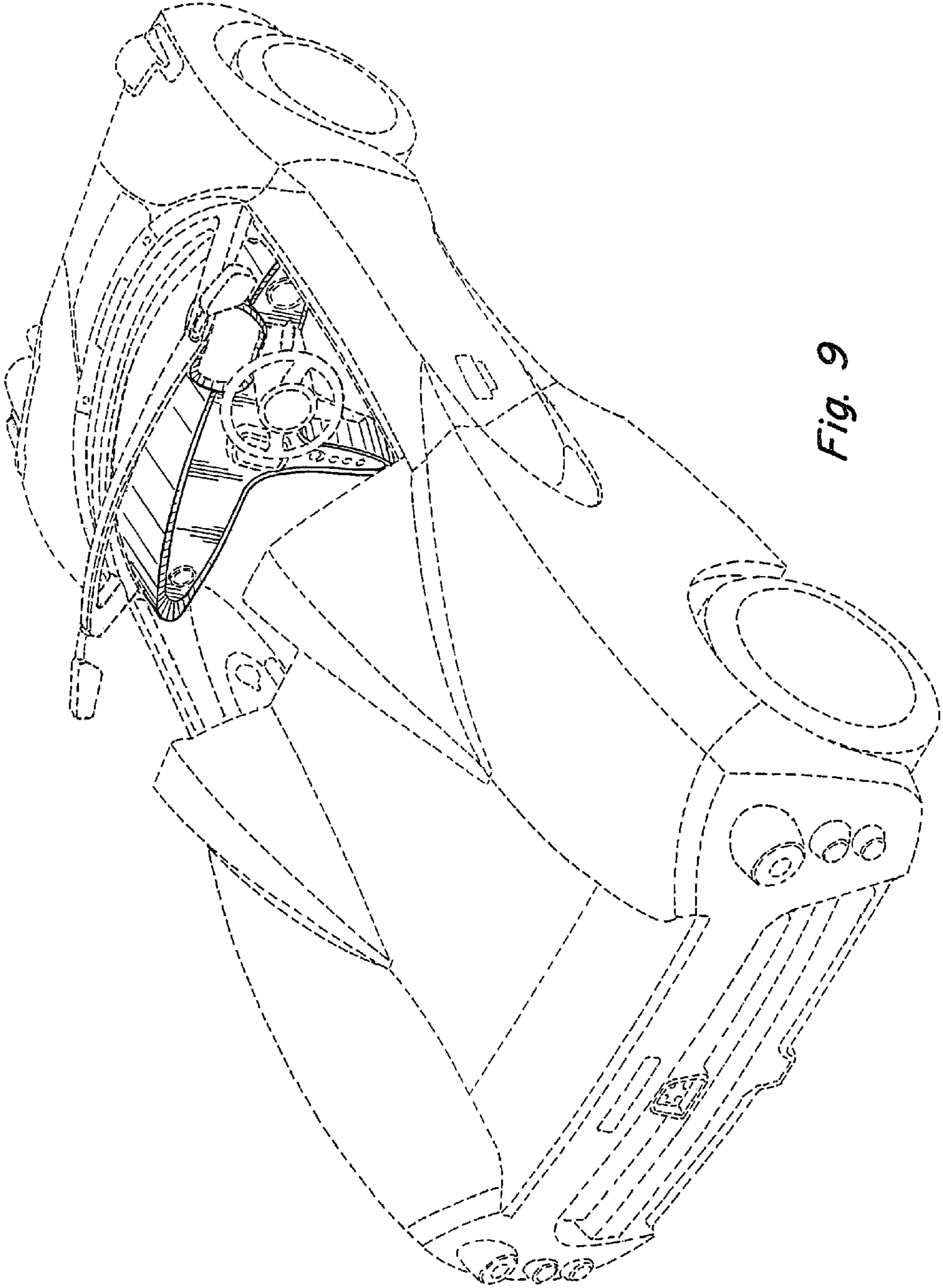
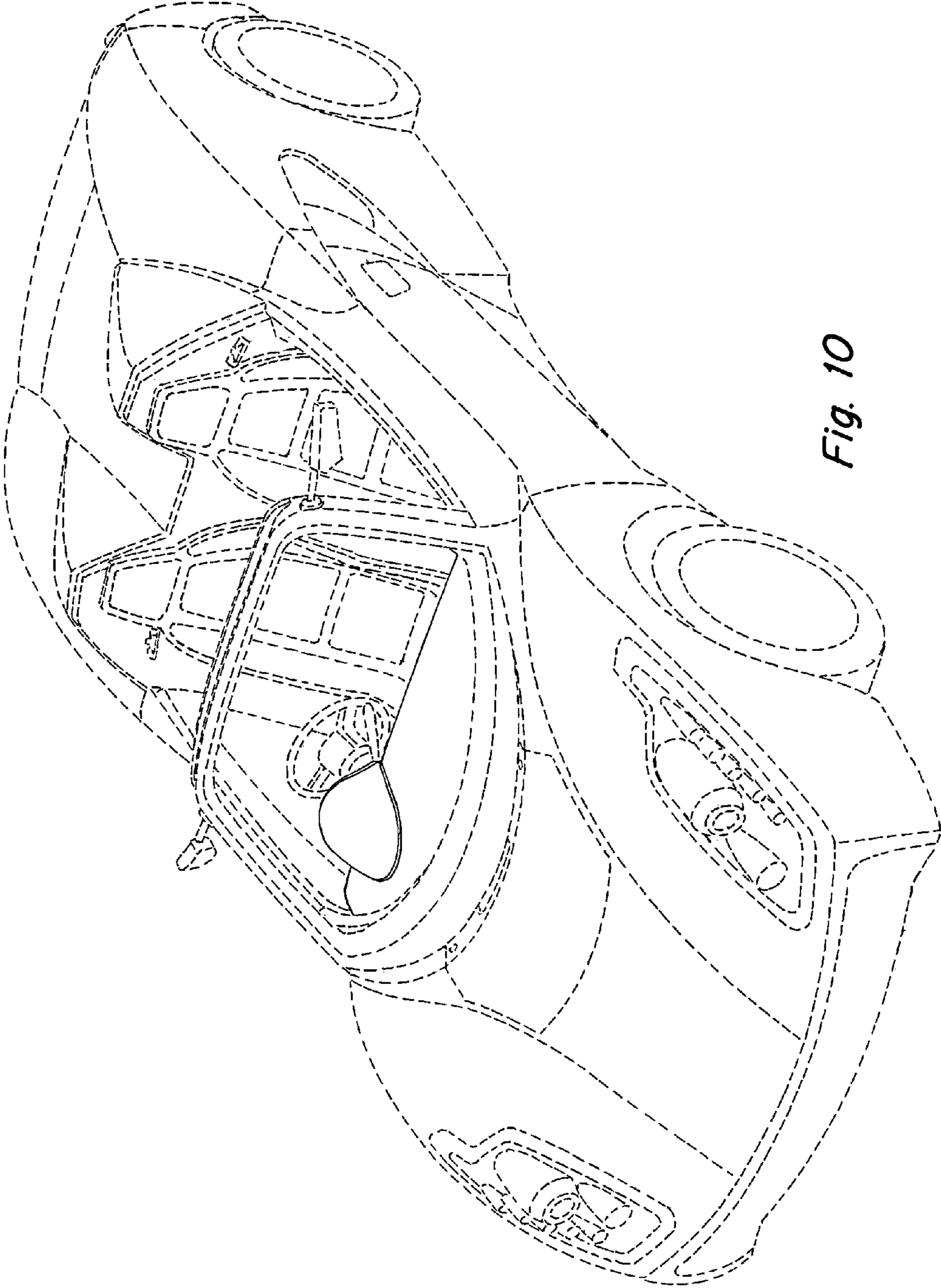
