DESCRIPTION

FIG. 1 is a perspective view of front and right side of an automobile tire showing my new design;

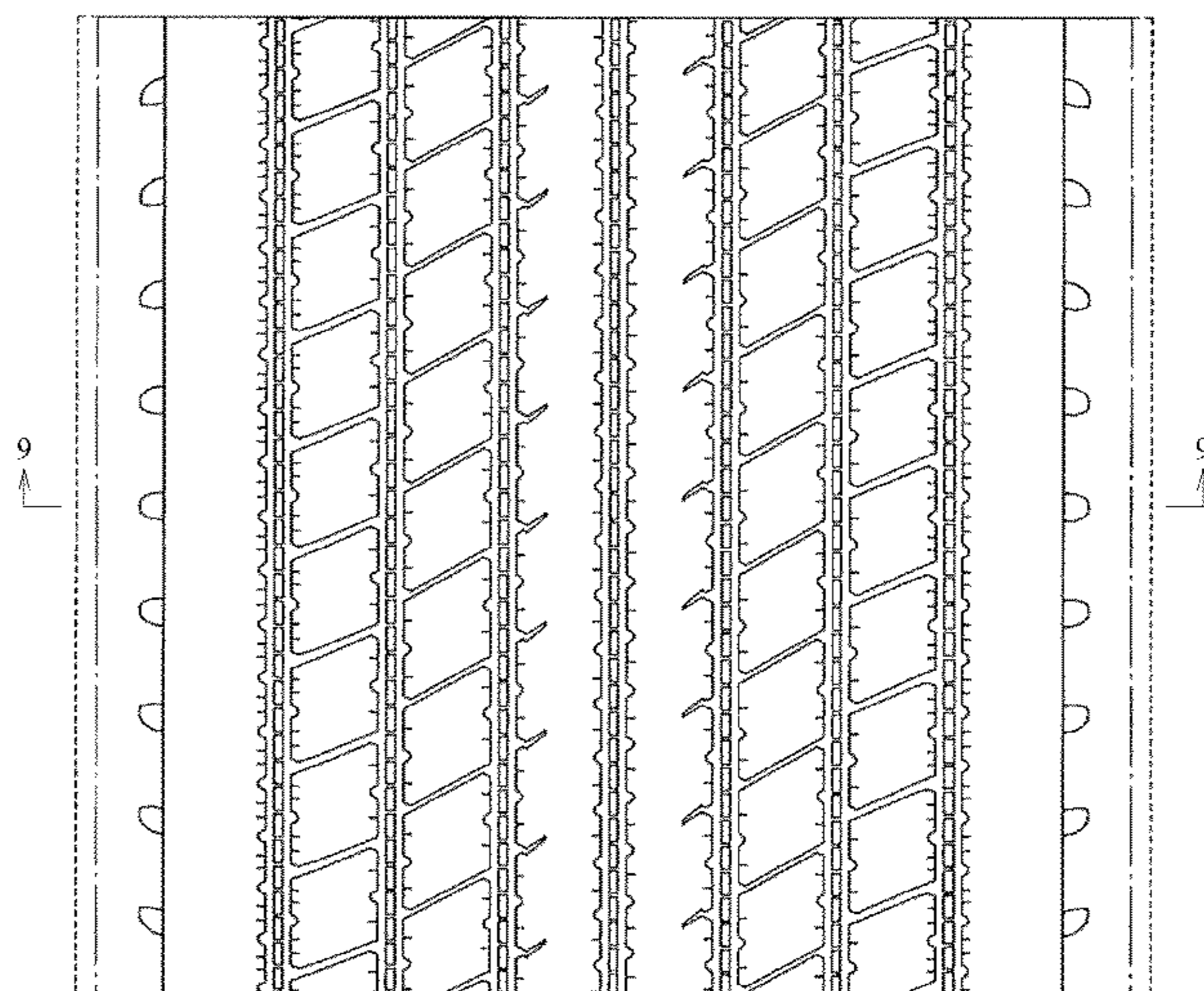
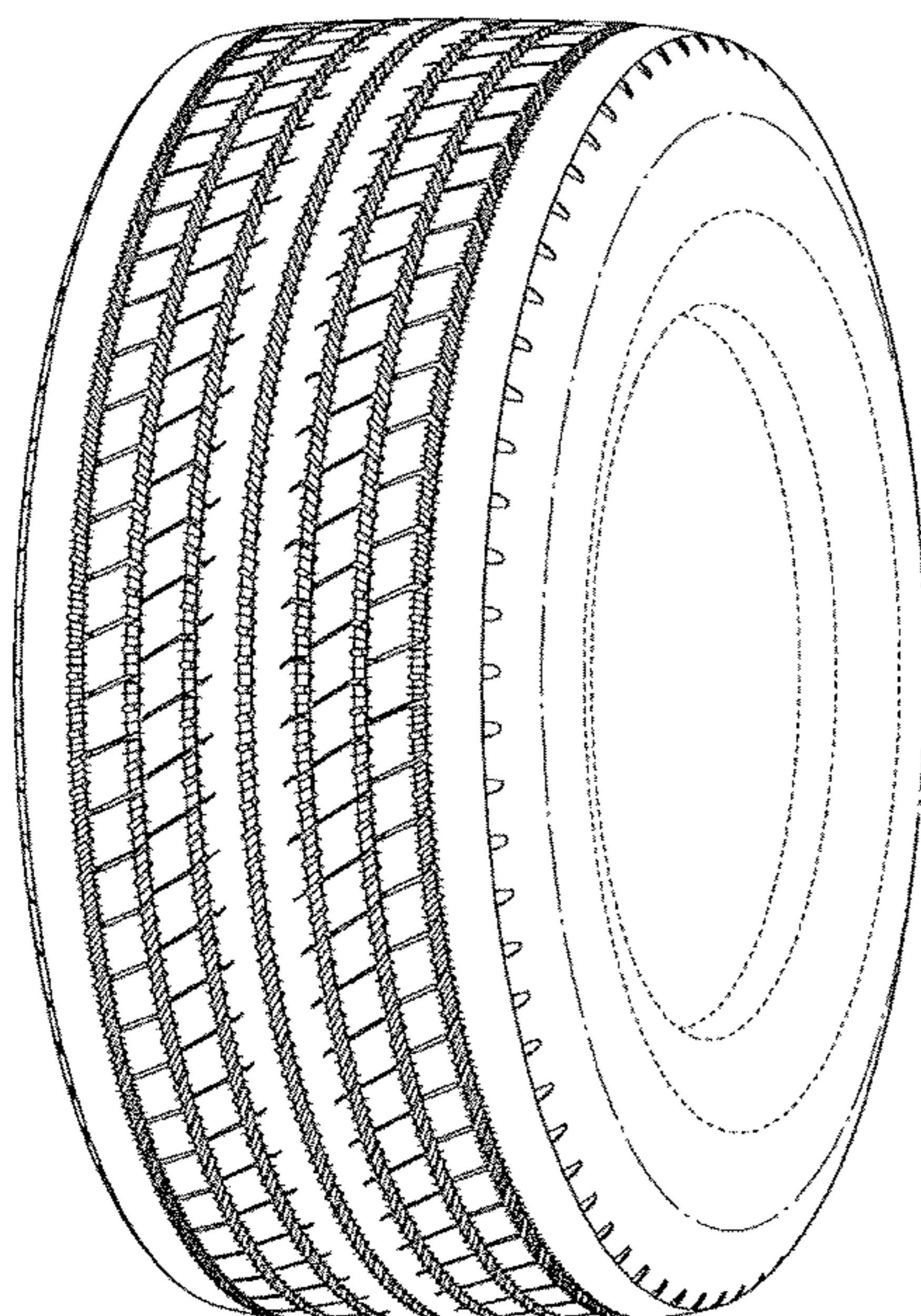

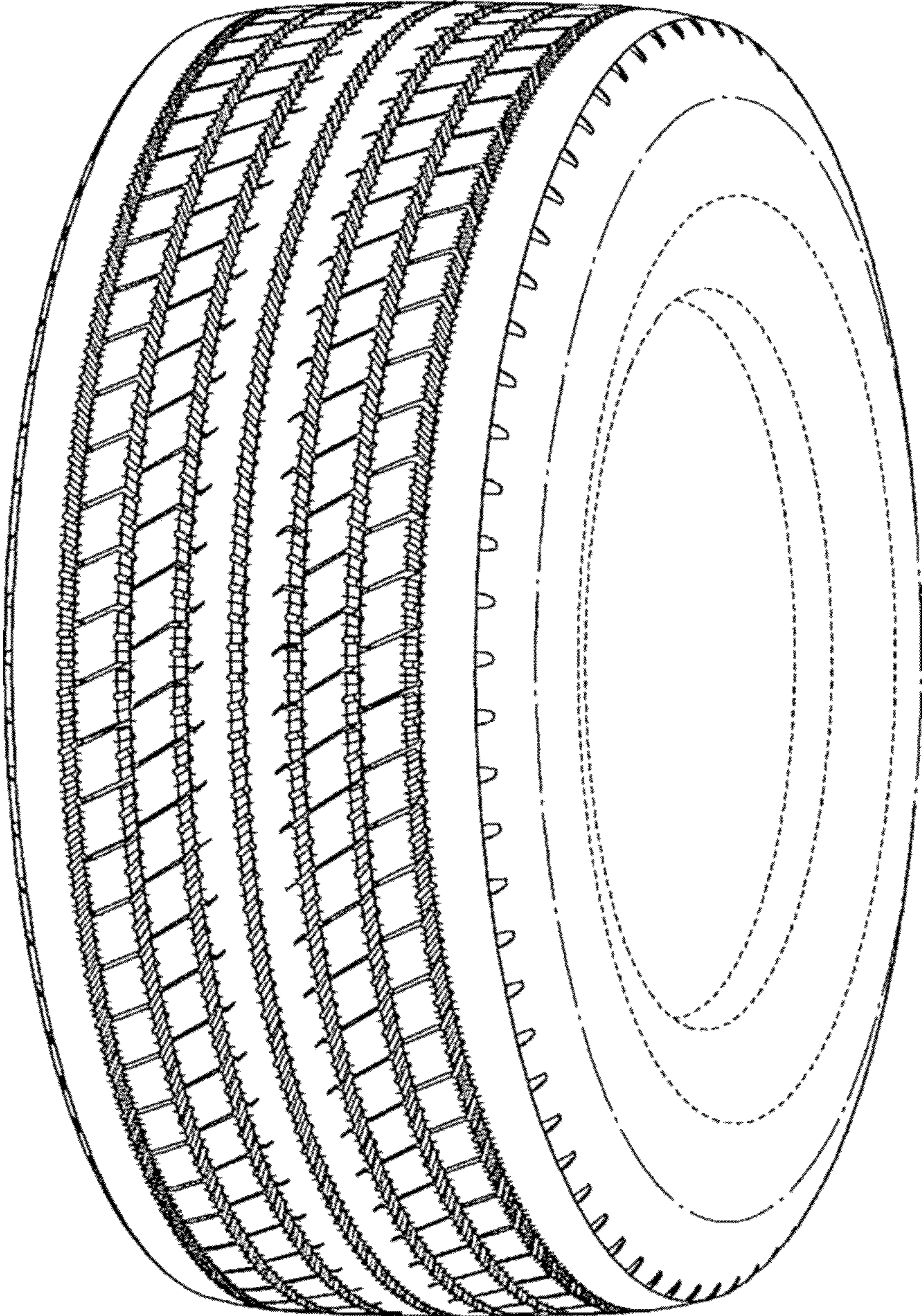

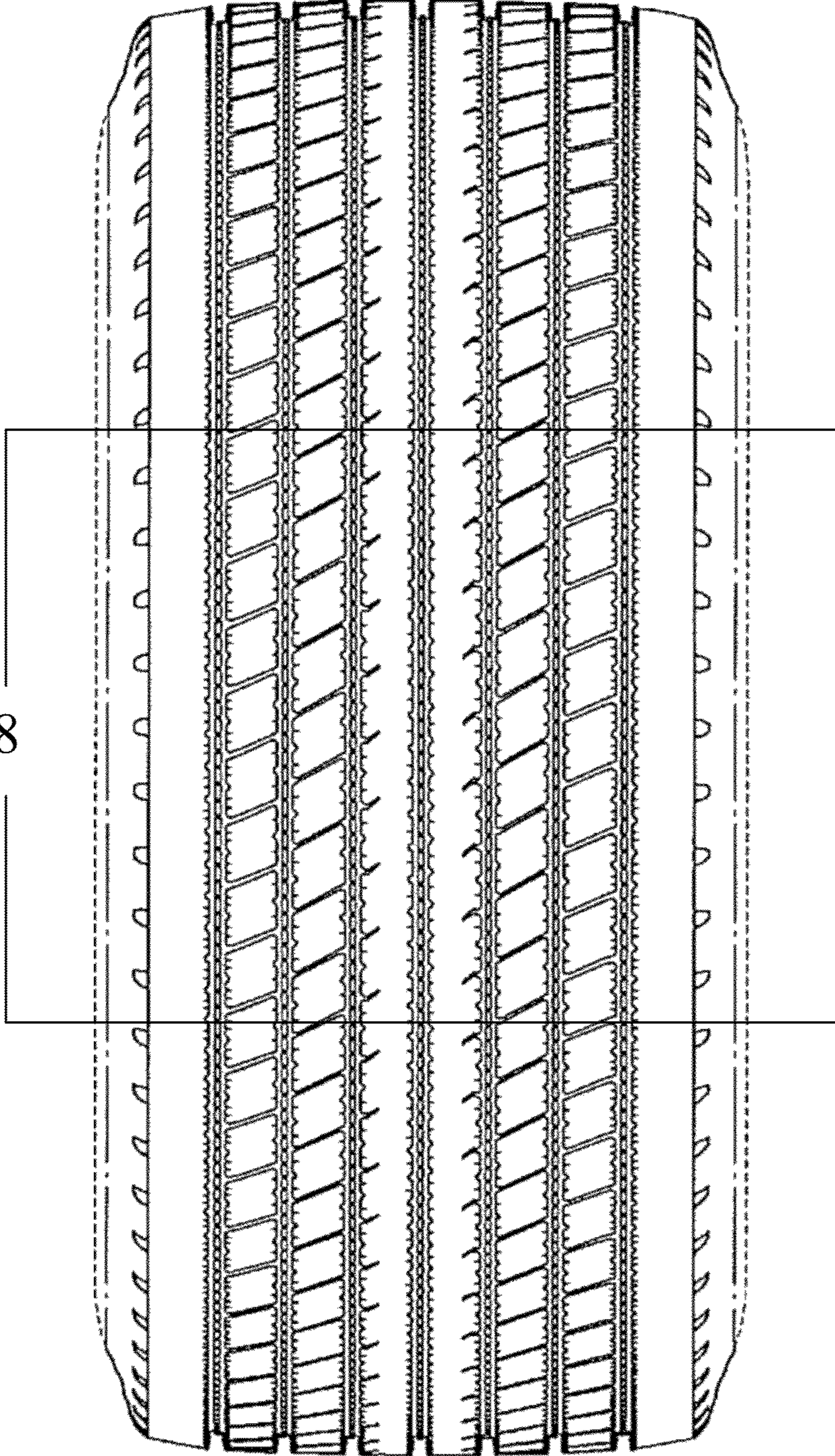

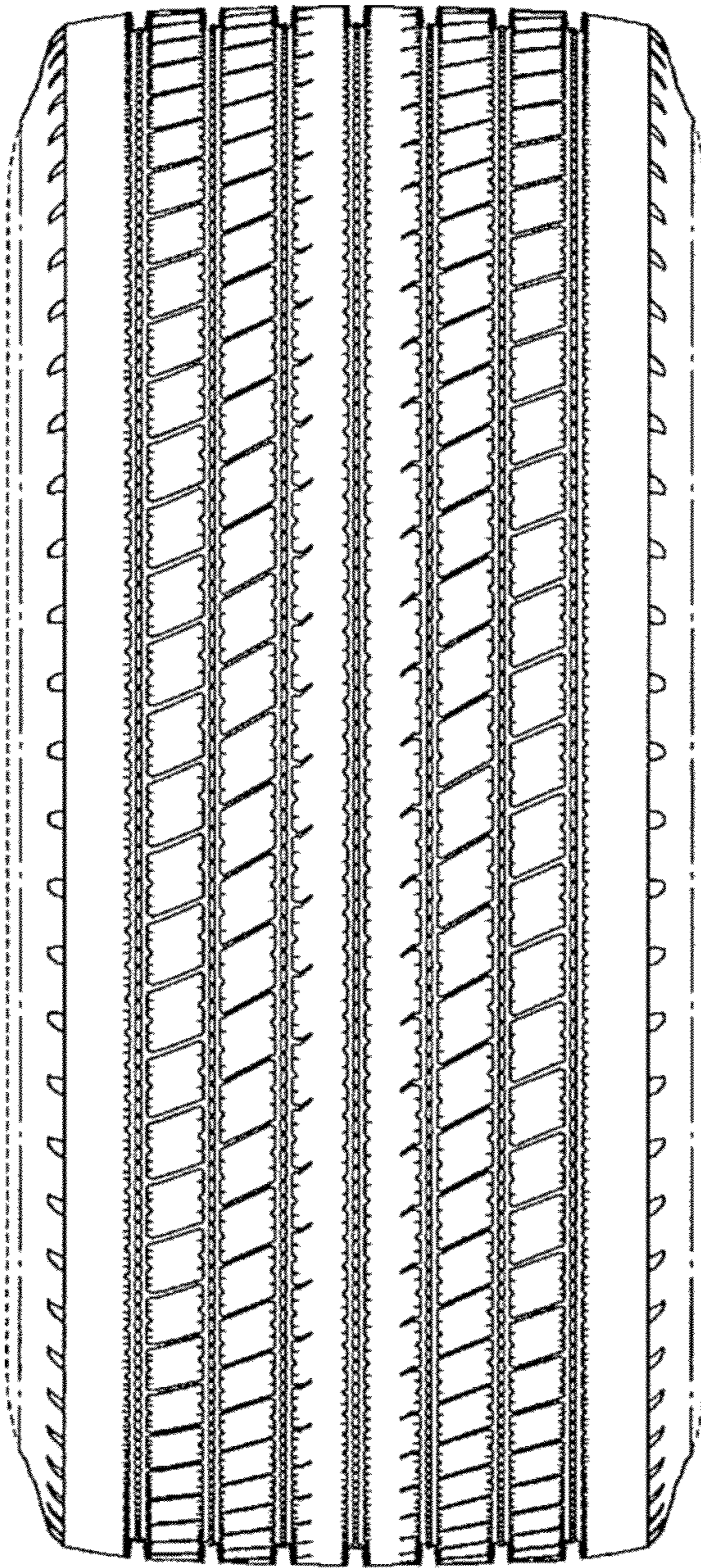

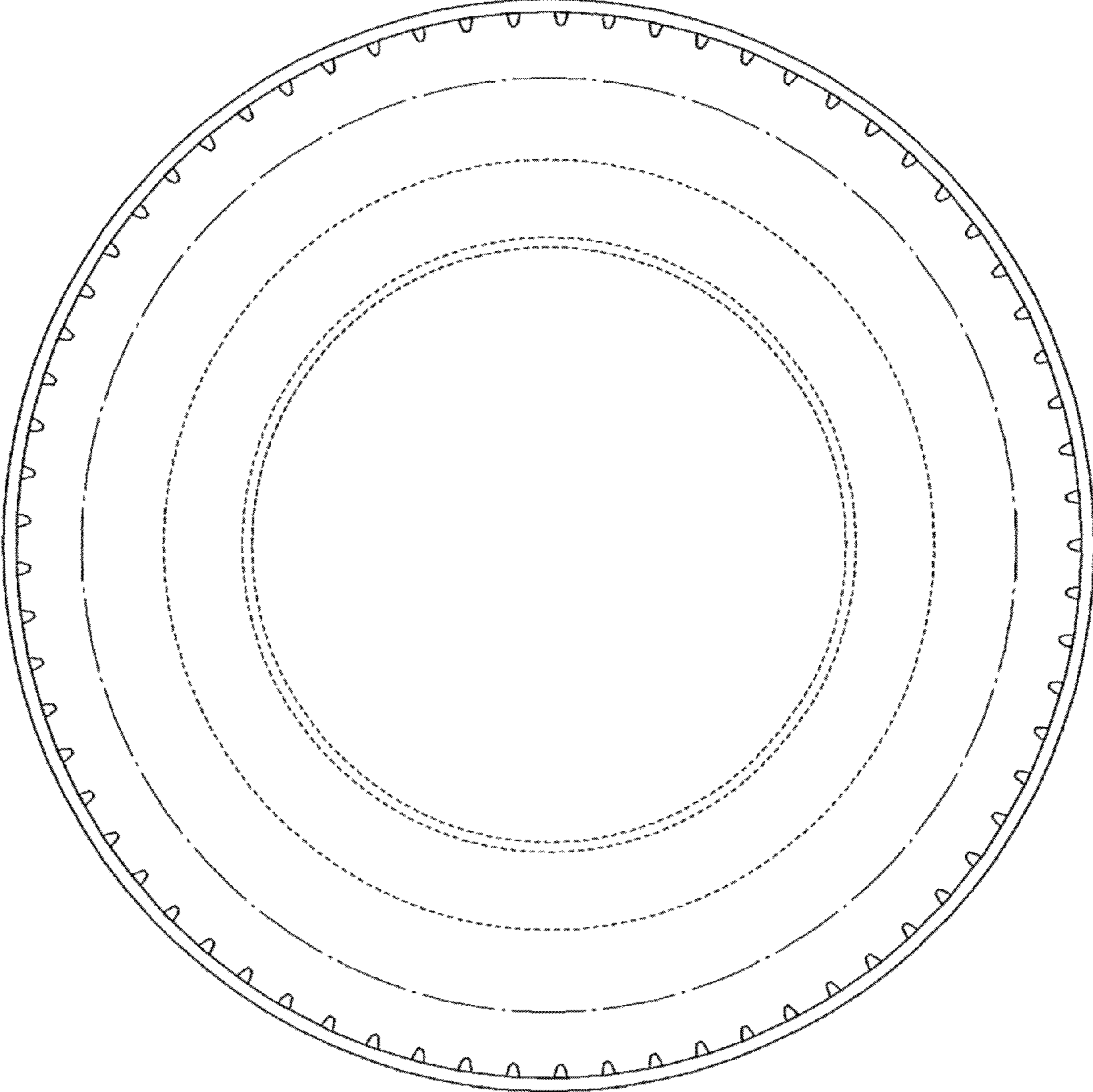

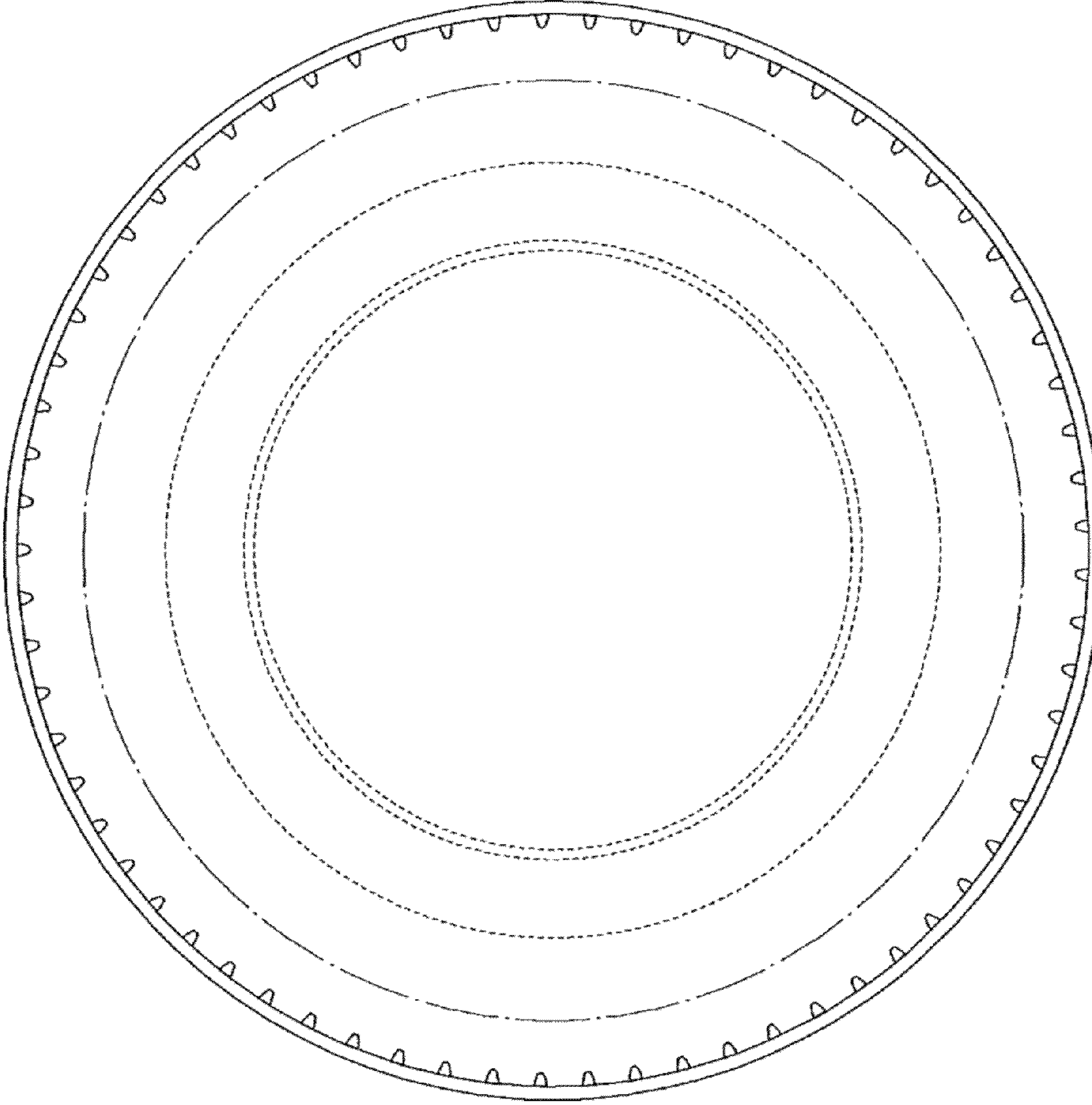

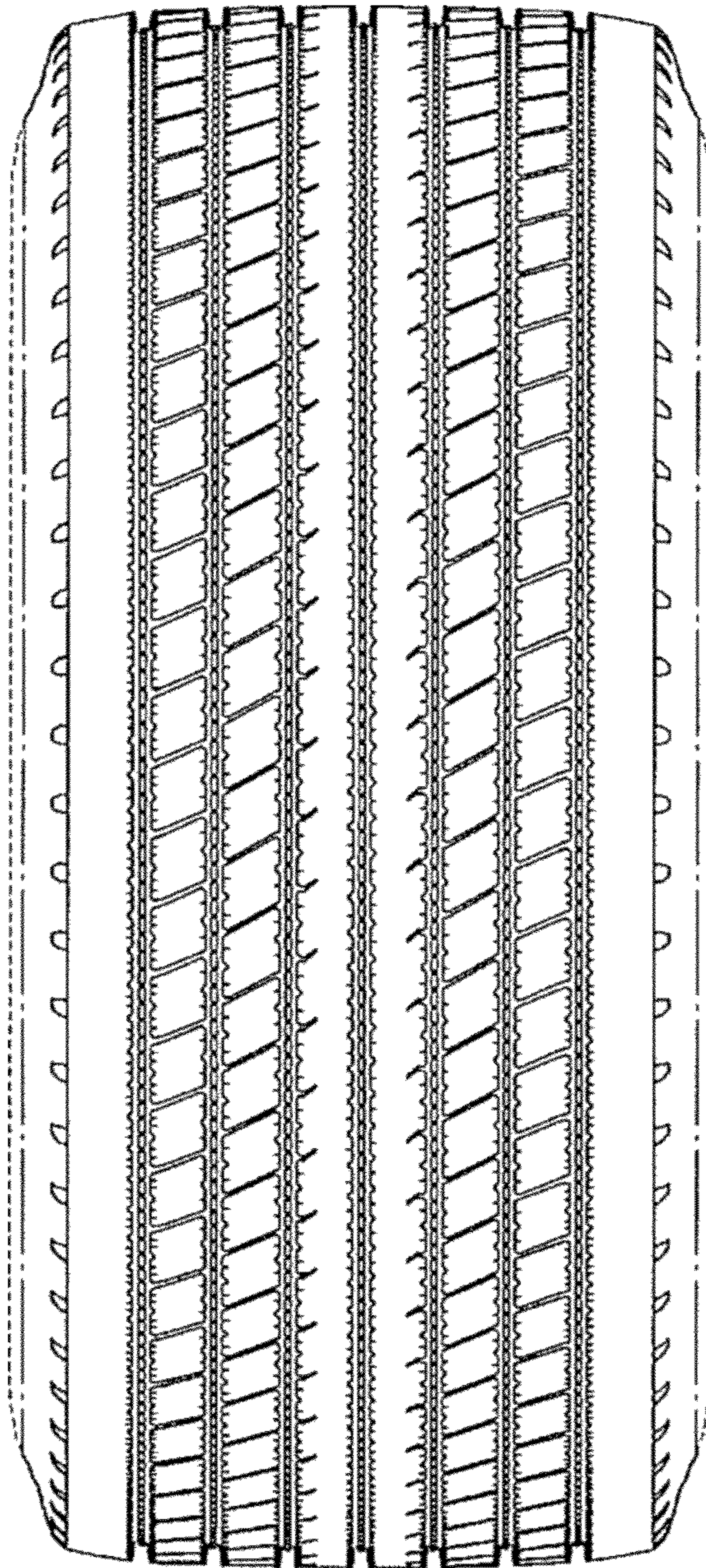

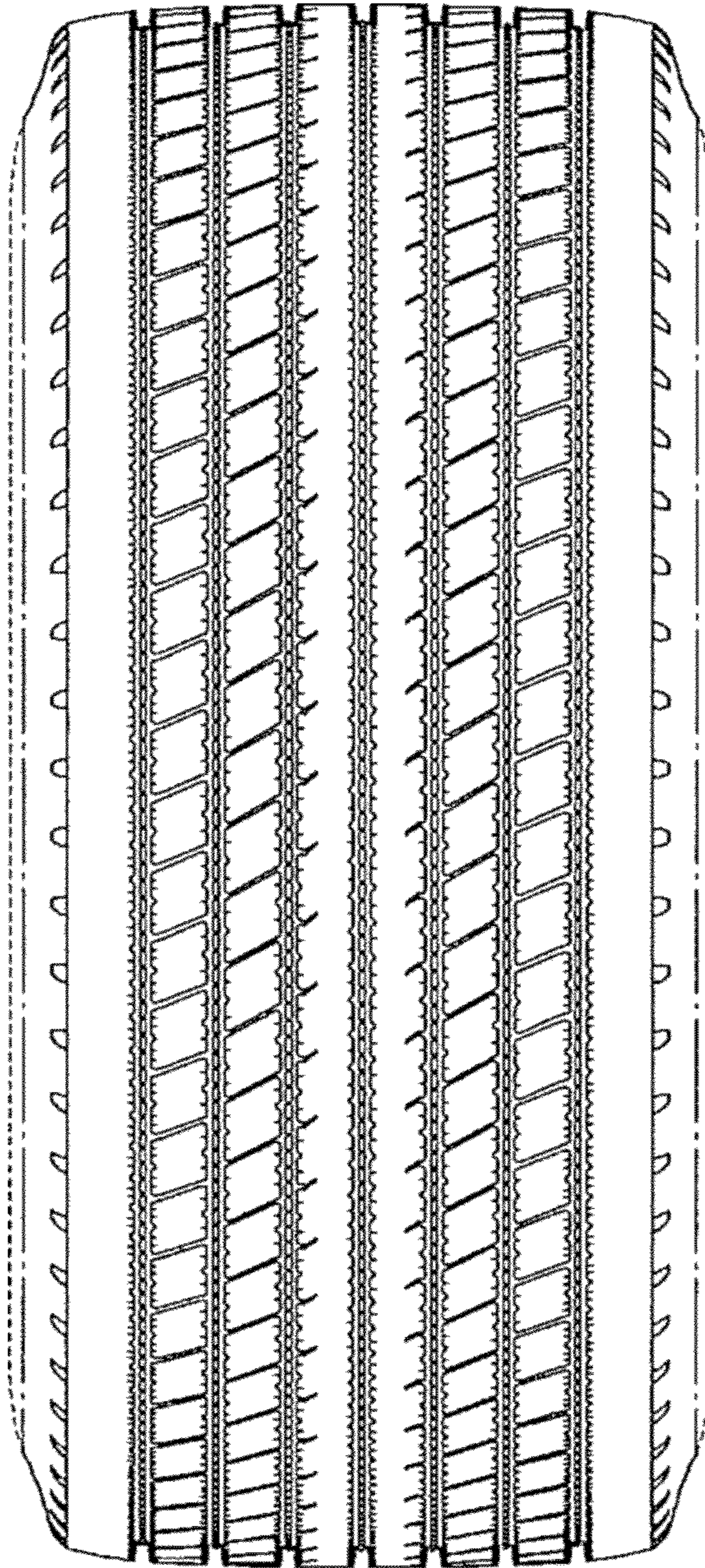

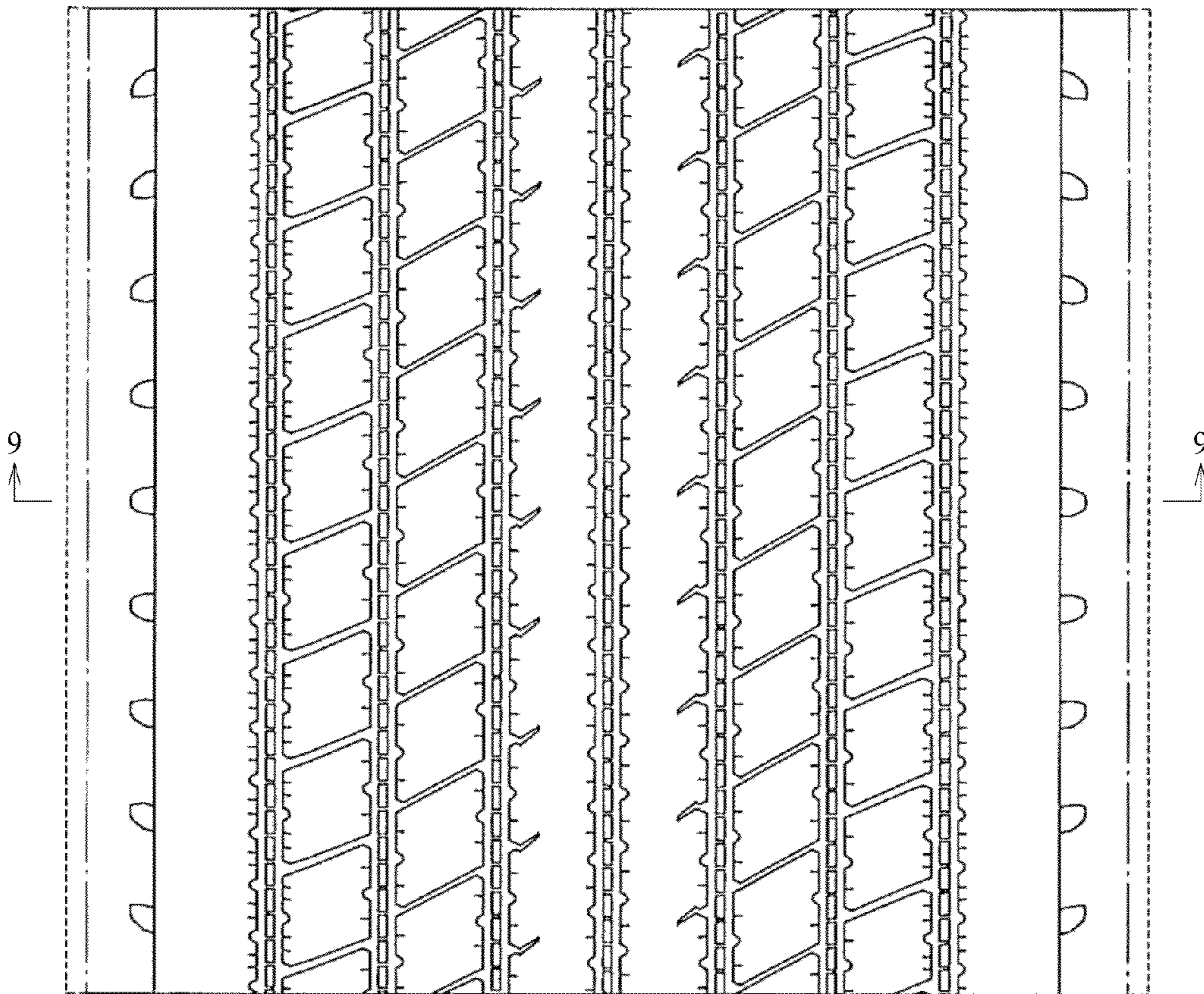
