FIG. 7 is an additional bottom view of the organizer of FIG. 1.

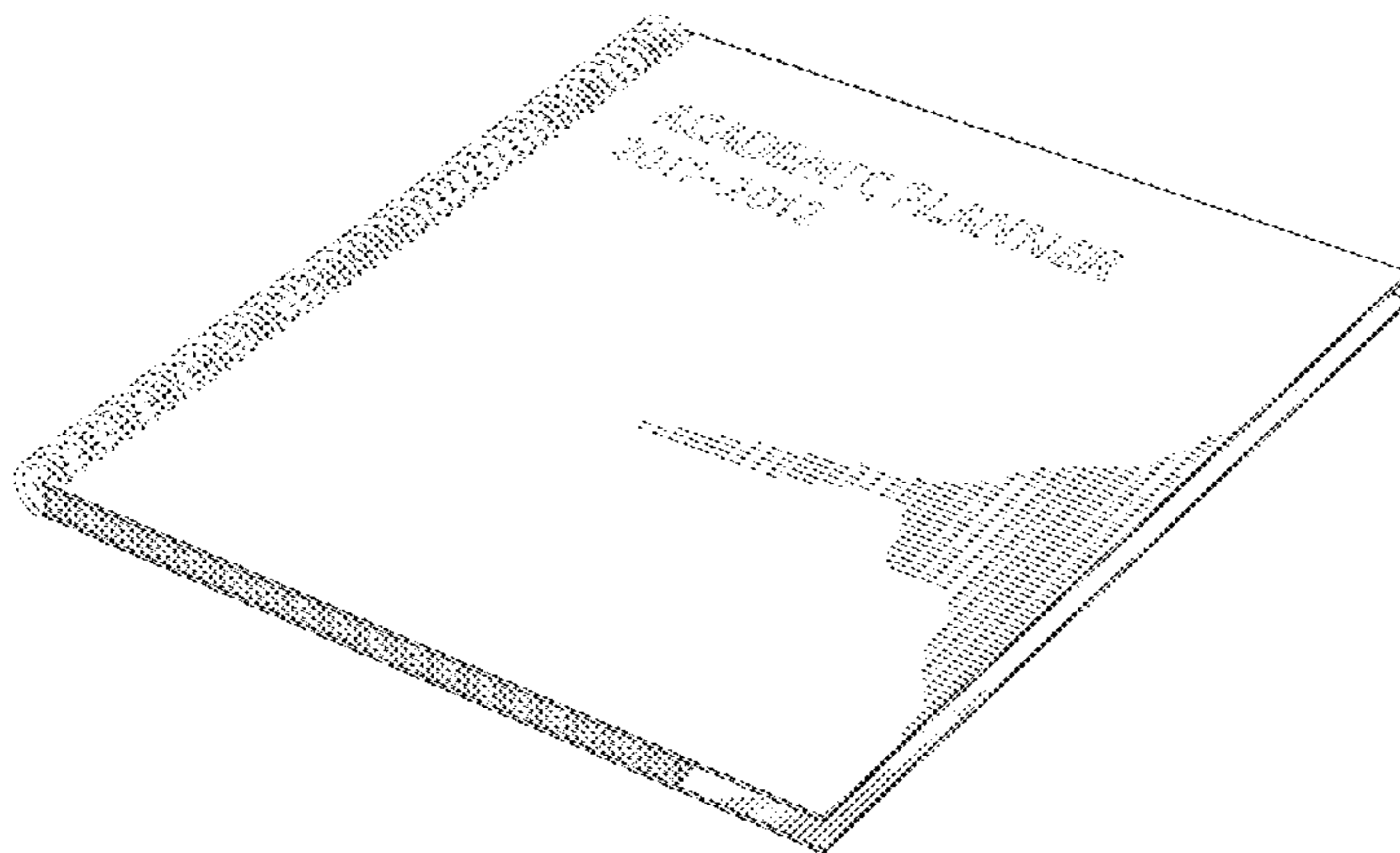
FIG. 8 is a front view of the organizer of FIG. 1 in an open position.

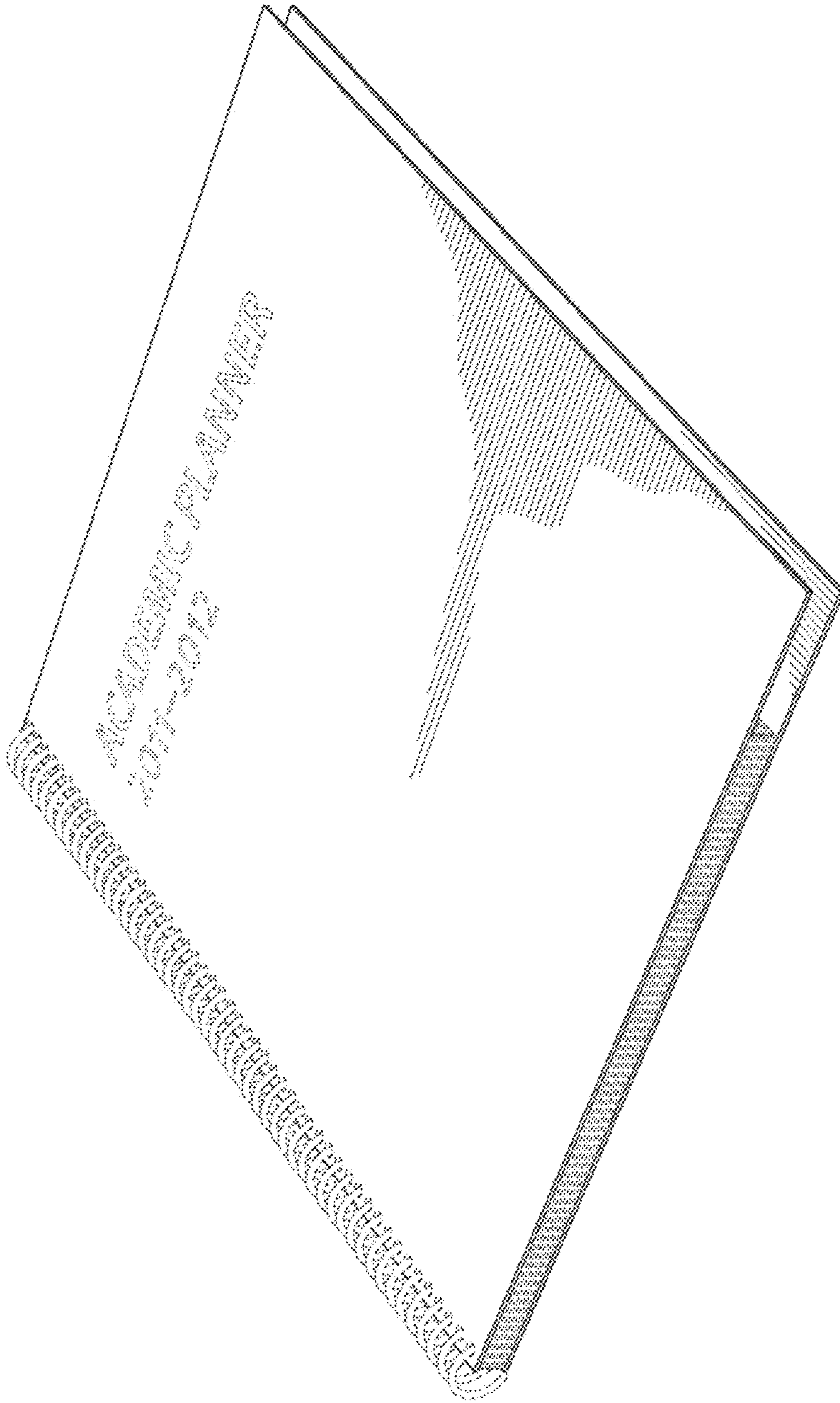

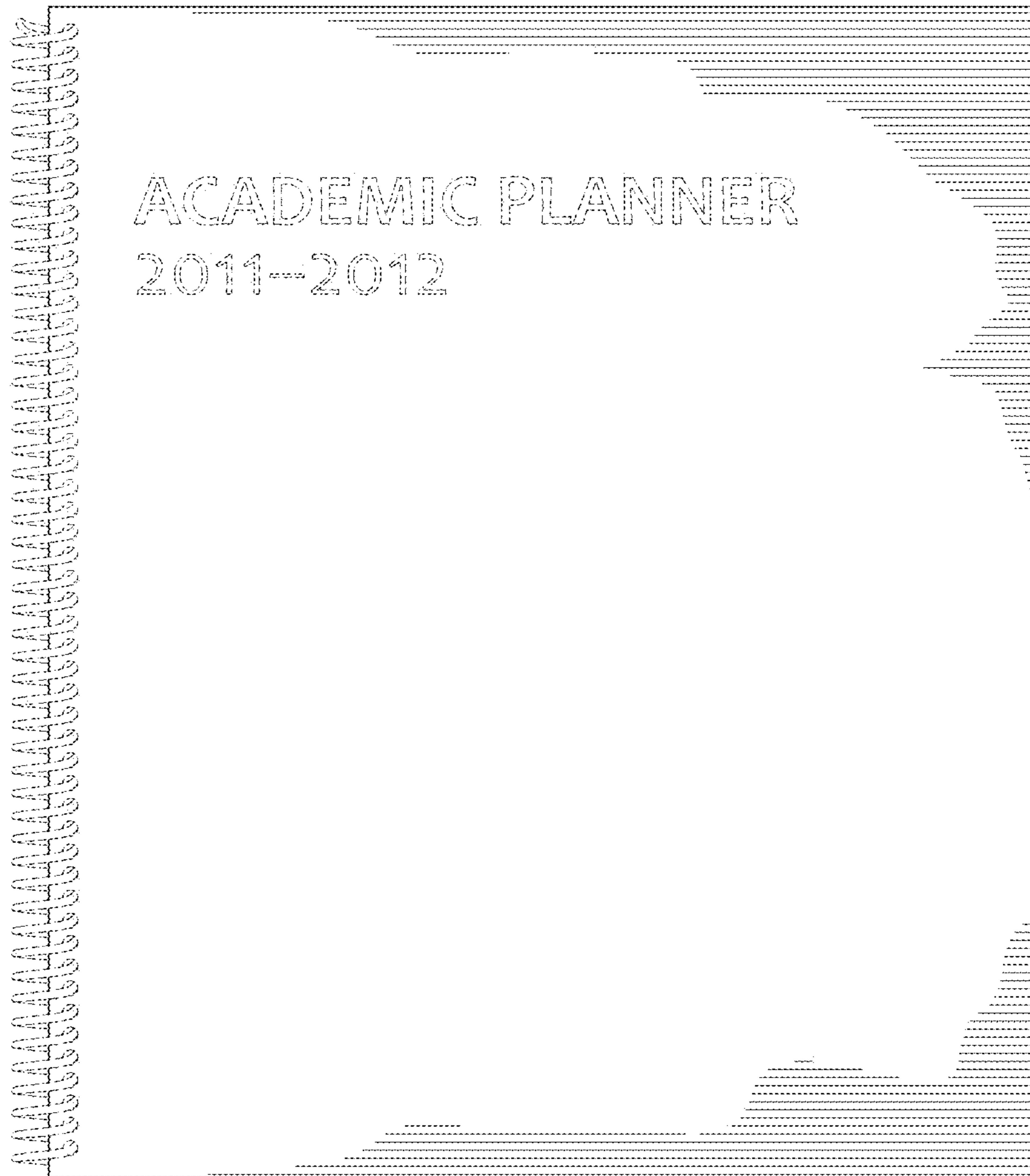

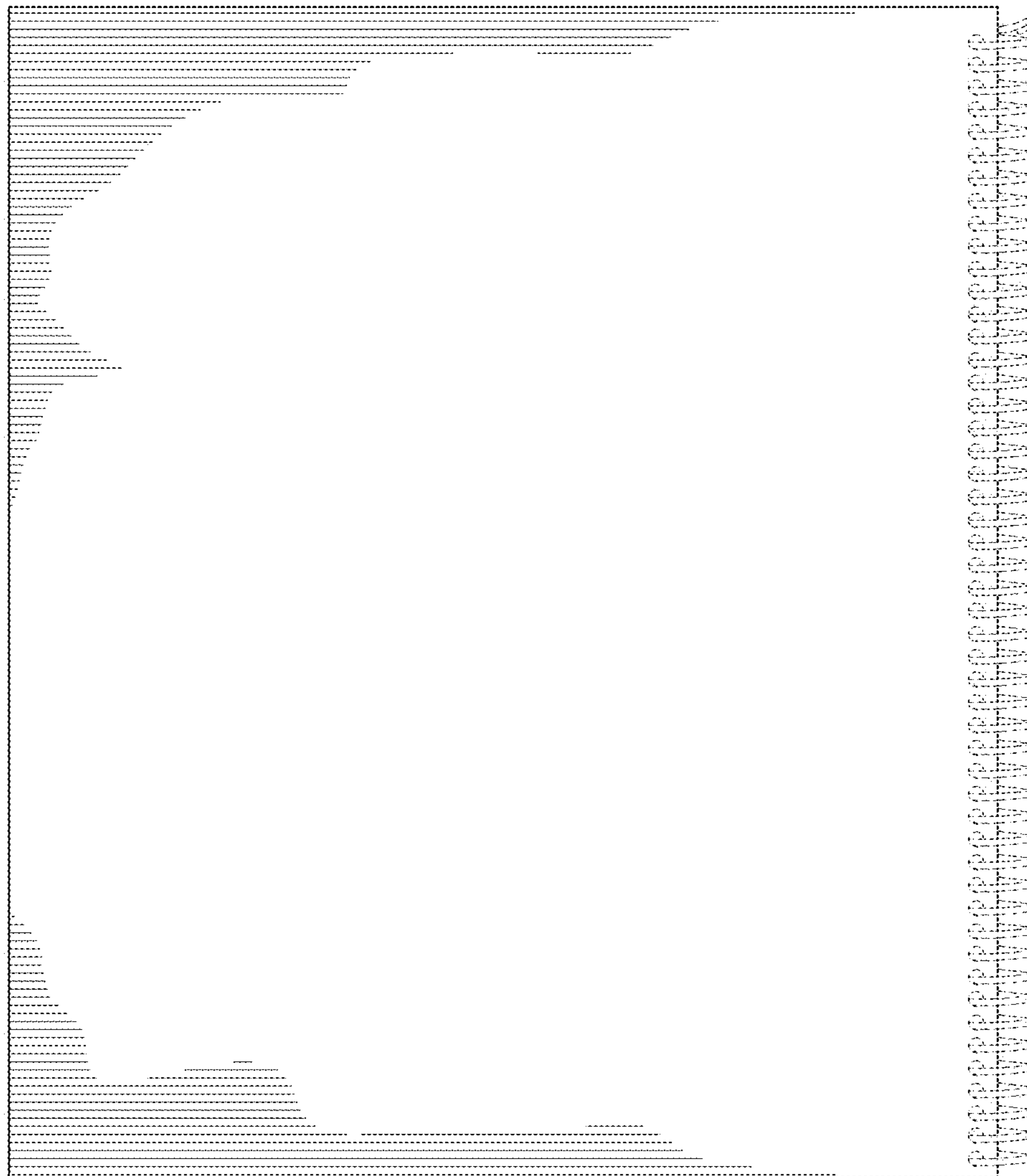

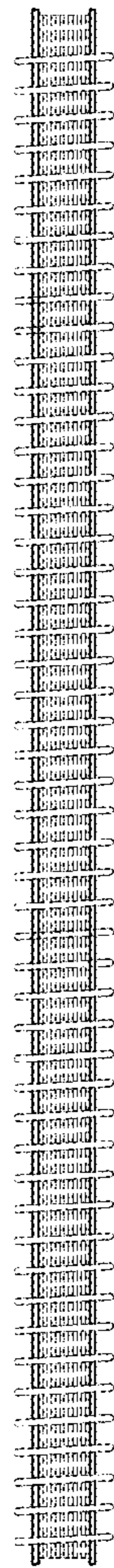

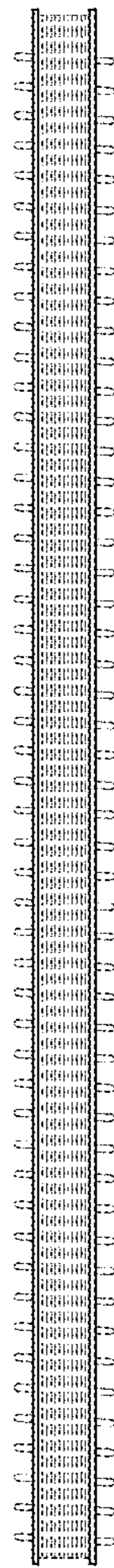

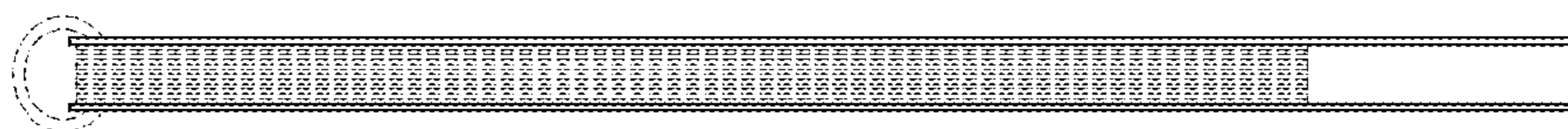

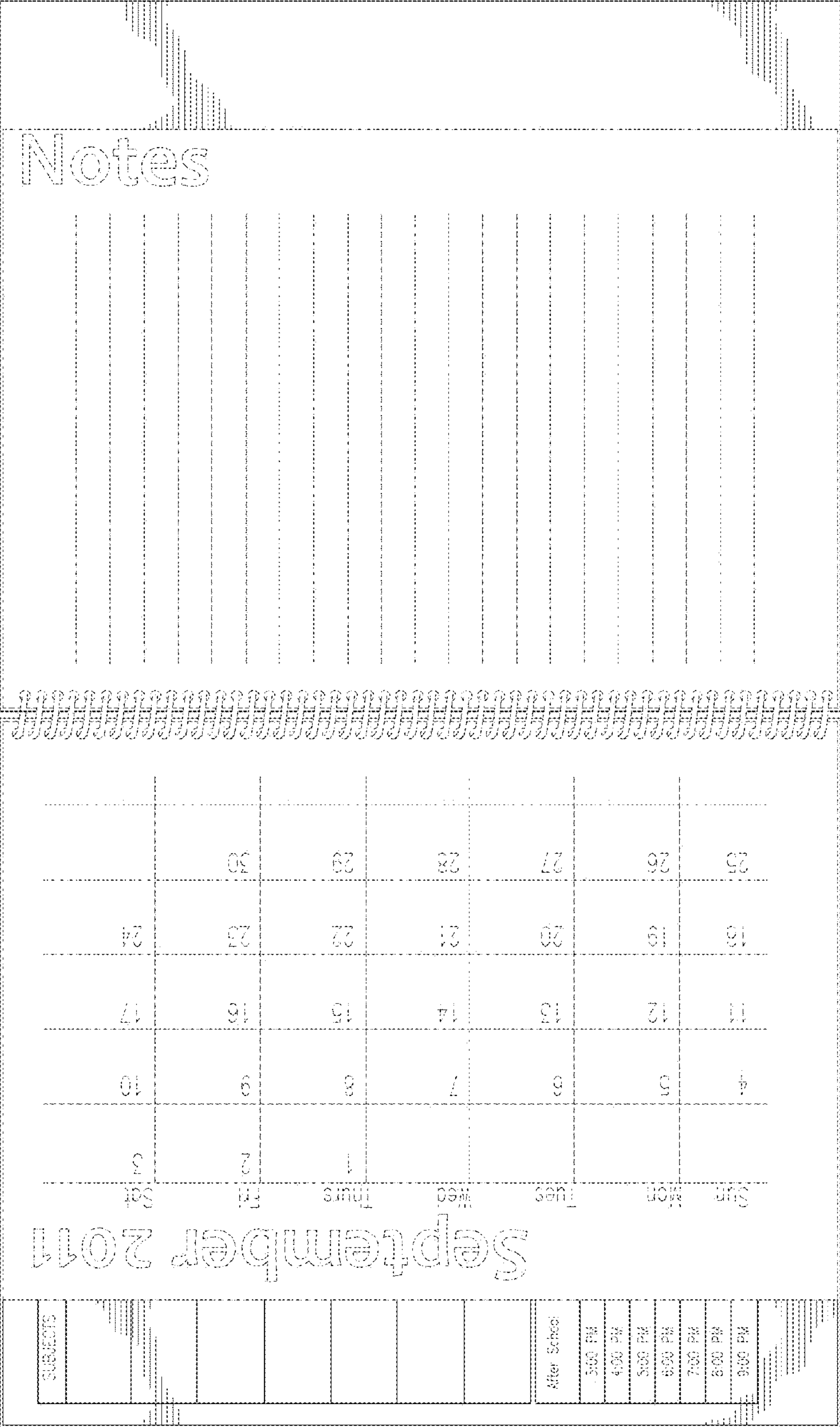

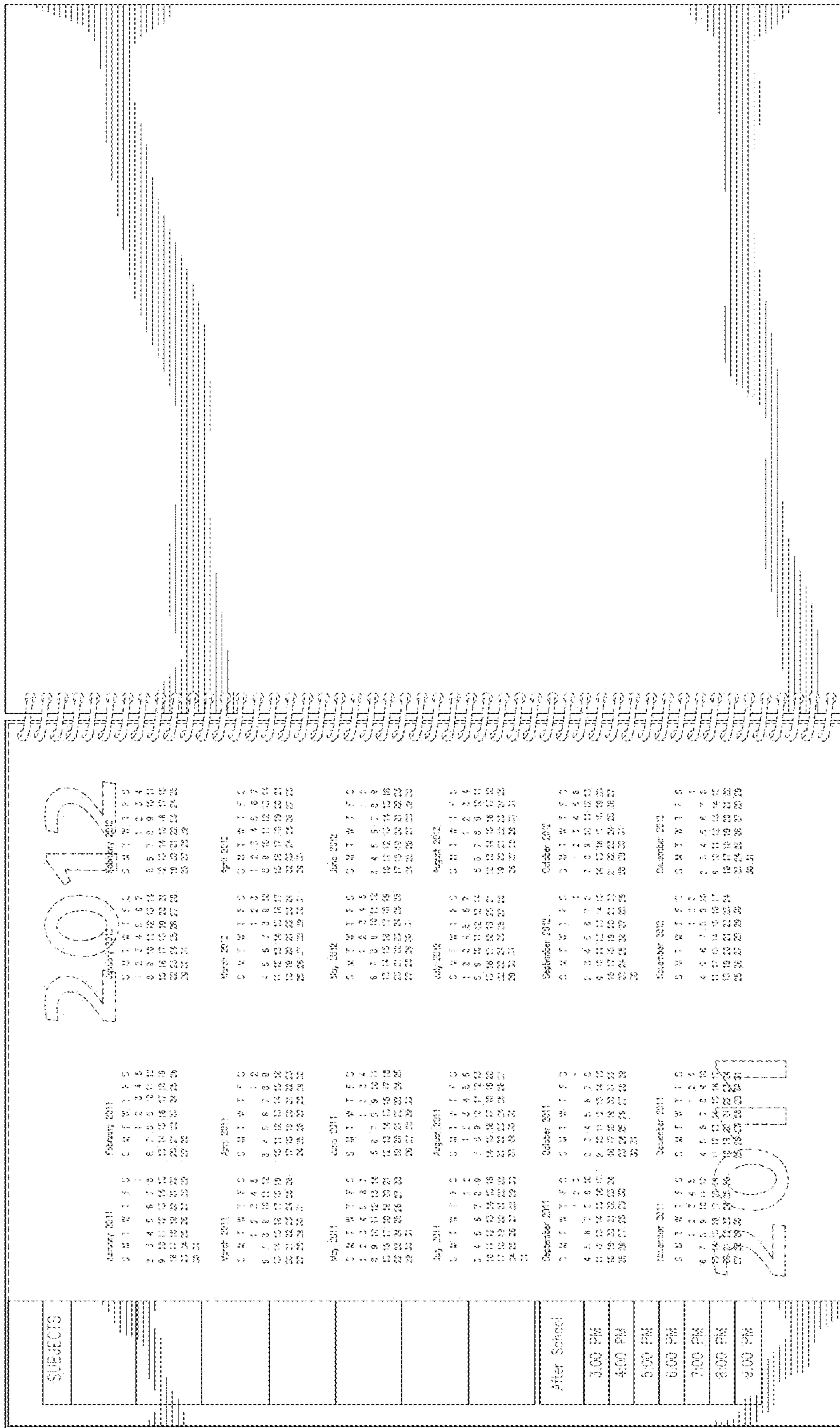
