DESCRIPTION

FIG. 7 is a right side view of the golf club head of my new design illustrated in FIG. 1.

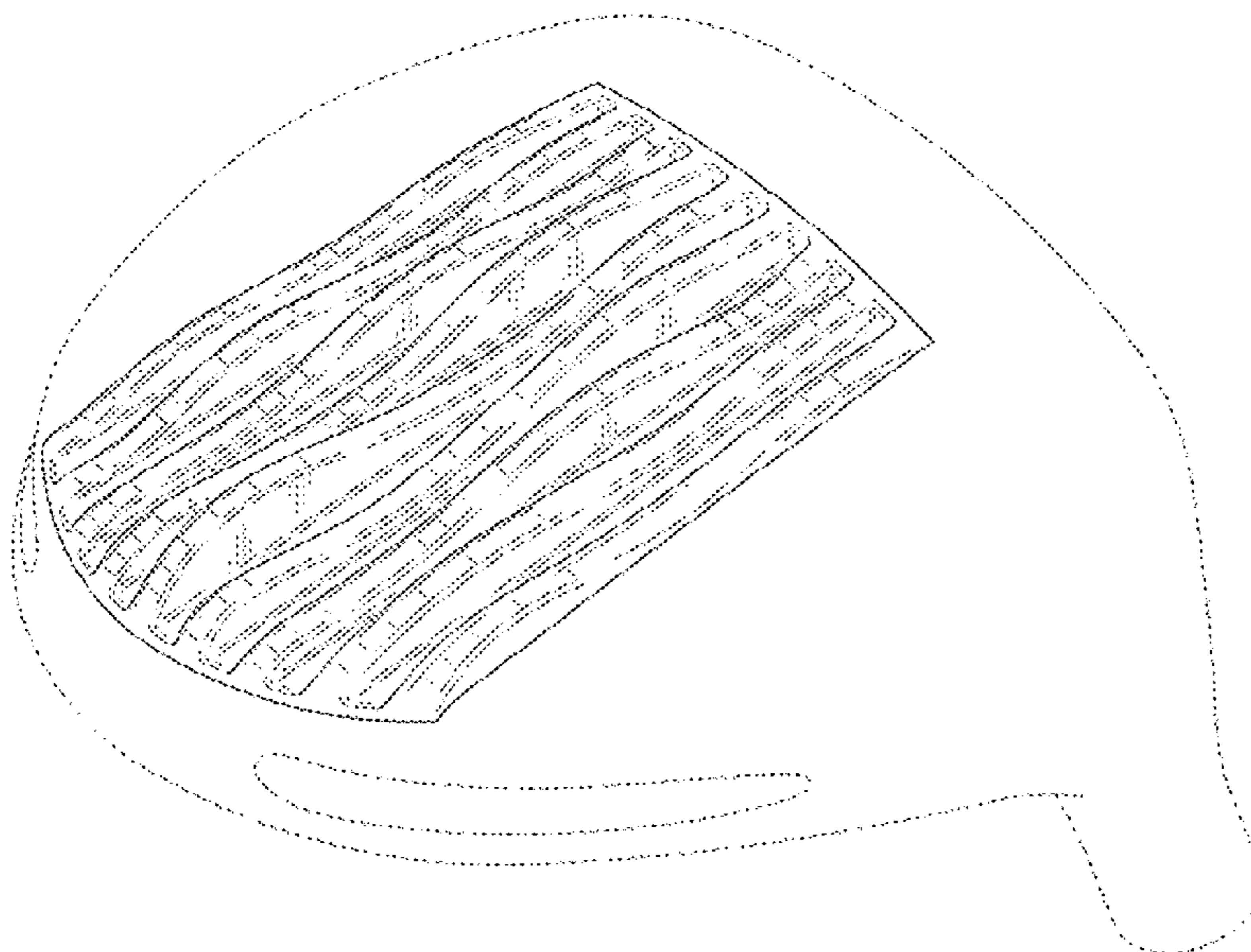

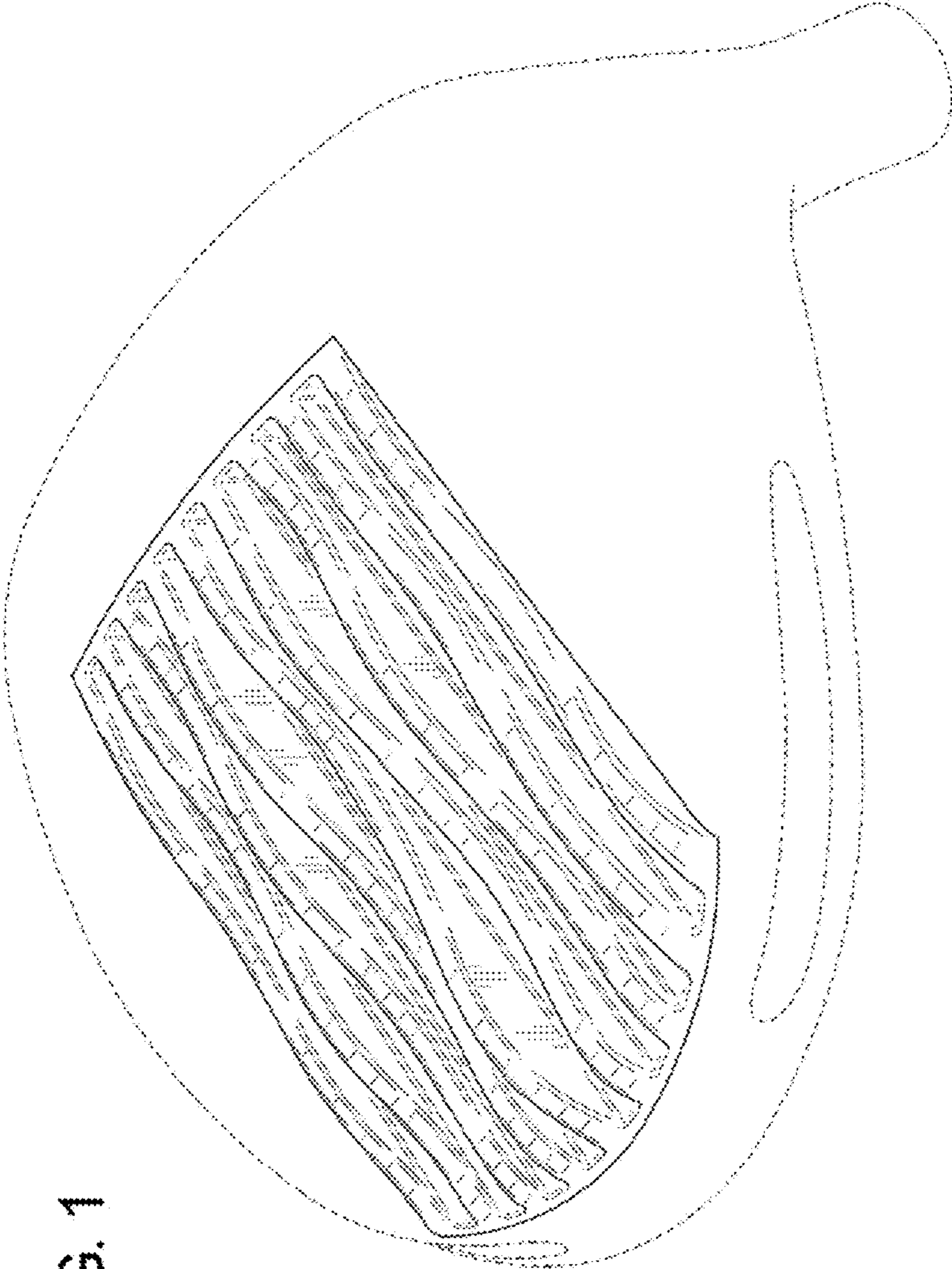

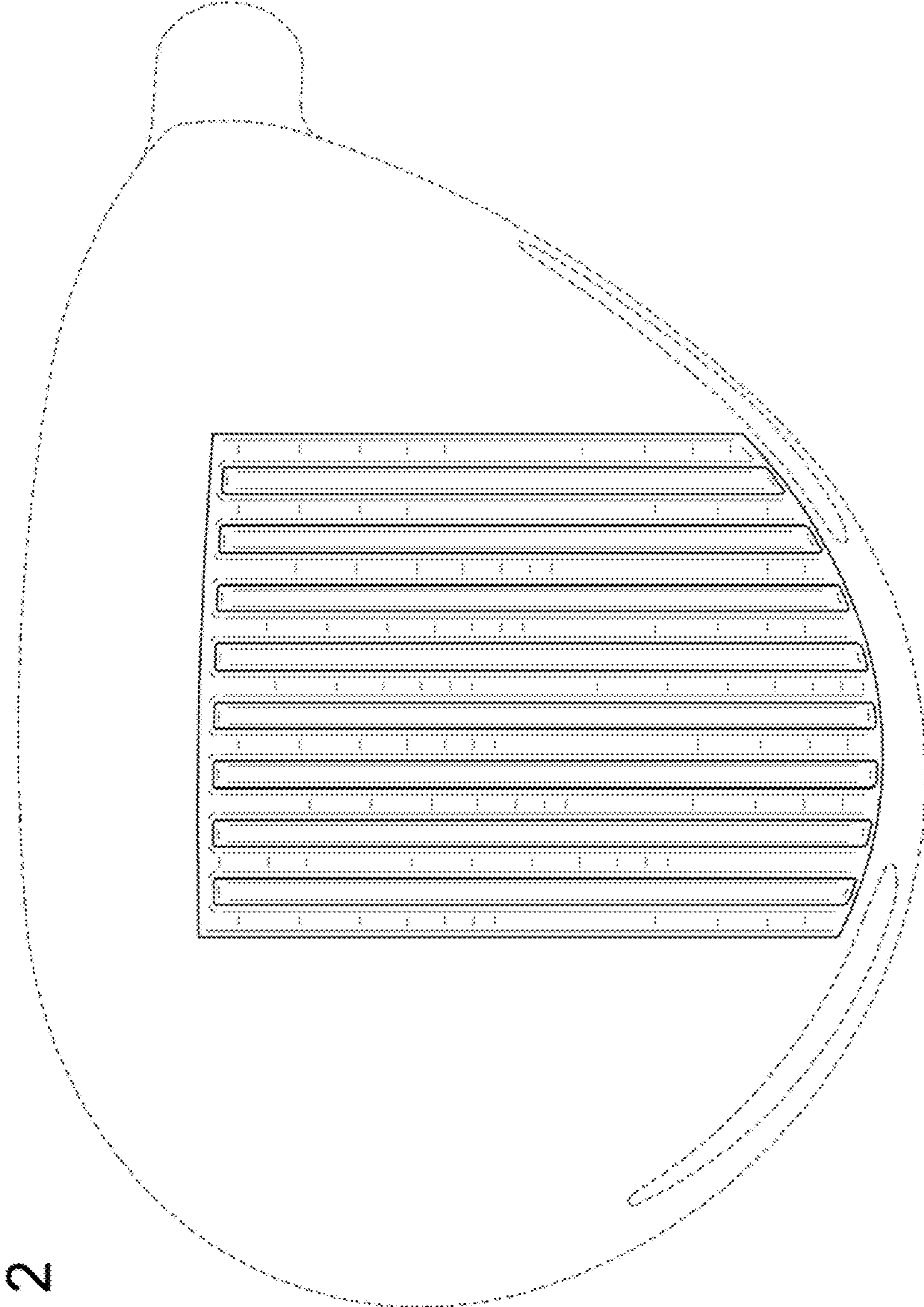

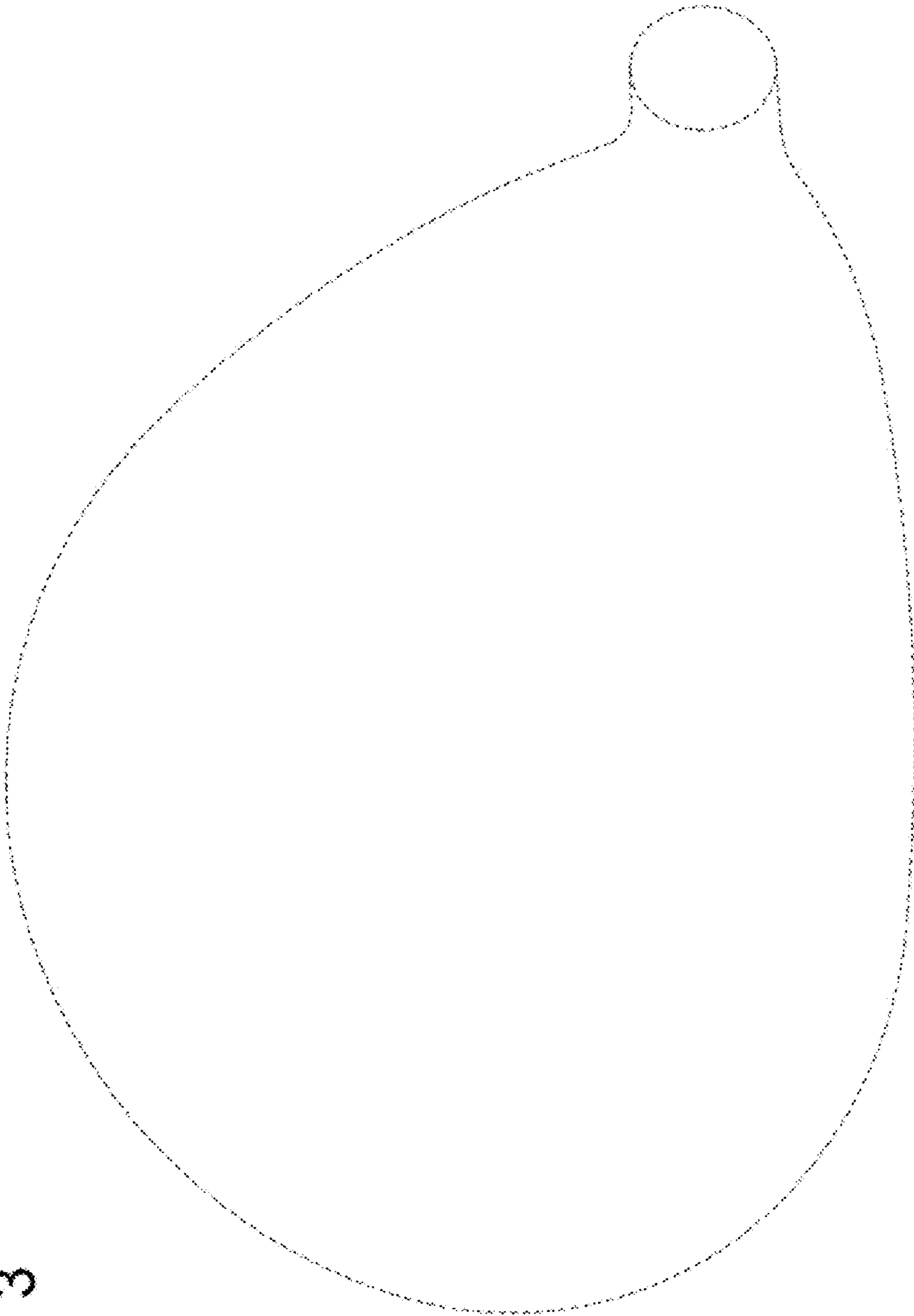

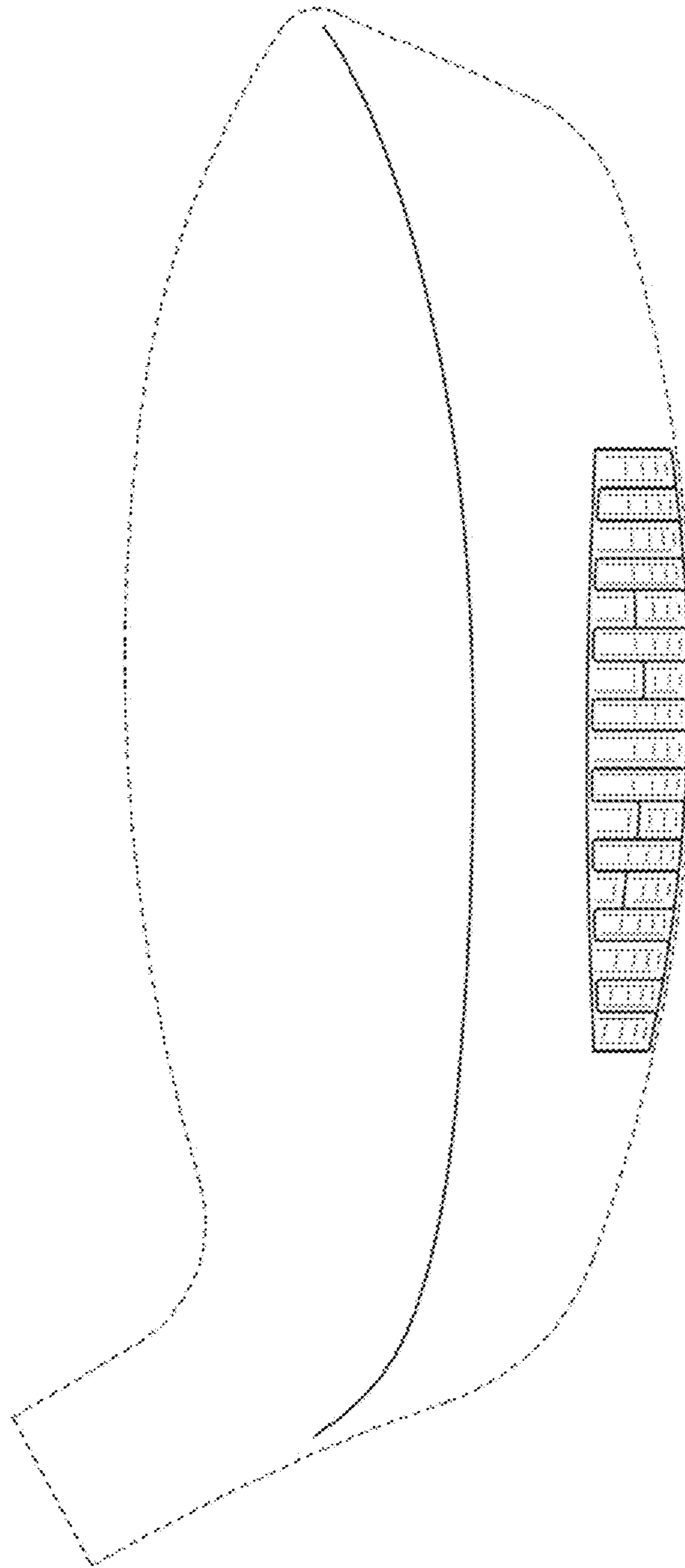

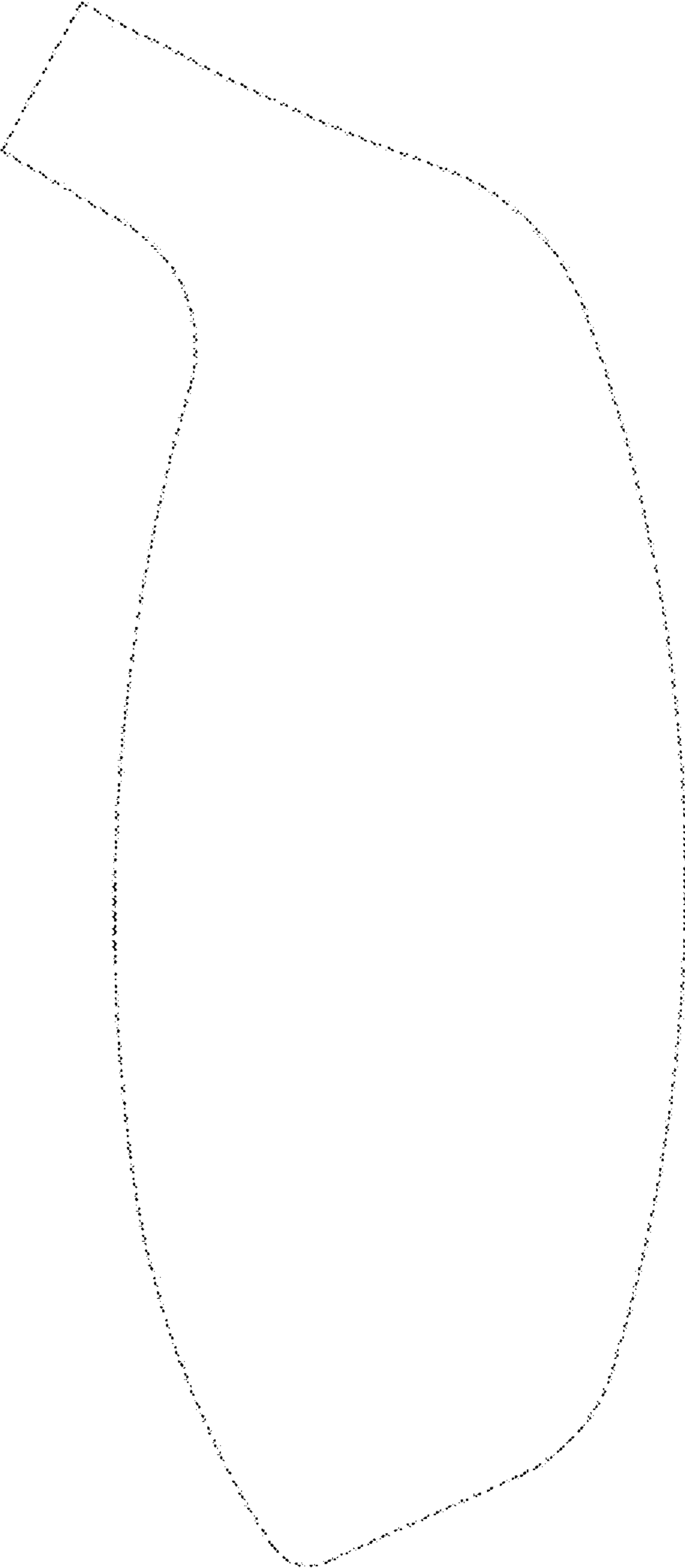

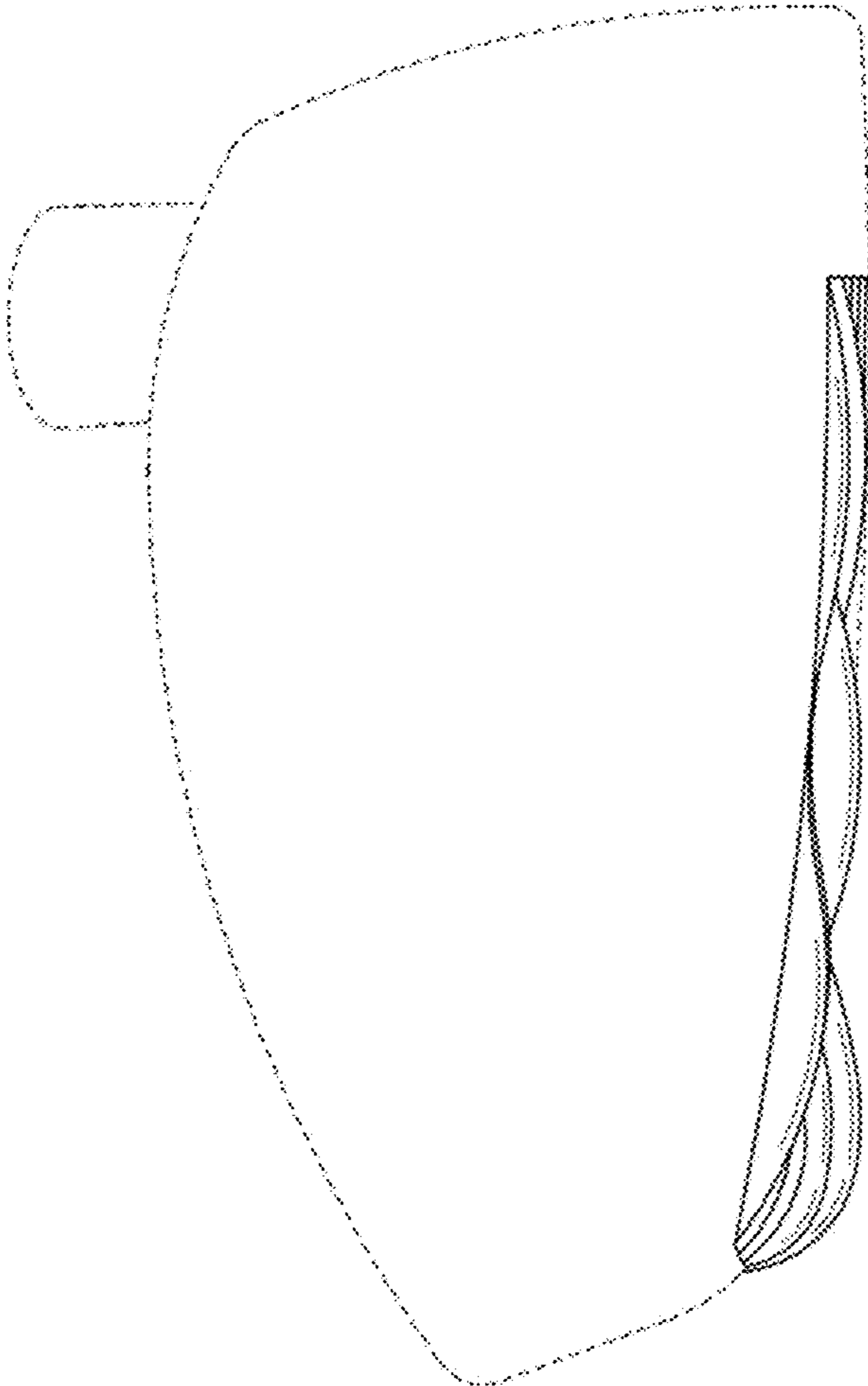
