(57) **CLAIM**

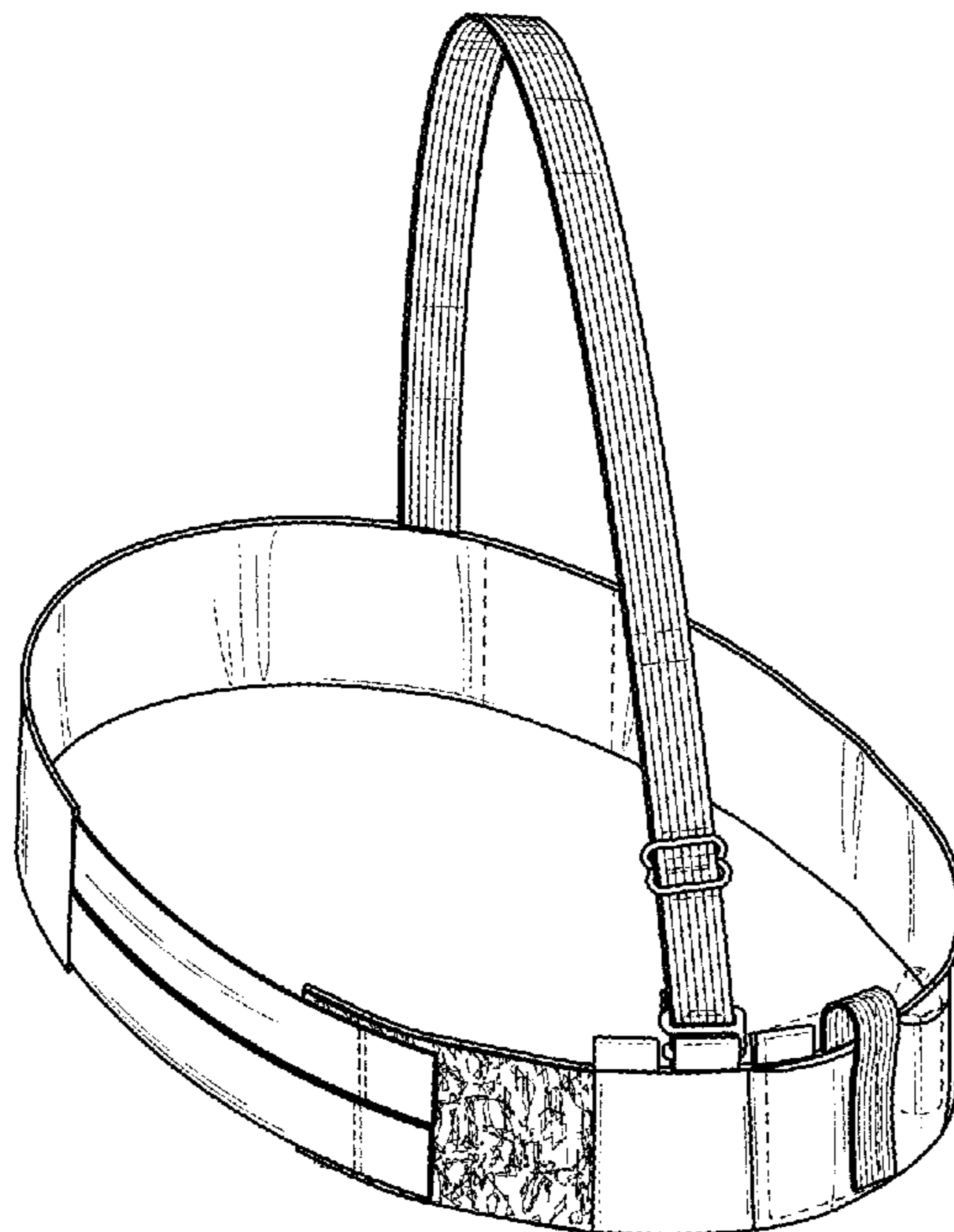
We claim the ornamental design for an insulin pump holster,
as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an insulin pump holster,
showing our new design in a worn configuration;
FIG. 2 is a right-side elevational view thereof, illustrated in a
flat configuration;
FIG. 3 is a left-side elevational view of FIG. 2;
FIG. 4 is a front elevational view of FIG. 2;
FIG. 5 is a rear elevational view of FIG. 2;
FIG. 6 is a top plan view of FIG. 2; and,
FIG. 7 is a bottom plan view of FIG. 2.

The broken lines showing an insulin pump and an emergency
contact card in FIG. 1 depict environmental matter and form
no part of the claimed design. Portions of the design between
the break lines in FIGS. 2-5 form no part of the claimed
design. The remaining broken lines represent stitching, and
are part of the claimed design.

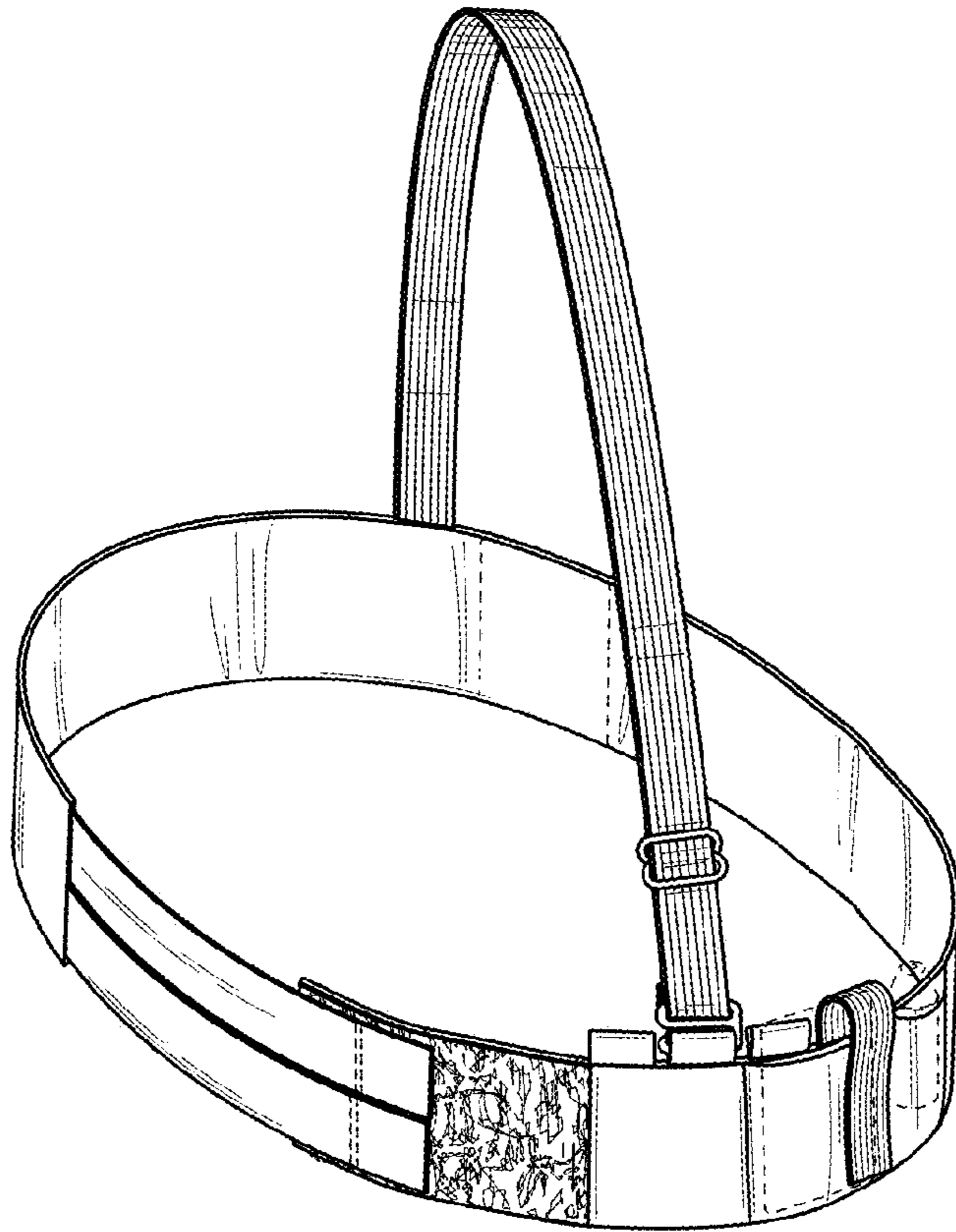

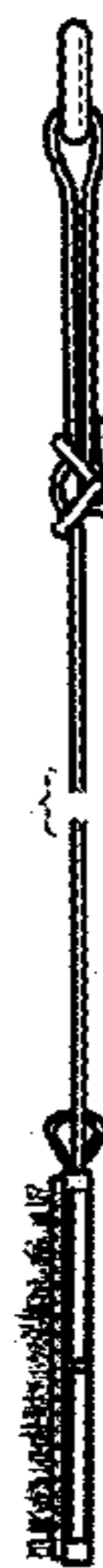

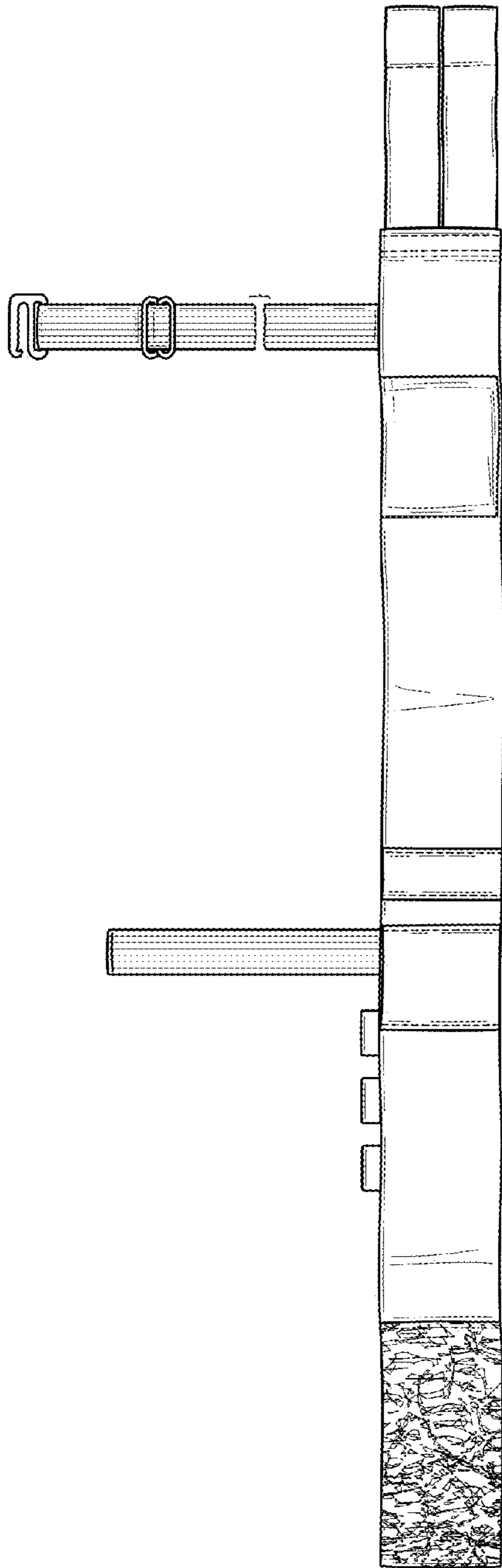

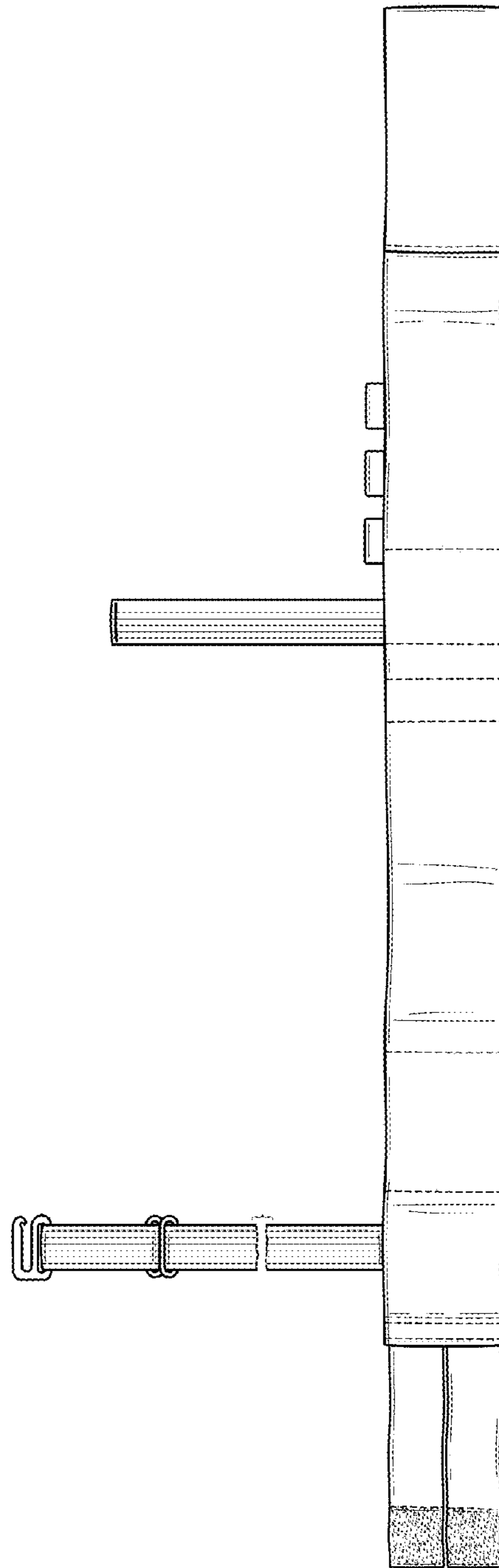

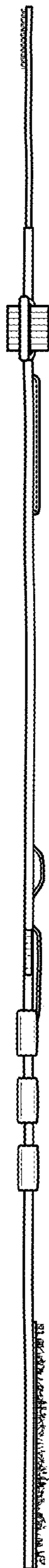

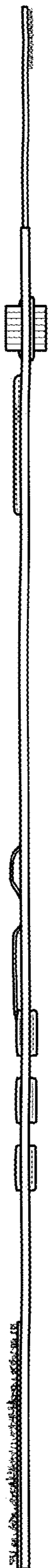
