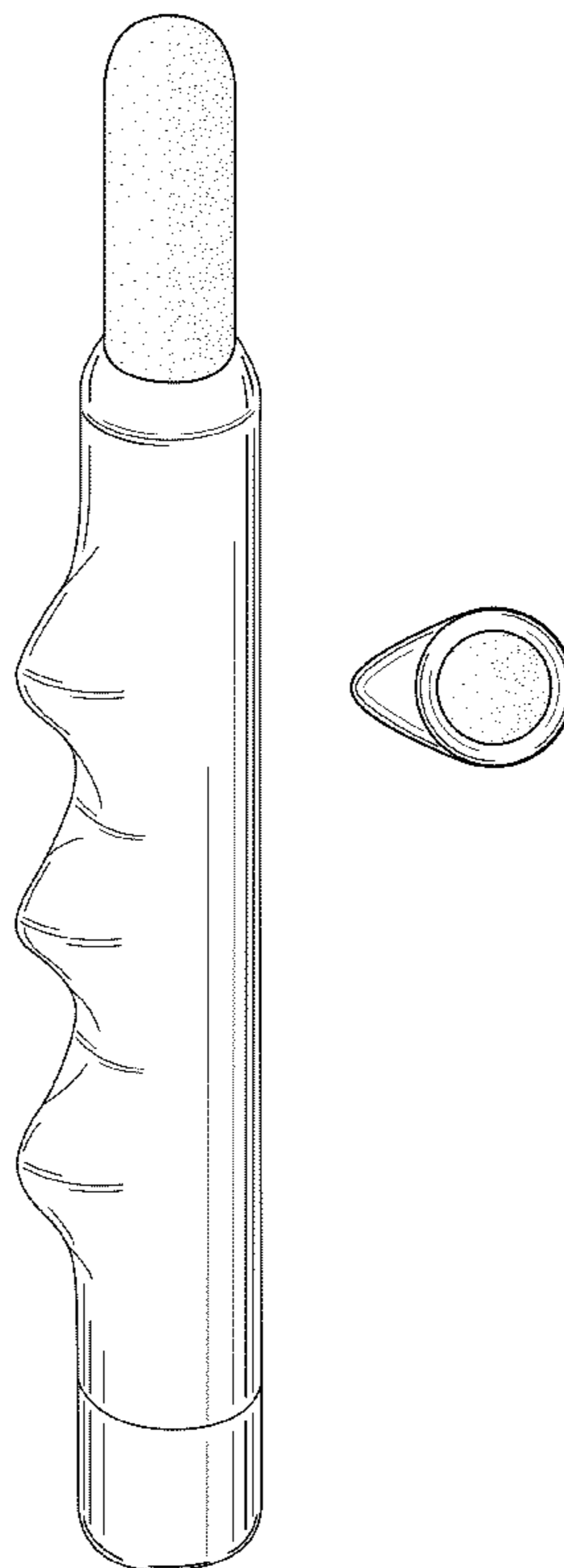
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a perspective front view of a tooth-extracting implement, showing my new design;

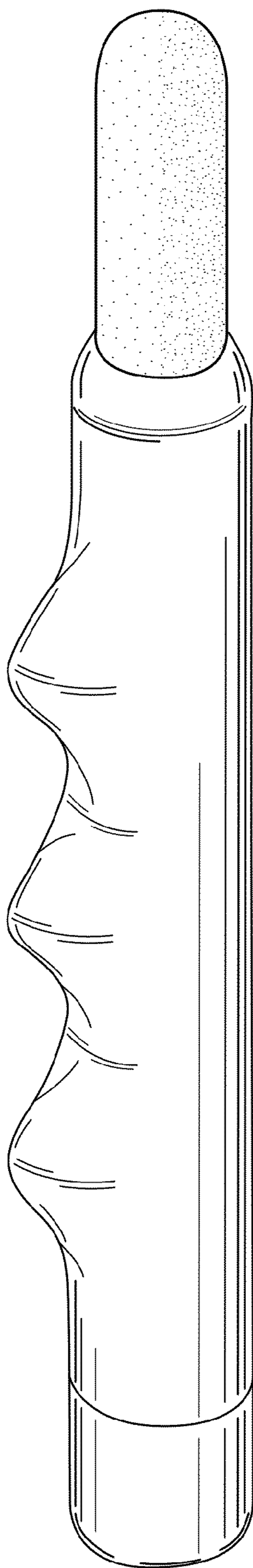

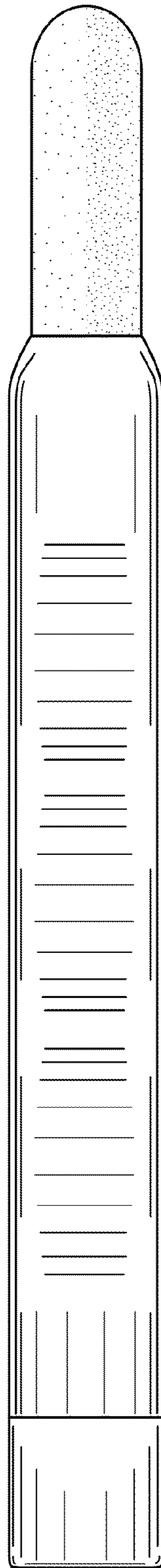

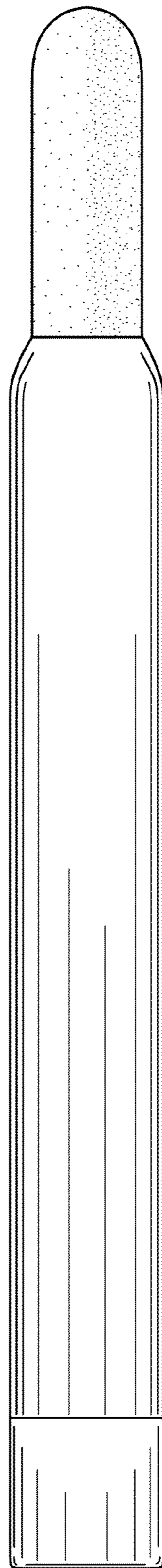

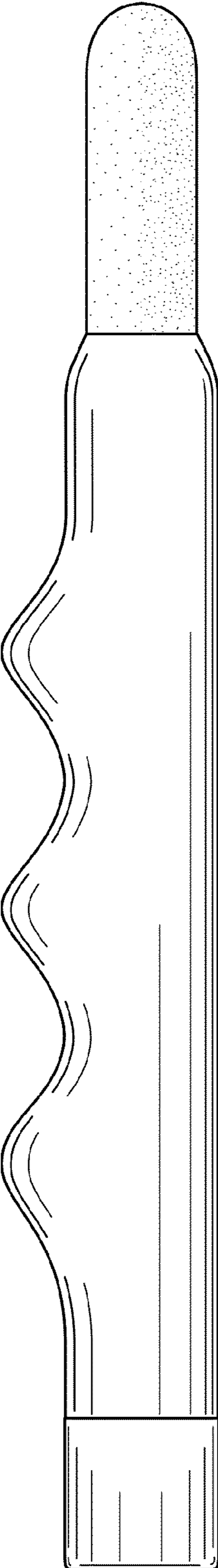

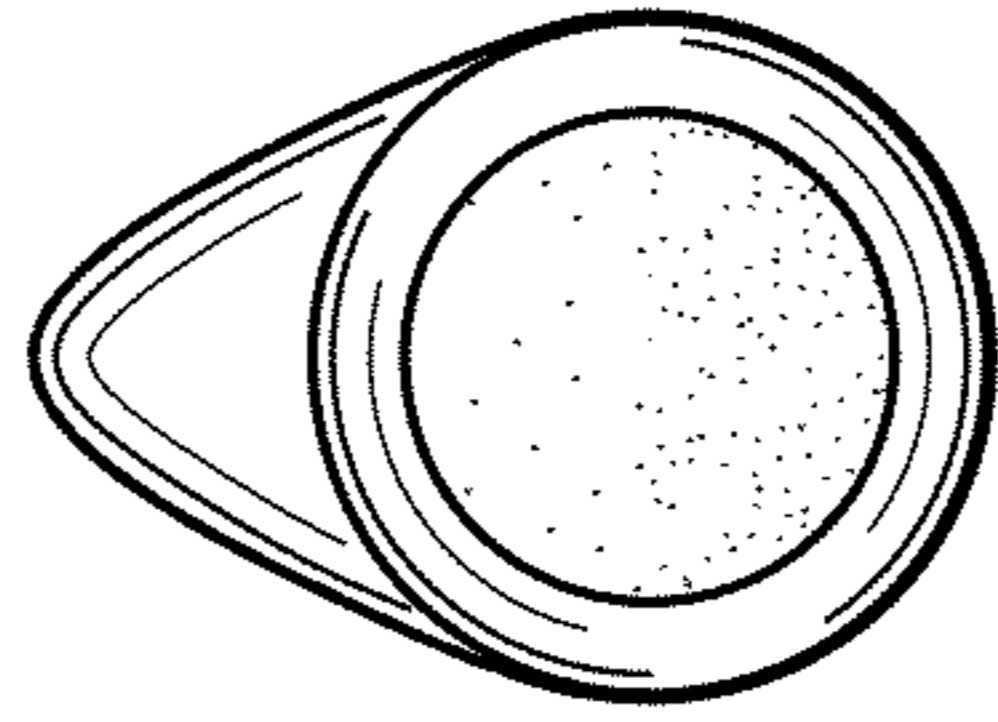

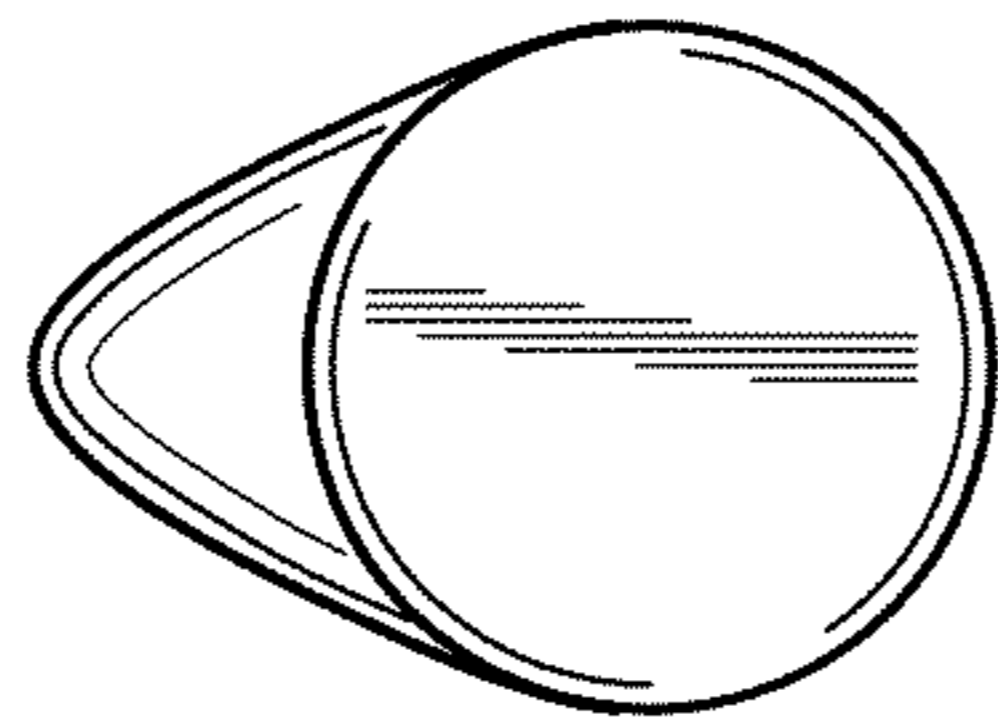
