FIG. 10 is a front elevation view of the electronic cigarette holder with the cover opened.

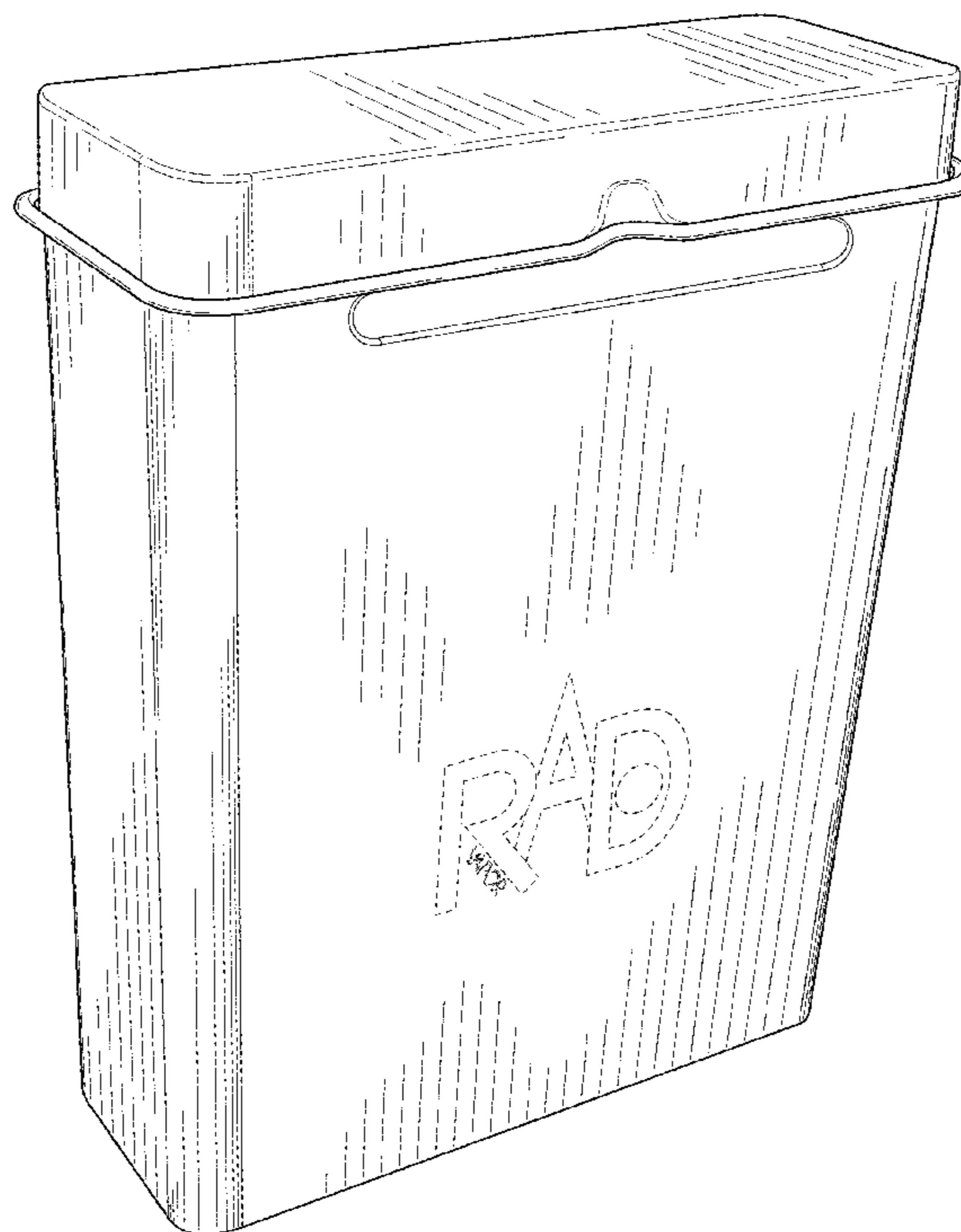

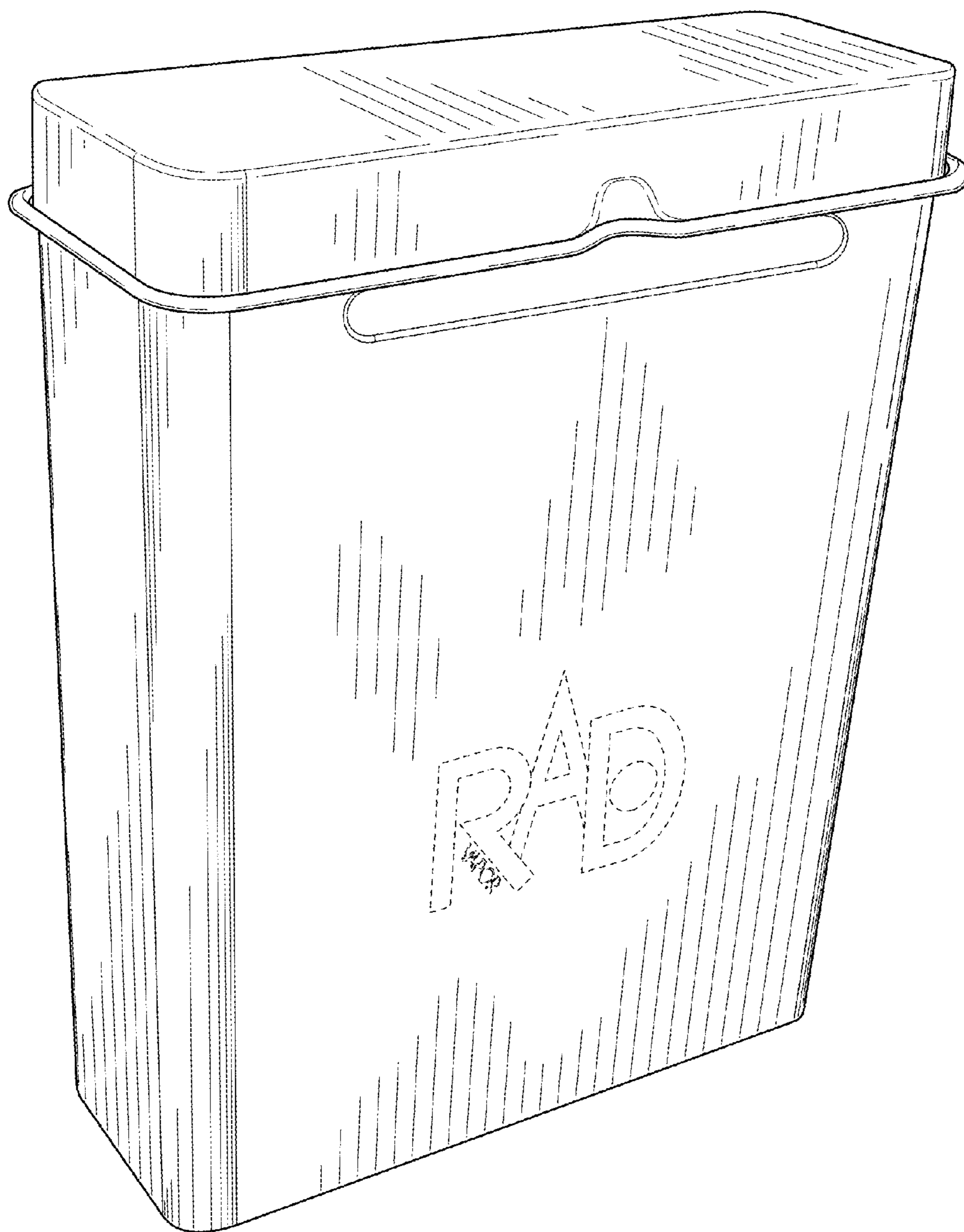

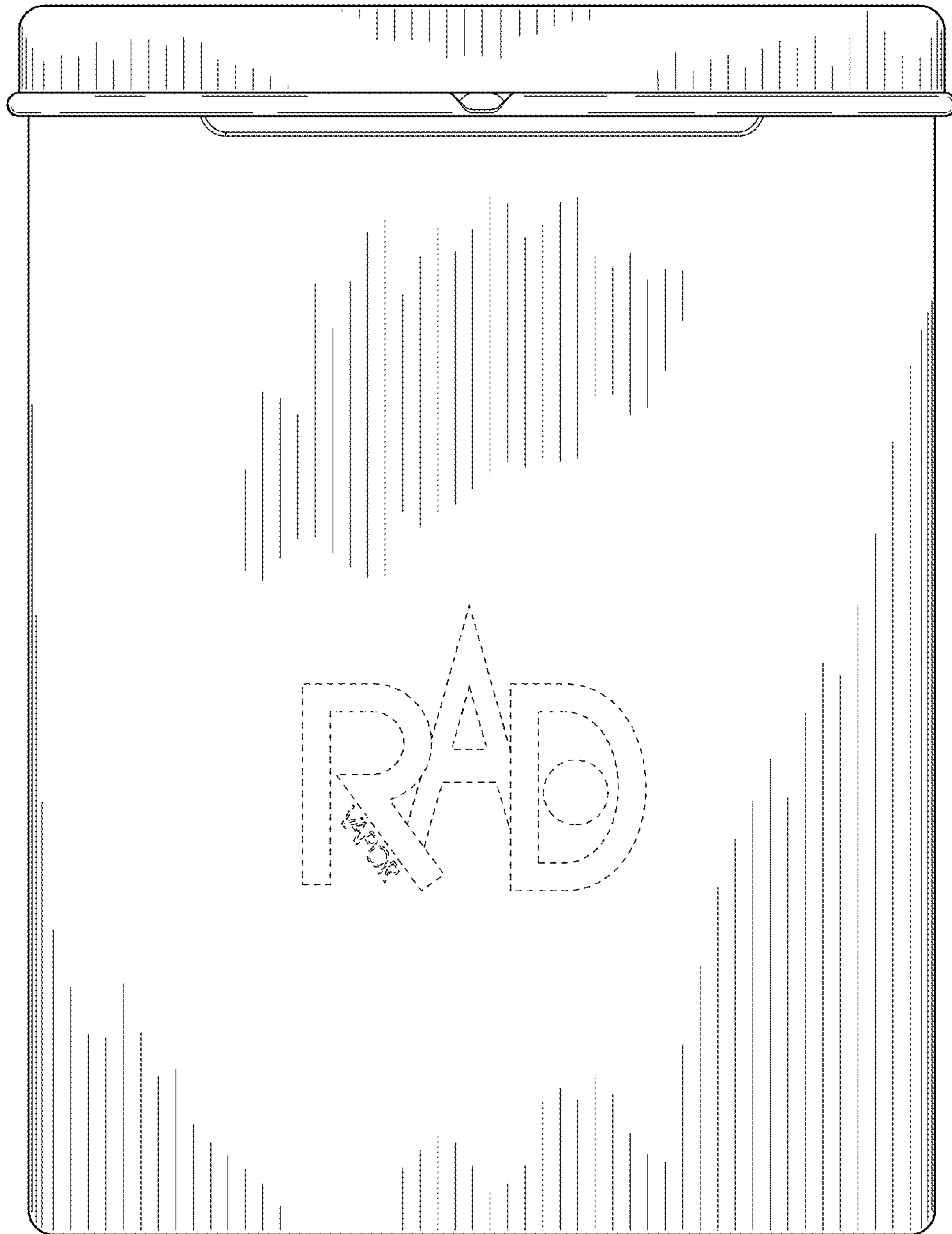

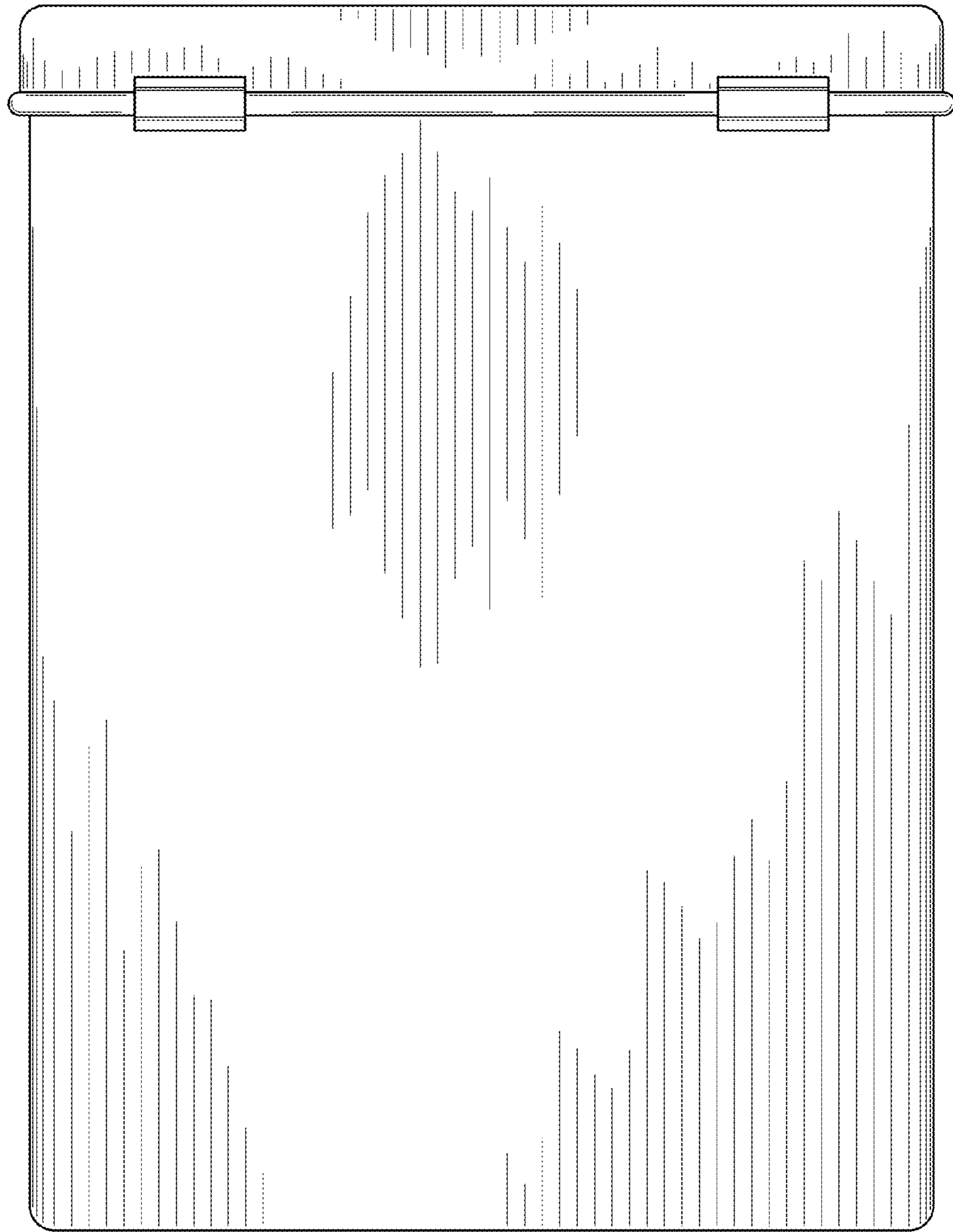

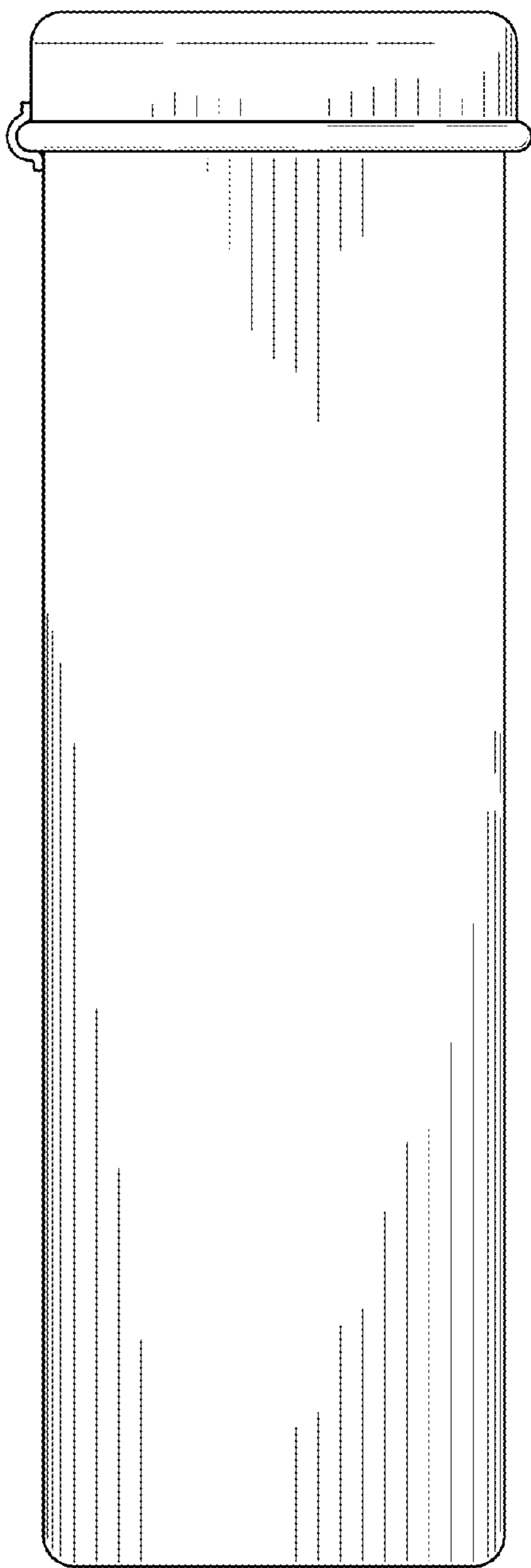

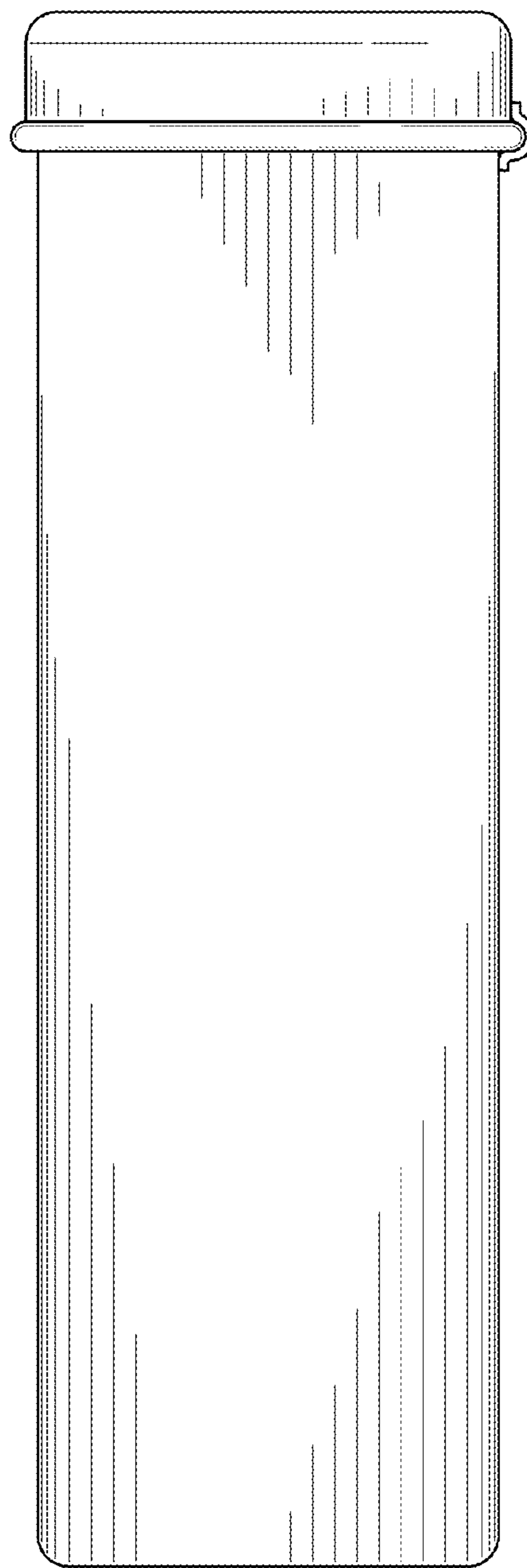

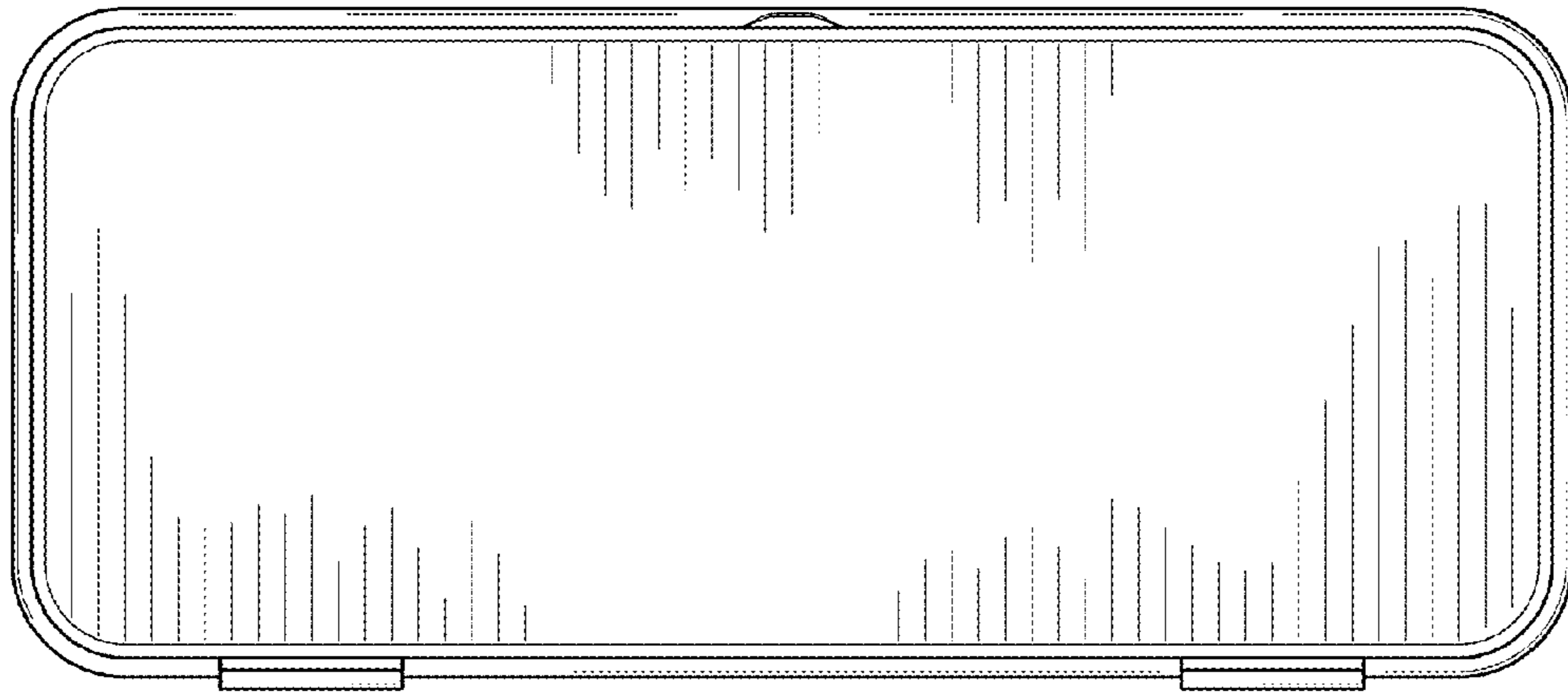

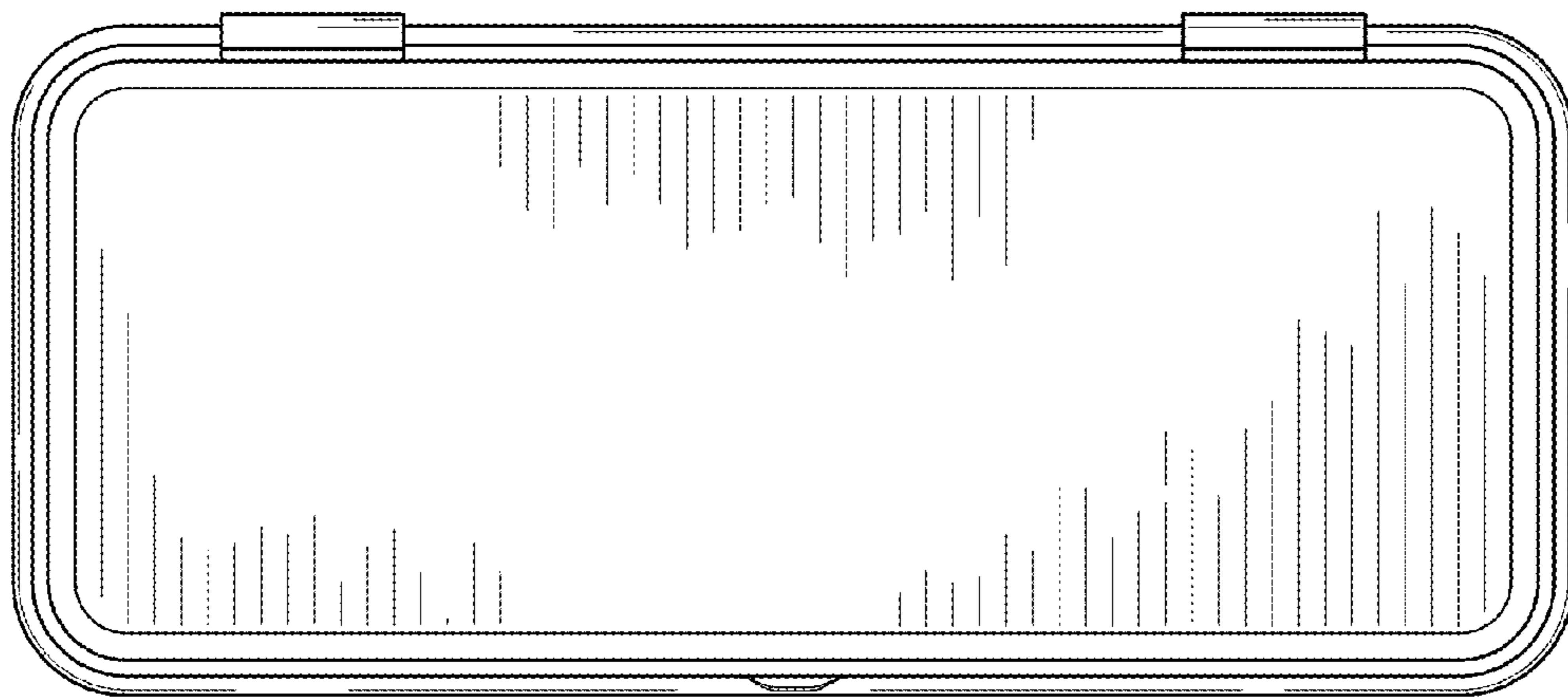

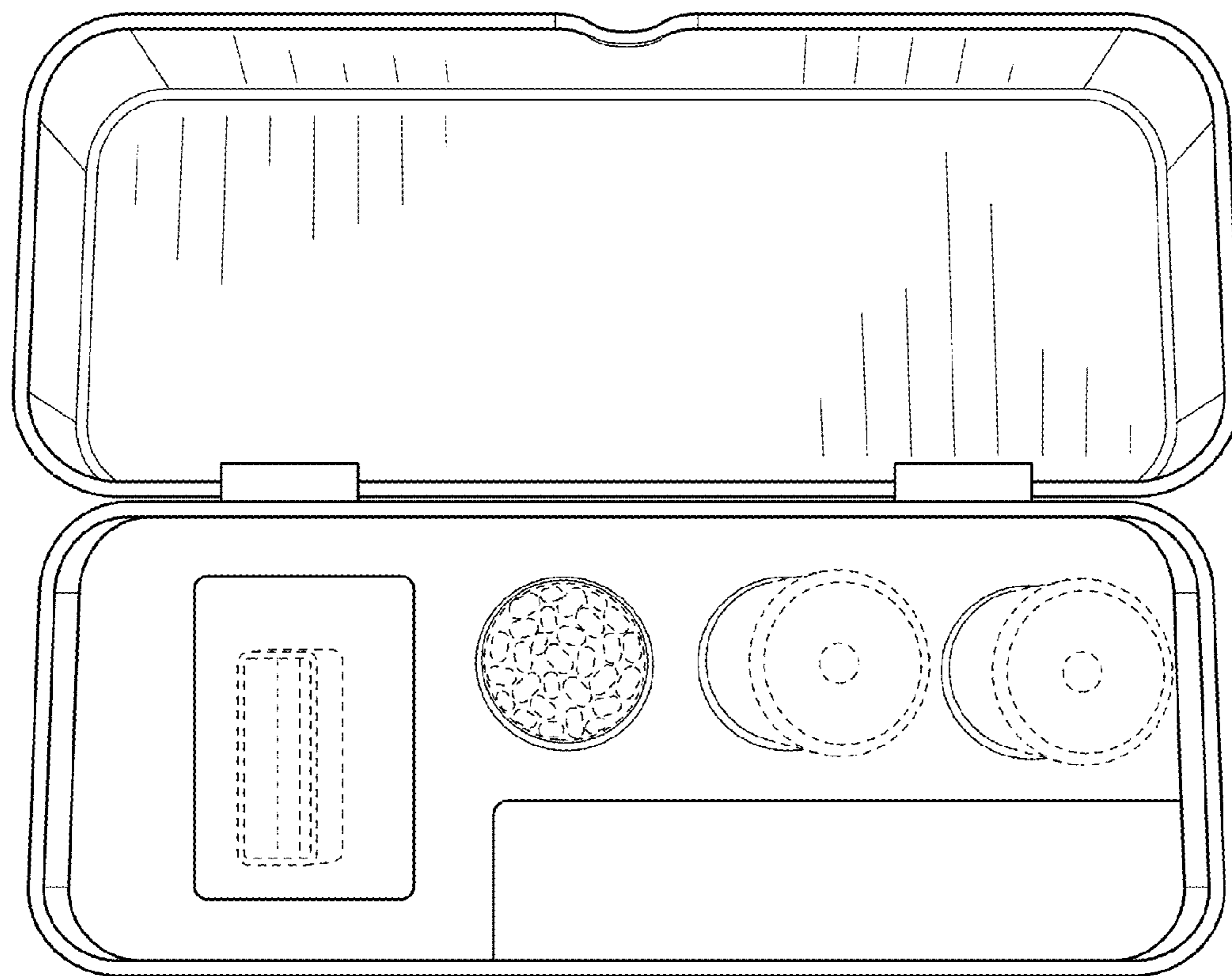

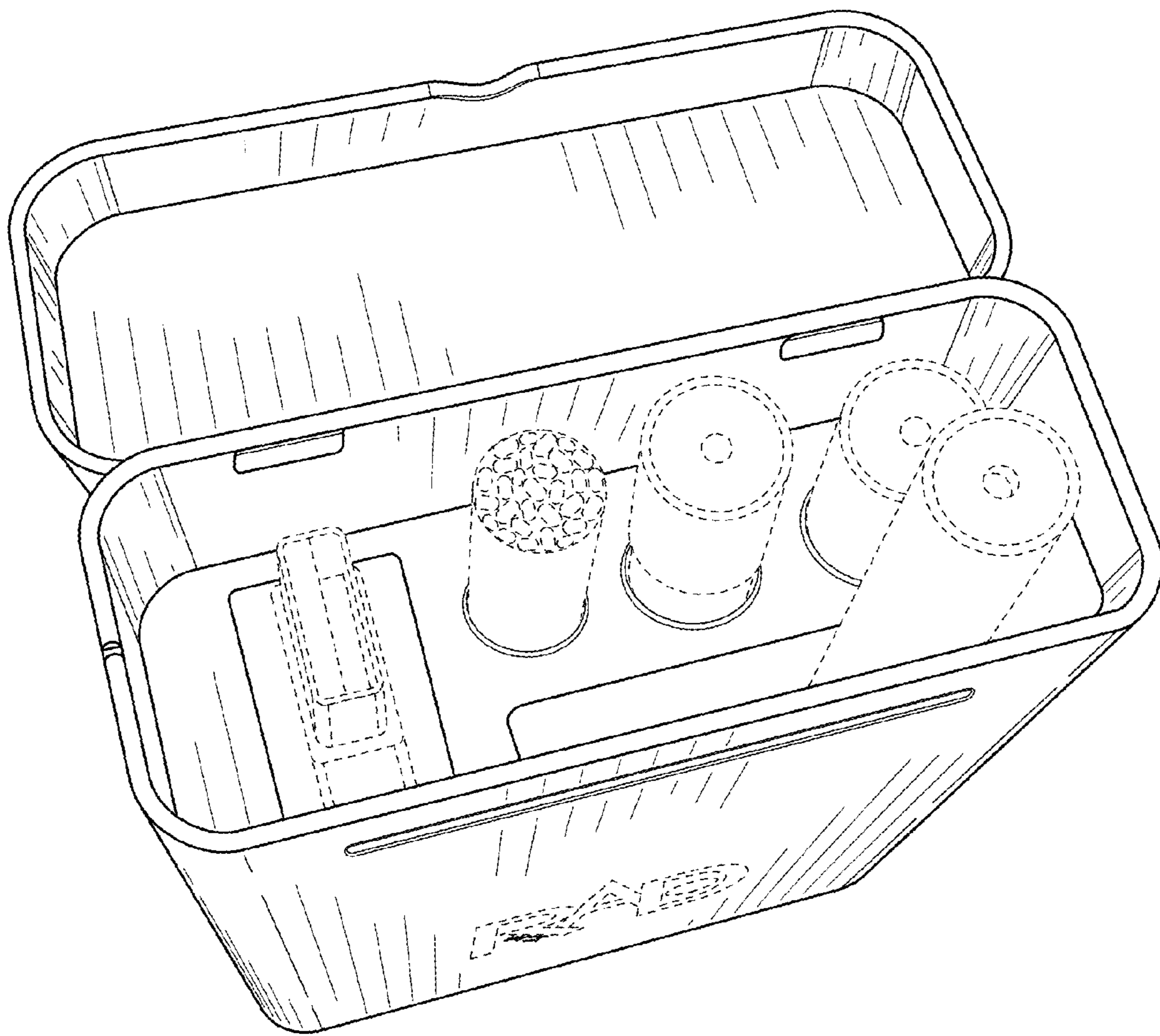

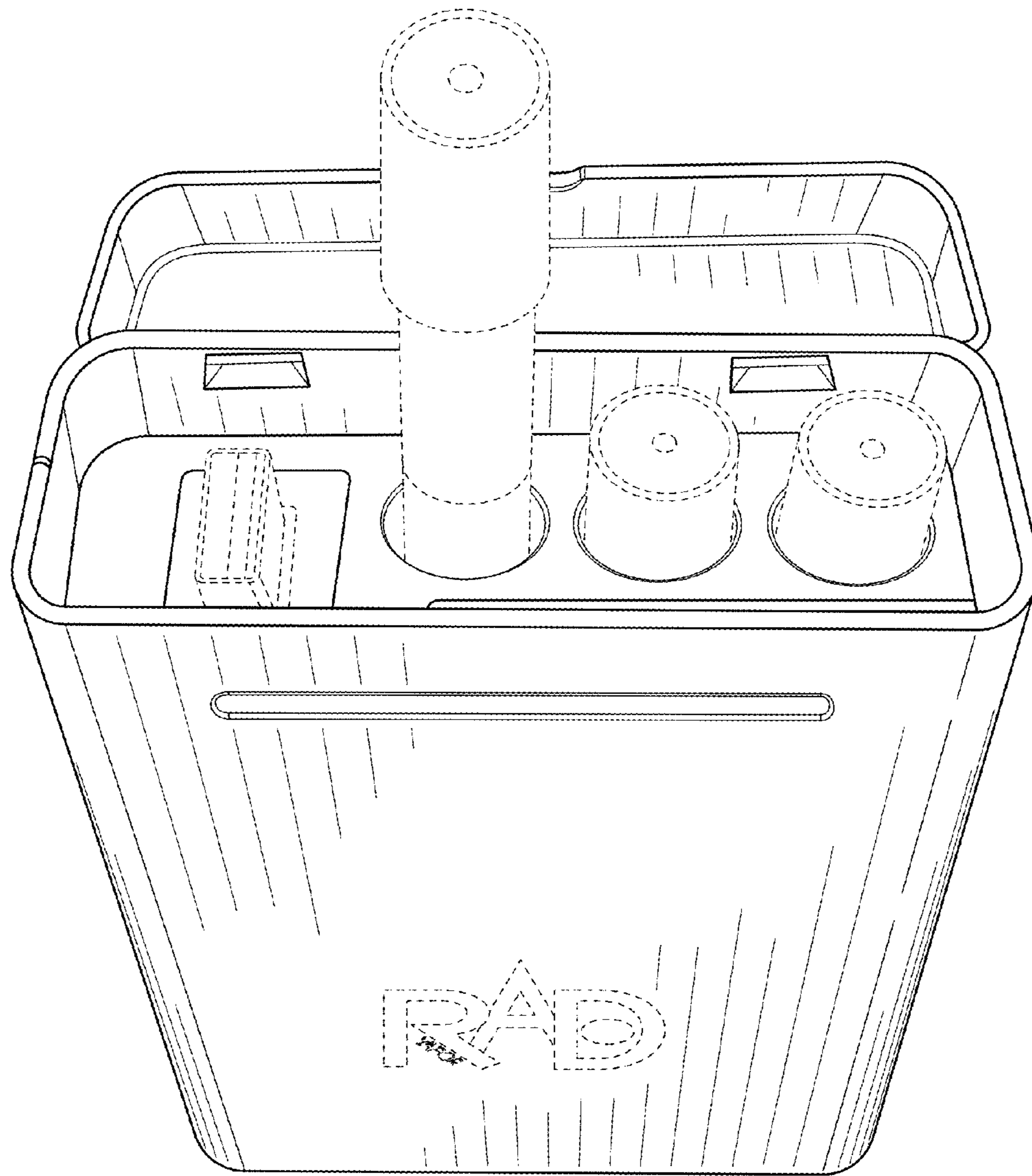
