The ornamental design for an iron, as shown and described.

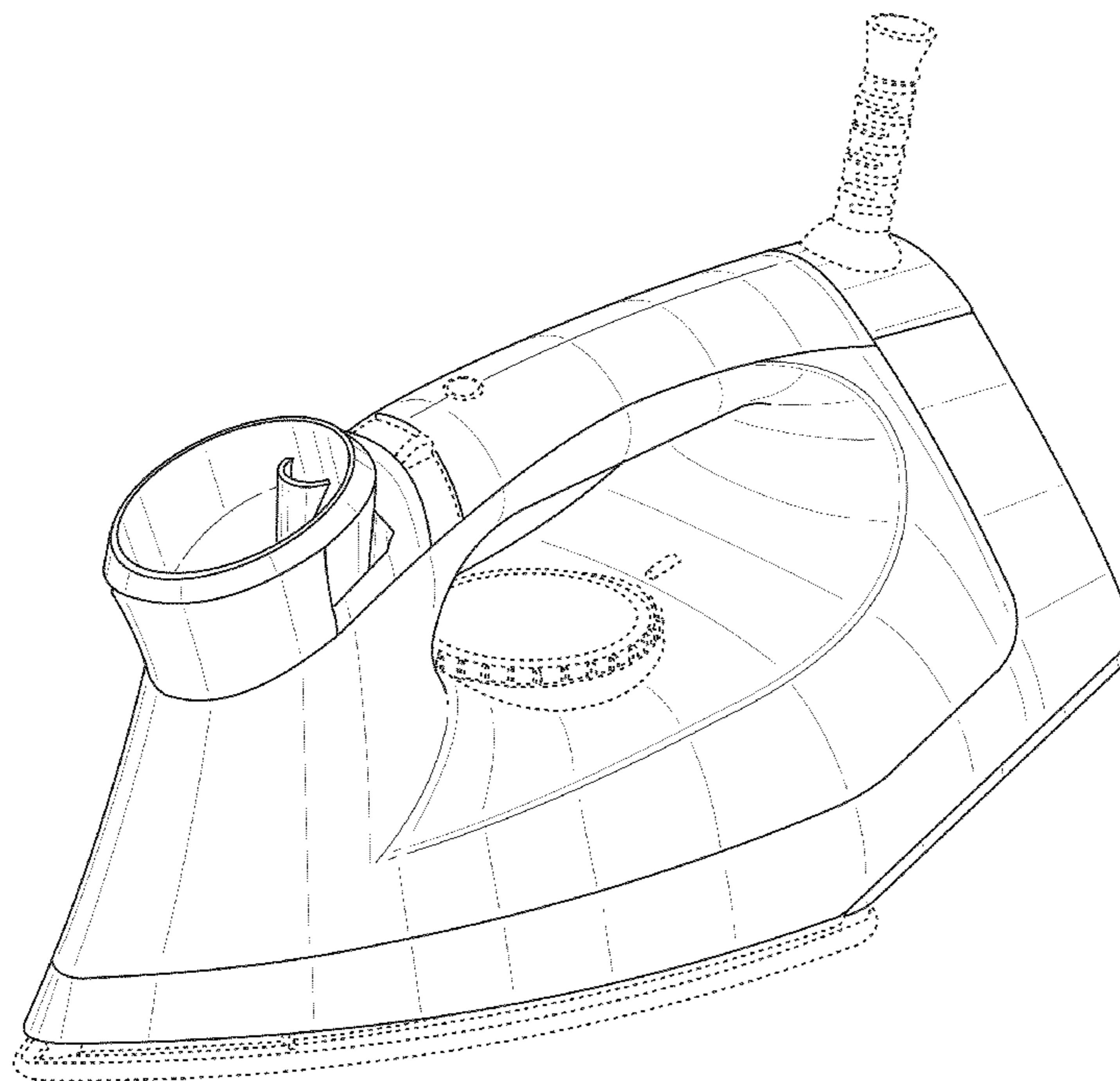
DESCRIPTION

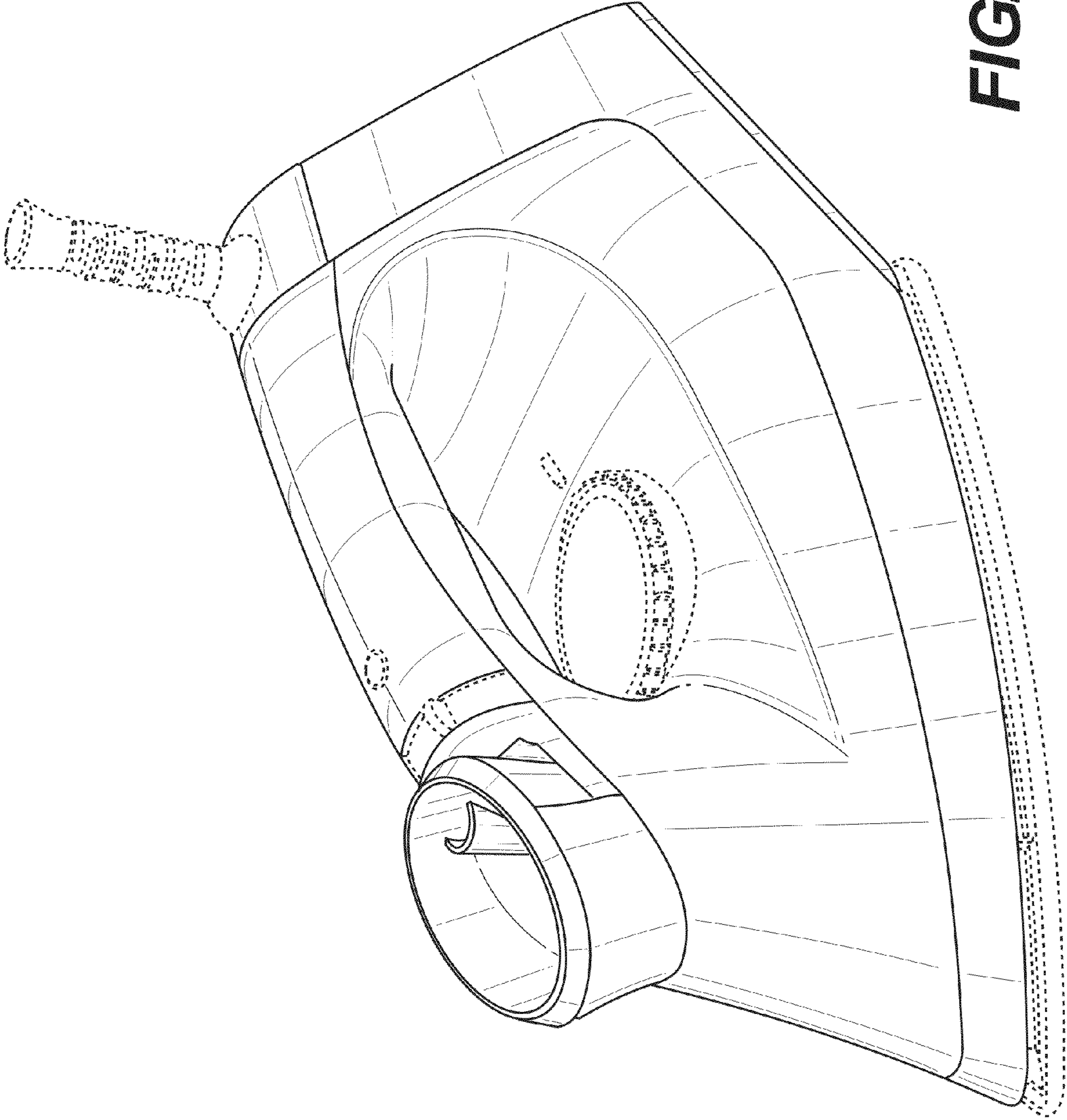

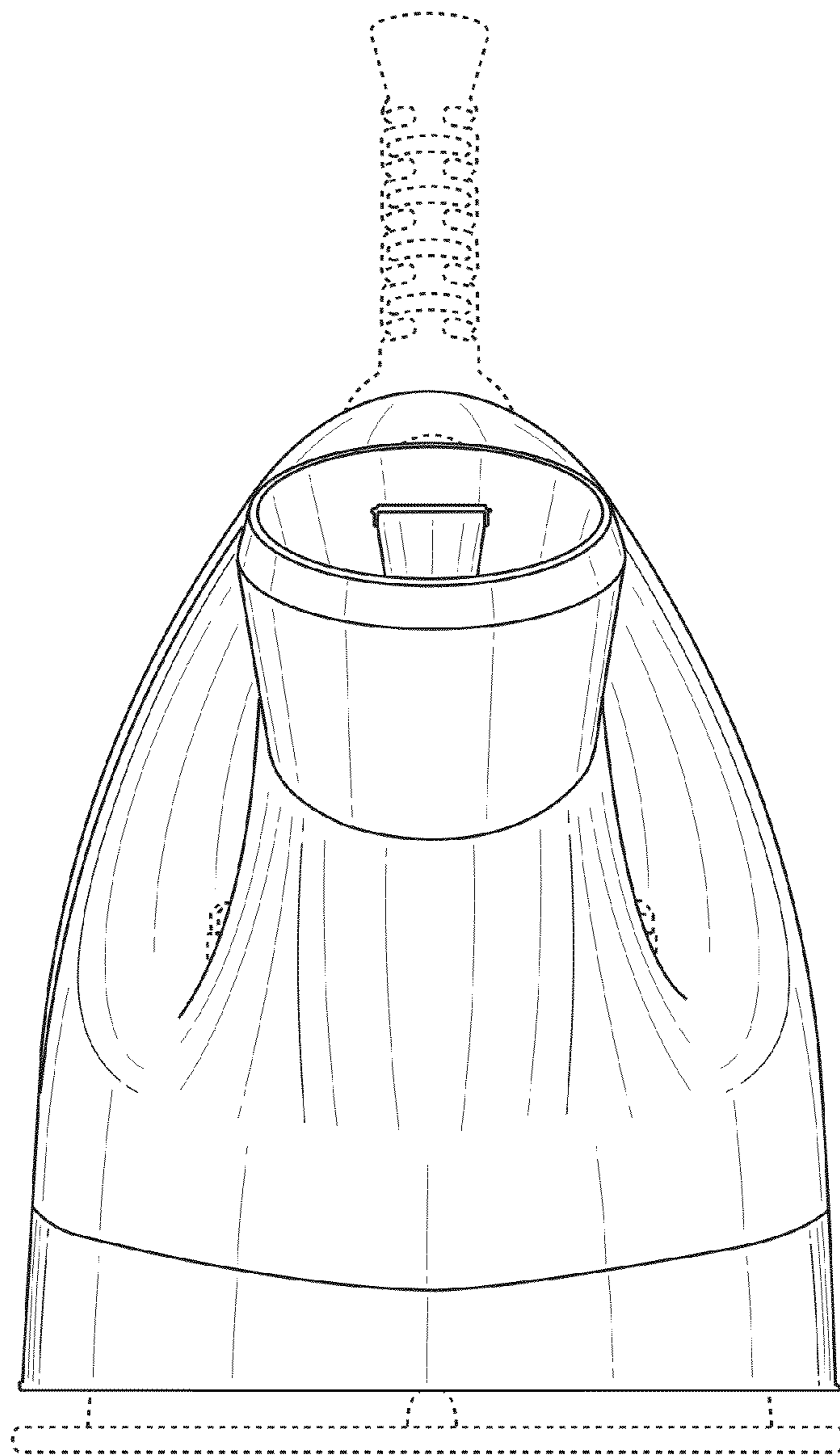

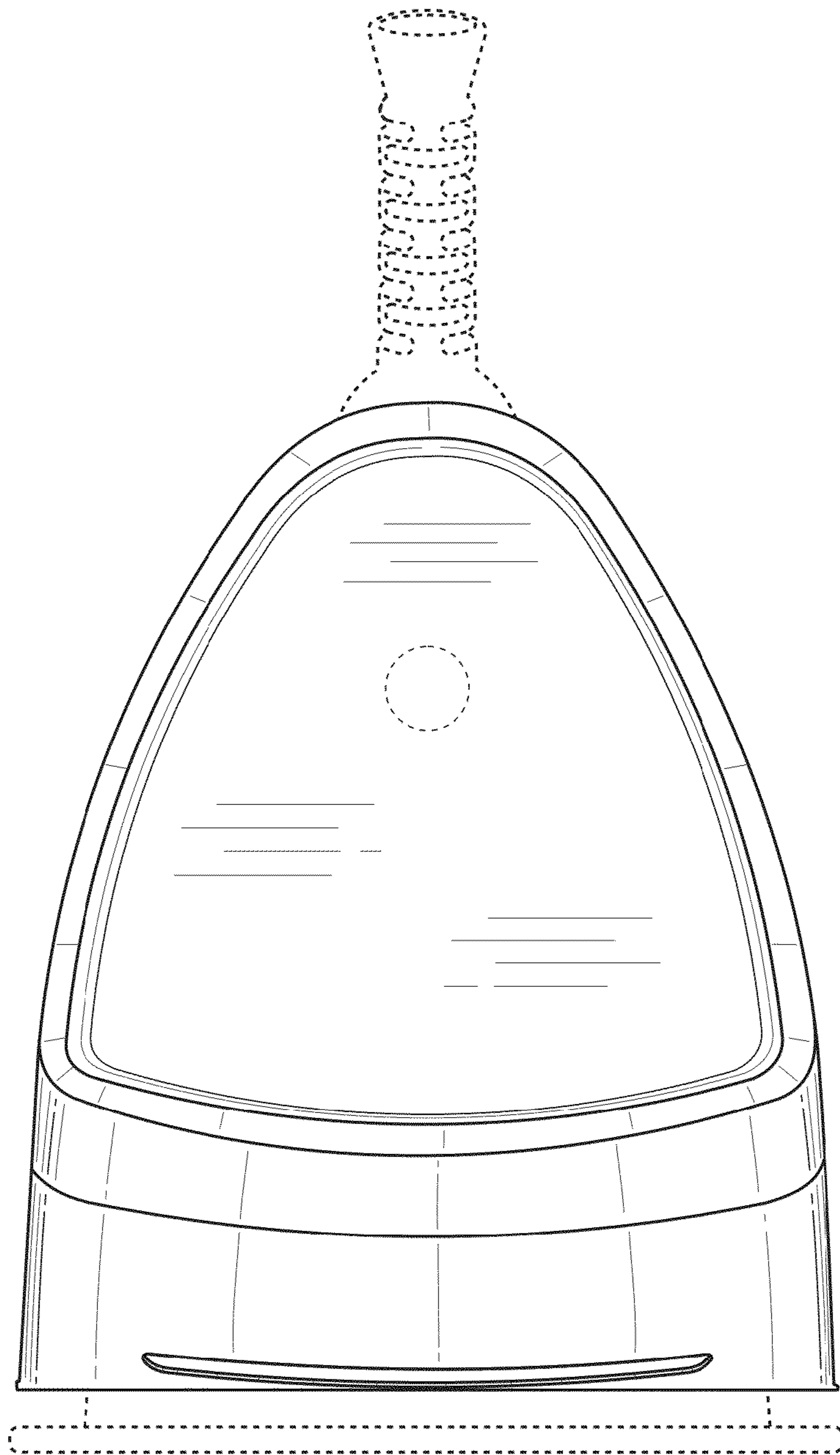
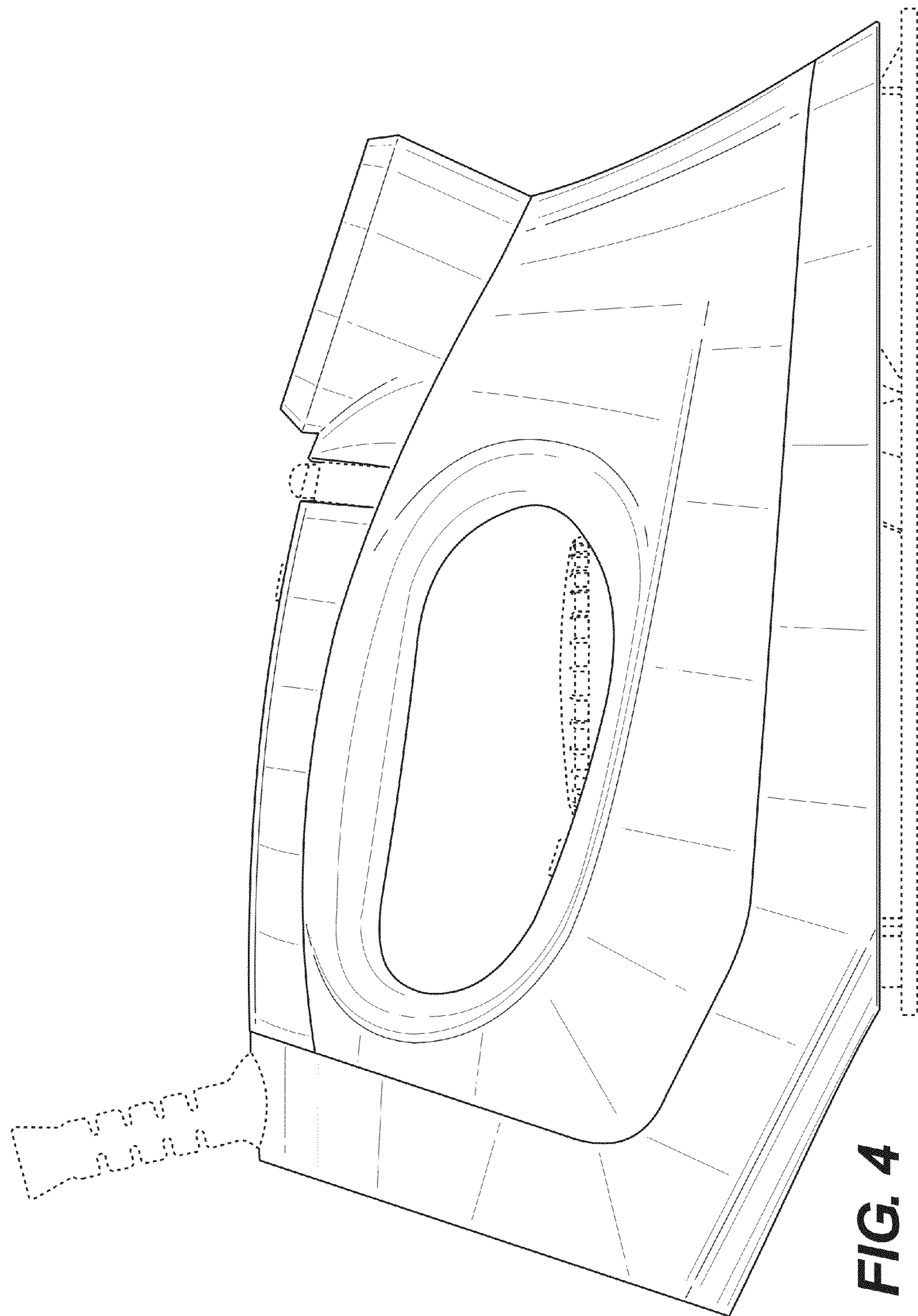
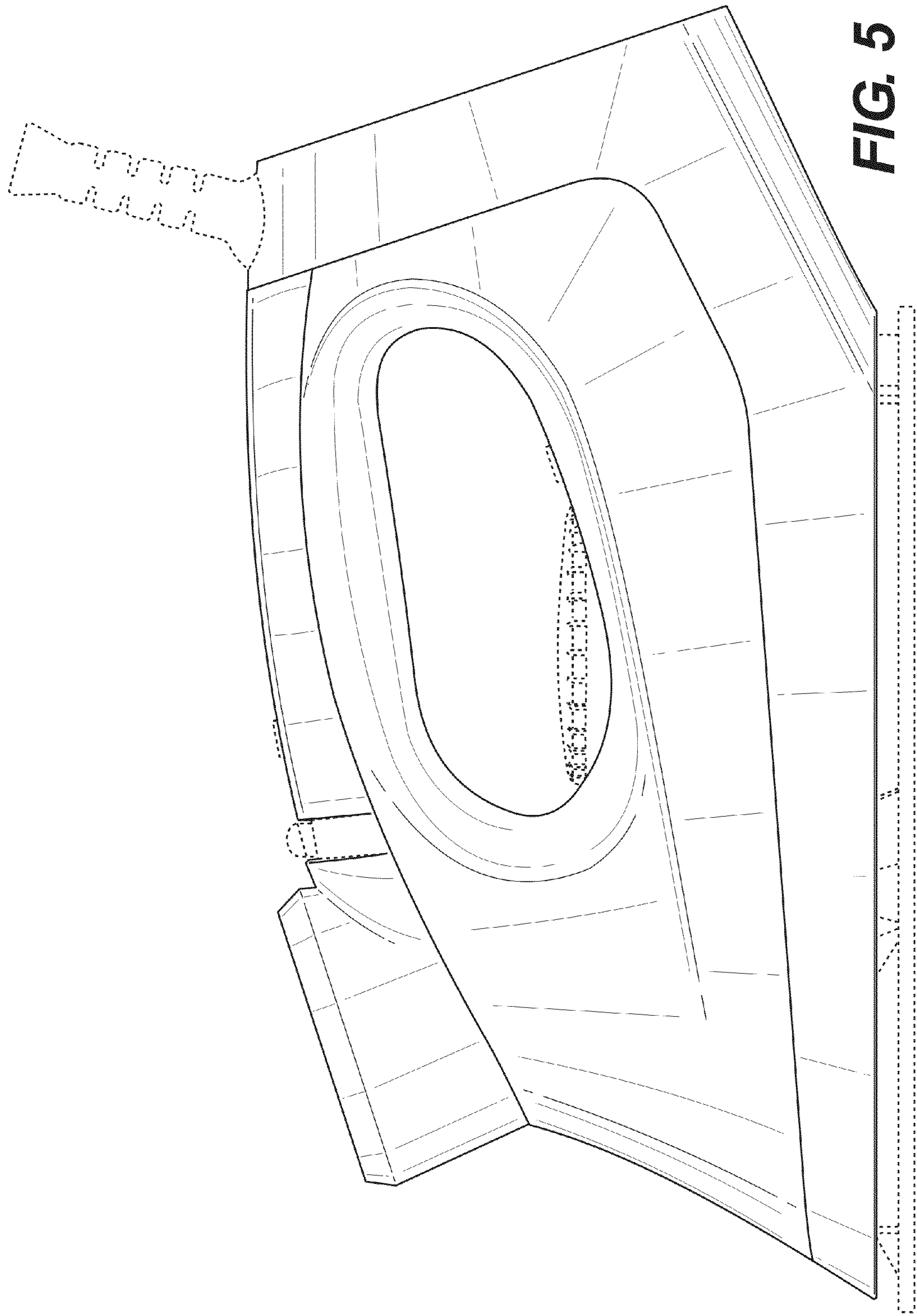

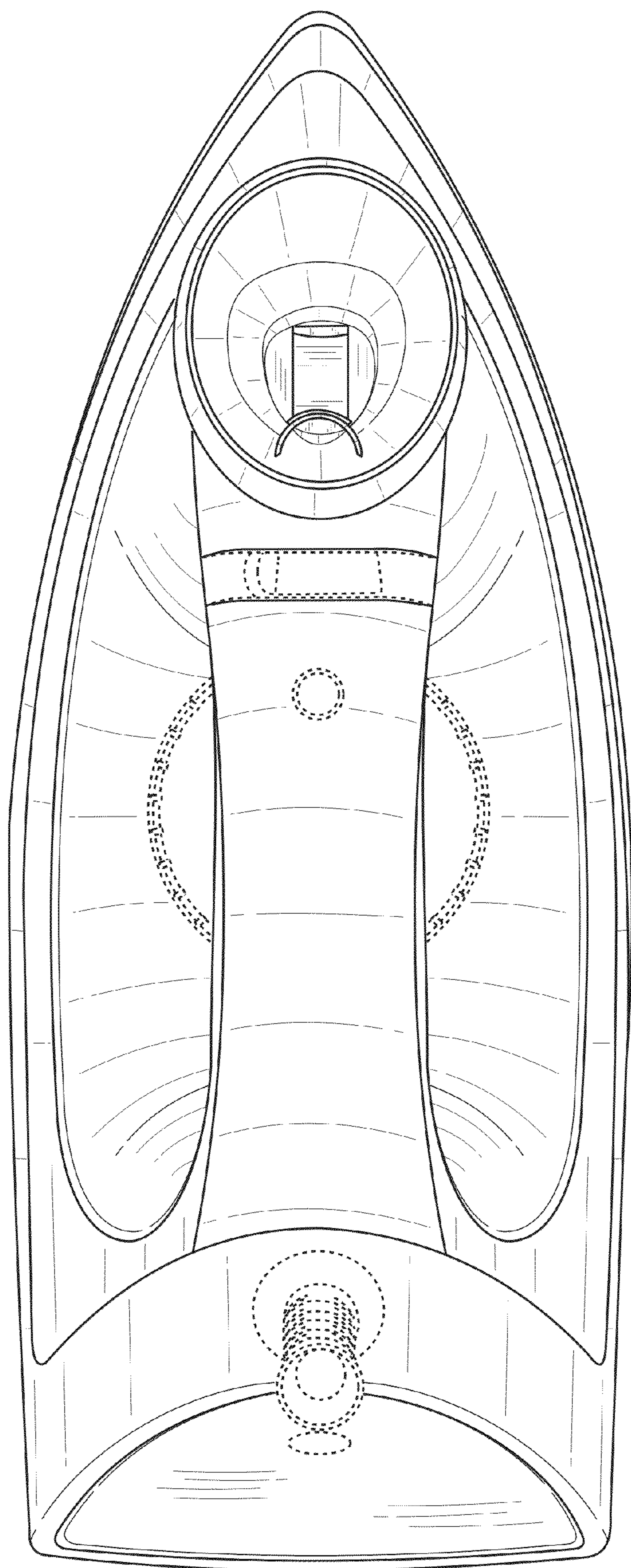

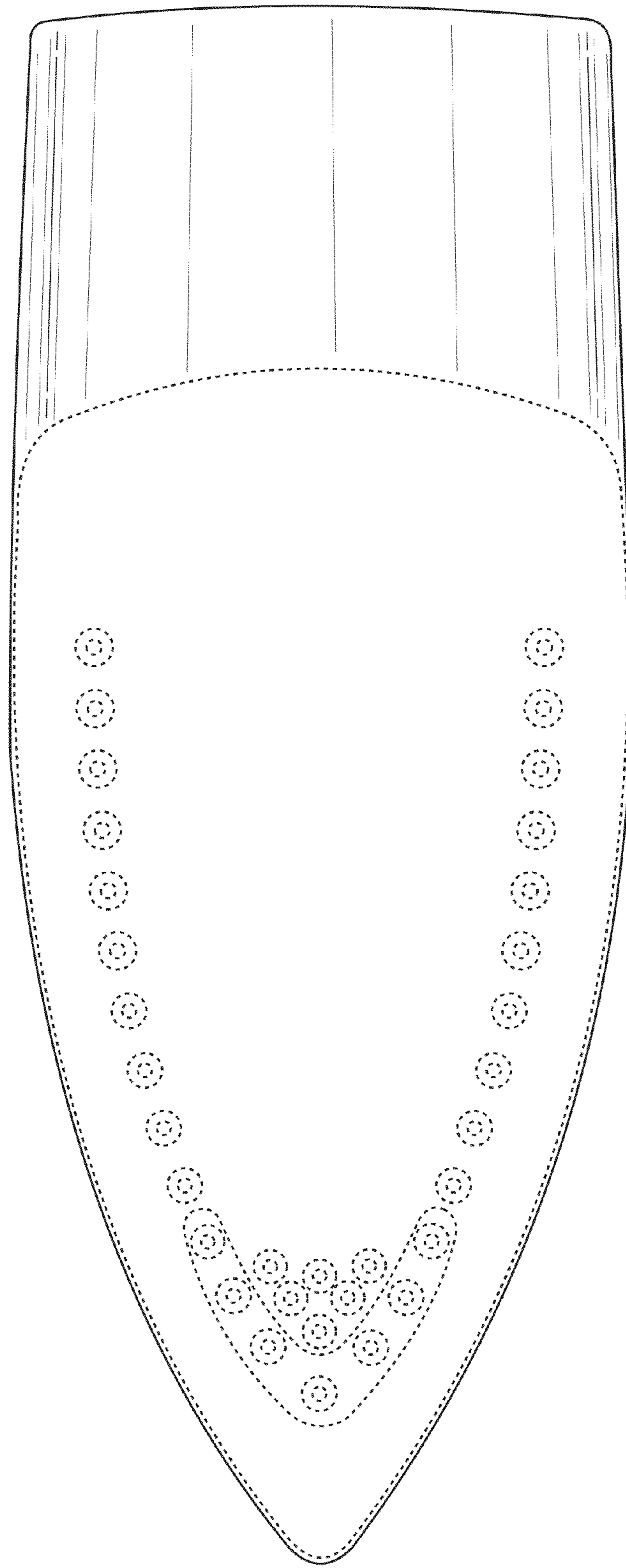
