DESCRIPTION

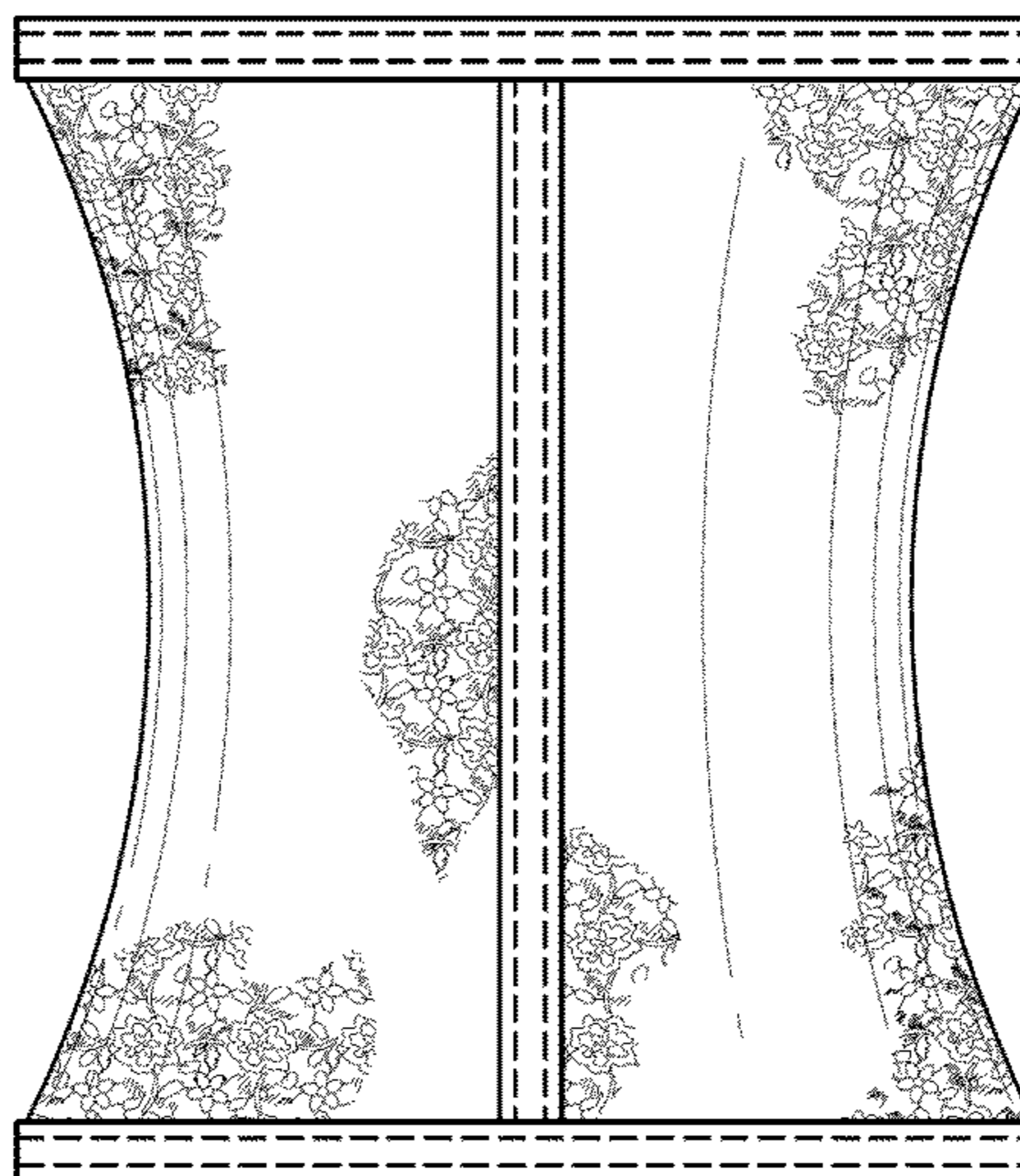
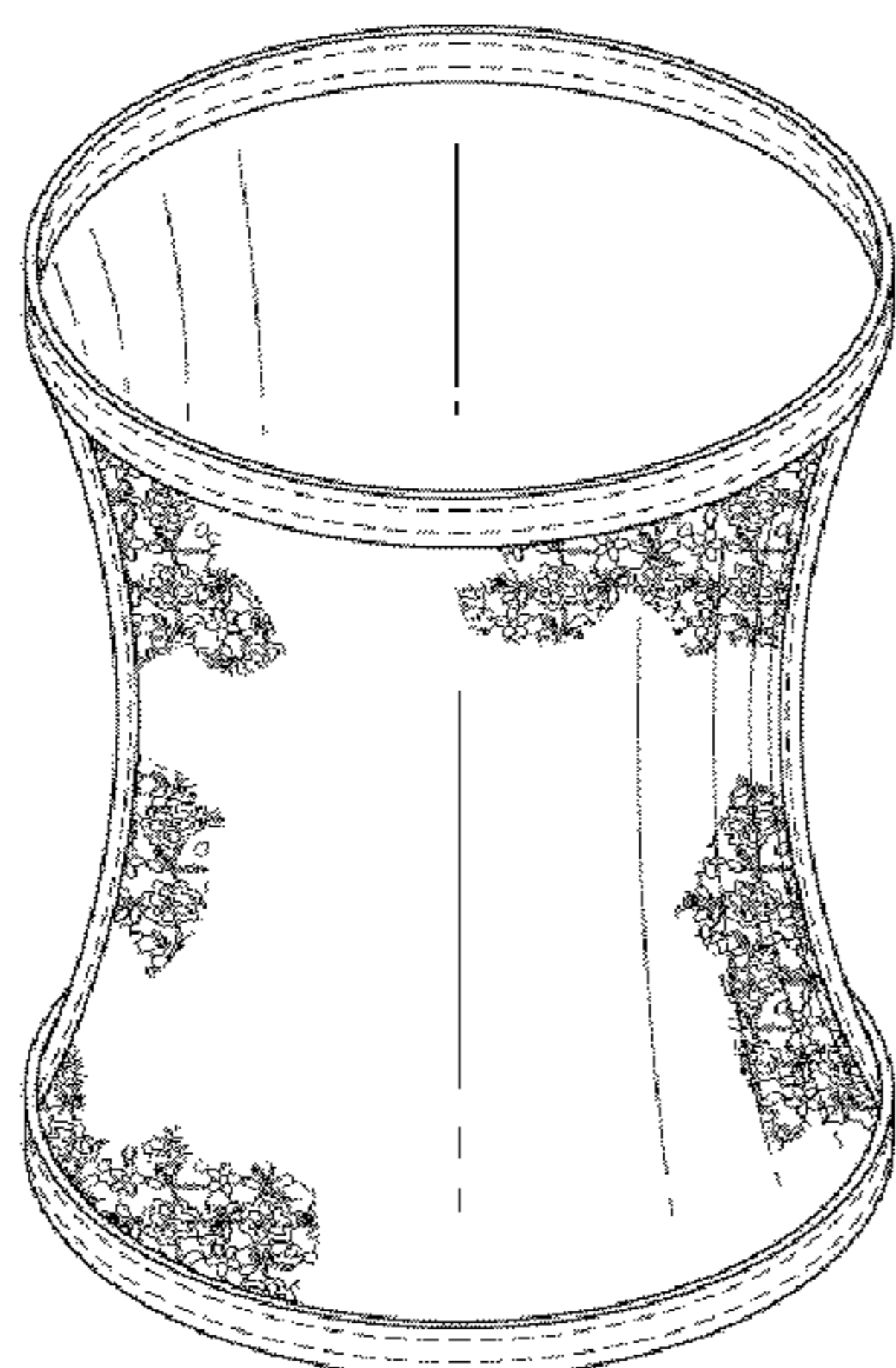
FIG. 1 is a perspective view thereof,

FIG. 4 is a top side view thereof; and,
FIG. 5 is an enlarged detail view of the back side thereof.
The bottom side is symmetrical to the top side, and the right and left sides are symmetrical to the front and back sides. The broken lines shown on the layered midriff defining garment is stitching and forms part of the claimed design.

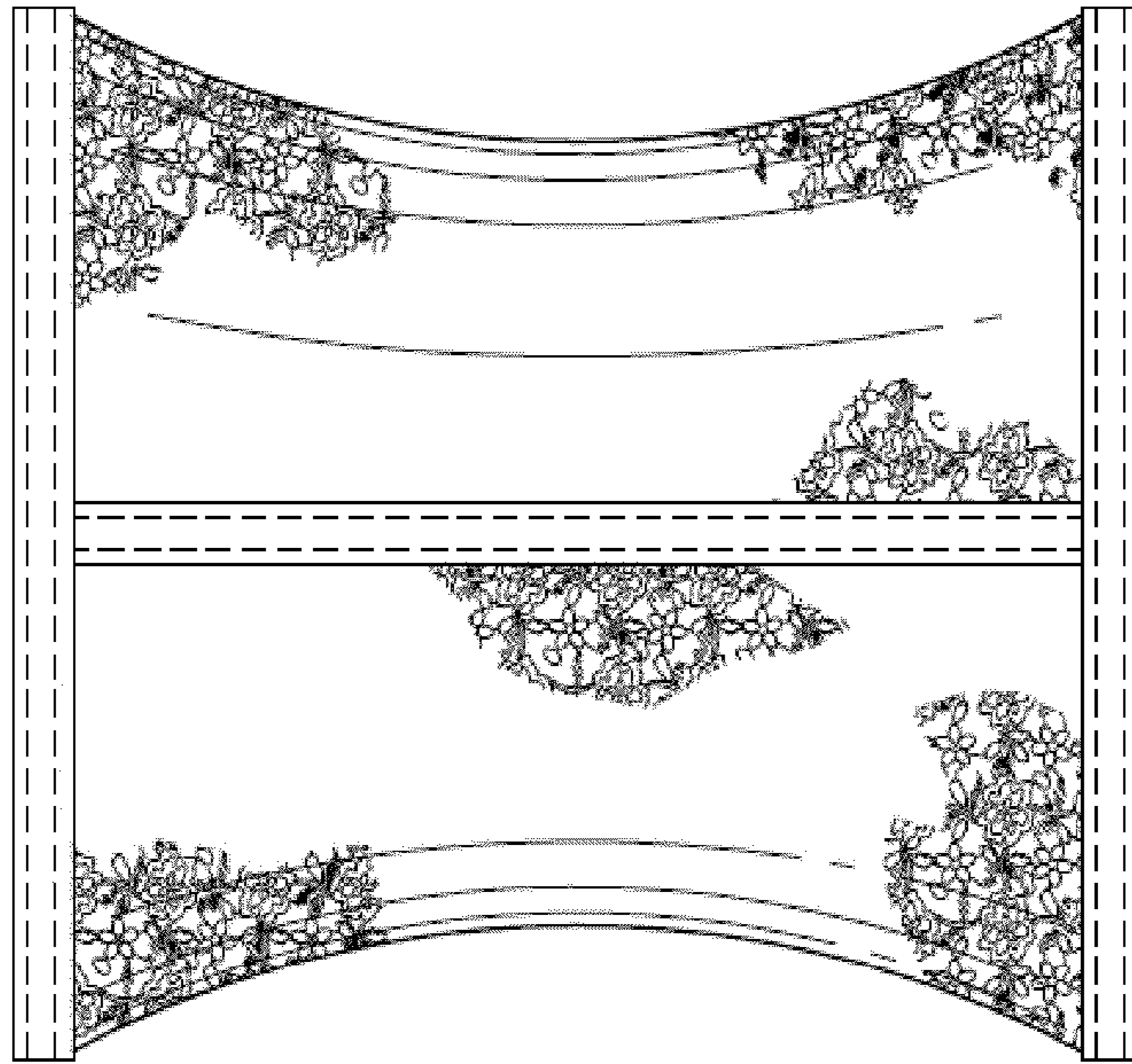

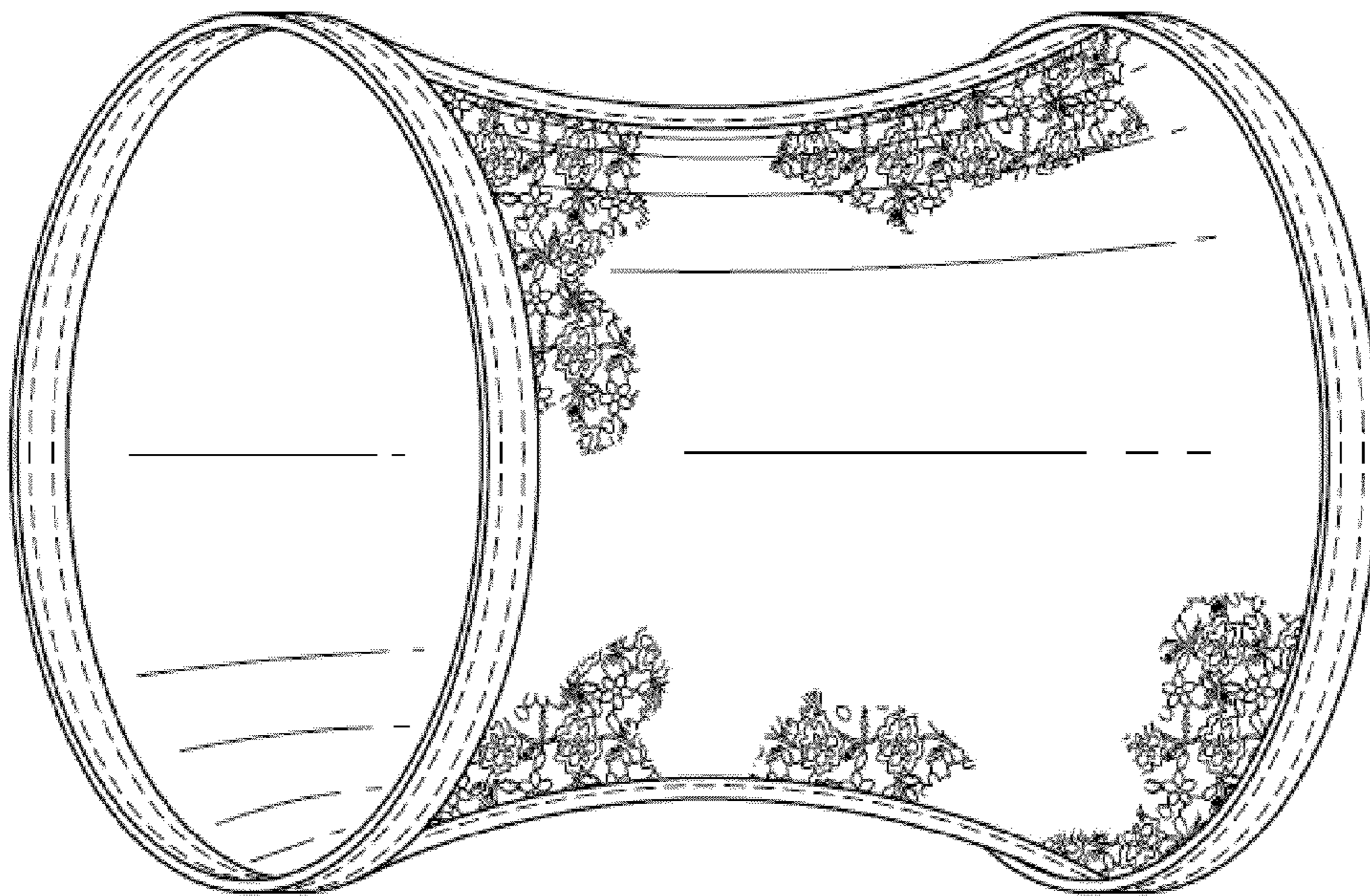

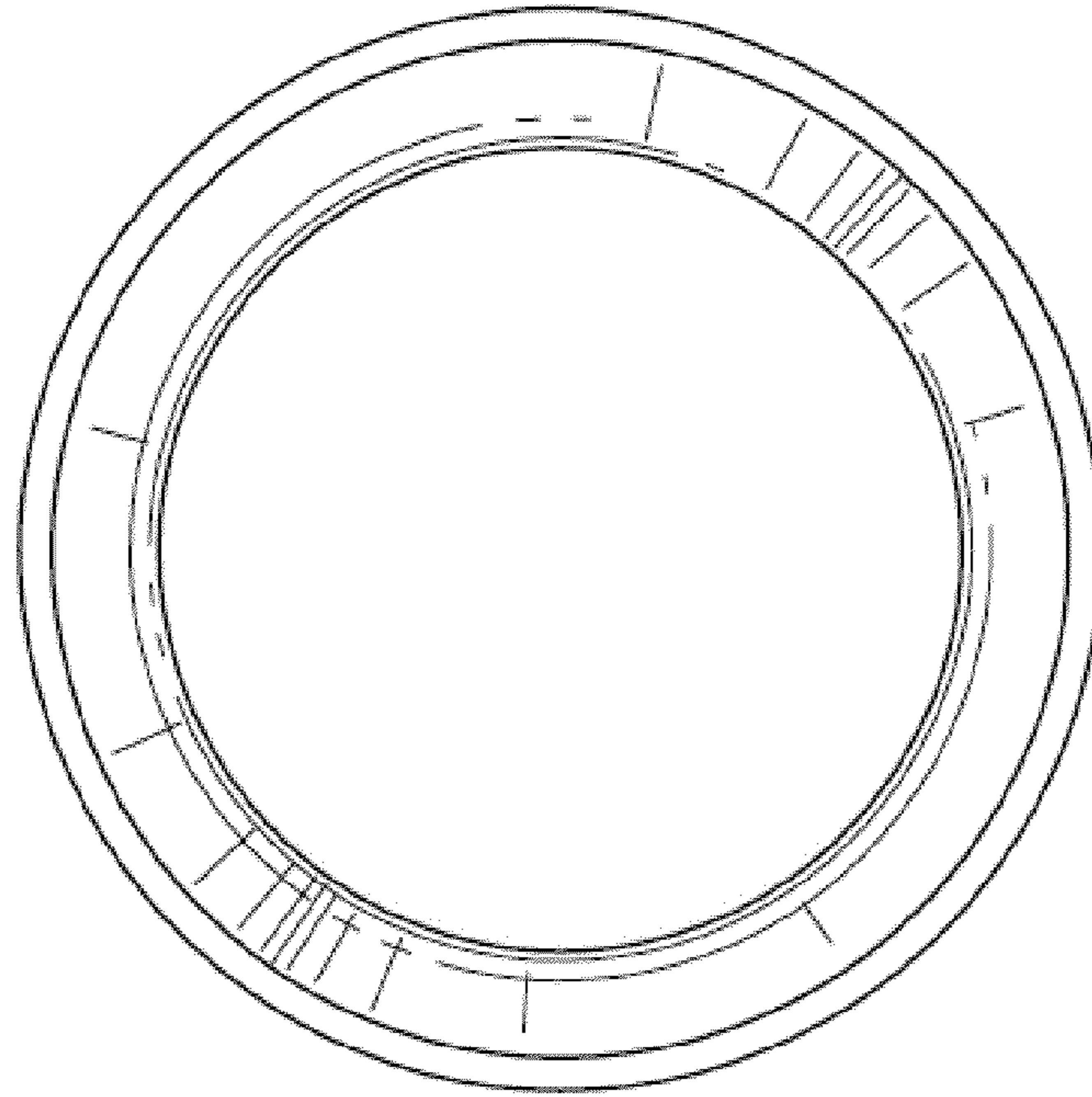

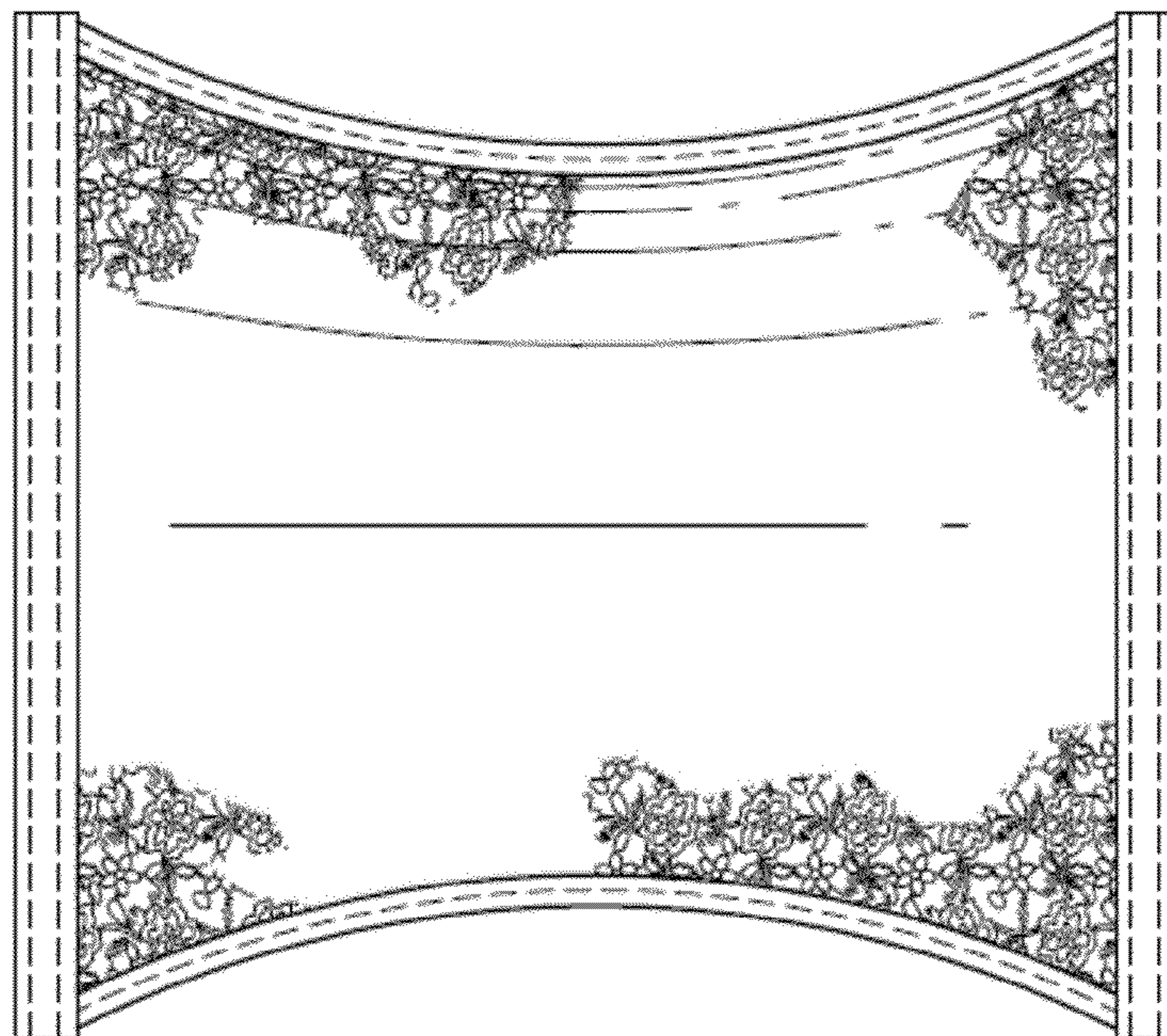

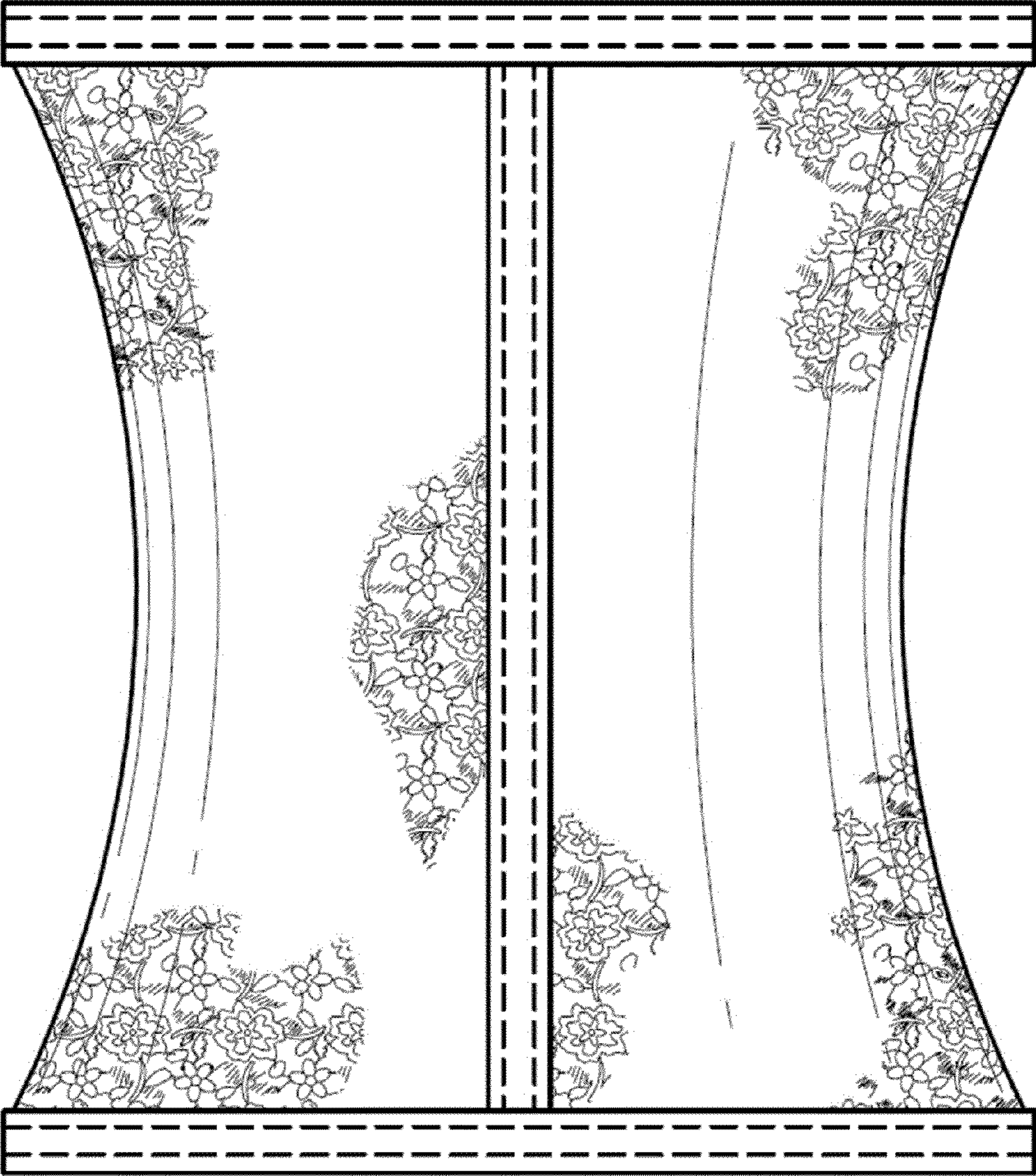
