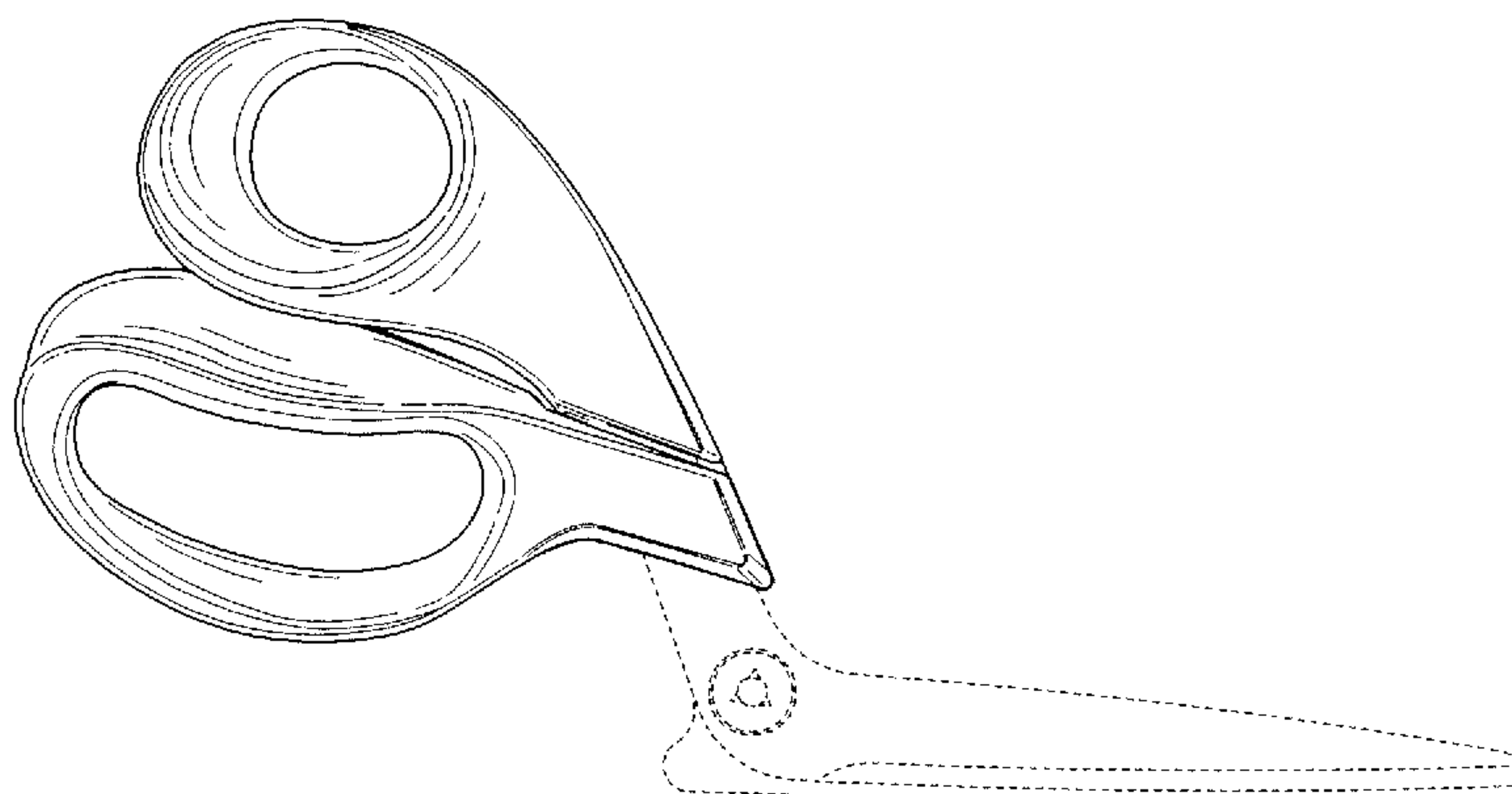
(57) **CLAIM**  
We claim the ornamental design for a set of handles for a cutting instrument, as shown and described.

**DESCRIPTION**

FIG. 1 is a first front isometric view of a first embodiment of a set of handles for a cutting instrument; FIG. 2 is a left side elevational view thereof; FIG. 3 is a right side elevational view thereof; FIG. 4 is a top plan view thereof; FIG. 5 is a bottom plan view thereof; FIG. 6 is a front elevational view thereof; FIG. 7 is a rear elevational view thereof; and, FIG. 8 is a second front isometric view thereof. The broken line showing of the blades illustrates the environment of the claimed design and forms no part thereof. The broken line showing of portions of the handles for a cutting instrument illustrate portions of the handles for a cutting instrument which form no part of the claimed design.

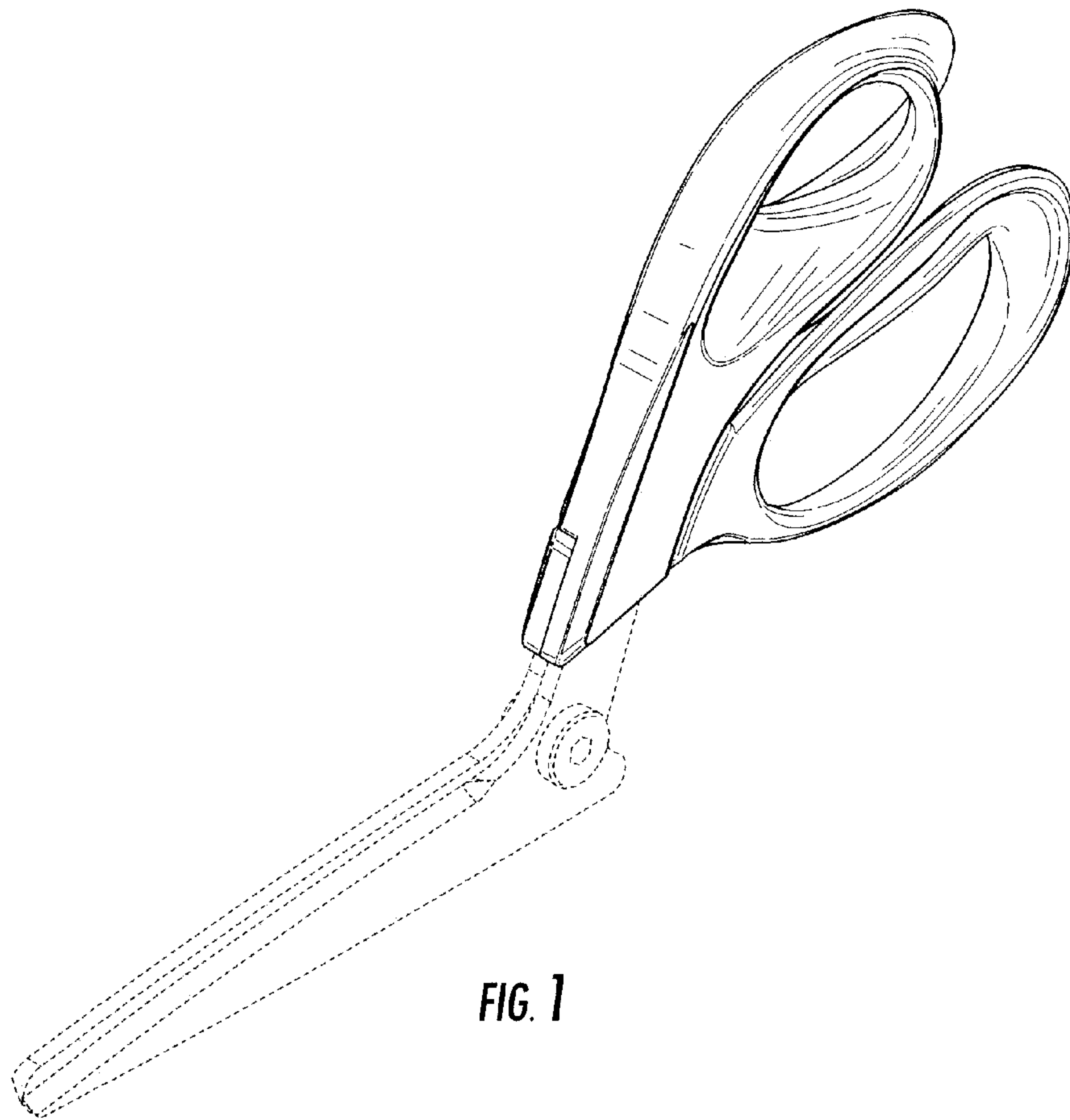

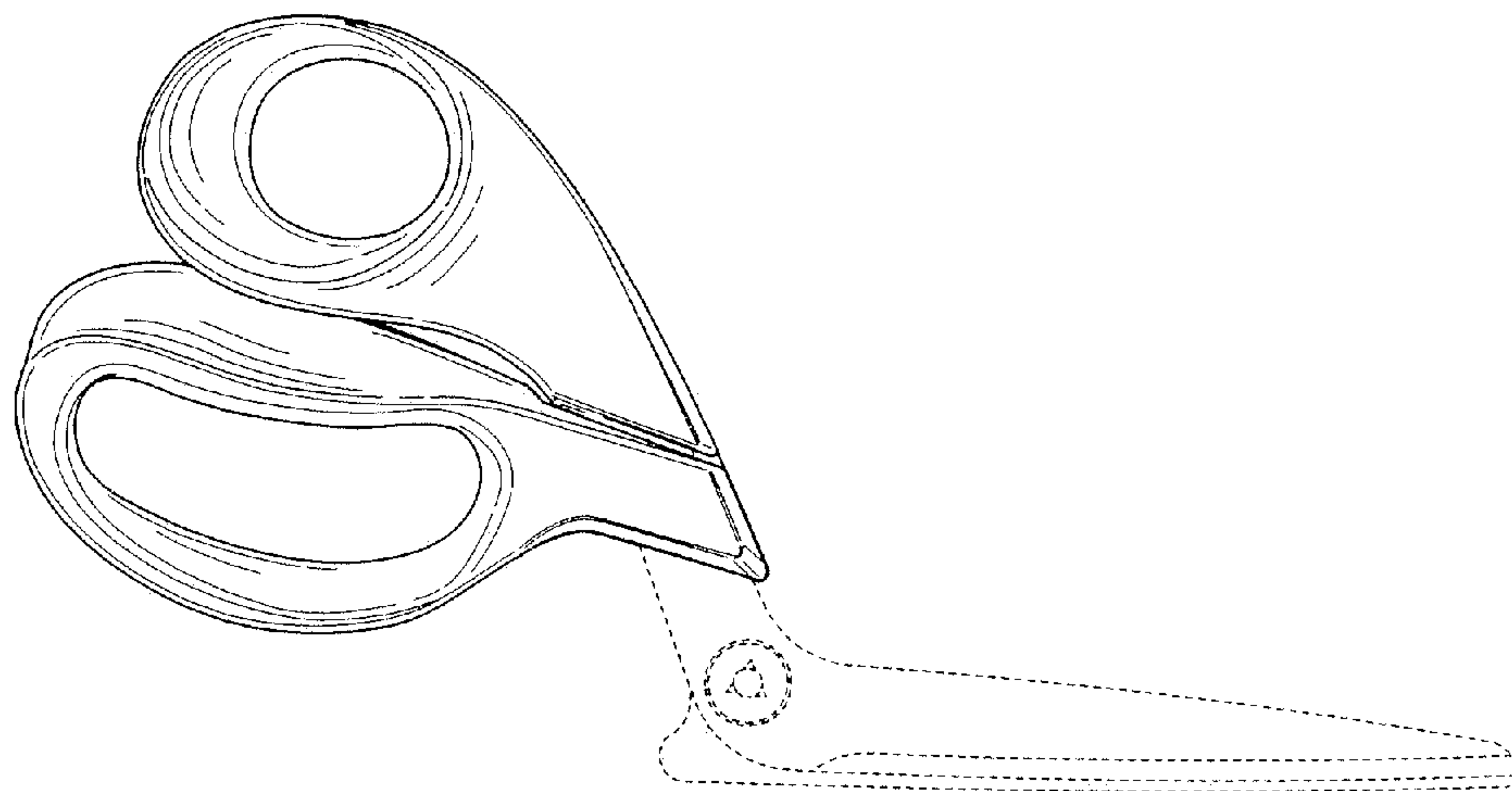

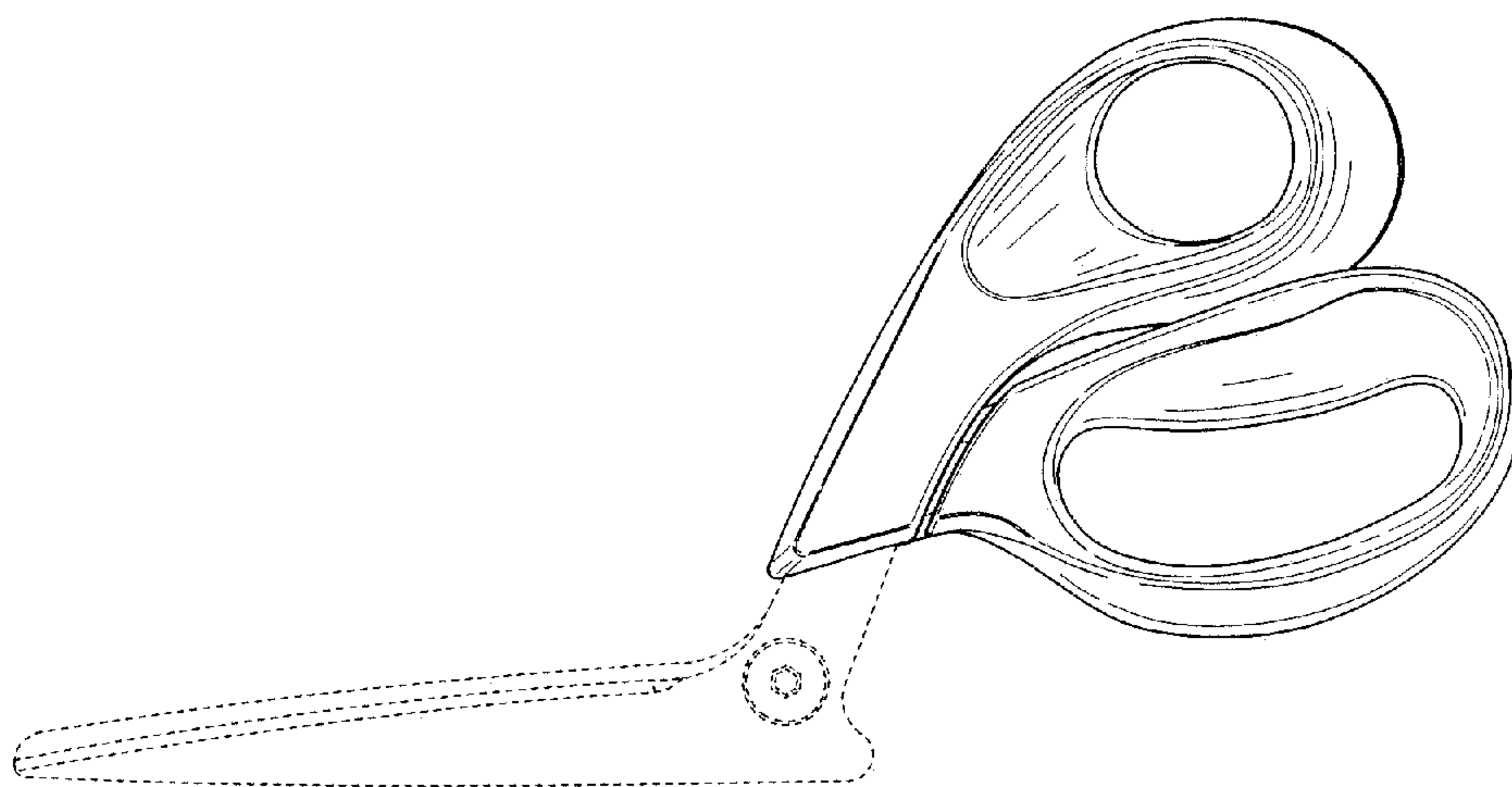

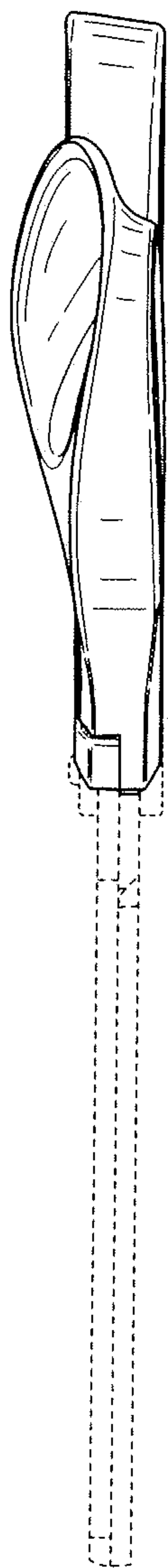
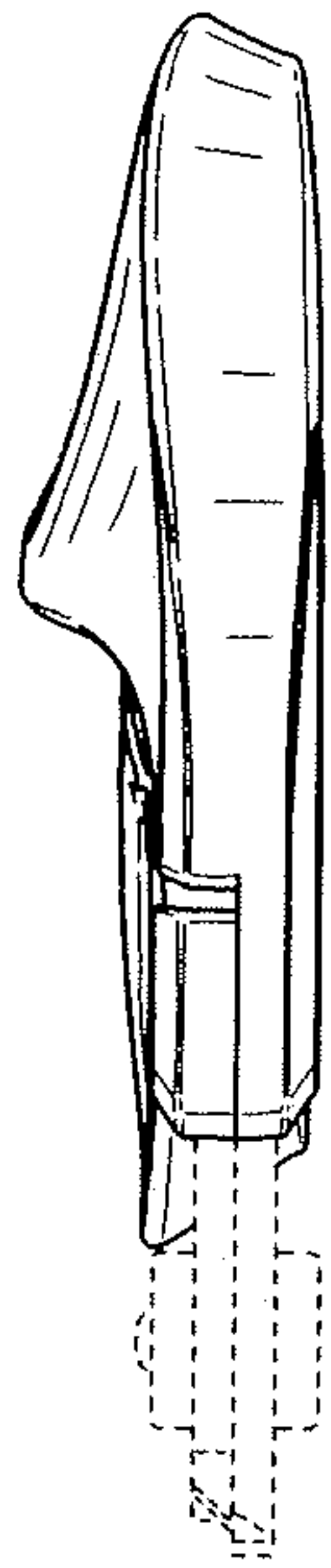


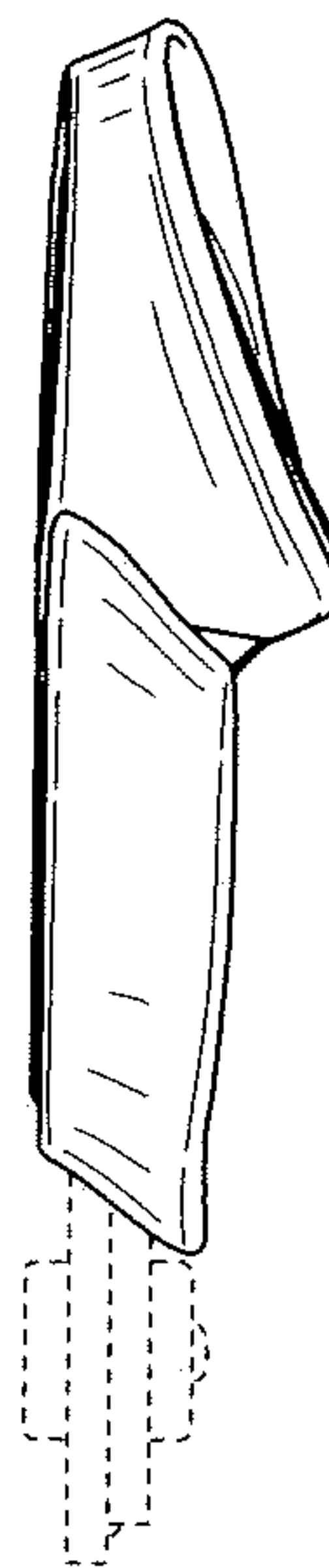

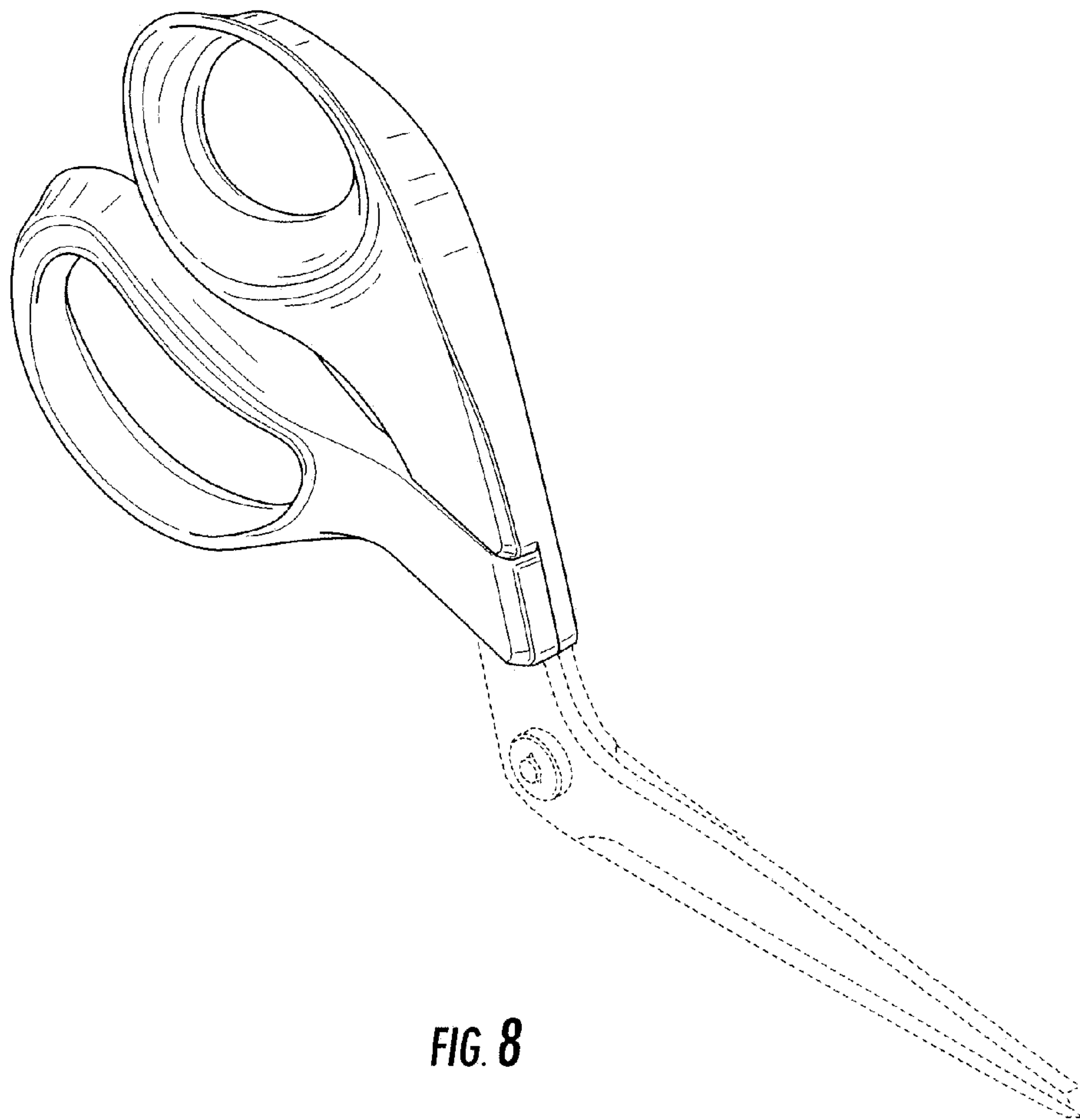
