(57) **CLAIM**

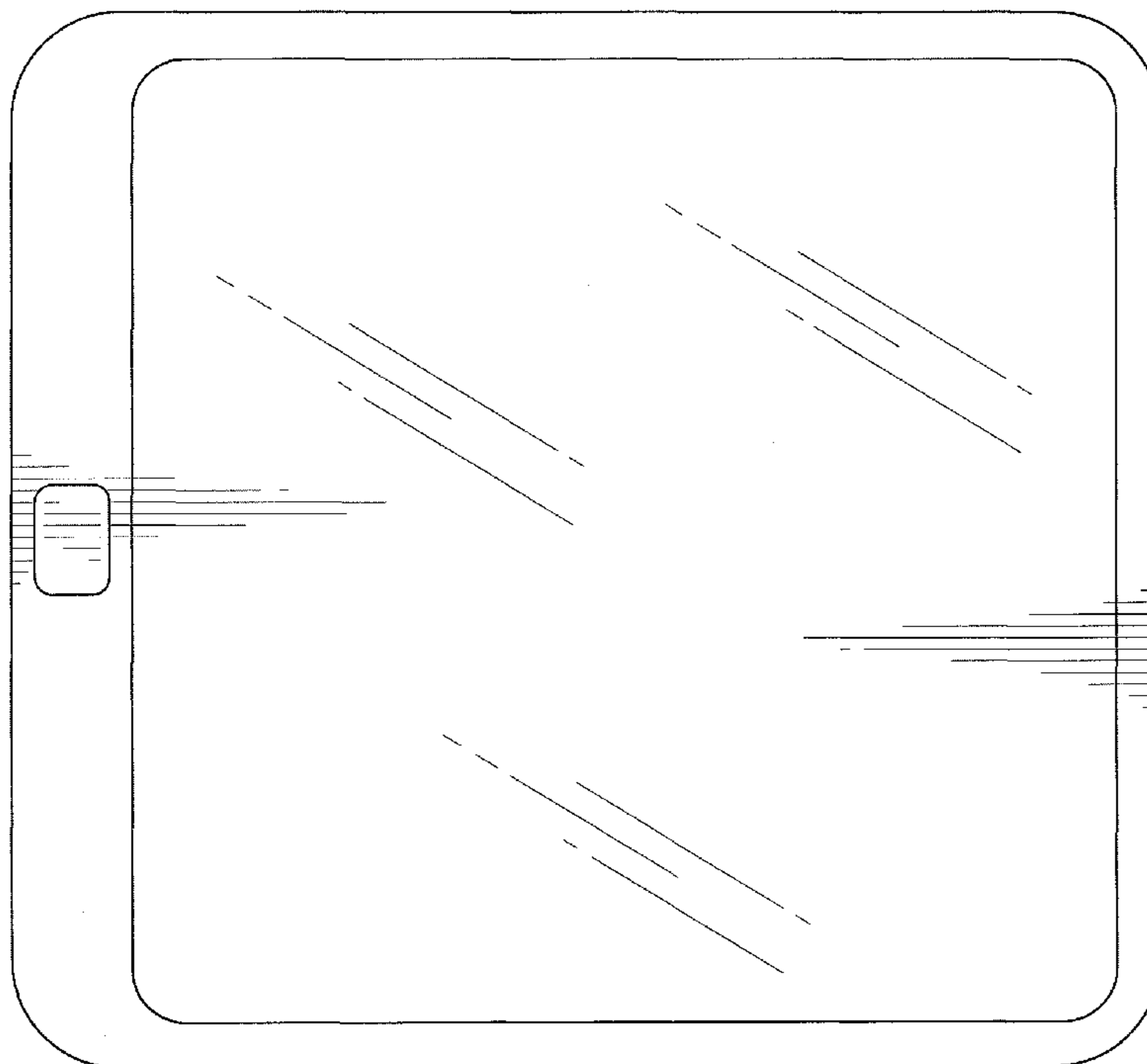
The ornamental design for a bottle lid display, as shown and described.

DESCRIPTION

FIG. 1 is a left side elevation view of a bottle lid display; FIG. 2 is a right side elevation thereof; FIG. 3 is a front elevation view thereof, the rear view being a mirror image; and, FIG. 4 is a top plan view thereof.

The bottom of the bottle lid display is flat and unornamented. The bottle to which the display is attached is partially shown in broken lines for illustrative purposes only and forms no part of the claimed design.

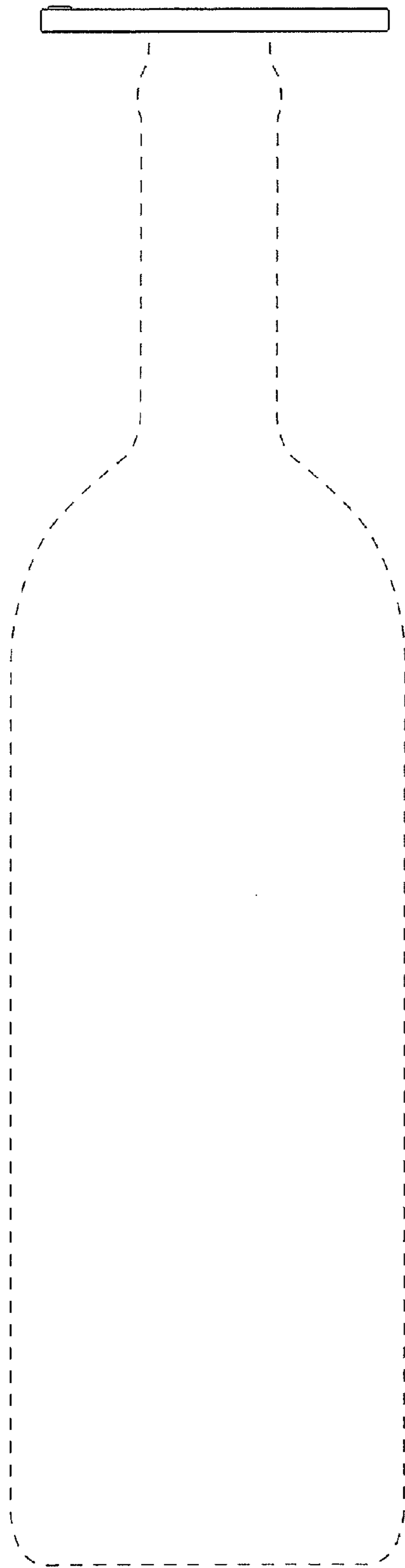

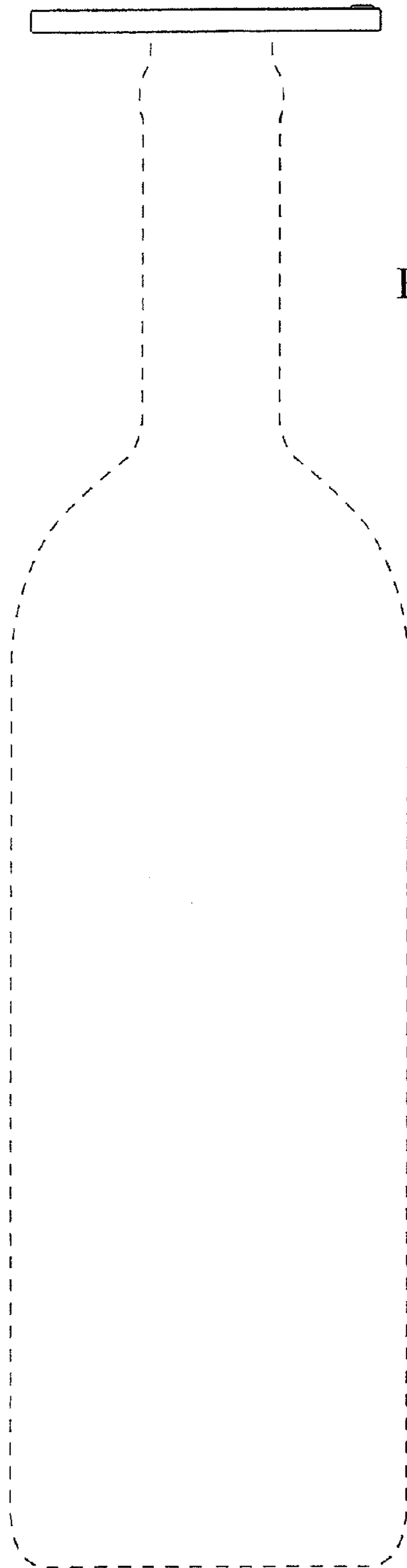

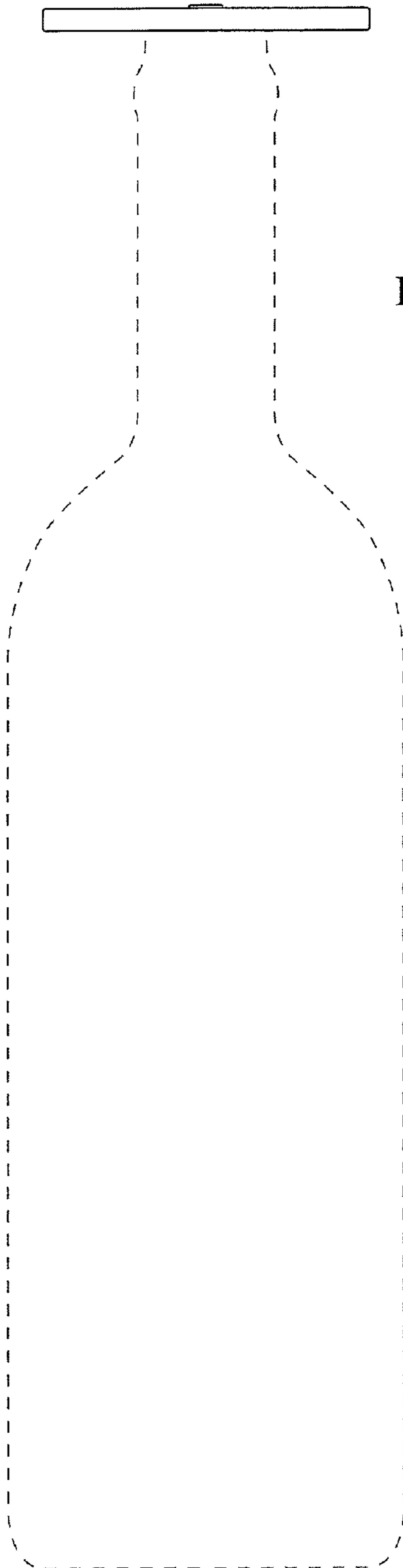
