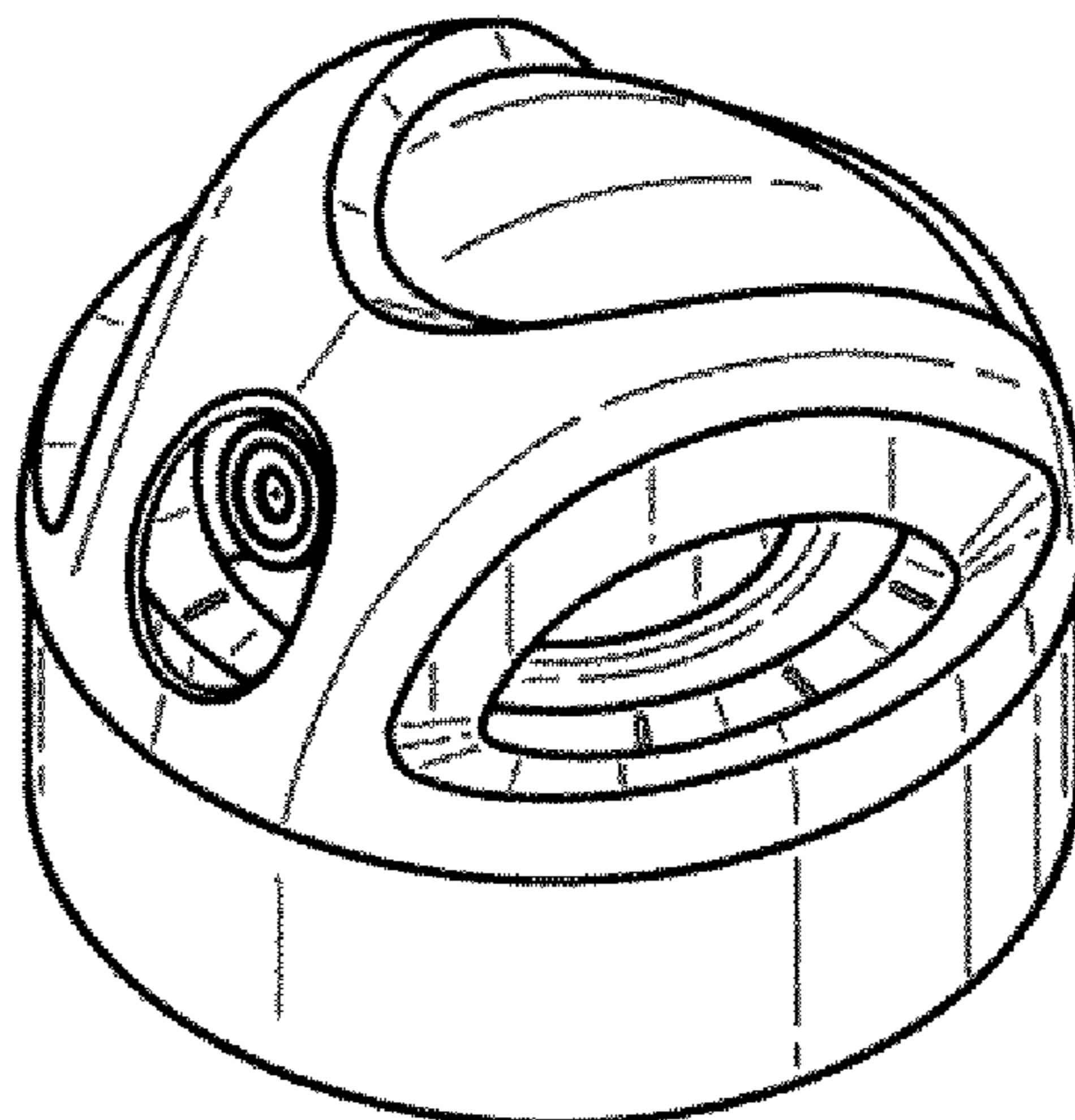

DESCRIPTION

FIG. 1 is a perspective view from the front, above and one side of my aerosol dispenser;

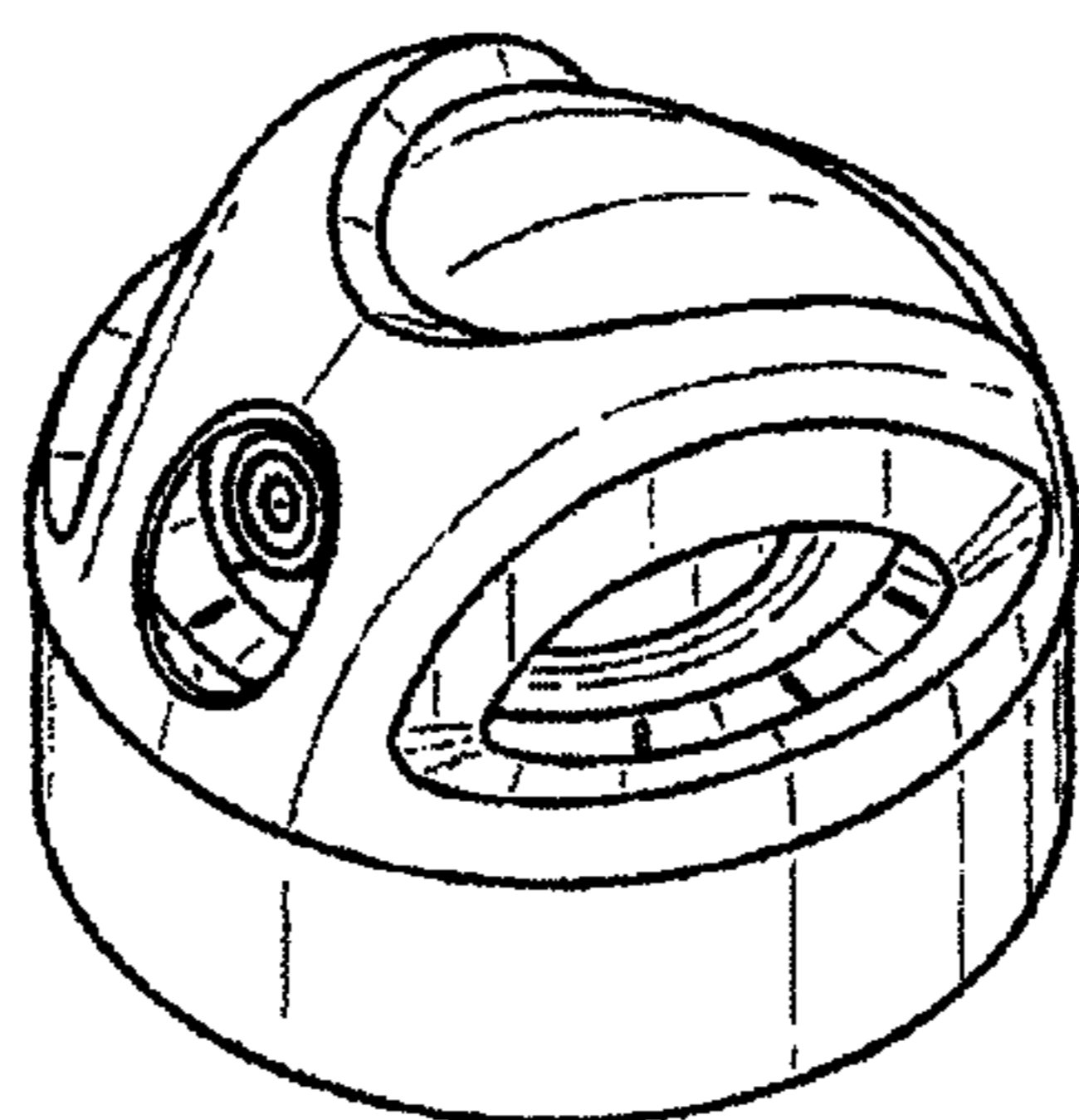

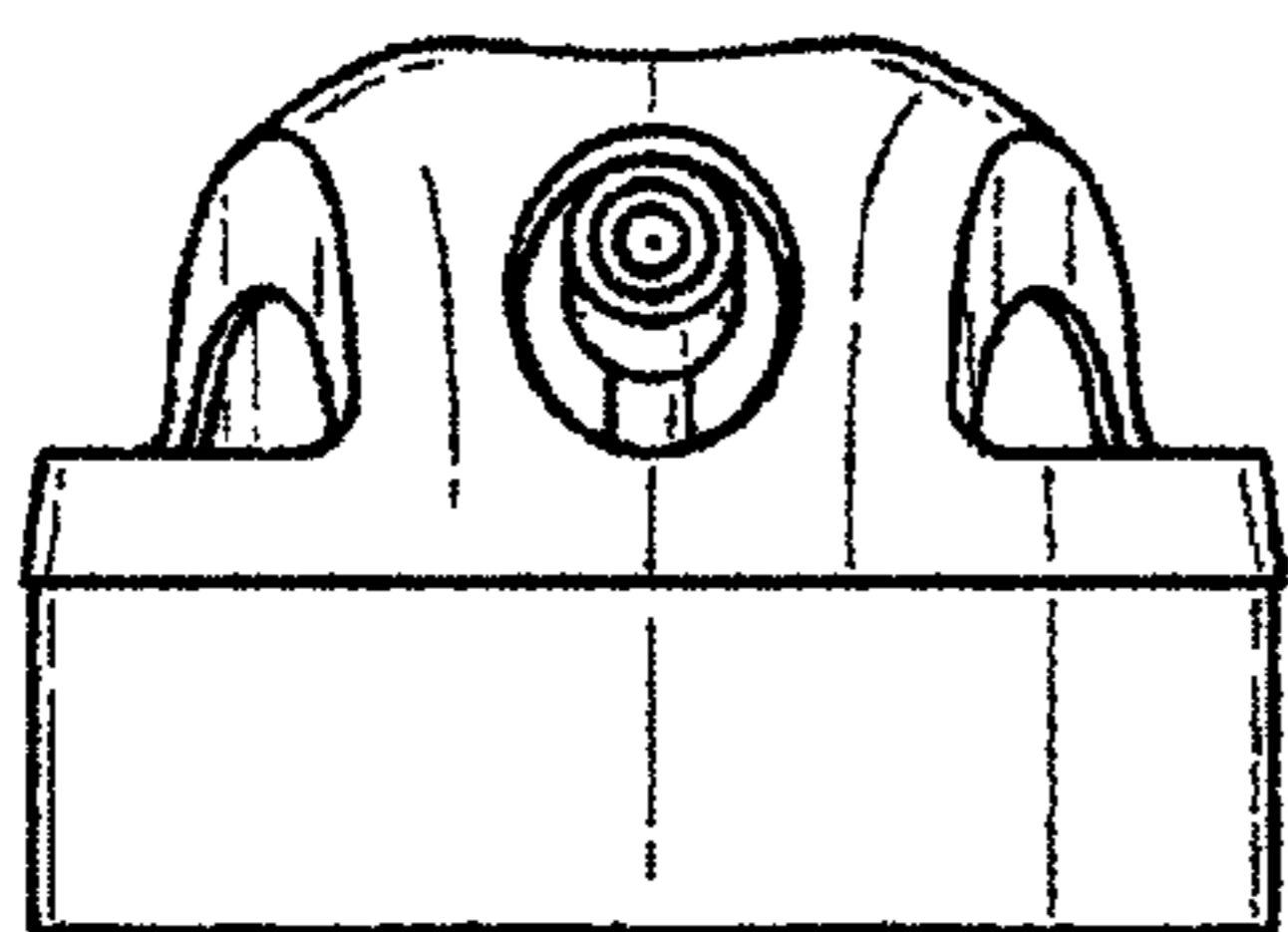

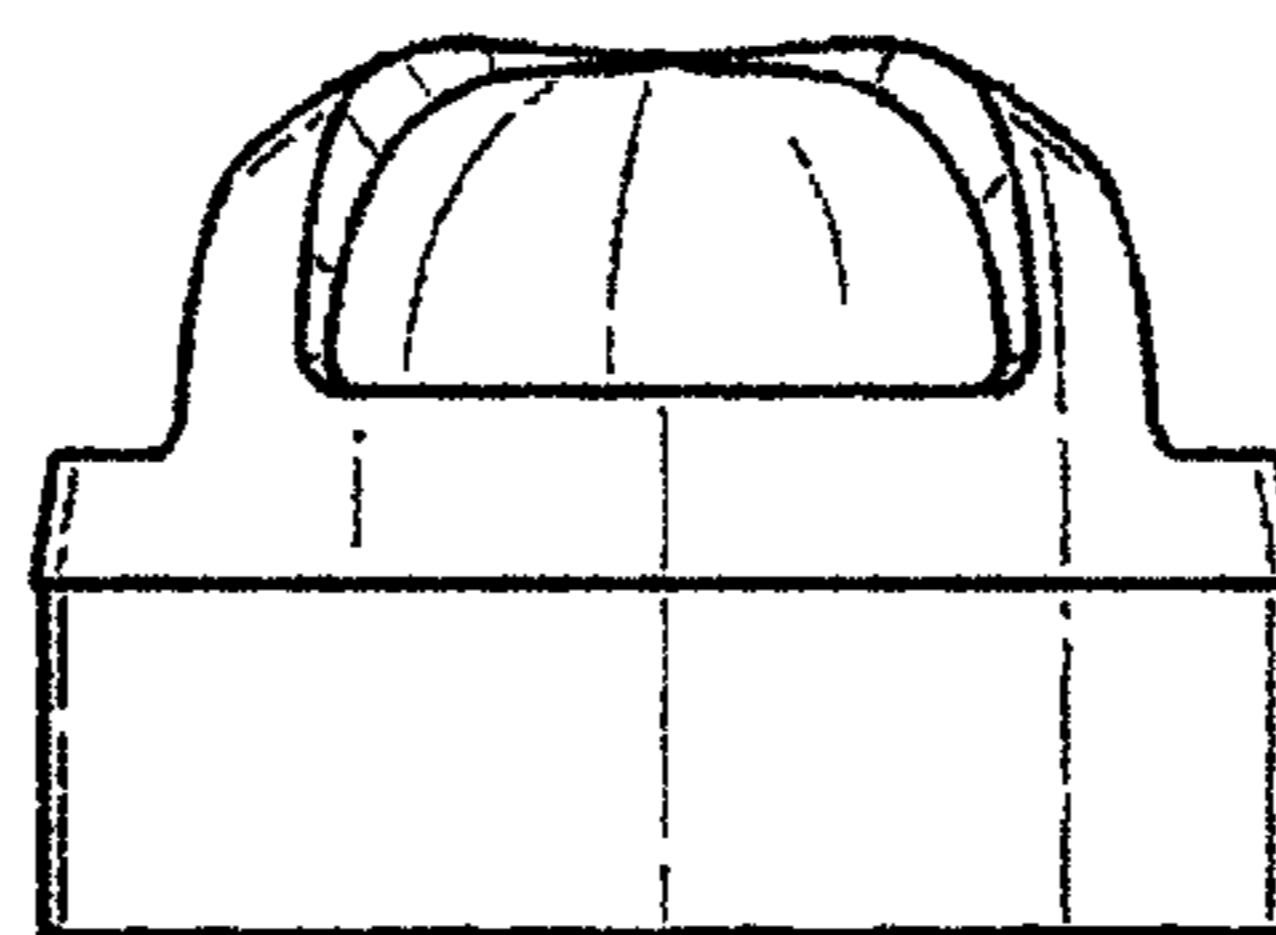

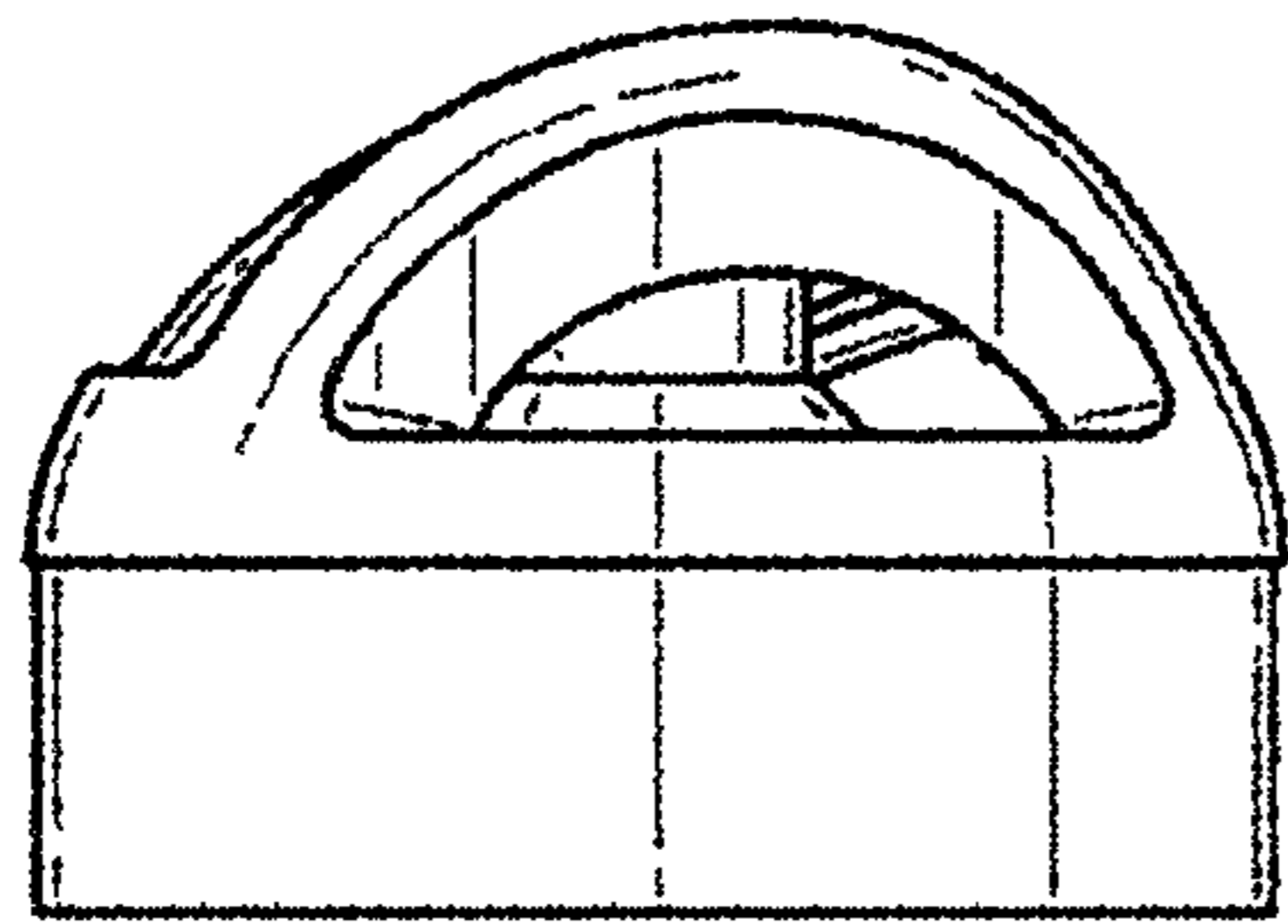

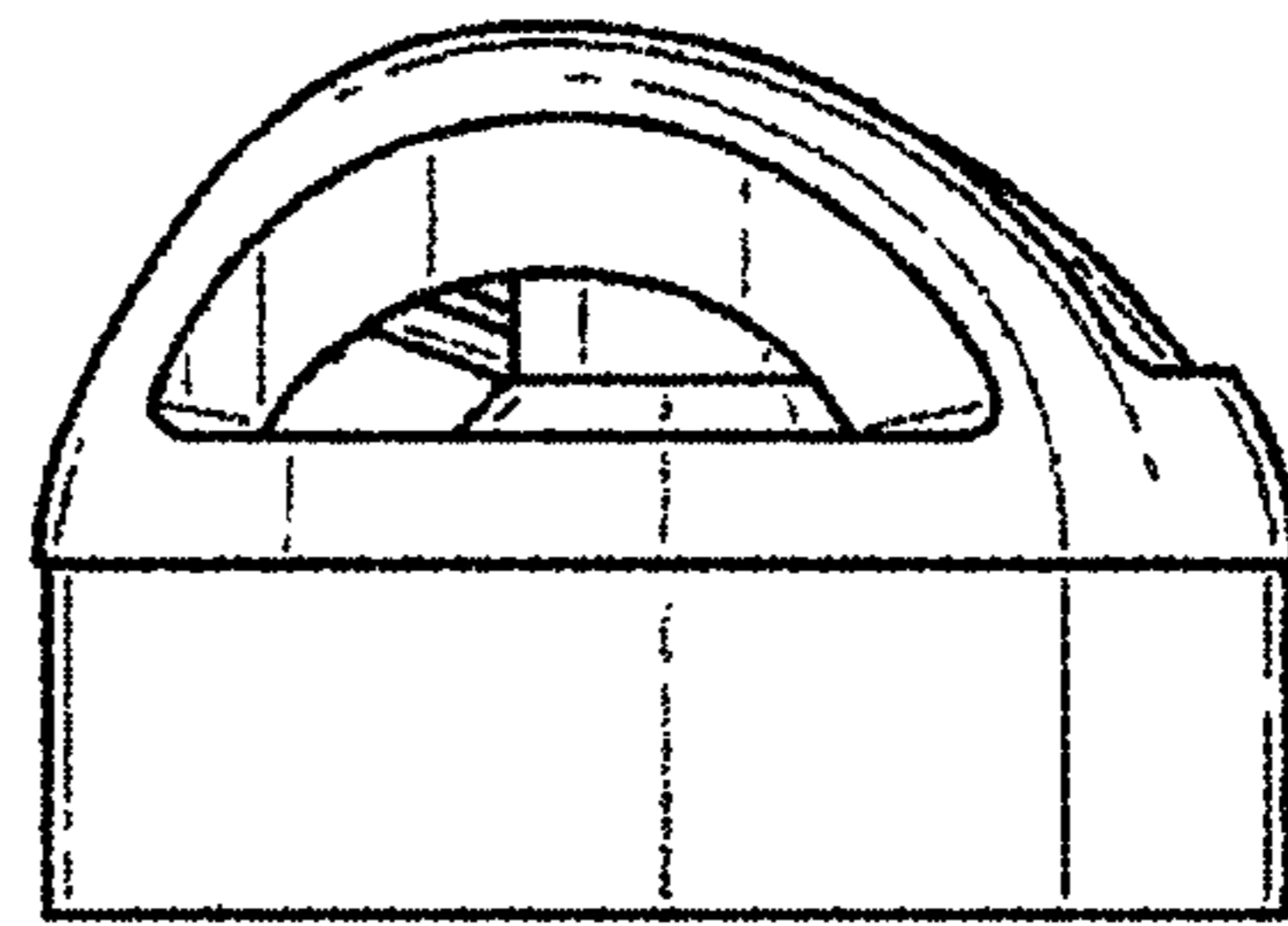

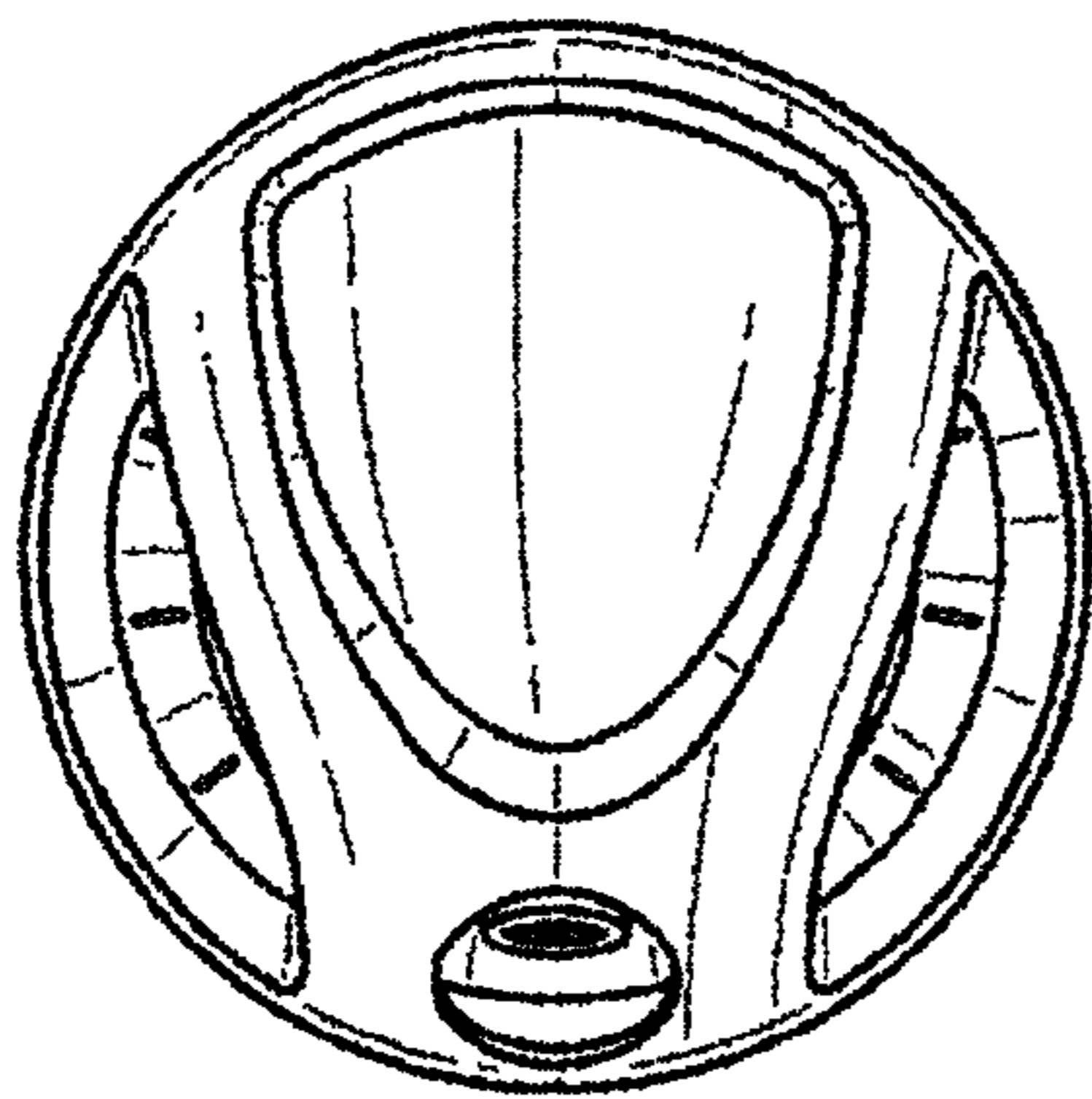

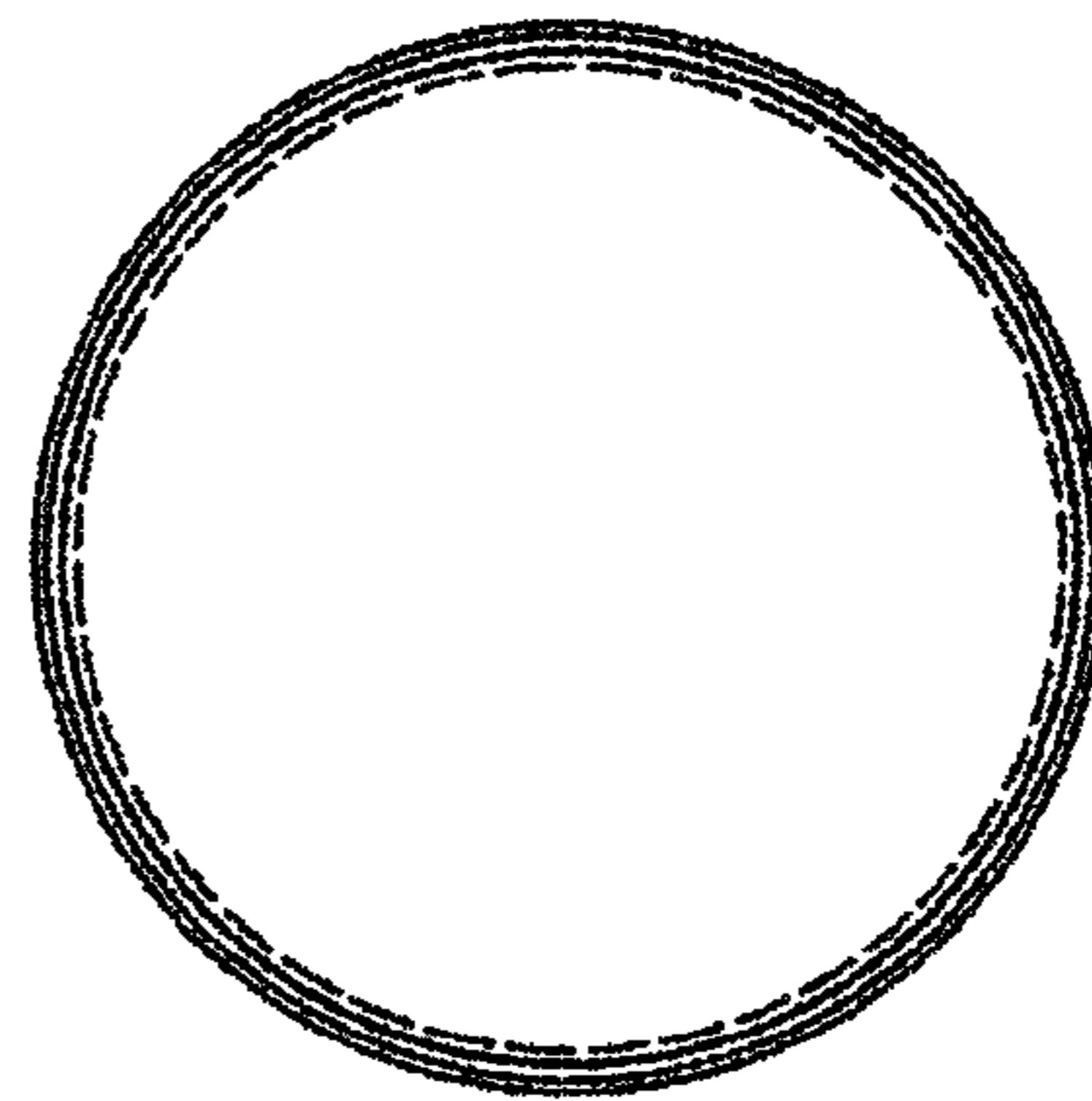
