FIG. 3 is a front perspective view thereof;

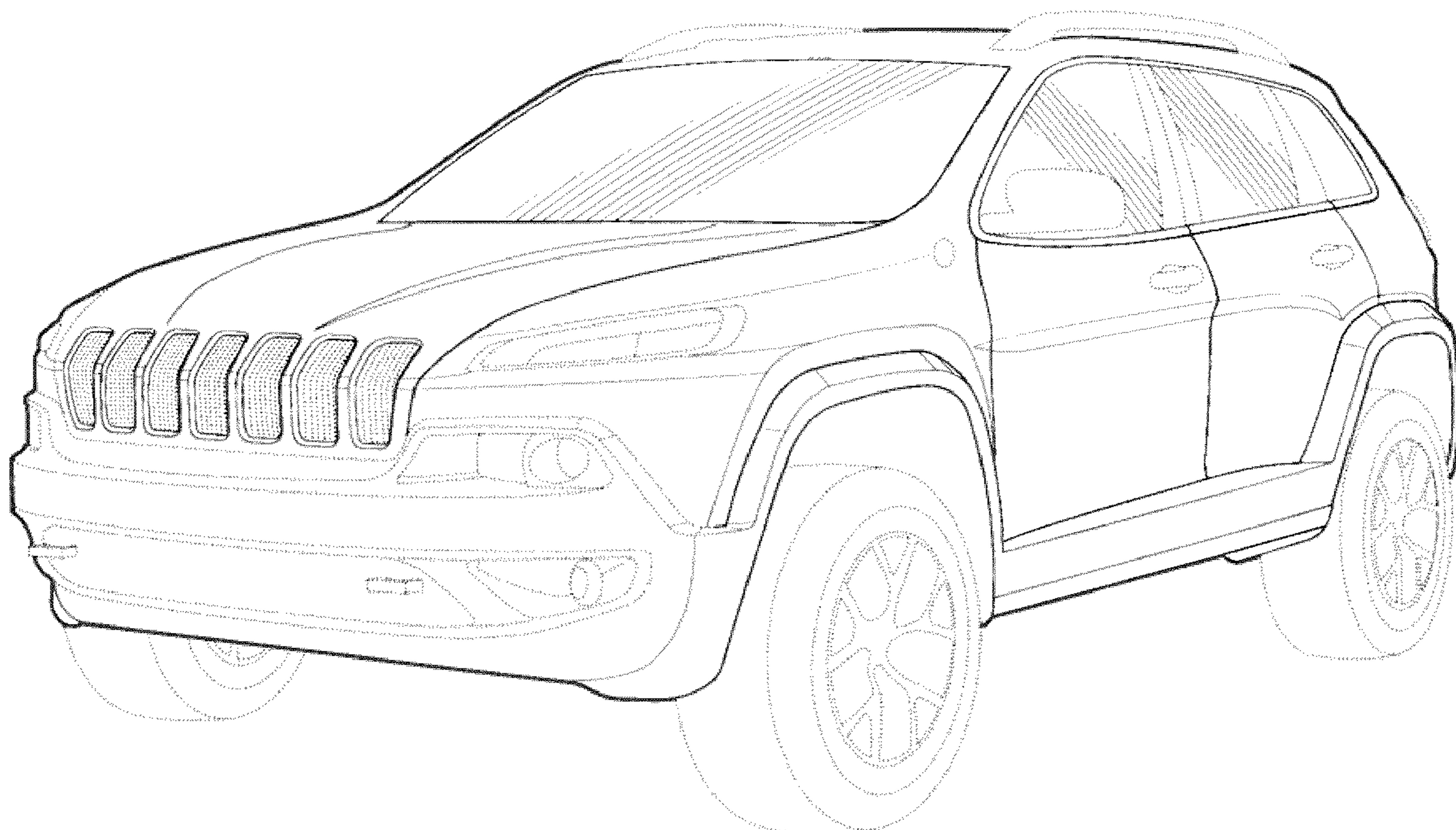
FIG. 4 is a rear perspective view thereof;

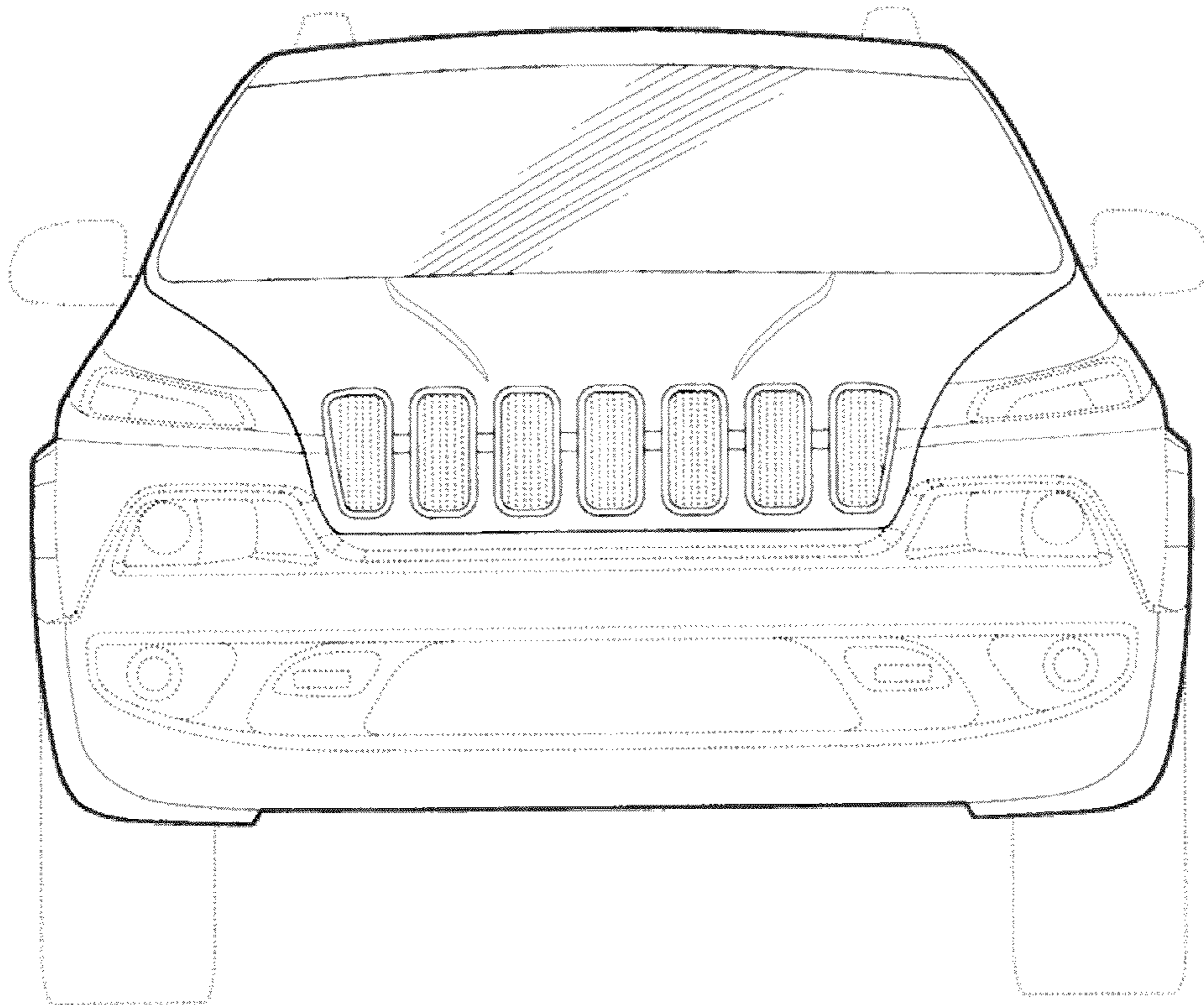

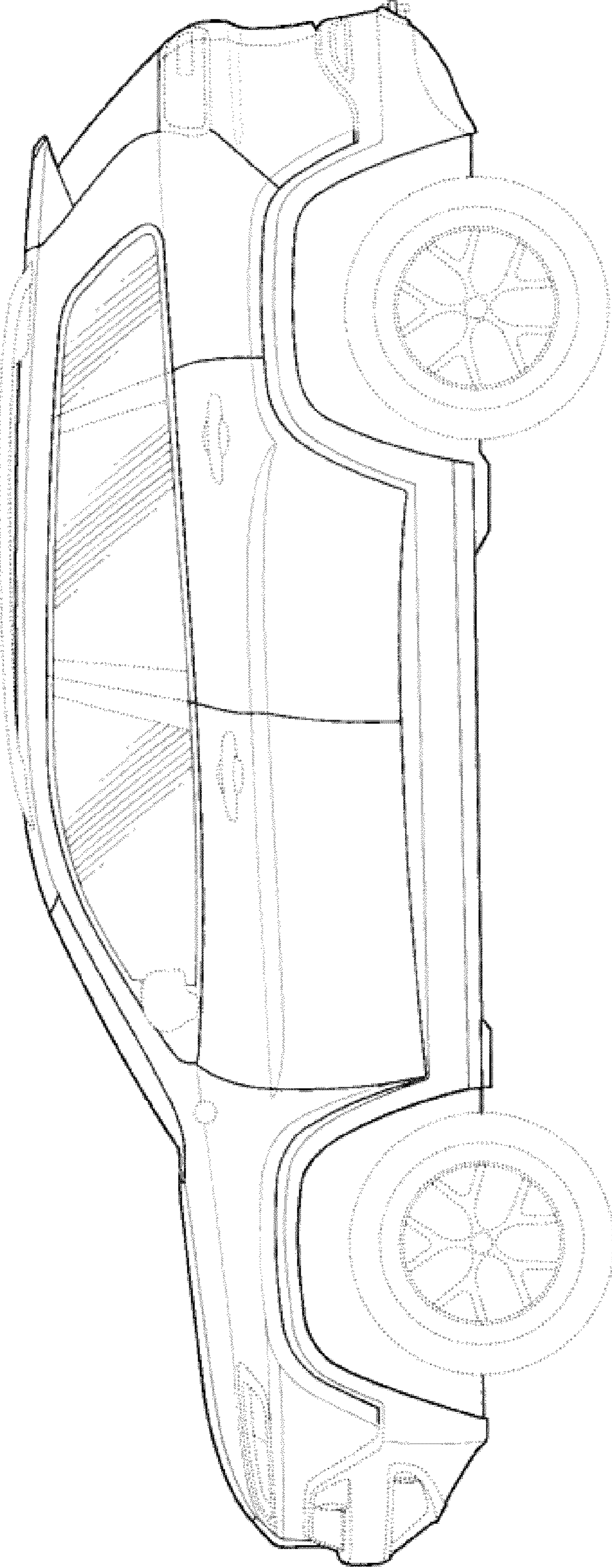

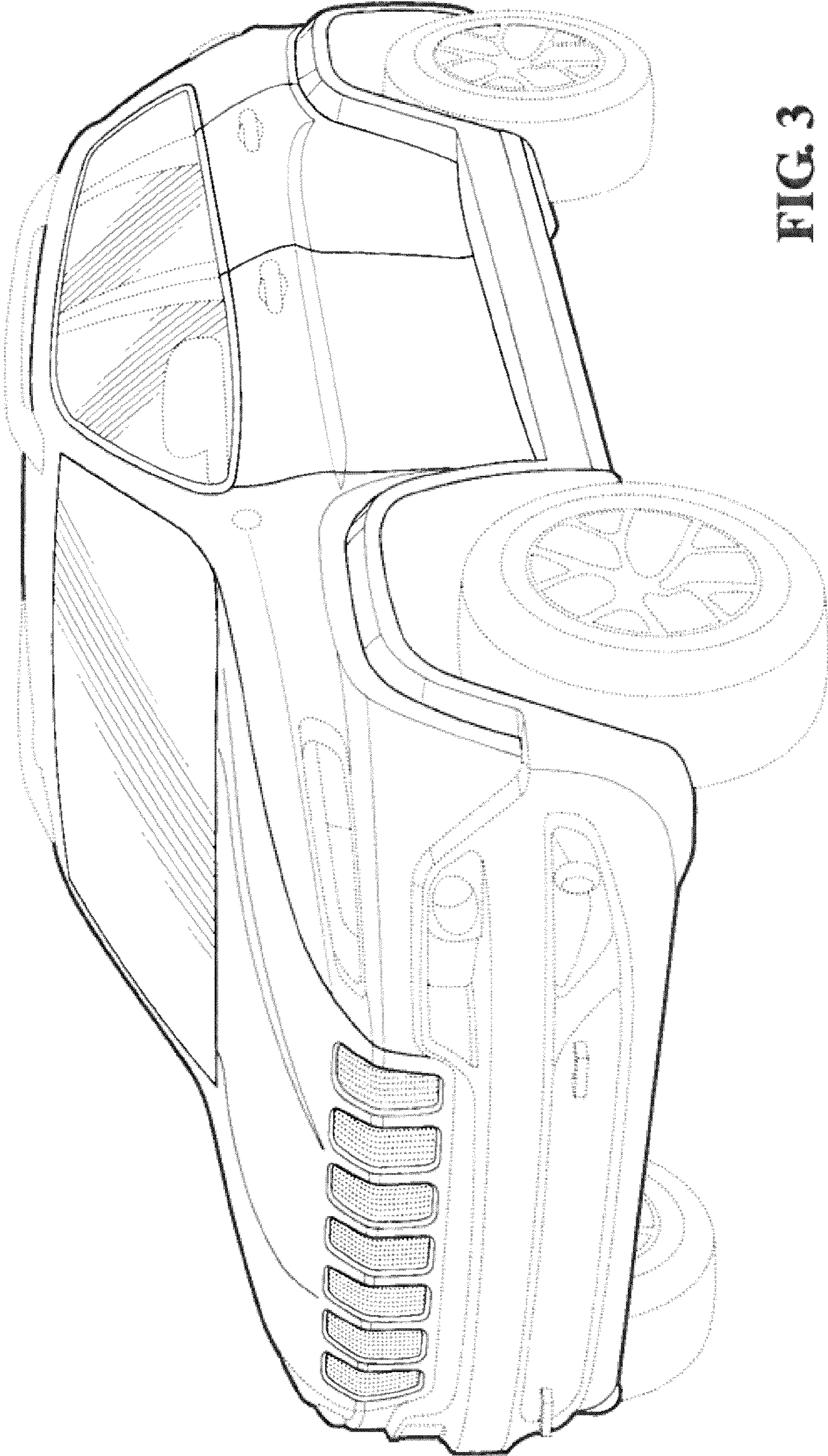

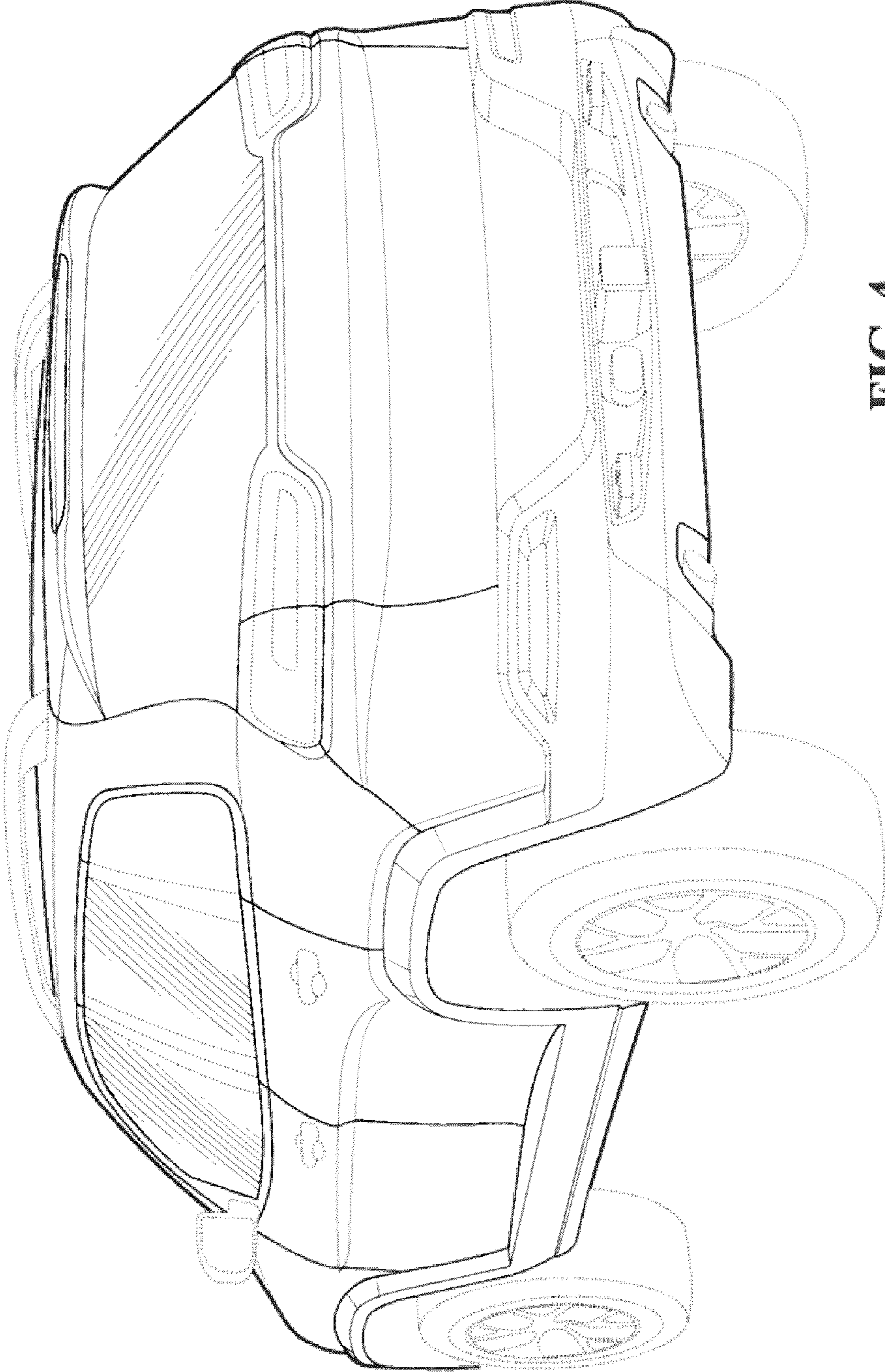
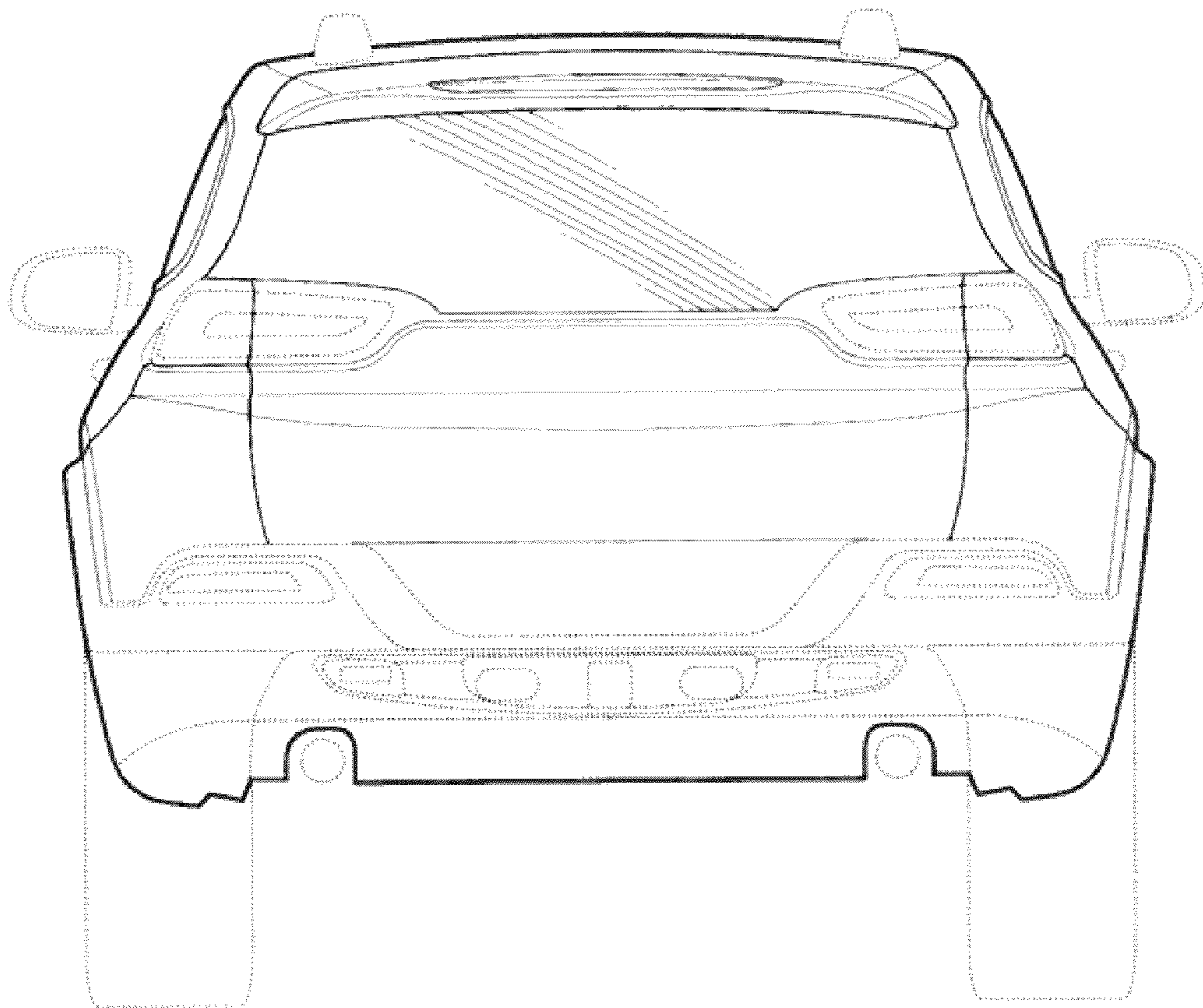

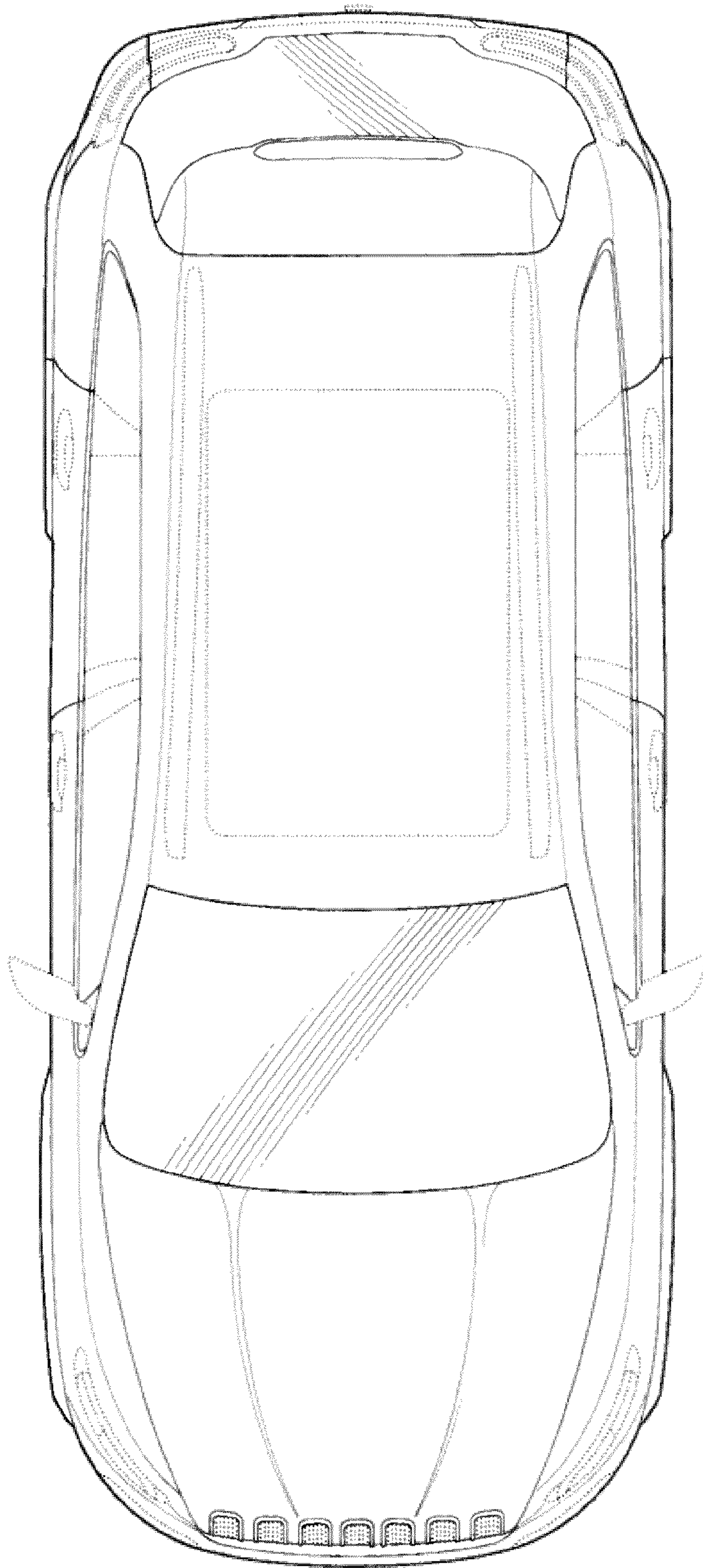
