**DESCRIPTION**

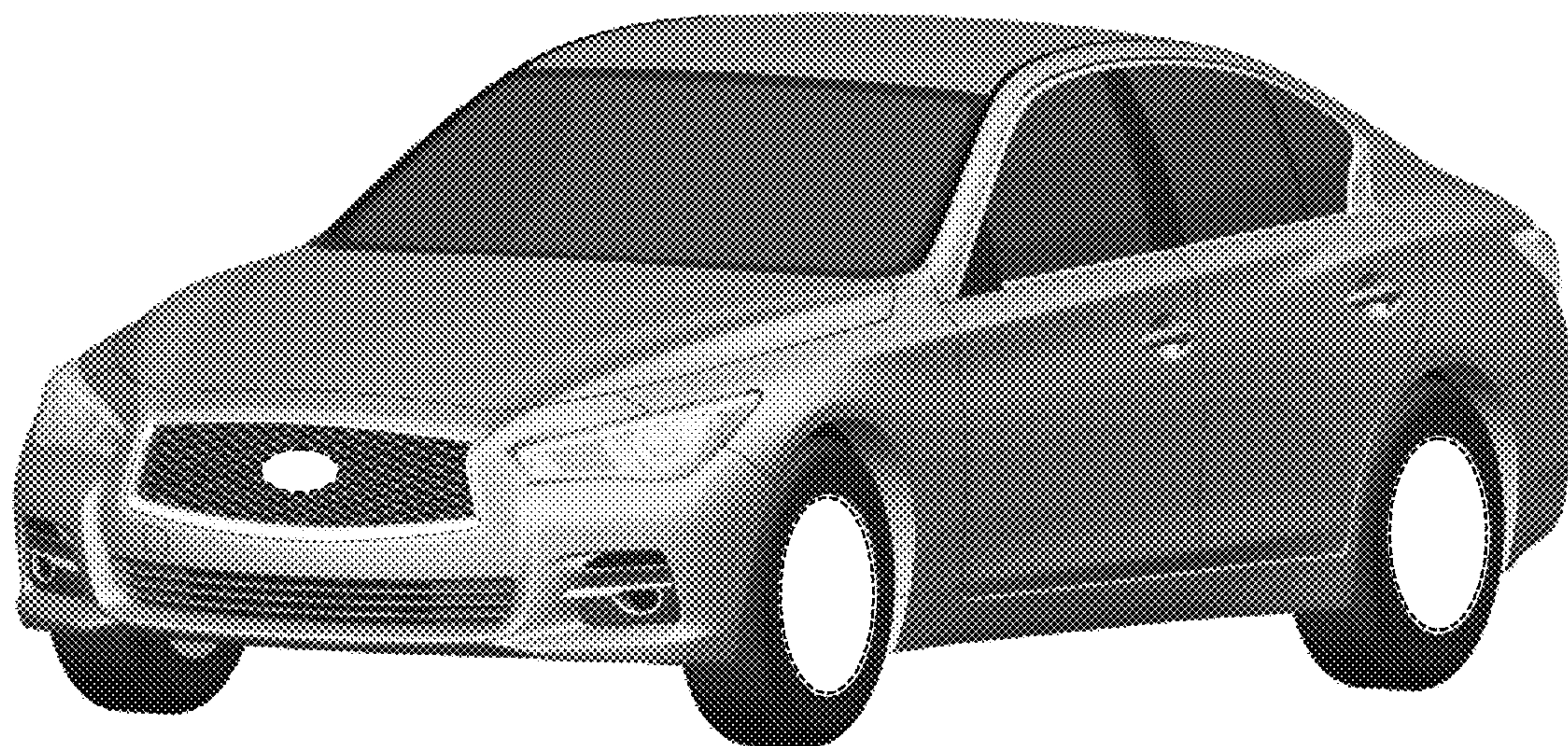

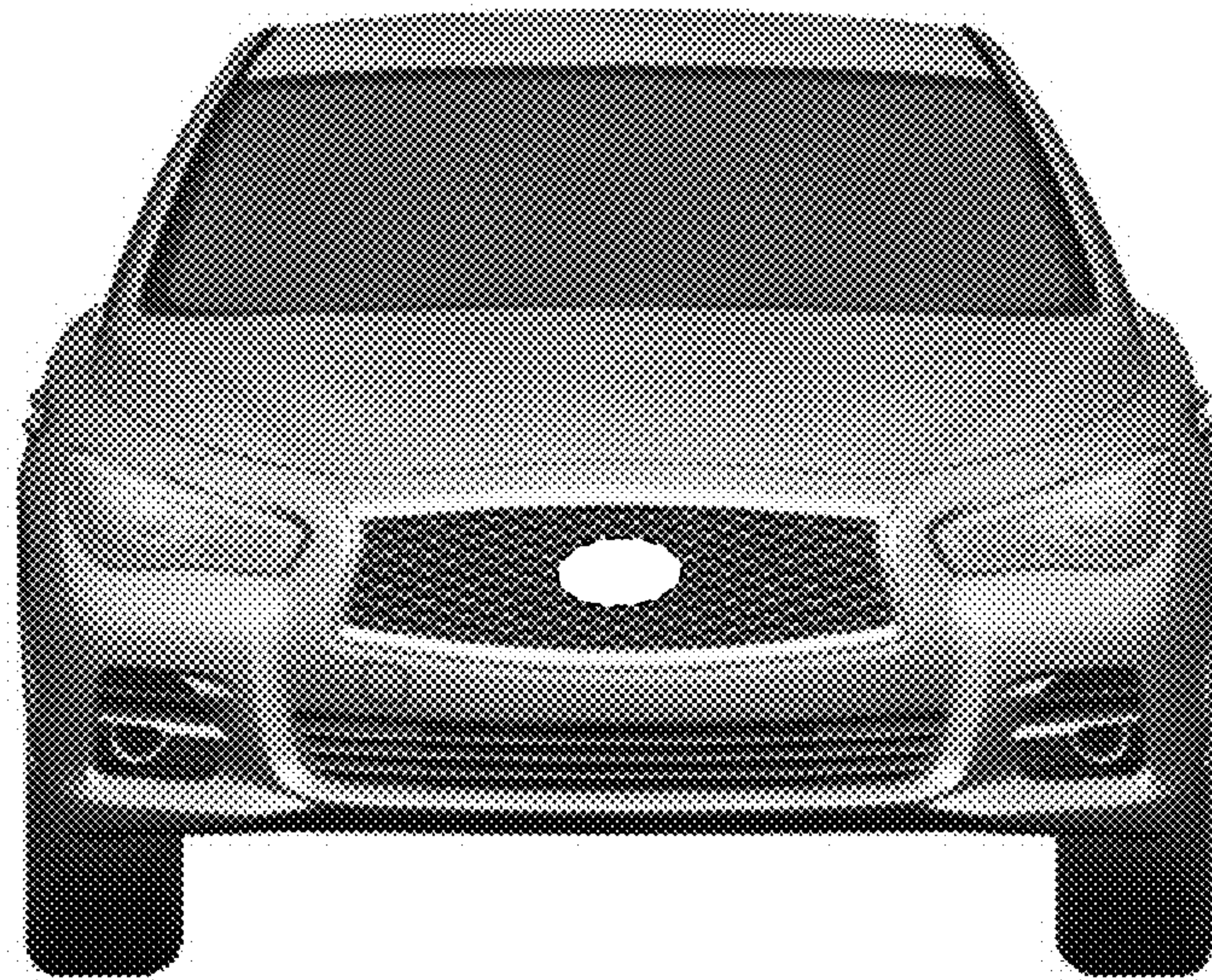

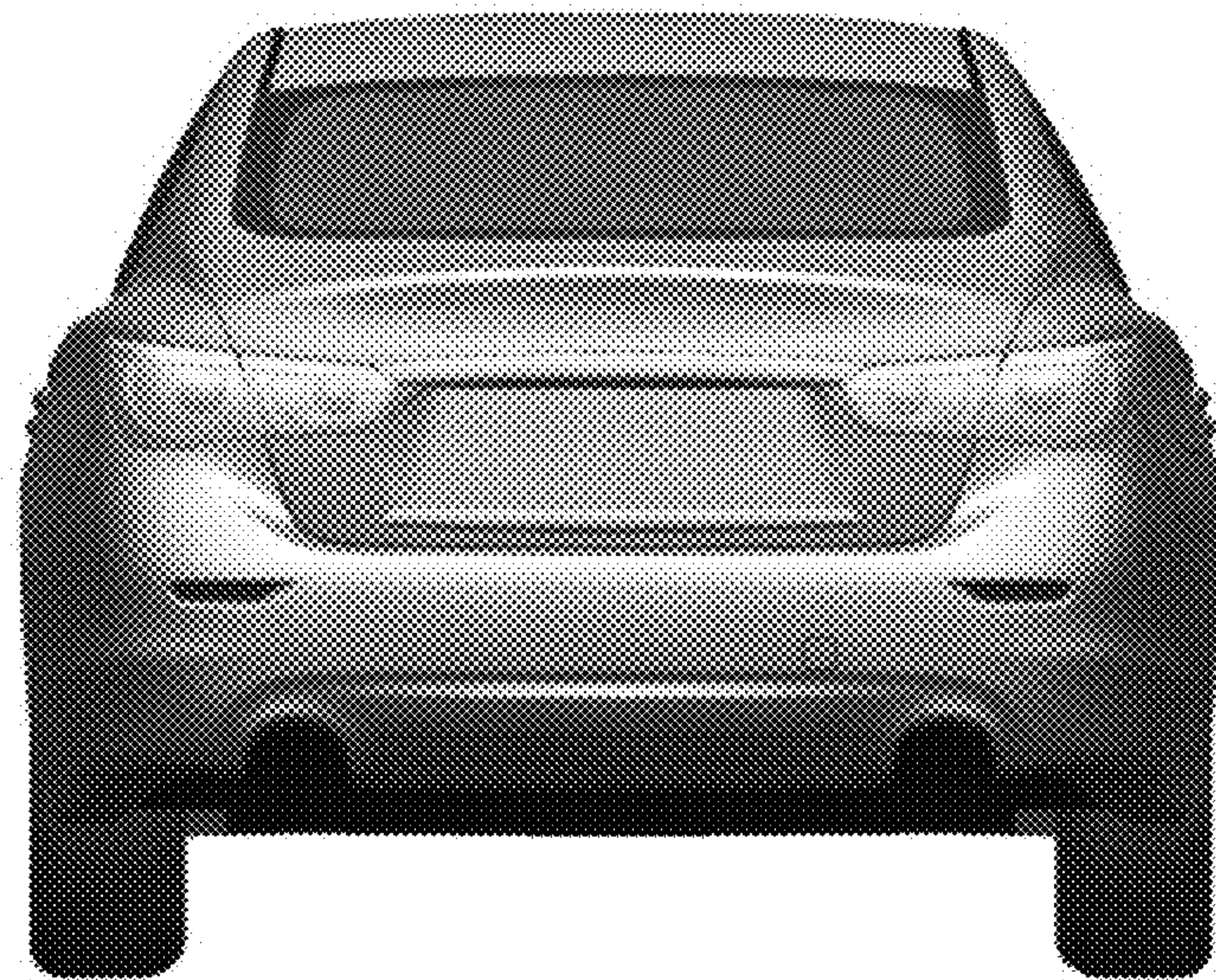
