The ornamental design for a car, toy replicas and/or other replicas, as shown and described.

DESCRIPTION

FIG. 1 is a top, front and side perspective view of a car, toy replica and/or other replicas showing our new design;

FIG. 2 is another perspective view thereof;

FIG. 3 is a front view thereof;

FIG. 4 is a side elevational view thereof, the opposite side being a mirror image of that side shown;

FIG. 5 is a rear view thereof; and,

FIG. 6 is a top plan view thereof.













