FIG. 7 is a front left perspective view thereof;

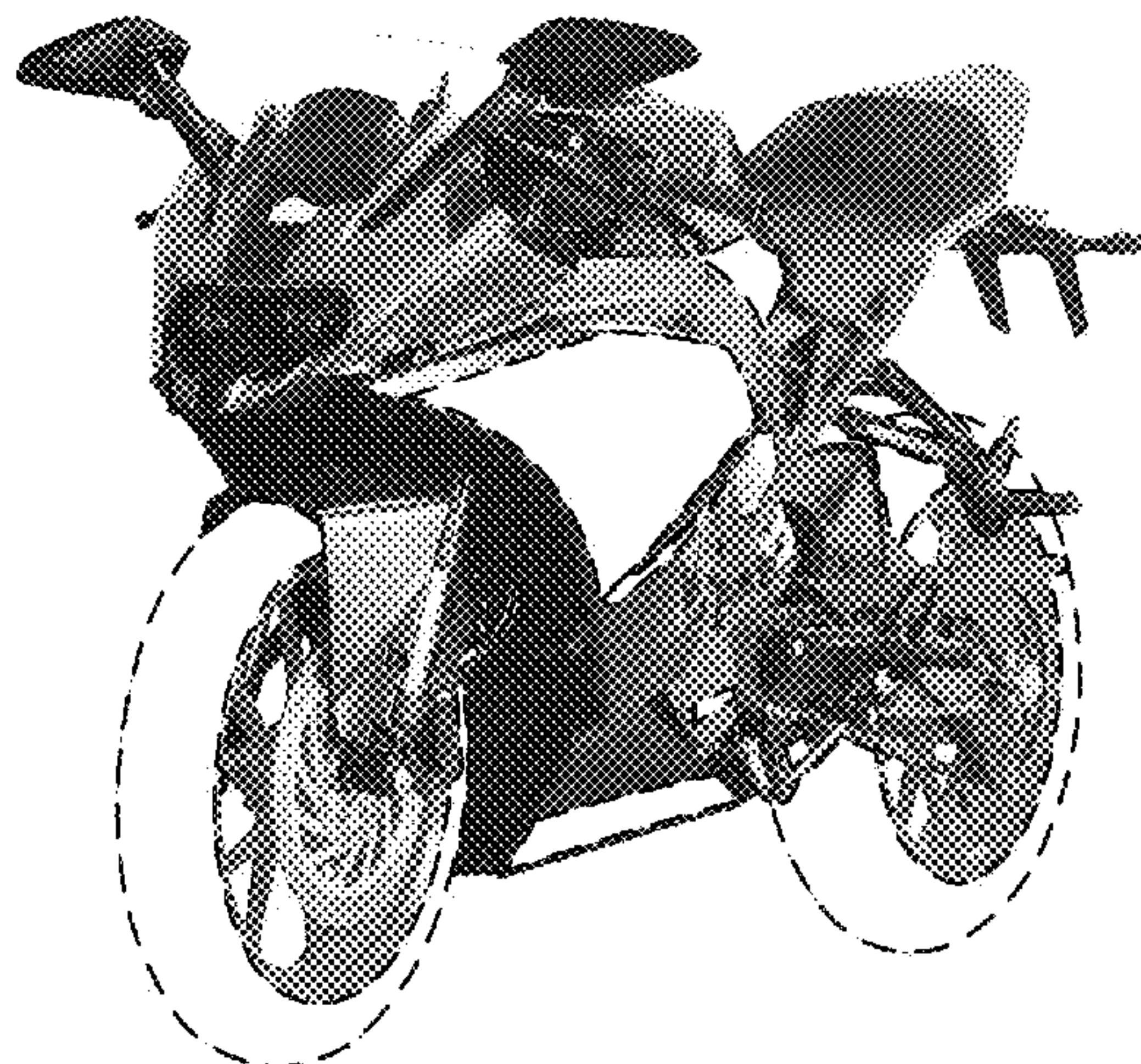
FIG. 8 is a rear right perspective view thereof; and,

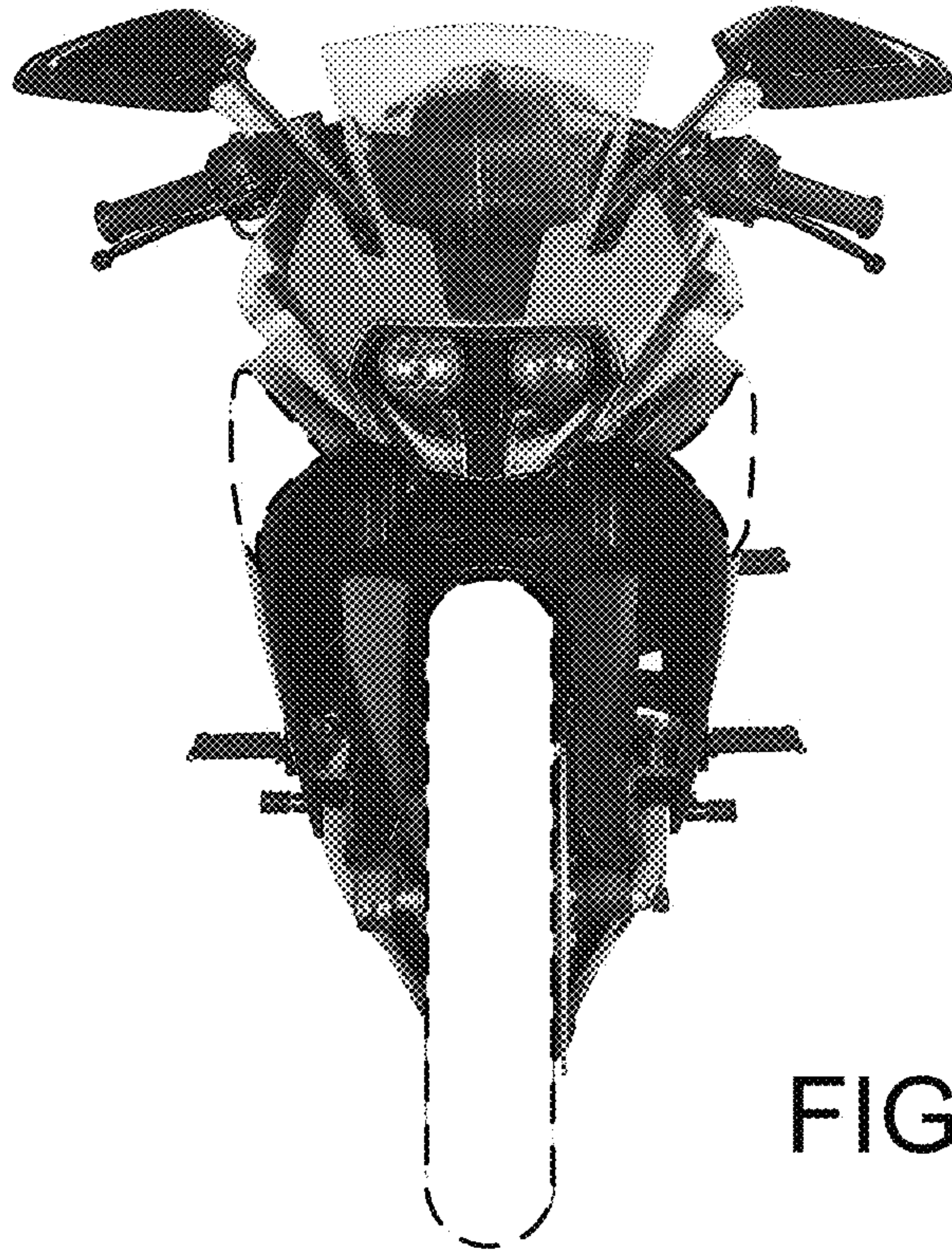

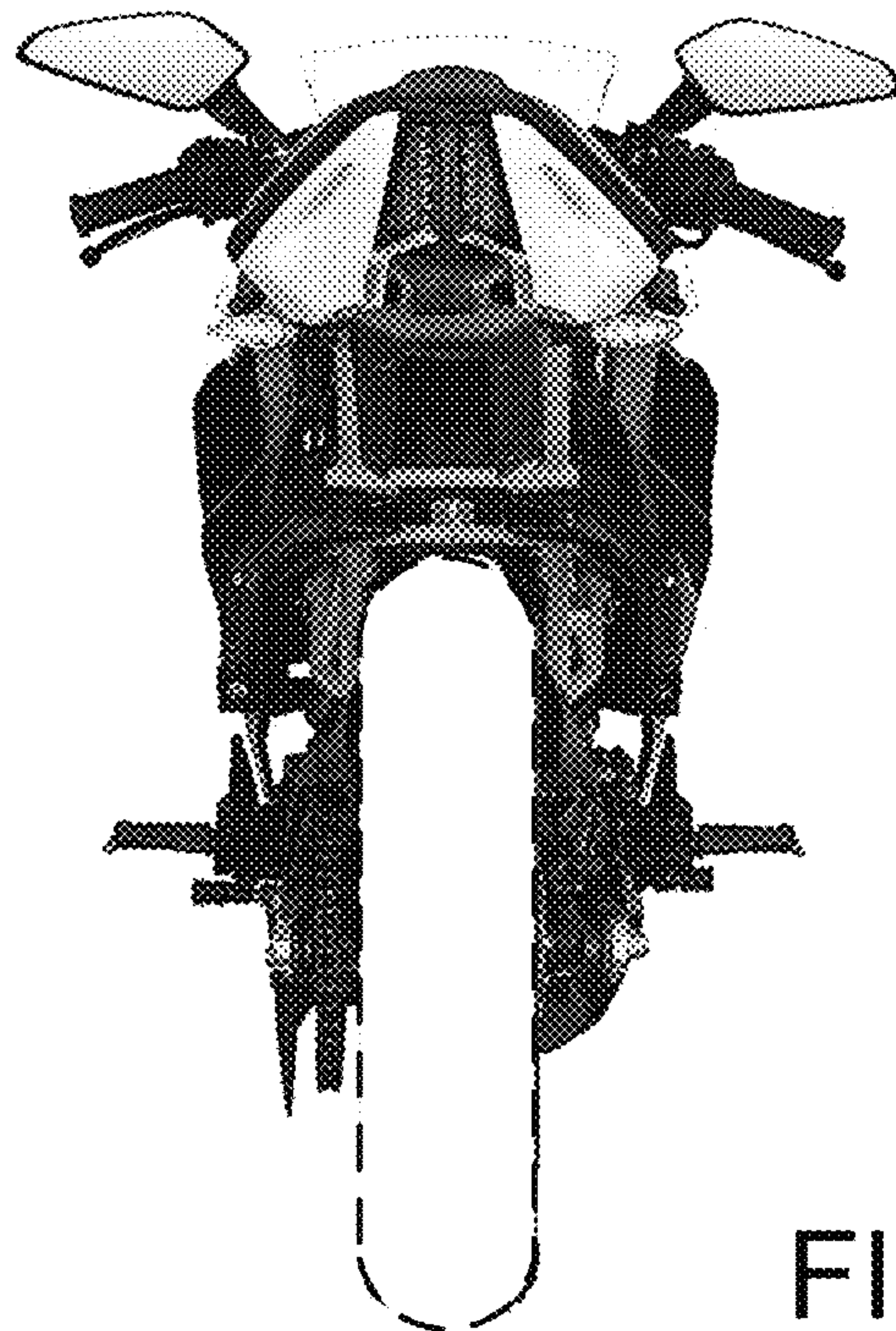

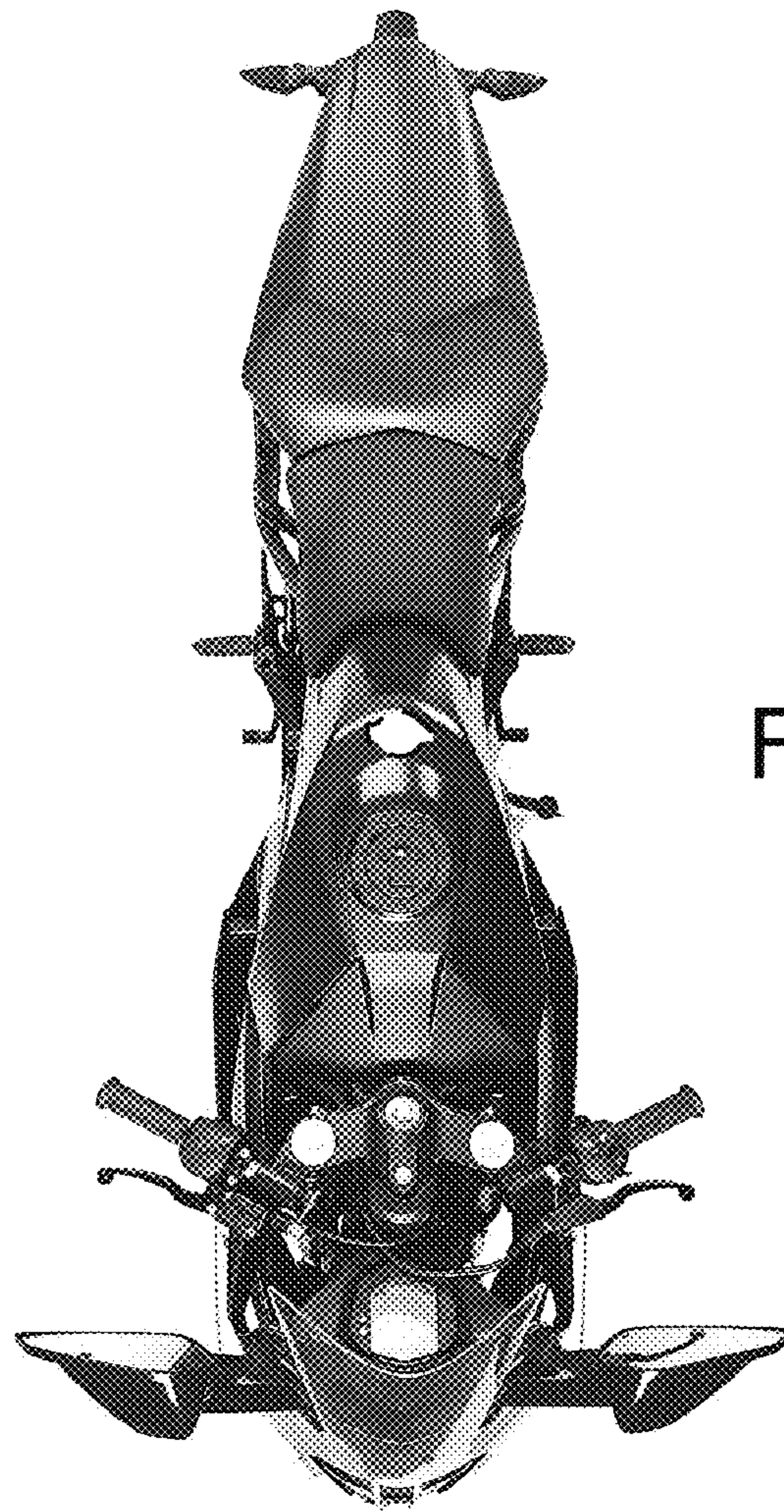

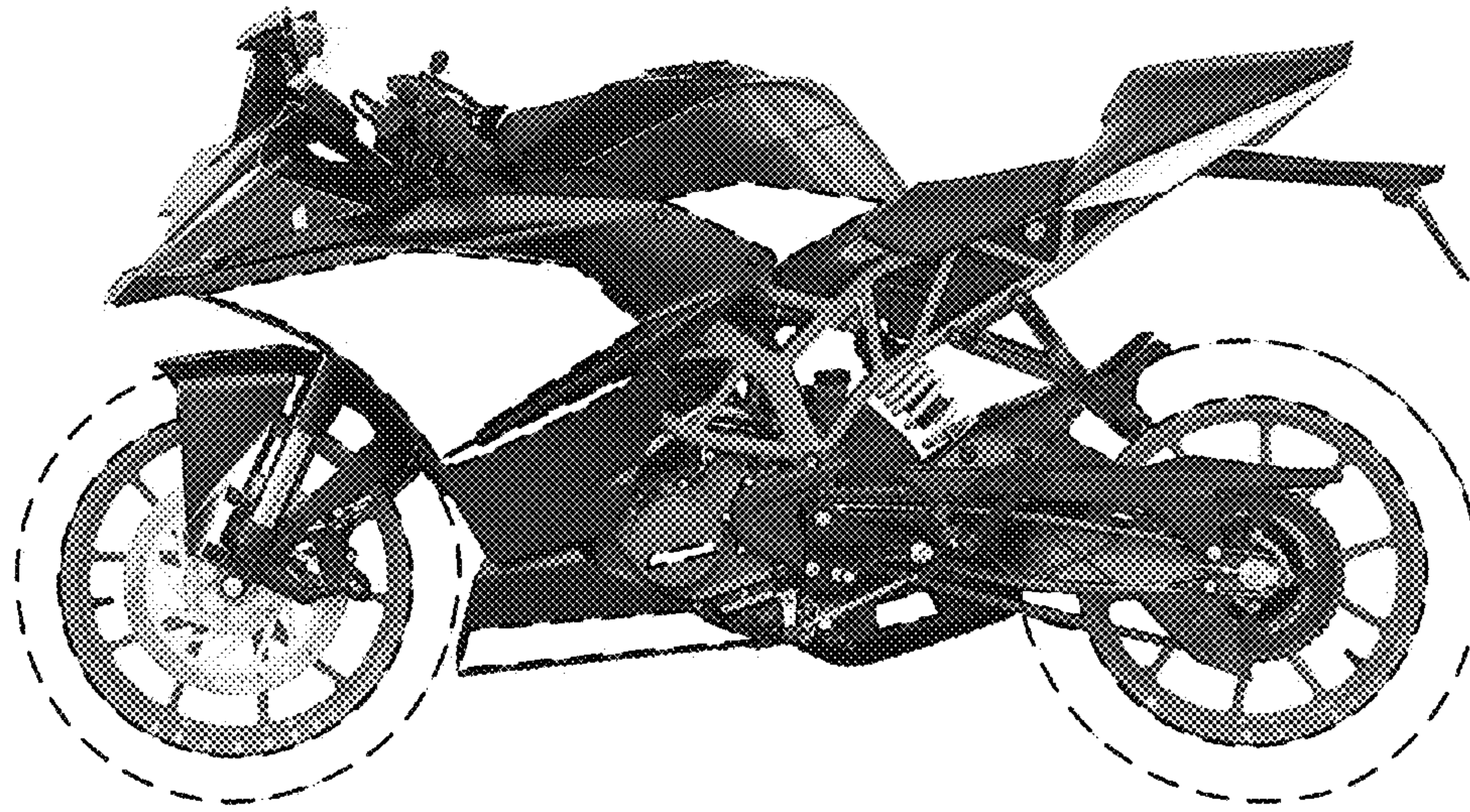

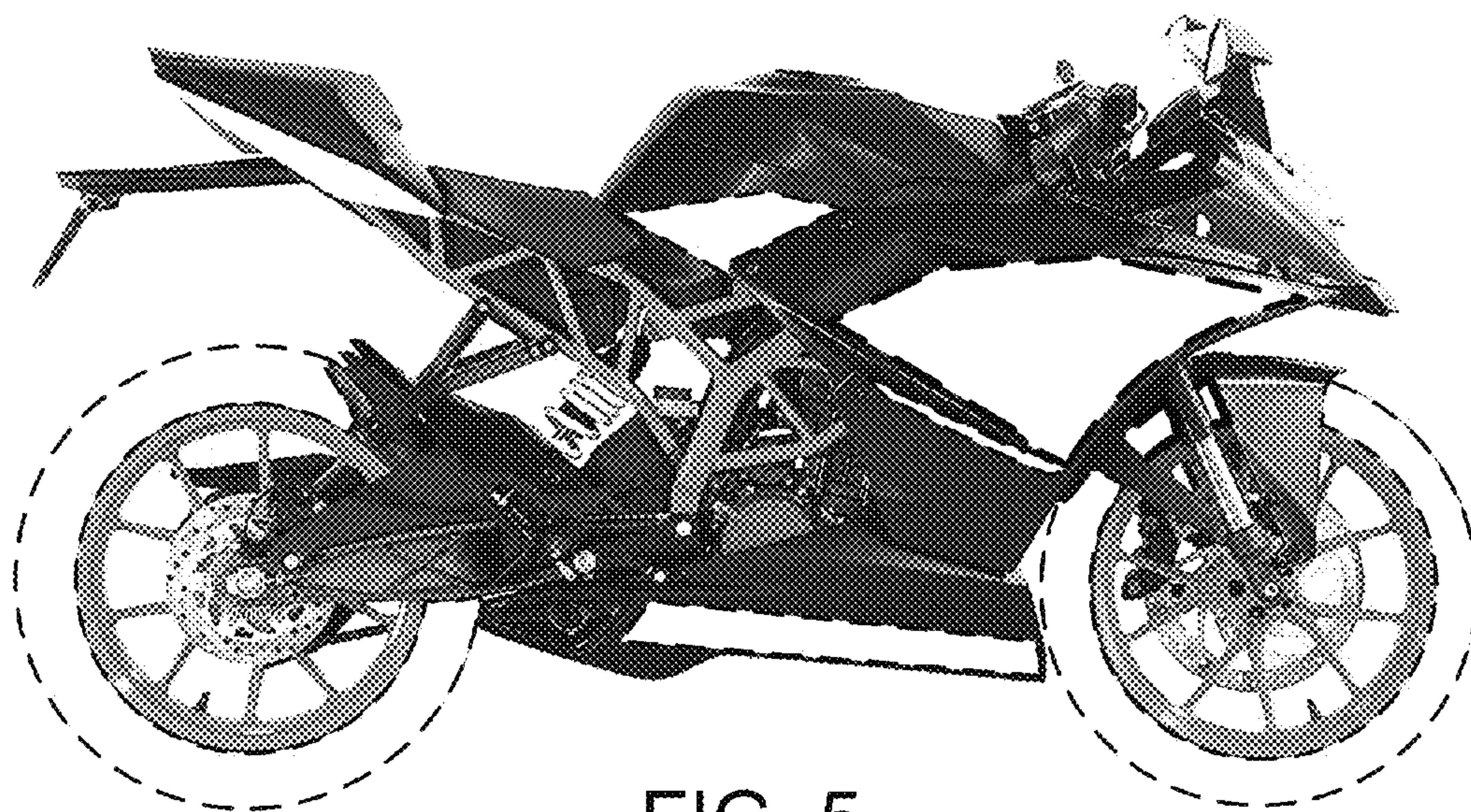

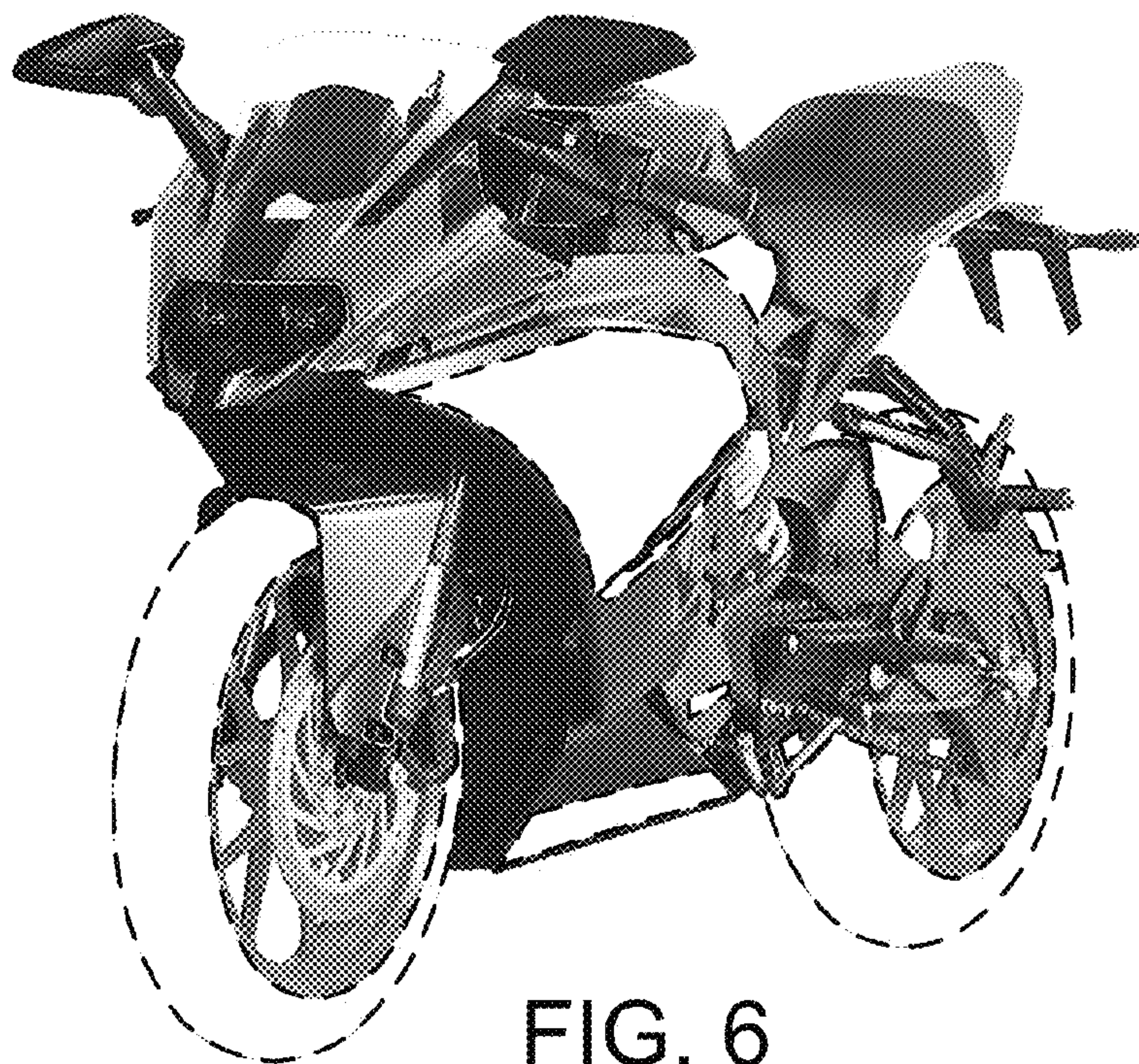

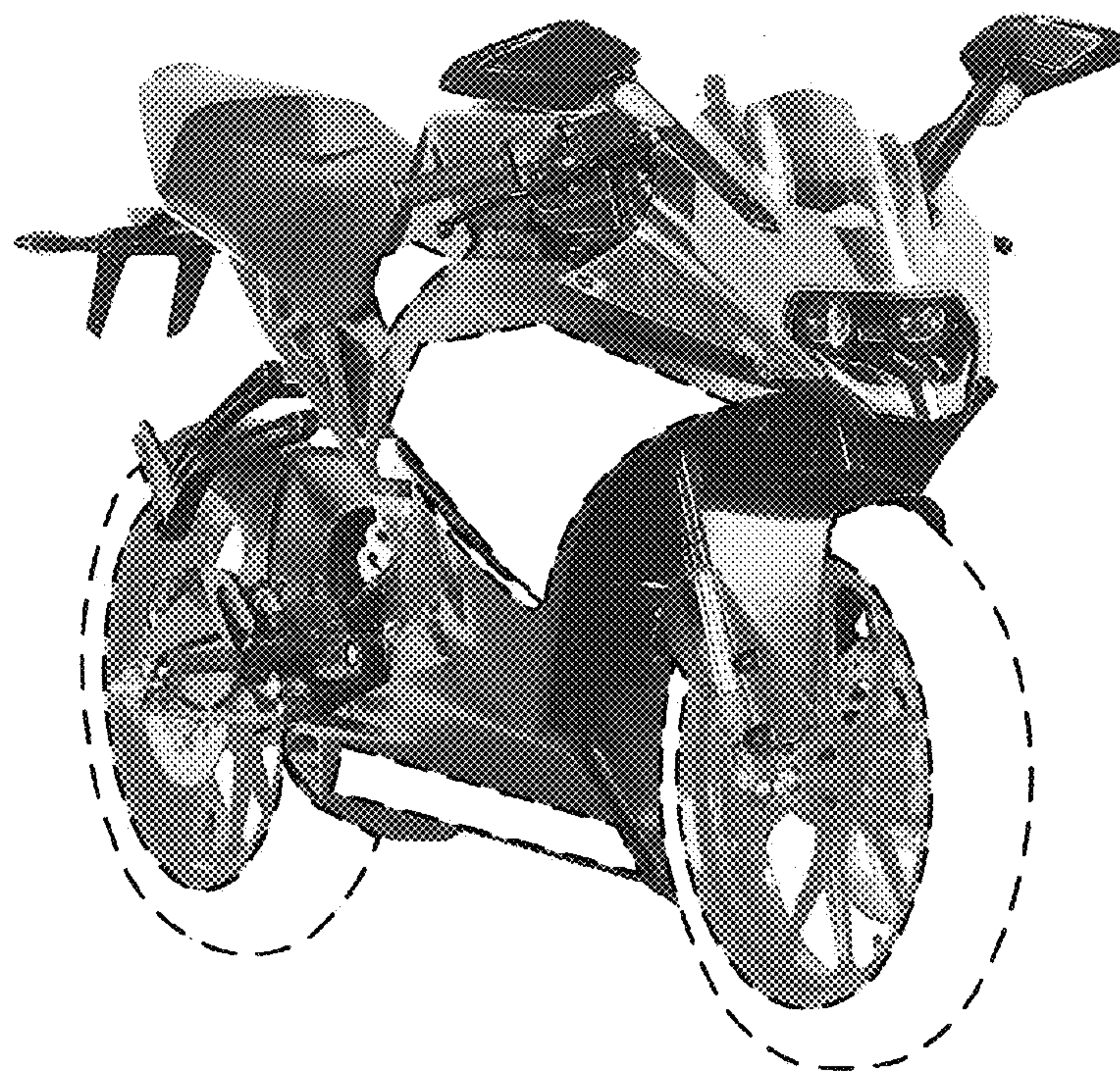

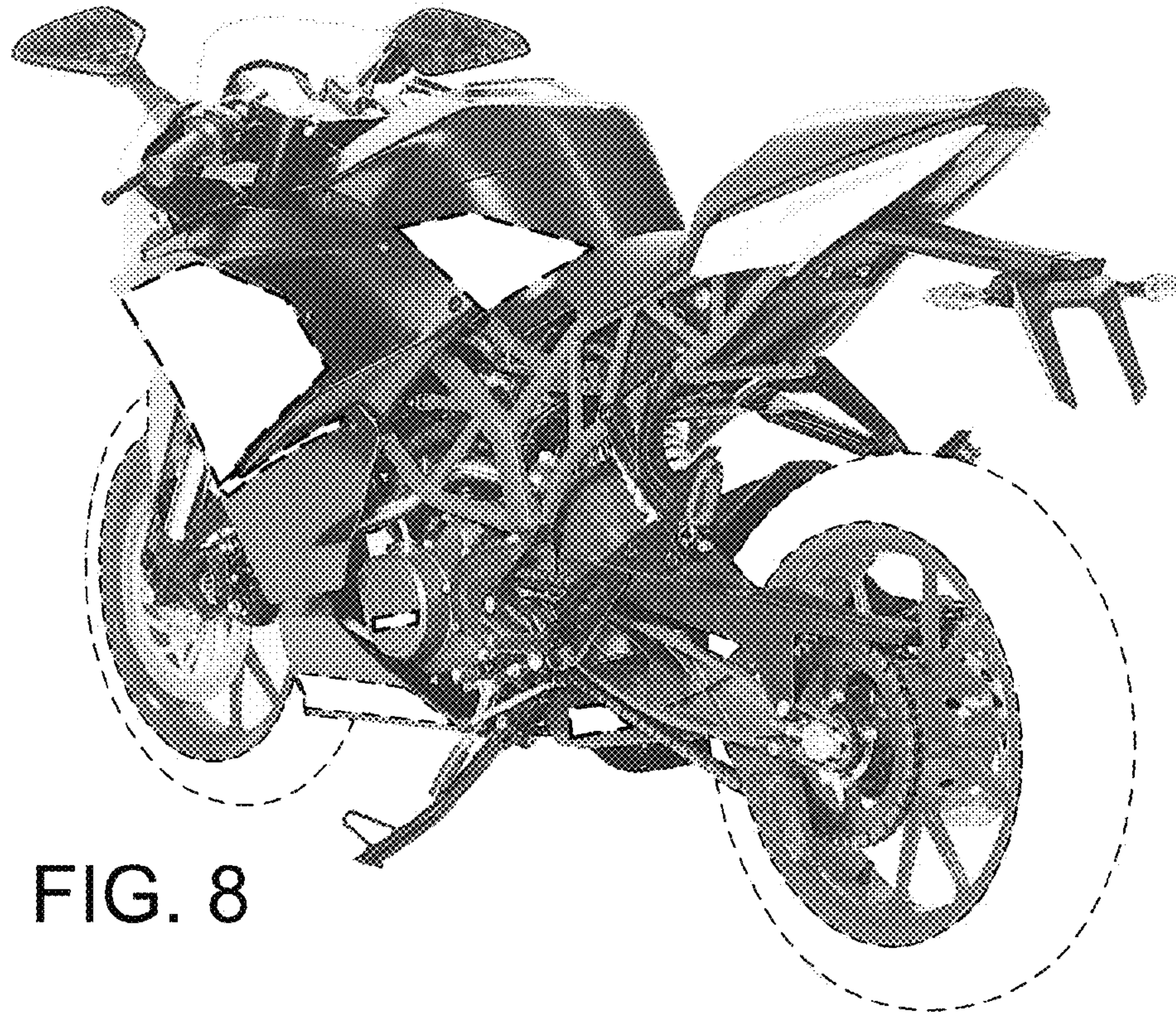

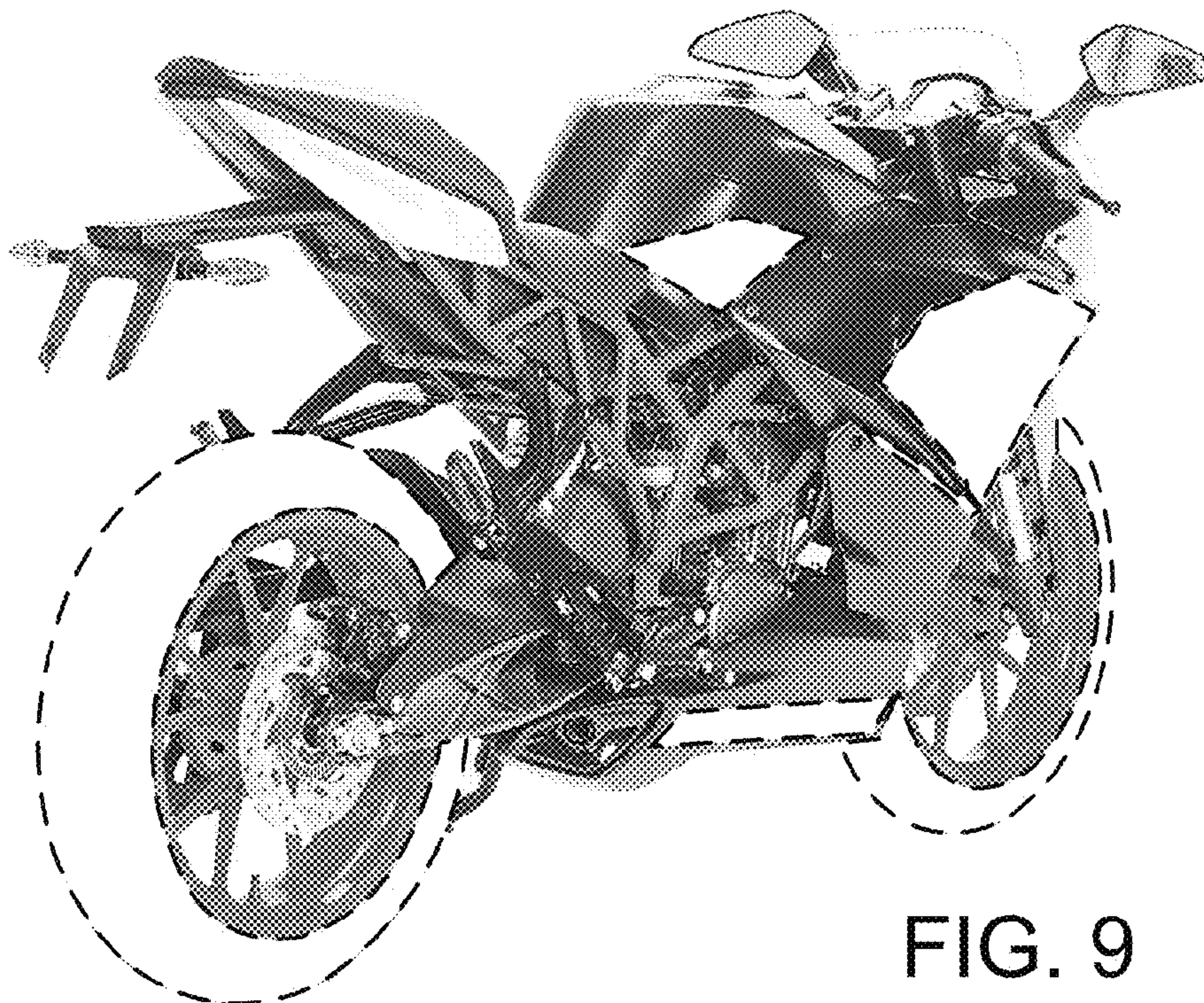
