(57) **CLAIM**

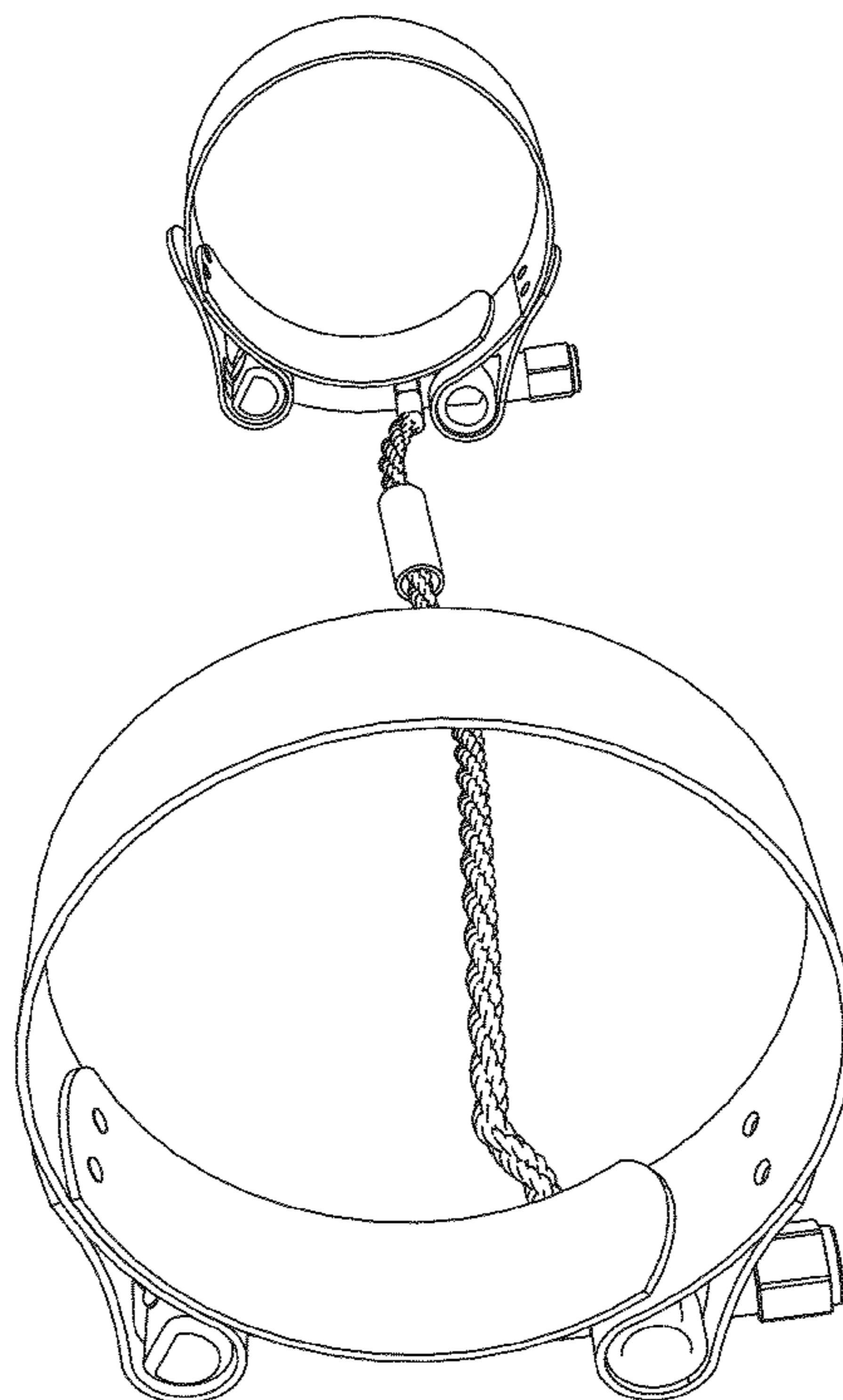
The ornamental design for a tethering device, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a tethering device; FIG. 2 is a side view of the tethering device of FIG. 1; FIG. 3 is a reversed side view of the tethering device of FIG. 1; FIG. 4 is a plan view of the tethering device of FIG. 1; FIG. 5 is an end view of the tethering device of FIG. 1; FIG. 6 is a flattened plan view of the tethering device of FIG. 1; FIG. 7 is another end view of the tethering device of FIG. 1; and, FIG. 8 is an additional perspective view of the tethering device of FIG. 1.

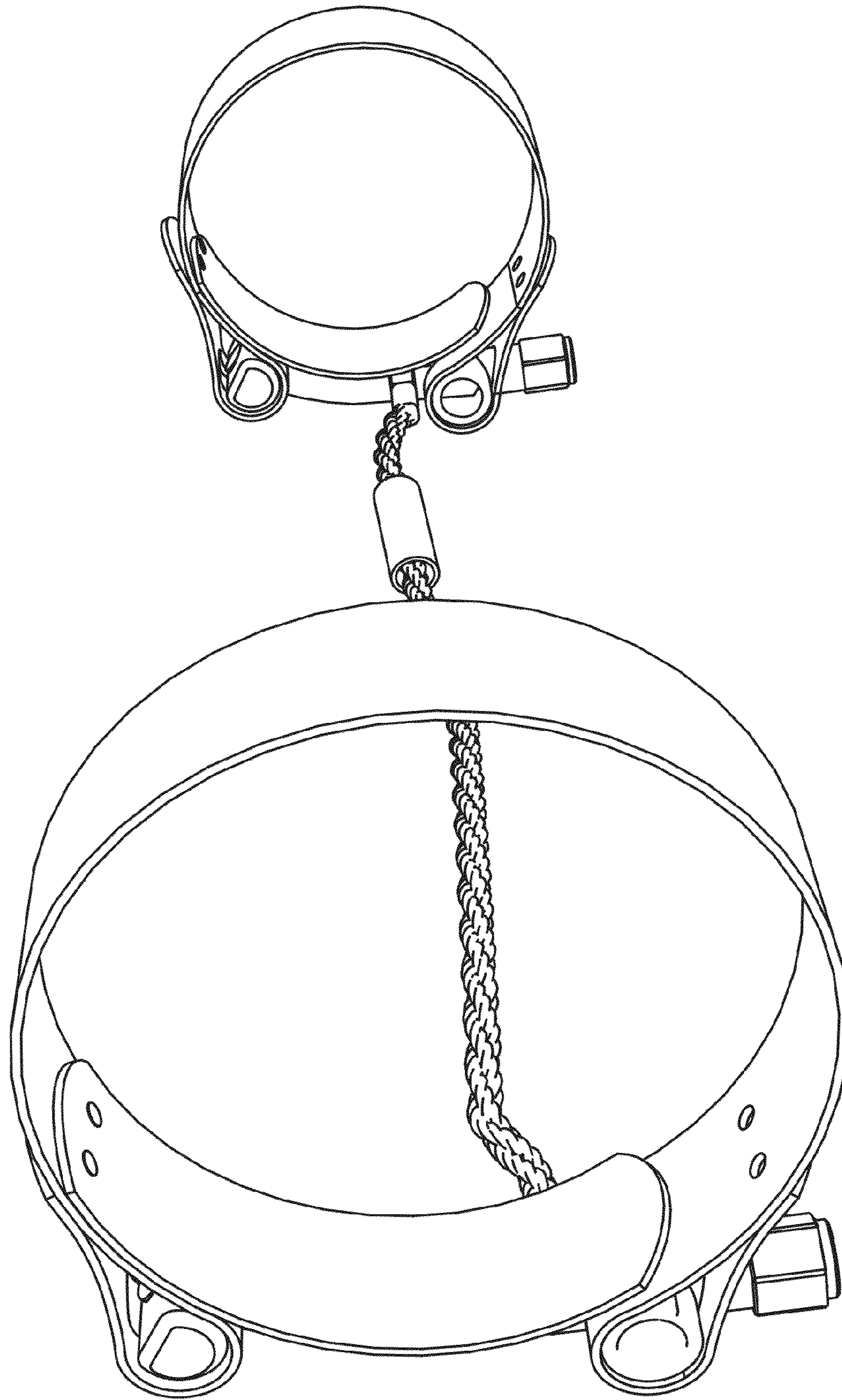

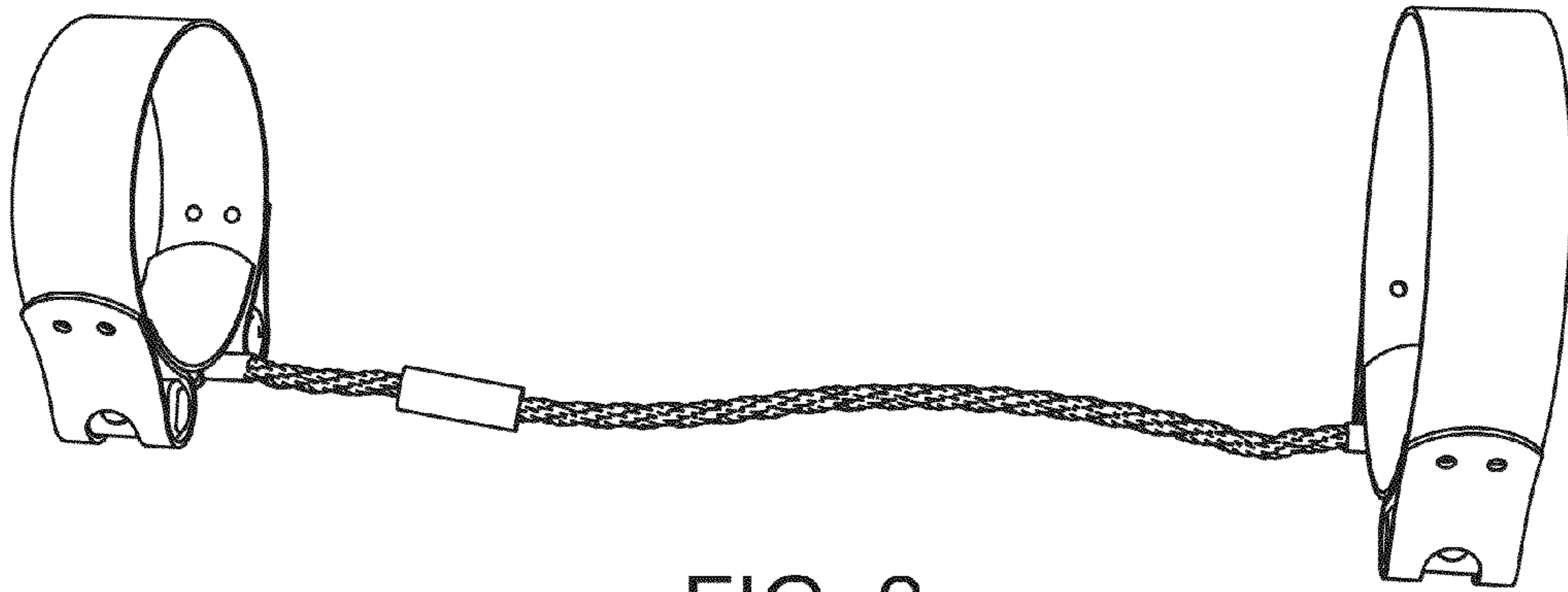

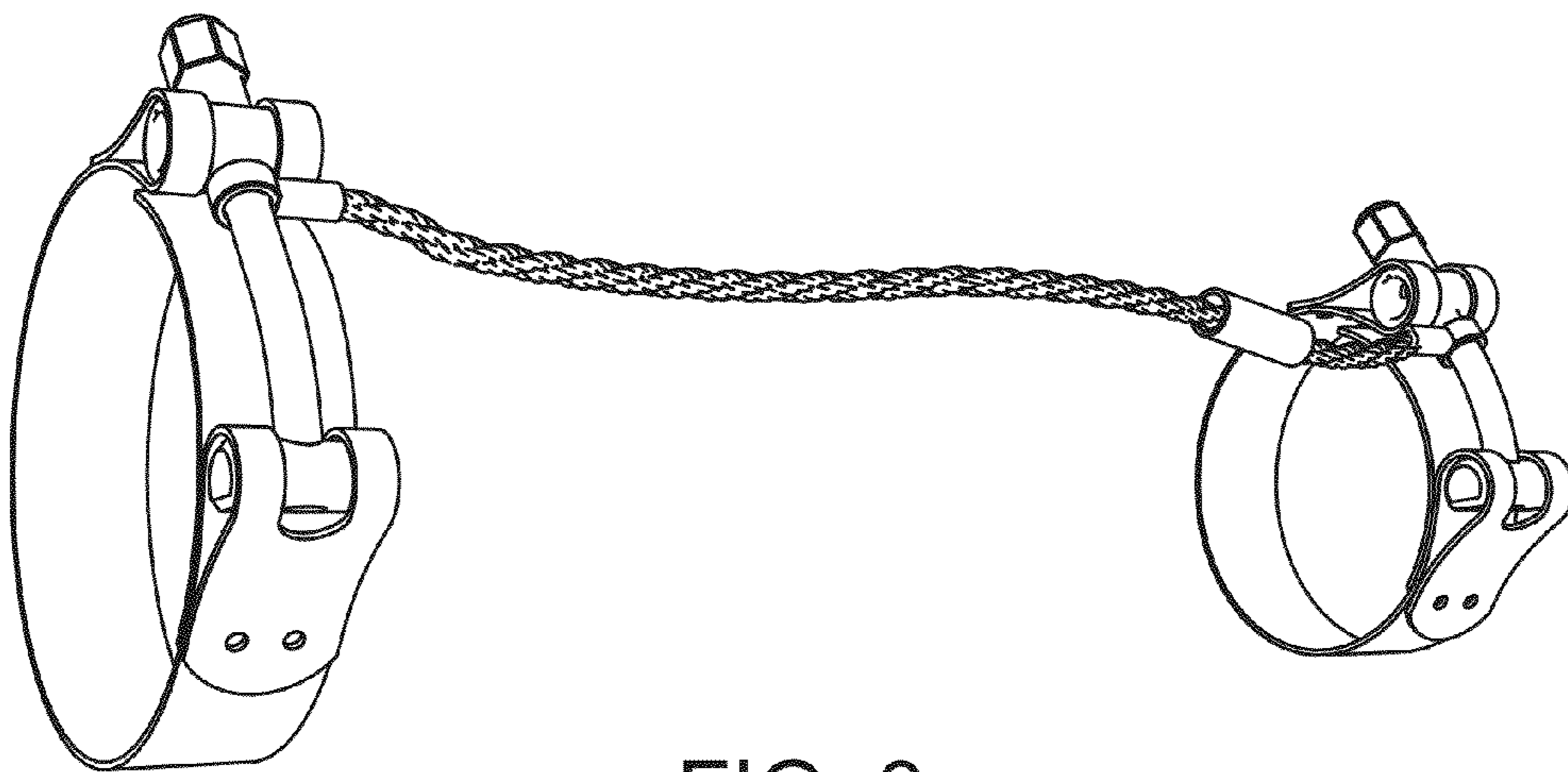

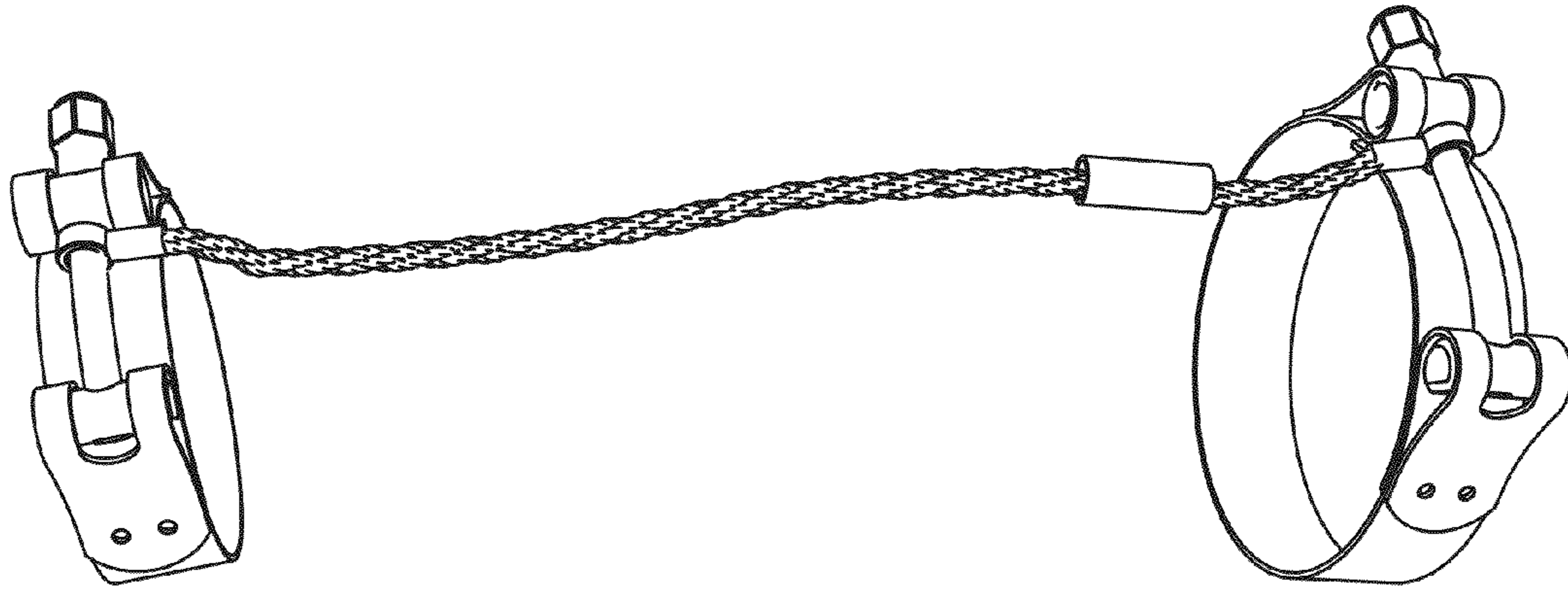

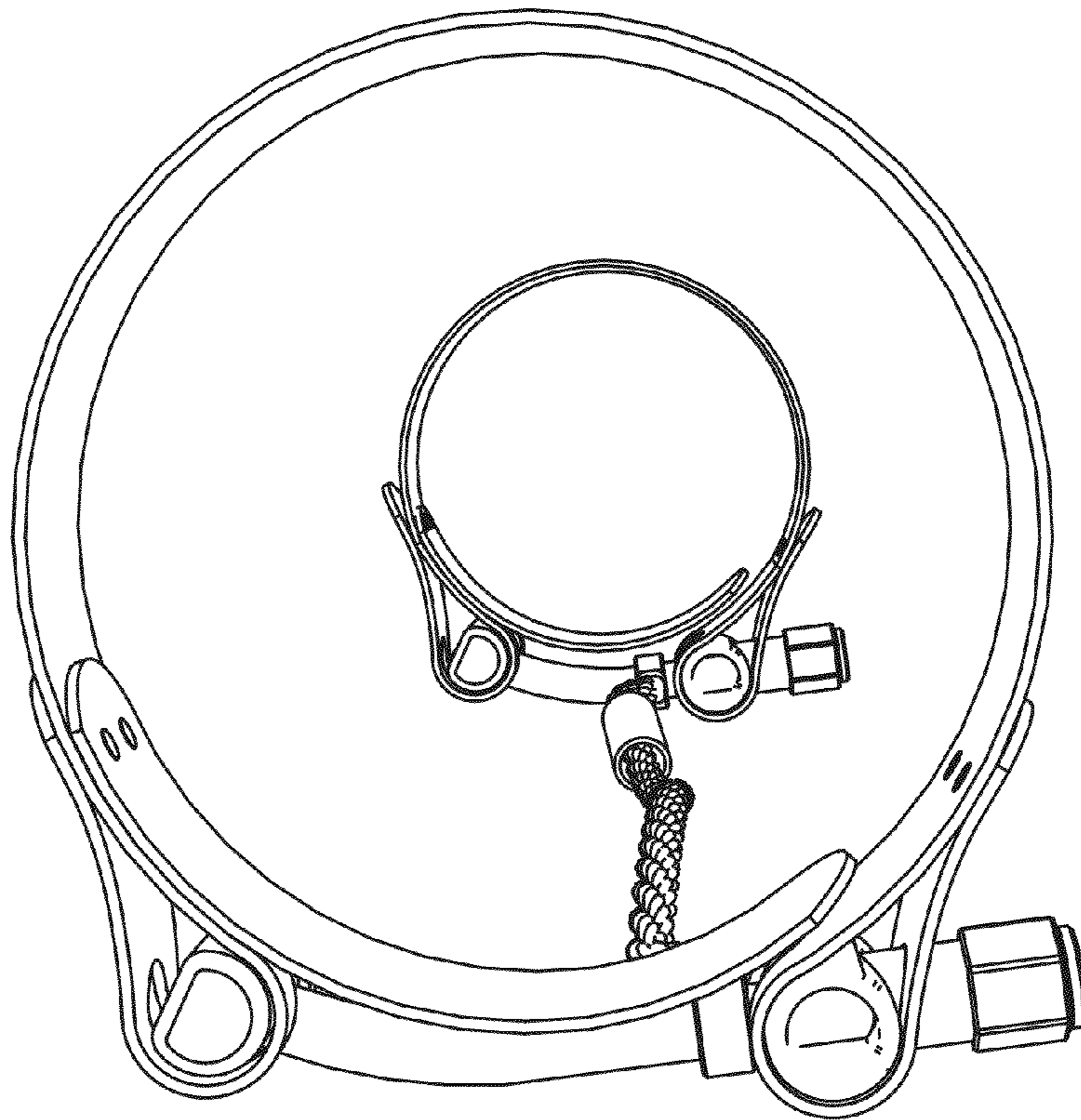

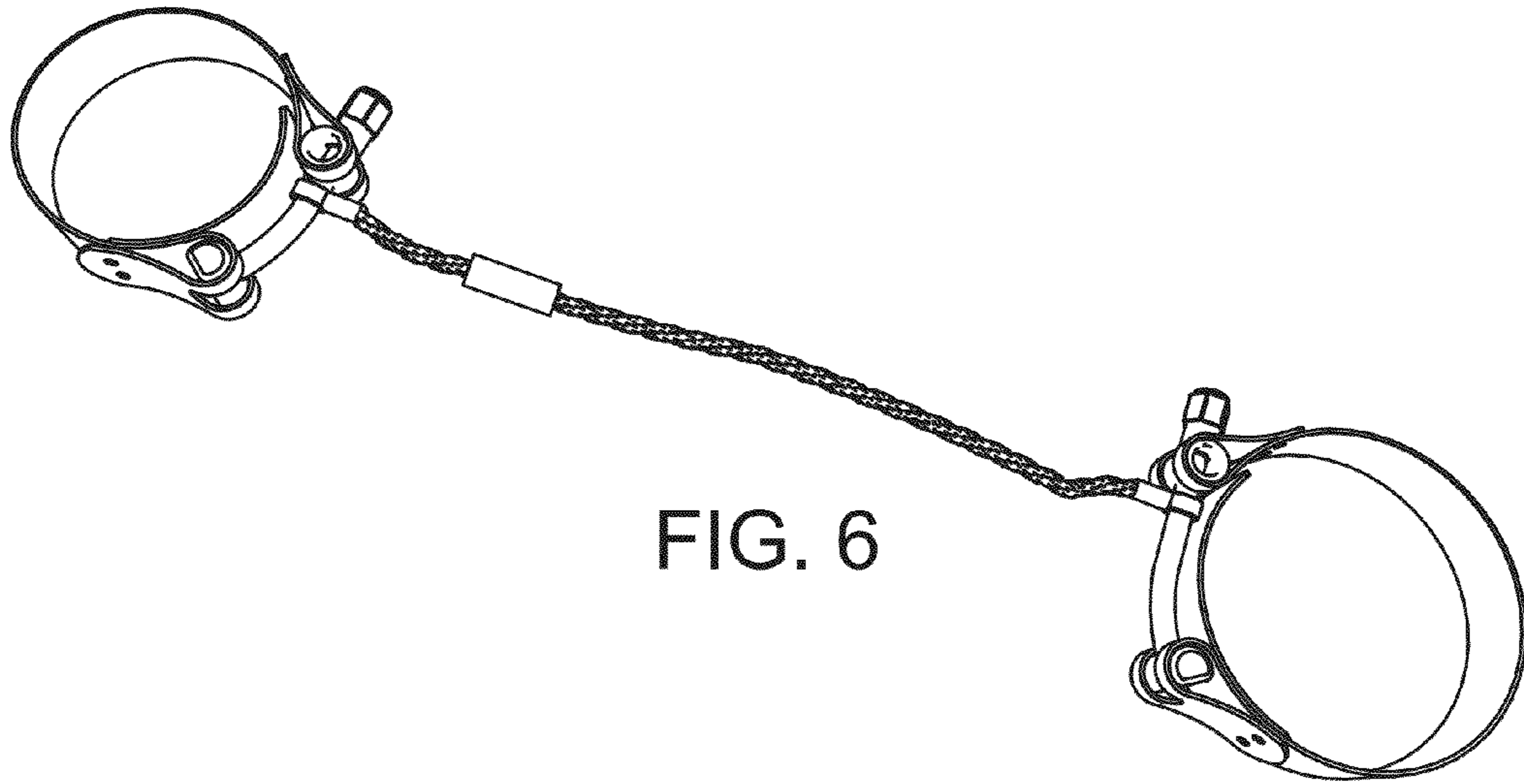

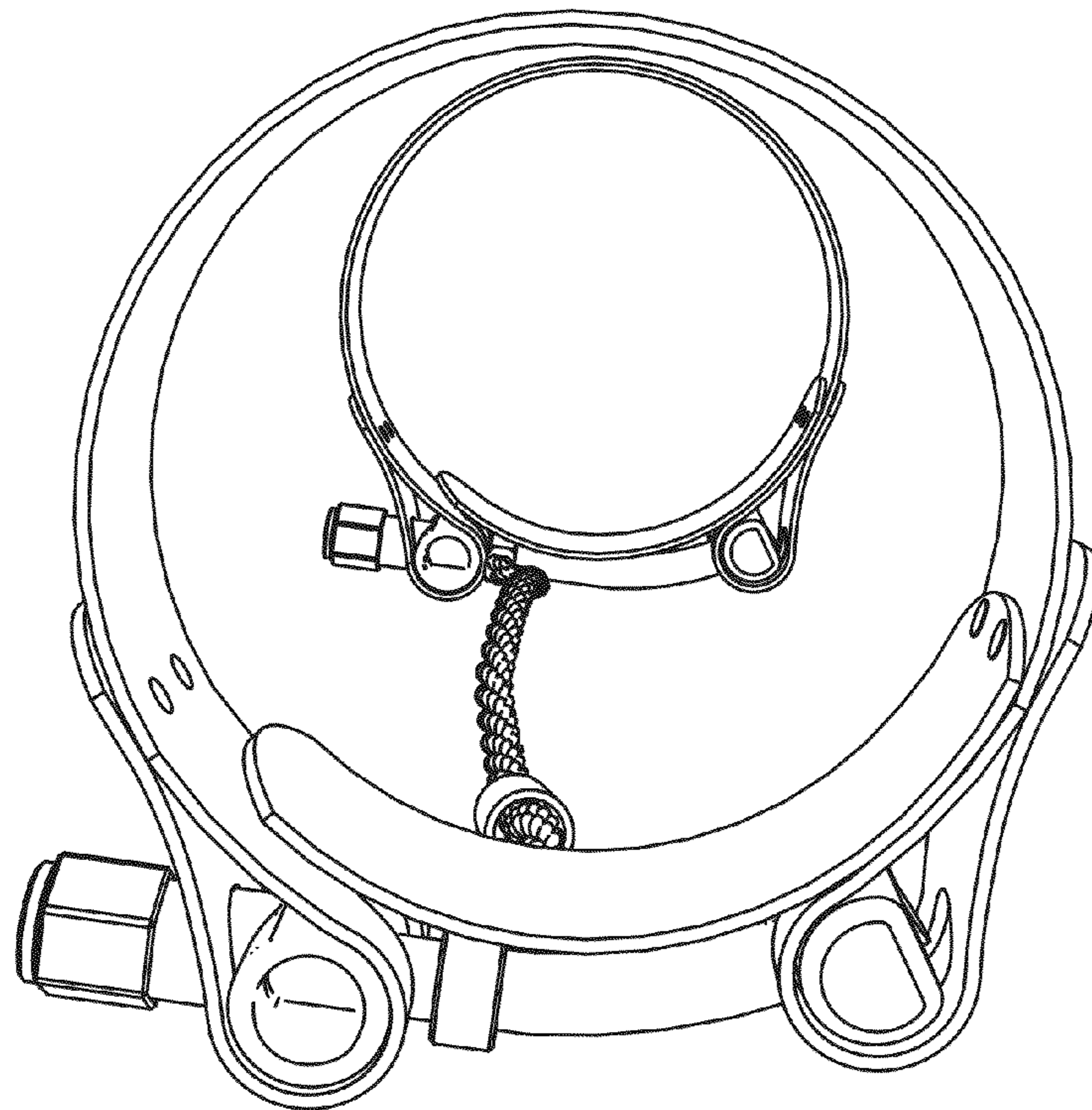

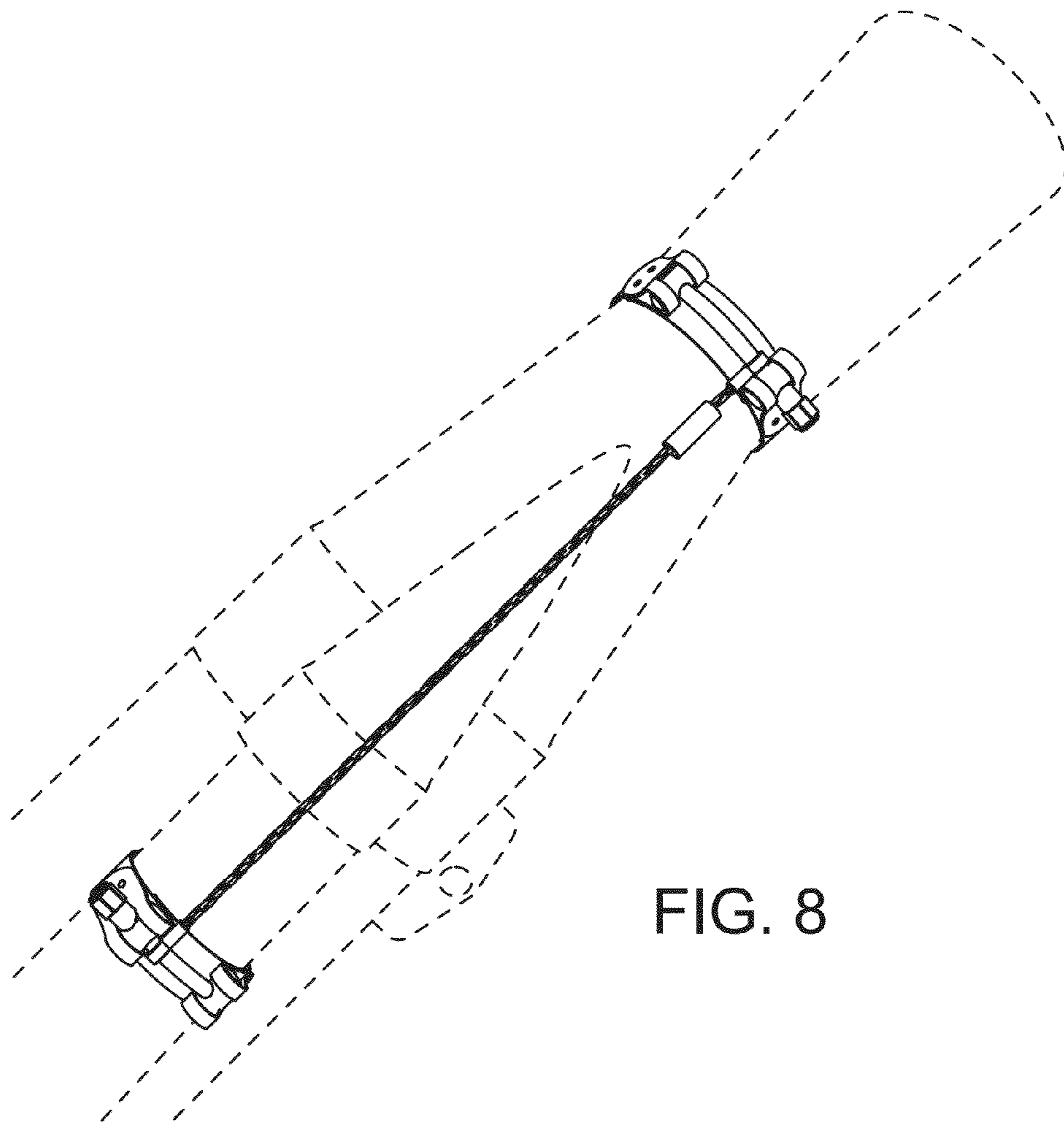
