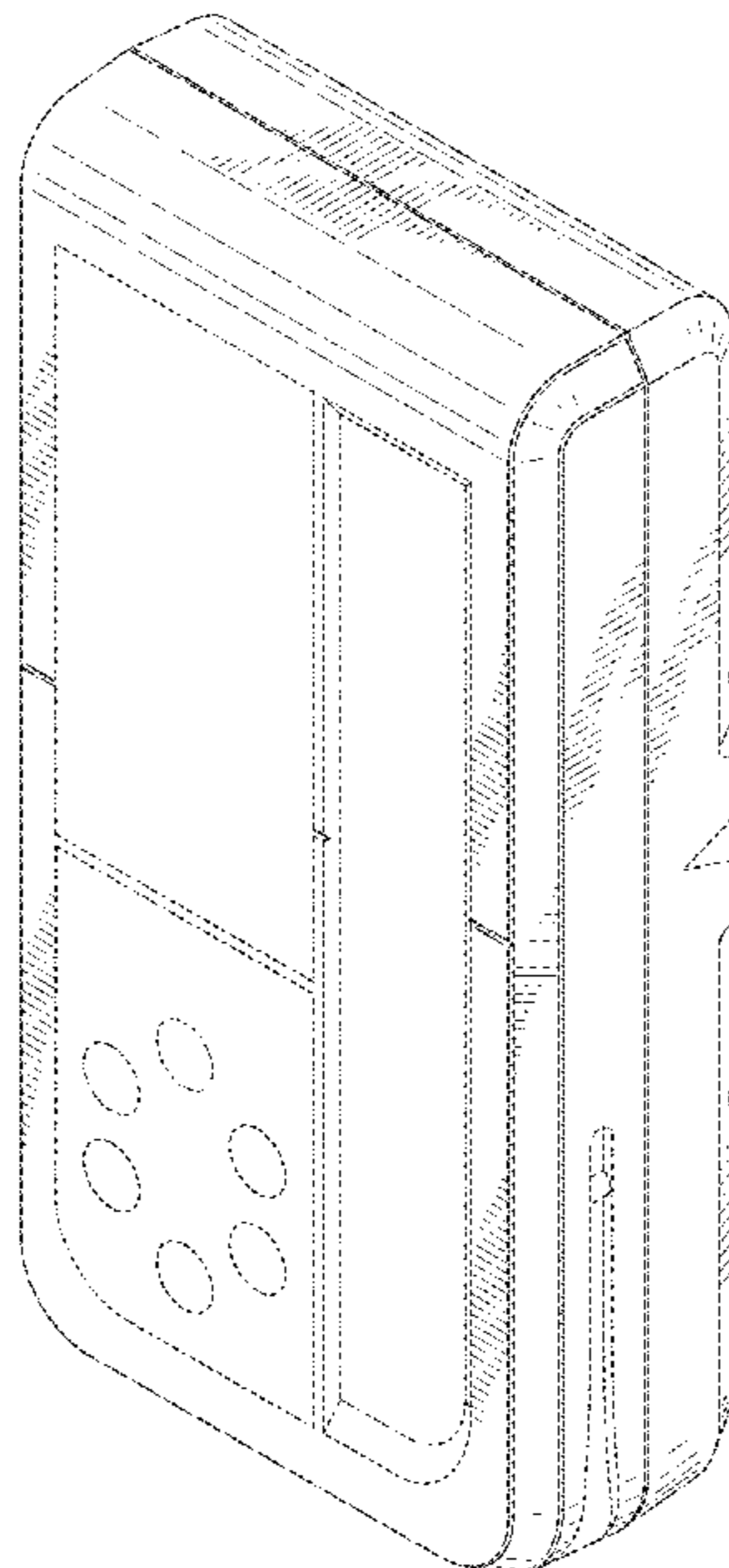
(57) **CLAIM**

The ornamental design for a remote control device, as shown  
and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a remote control device show-  
ing our new design;  
FIG. 2 is a front elevational view showing the design for the  
remote control device of FIG. 1;  
FIG. 3 is a rear elevational view showing the design for the  
remote control device of FIG. 1;  
FIG. 4 is a left side elevational view showing the design for  
the remote control device of FIG. 1;  
FIG. 5 is a right side elevational view showing the design for

FIG. 6 is a top plan view showing the design for the remote

FIG. 7 is a bottom plan view showing the design for the

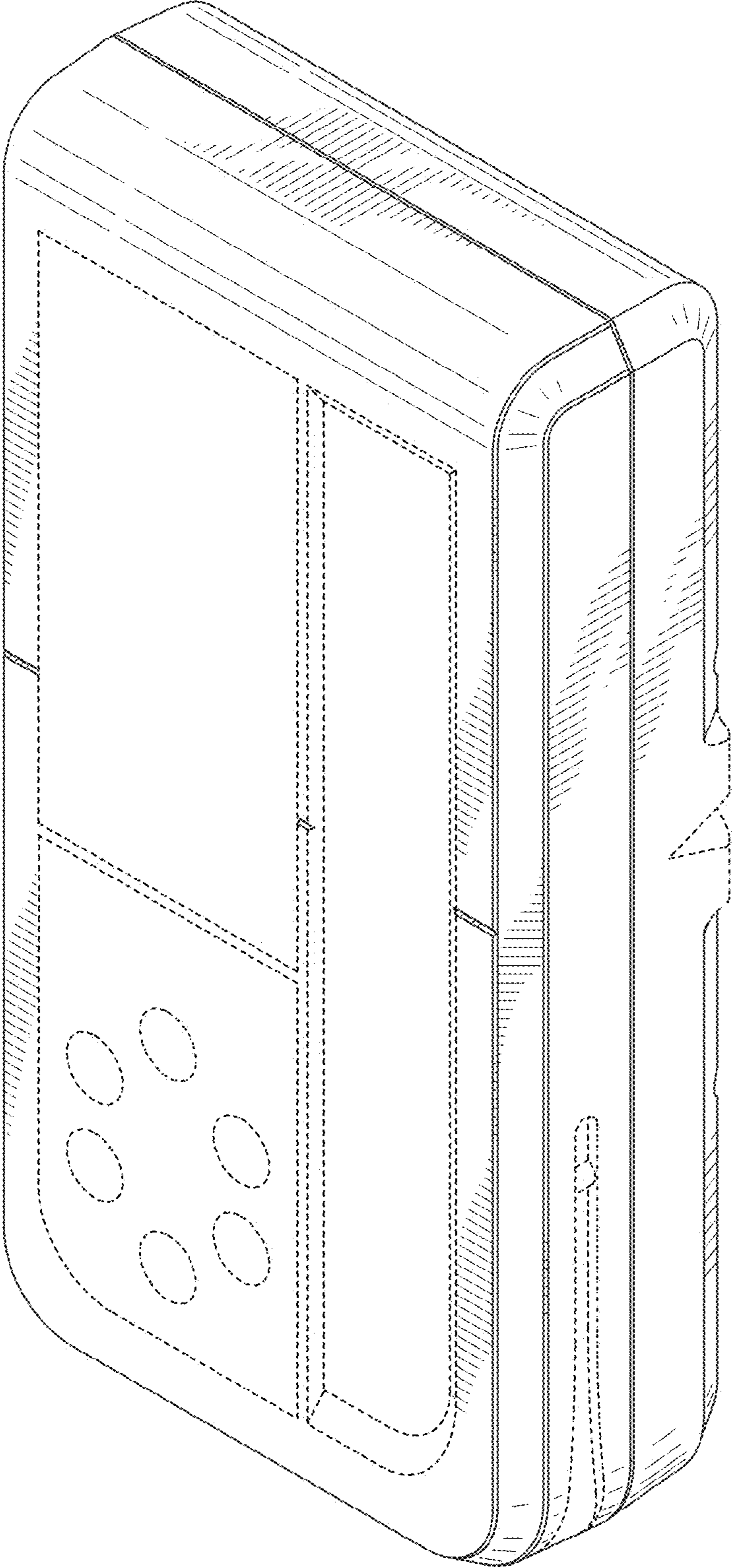

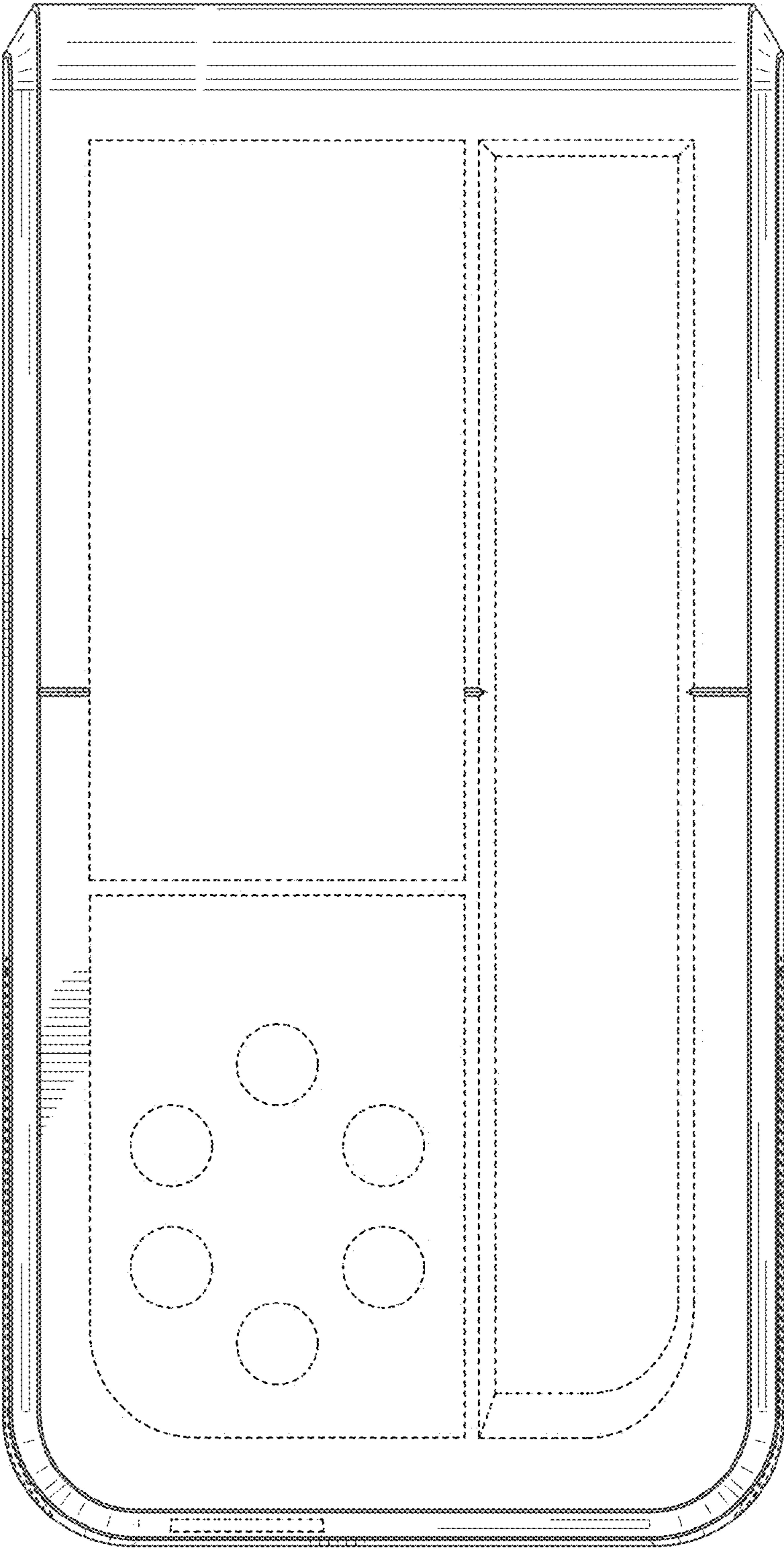

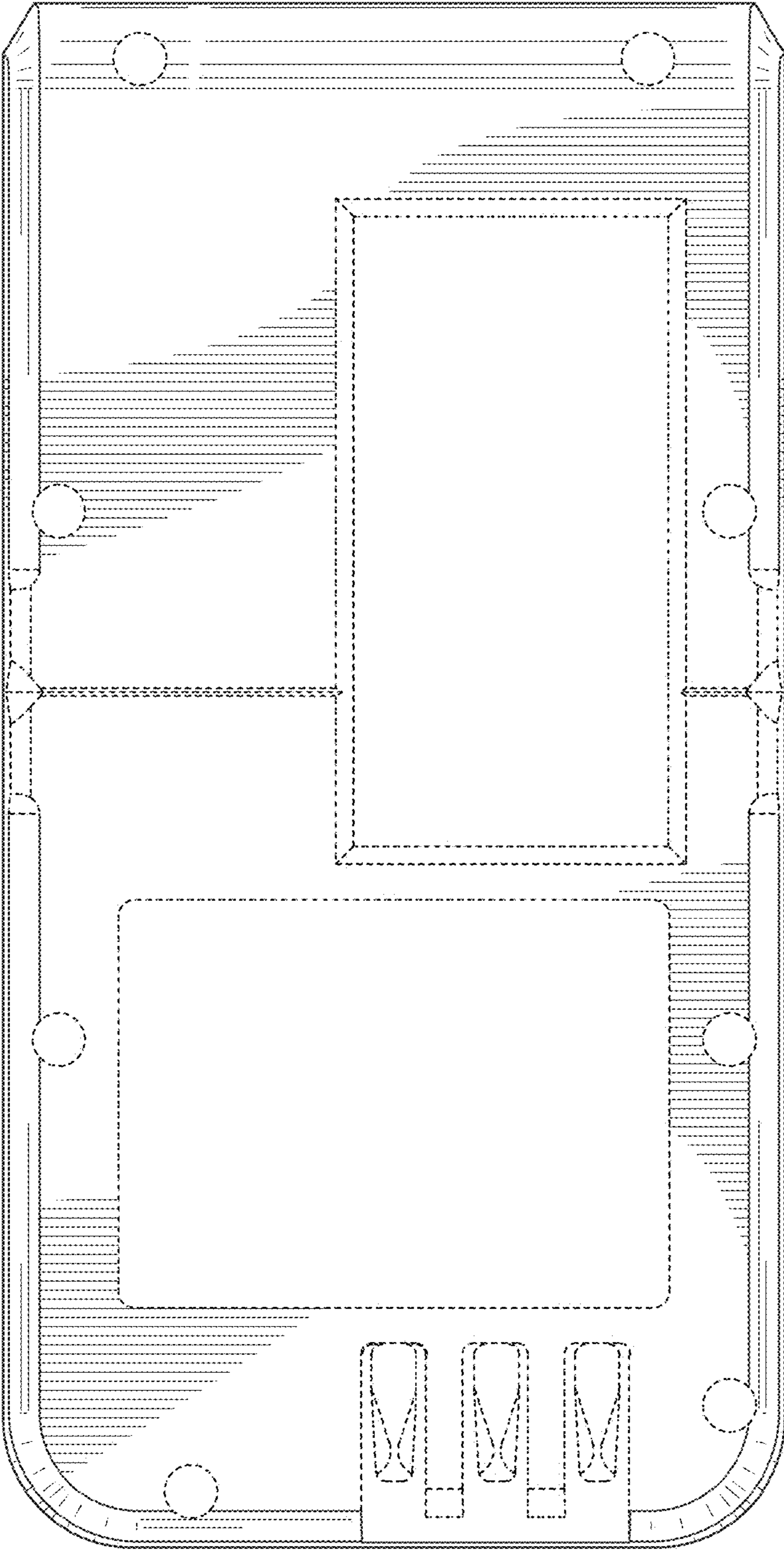

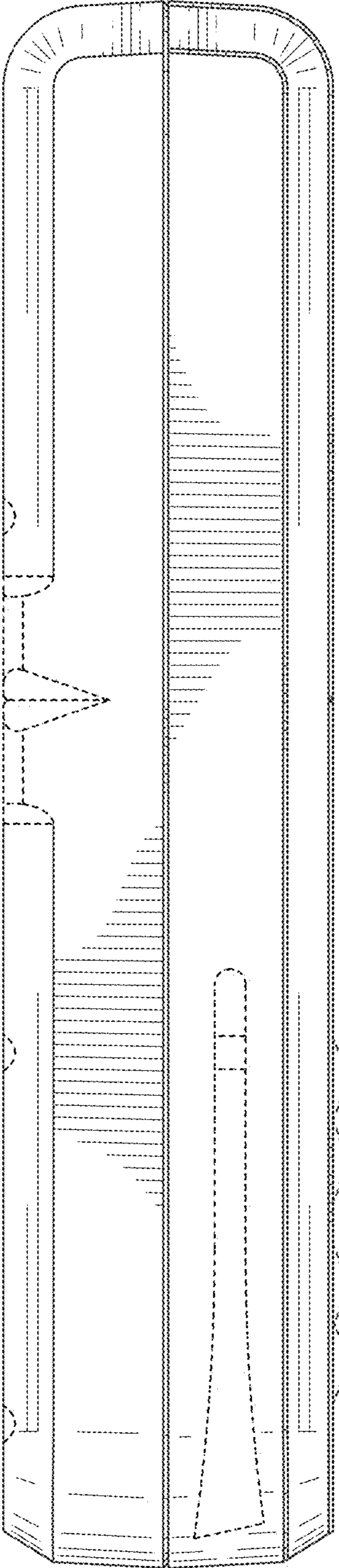

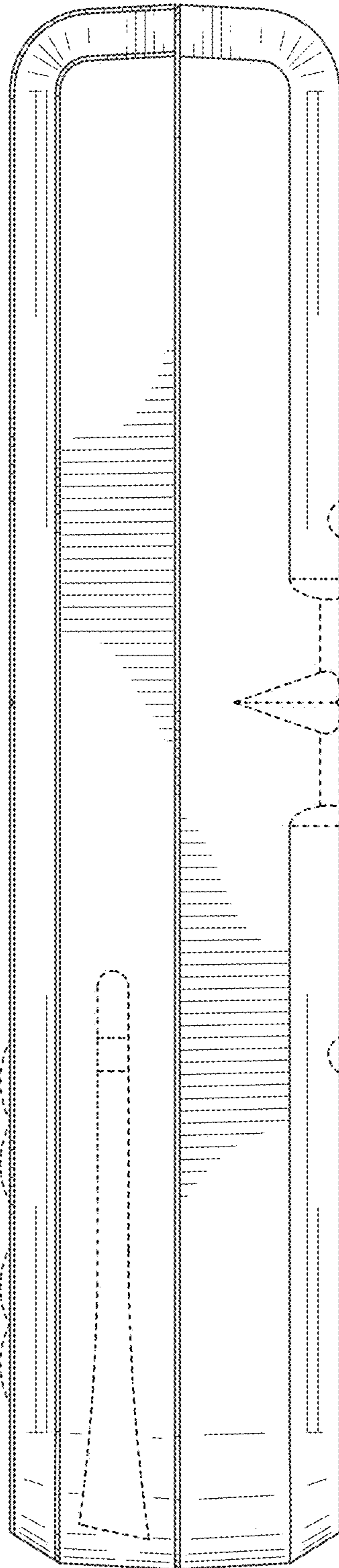

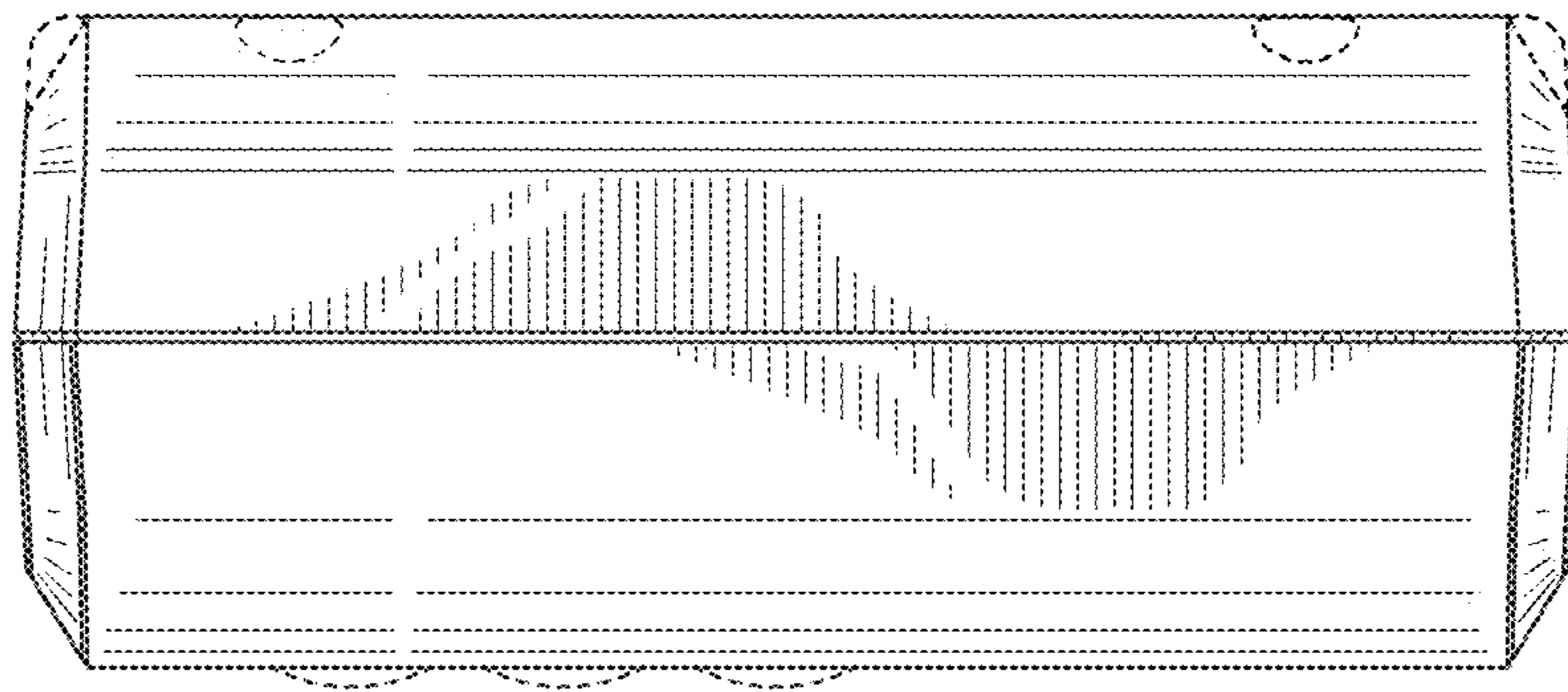

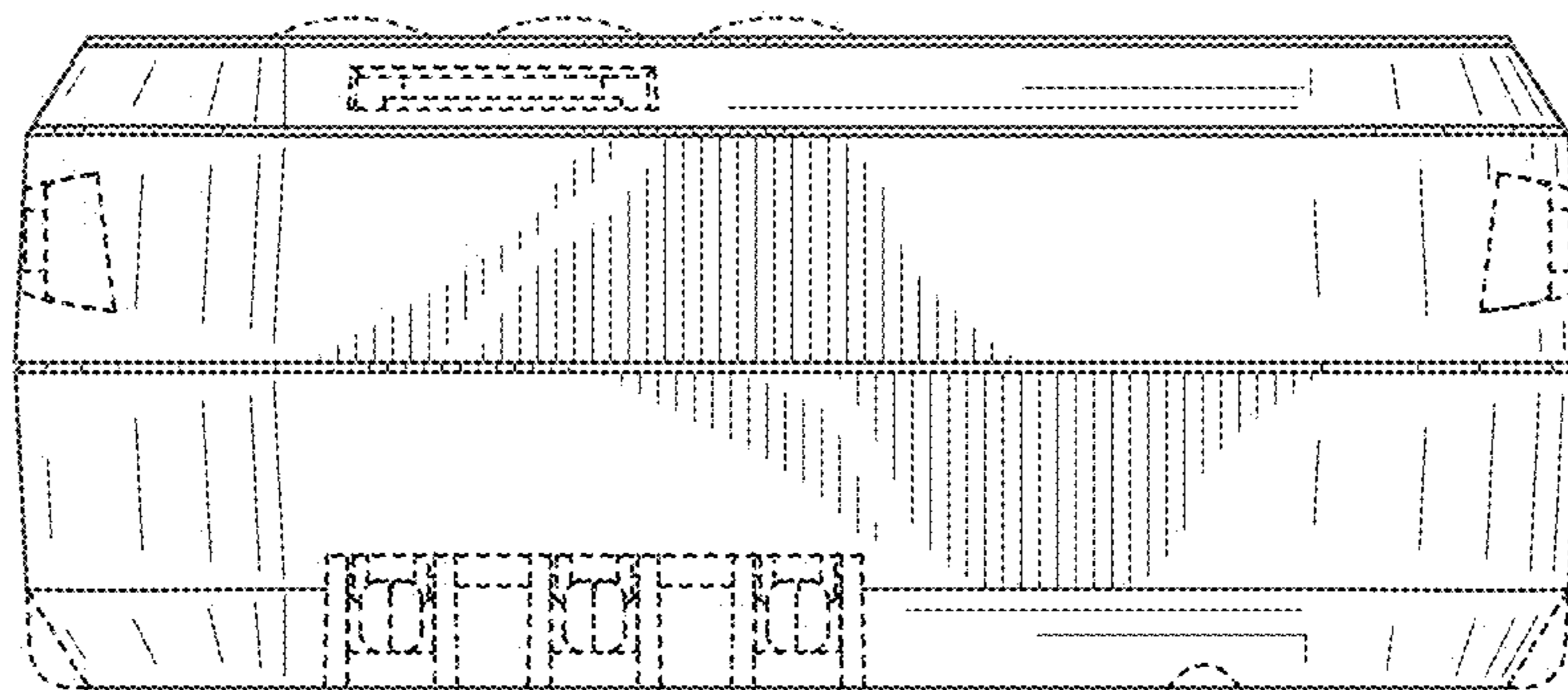
