FIG. 4 is a top view of the lens mount. The broken line disclosure (the lens) is for illustrative purposes only and forms no part of the claimed design.

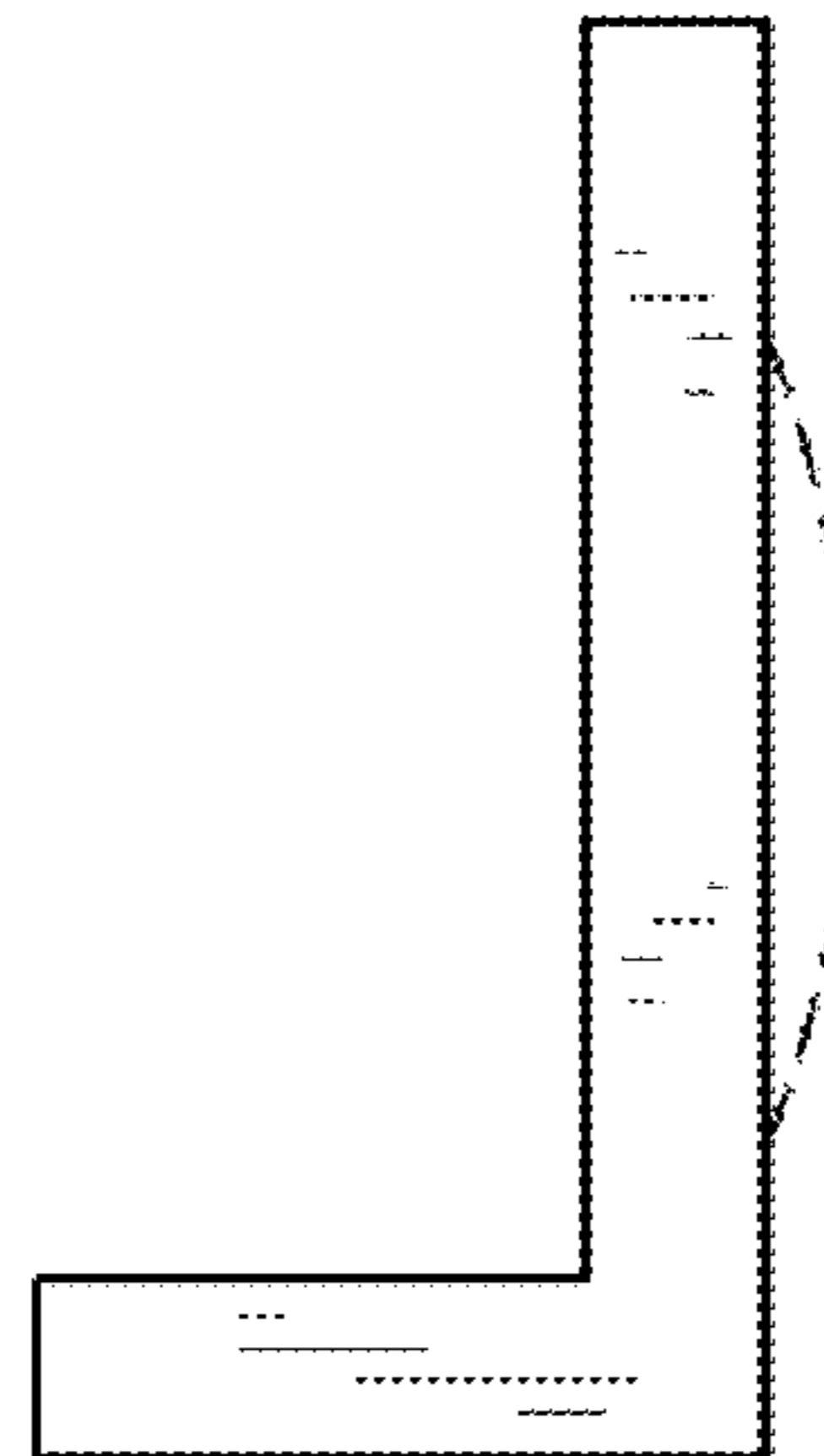
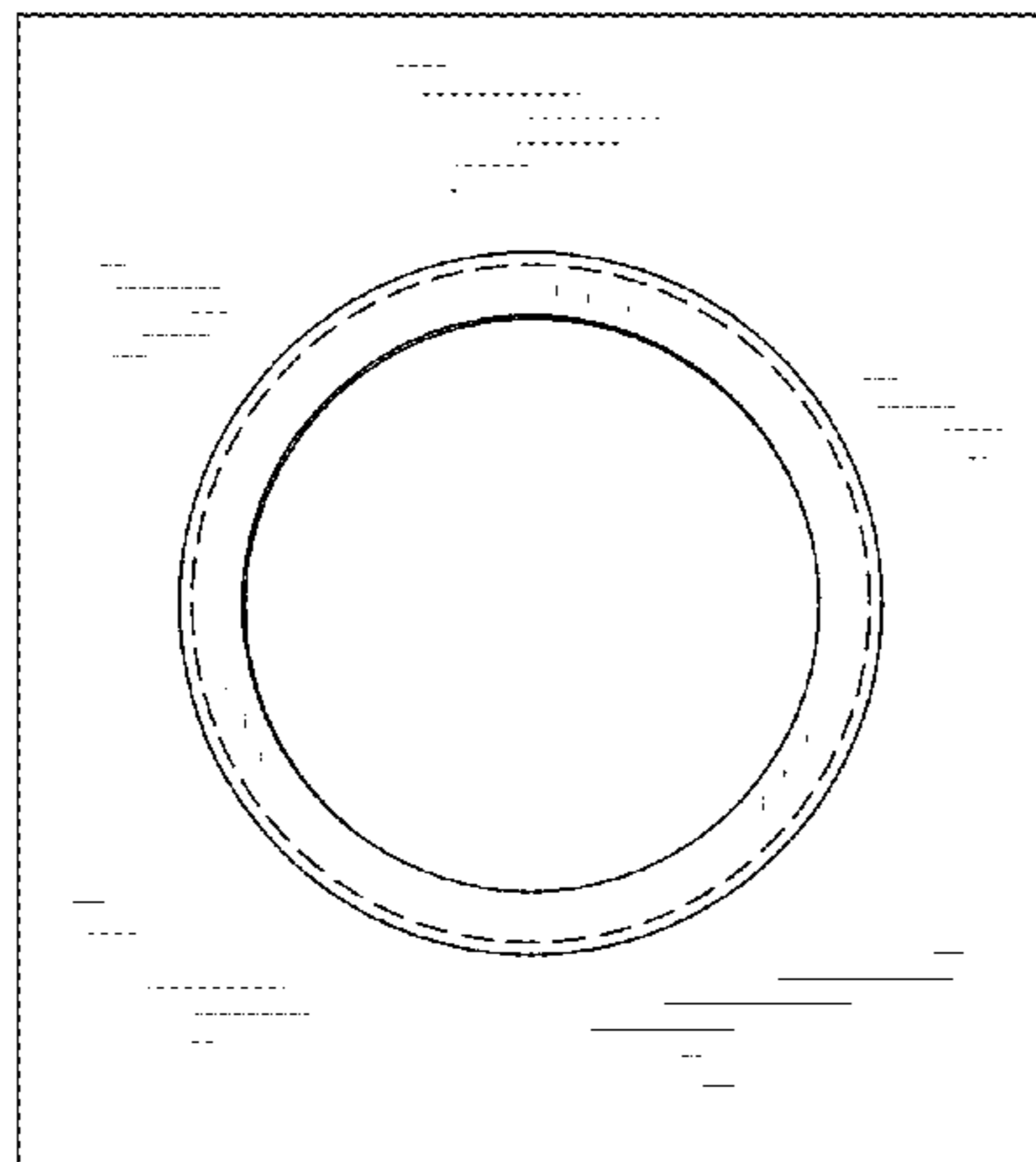
FIG. 5 is a bottom view of the lens mount. The broken line disclosure (the lens) is for illustrative purposes only and forms no part of the claimed design.

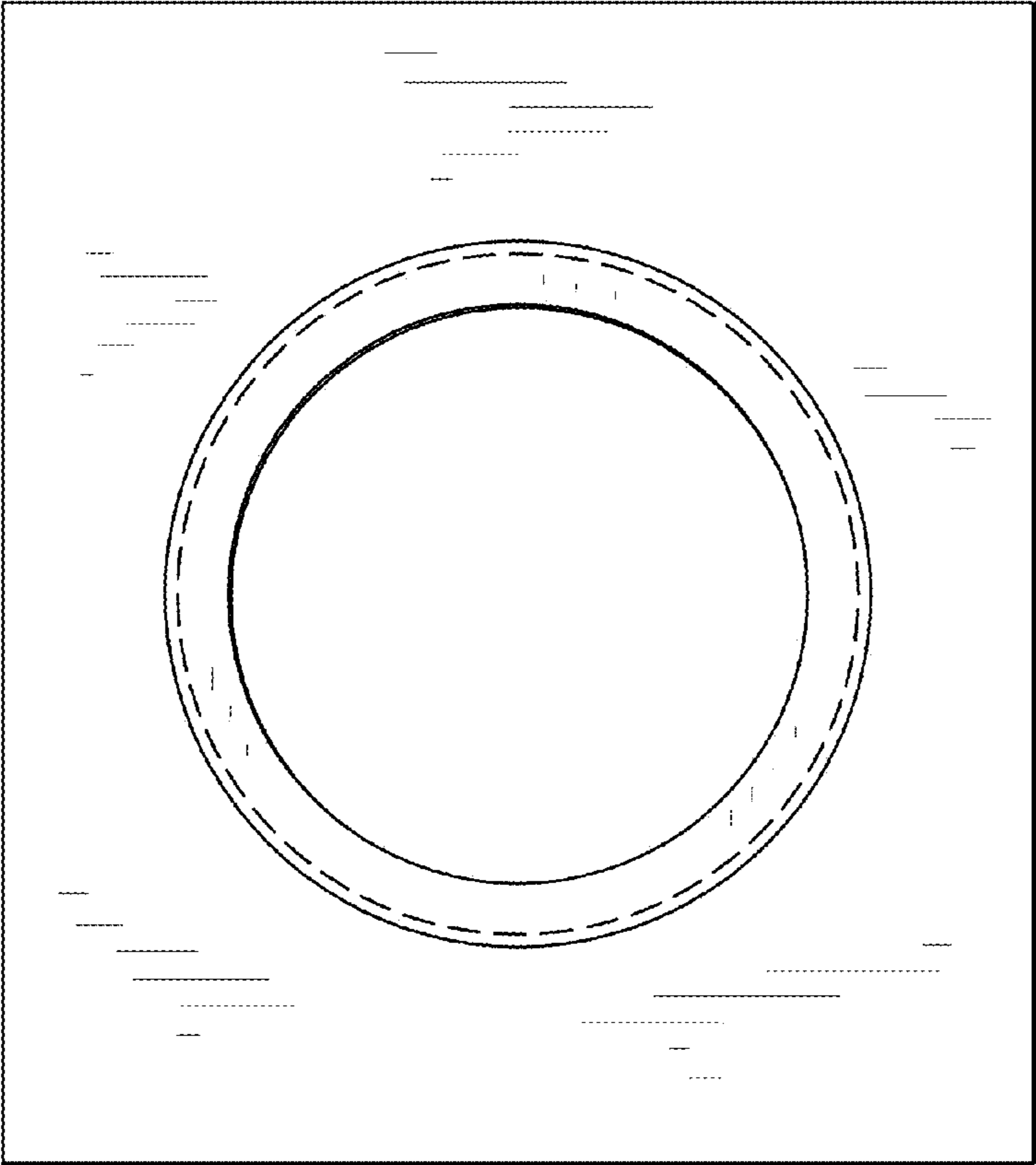

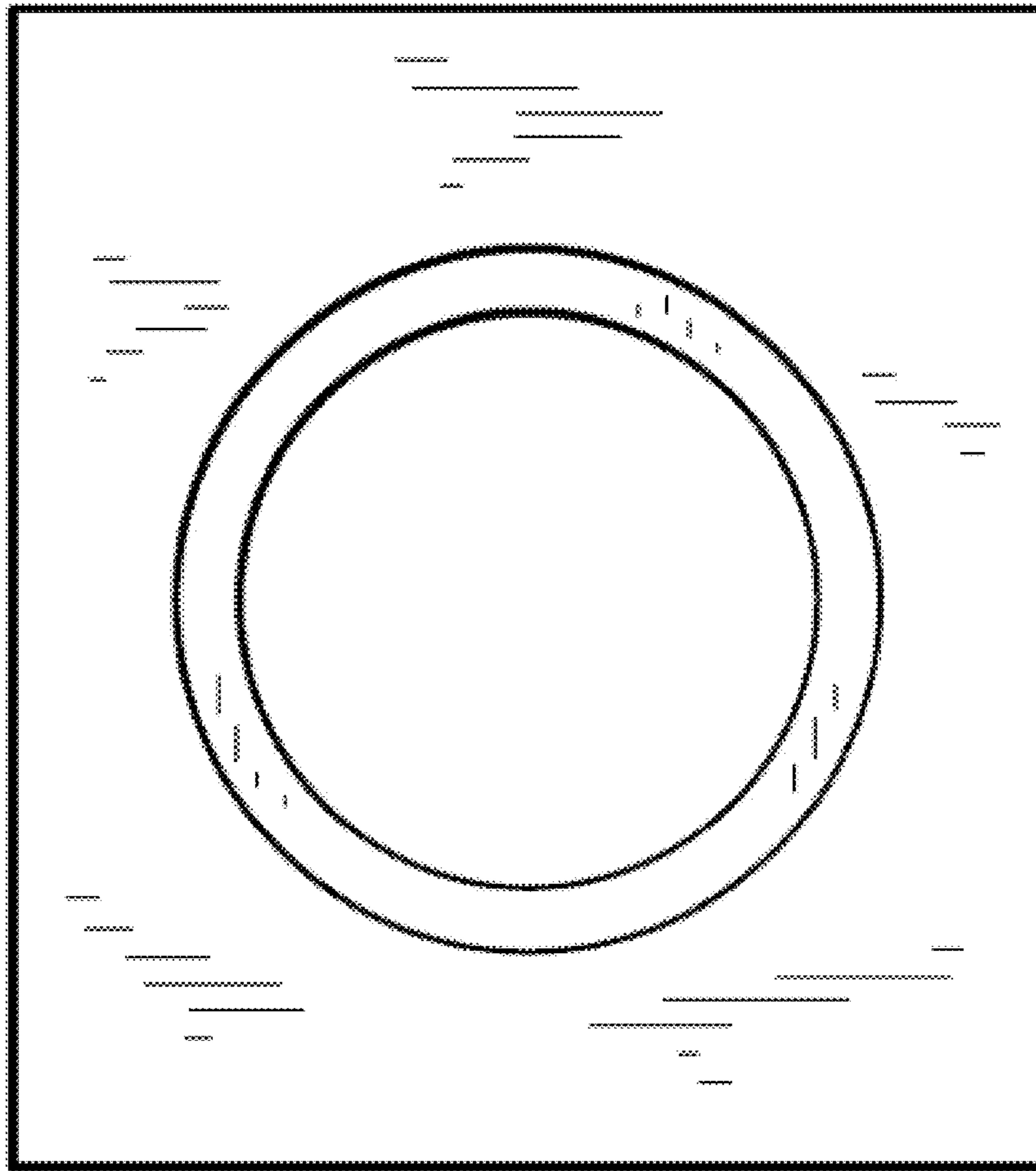

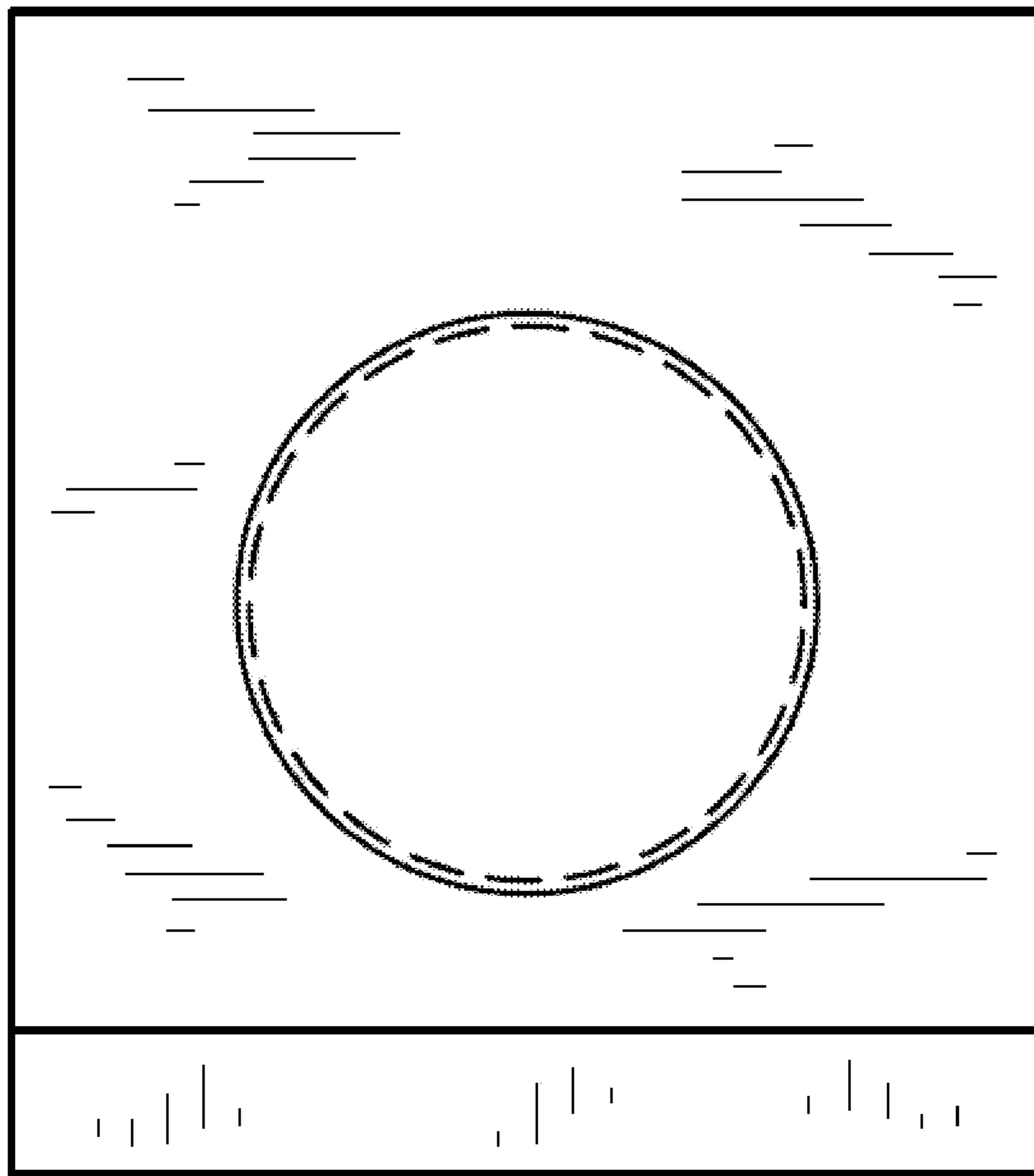

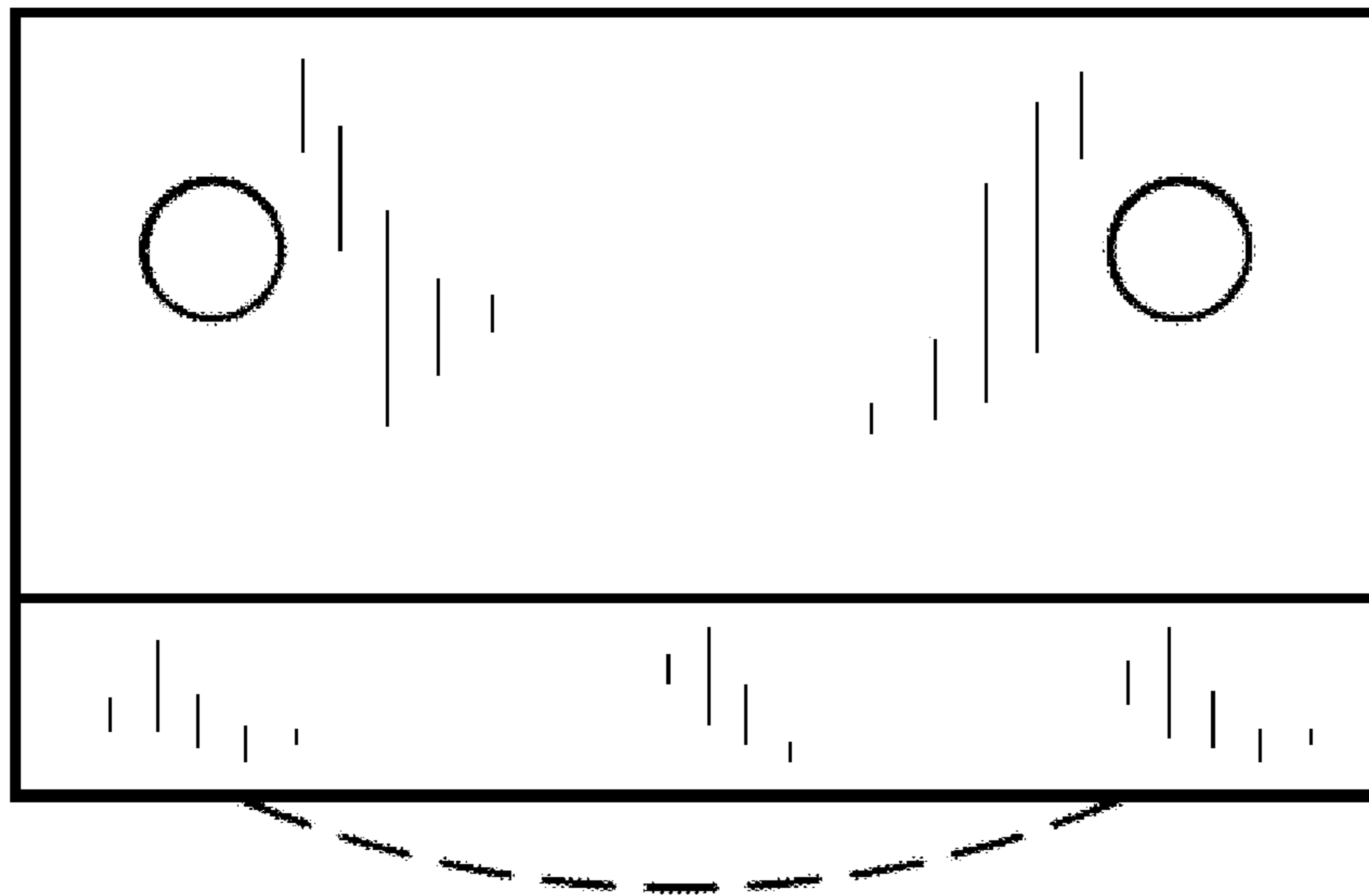

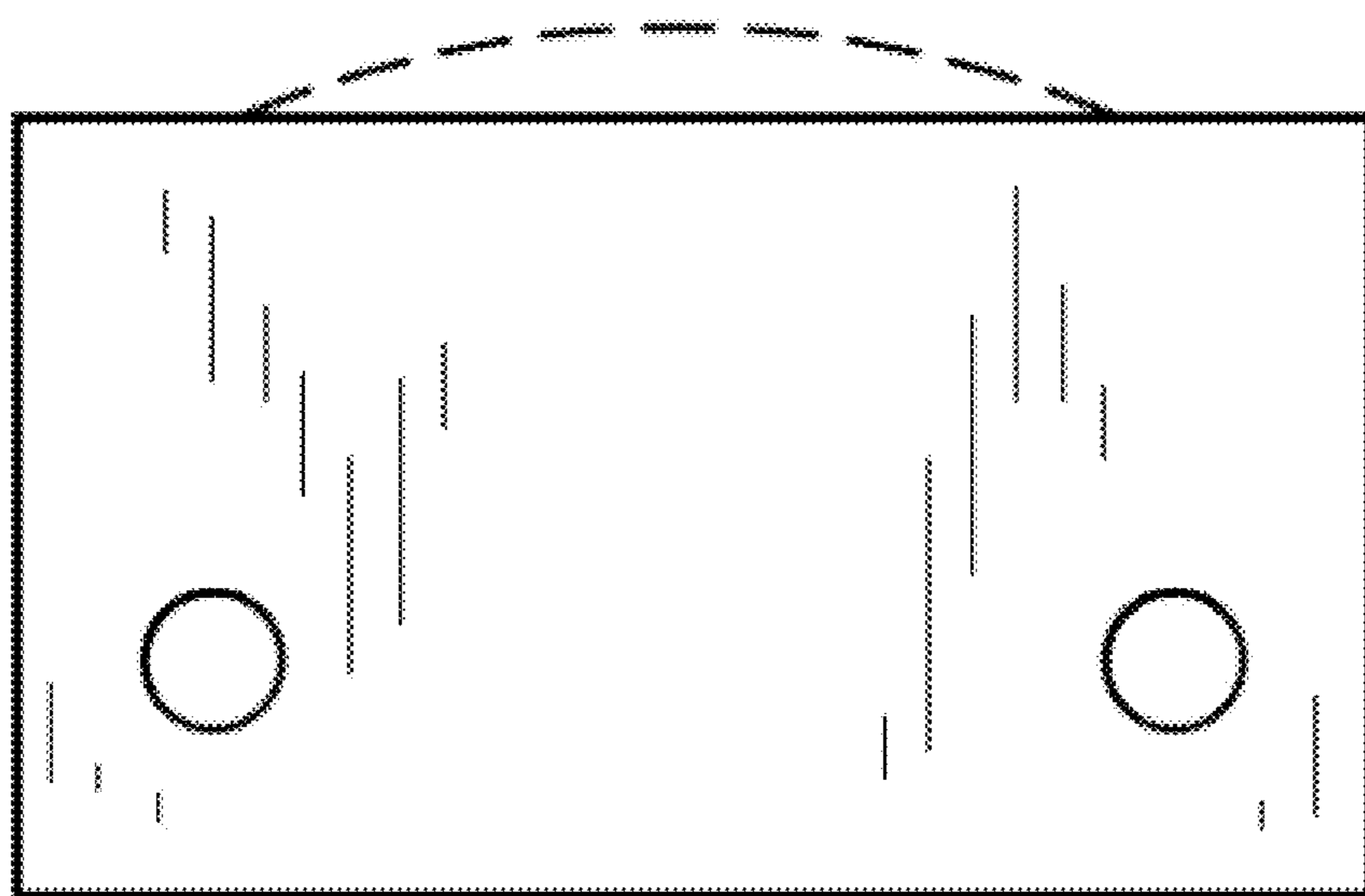

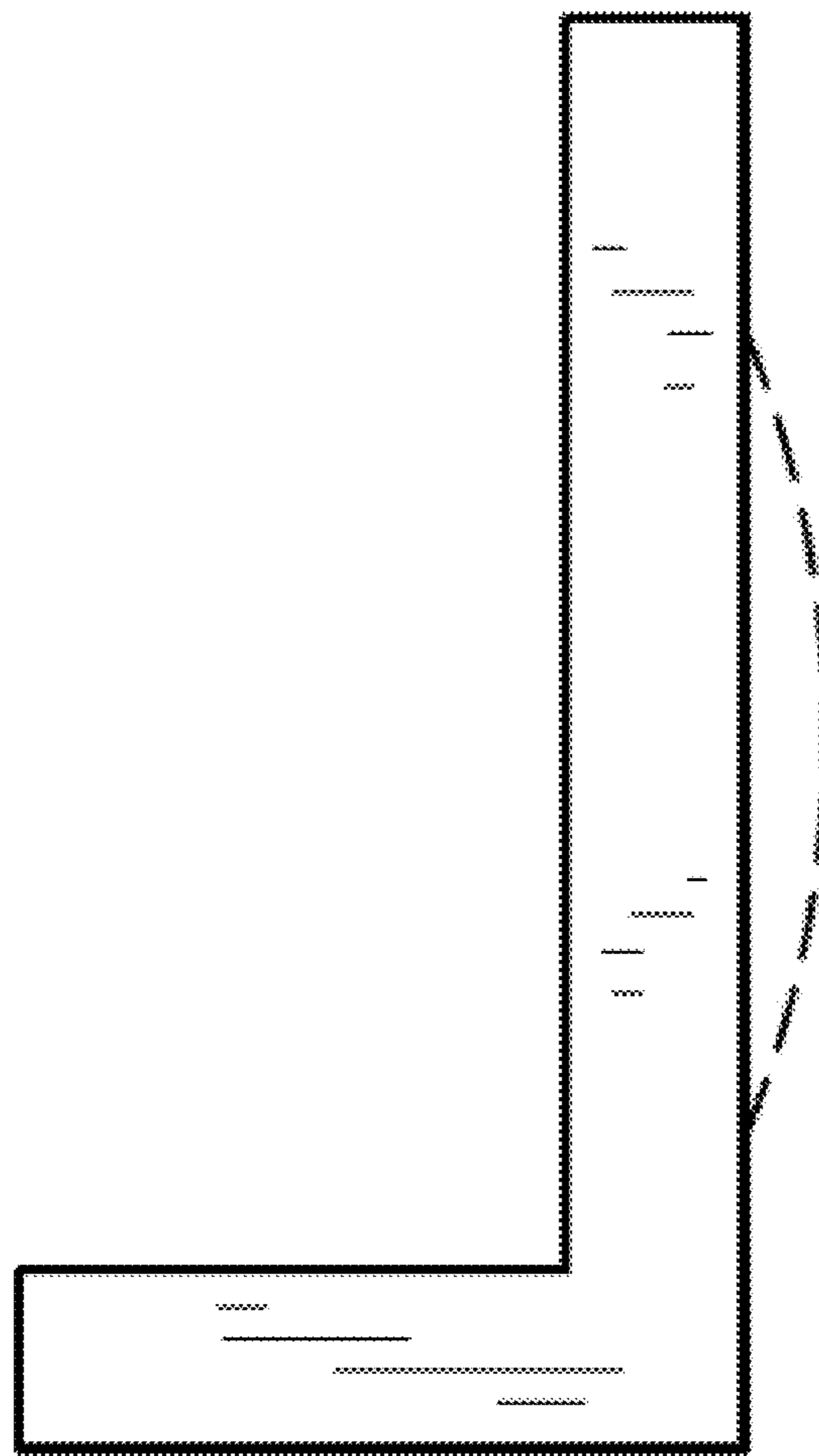
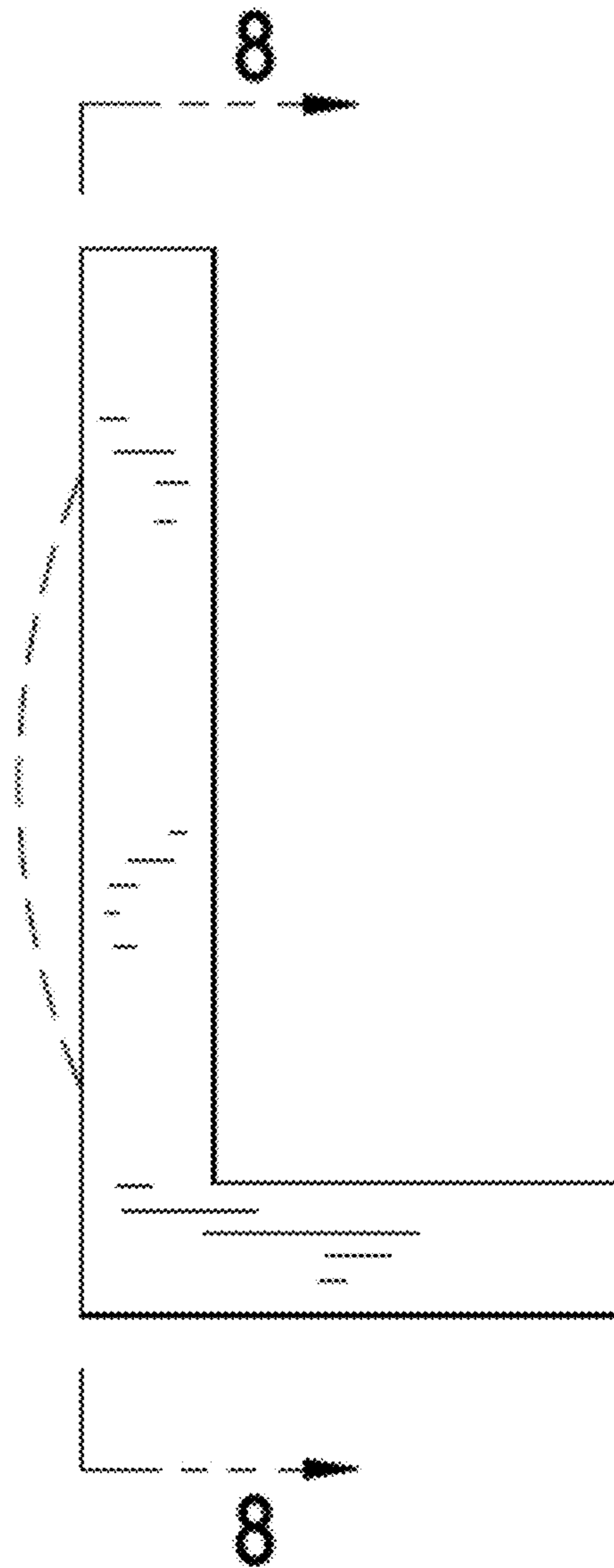

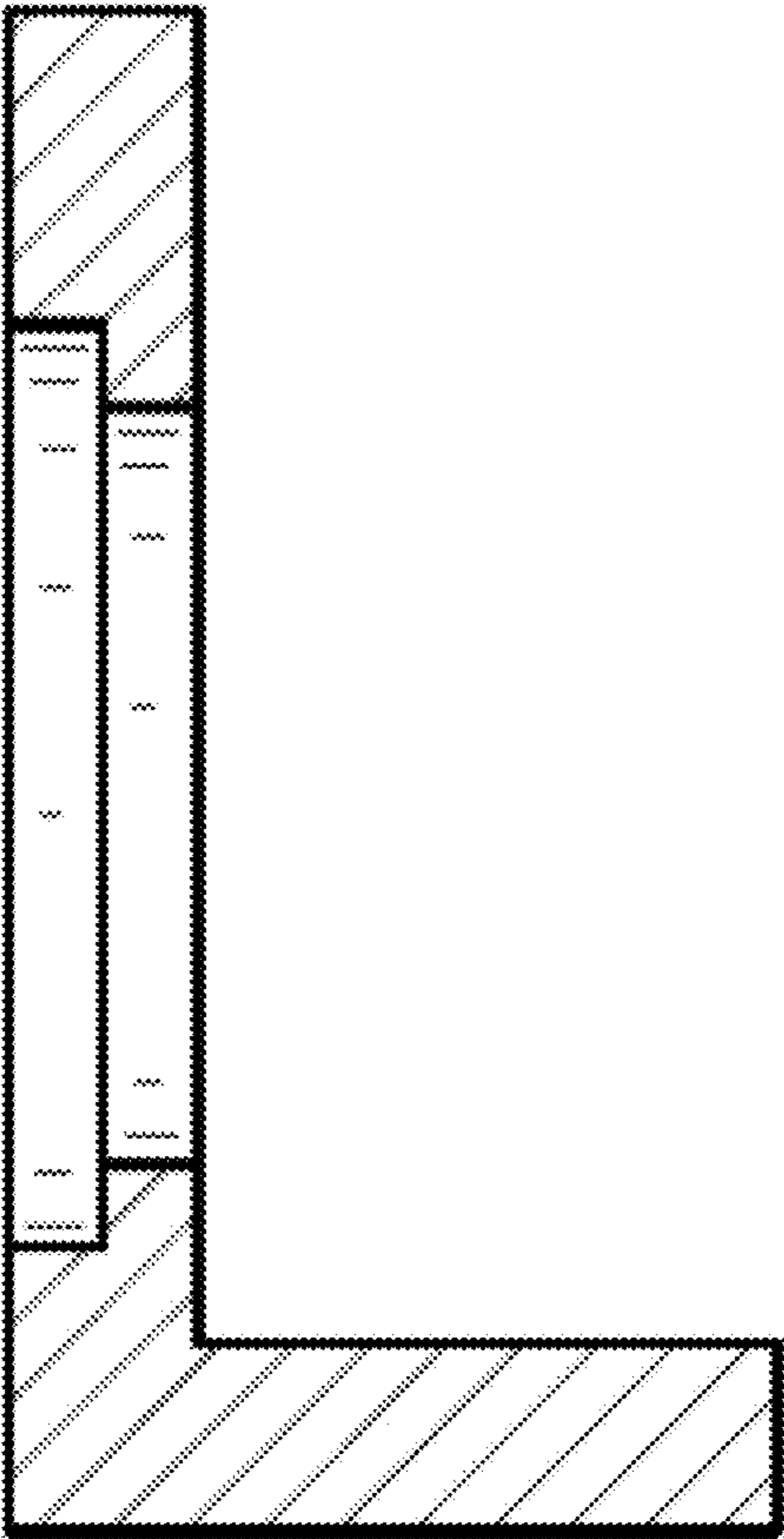
