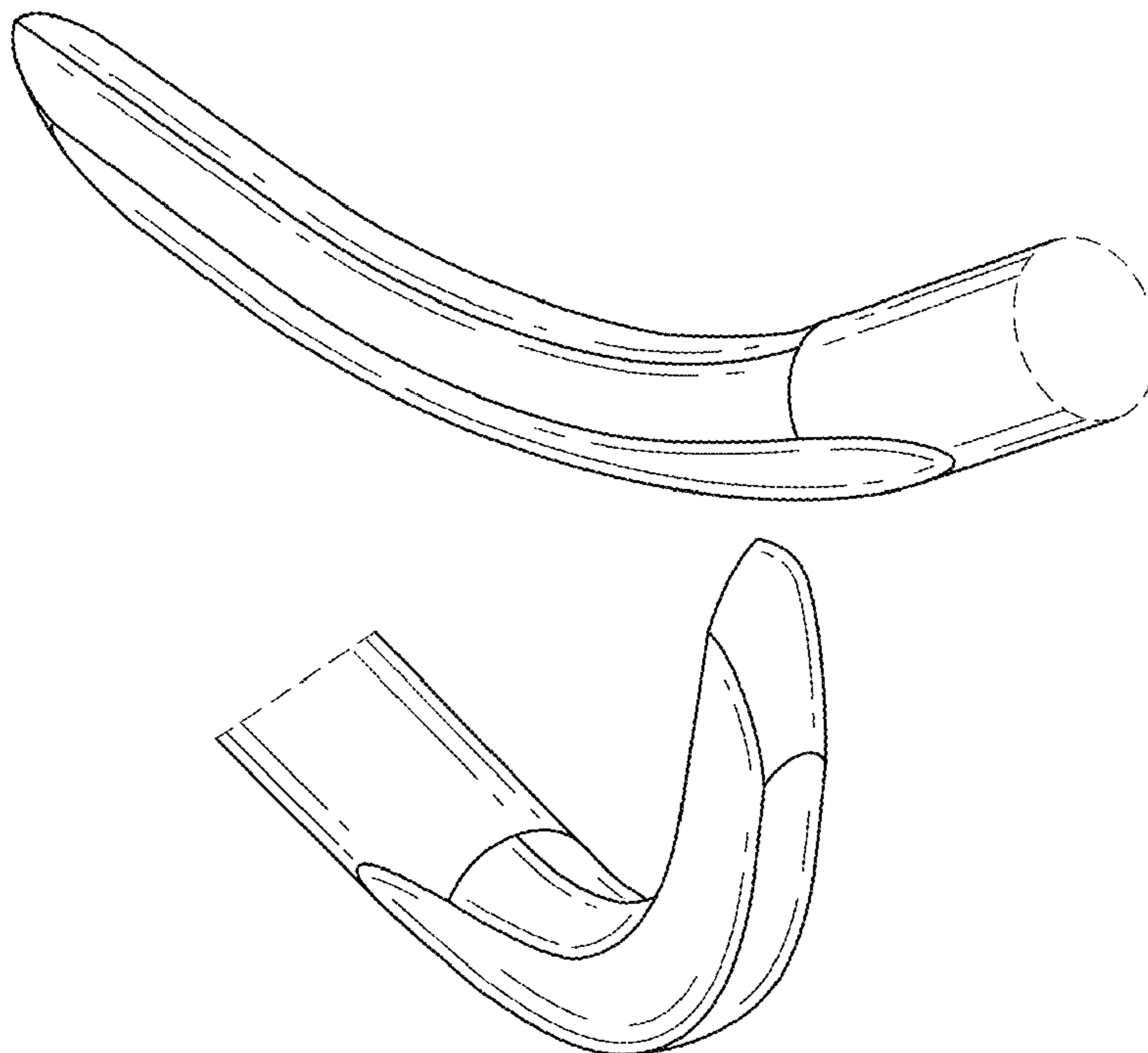
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front perspective view of a dental scaler comprising the new design;
FIG. 2 is a back perspective view of the design of FIG. 1;

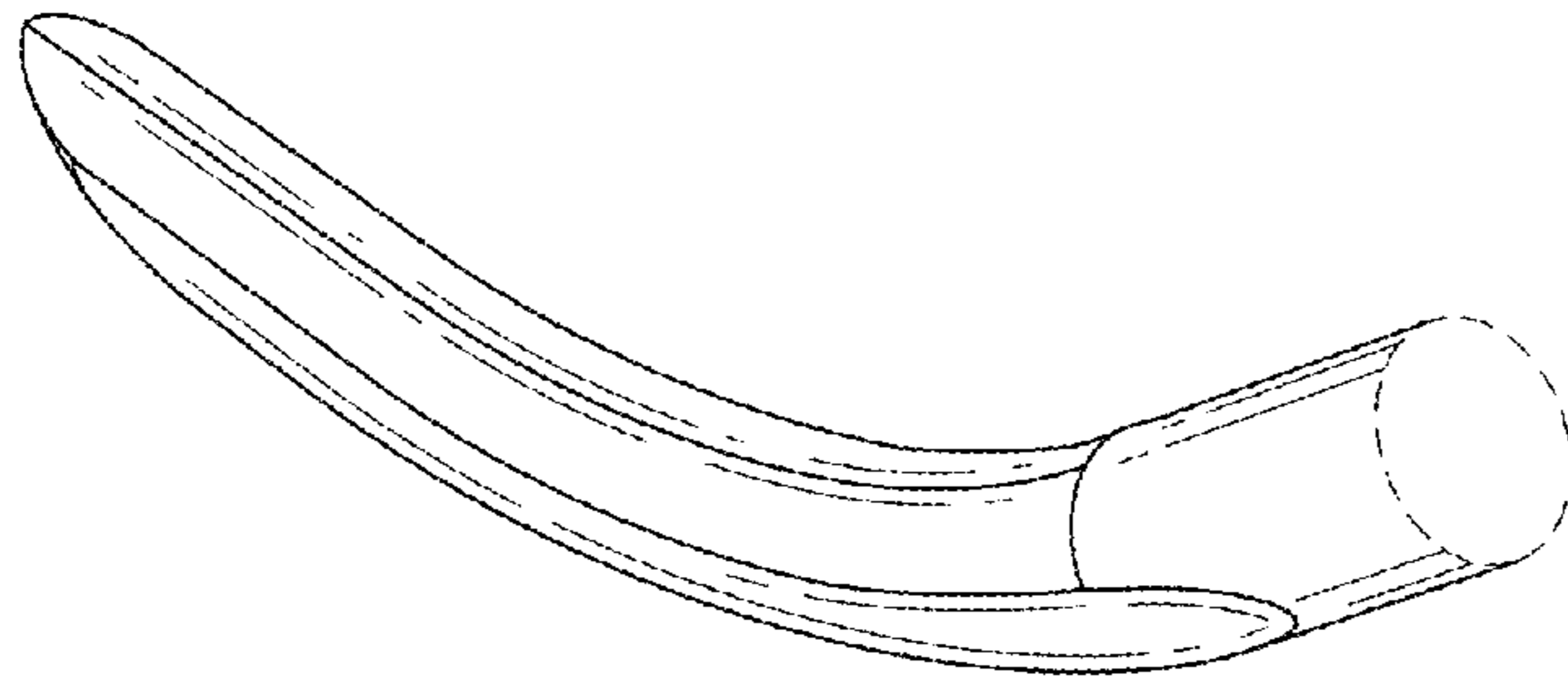

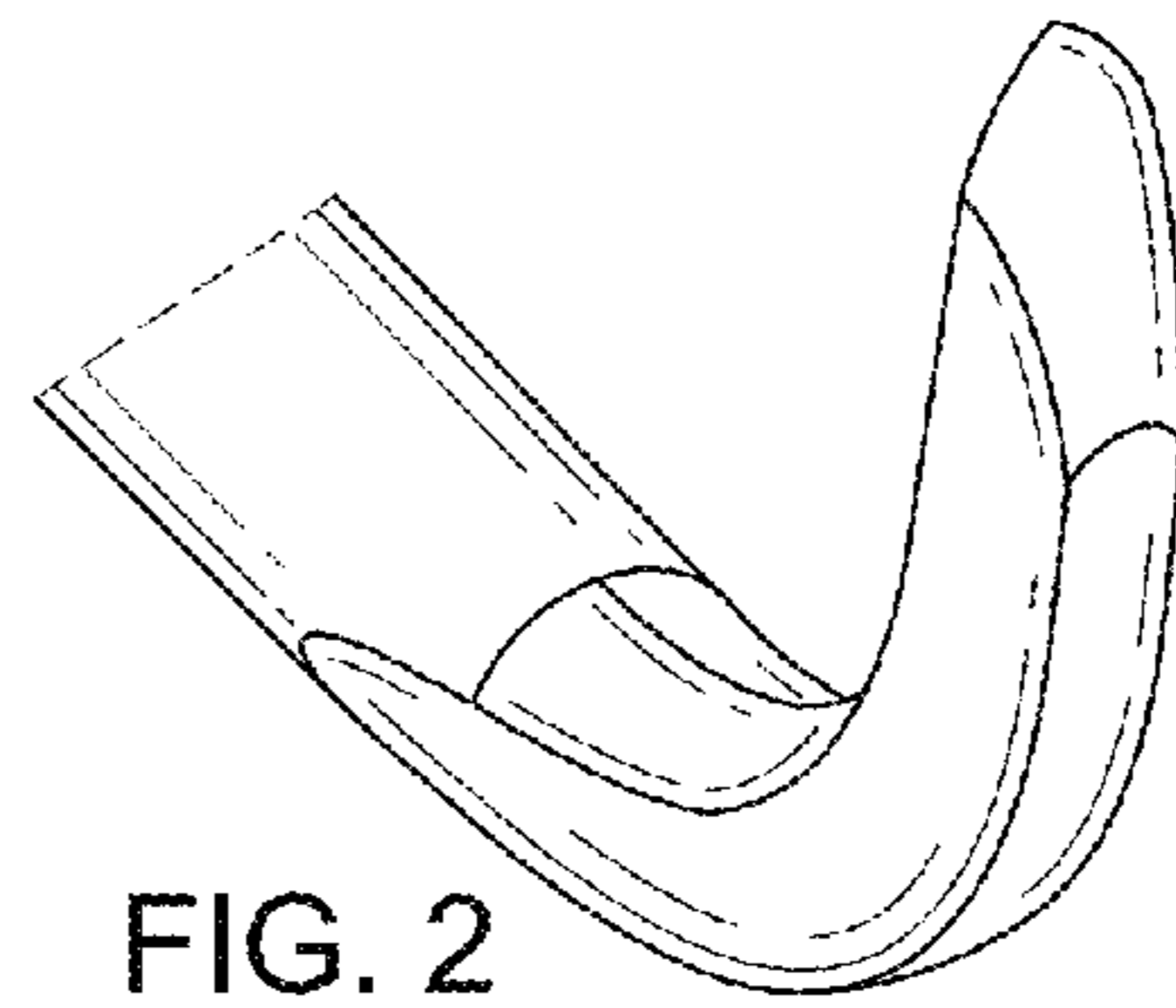

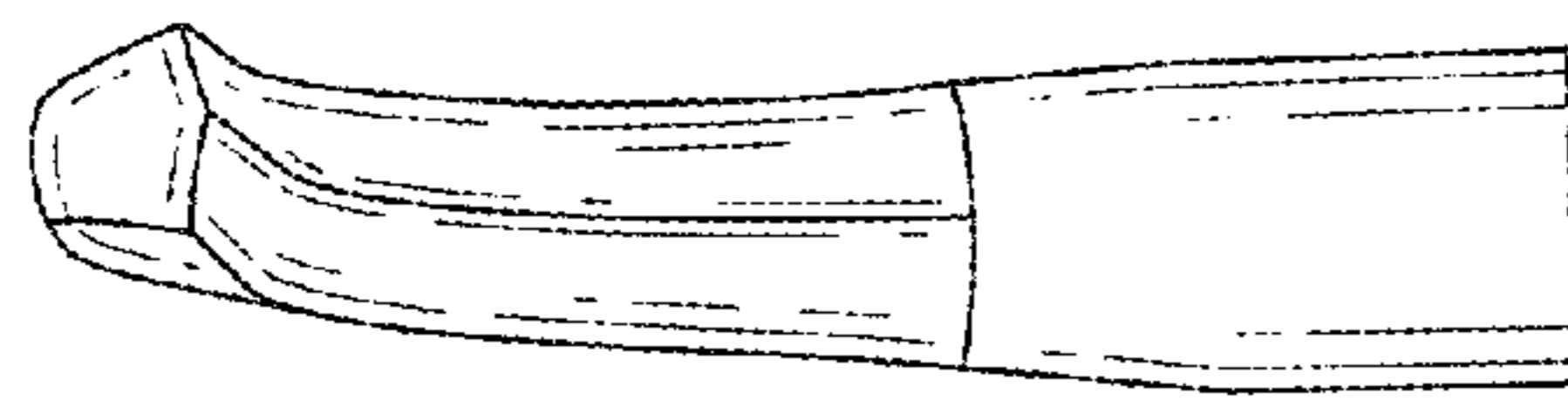

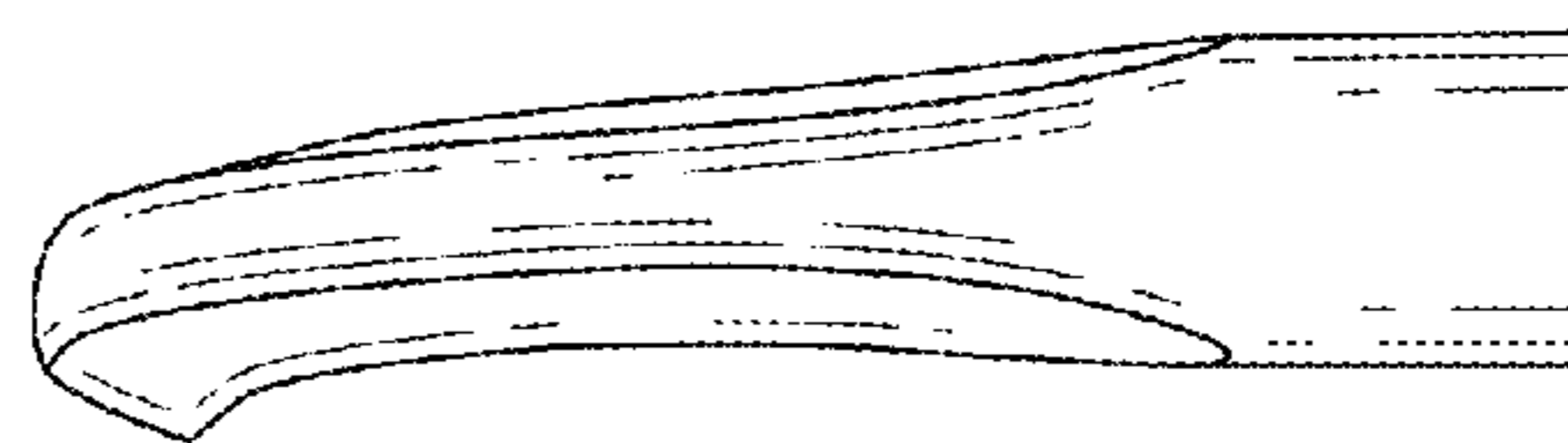

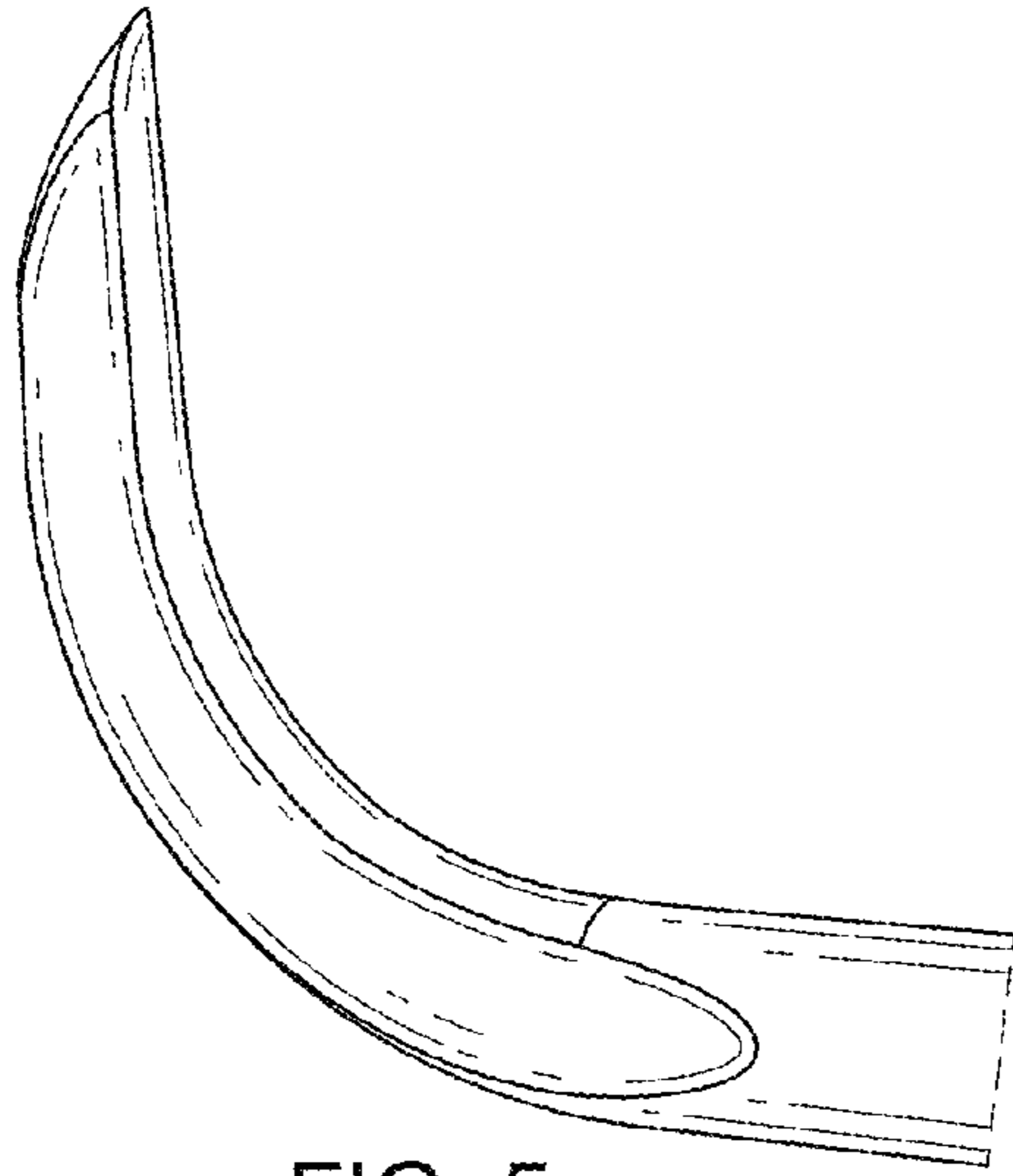

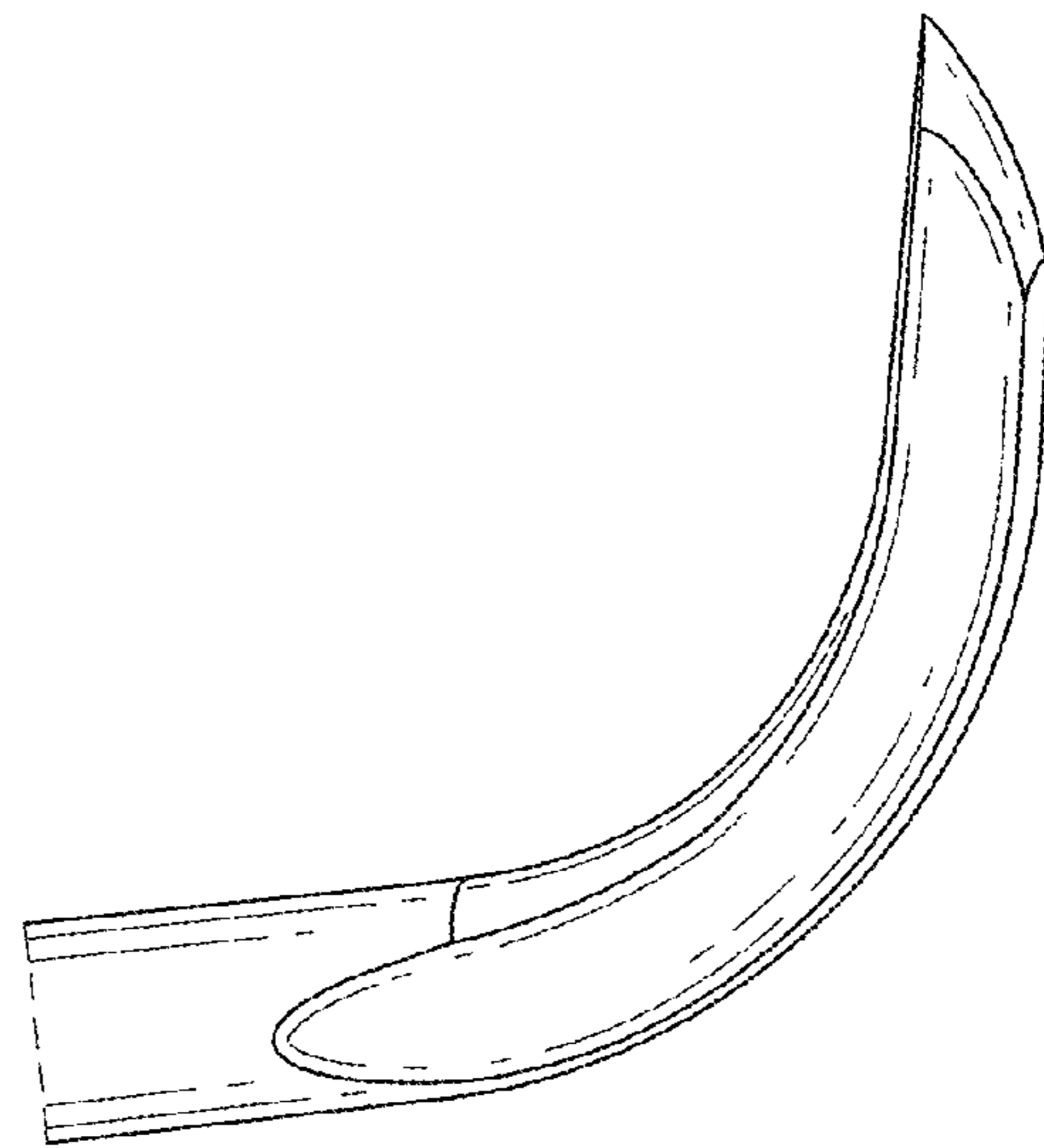

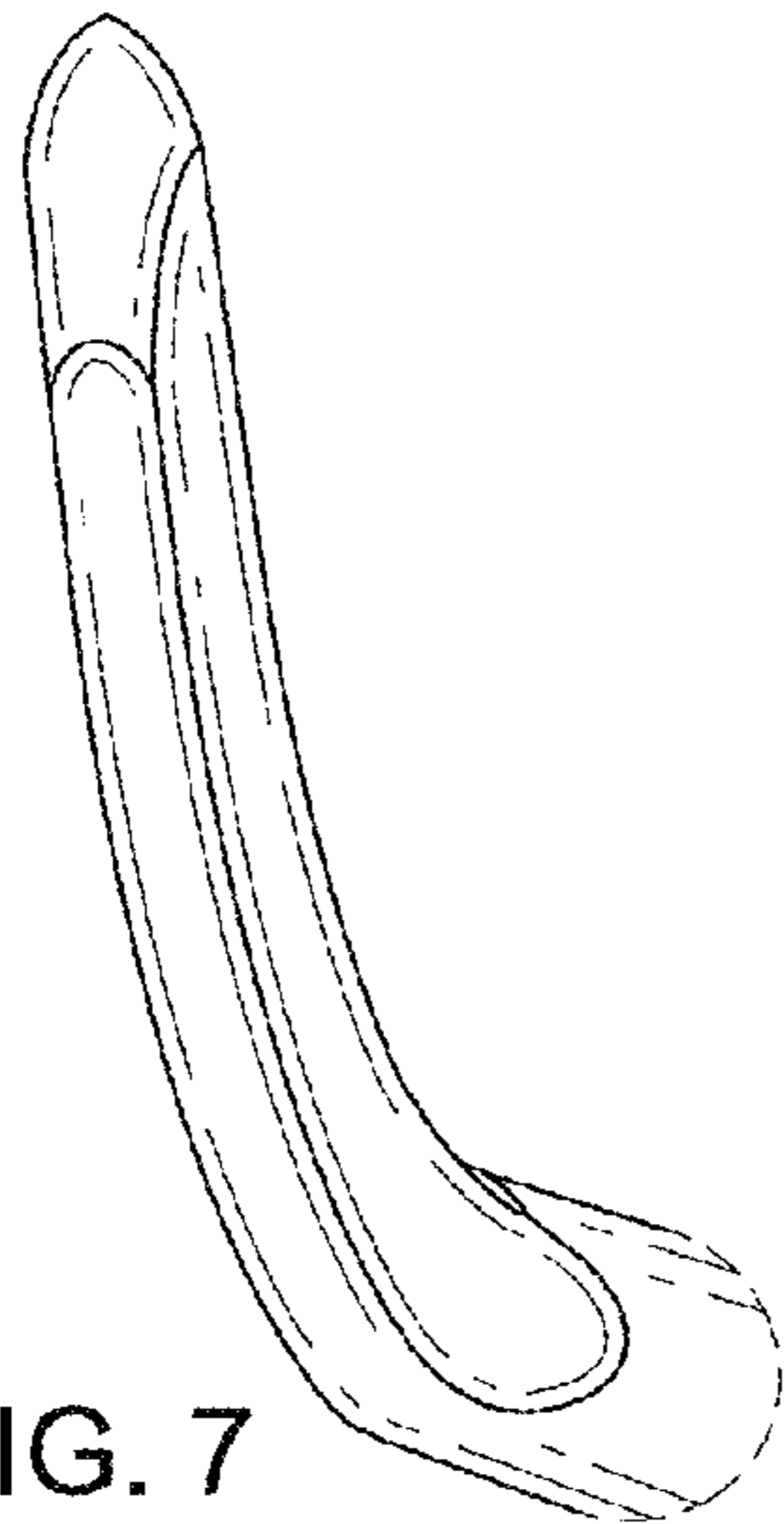

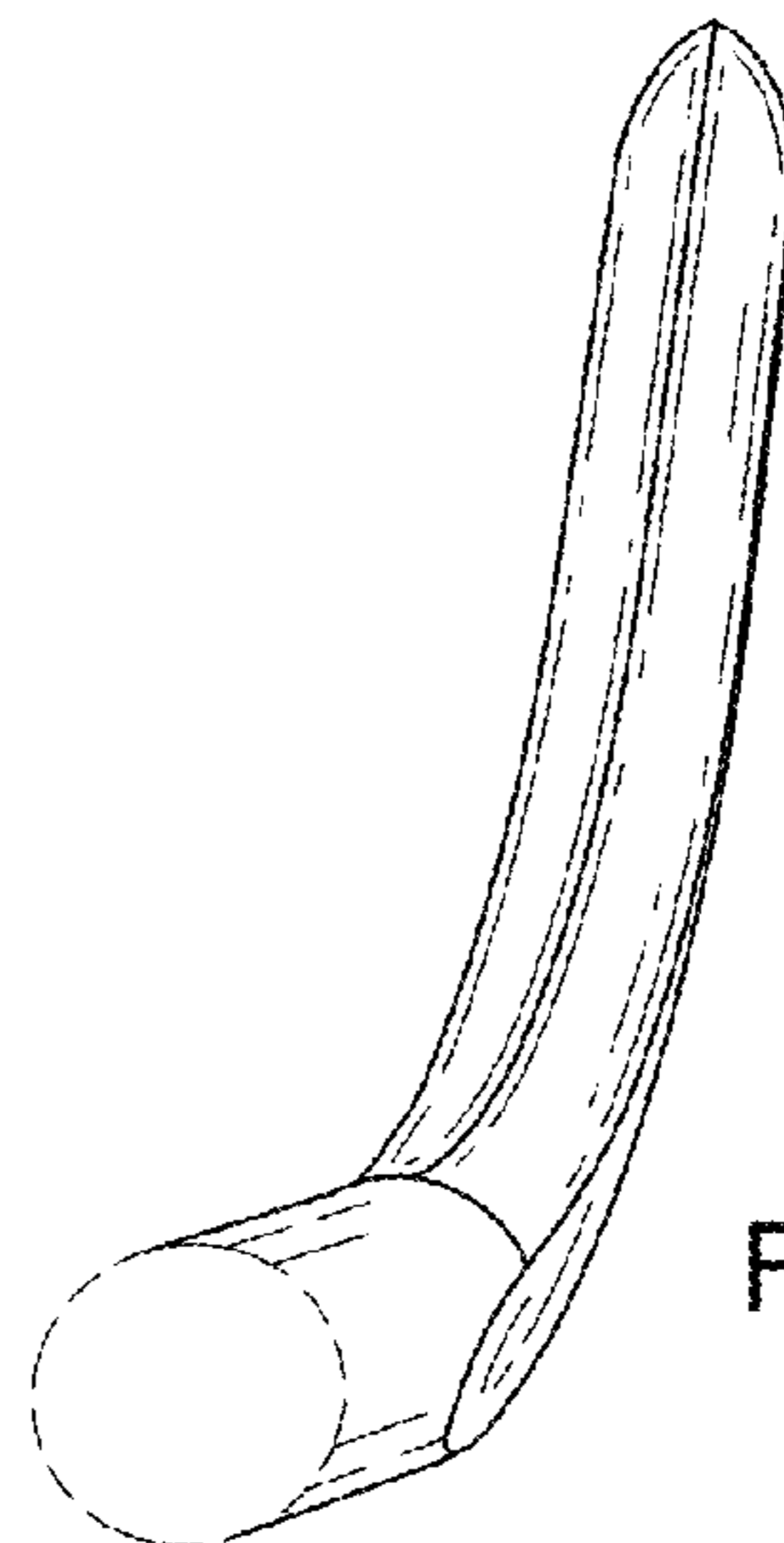

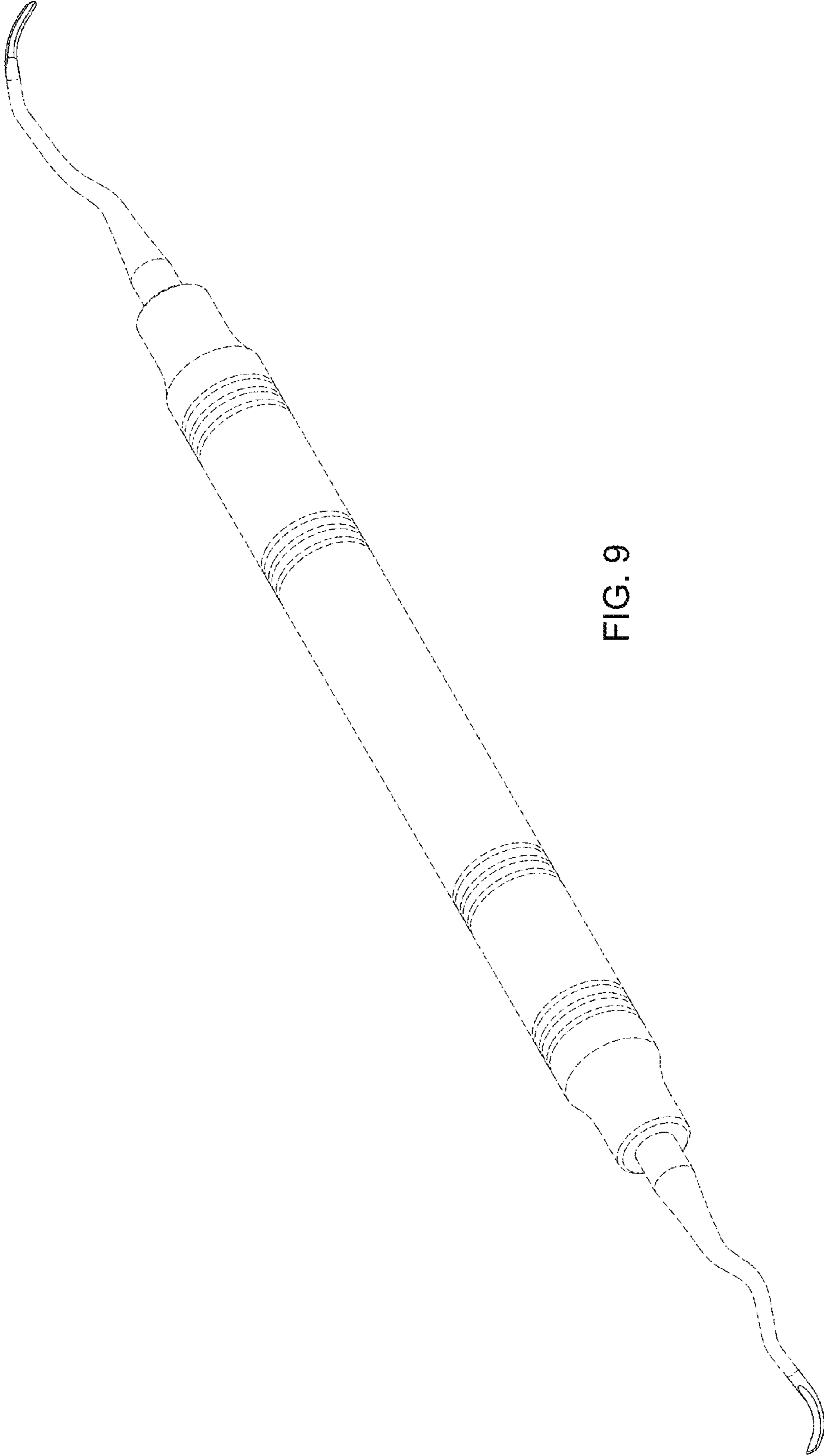
