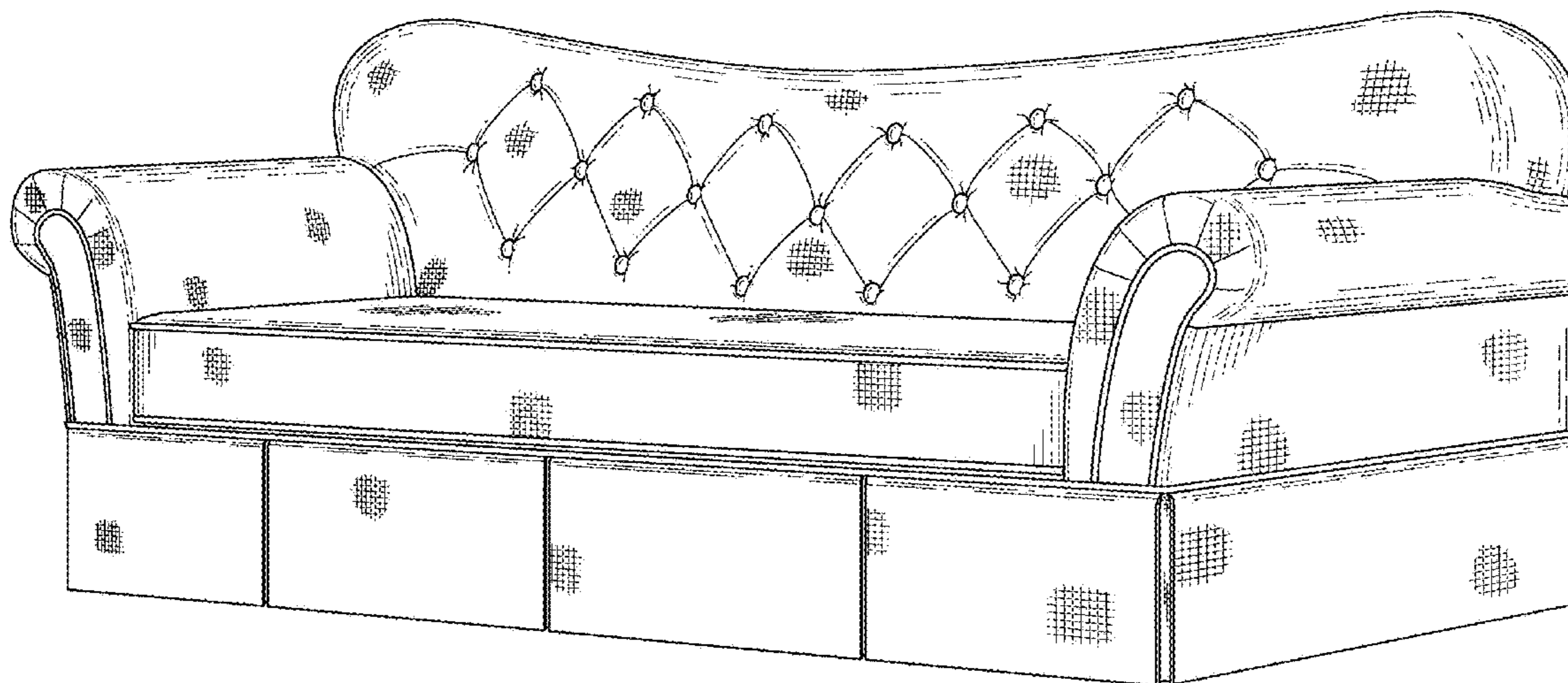
(57) **CLAIM**

The ornamental design for a sofa, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, front, right side perspective view of a sofa showing my new design;  
FIG. 2 is a front elevational view thereof;  
FIG. 3 is a rear elevational view thereof;  
FIG. 4 is a right side elevational view thereof, the left side elevational view being a mirror image thereof;  
FIG. 5 is a top plan view thereof; and,

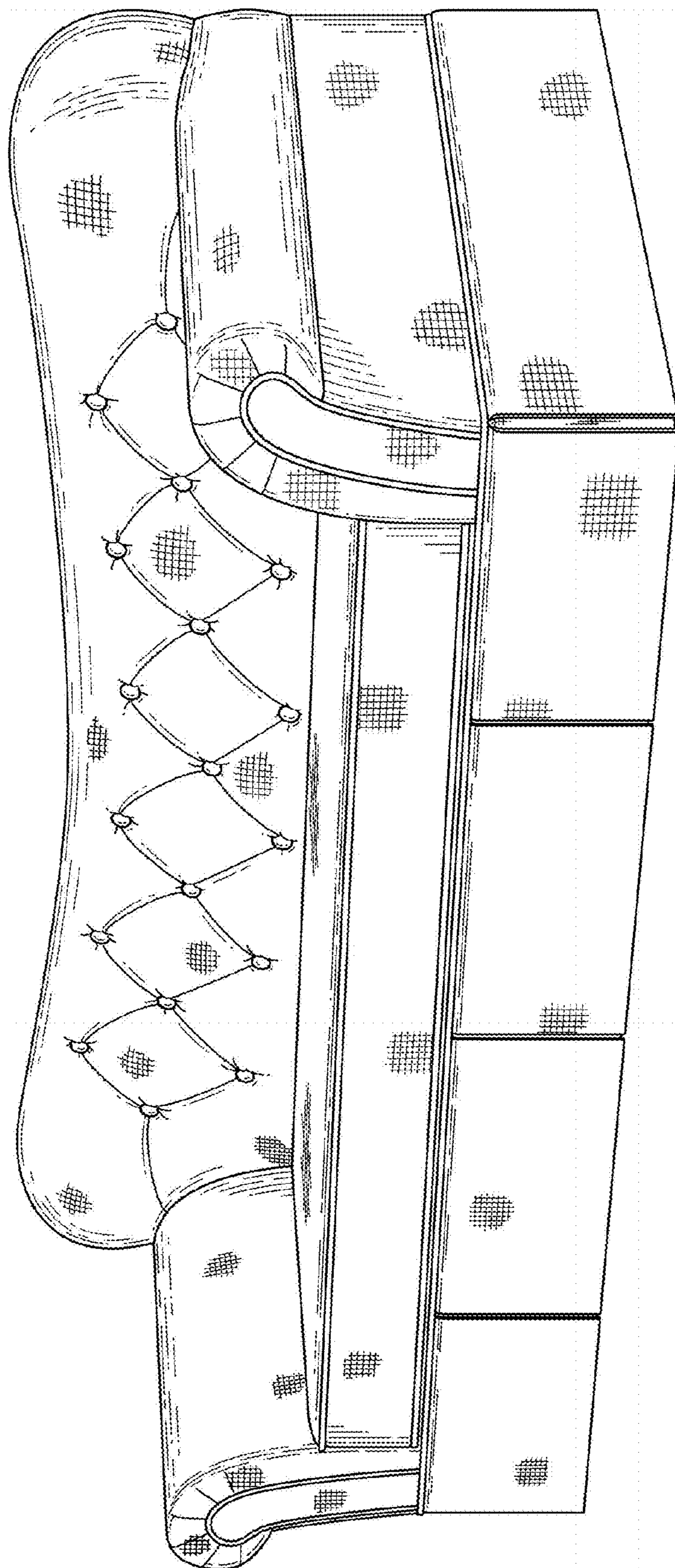

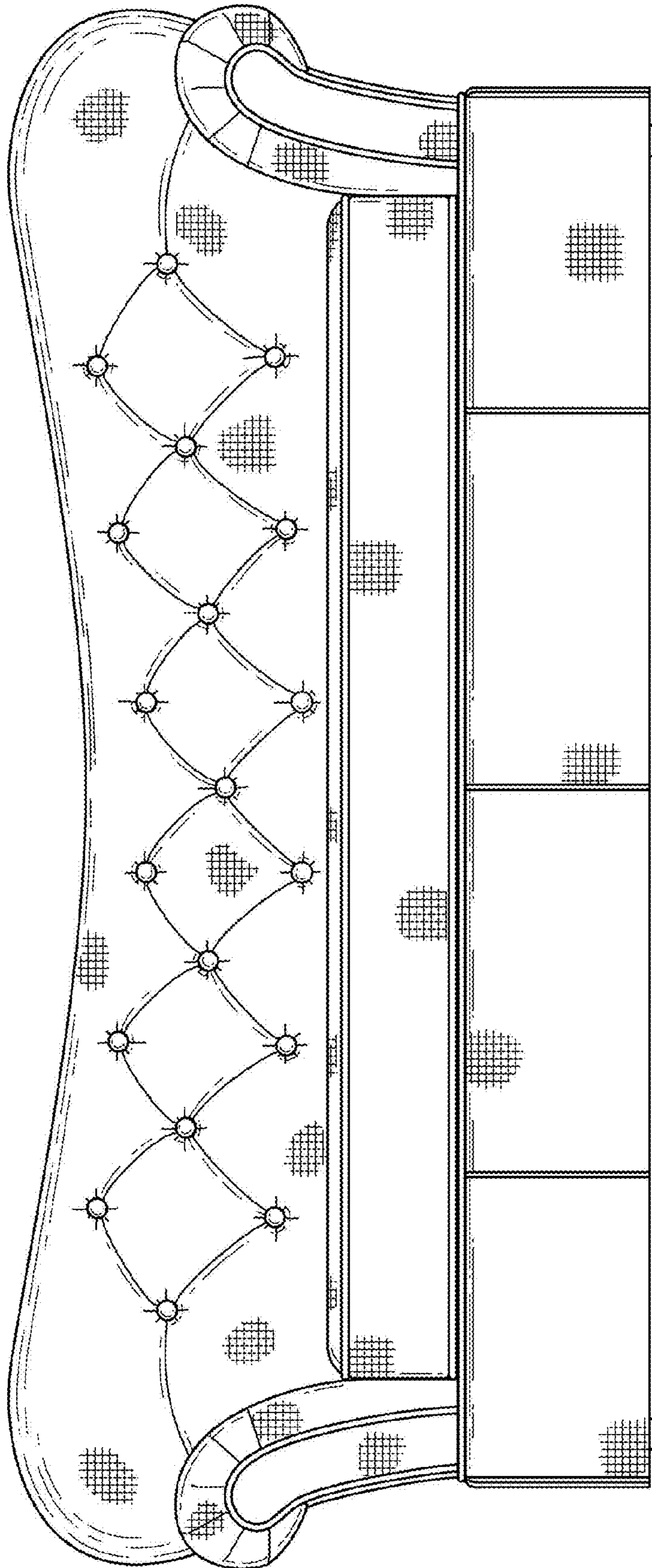

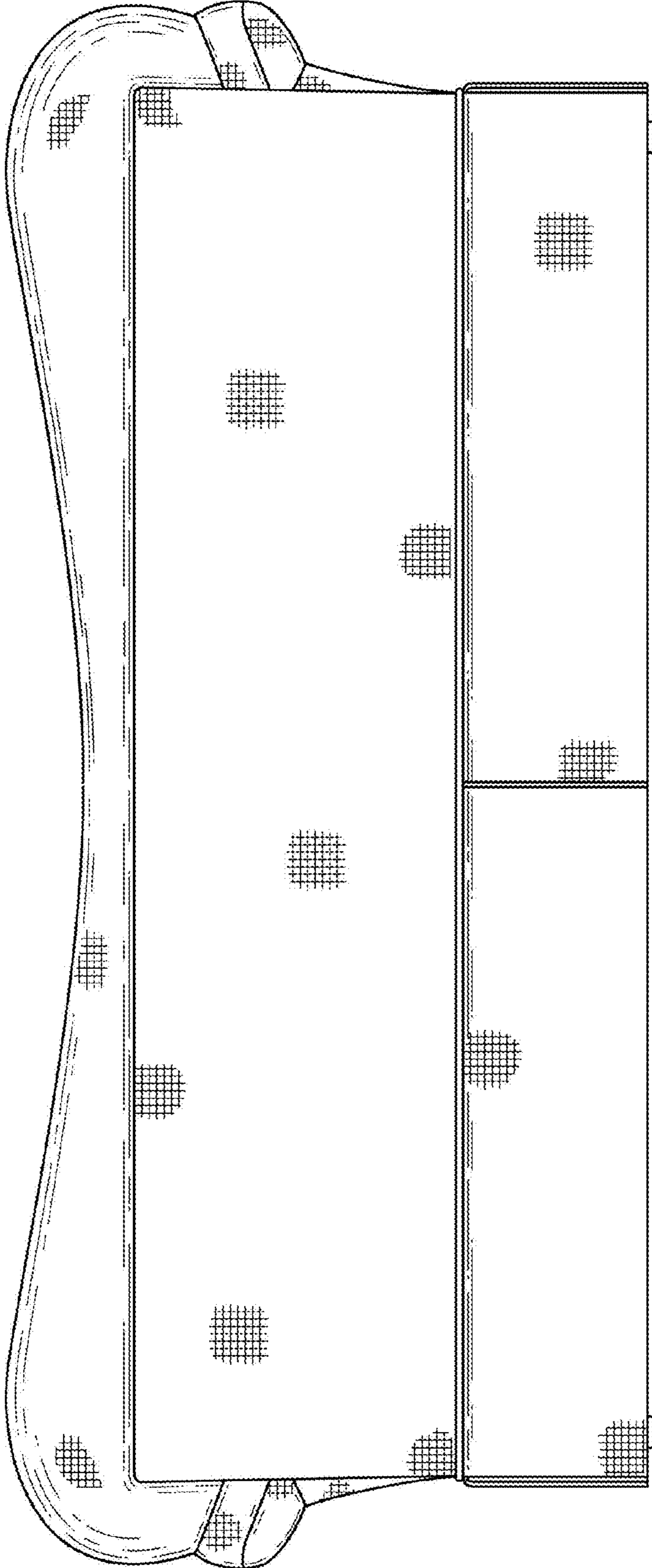

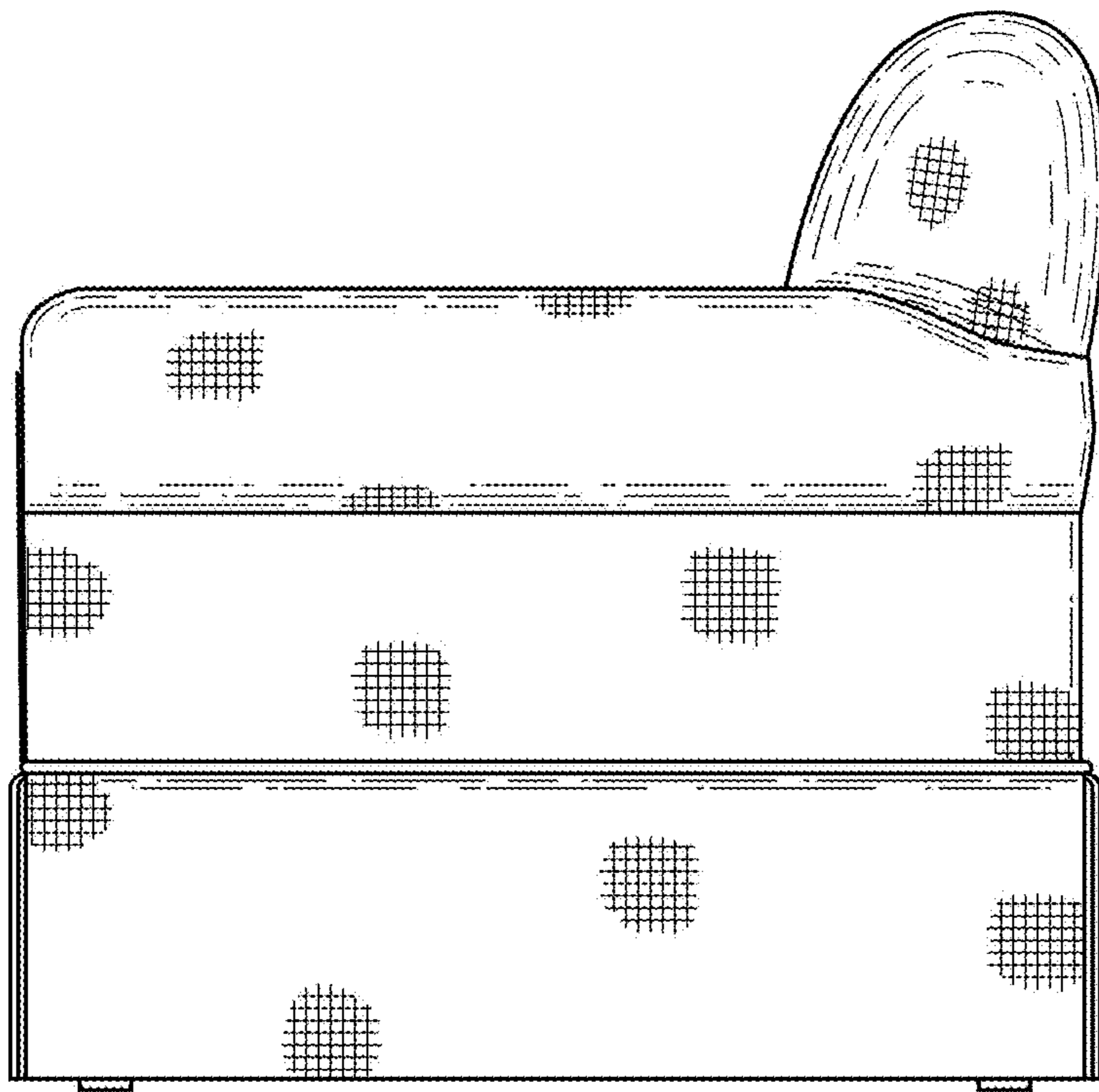

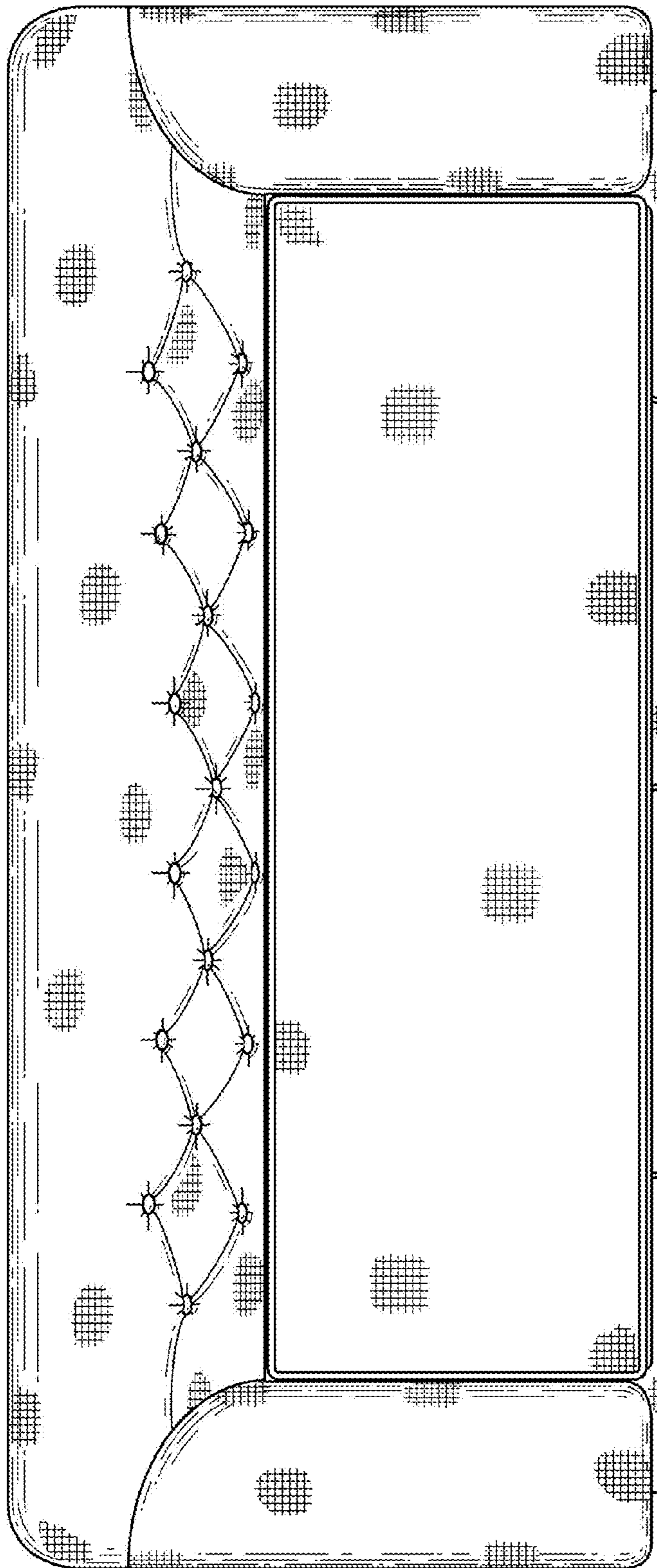

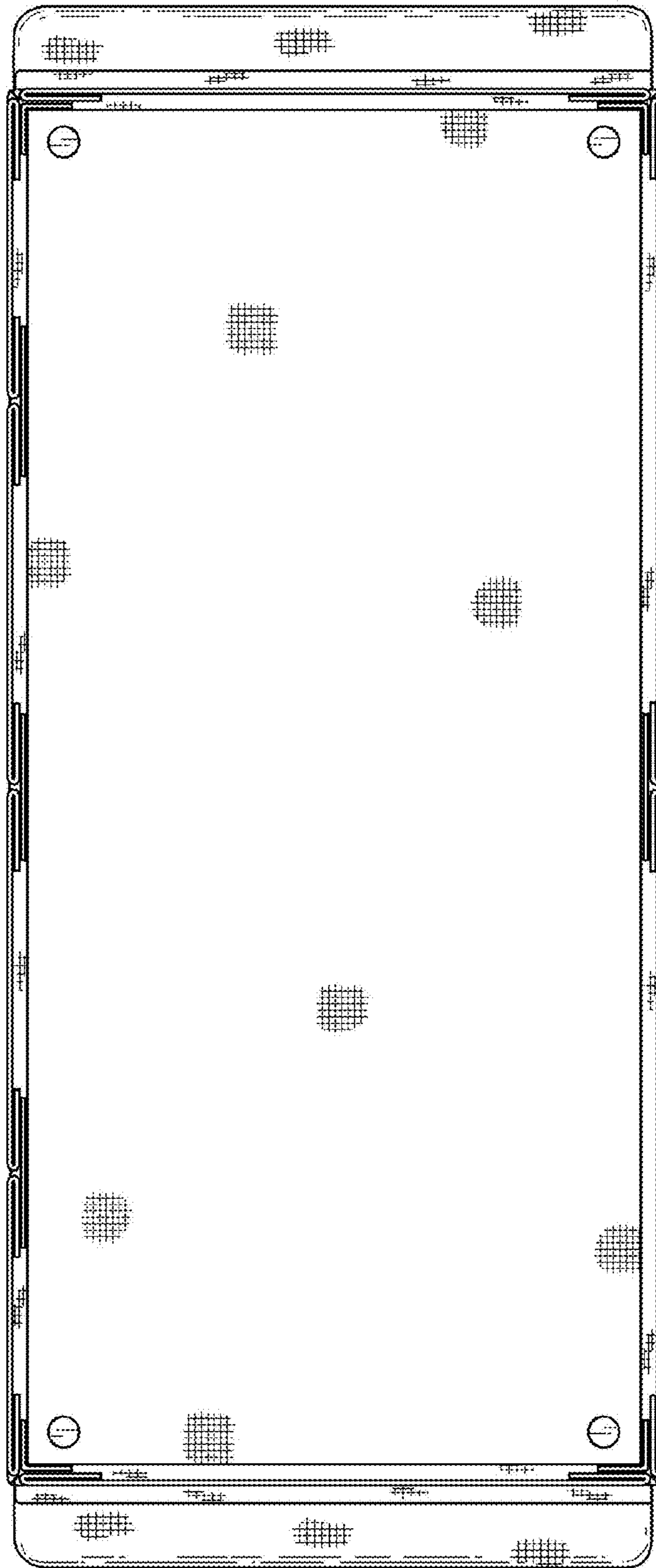
