FIG. 3 is a front elevational view thereof;

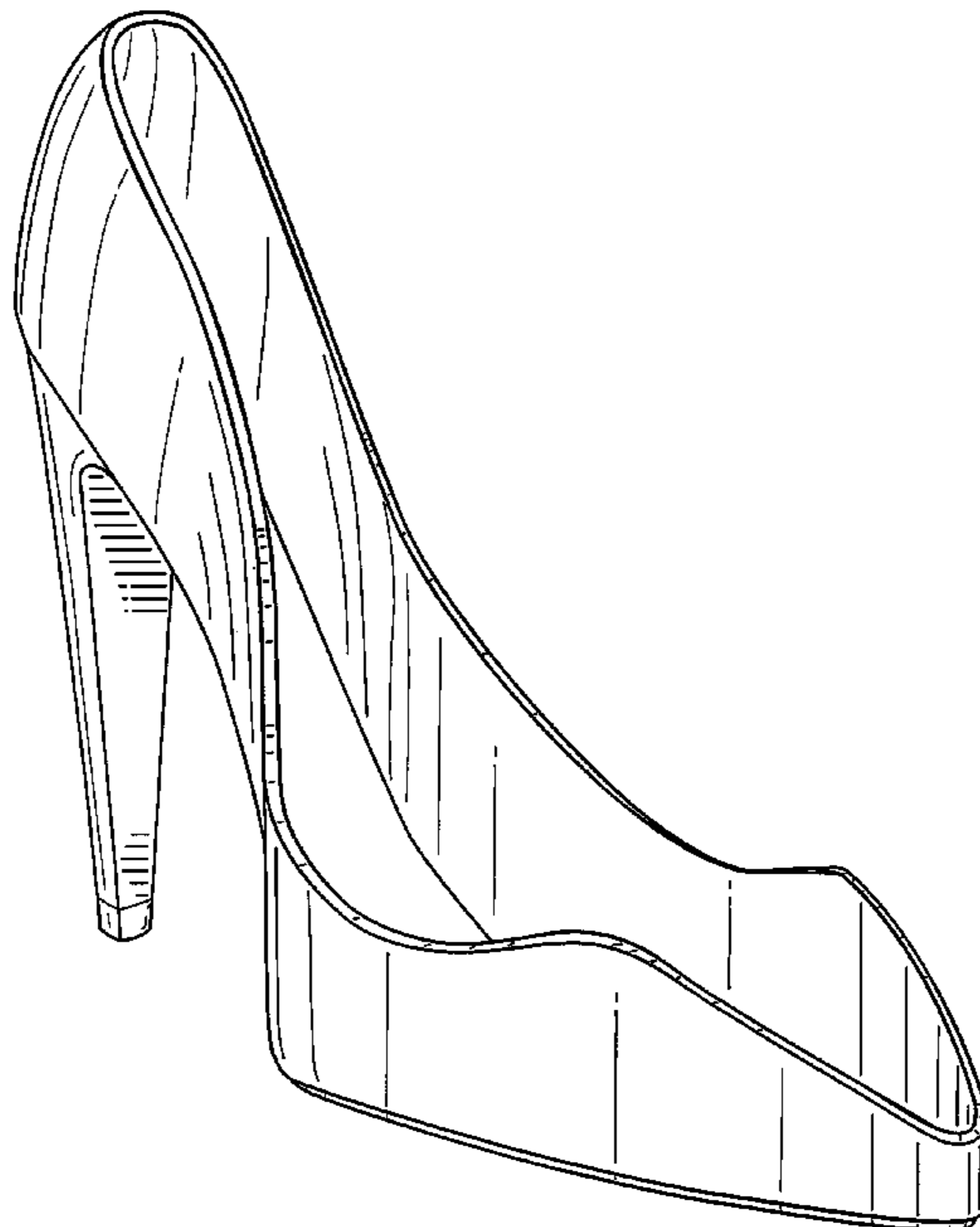
FIG. 4 is a rear elevational view thereof;

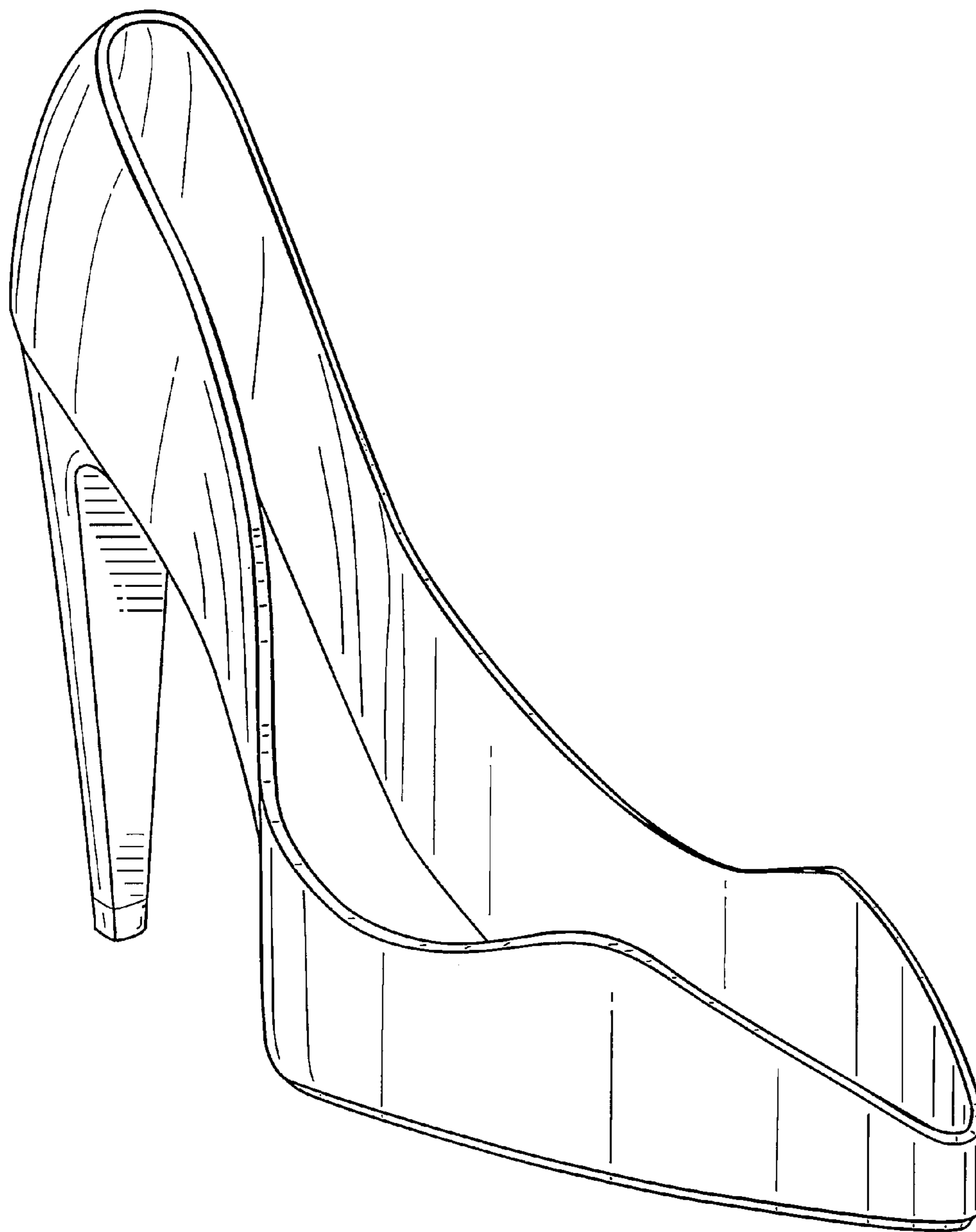
FIG. 5 is a right side view thereof, the left side being identical;

FIG. 6 is a top view thereof; and,

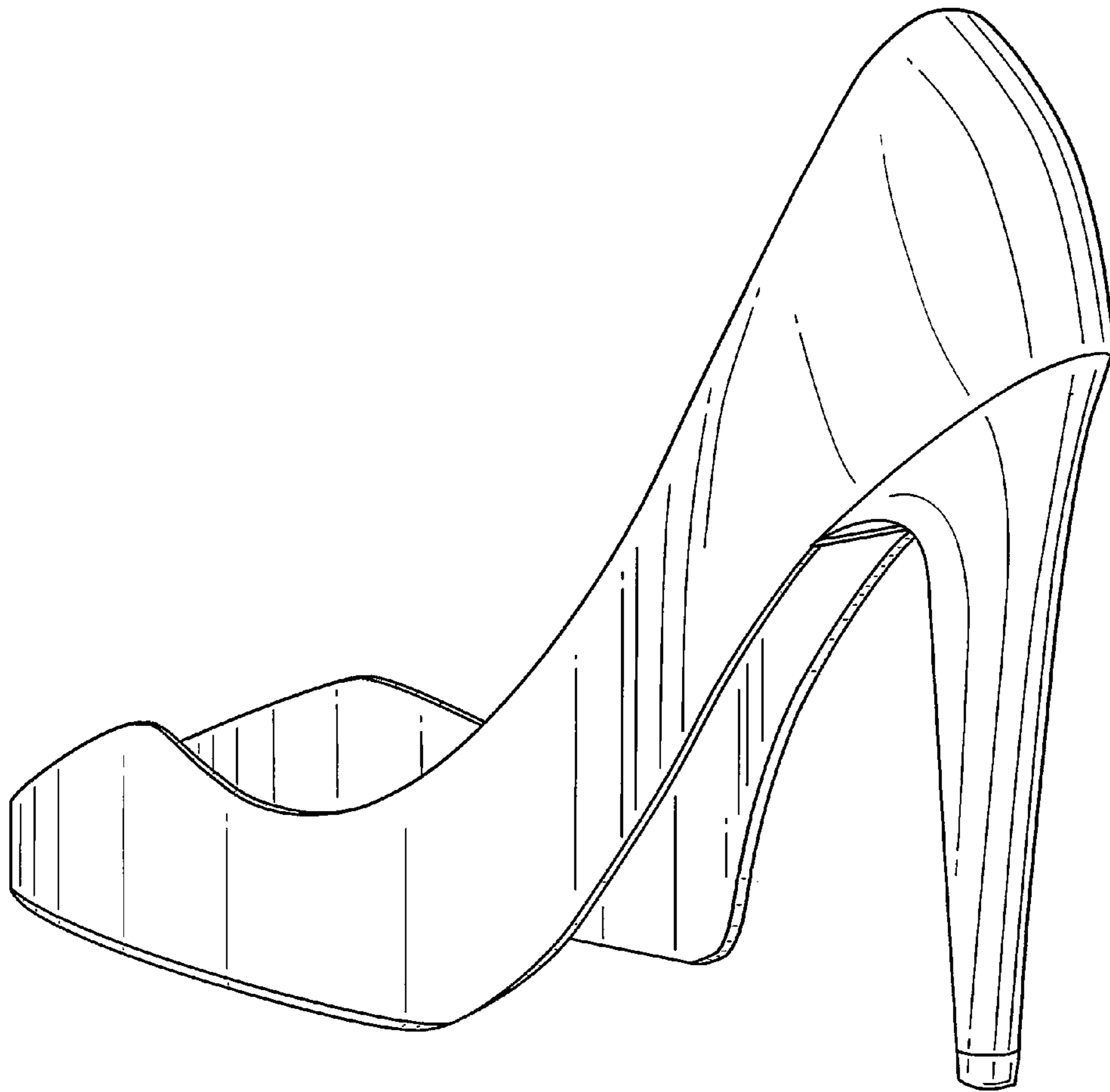
FIG. 7 is a bottom view thereof.

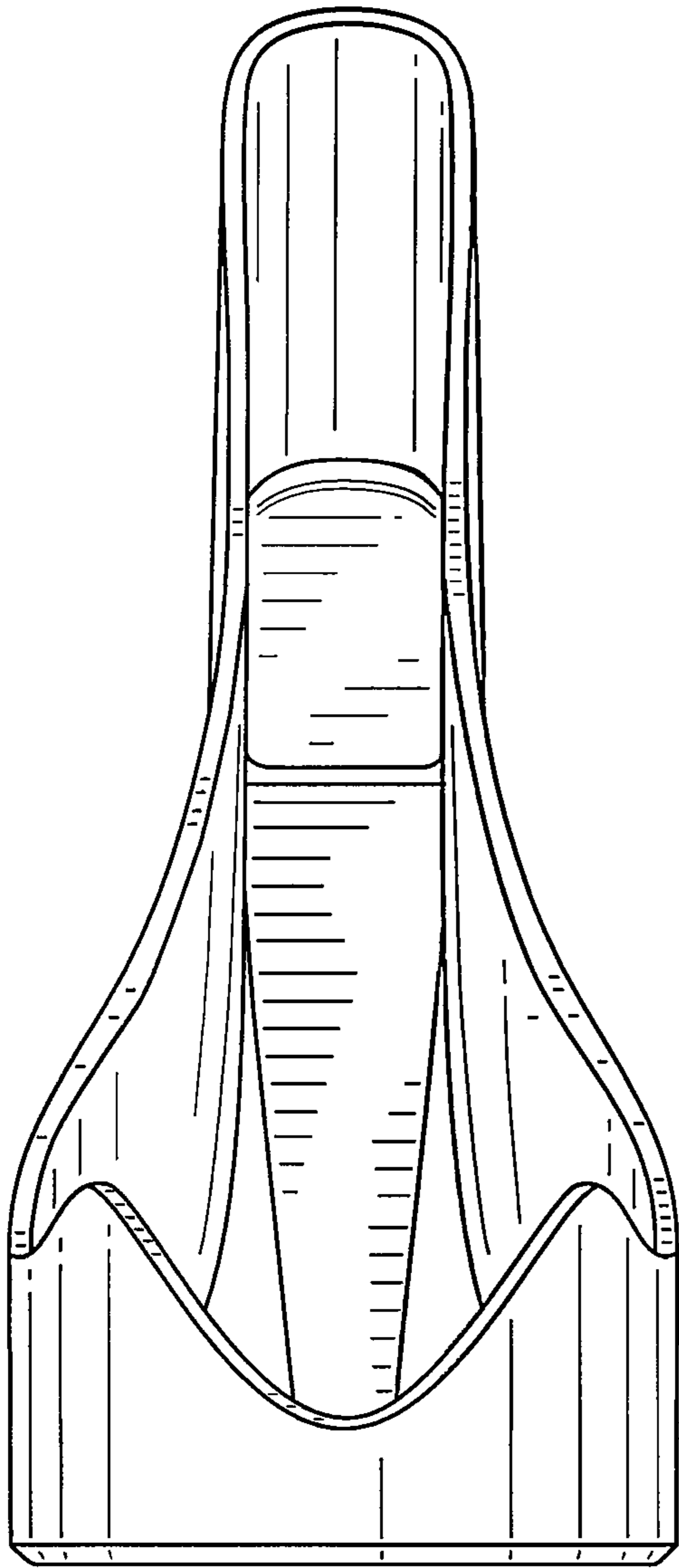




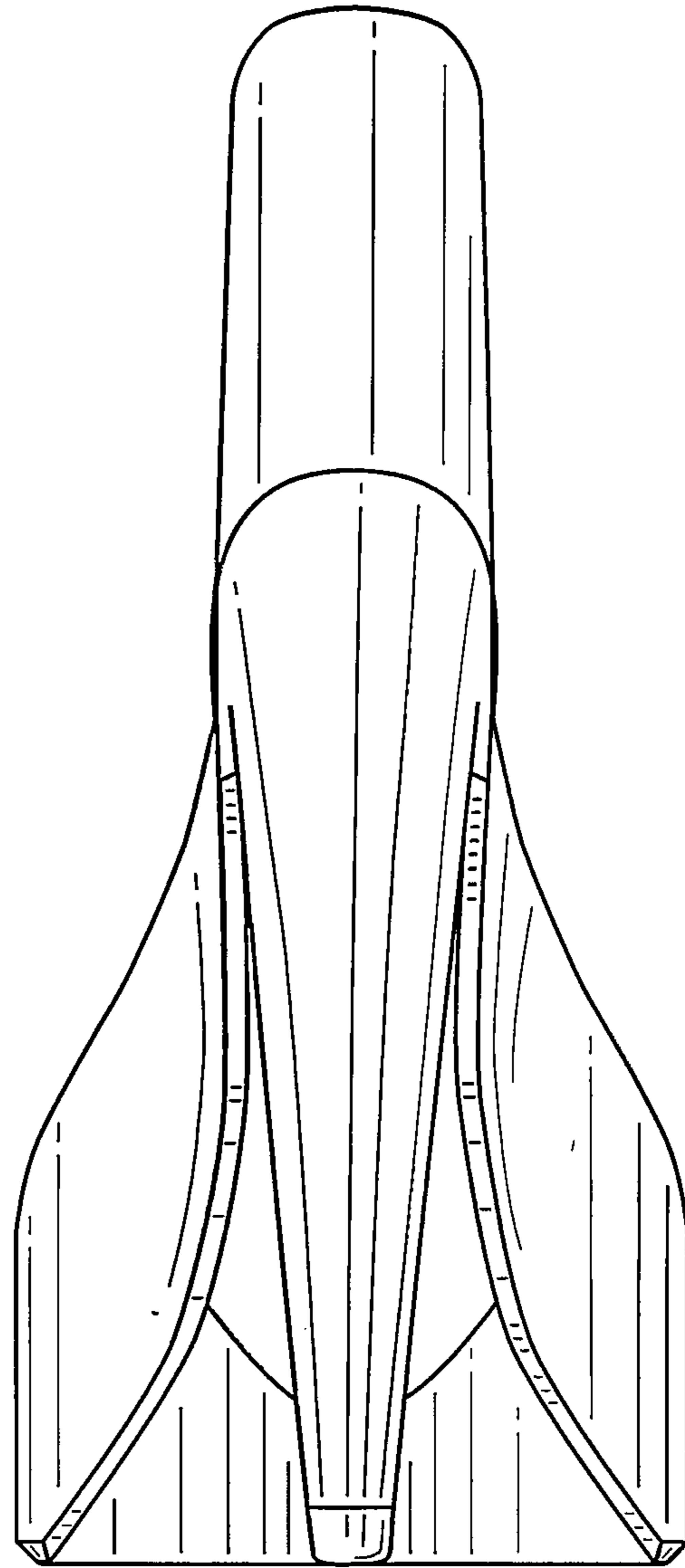

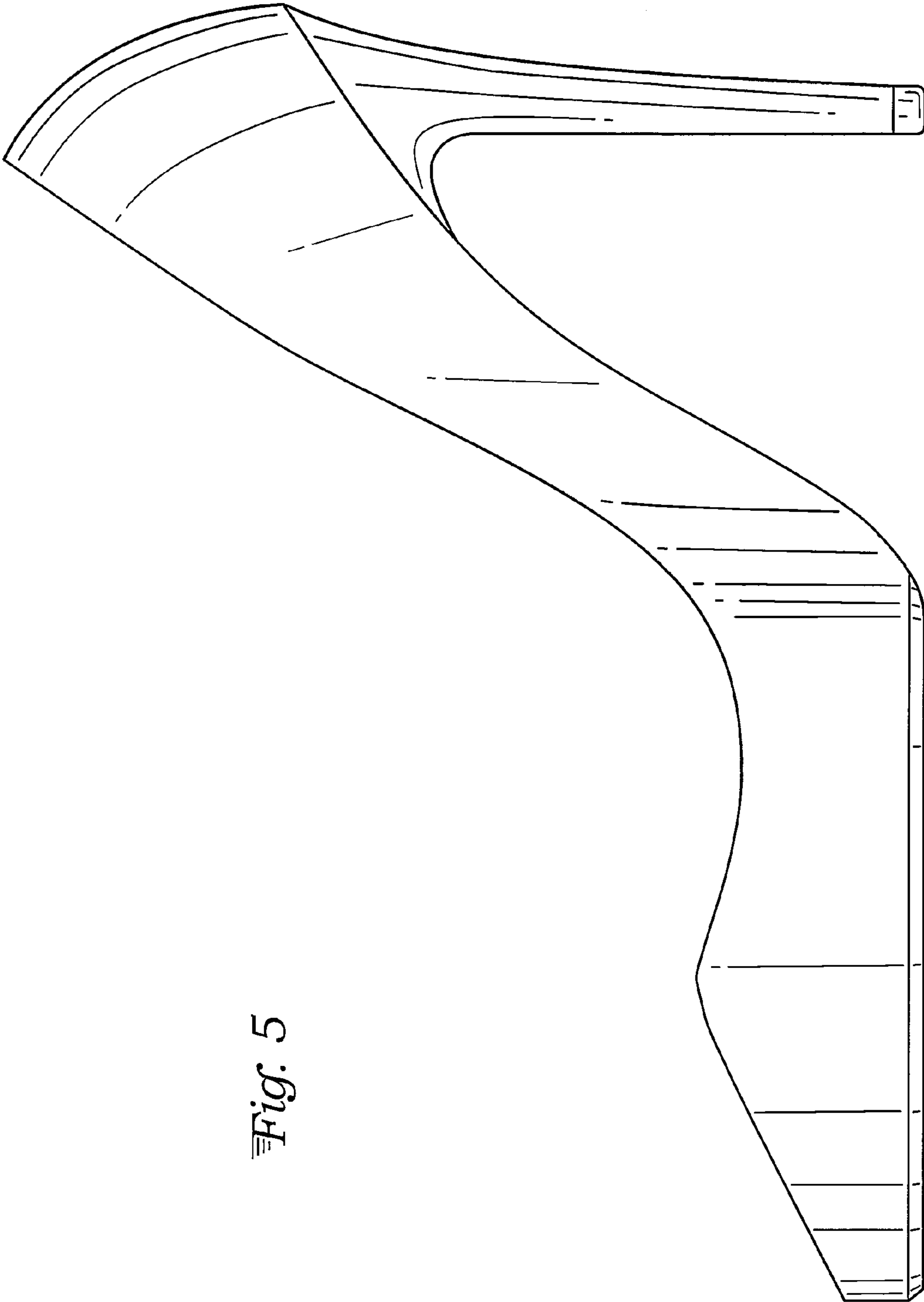
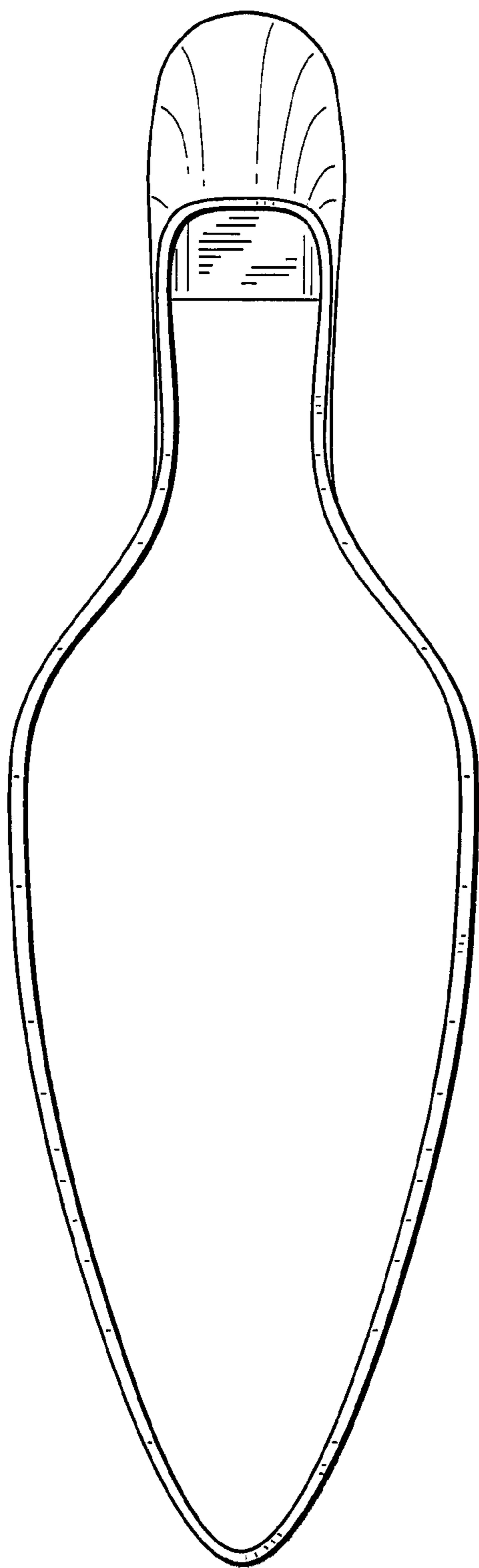
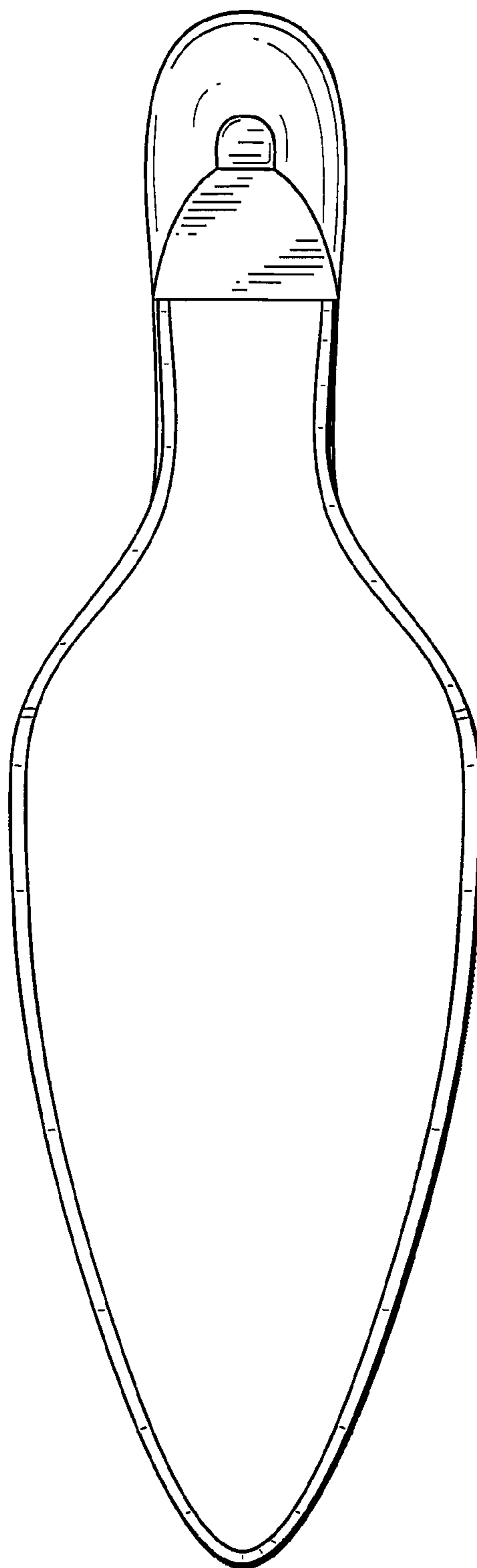
