FIG. 4 is a right side view of the necklace;

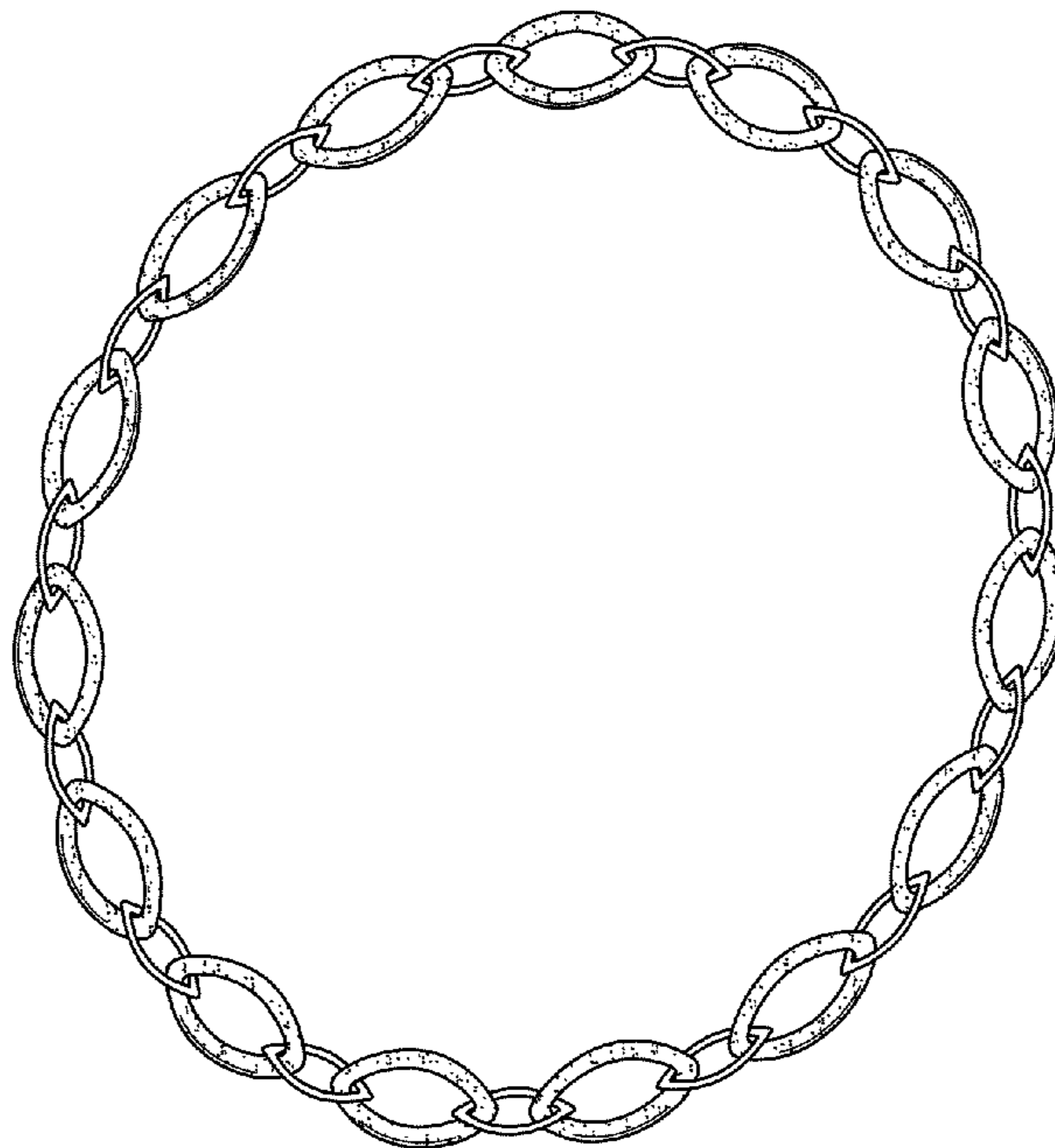
FIG. 5 is a rear view of the necklace;

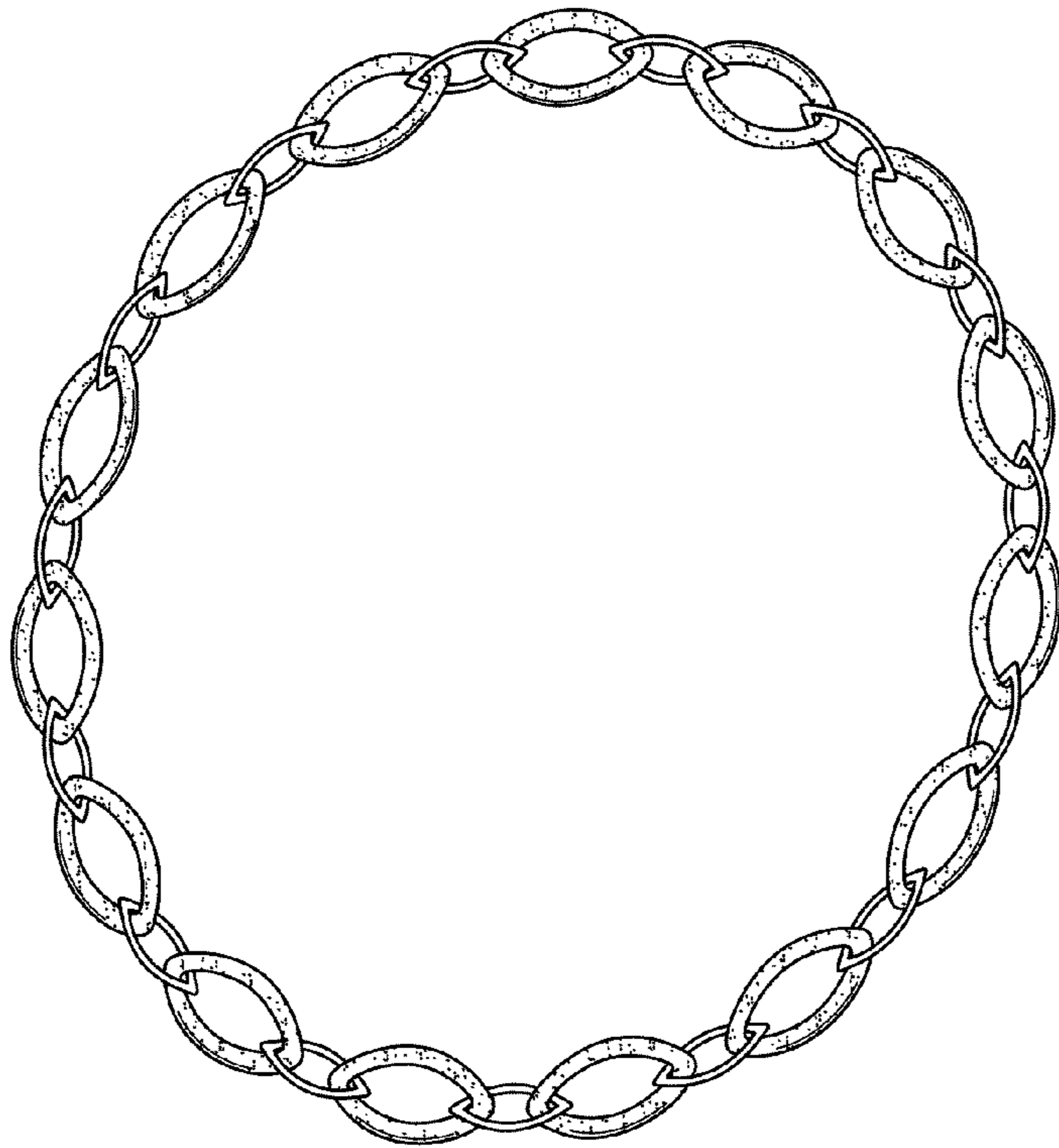

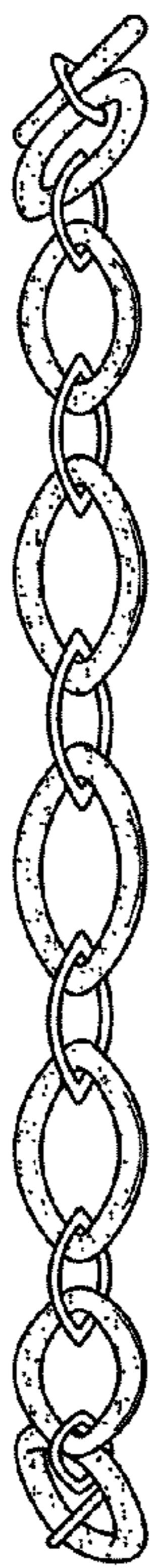

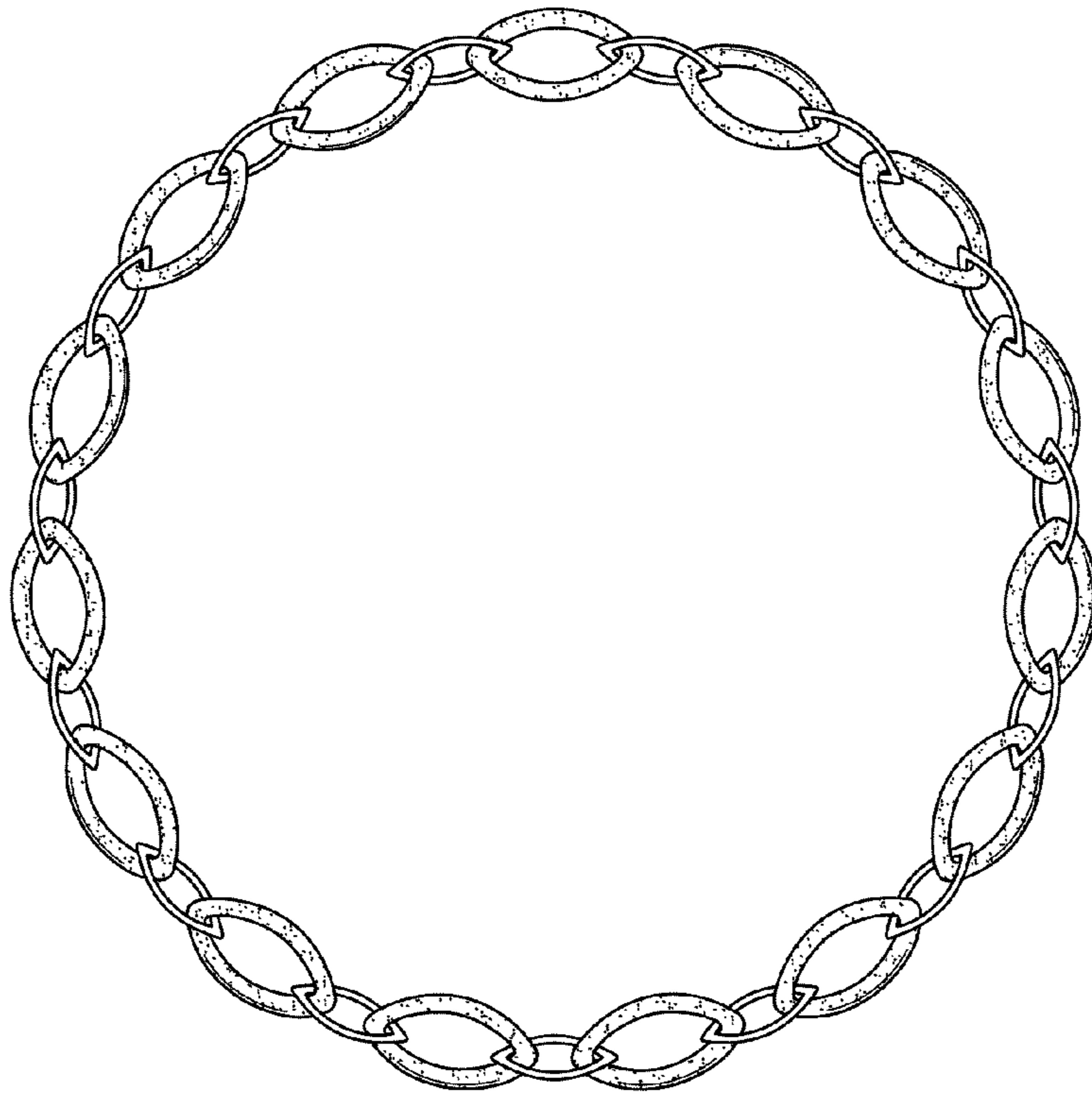

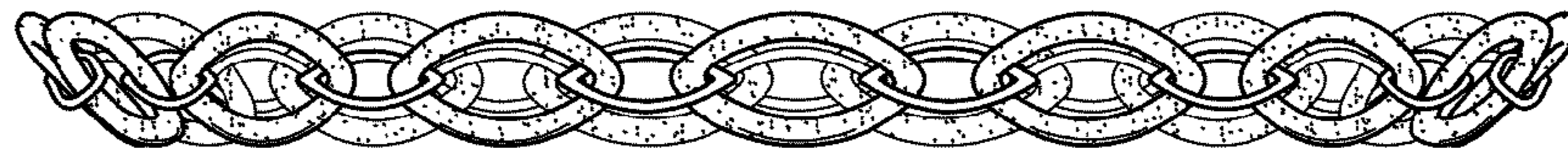

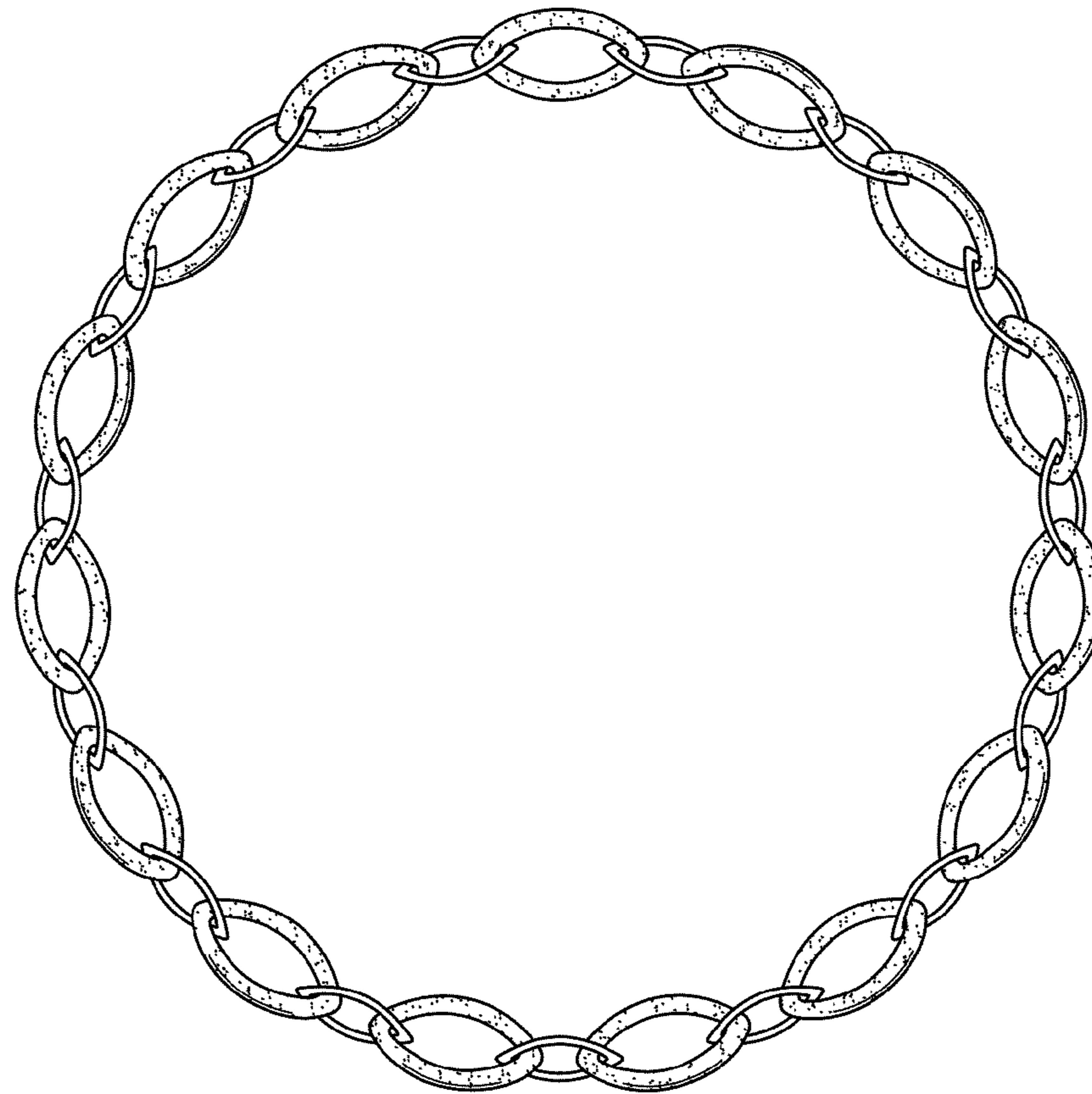

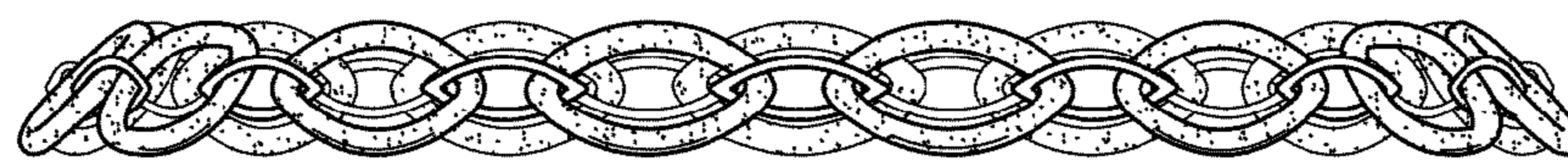
