DESCRIPTION

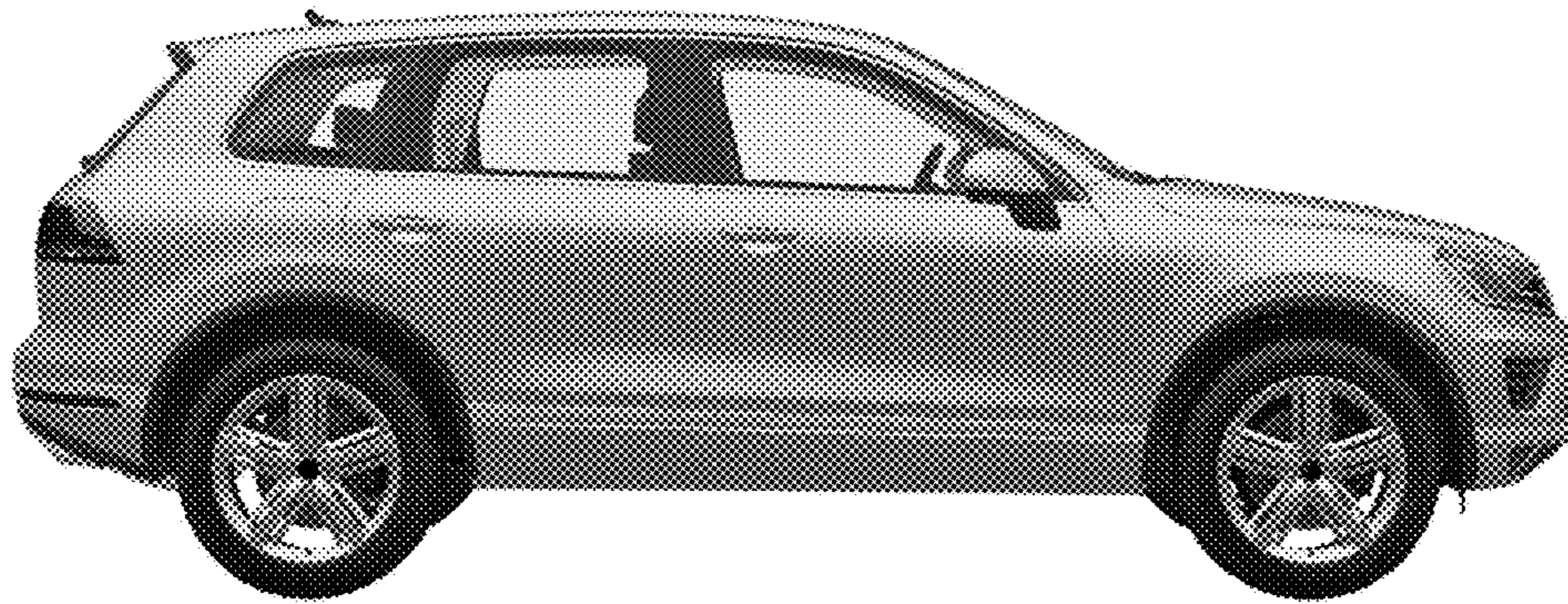

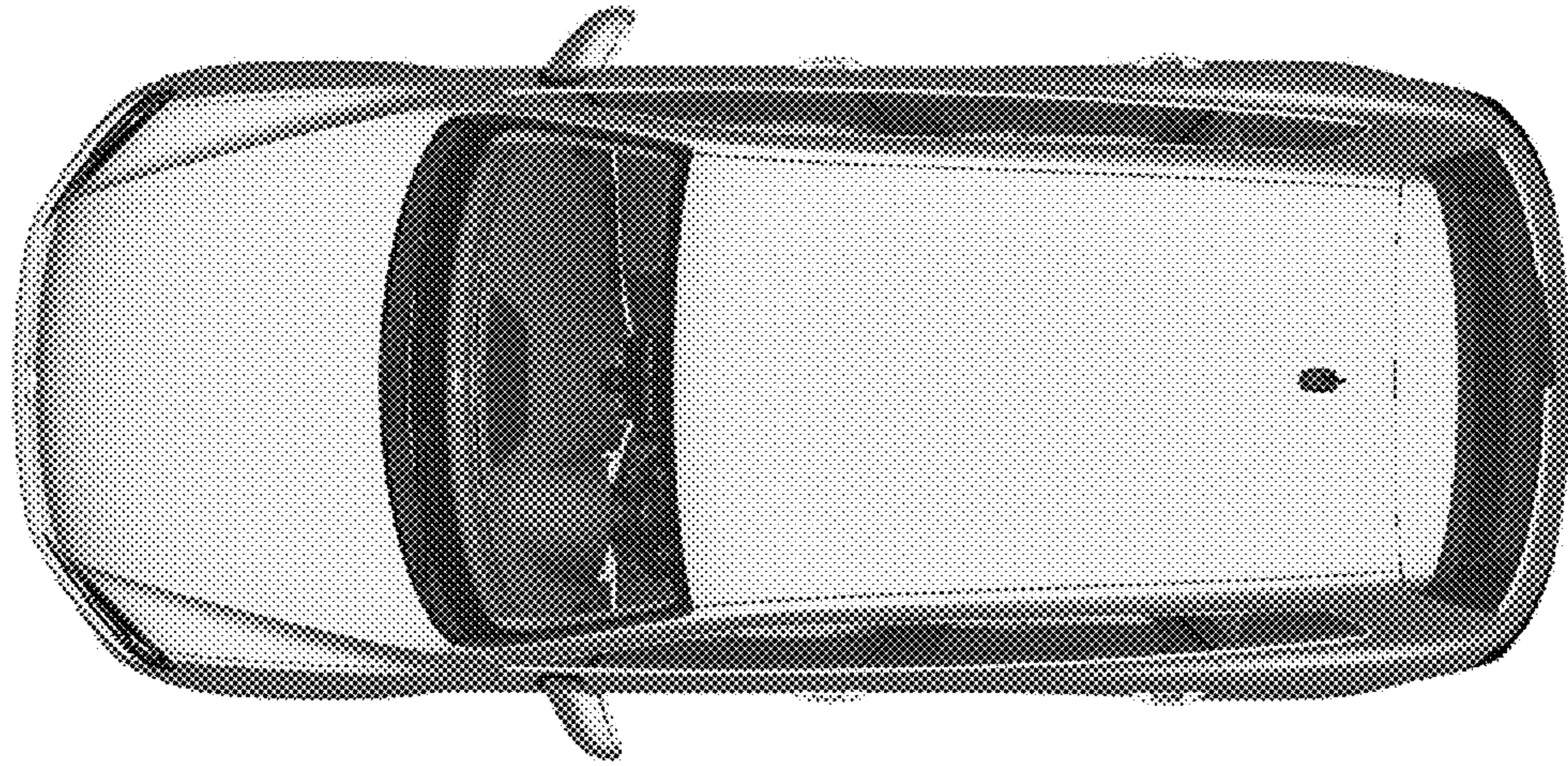
