FIG. 2 is a front elevation view thereof;

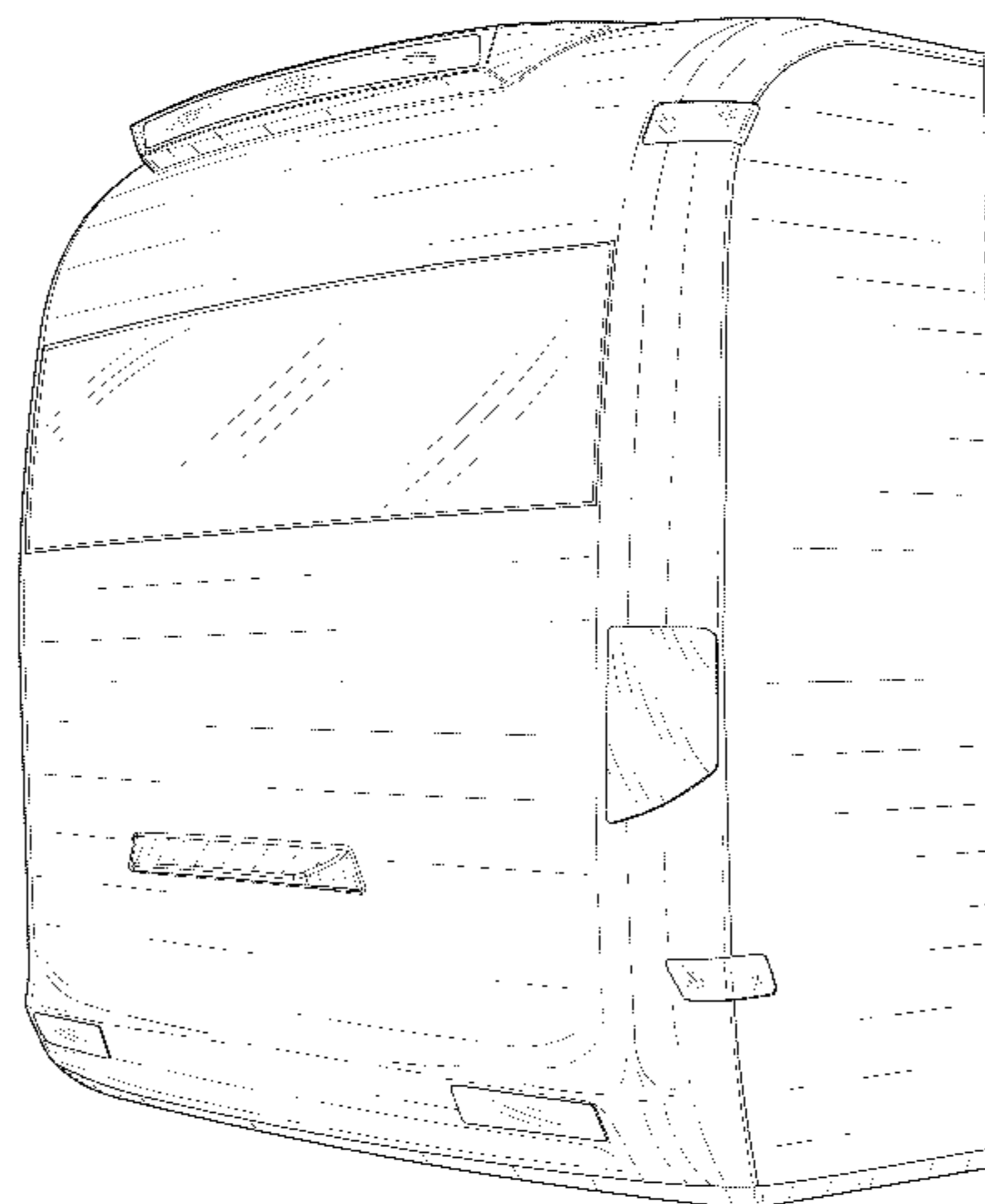
FIG. 3 is a right side elevation view thereof;

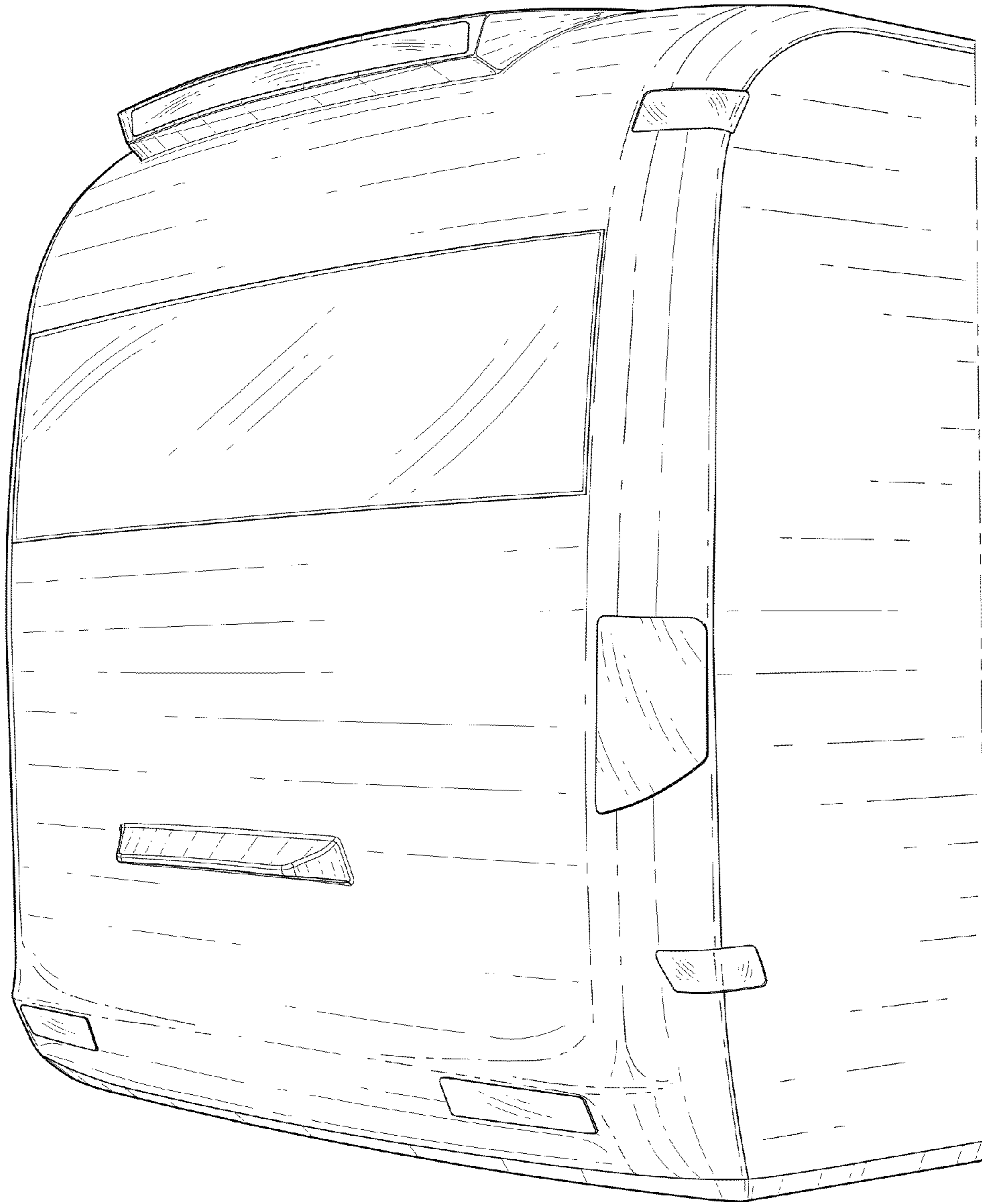
FIG. 4 is a left side elevation view thereof; and,

FIG. 5 is a top plan view thereof.

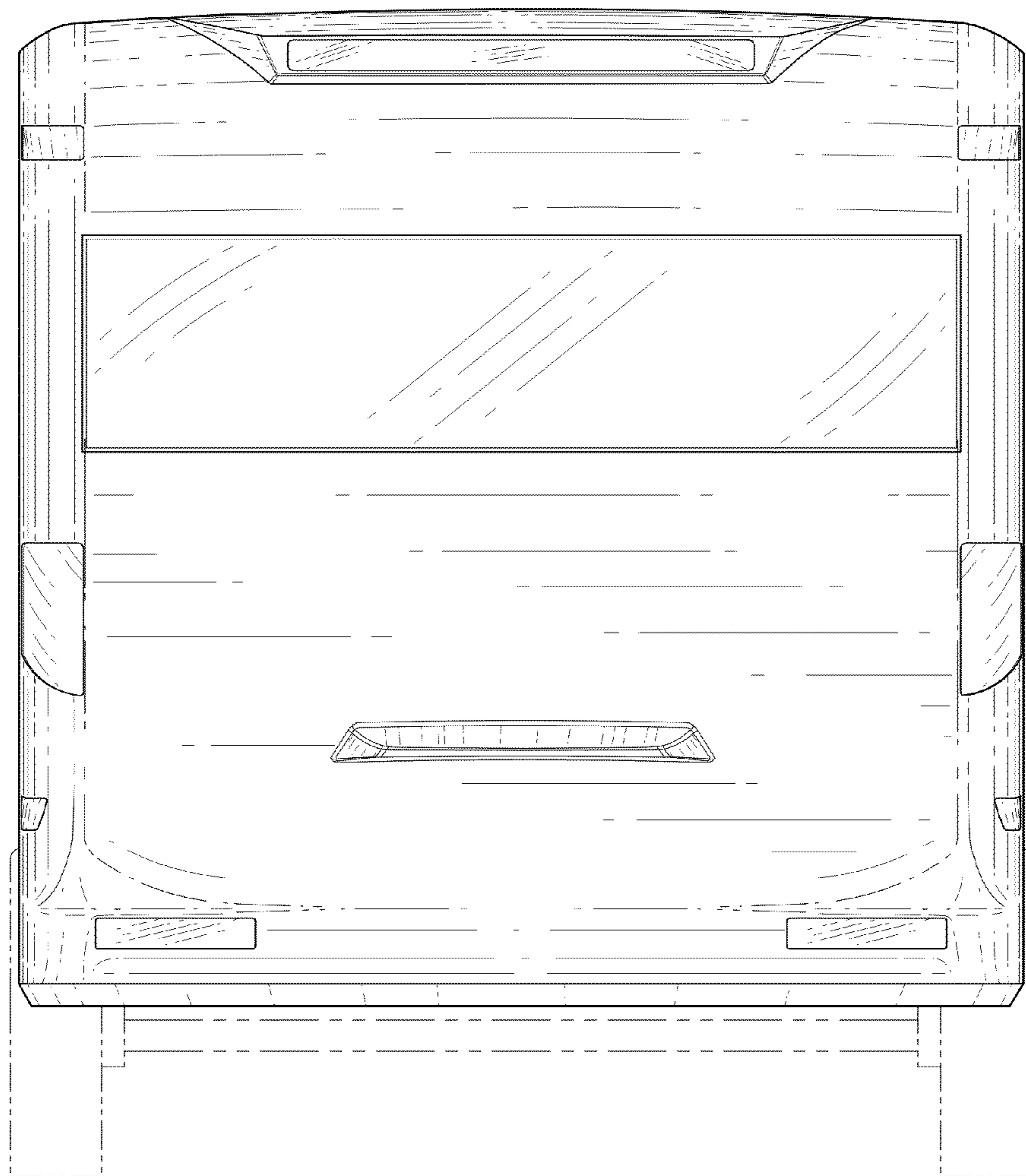
The broken lines shown in the drawings illustrate portions of the recreational vehicle that form no part of the claimed design.

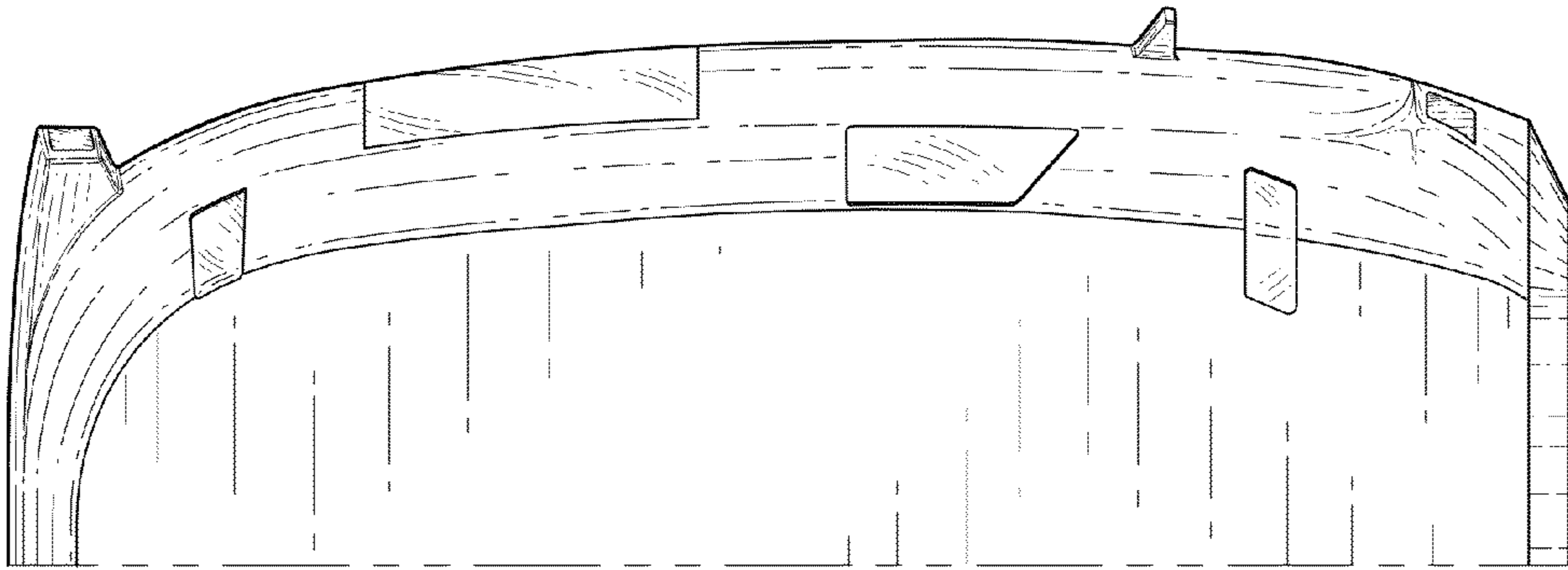




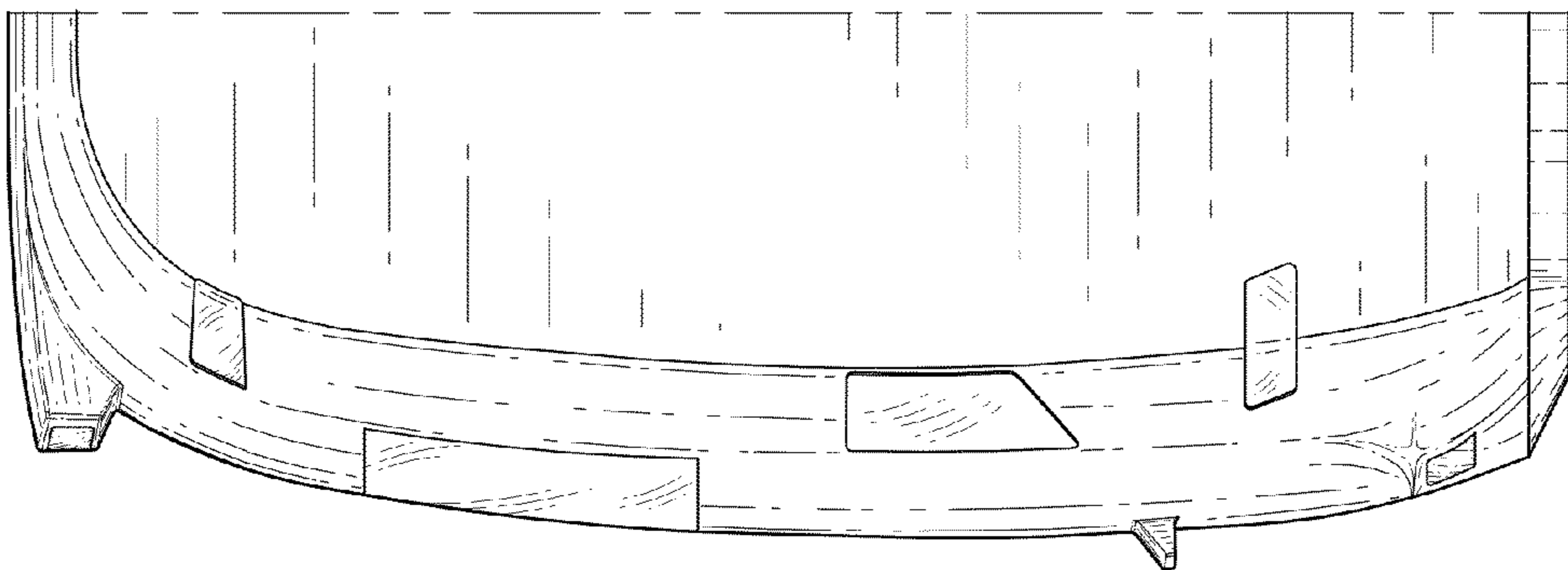

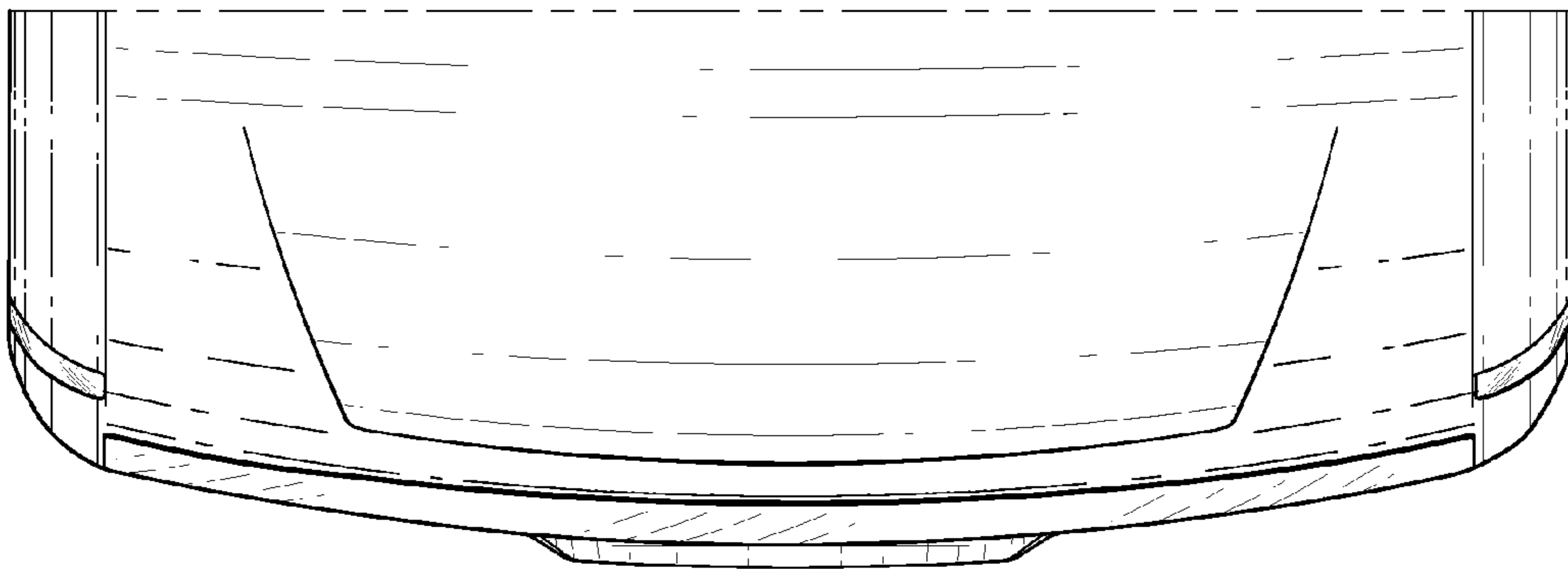
