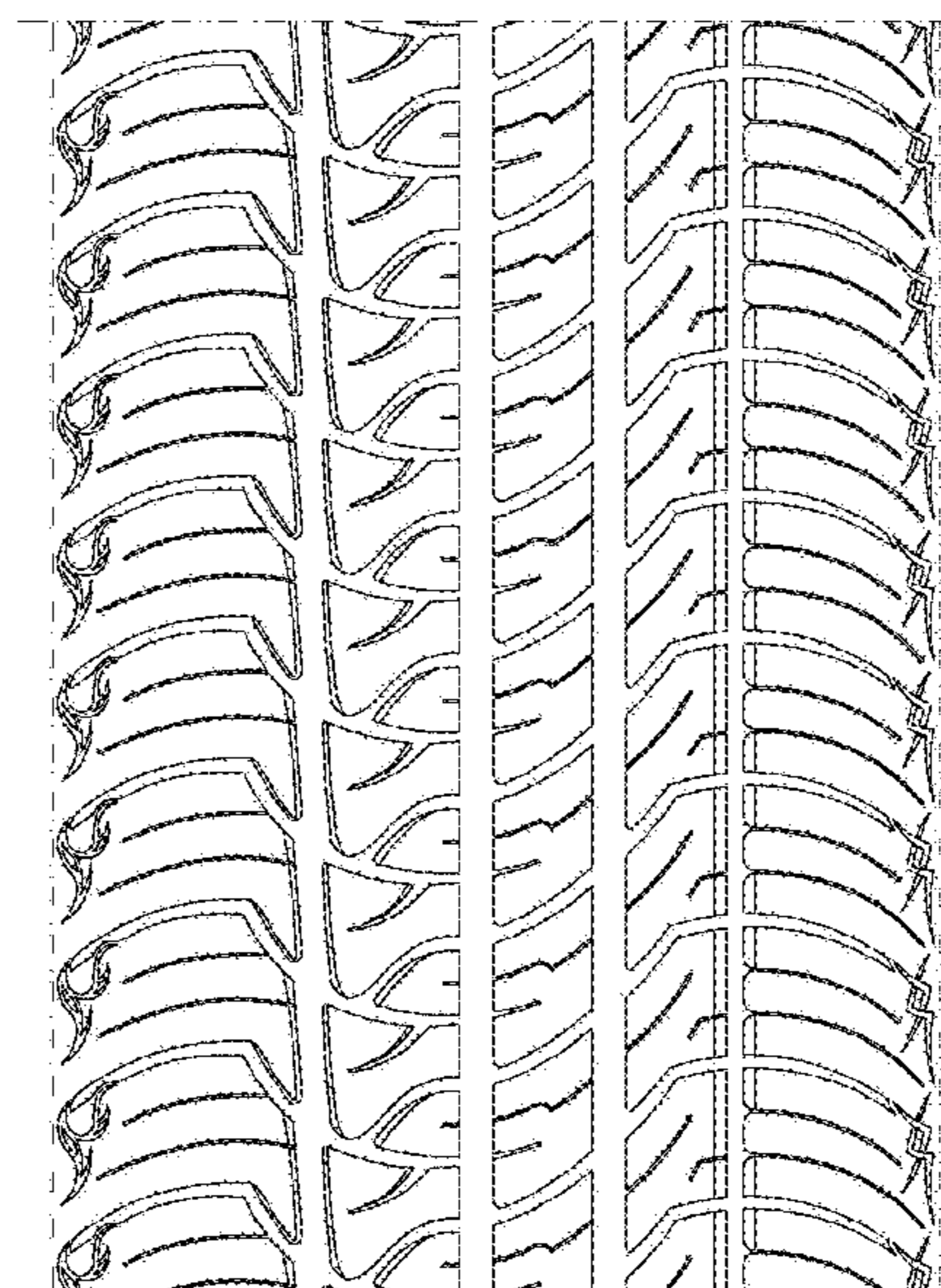
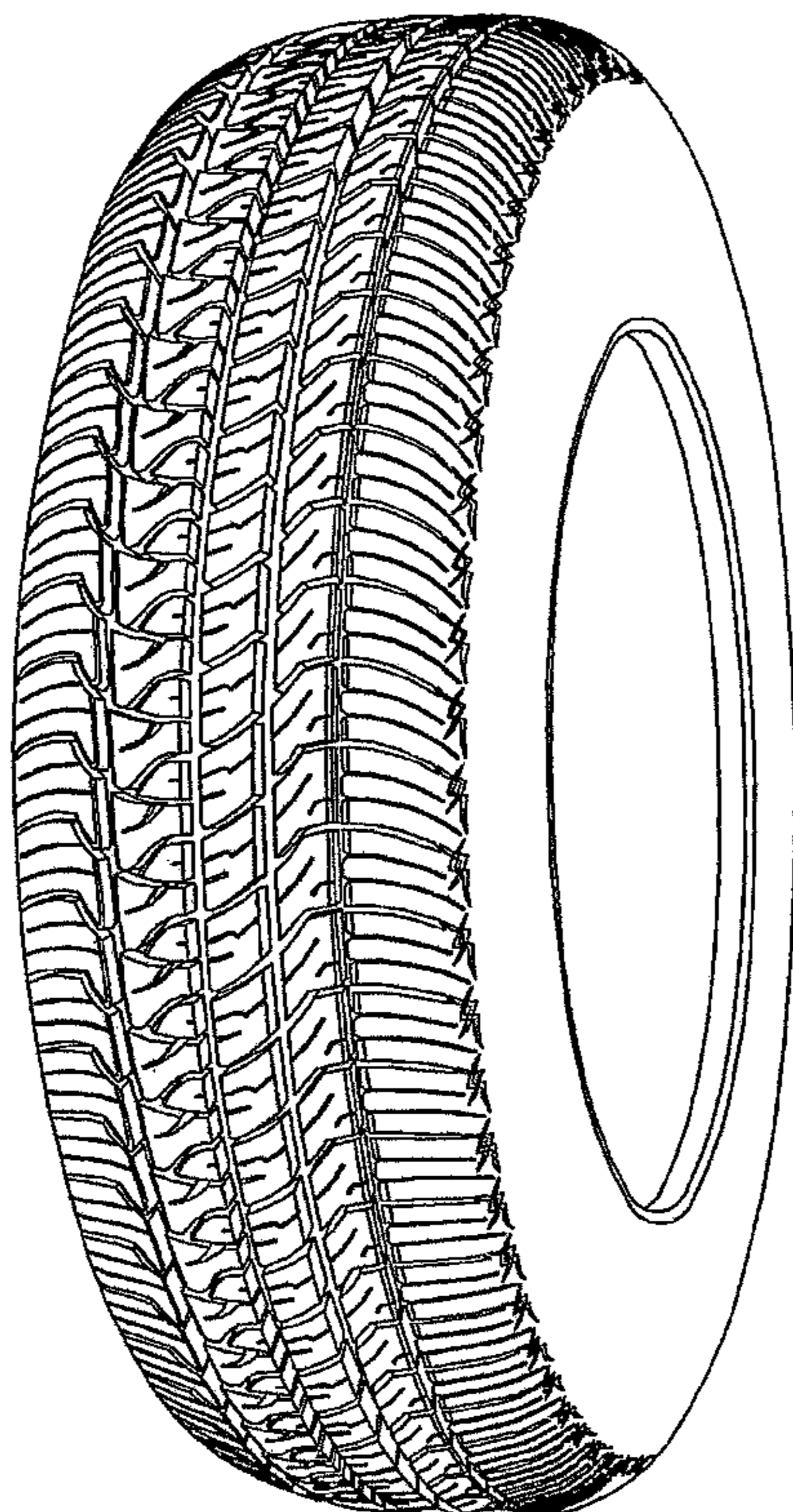
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of a tire for automobile, showing our new design;

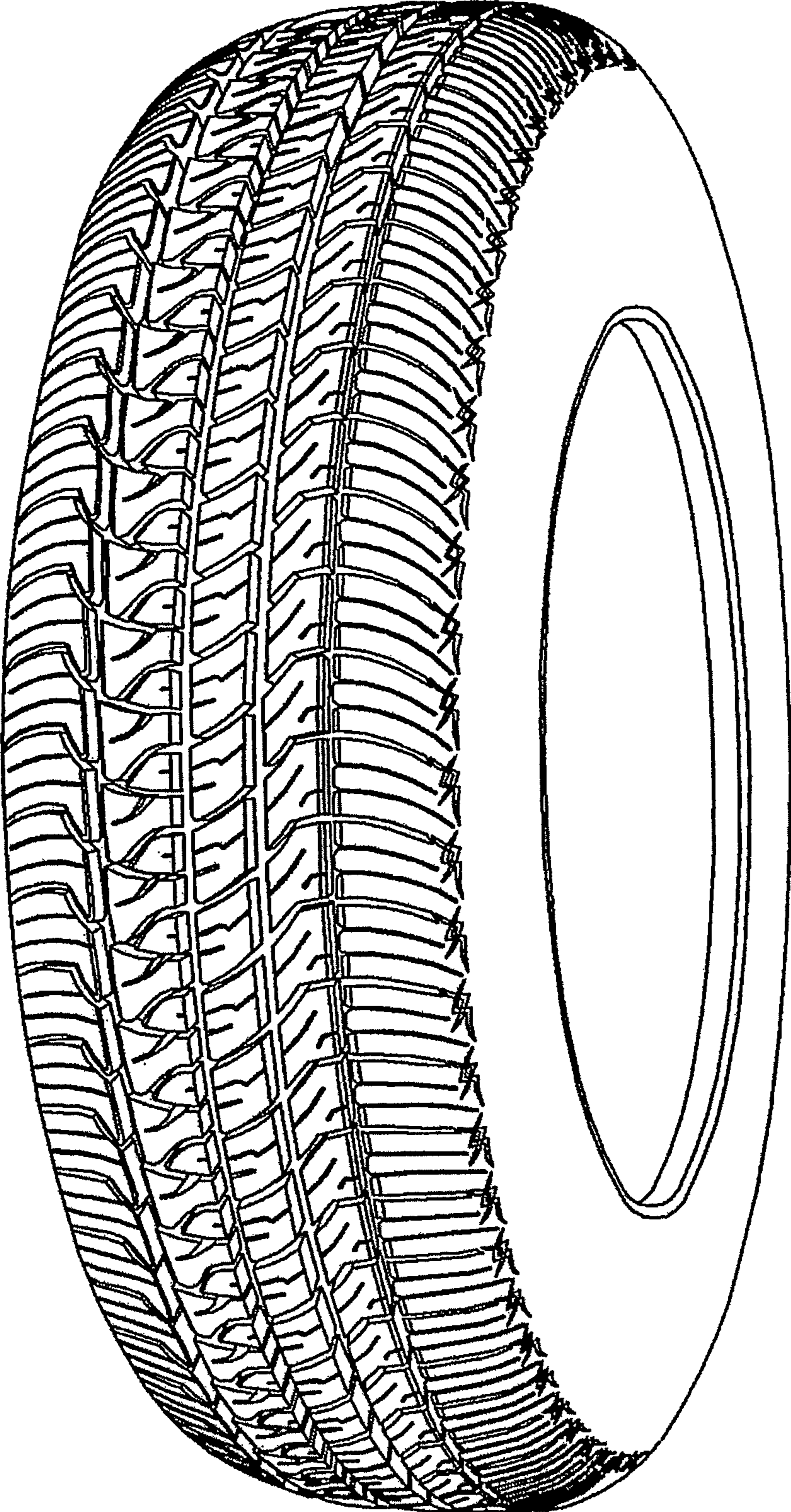

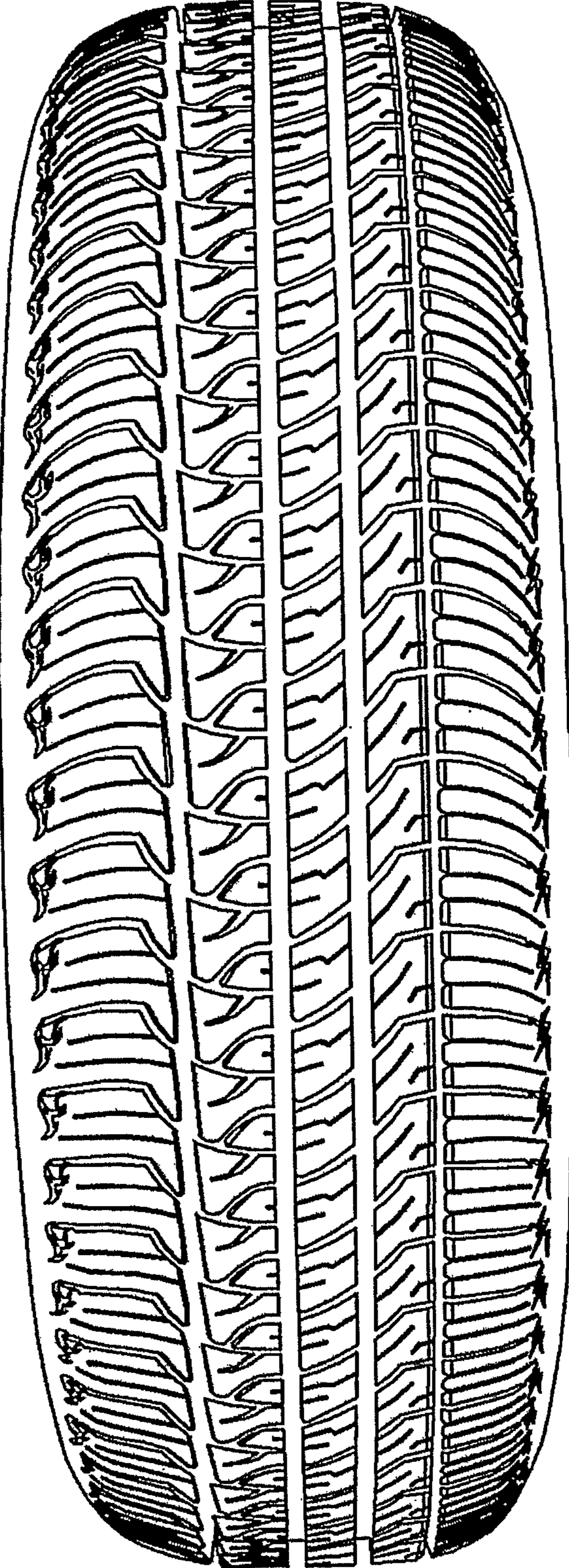

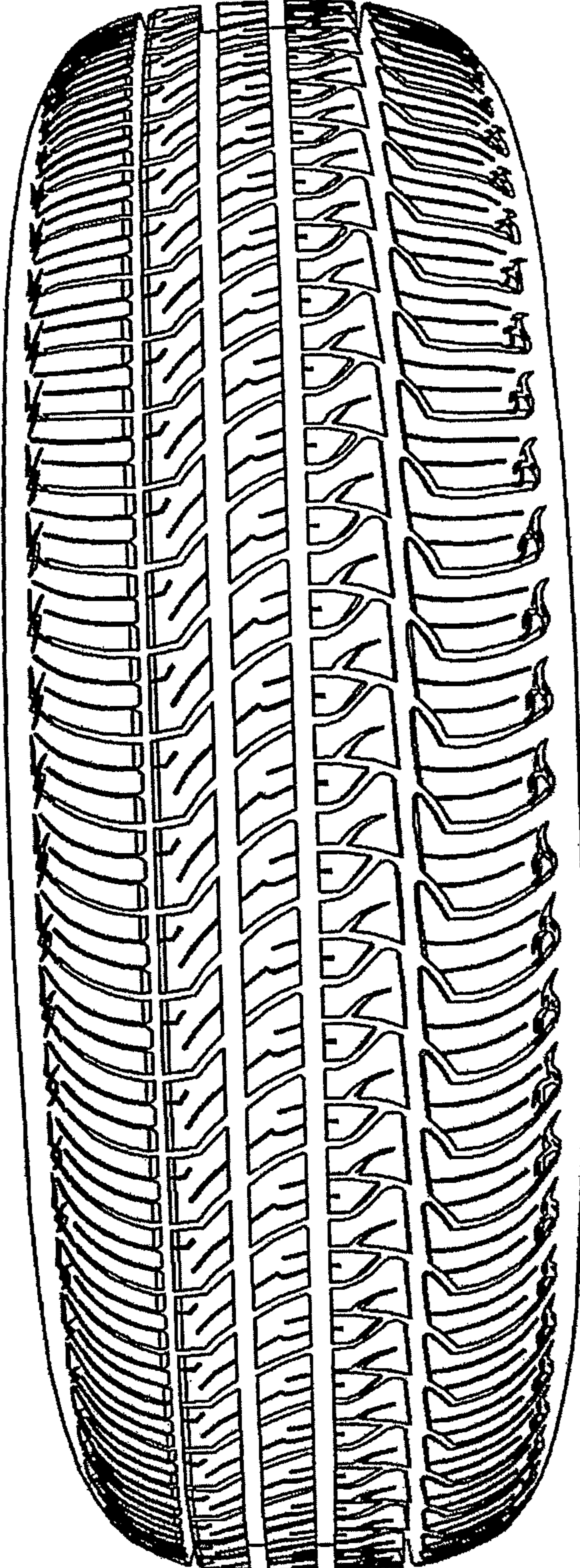

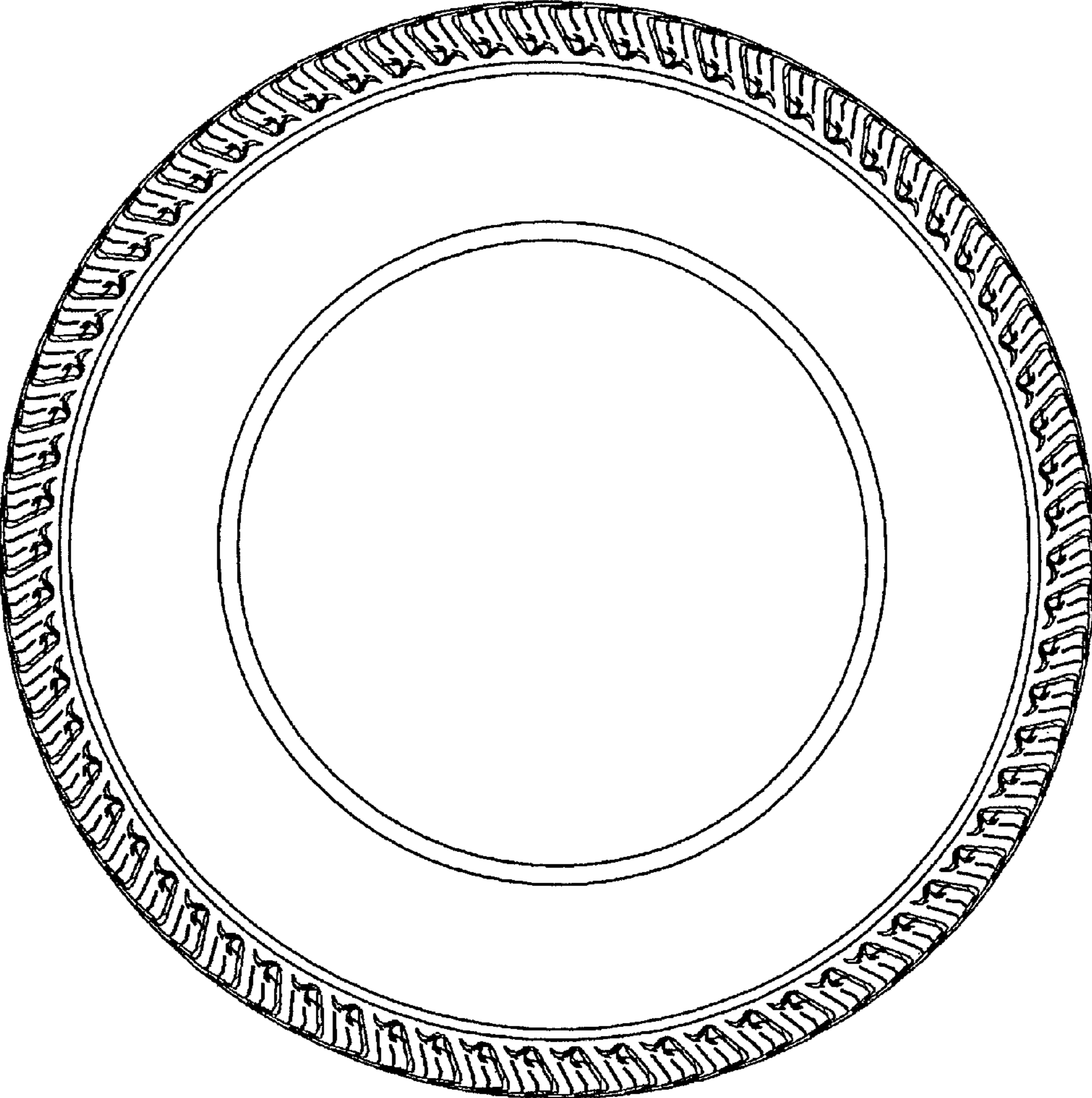

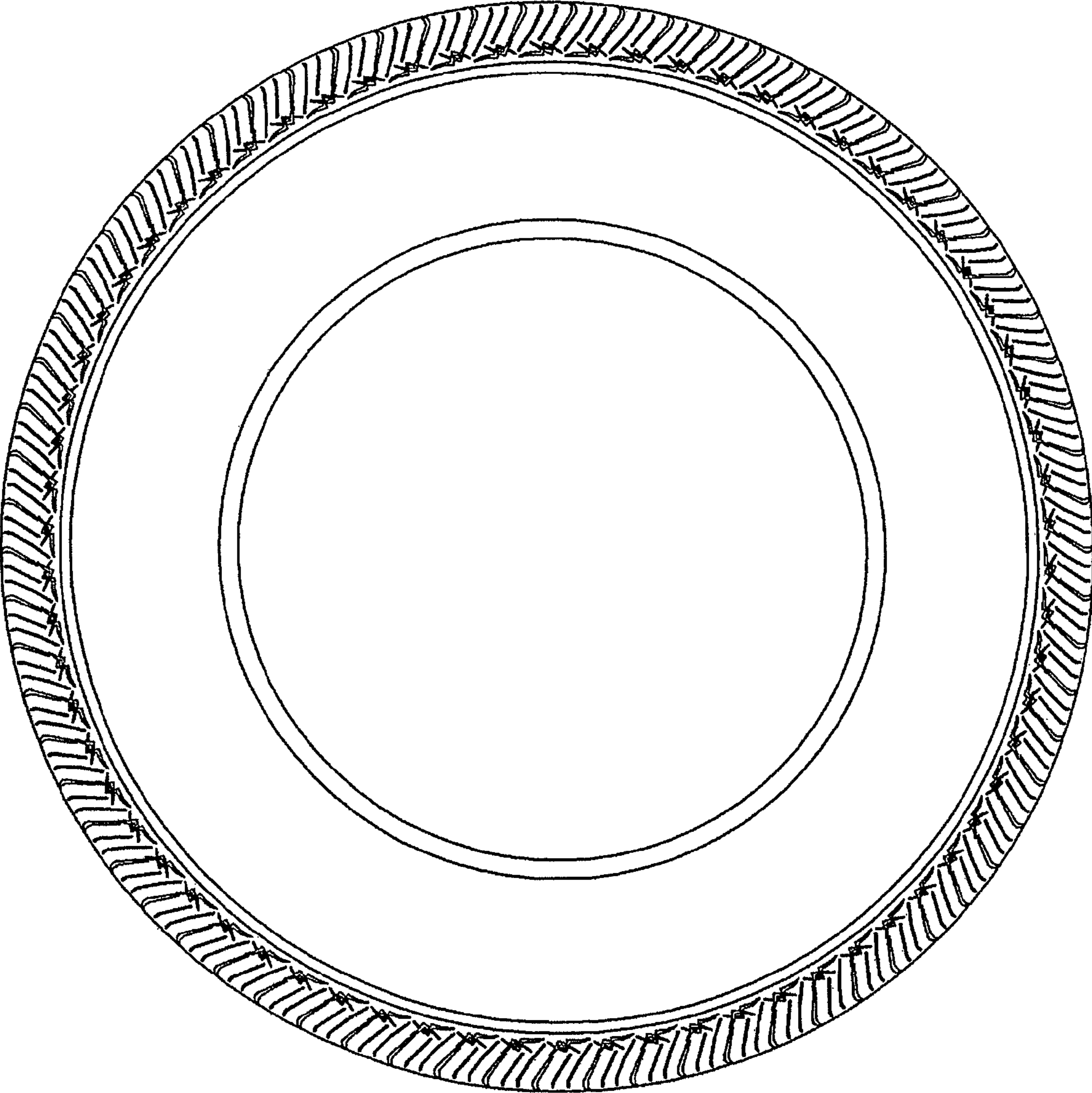

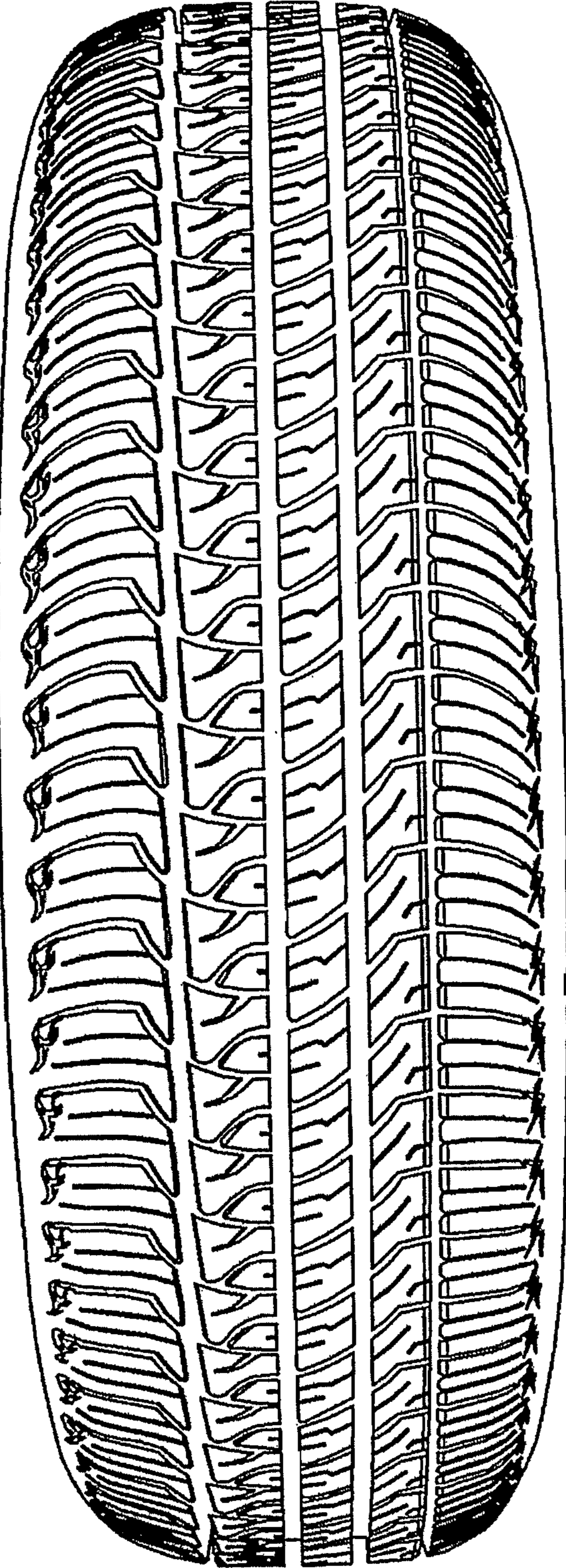

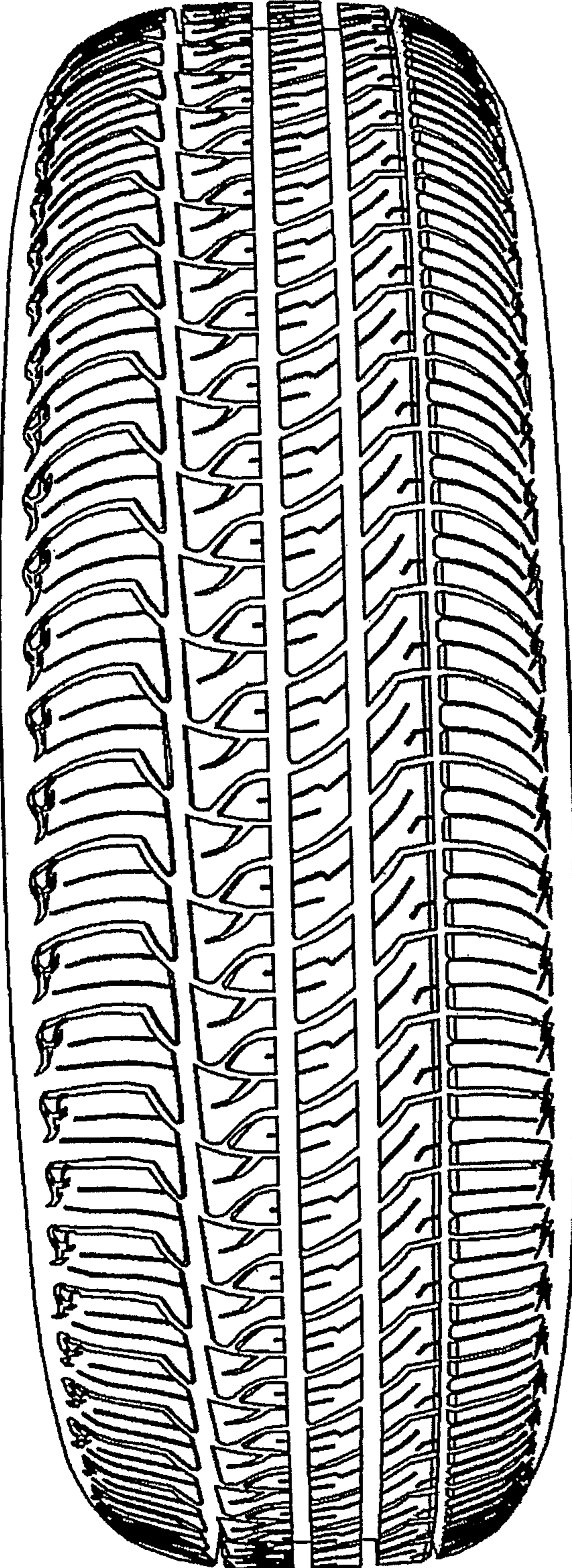
