(57) **CLAIM**

We claim the ornamental design for a portable electronic device displaying graphical user interface, as shown and described.

**DESCRIPTION**

FIG. 1 is a first image of a portable electronic device displaying graphical user interface showing our new design;

FIG. 2 is a second image of a portable electronic device displaying graphical user interface showing our new design; and,

FIG. 3 is a third image of a portable electronic device displaying graphical user interface showing our new design.

The appearance of the transitional image sequentially transitions between the images shown in FIGS. 1-3. The process or period in which one image transitions to another image forms no part of the claimed design.

The broken line showing of the mobile terminal, and the numbers and symbols, is included for the purpose of illustrating environmental structure and portions of the article, respectively, and forms no part of the claimed design.

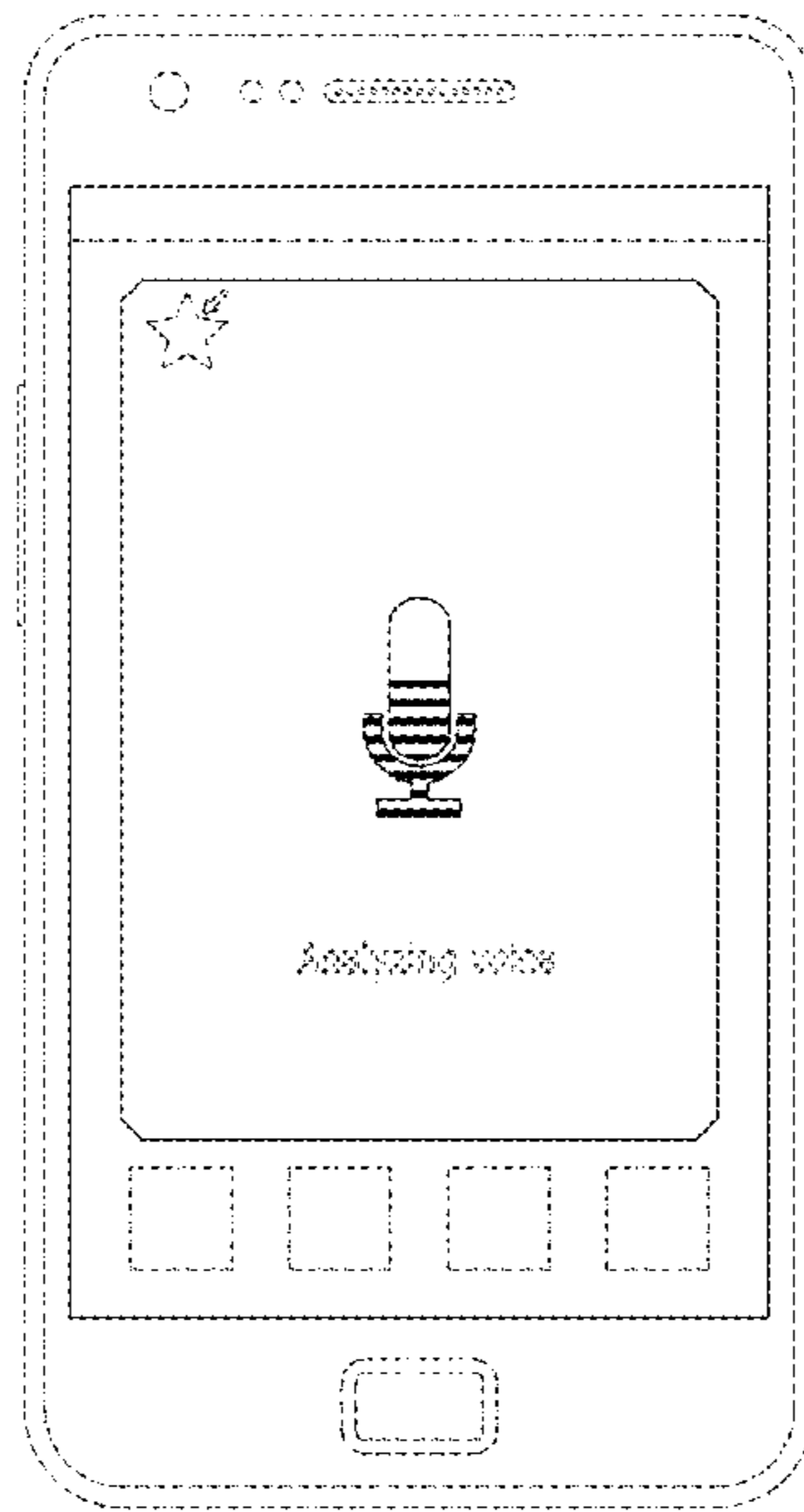
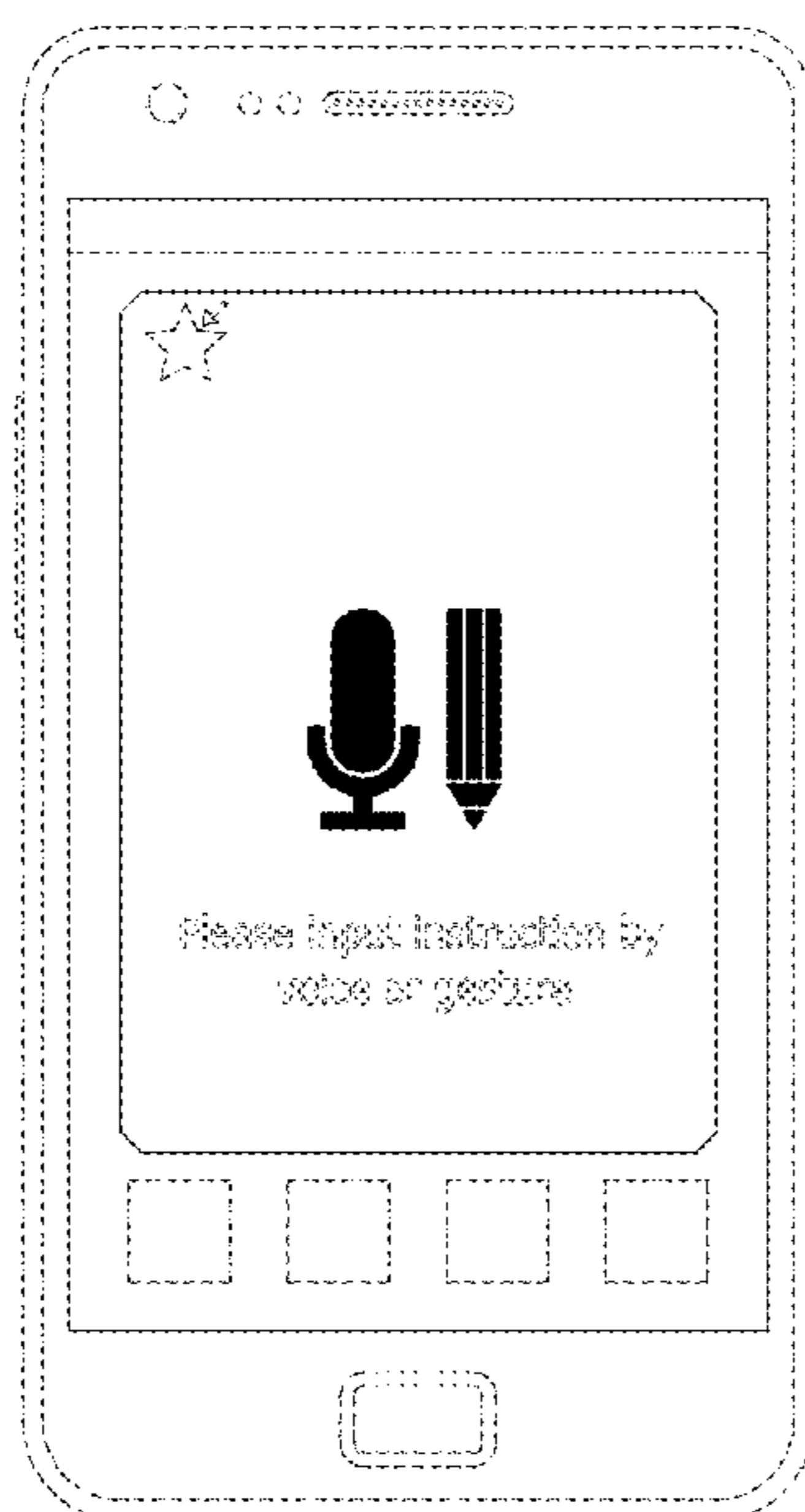

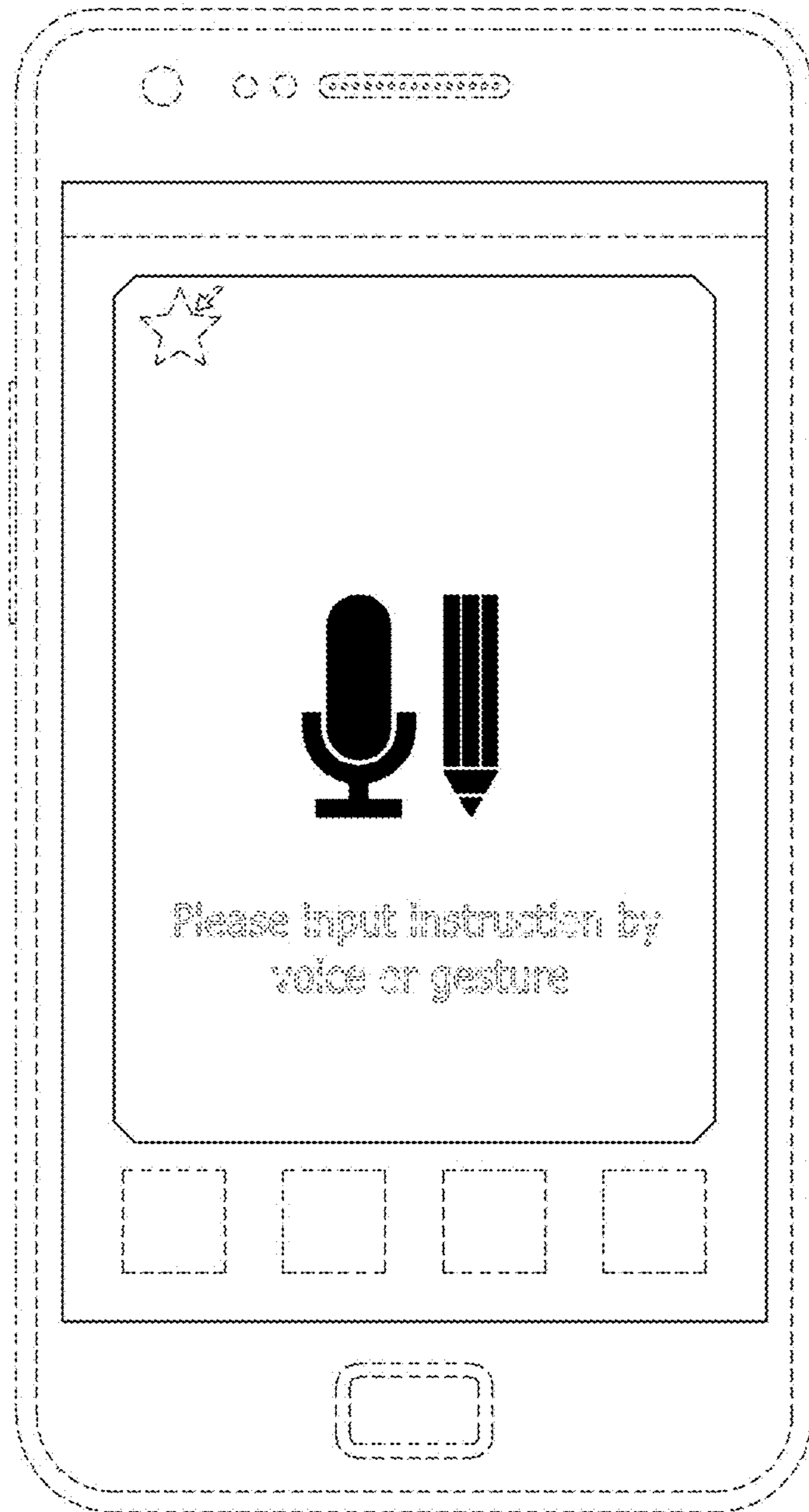
