(57) **CLAIM**

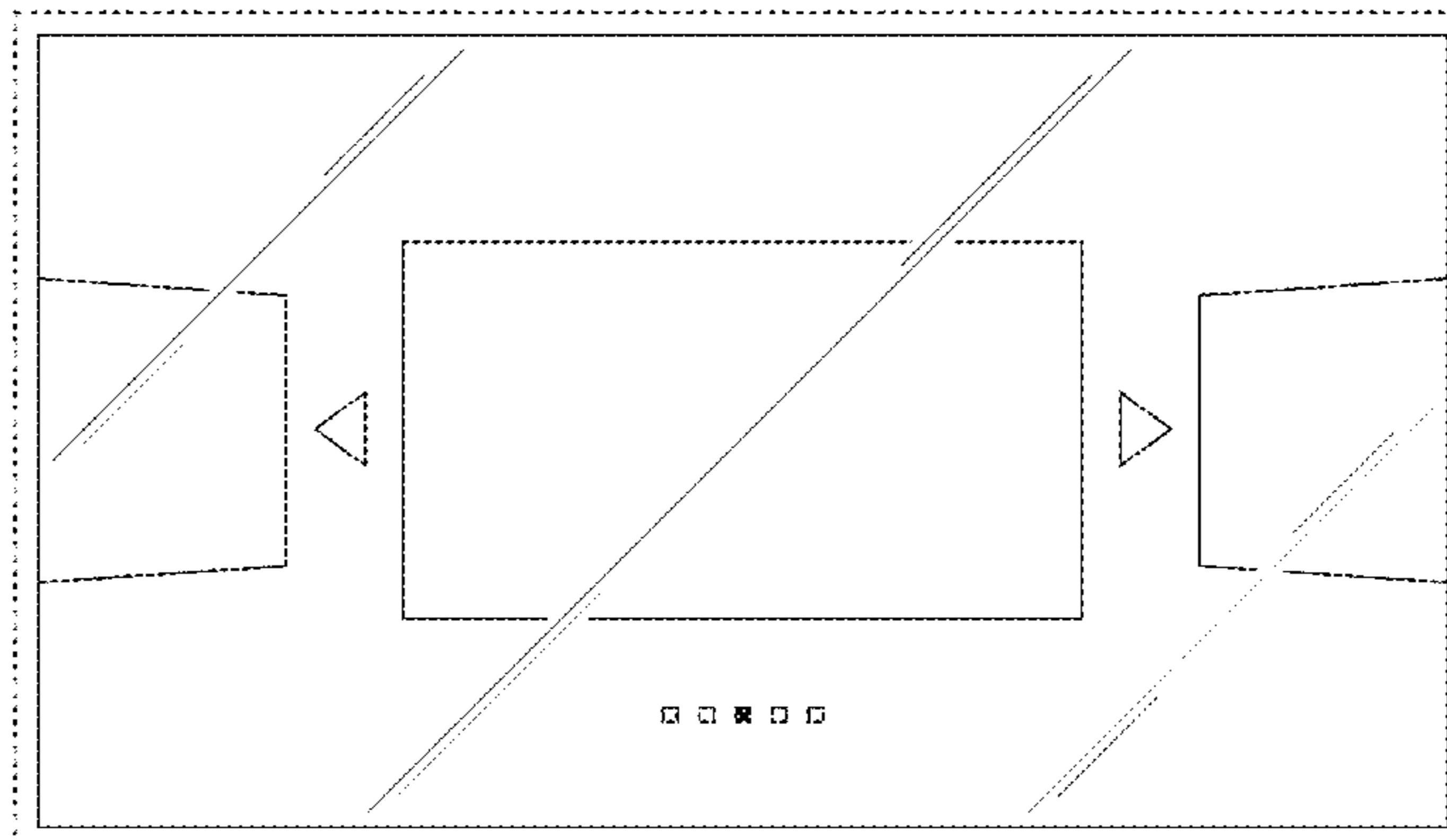
I claim the ornamental design for a display screen with graphical user interface, as shown and described.

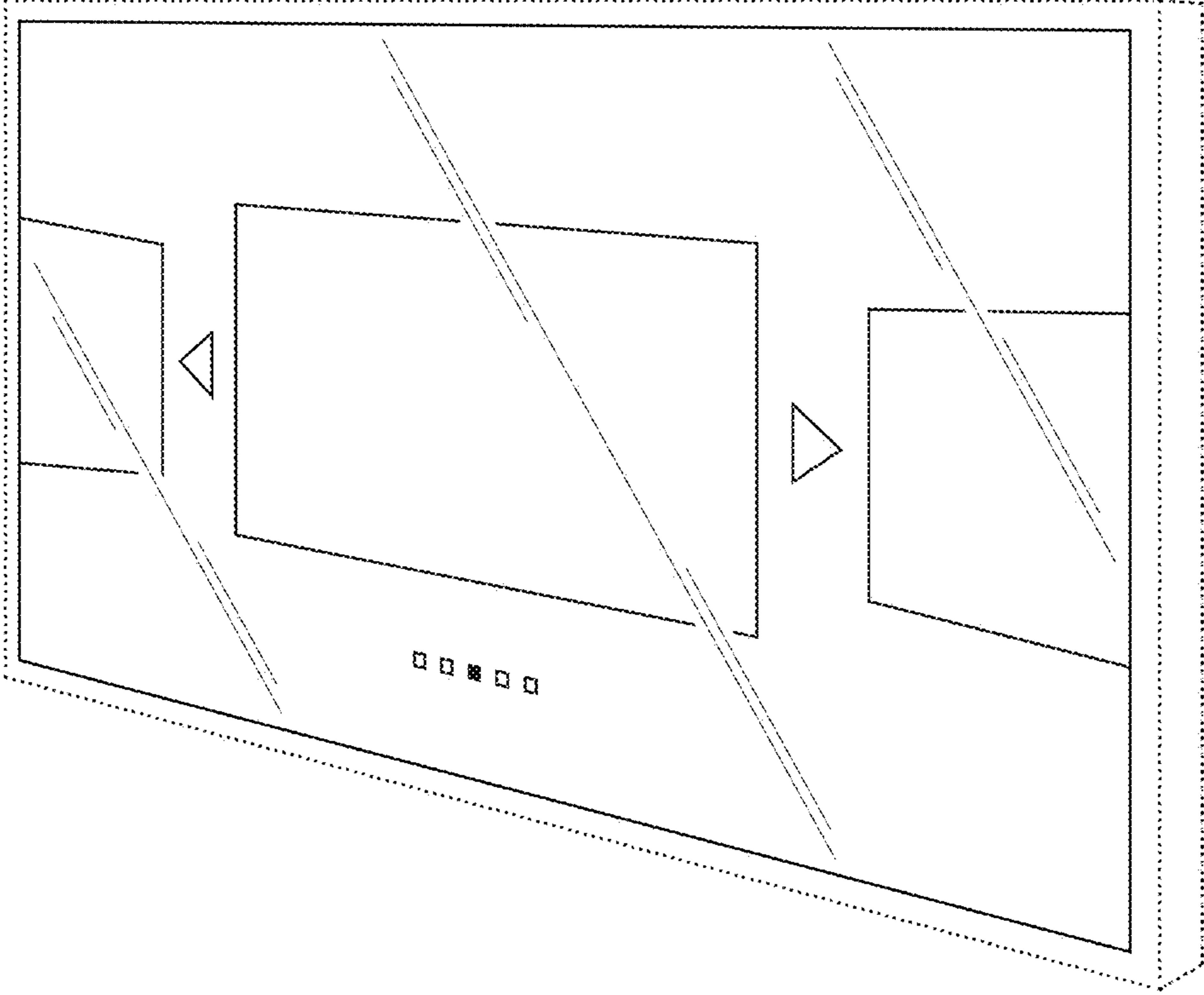

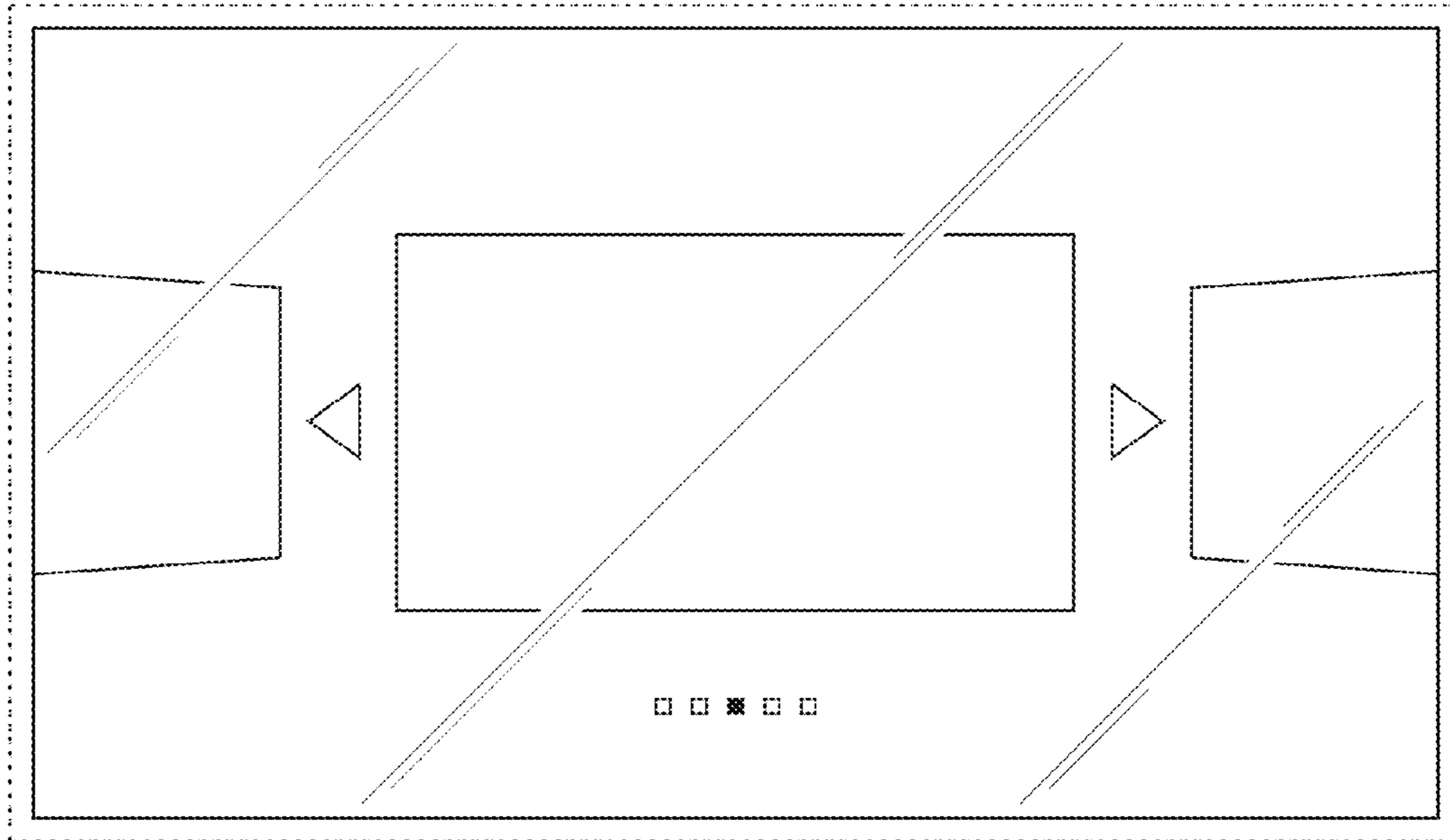

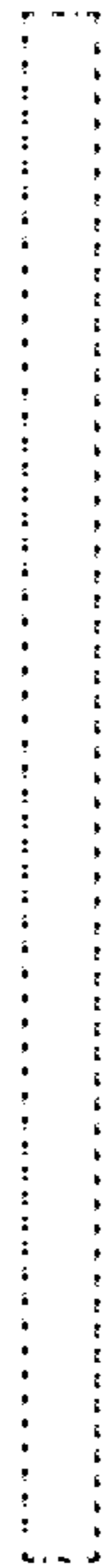

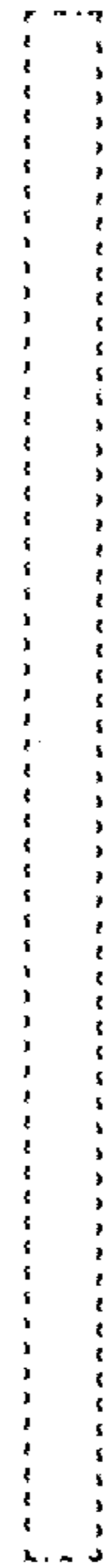

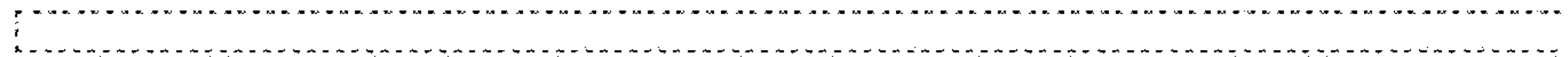
