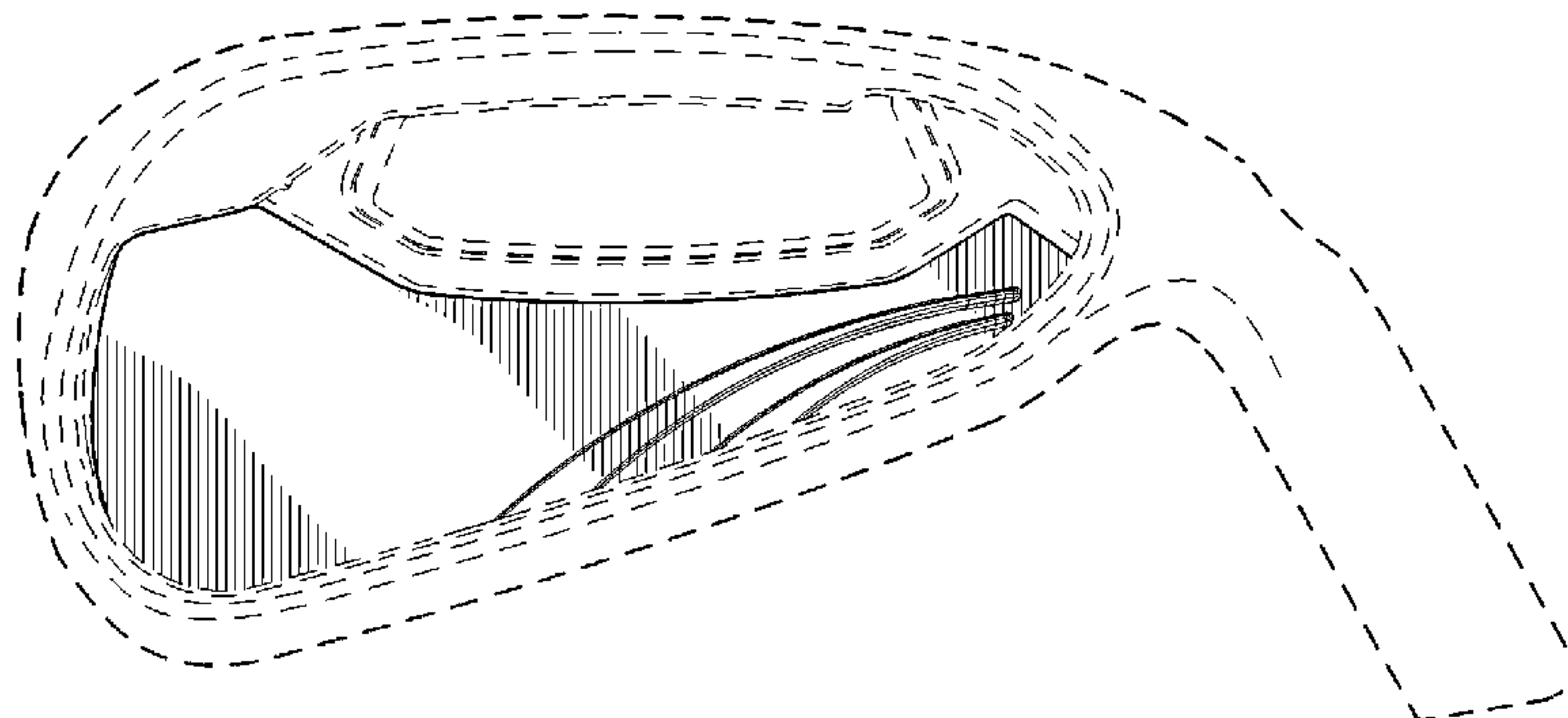
(57) **CLAIM**

The ornamental design for a badge for a golf club head, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a badge for a golf club head;
FIG. 2 is a bottom perspective view of a badge for a golf club head;

FIG. 4 is a rear view of the badge of FIG. 1;
FIG. 5 is a top view of the badge of FIG. 1;

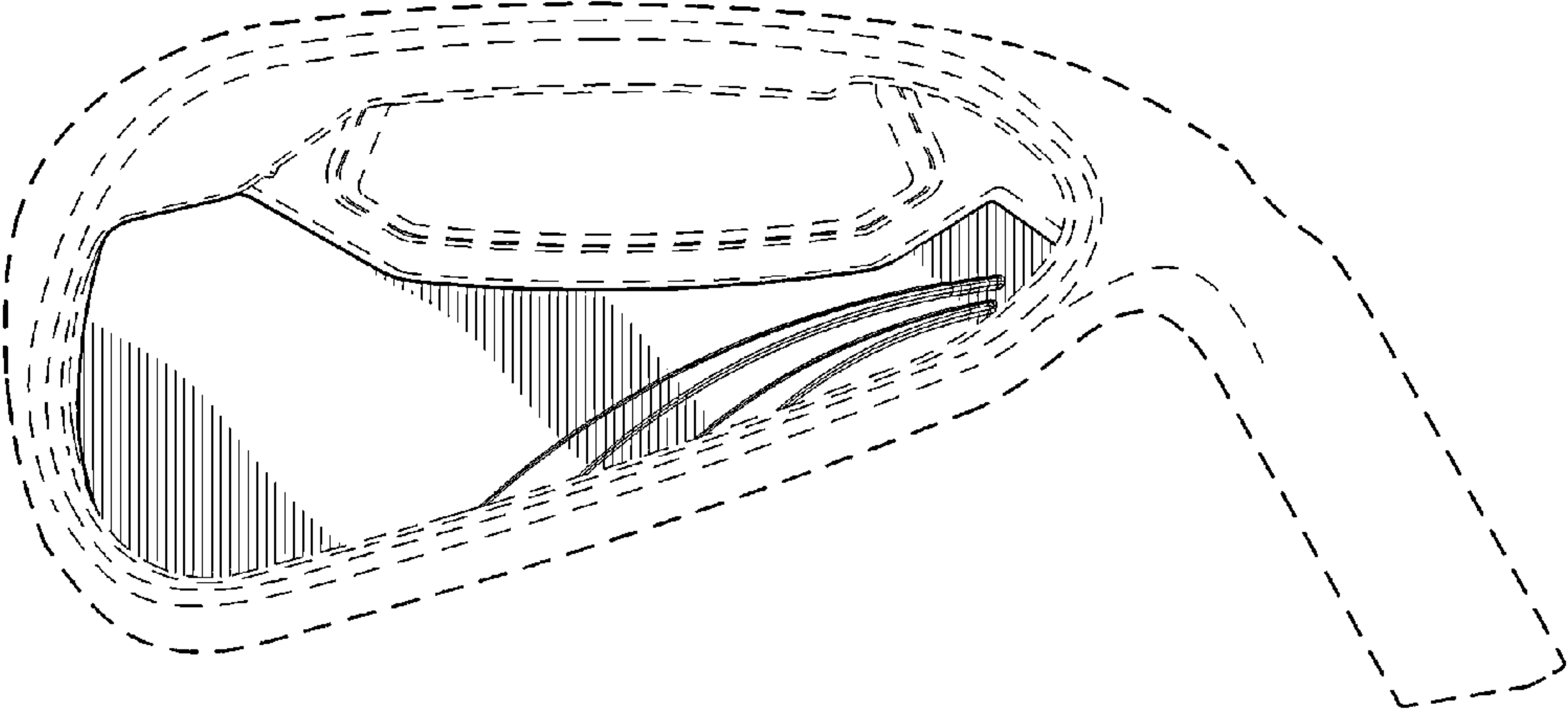

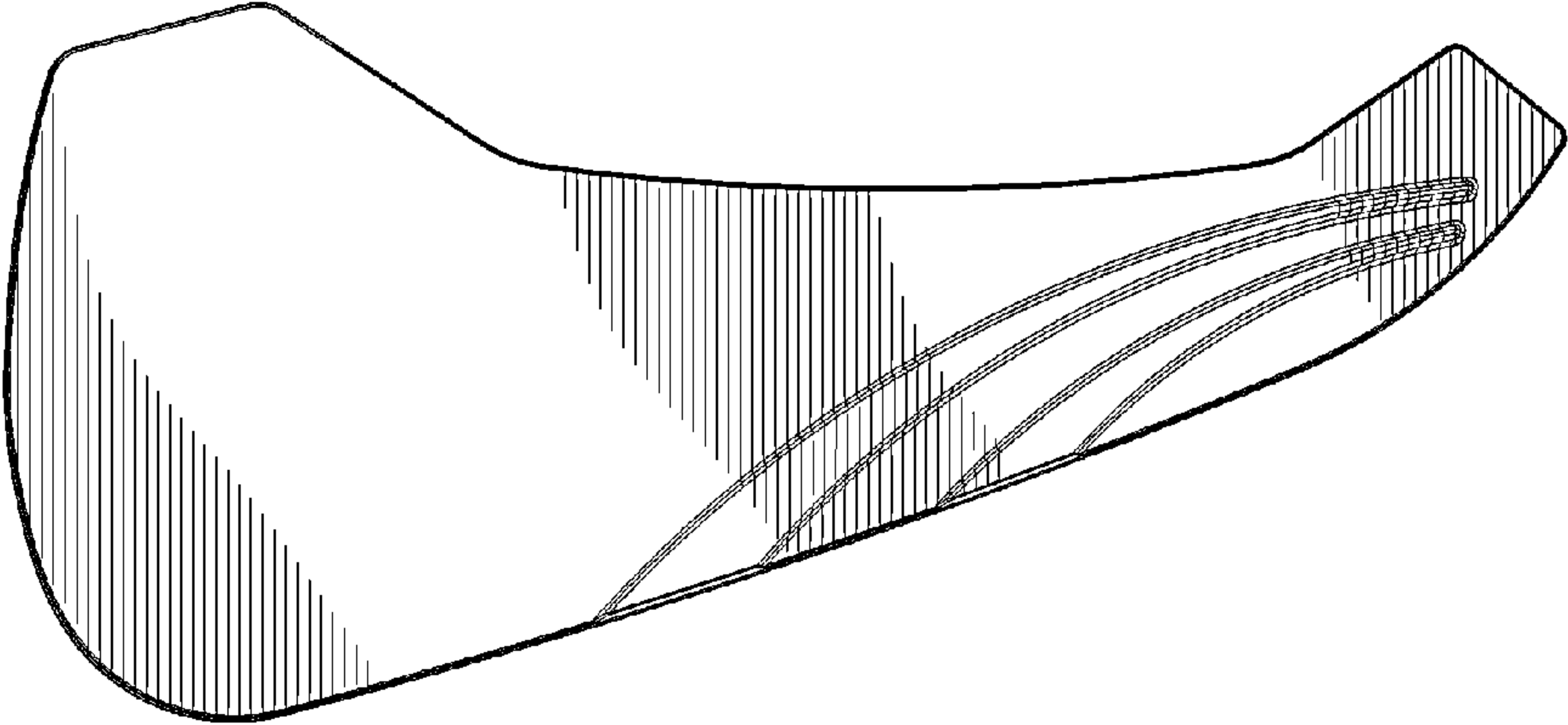

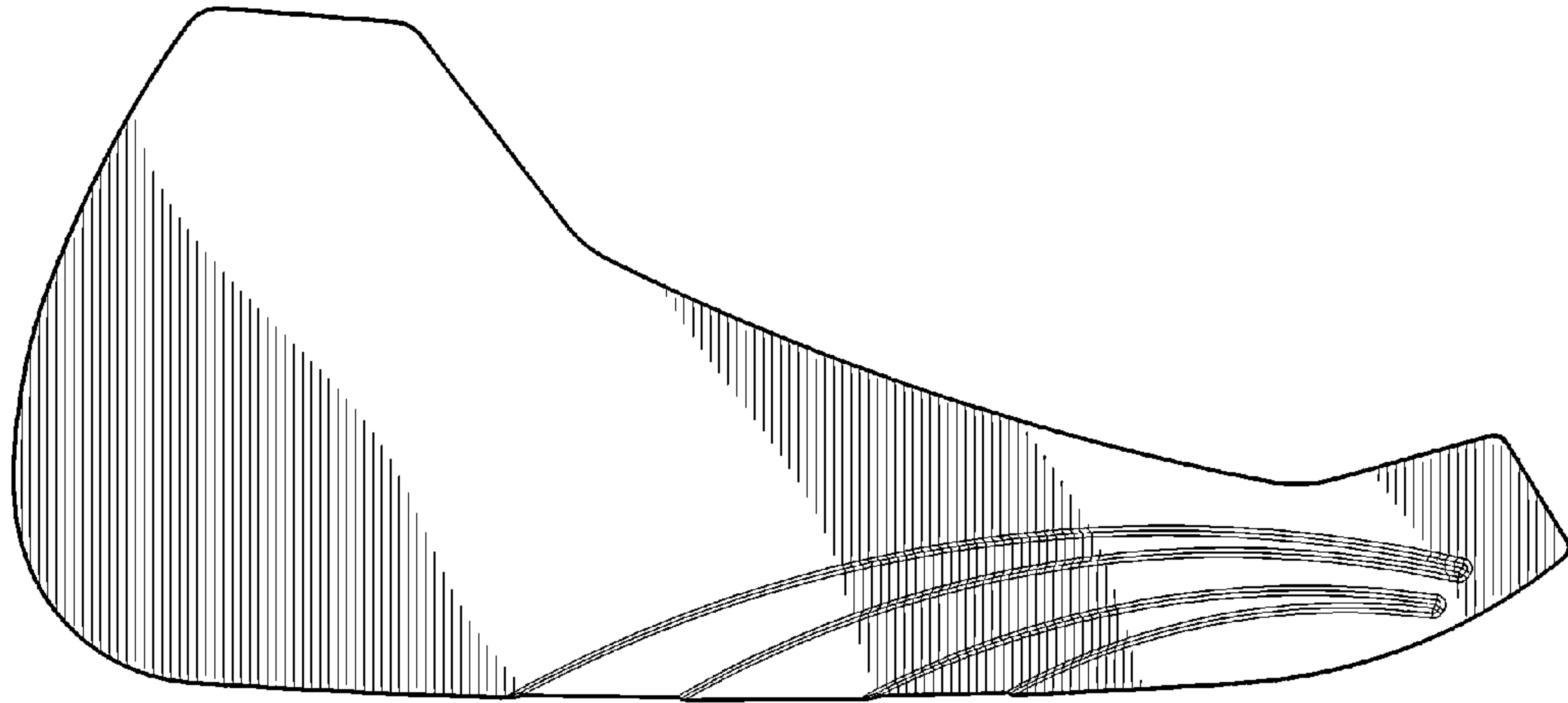

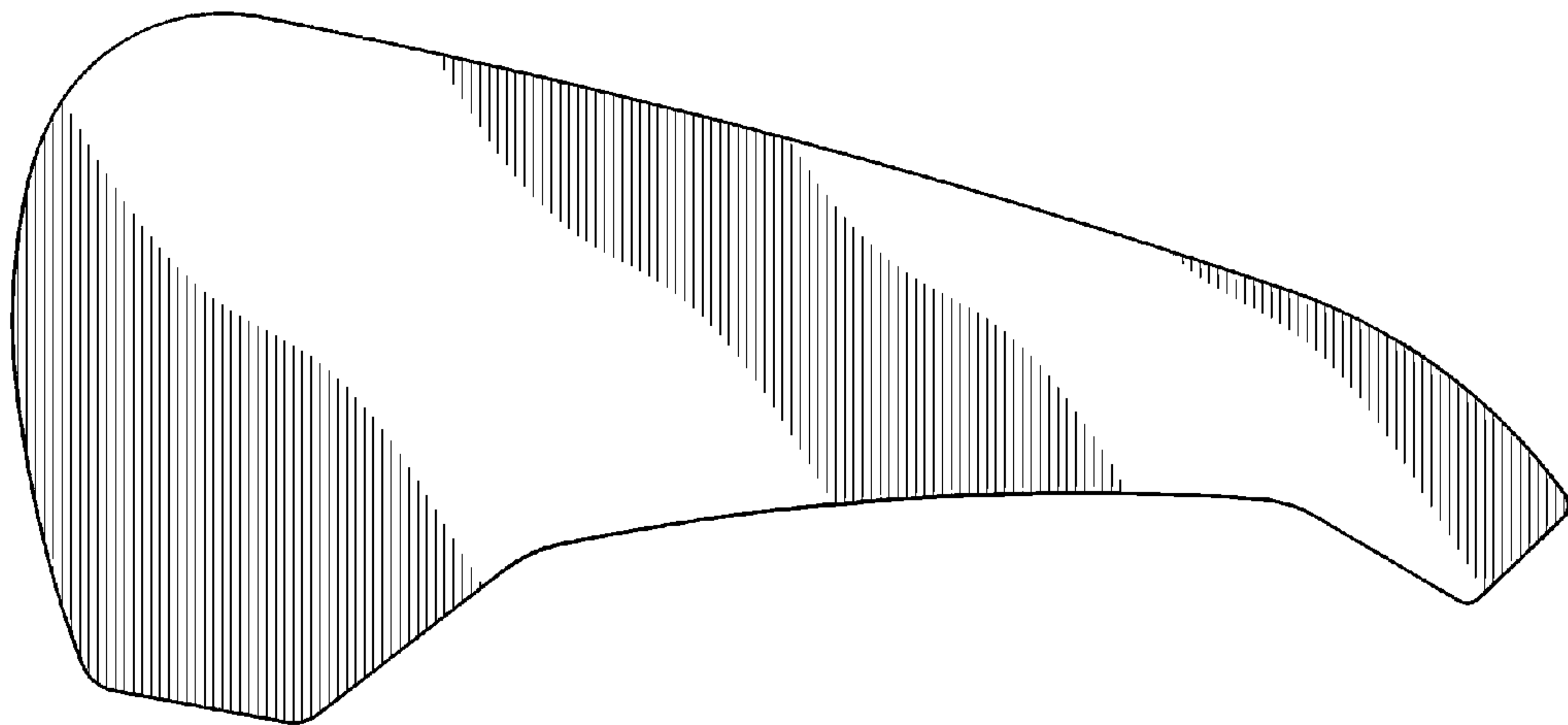
