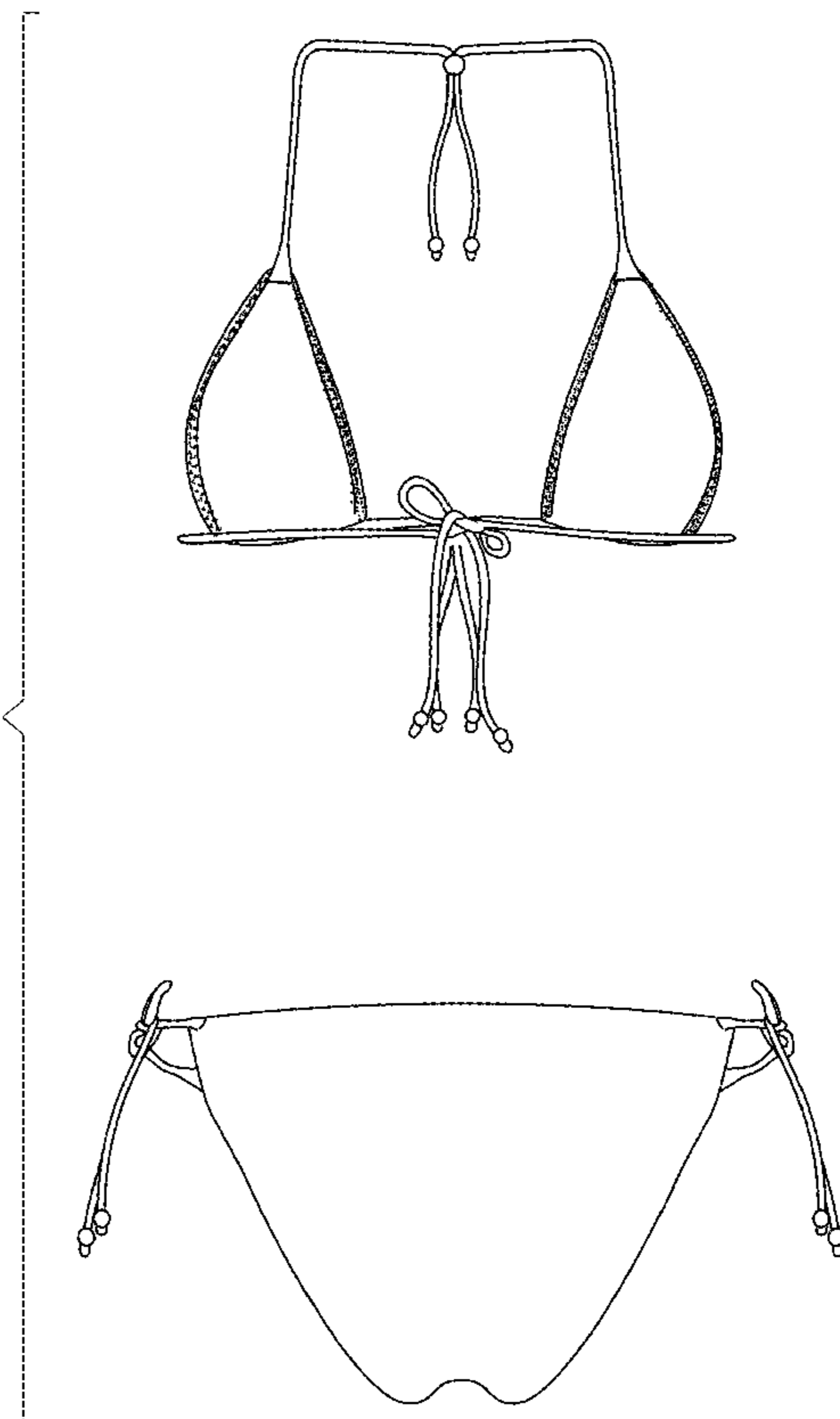
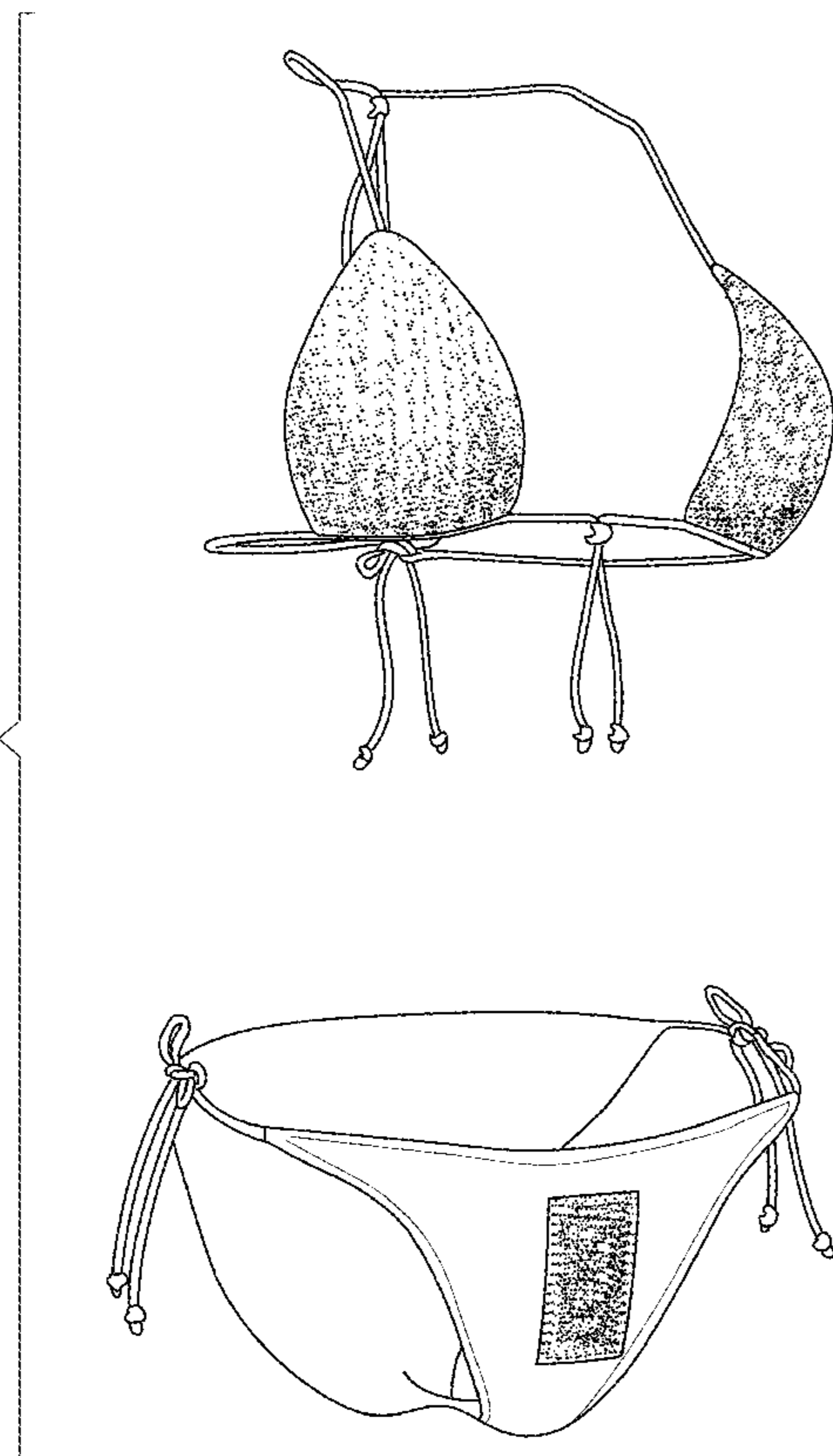
The ornamental design for a coconut bathing suit, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a coconut bathing suit;

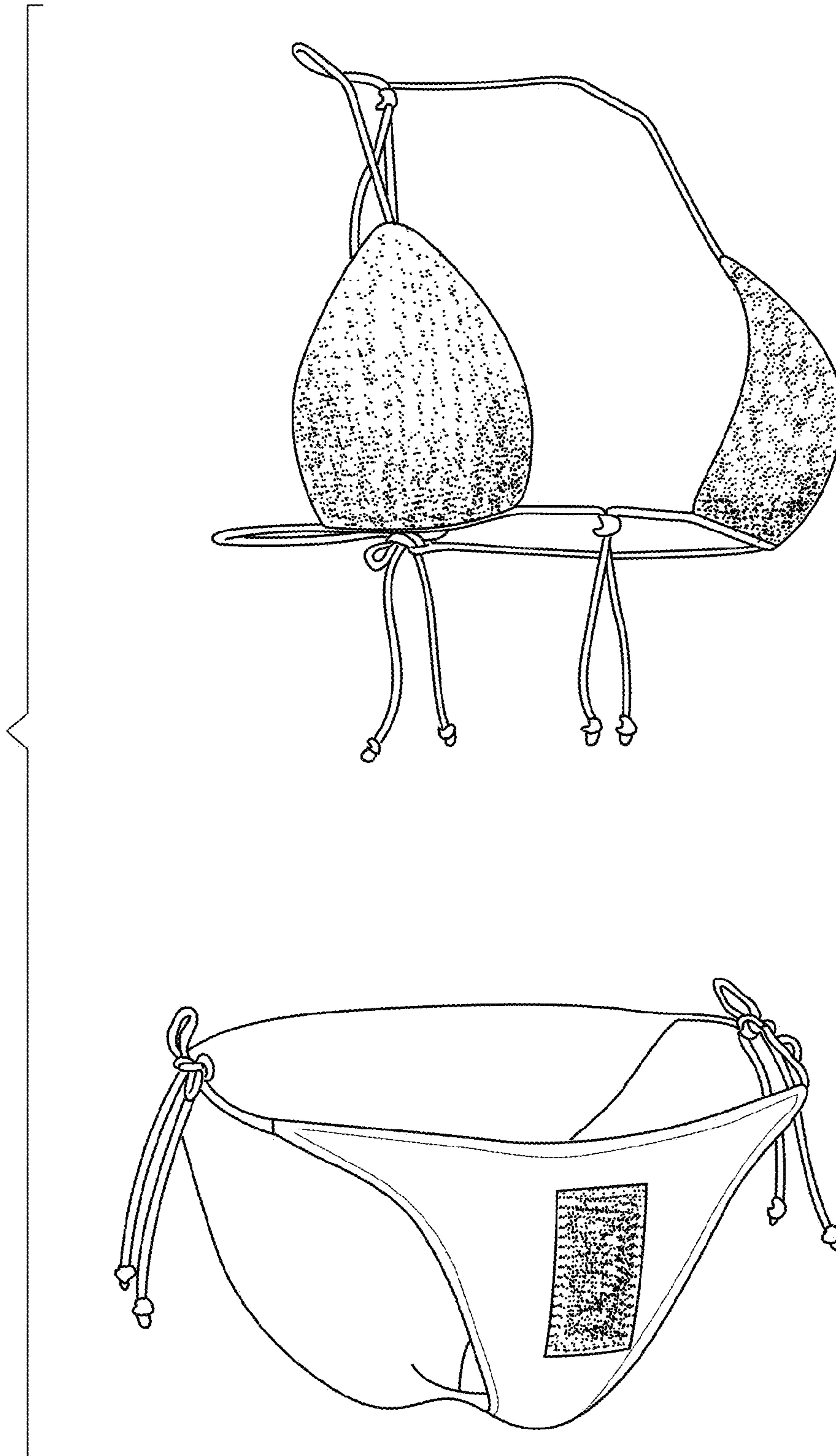

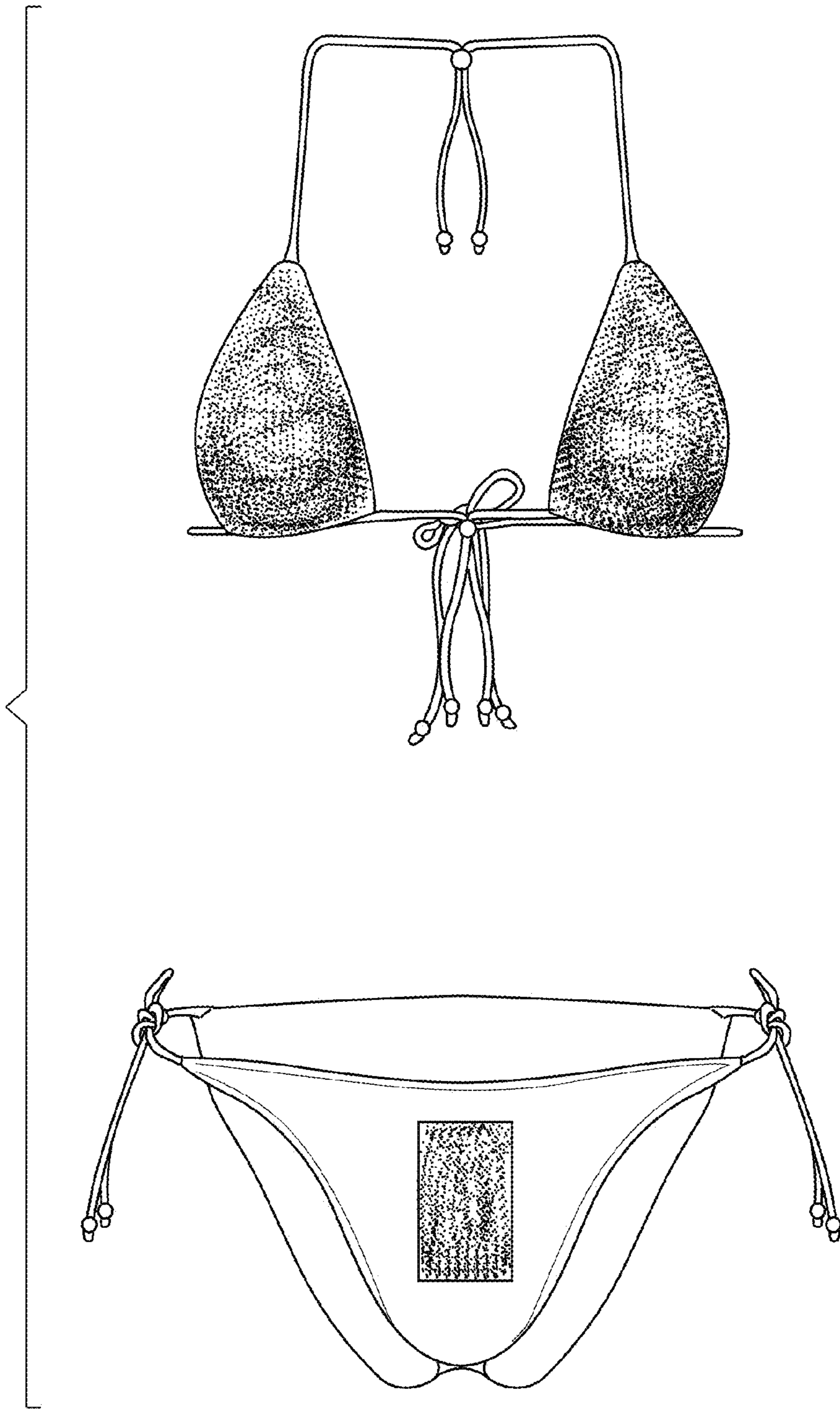

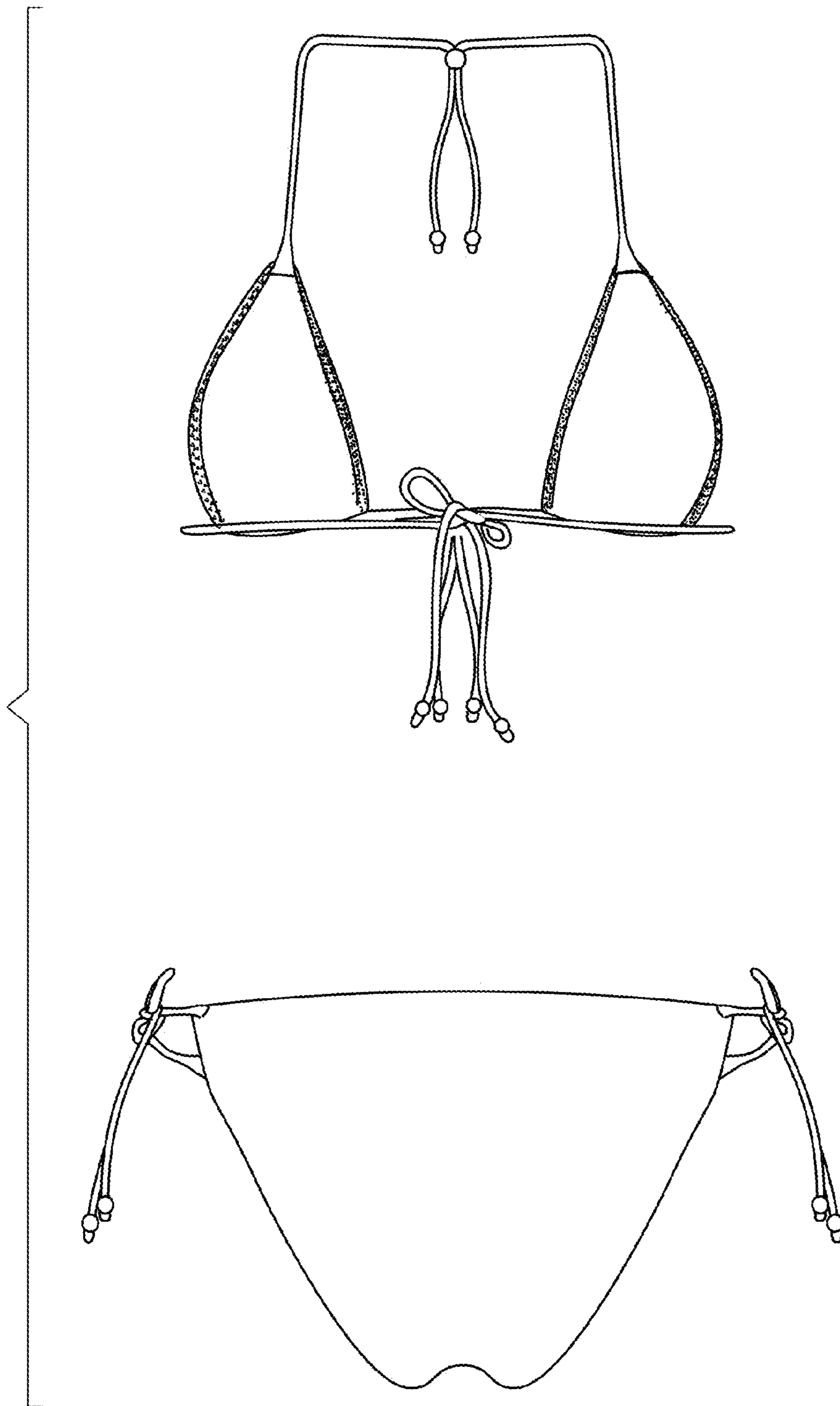

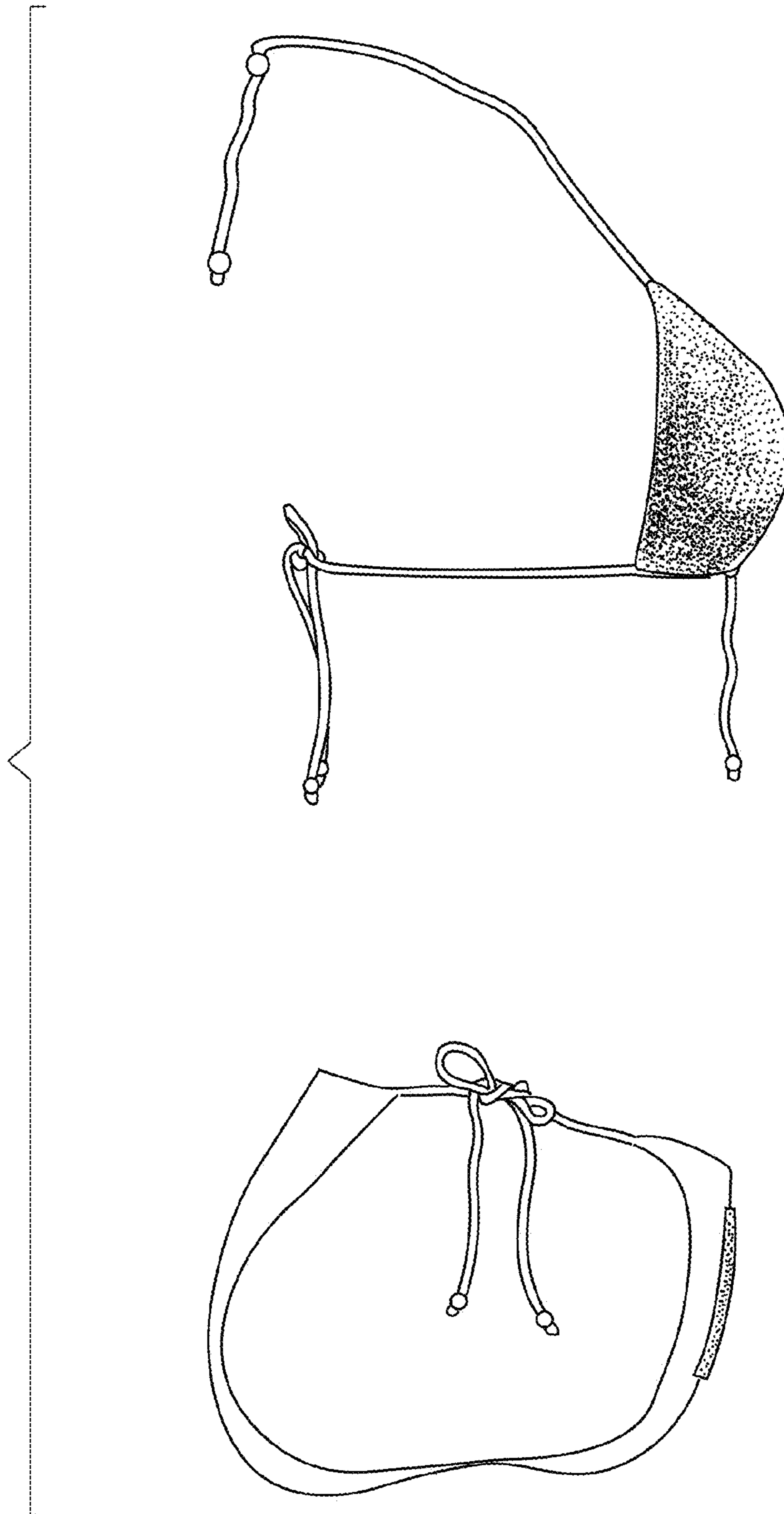

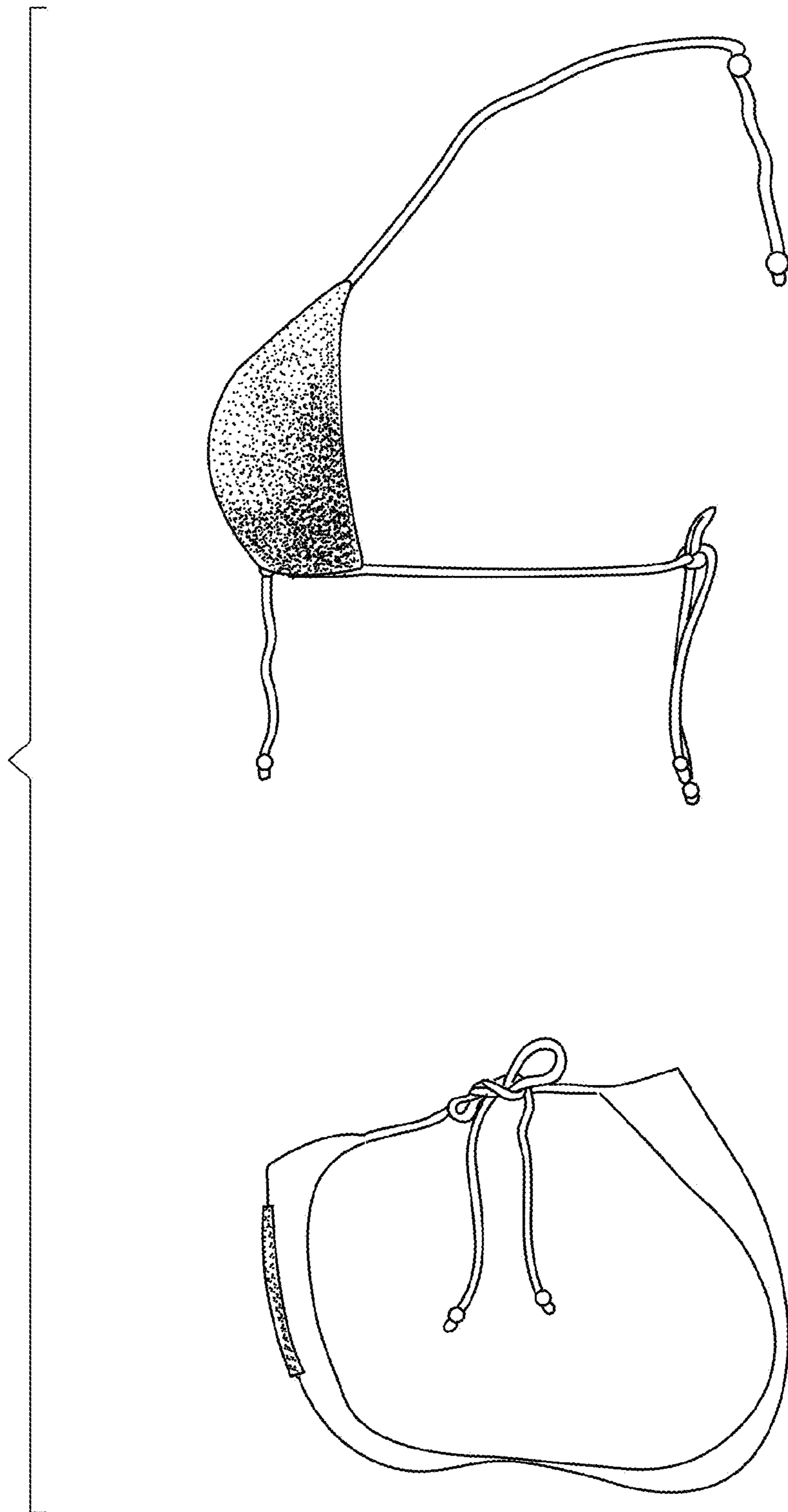

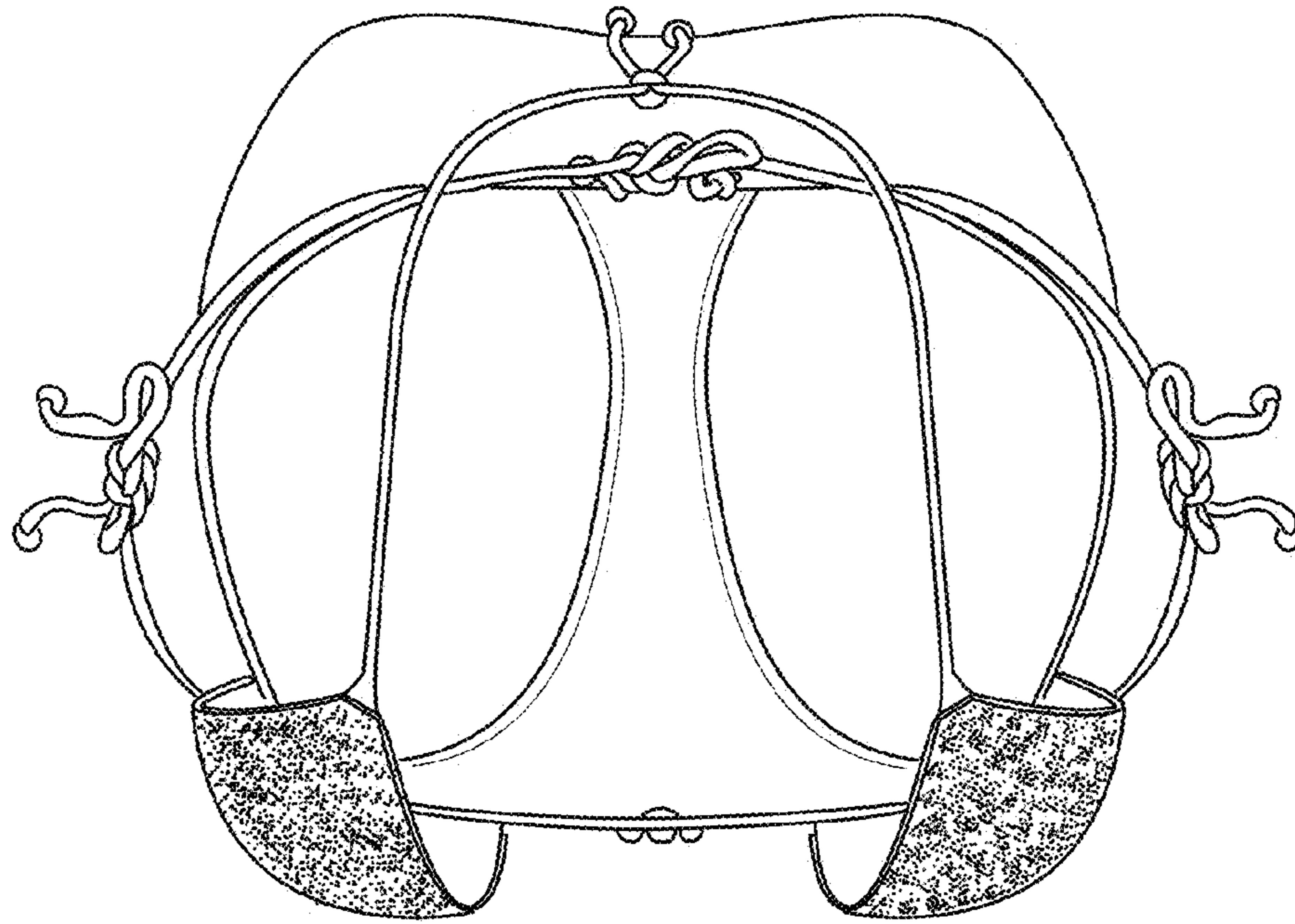

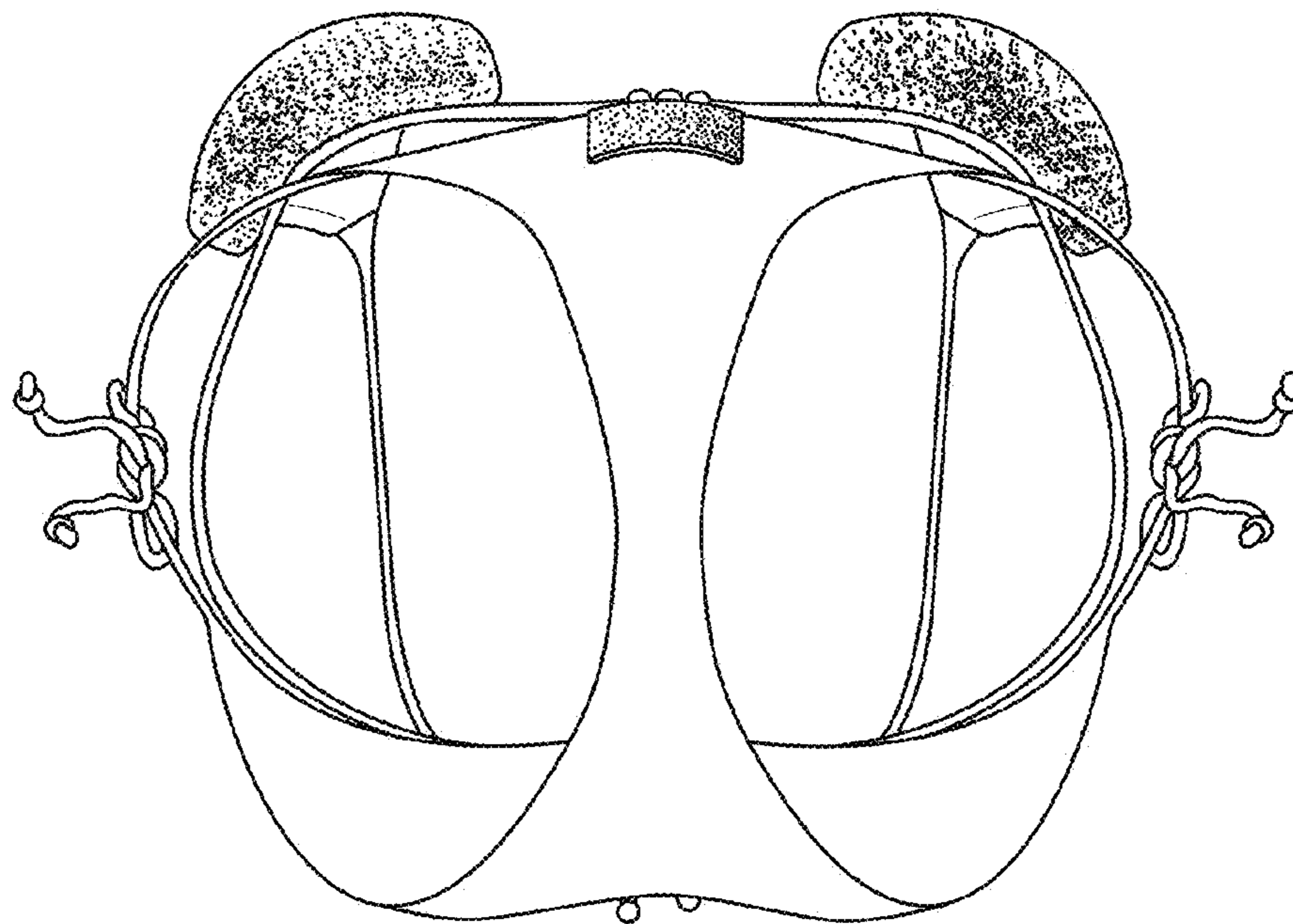

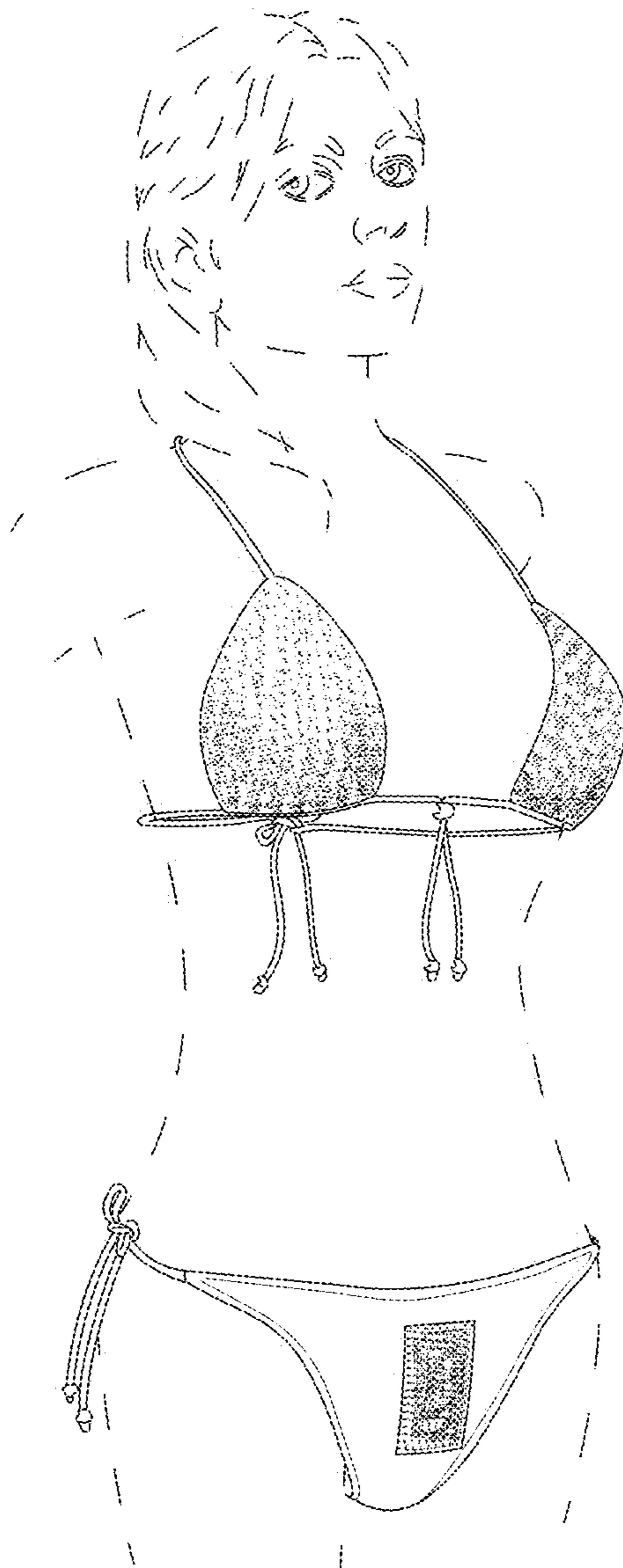

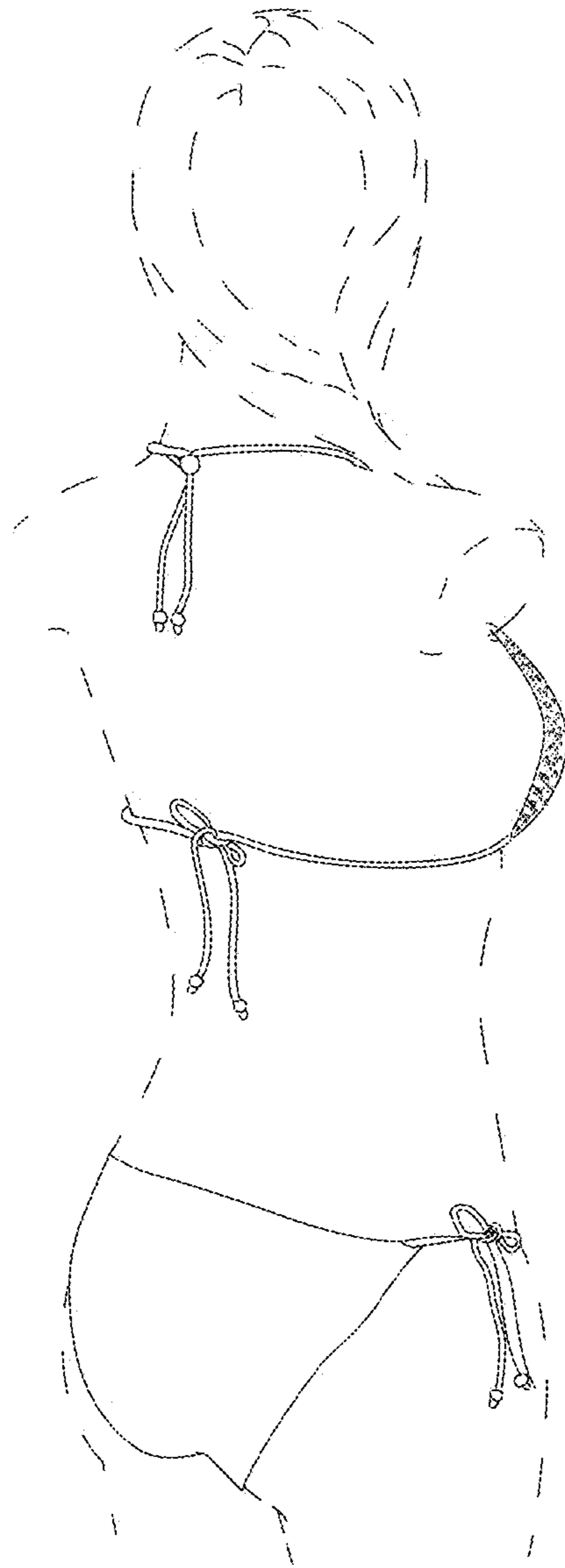
