(57) **CLAIM**

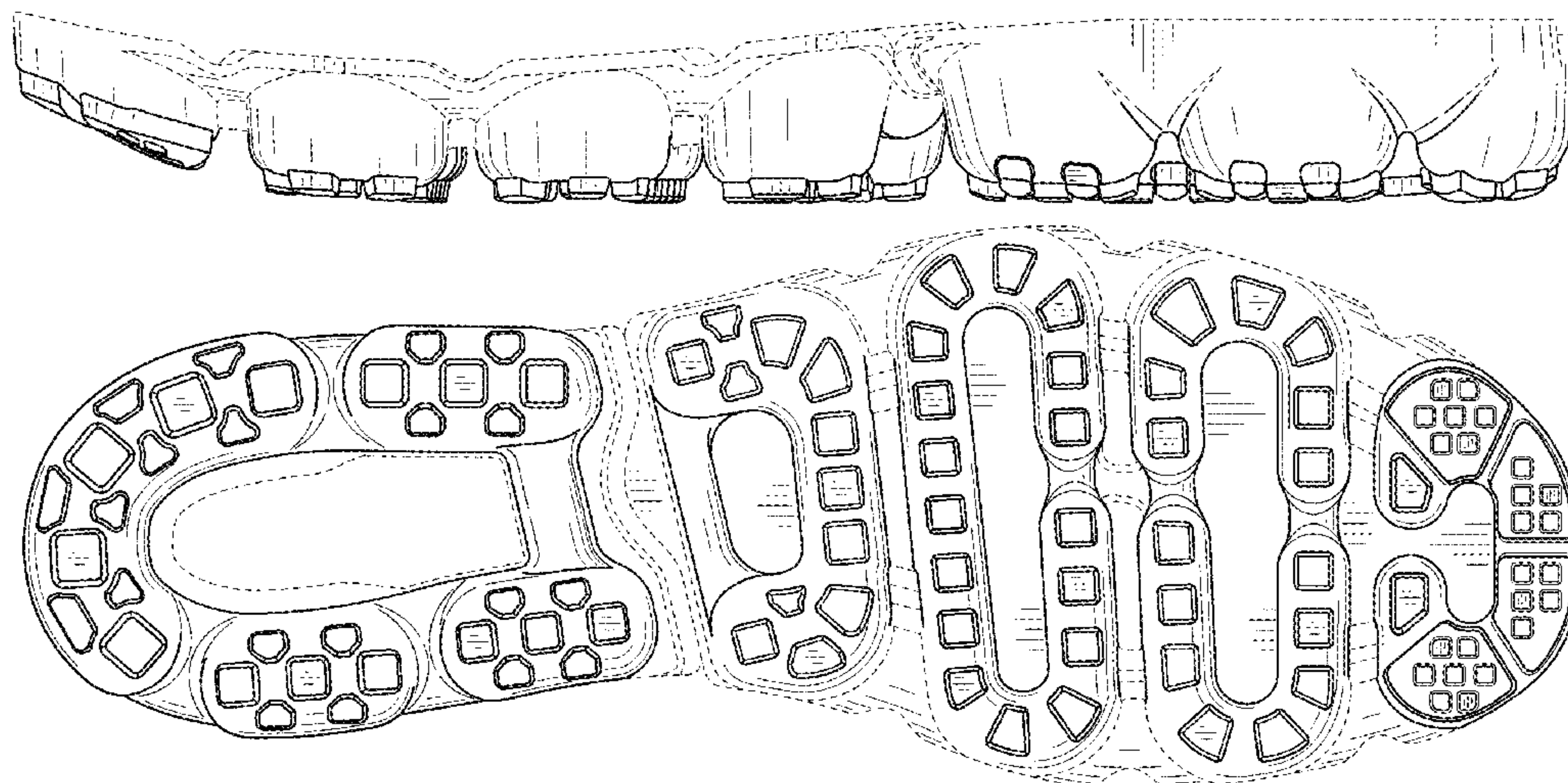
The ornamental design for a shoe sole, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a shoe sole showing our new design;  
FIG. 2 is a medial side view thereof;  
FIG. 3 is a lateral side view thereof;  
FIG. 4 is front view thereof;  
FIG. 5 is a rear view thereof;  
FIG. 6 is a bottom view thereof;  
FIG. 7 is a perspective view of the shoe sole of FIGS. 1-6 depicted with the generally-horizontal disclaimed seam line removed for clarity purposes;  
FIG. 8 is a medial side view thereof;  
FIG. 9 lateral side view thereof;  
FIG. 10 is a front view thereof;  
FIG. 11 is a rear view thereof; and,  
FIG. 12 is a bottom view thereof.

The broken lines immediately adjacent to the claimed area represent unclaimed boundaries of the design. The broken lines showing the remainder of the shoe sole are for environmental purposes only and form no part of the claimed design.

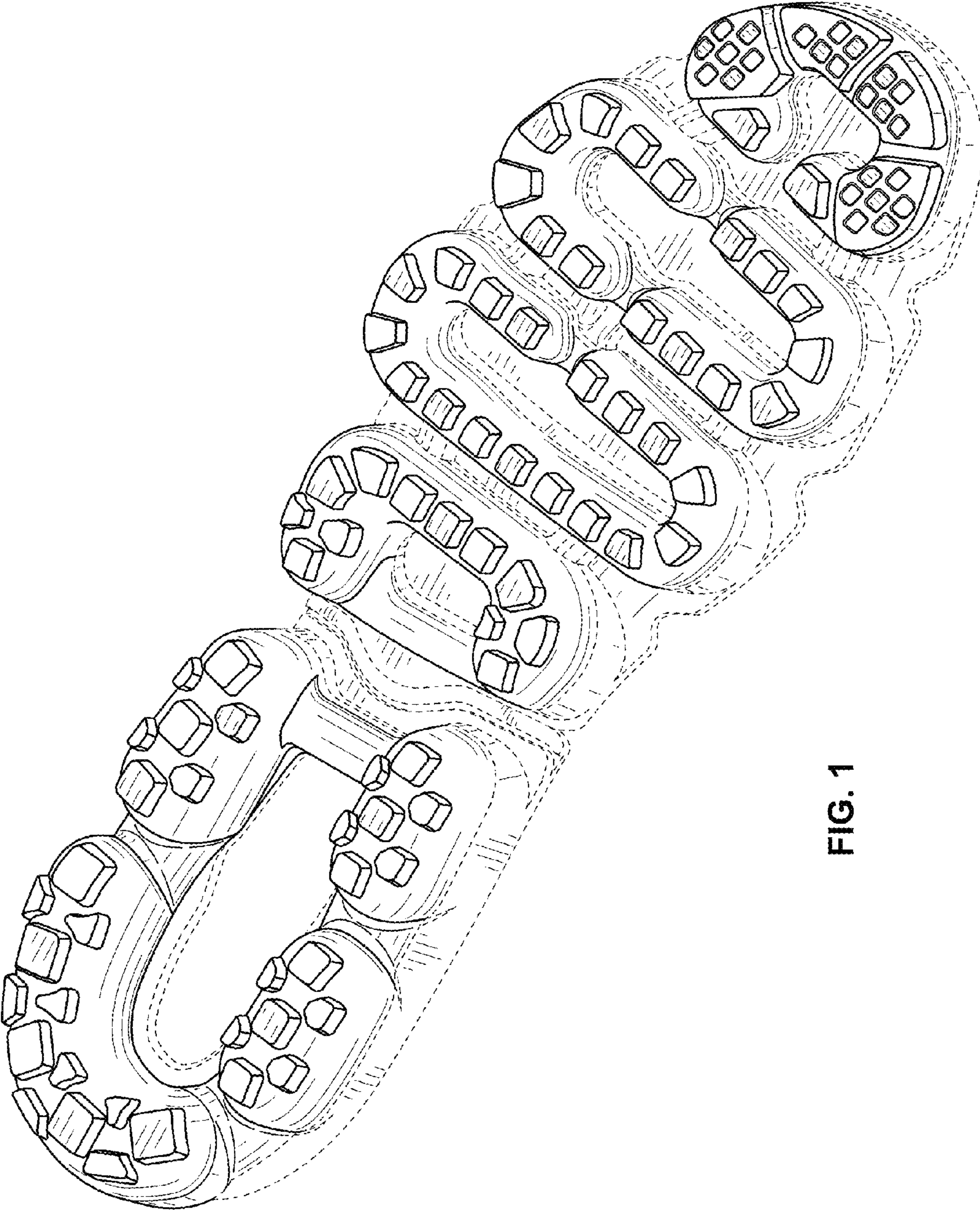

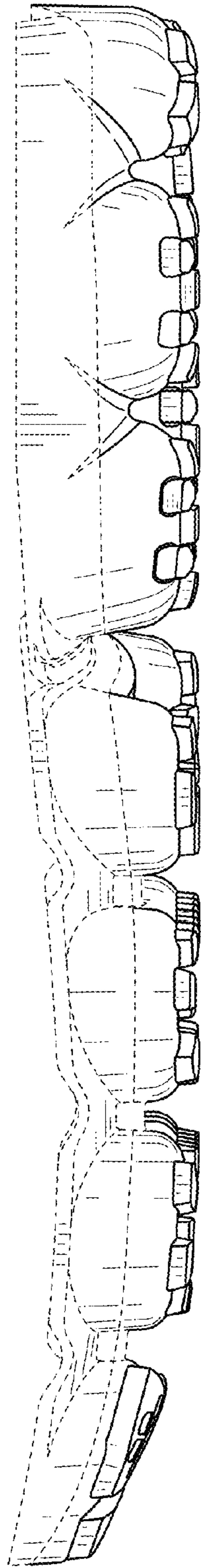

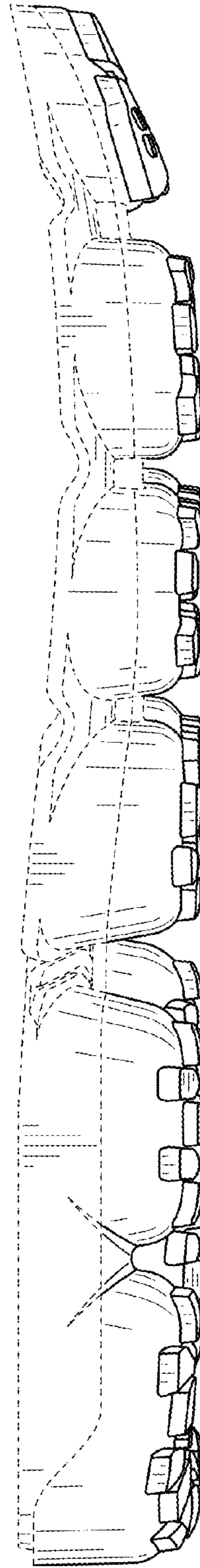

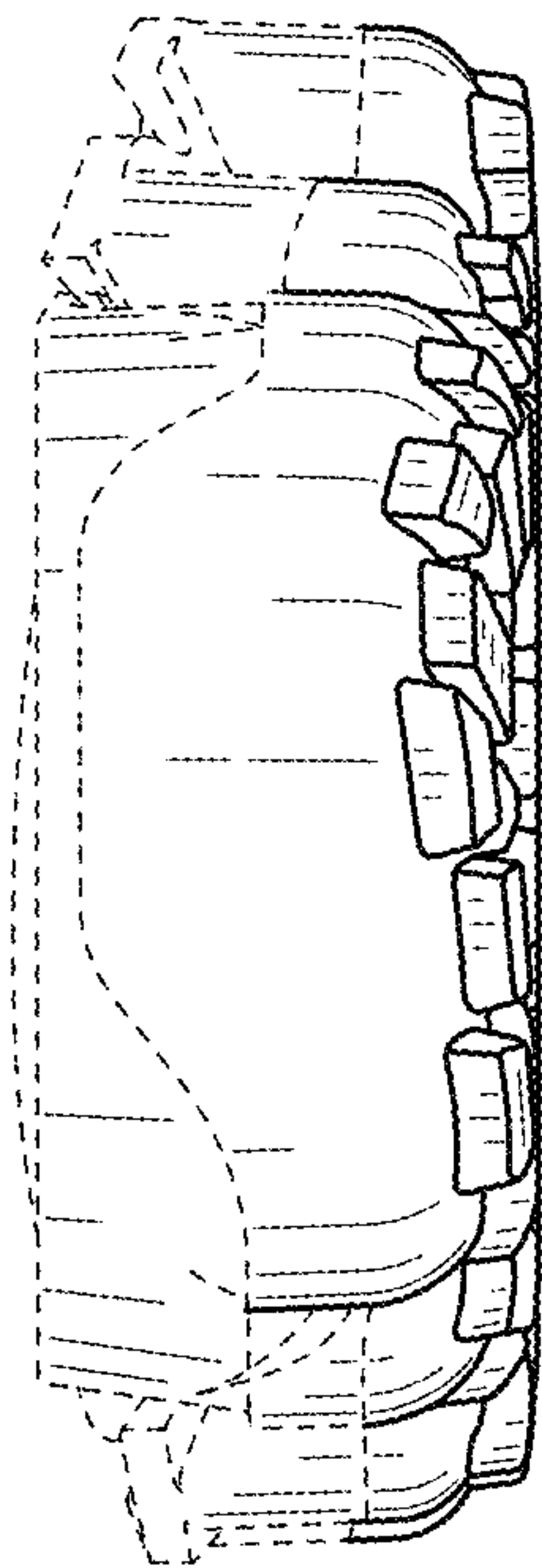

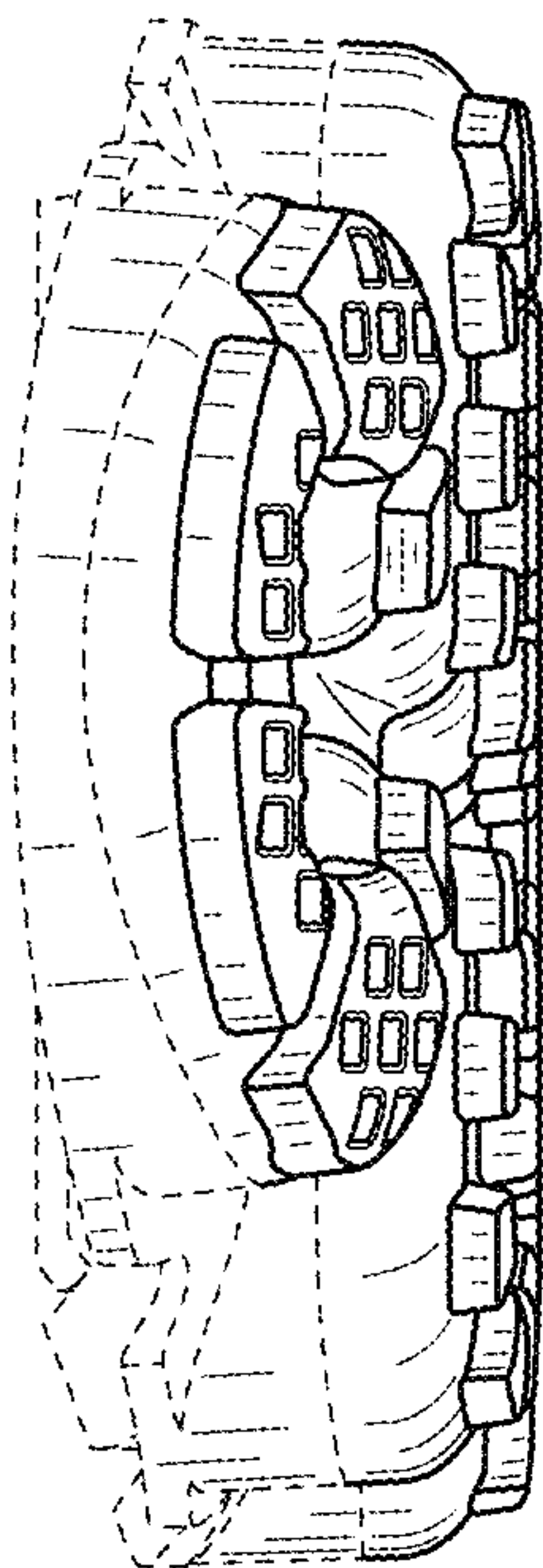

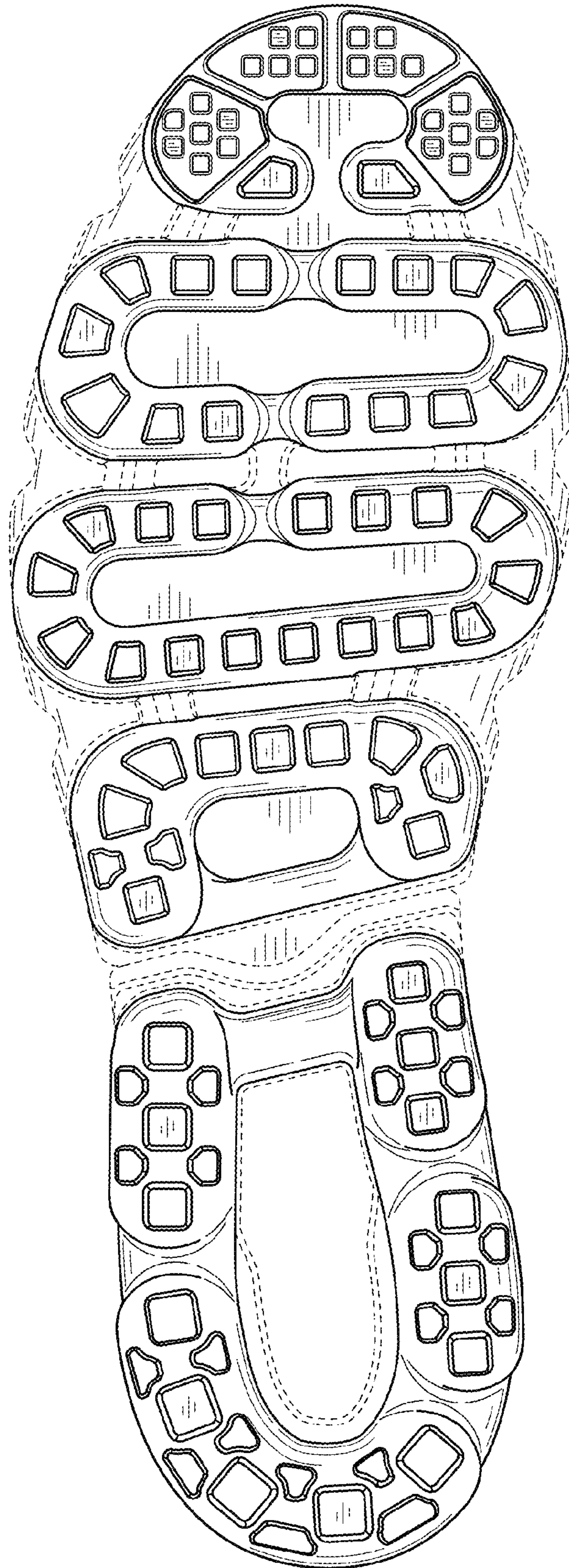

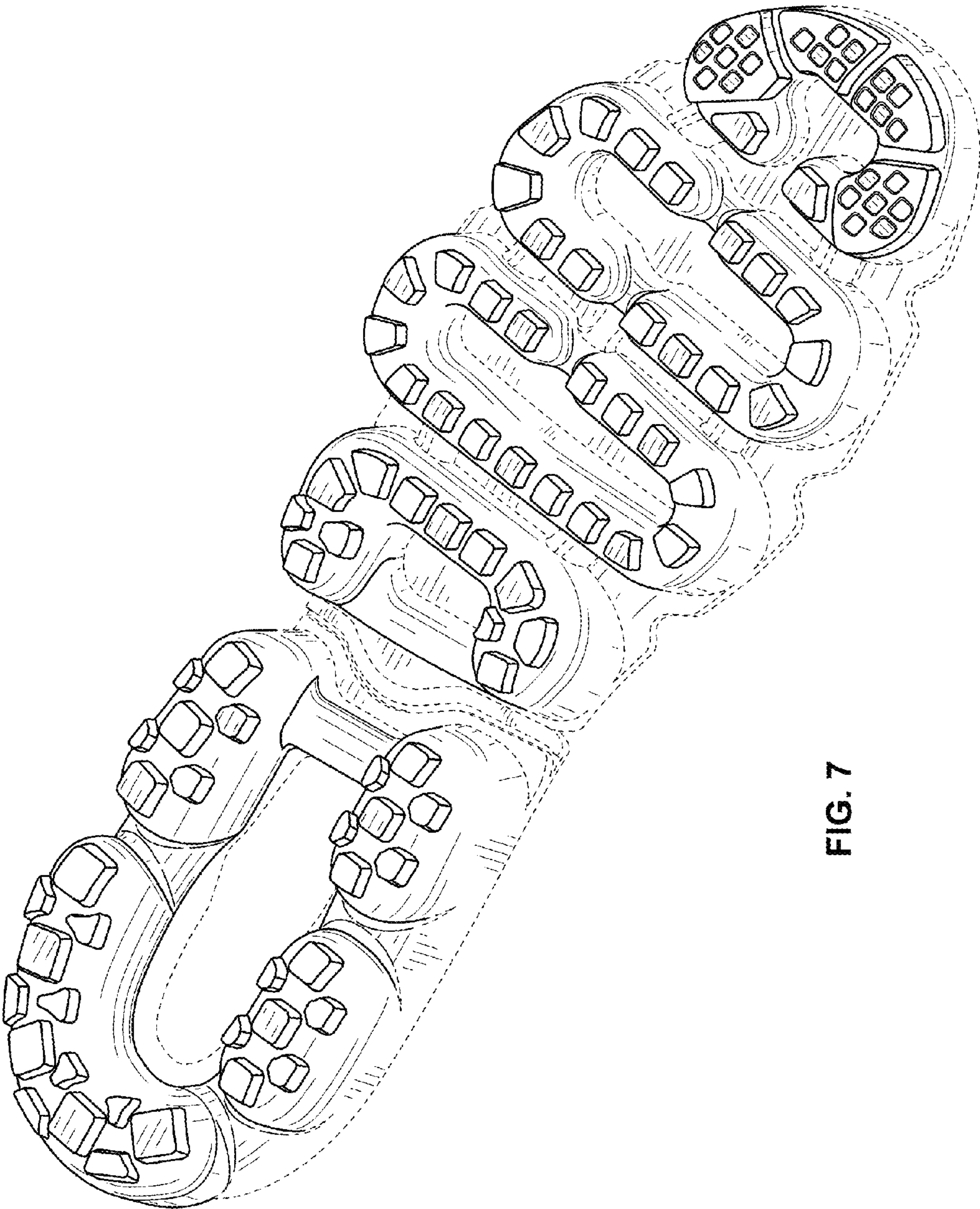

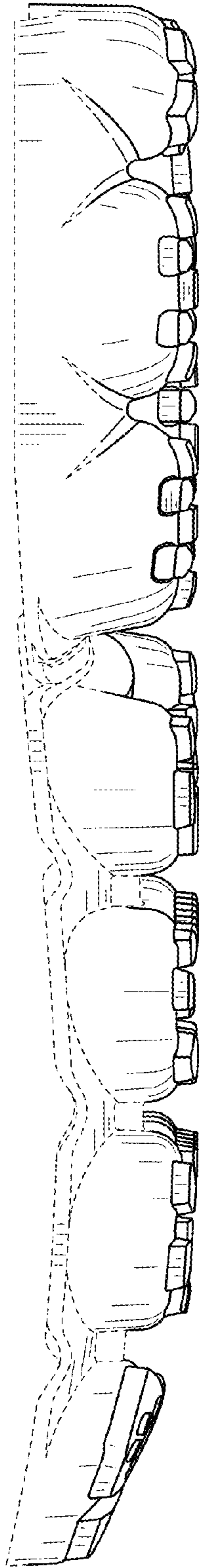

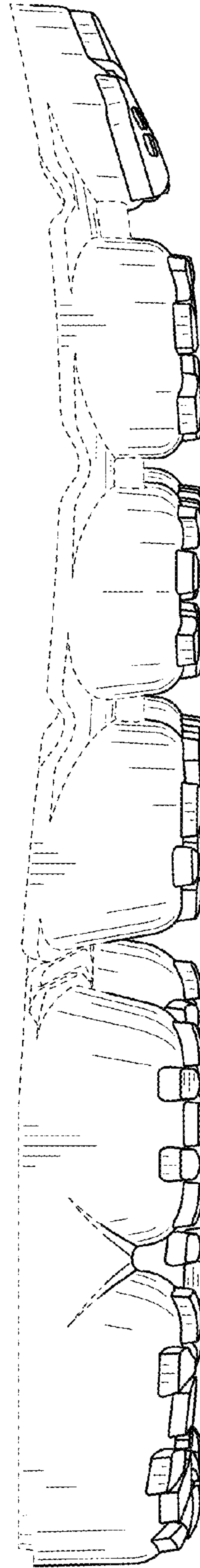

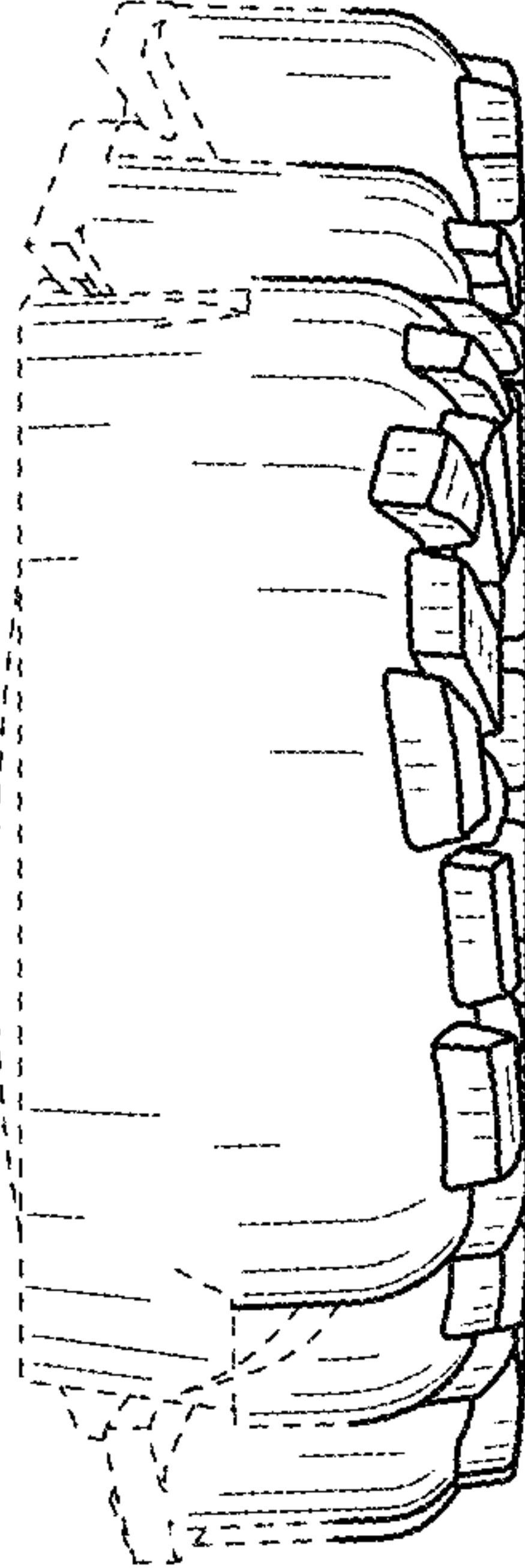

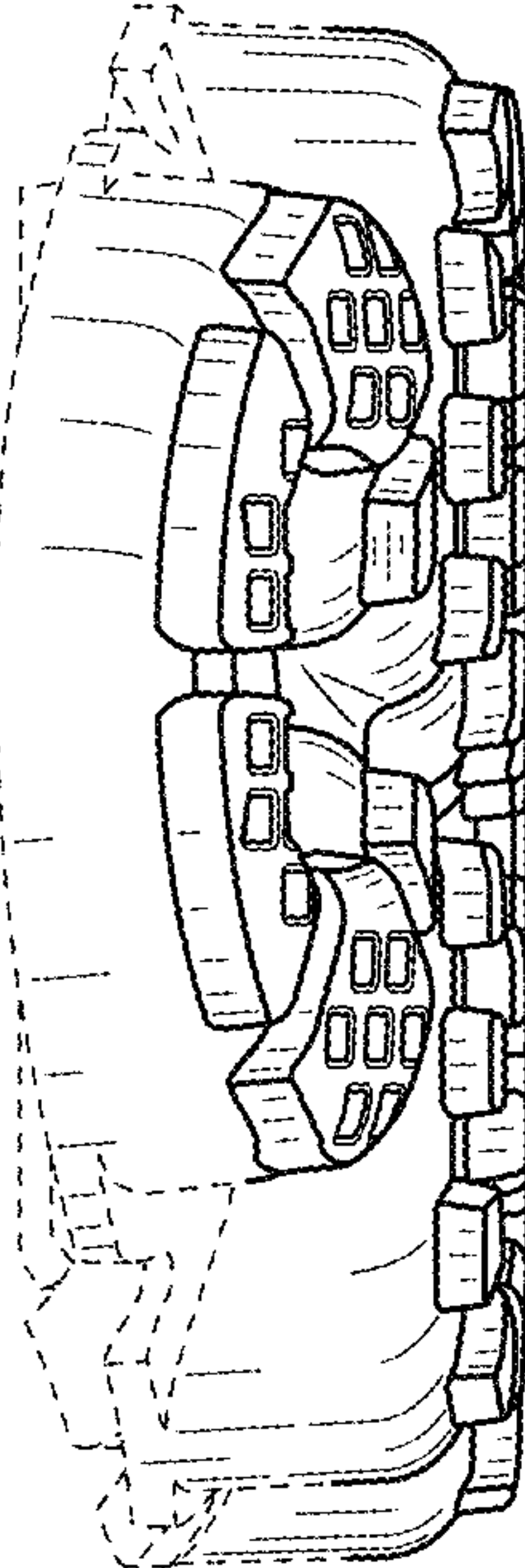

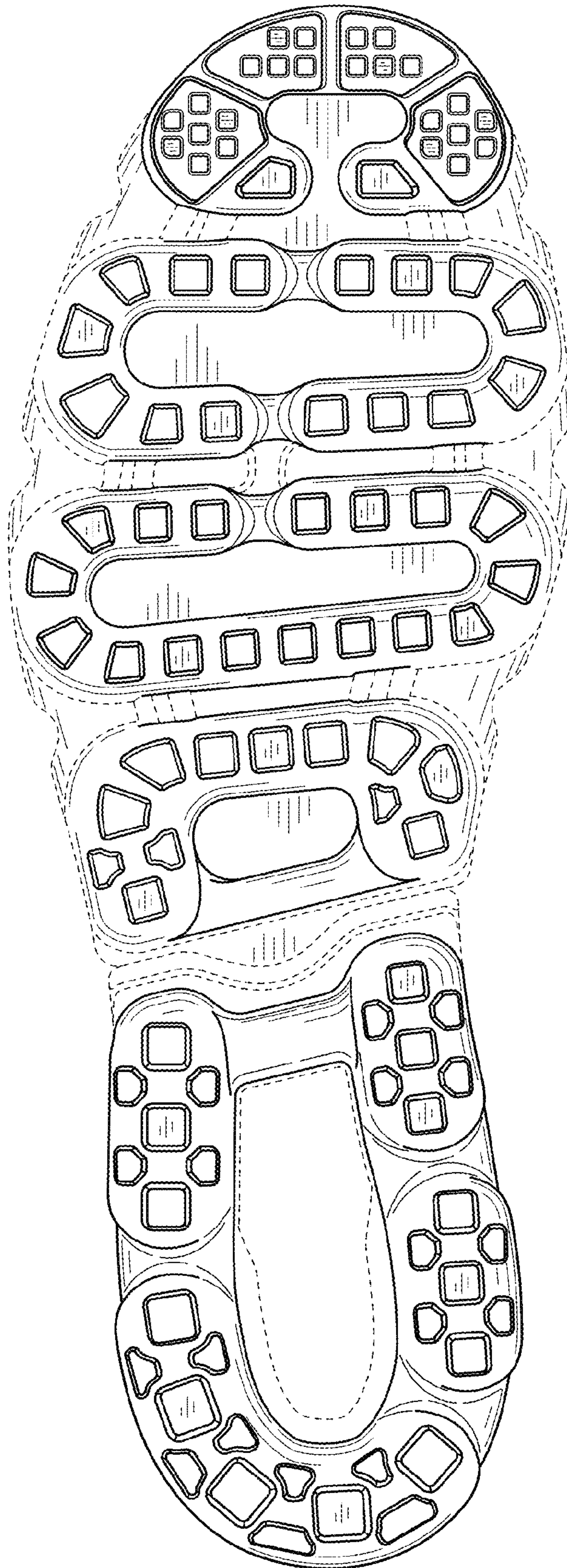
