The ornamental design for a head of a cleaning device, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a head of a cleaning device showing our new design;

FIG. 2 is a top plan view thereof;

FIG. 4 is a right side elevational view thereof;

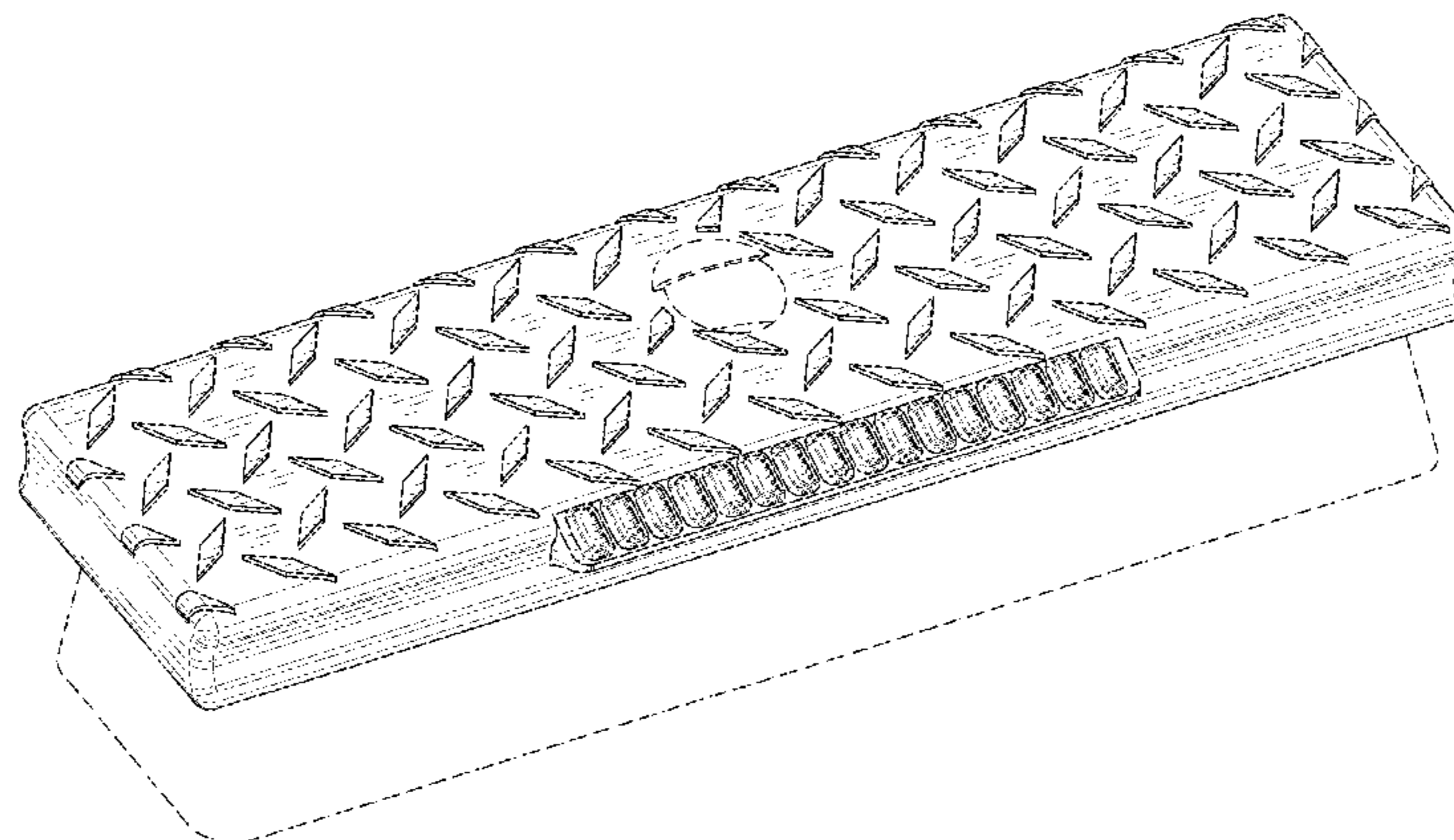
FIG. 5 is a left side elevational view thereof;

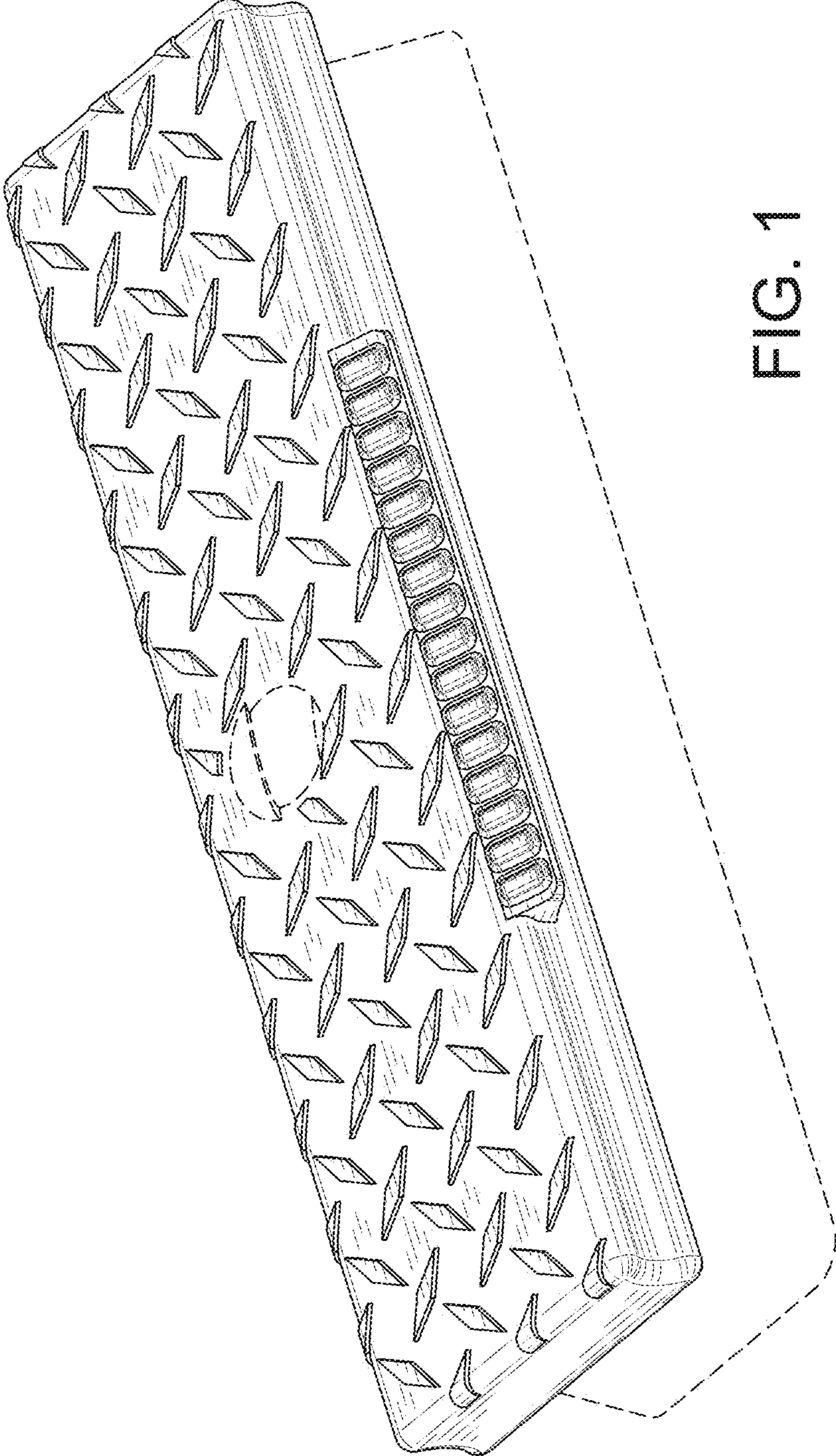

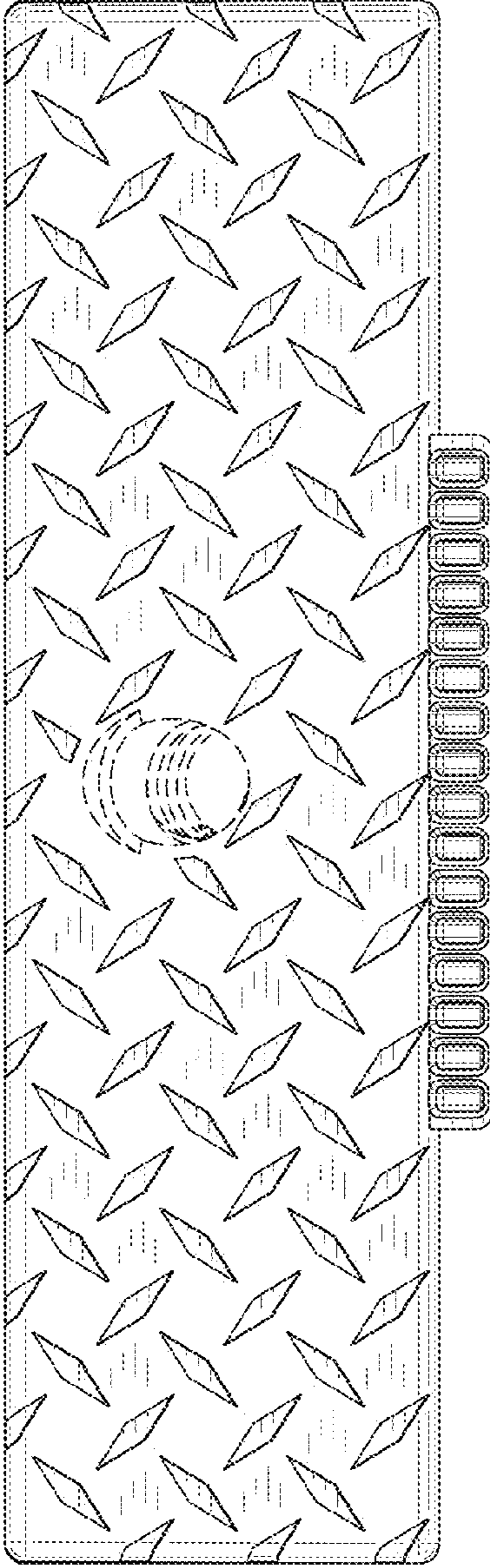

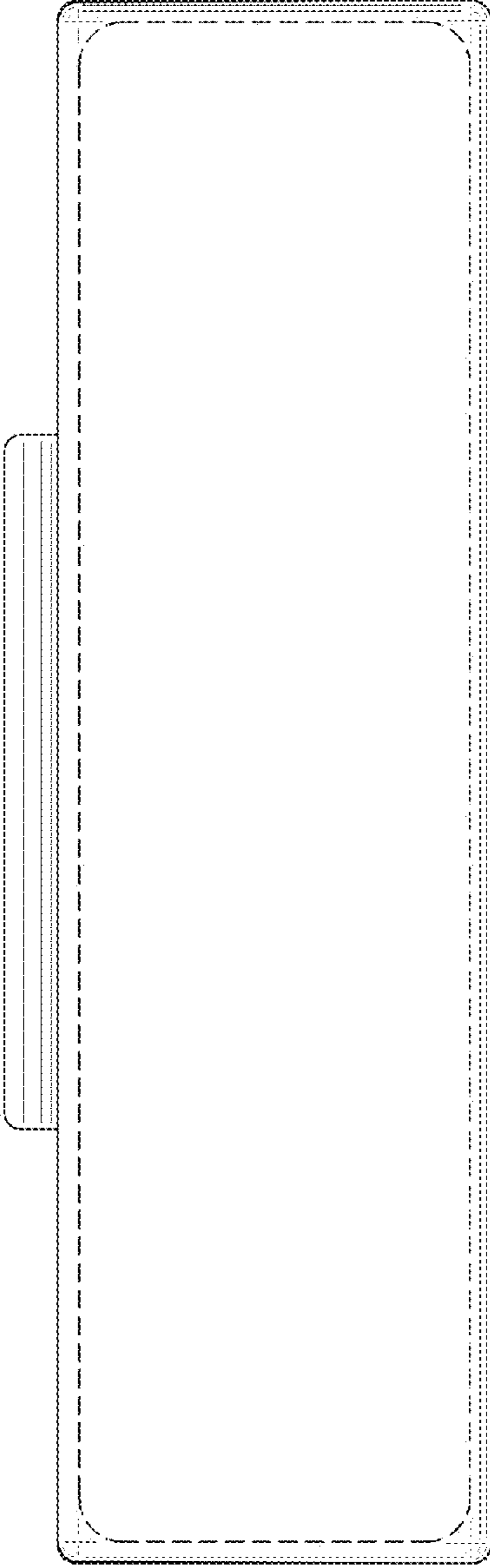

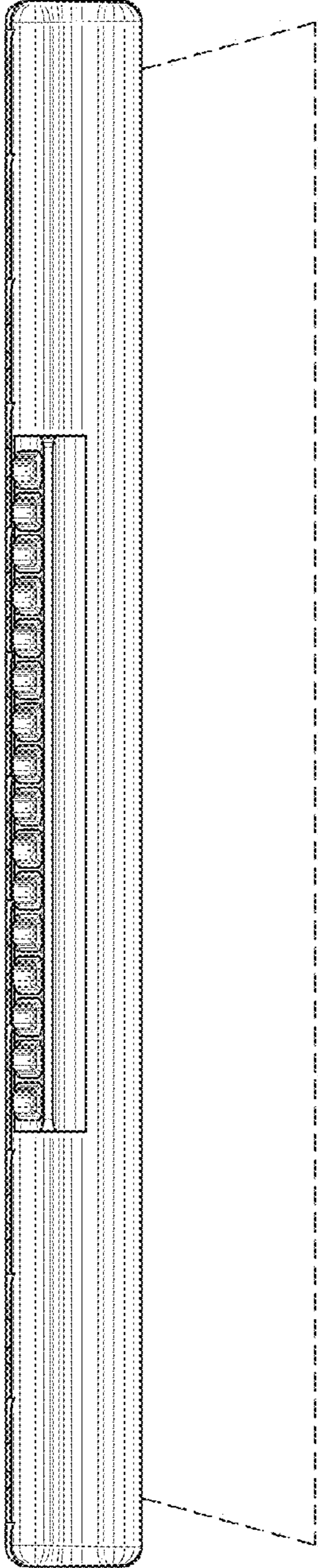

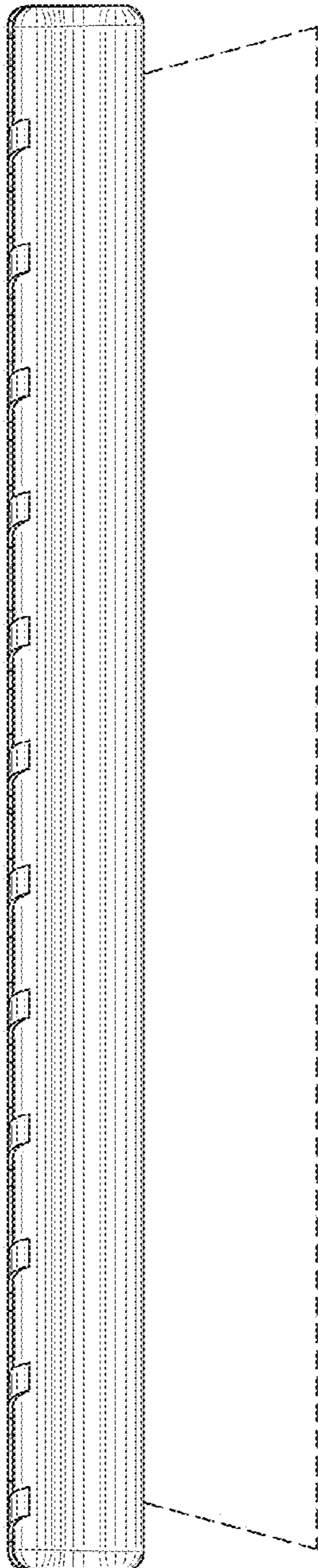

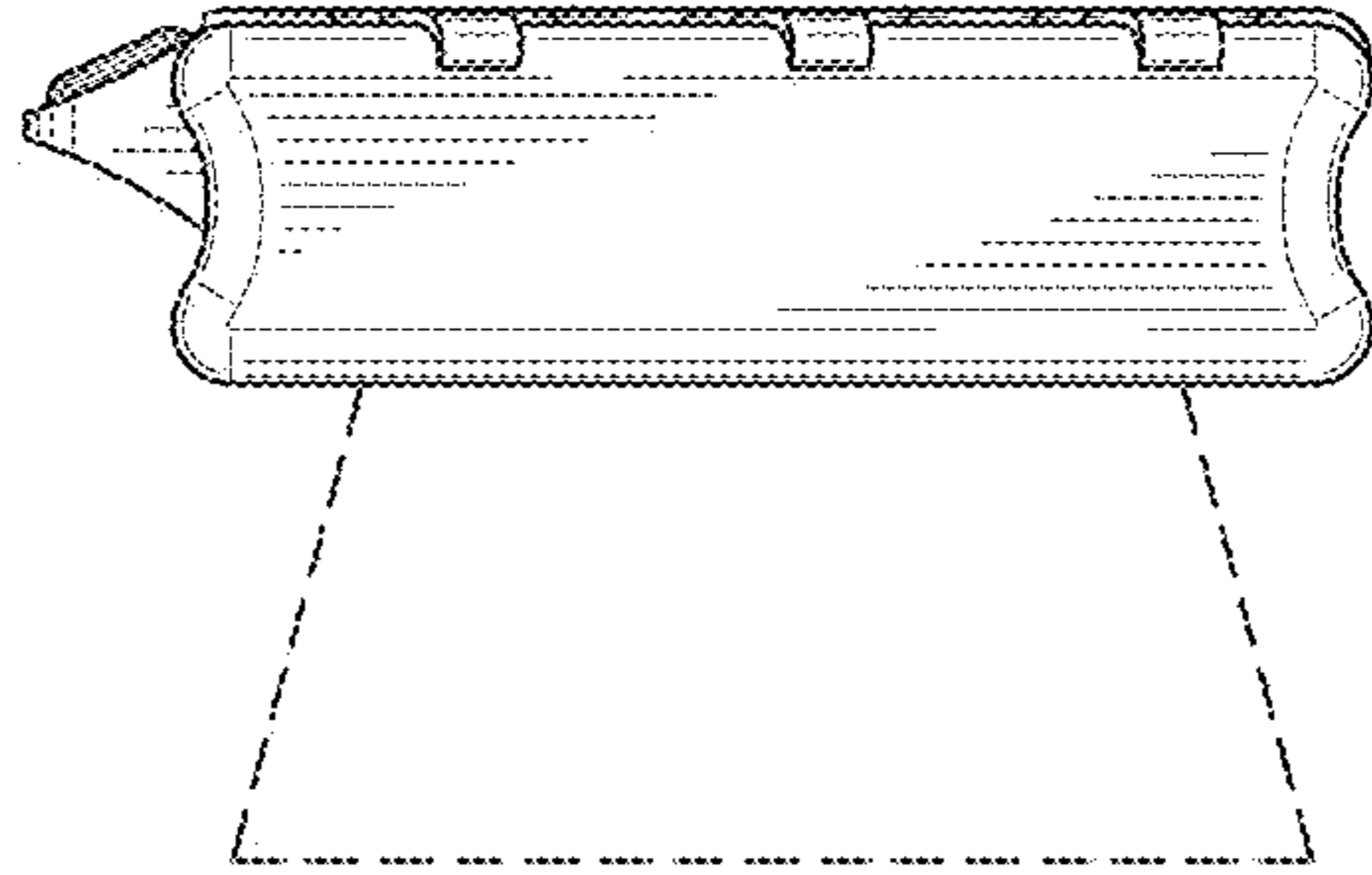

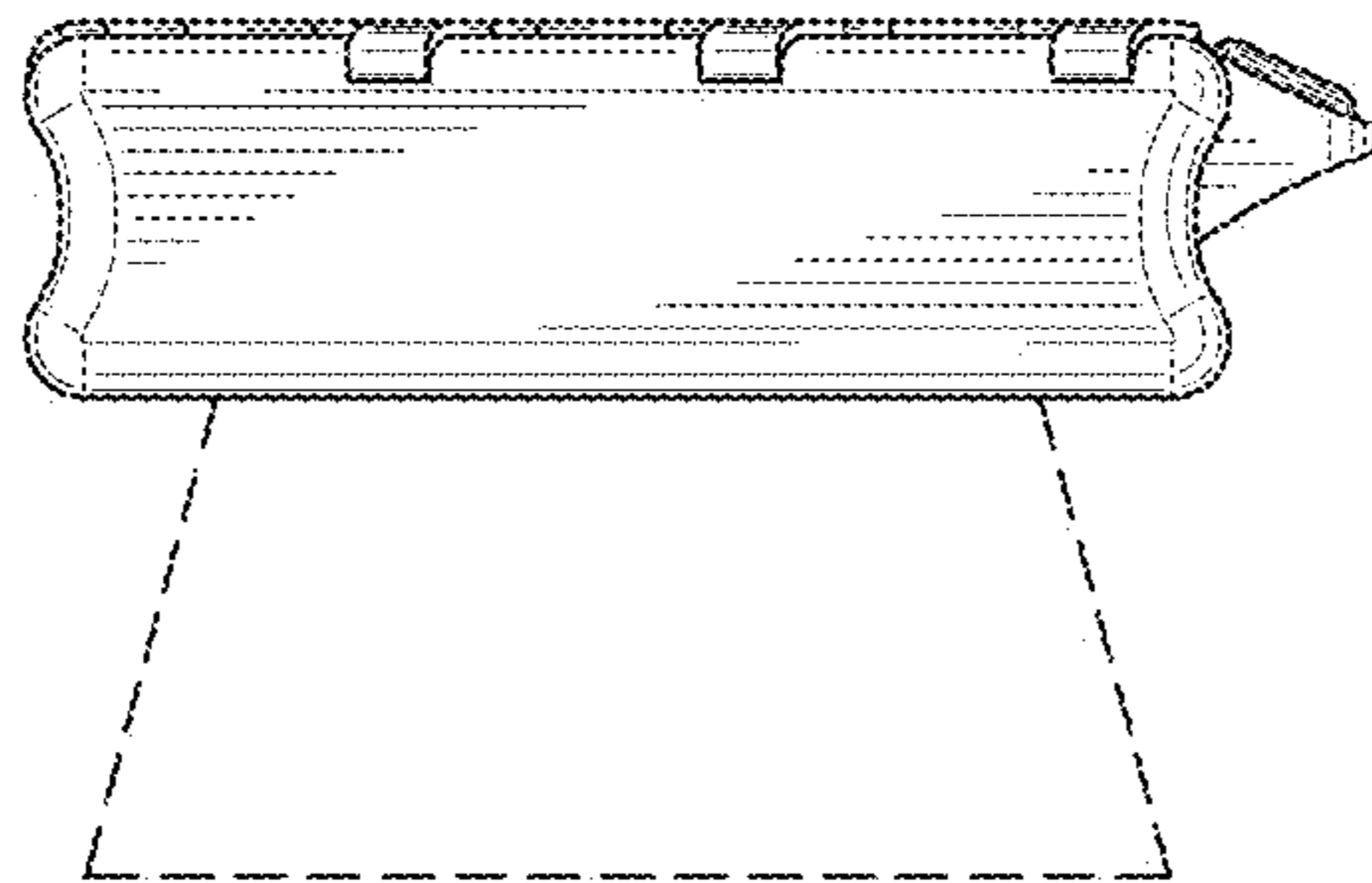
