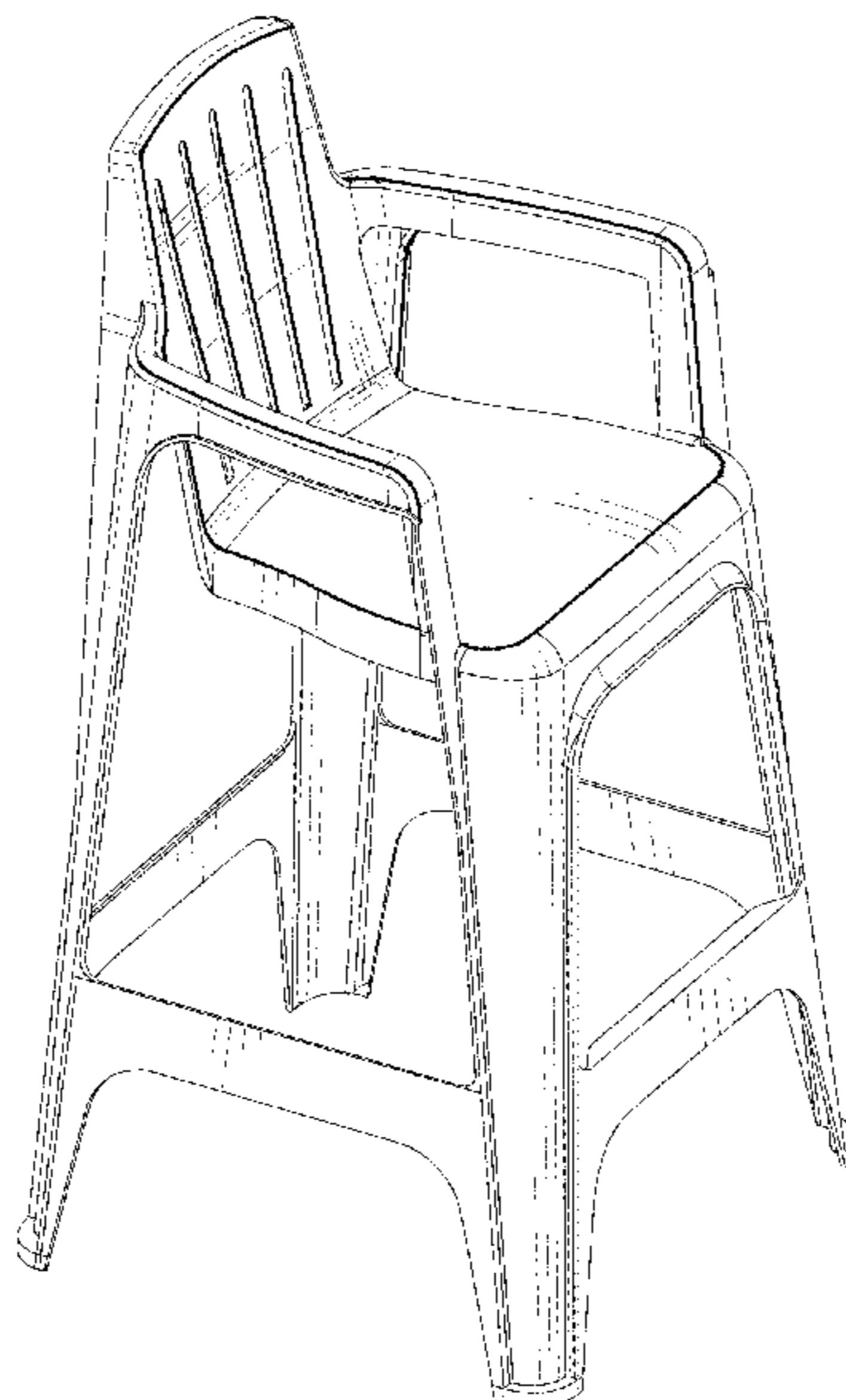

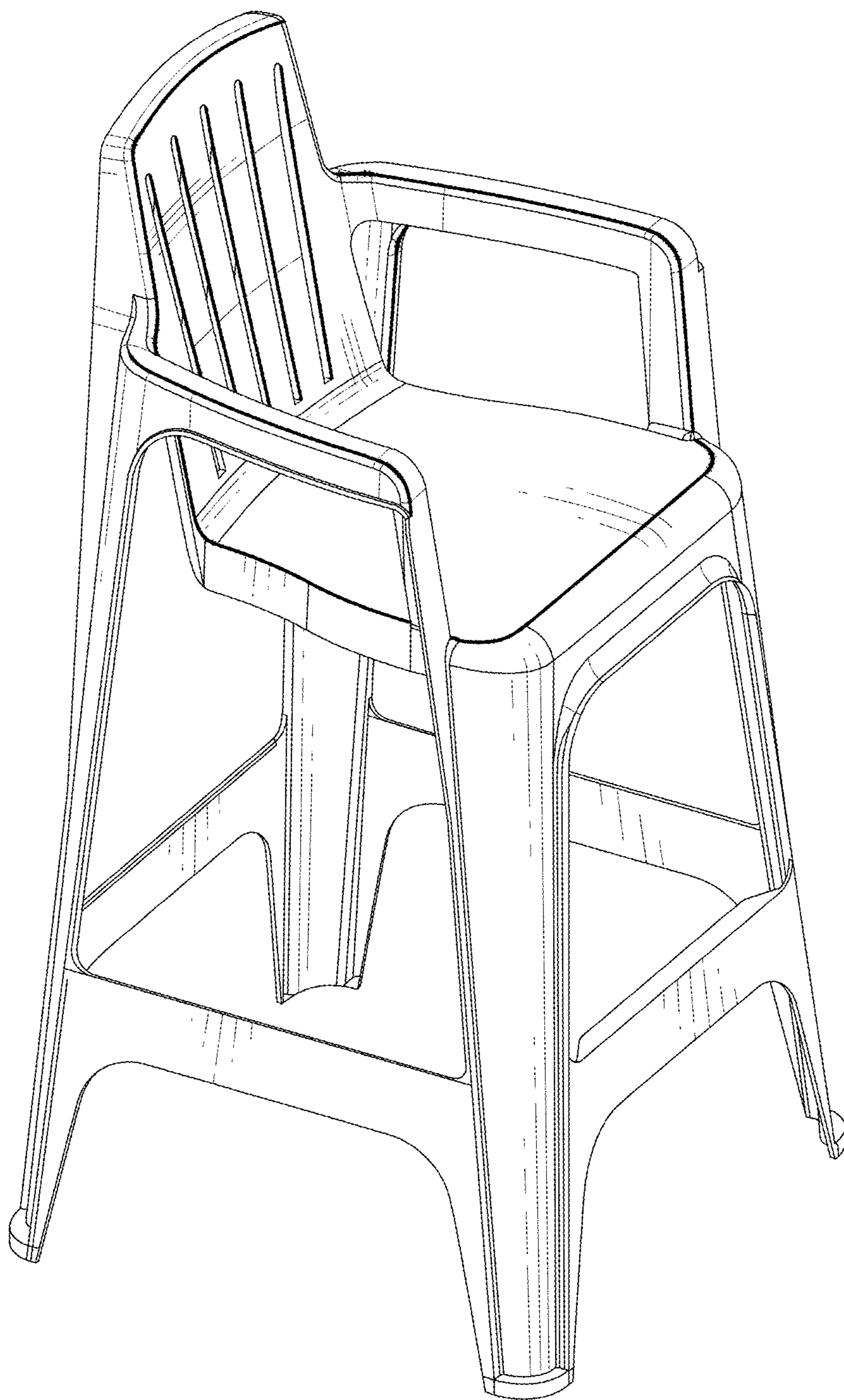
The ornamental design for a stackable bar stool having a back and arms, as shown and described.

**DESCRIPTION**

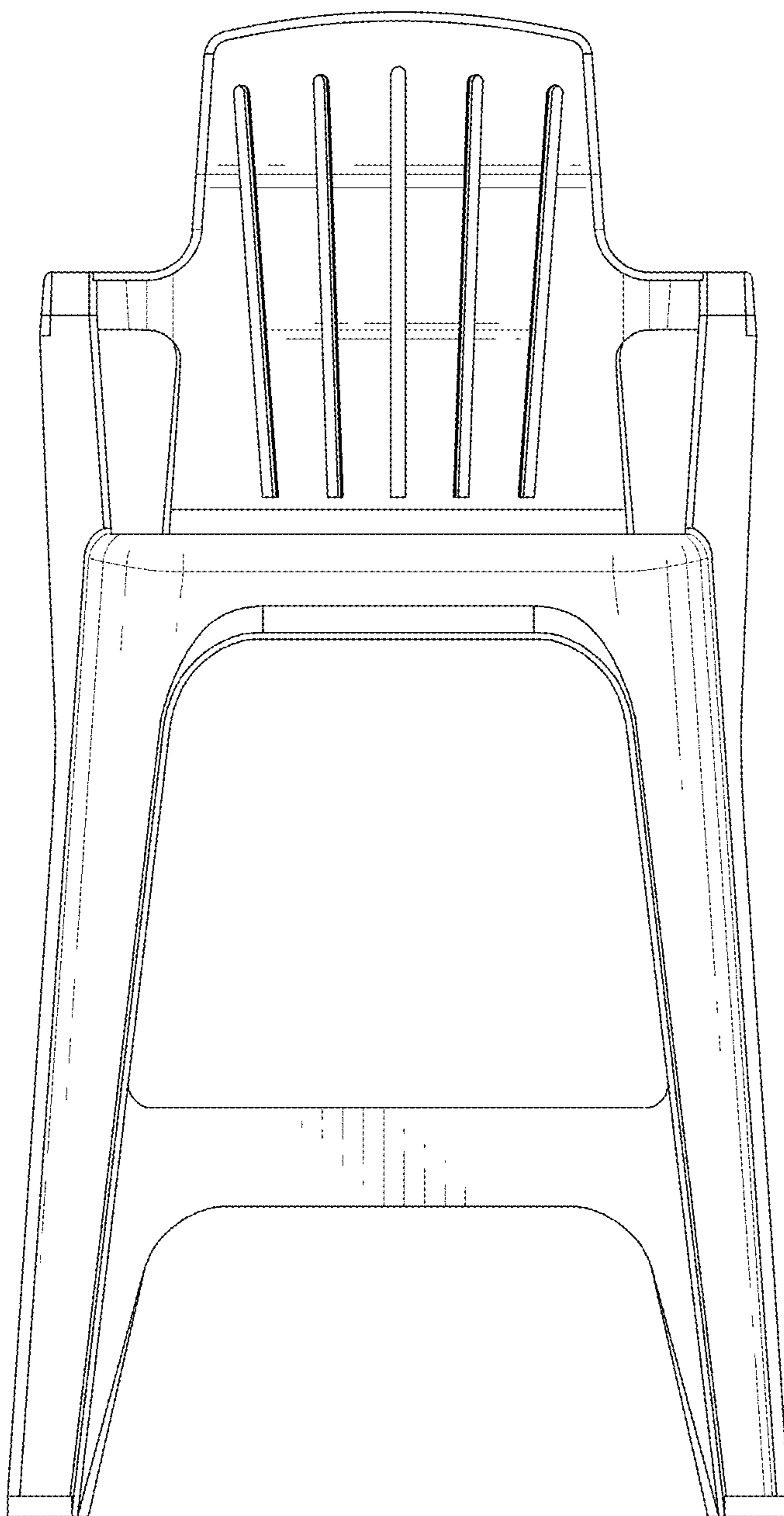
FIG. 1 is a right front perspective view of my stackable bar stool having a back and arms;

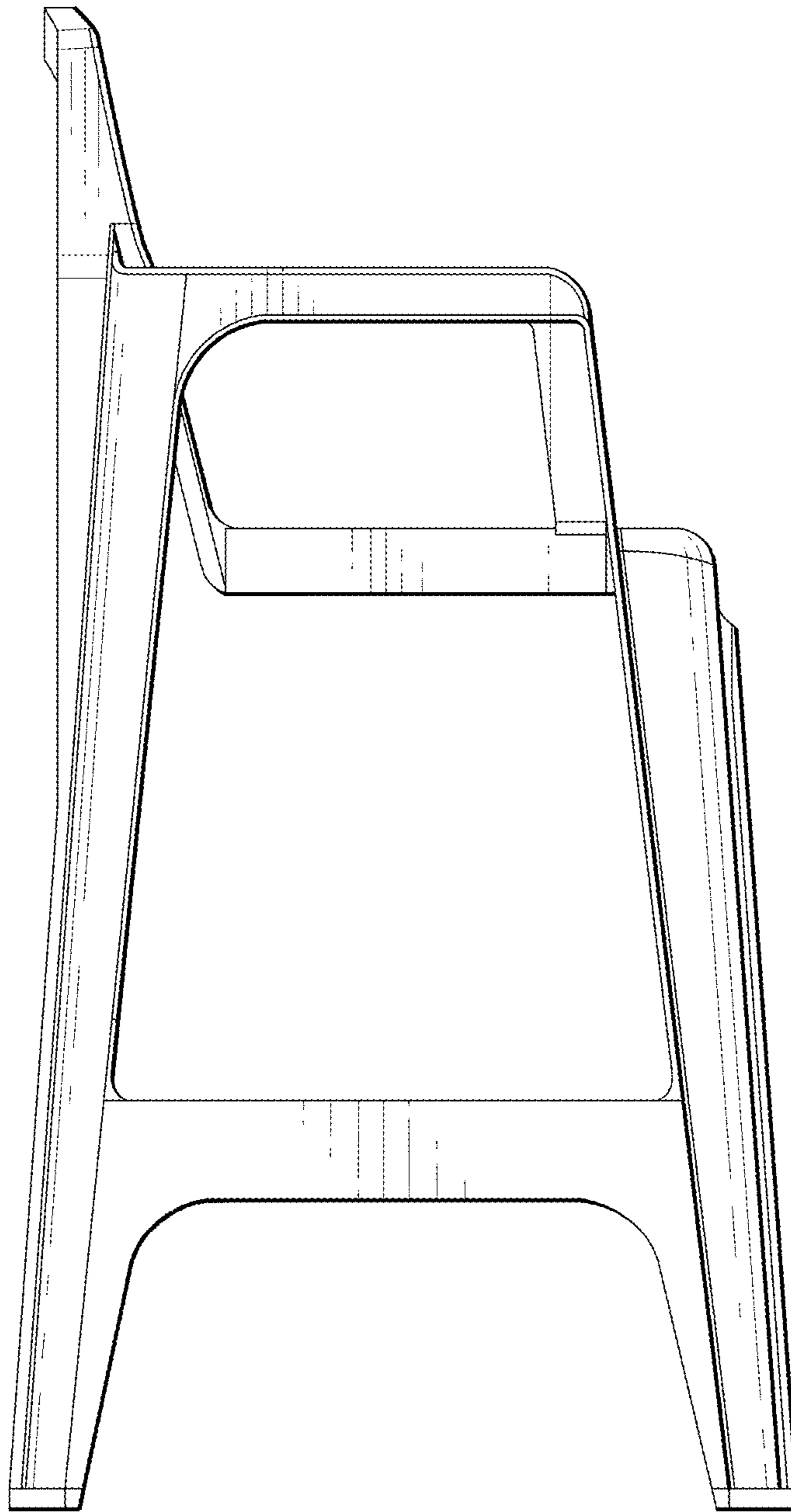




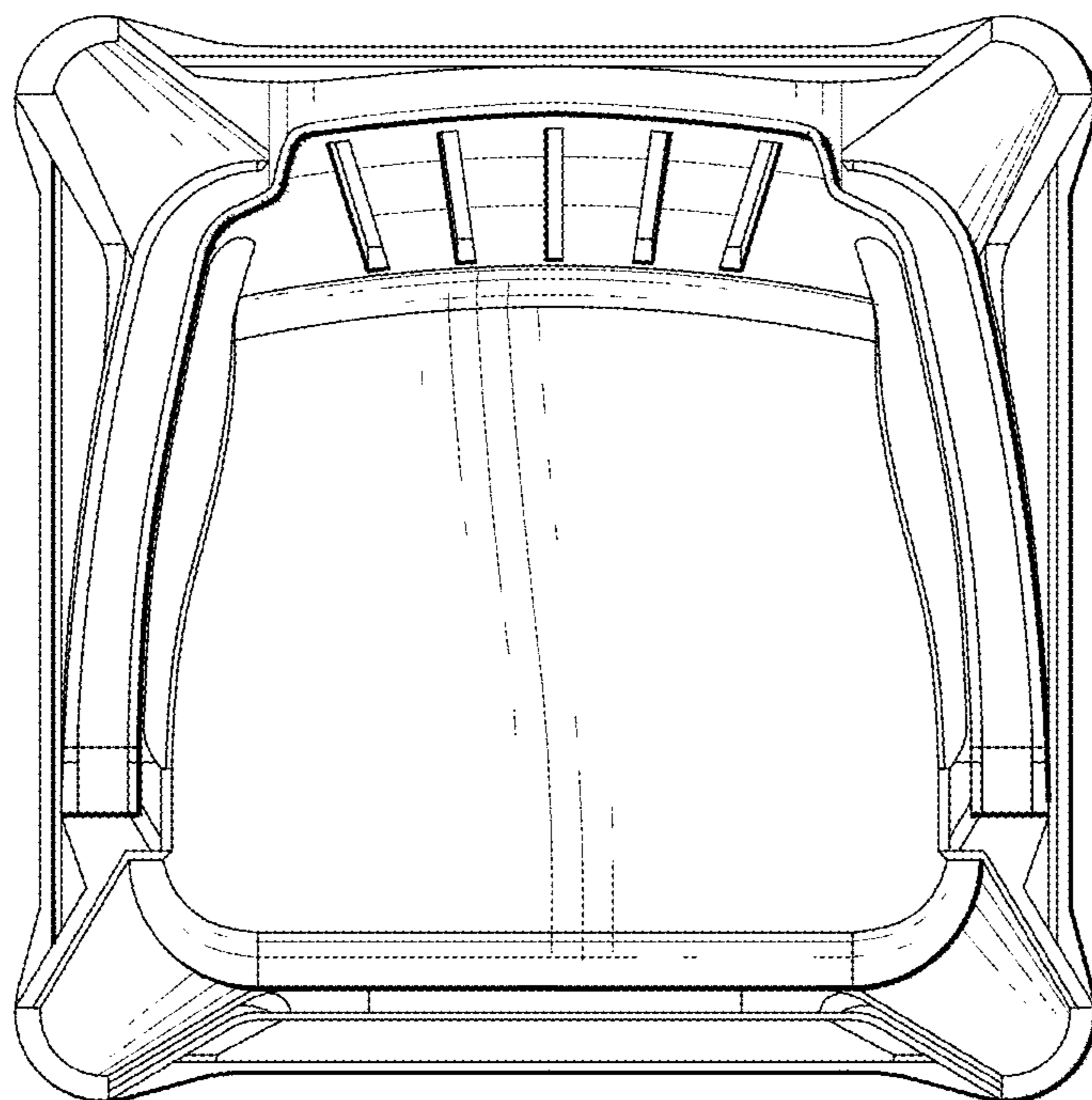

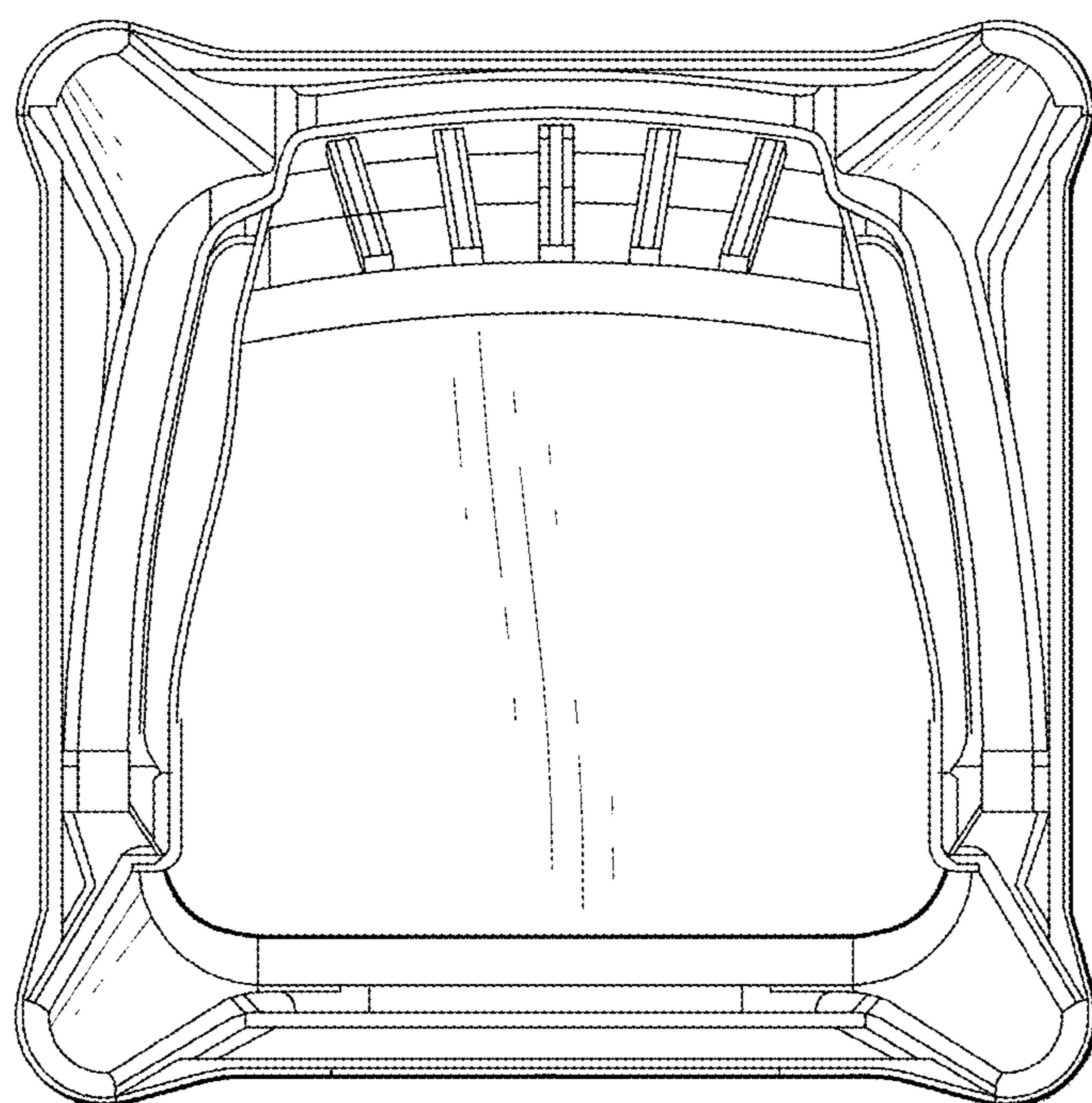

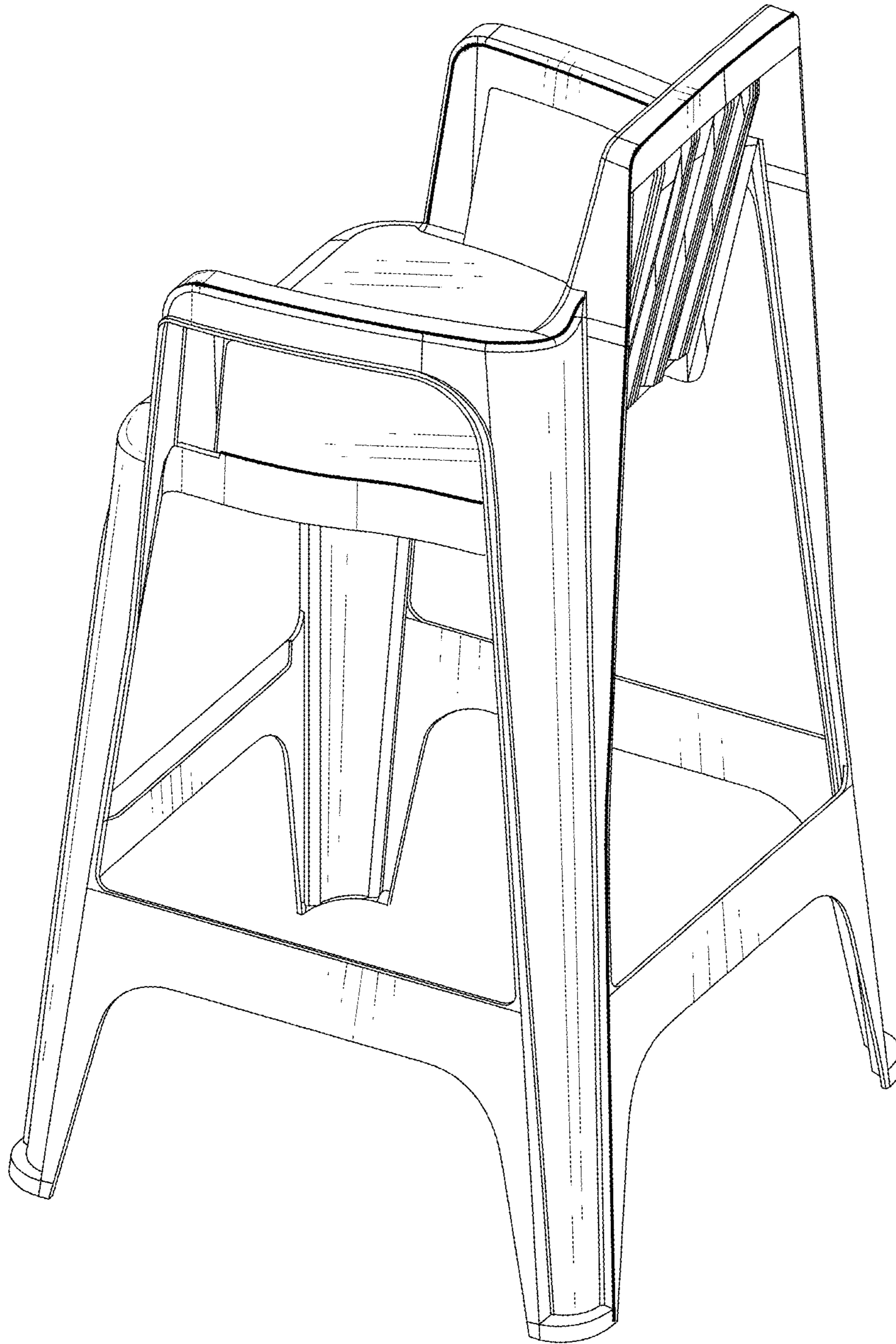
