**DESCRIPTION**

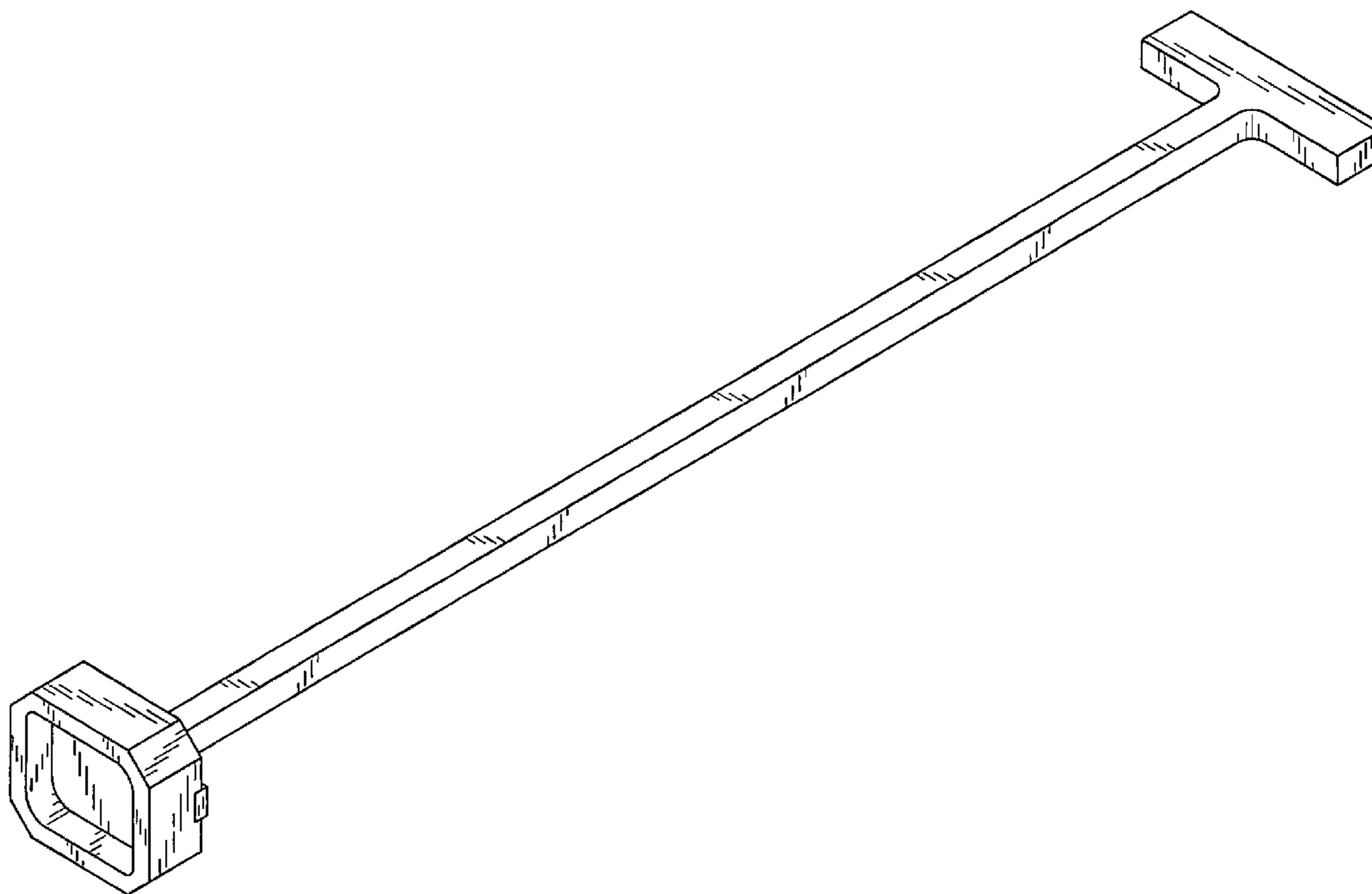
FIG. 1 is a perspective view of a faucet handle reach tool showing my new design;

 FIG. 6 is a second right side elevation view thereof, wherein the broken line showing of the faucet handle is provided for purposes of environment and forms no part of the claimed design; and,  
 FIG. 7 is a third right side elevation view thereof, wherein the broken line showing of the faucet handle is provided for purposes of environment and forms no part of the claimed design.

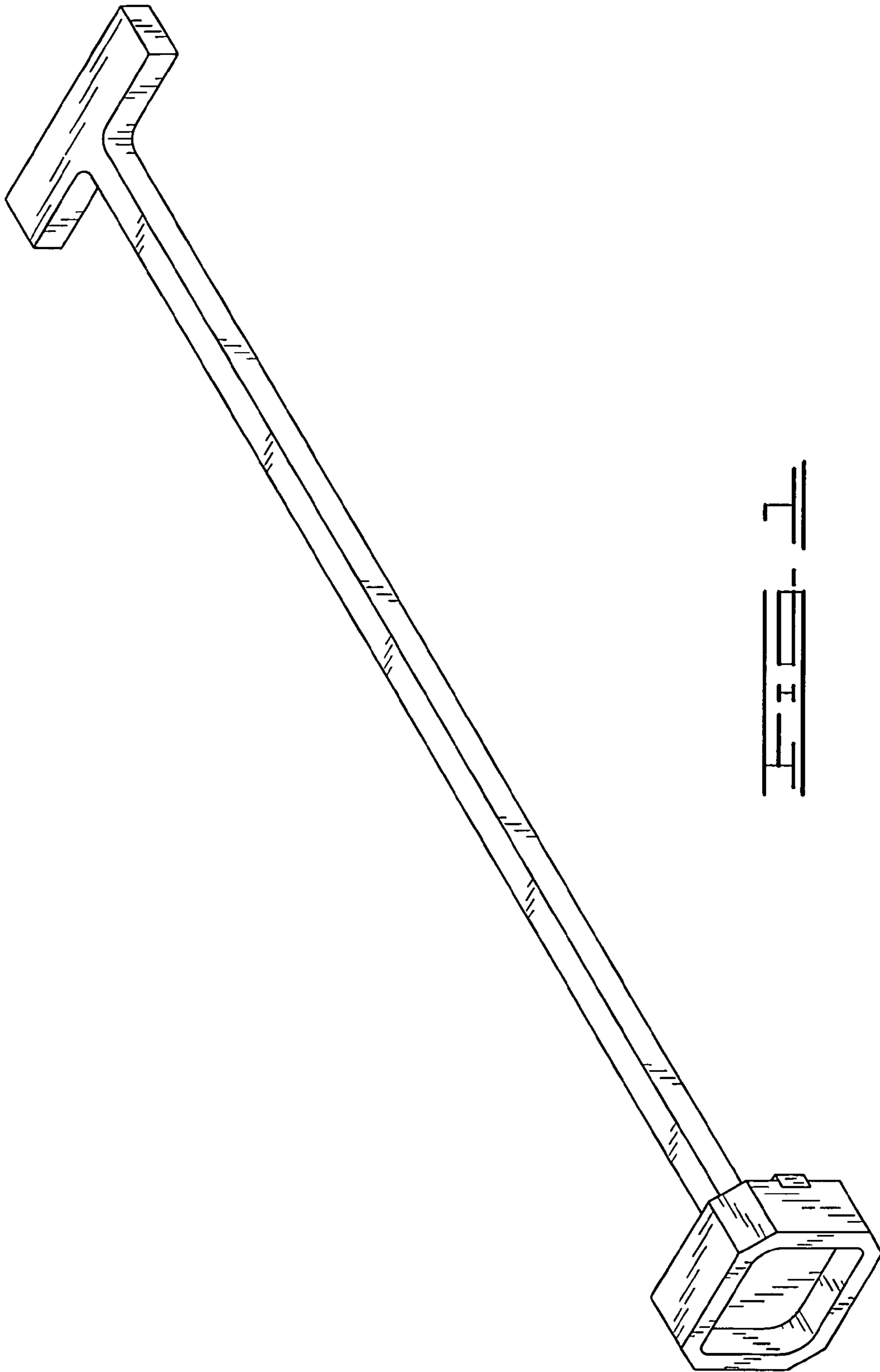

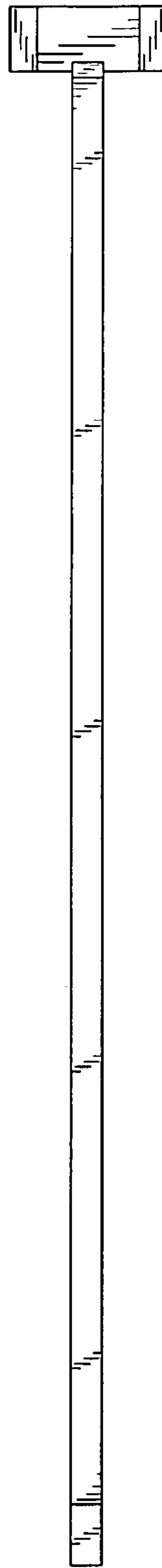
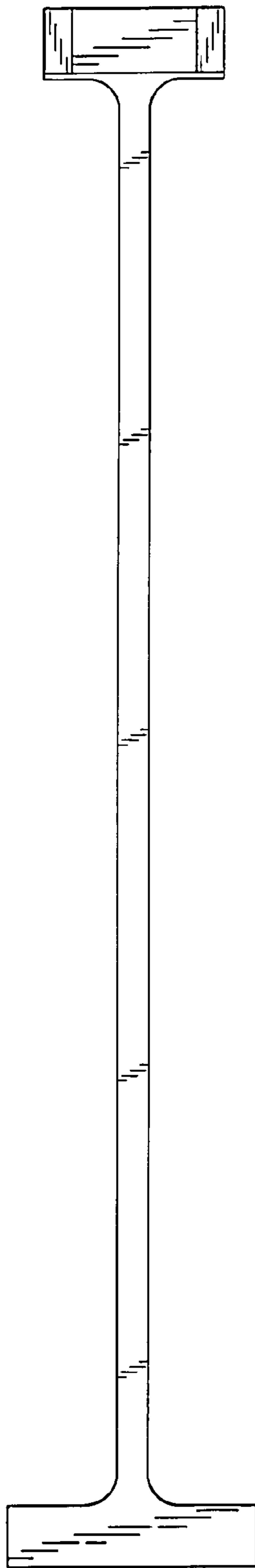

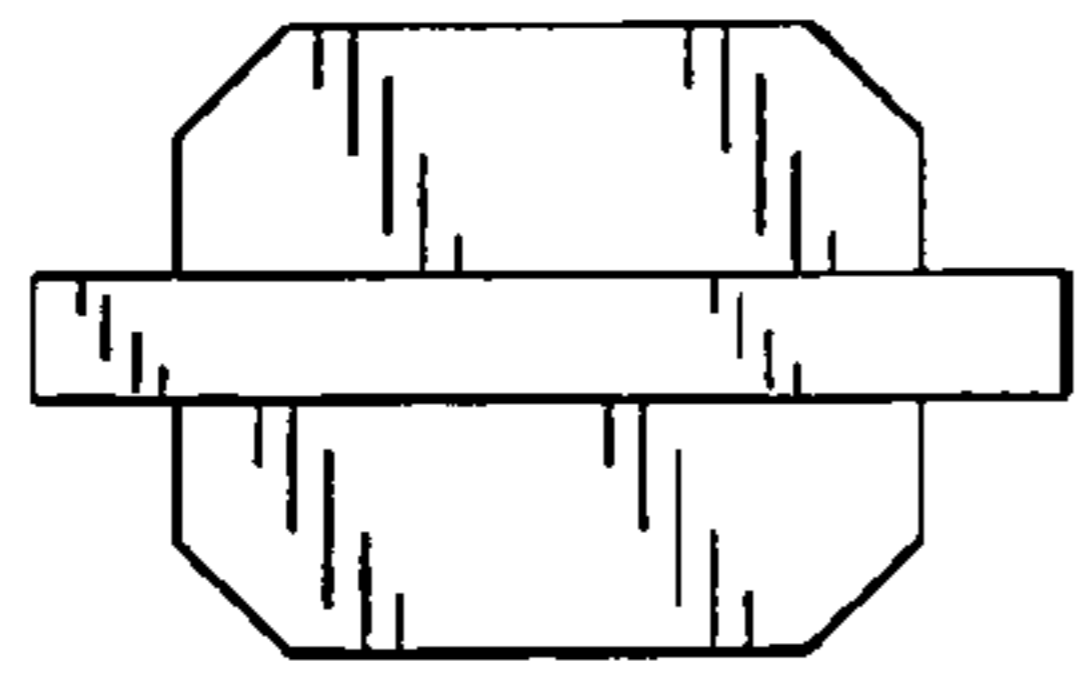

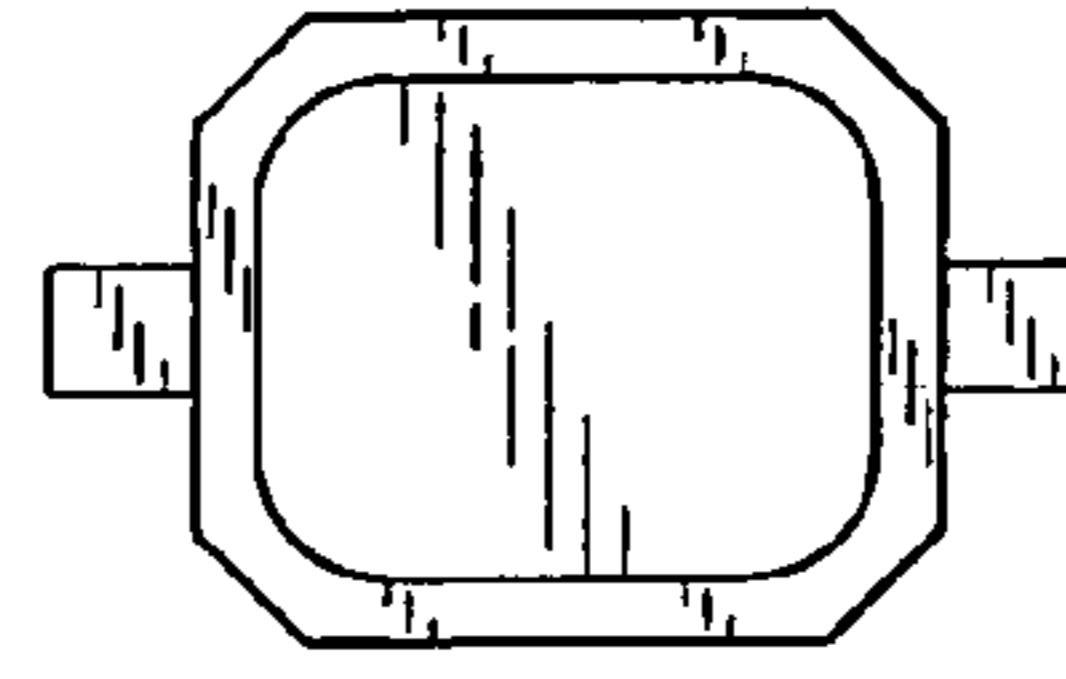

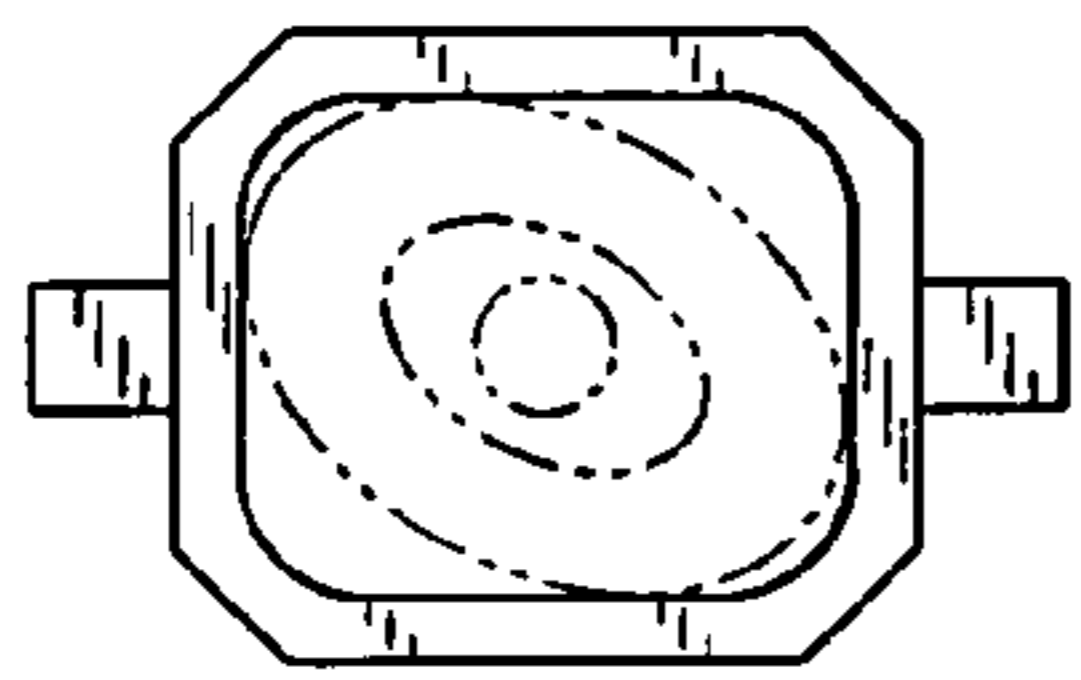

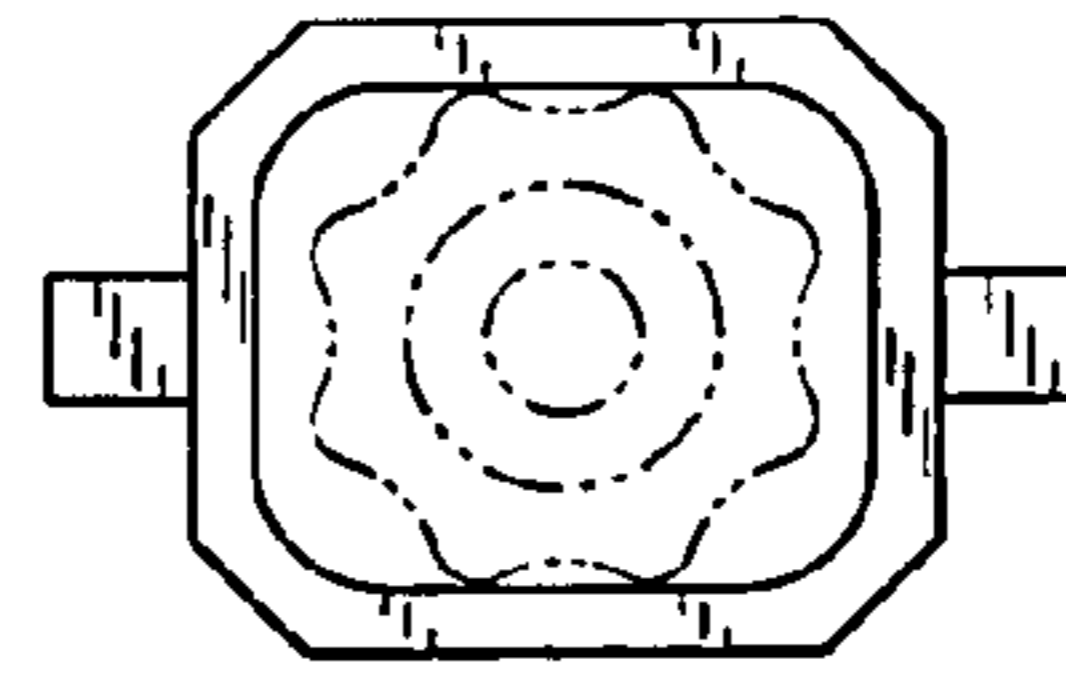
