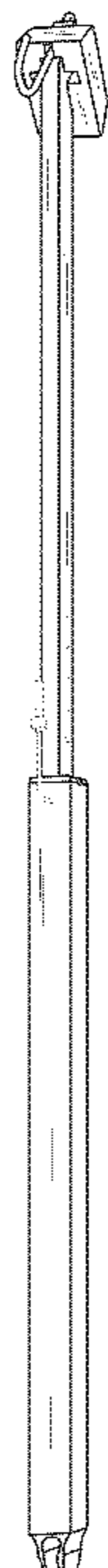
The ornamental design for a hanging system, as shown and described.

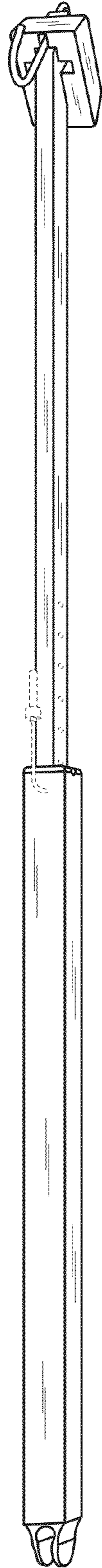
**DESCRIPTION**

FIG. 1 is a front perspective view of a hanging system in an expanded configuration showing my new design;

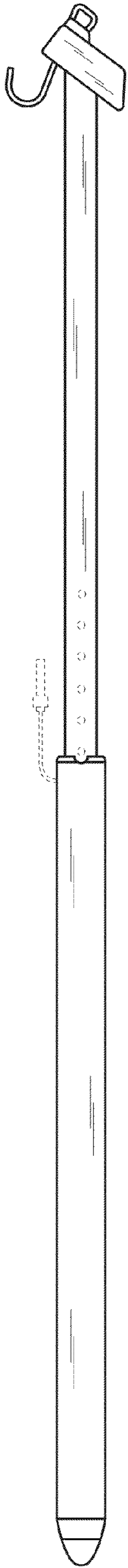

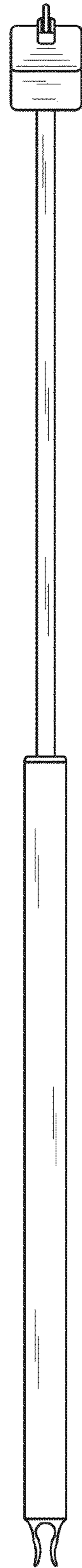

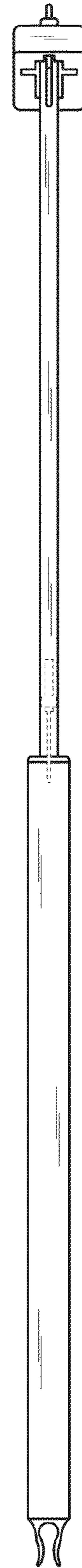
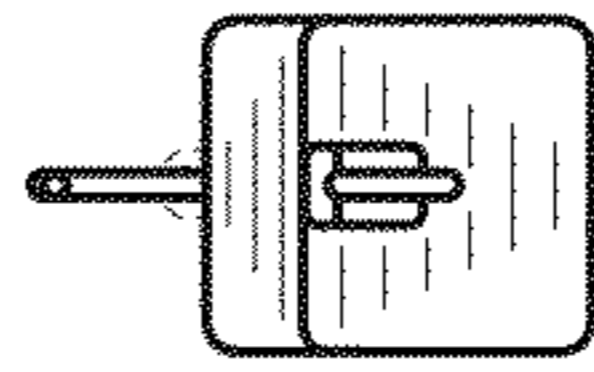
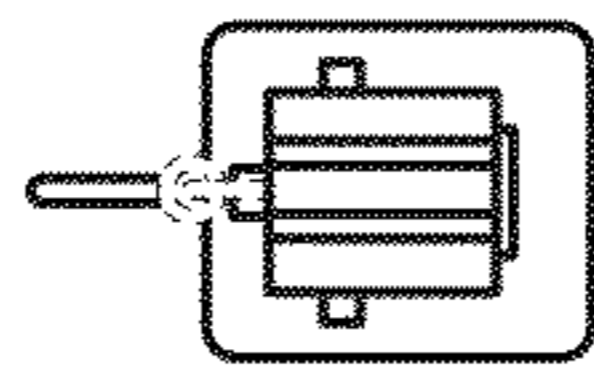


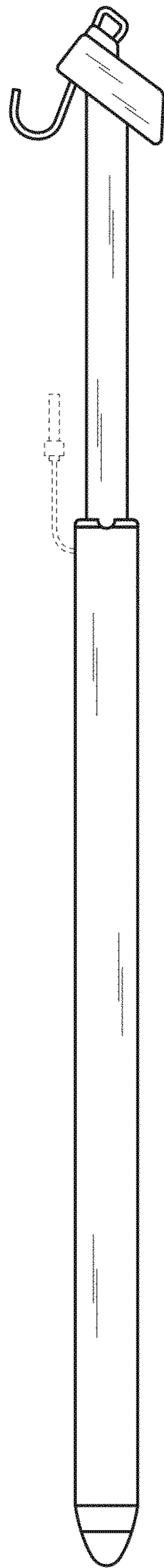
