**DESCRIPTION**

FIG. 1 is a front and left side perspective view of a latch showing our new design;

FIG. 2 is an enlarged front and left side perspective view thereof;

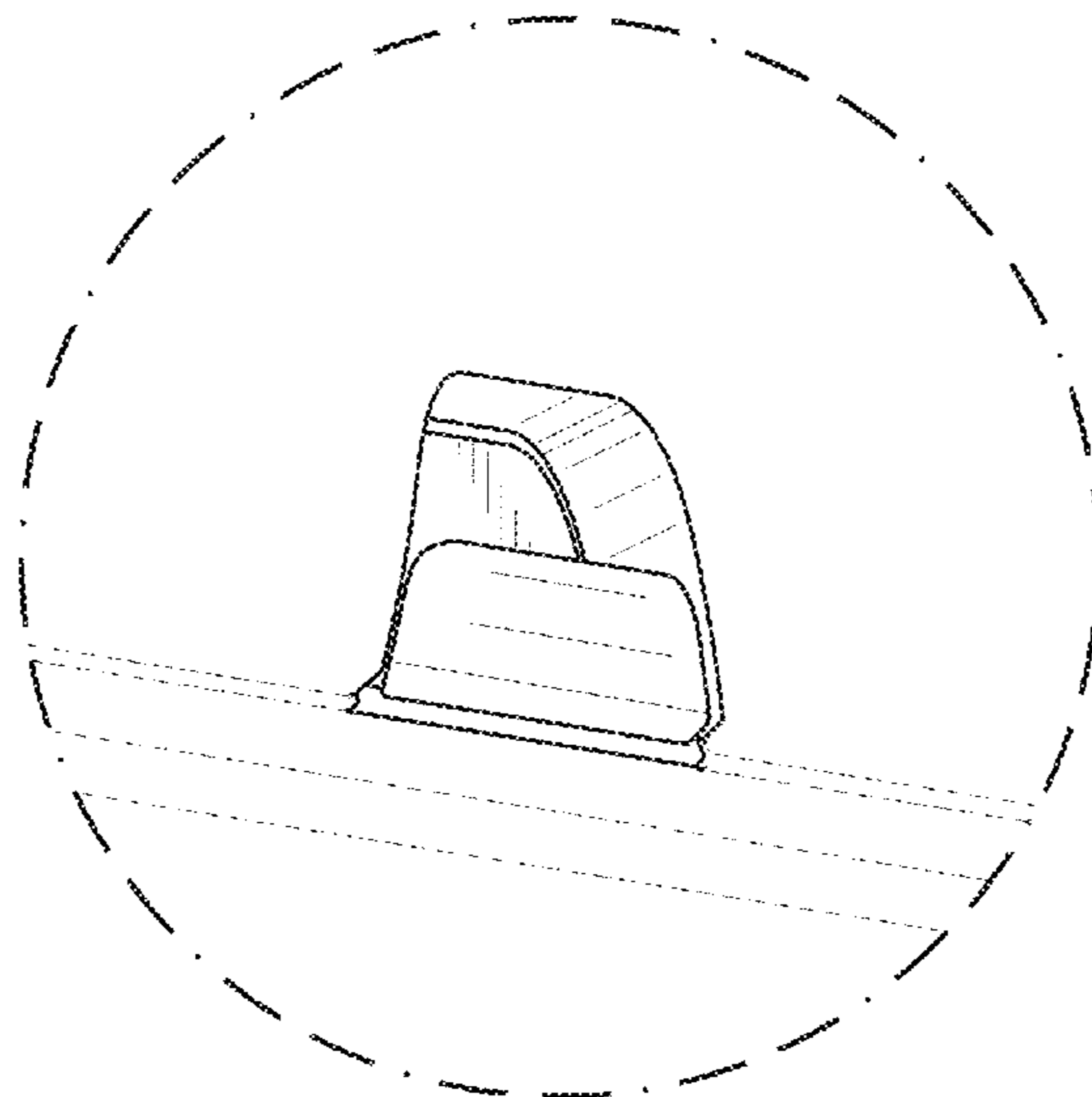
FIG. 3 is an enlarged front and right side perspective view thereof;

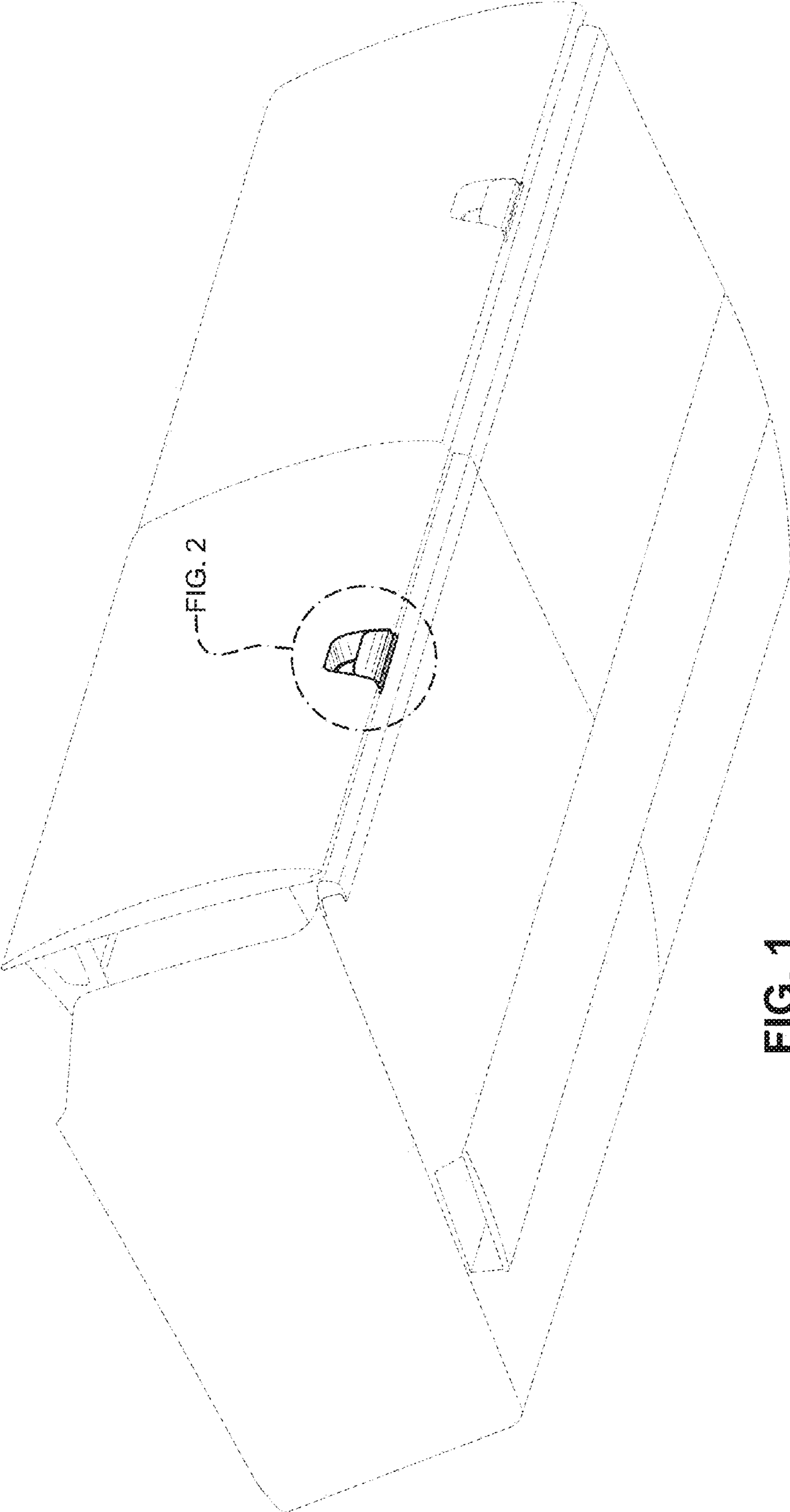

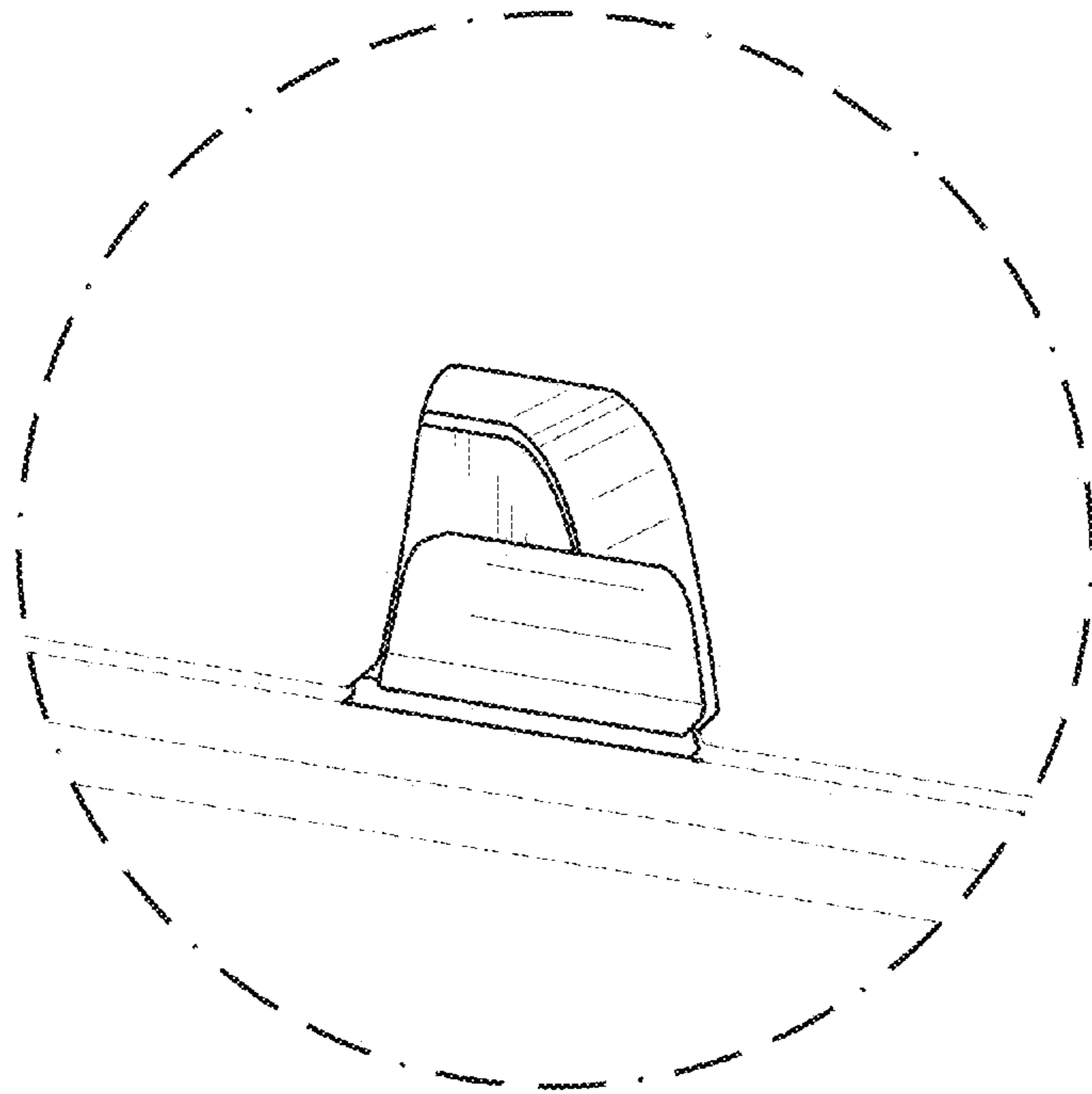

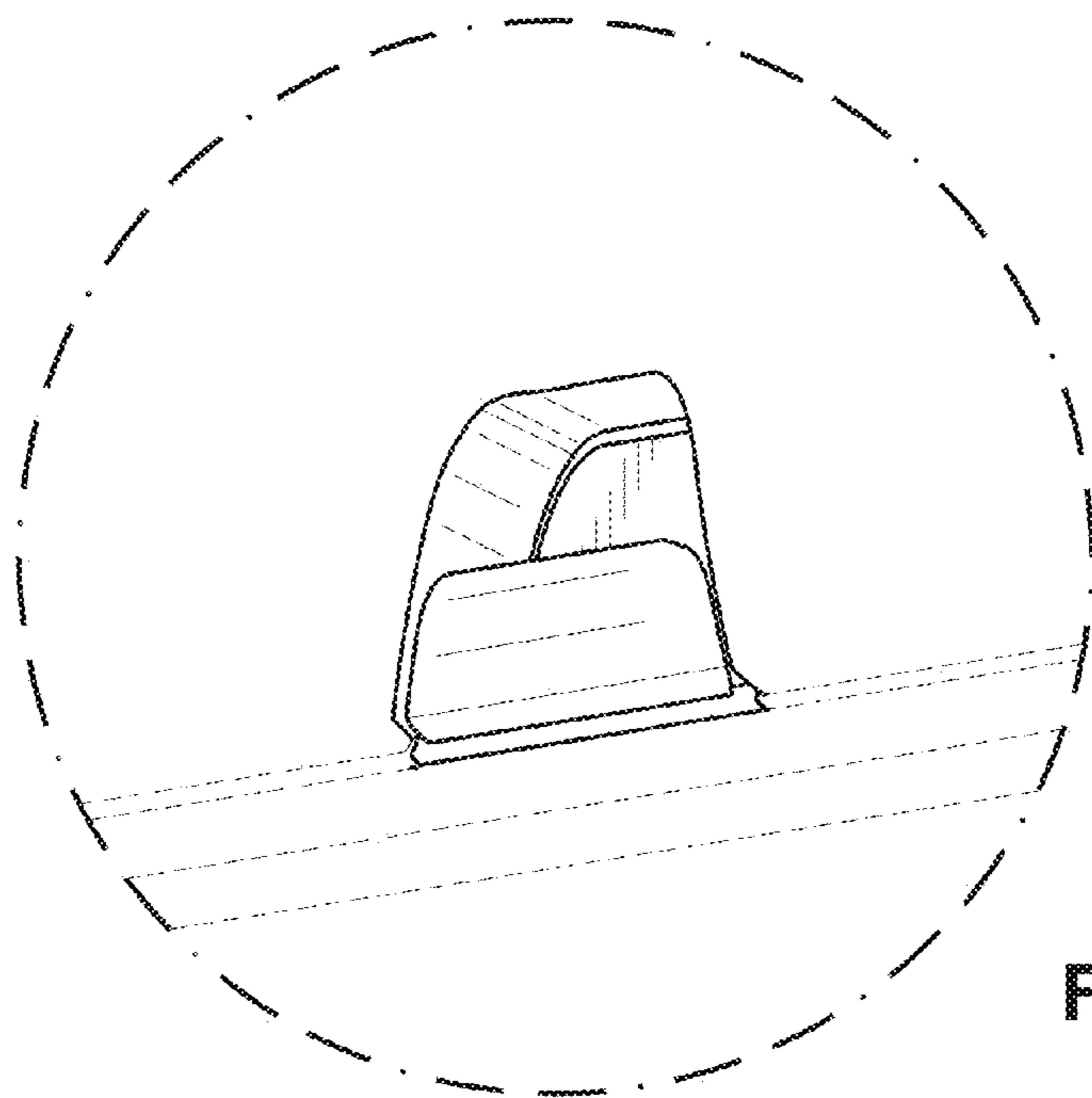

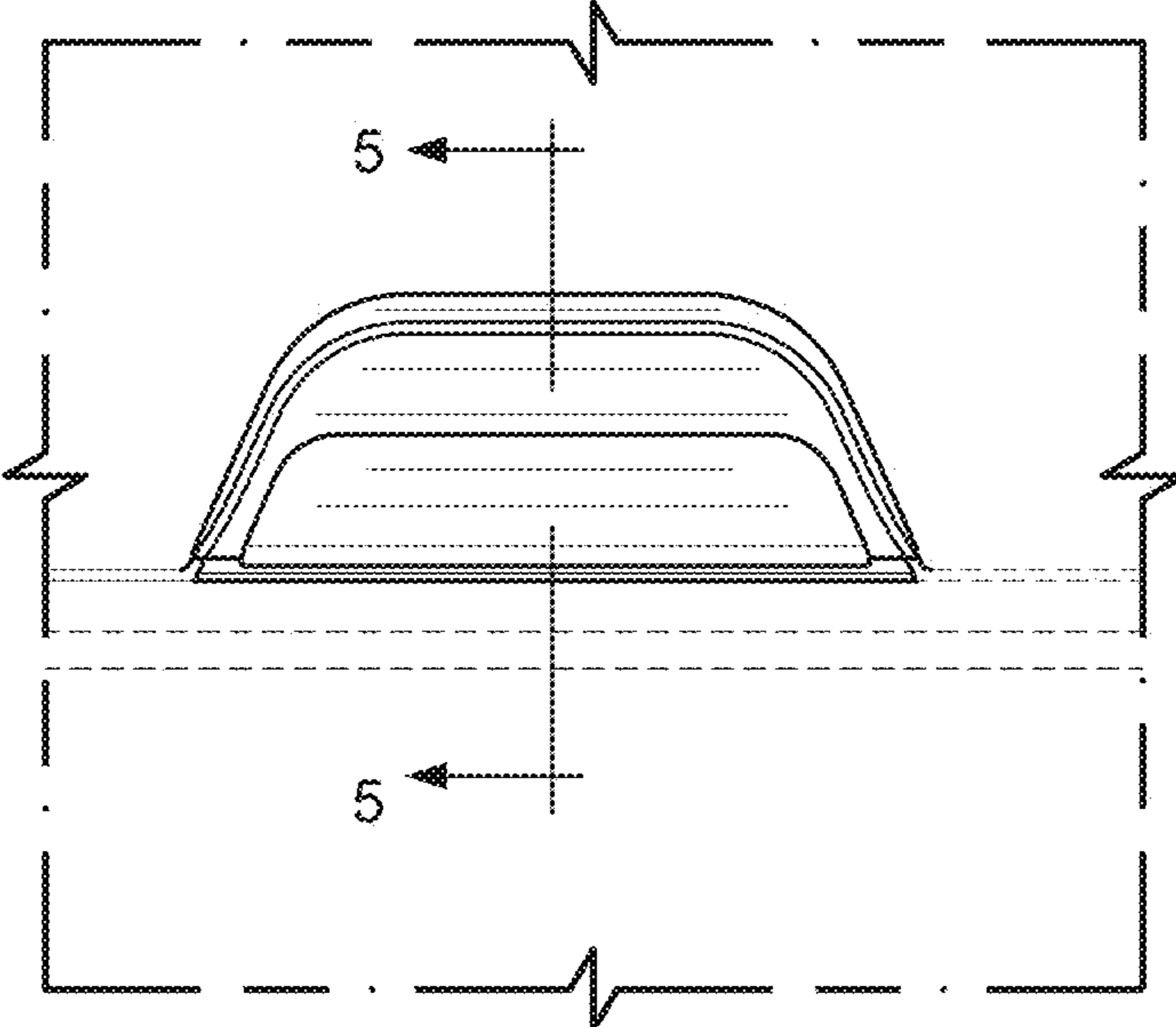

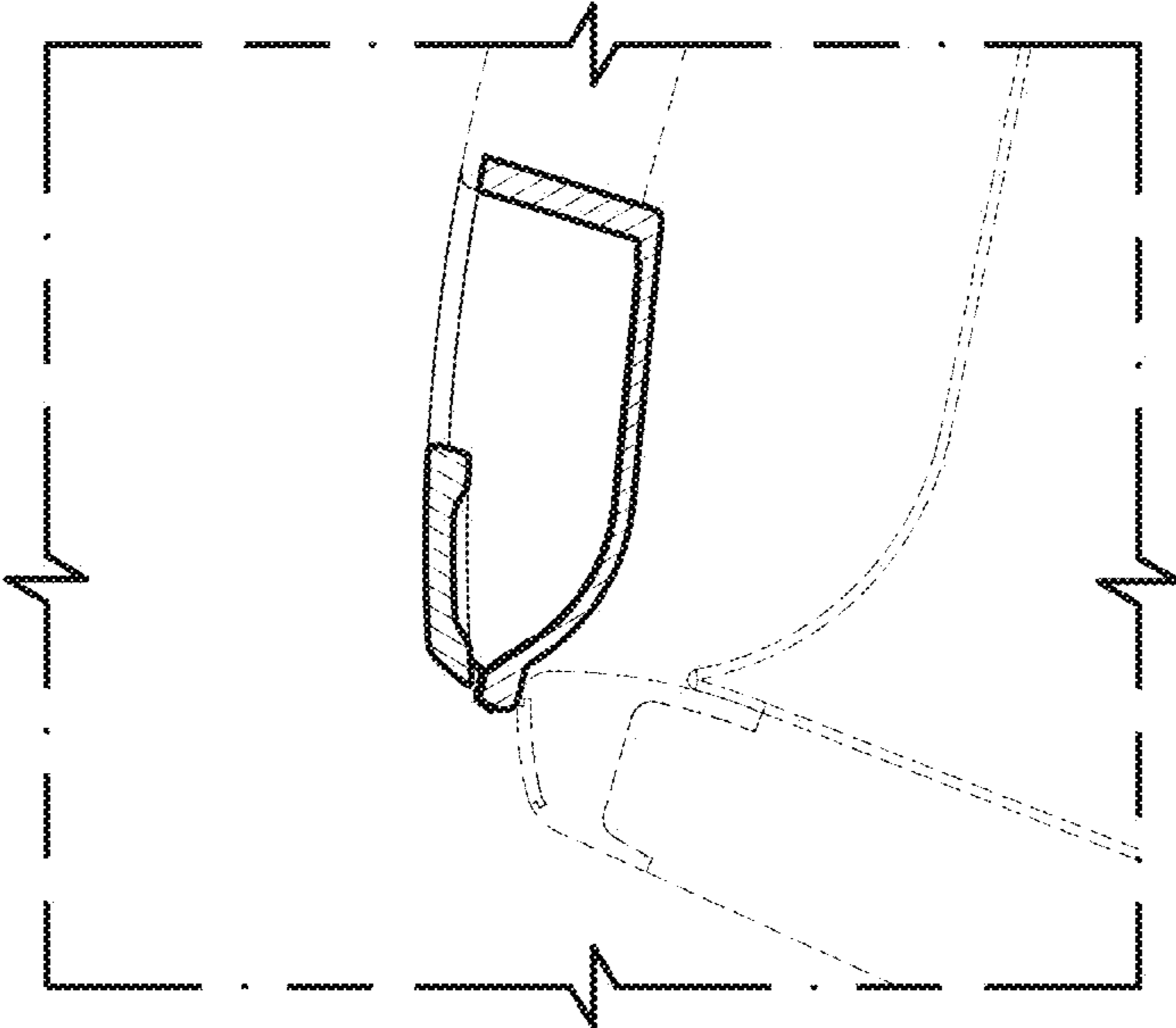
