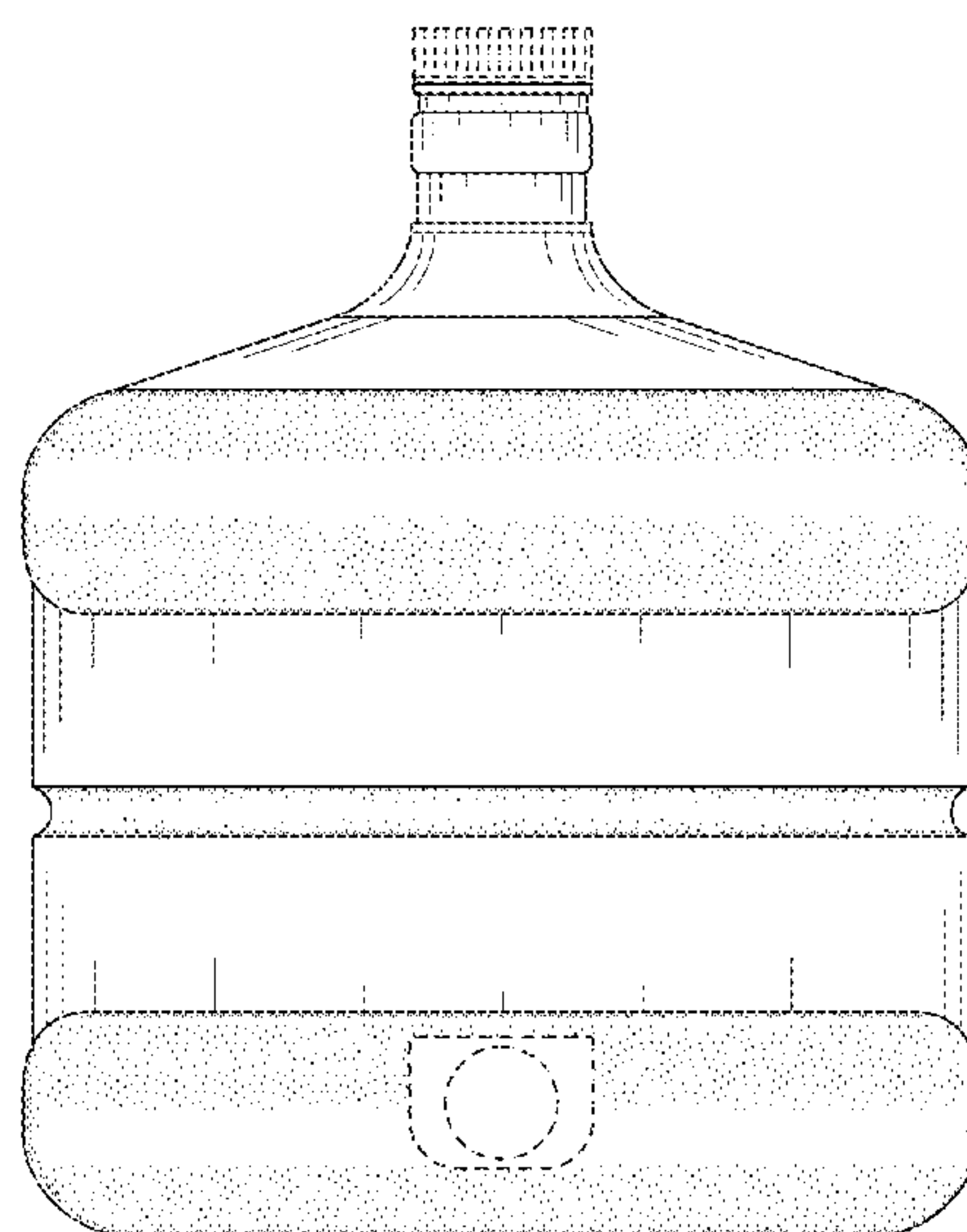
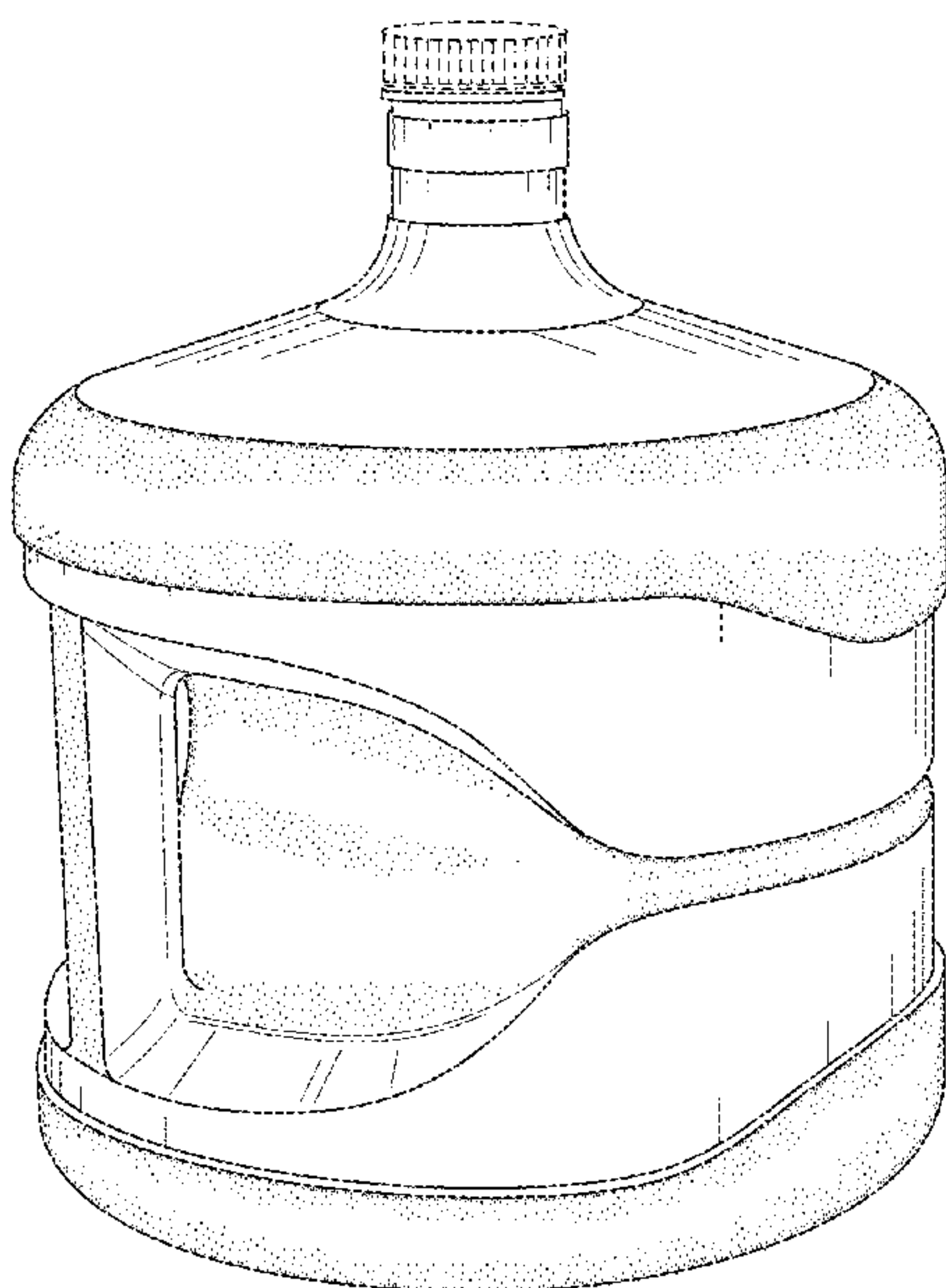
CLAIM

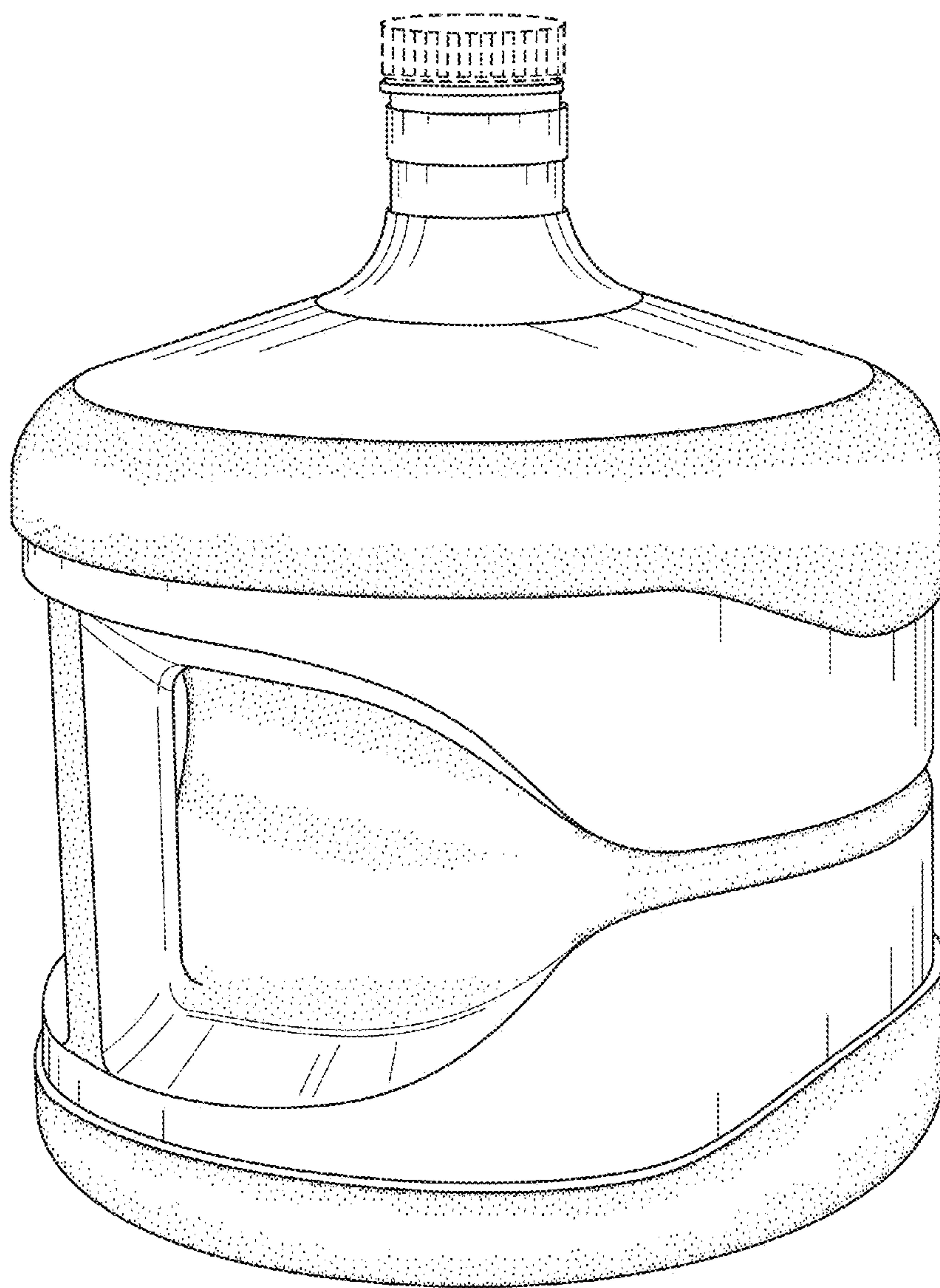

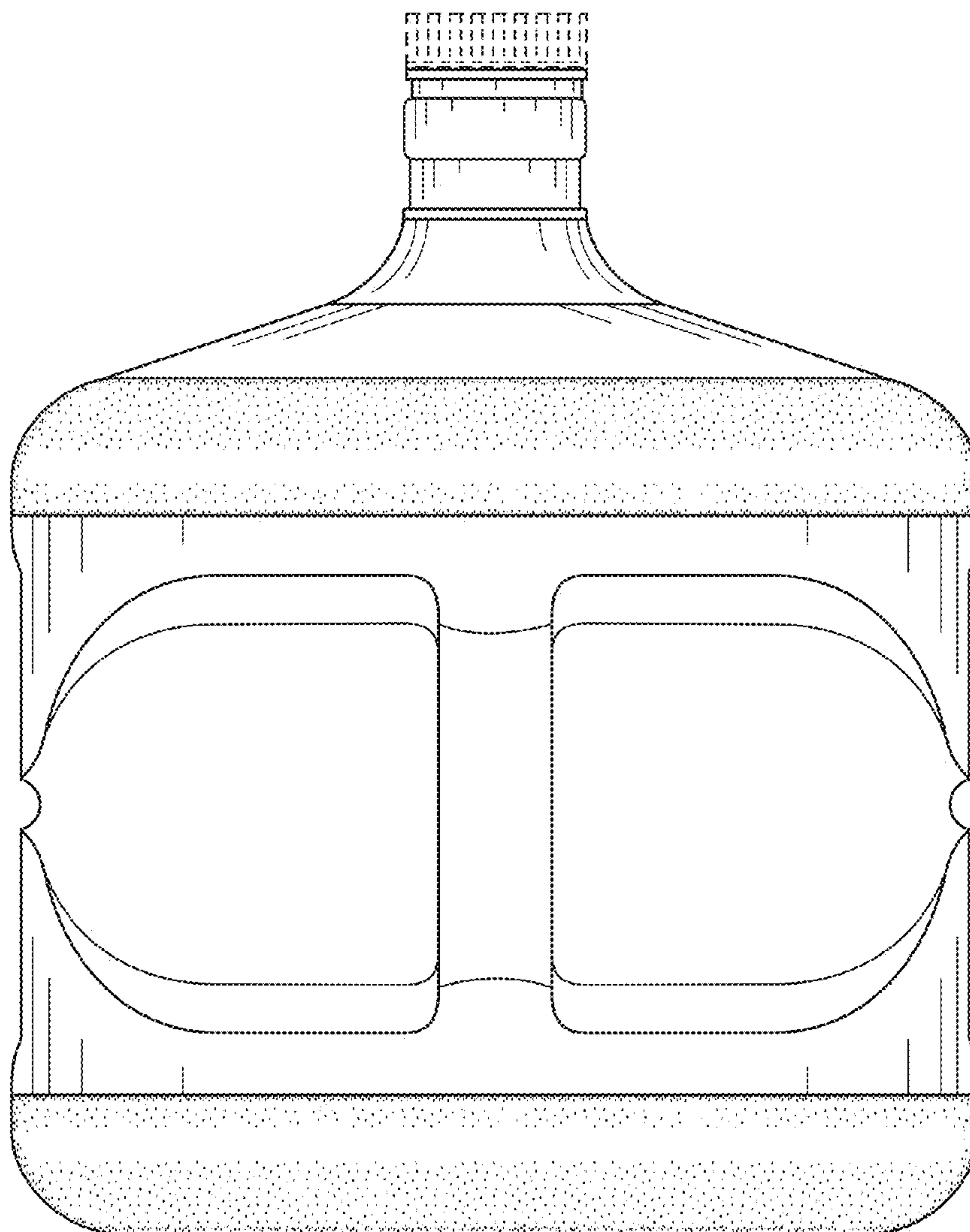

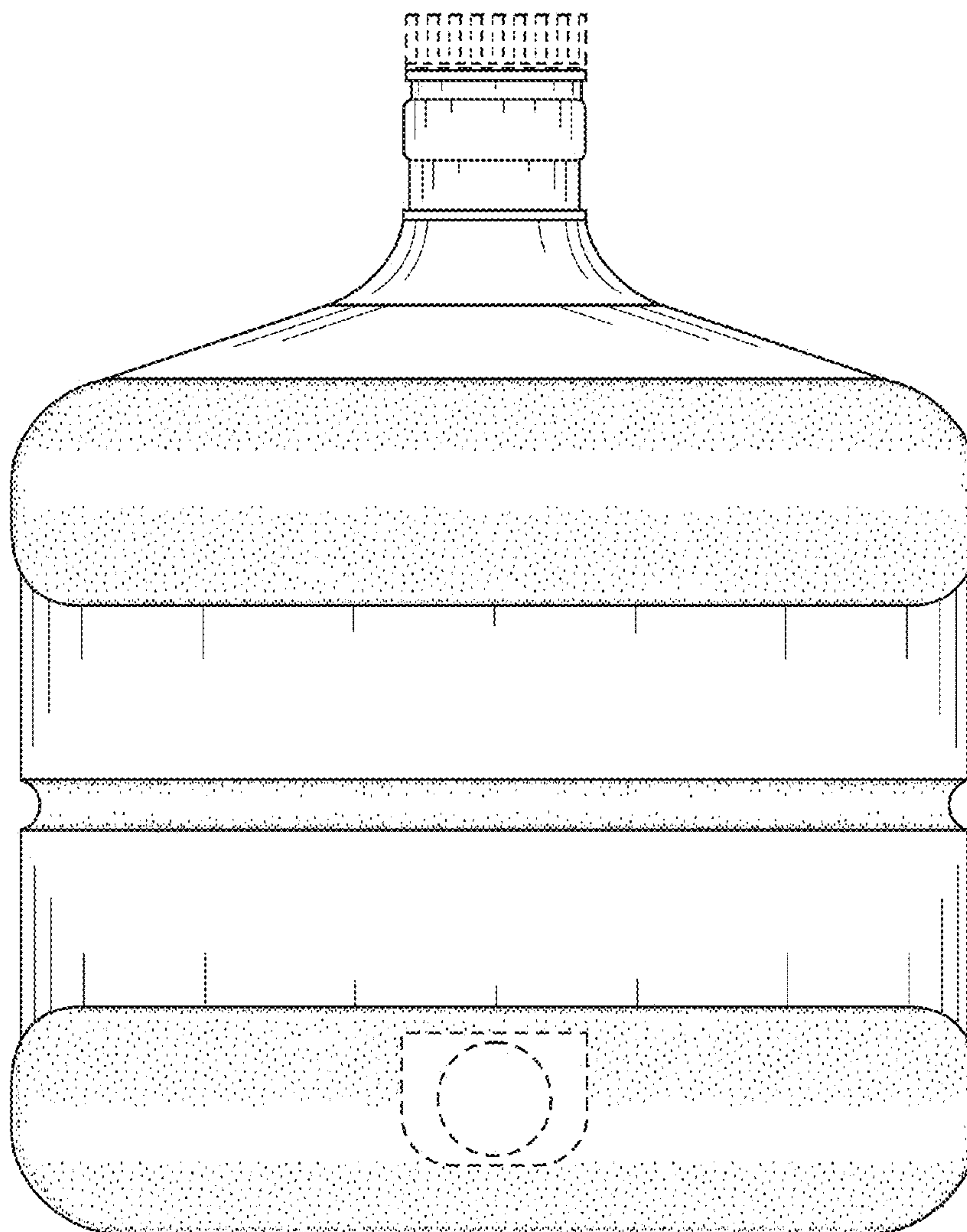

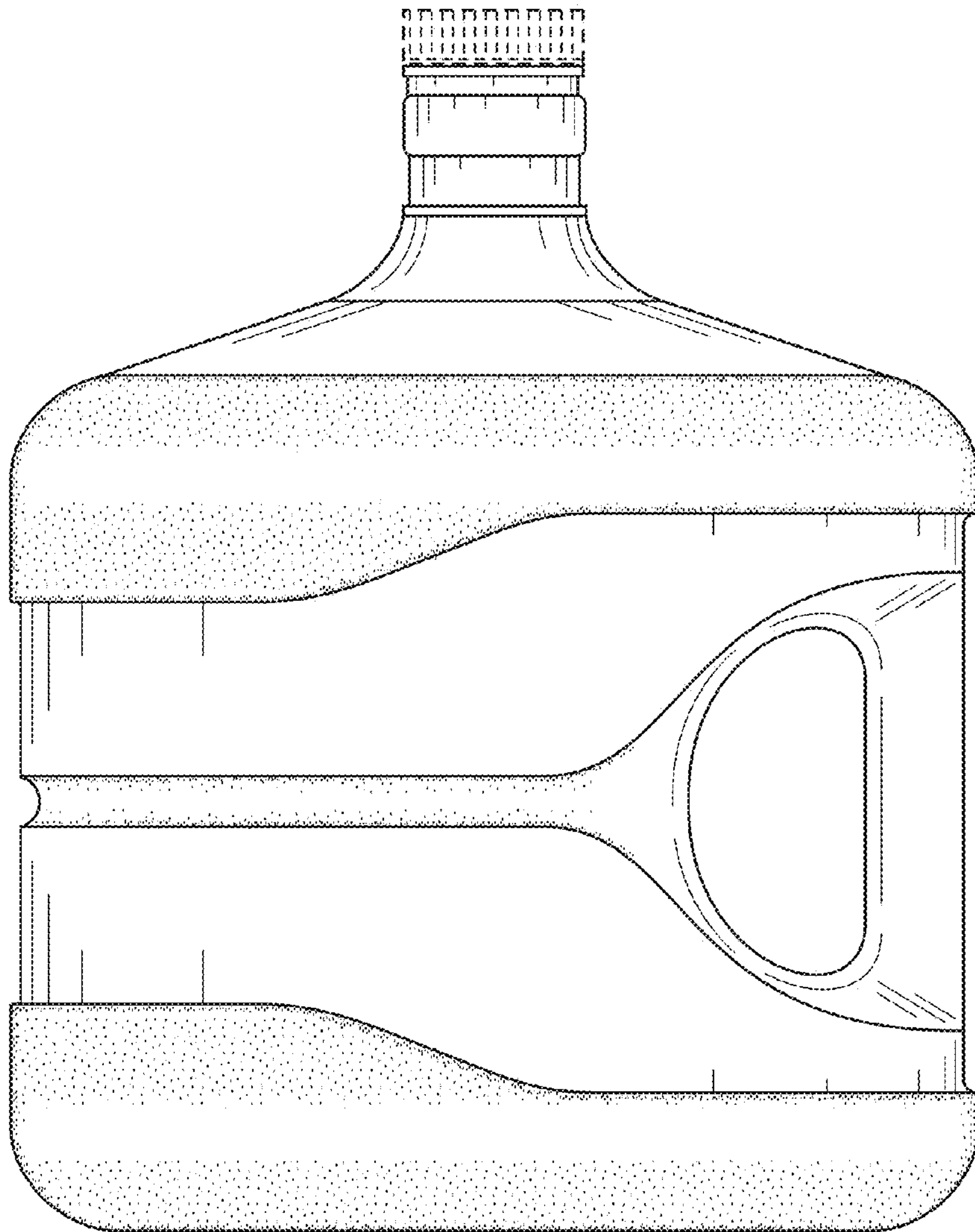

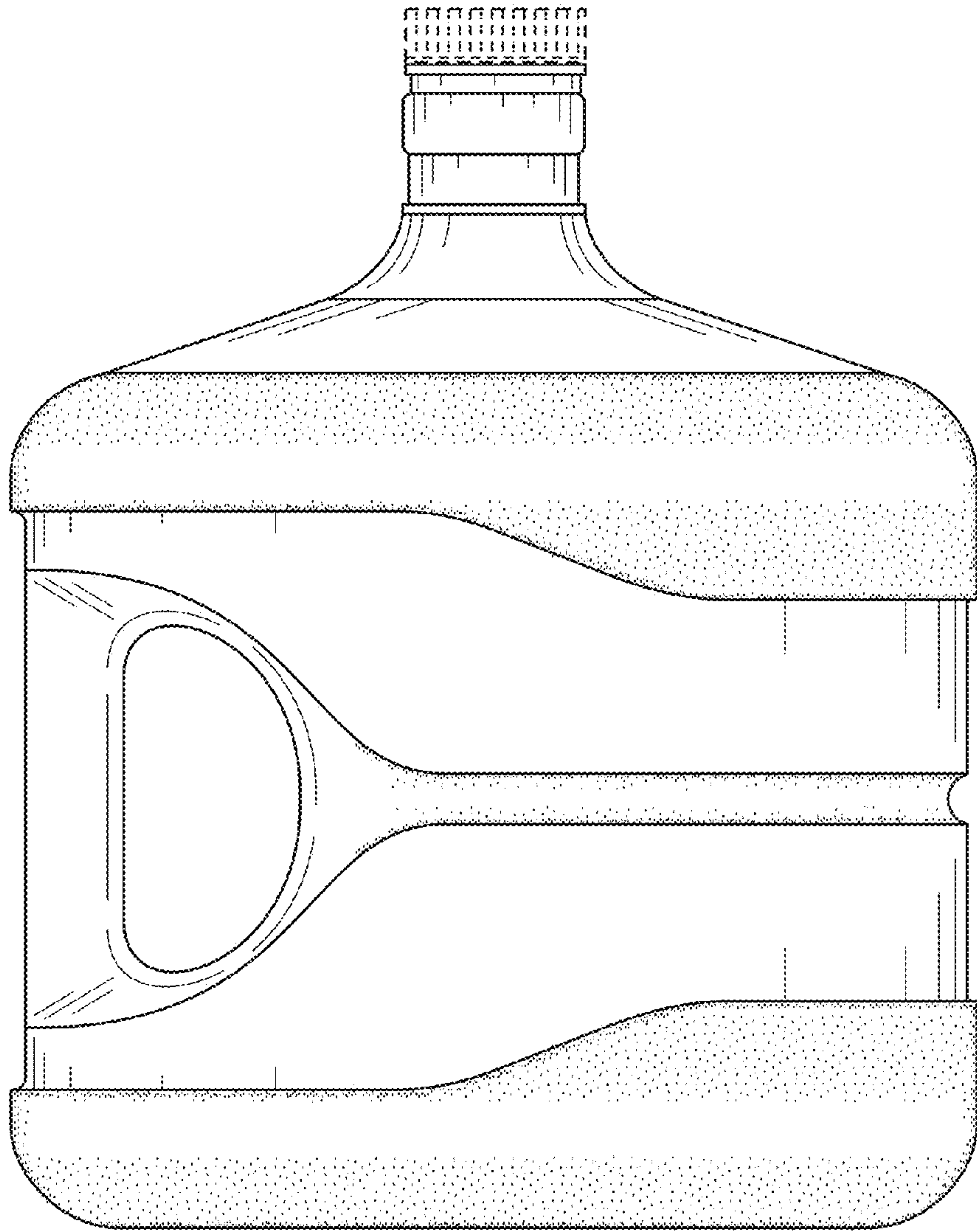

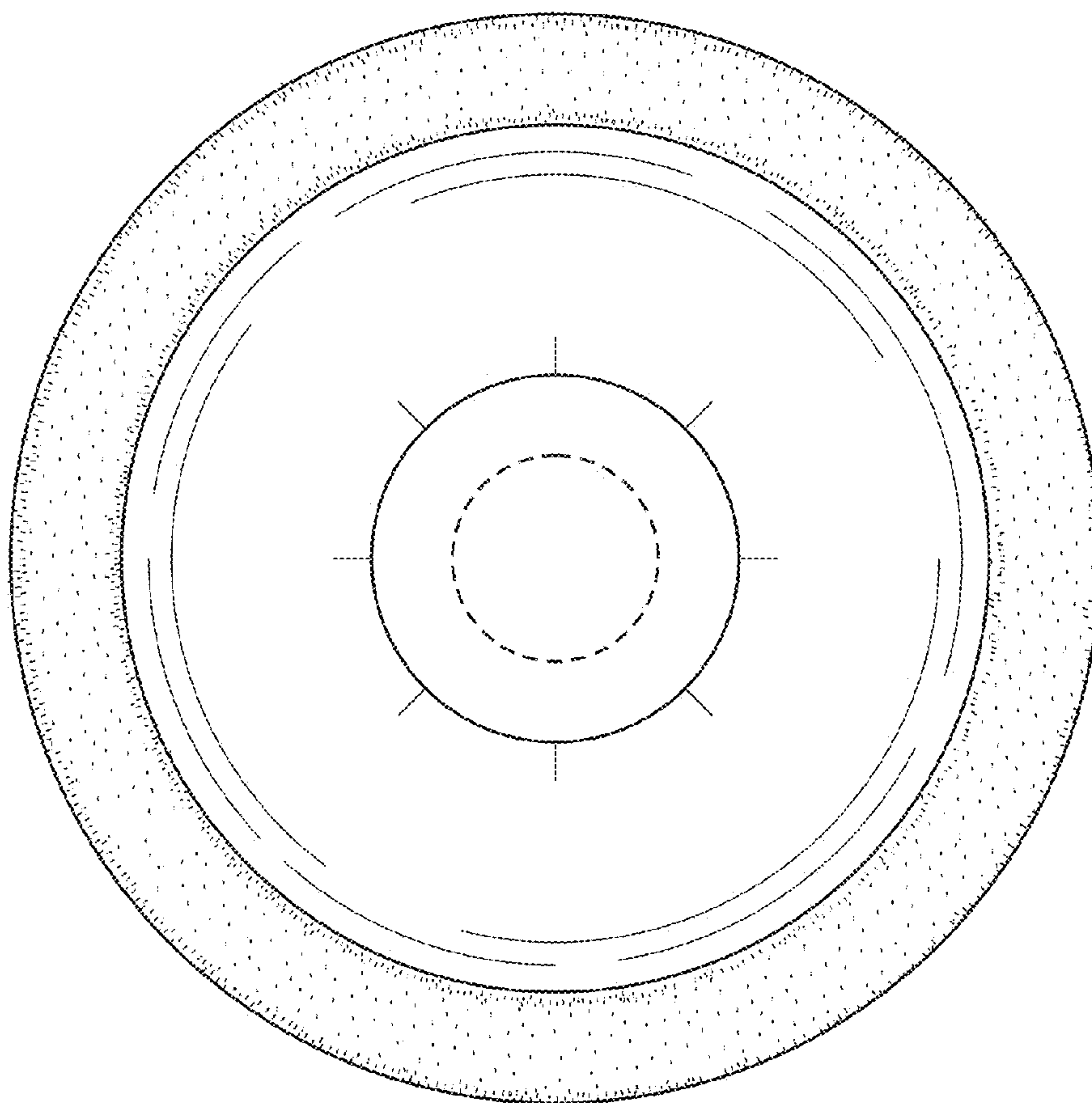

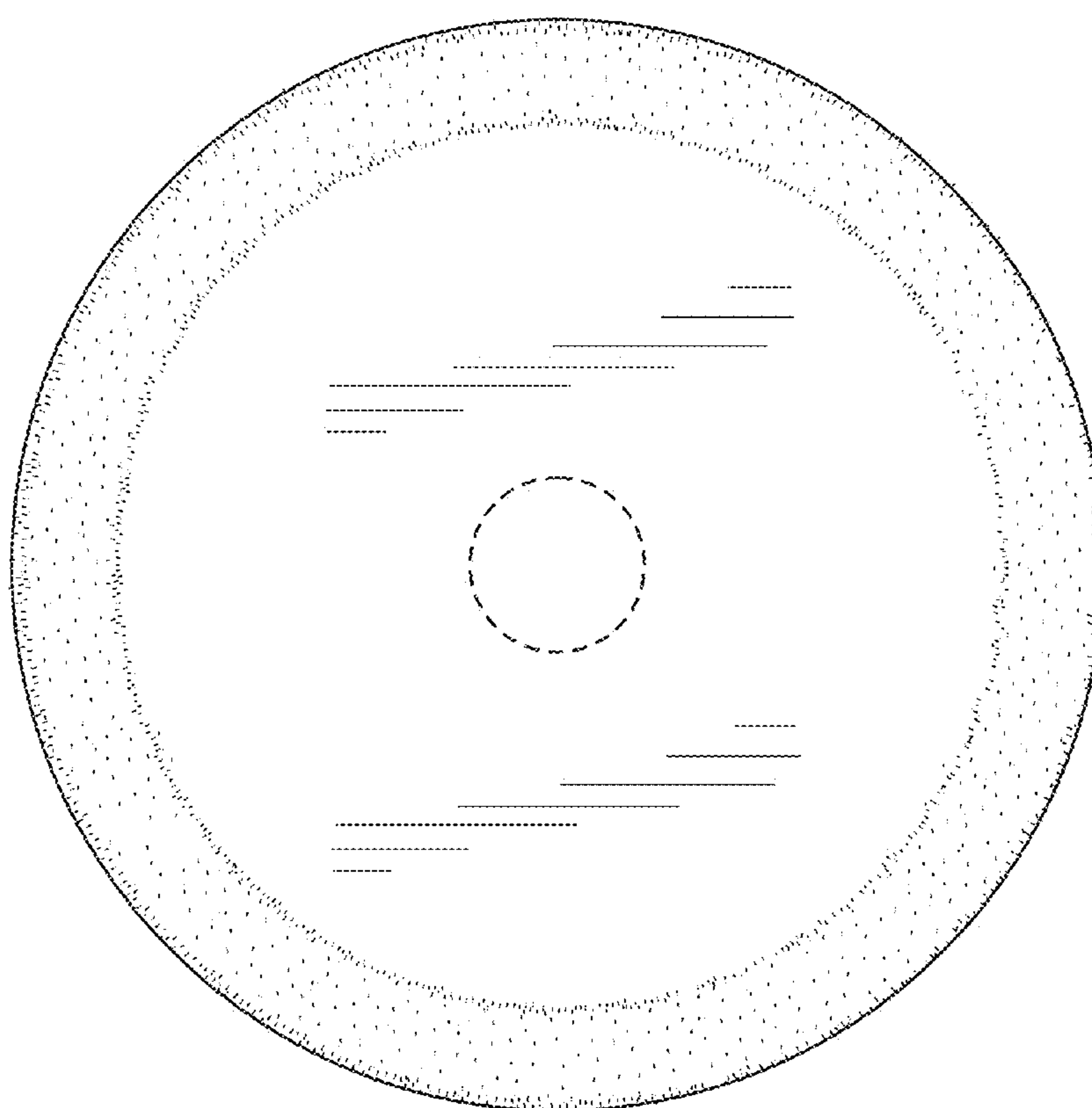
