FIG. 15 is a front elevational view thereof;

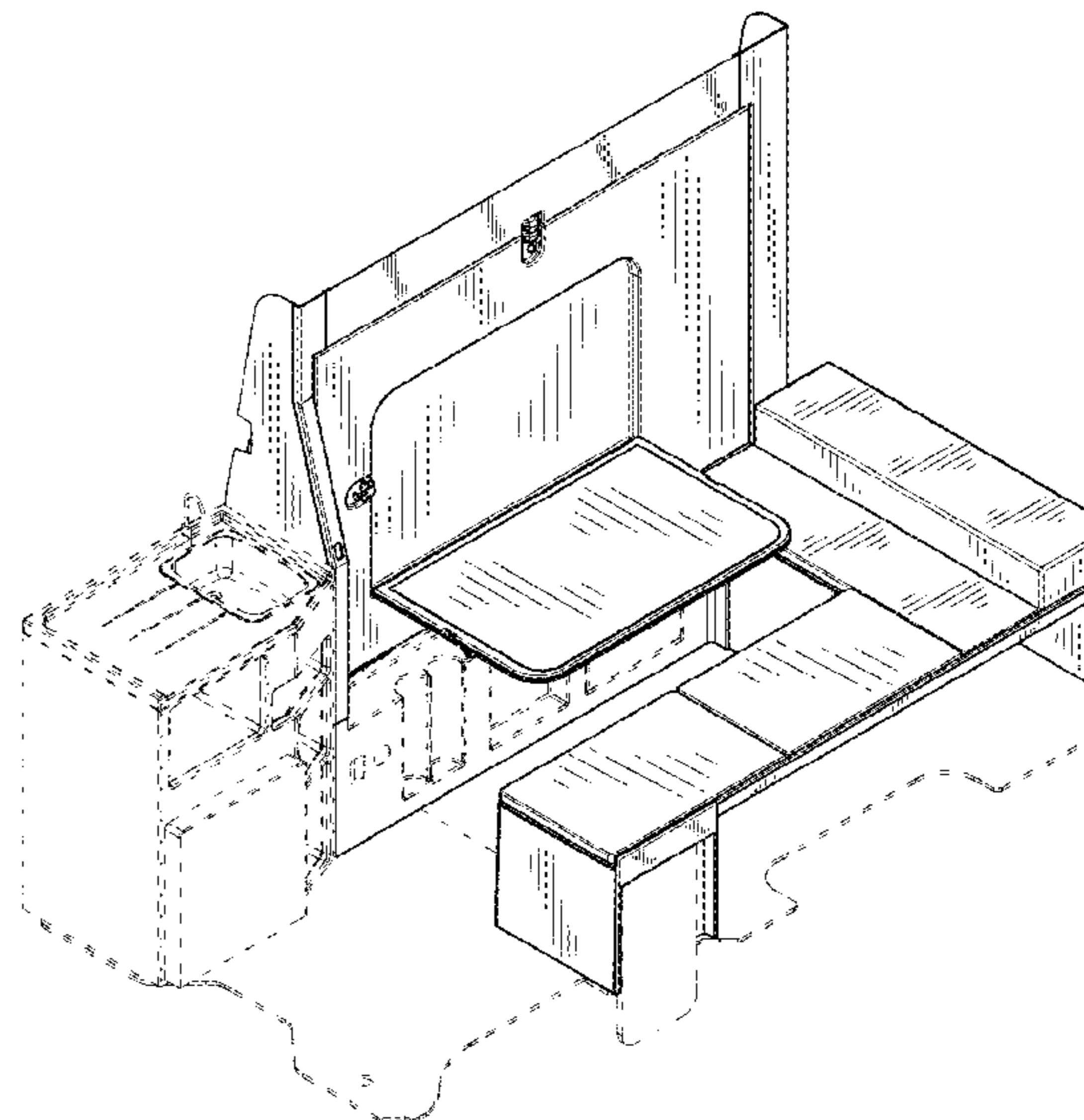
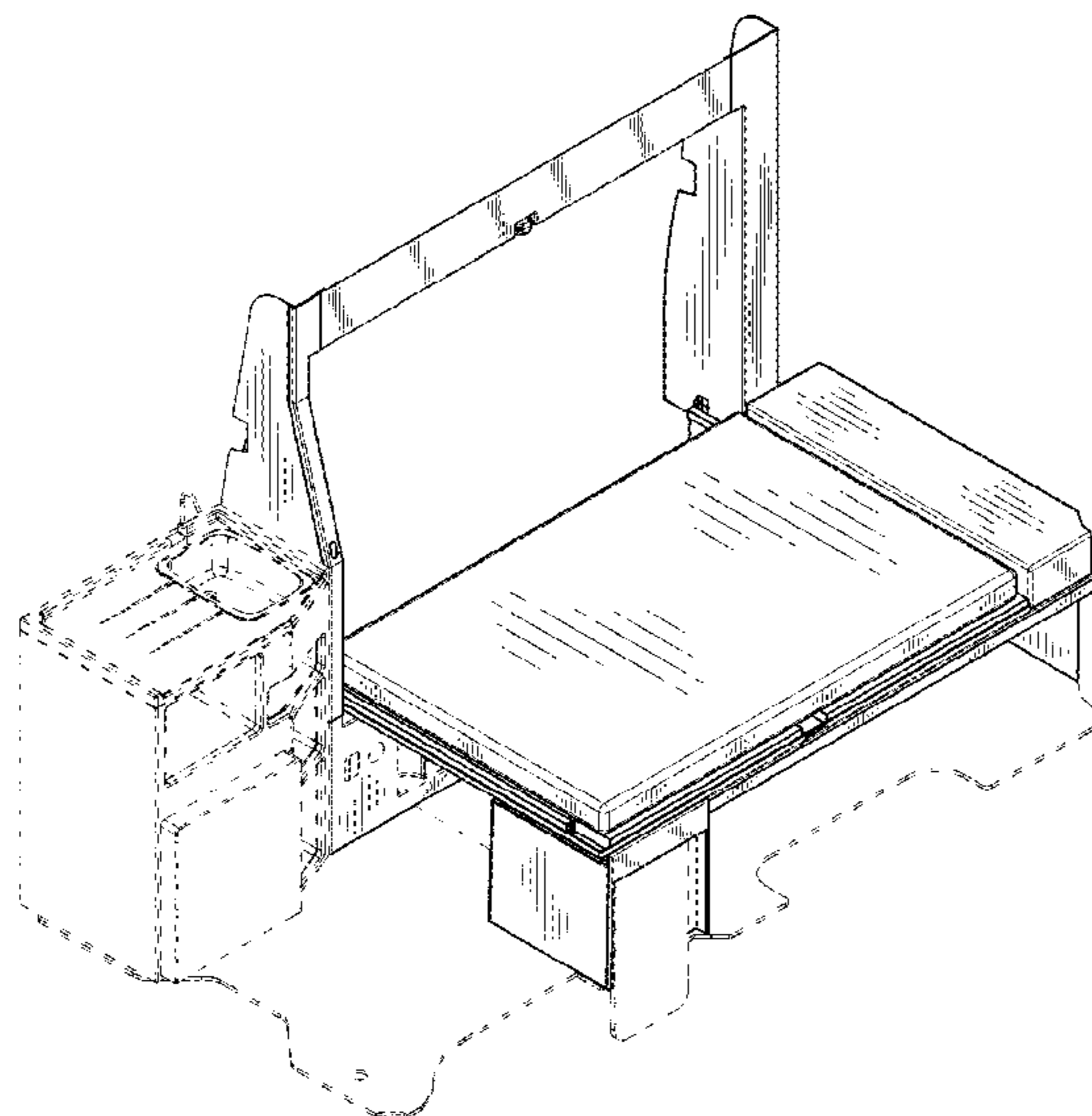
FIG. 16 is a rear elevational view thereof;

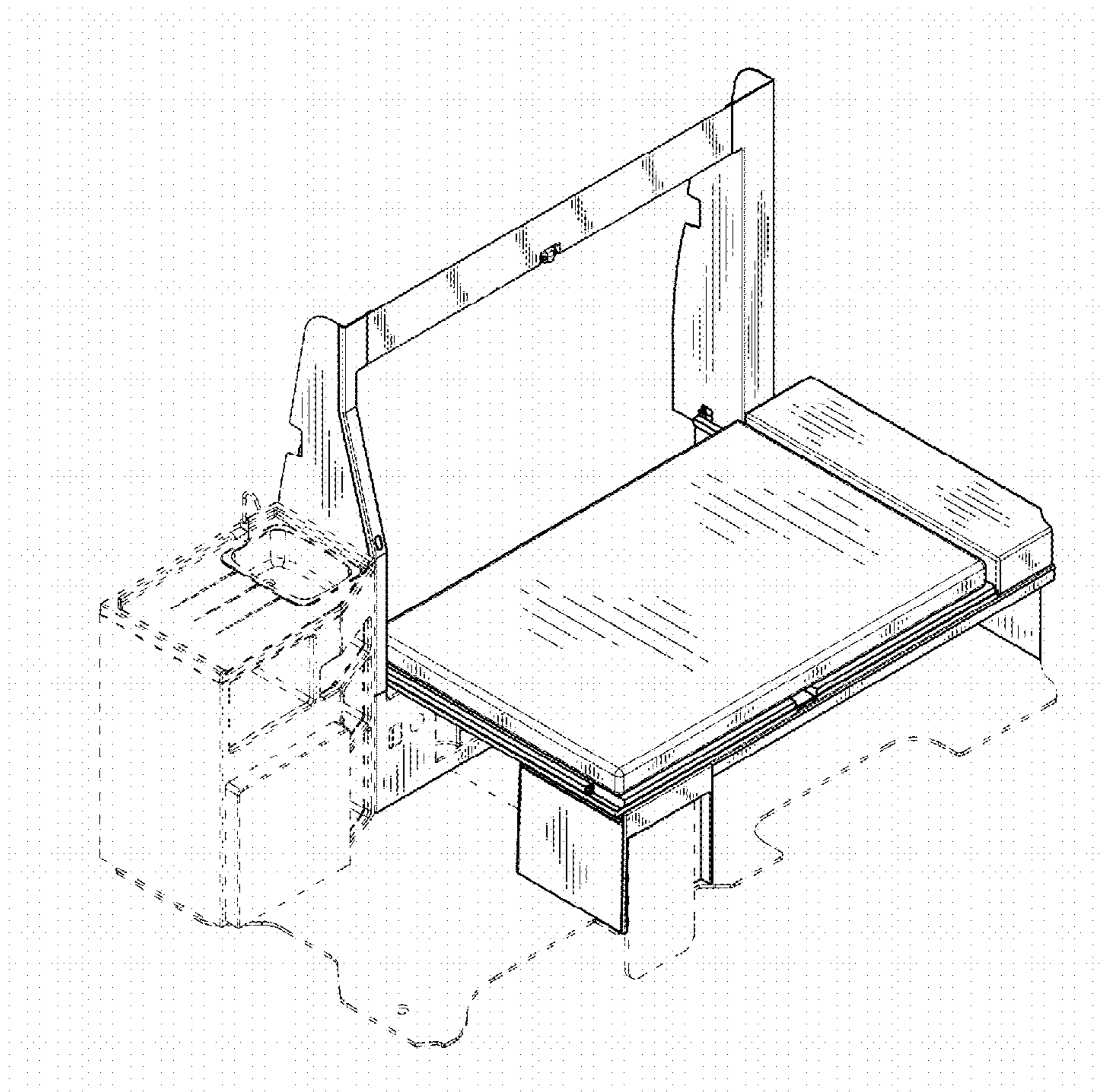

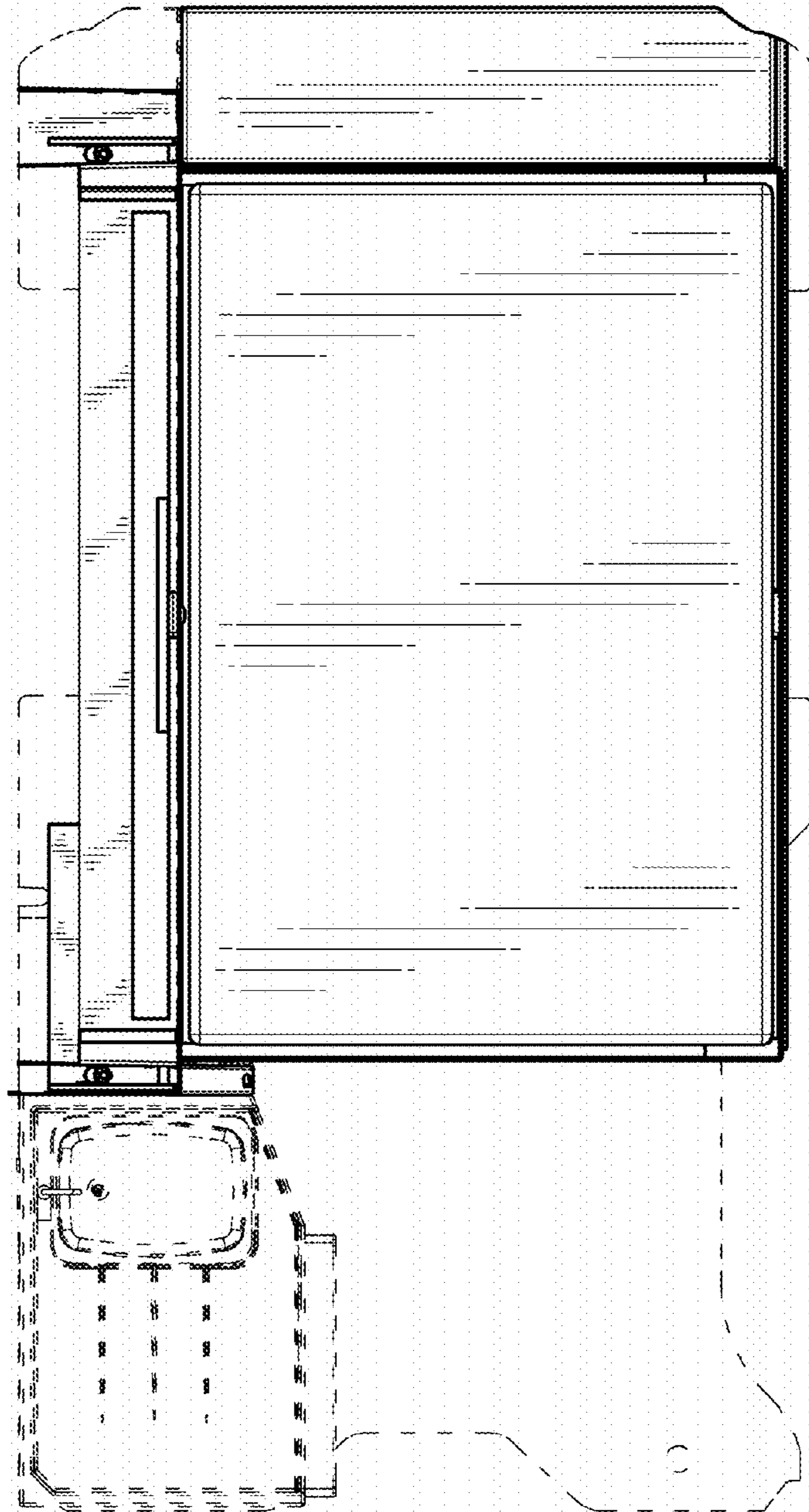

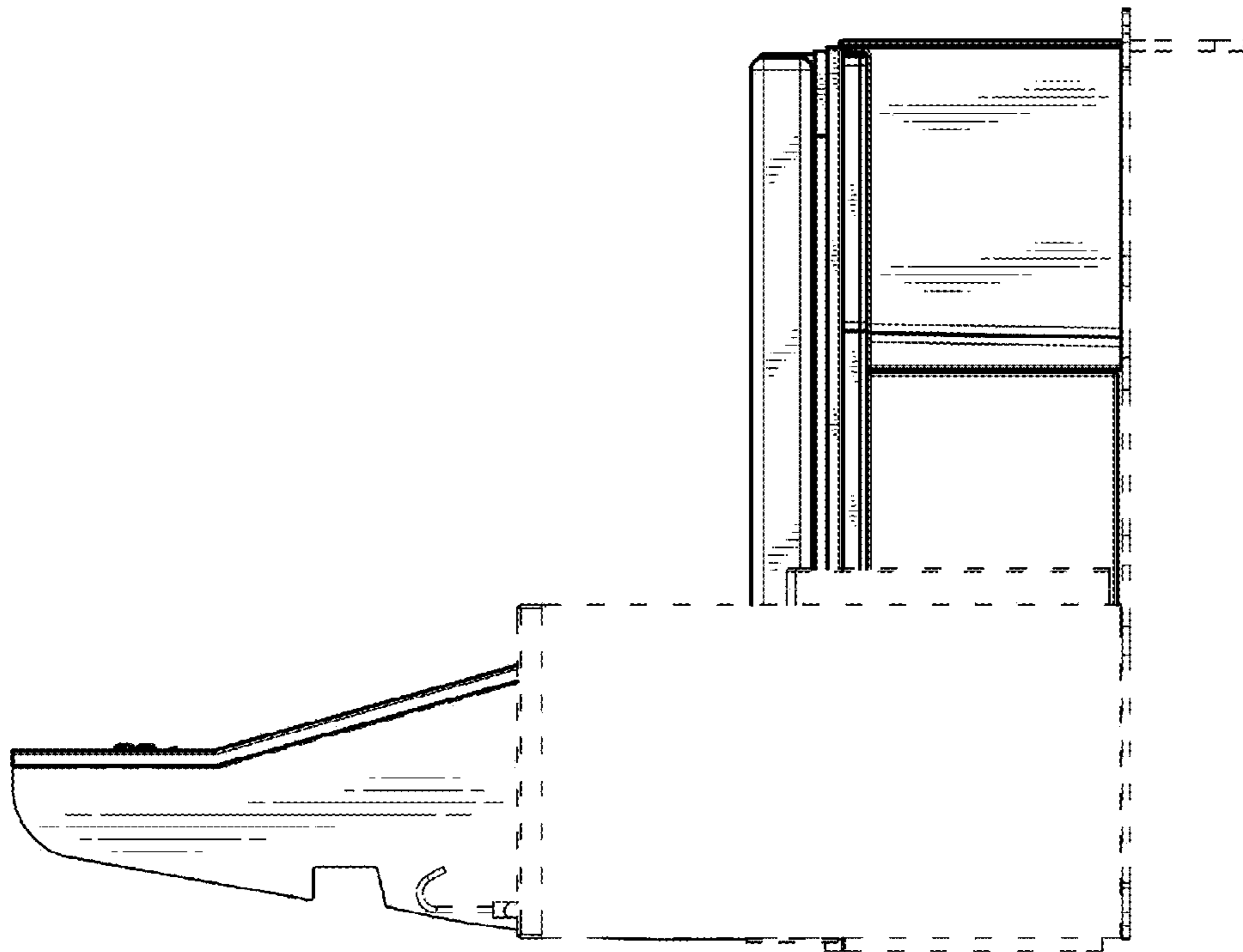

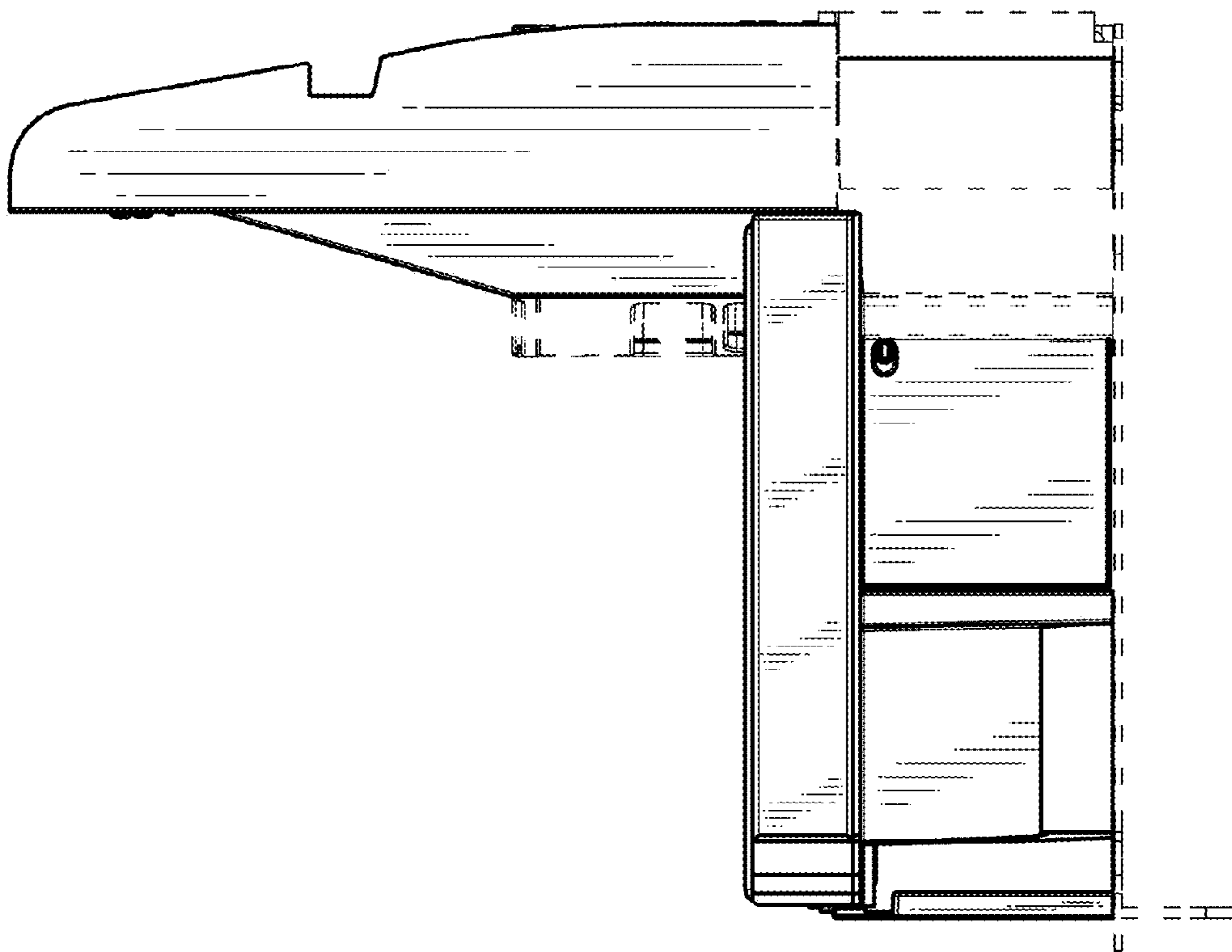

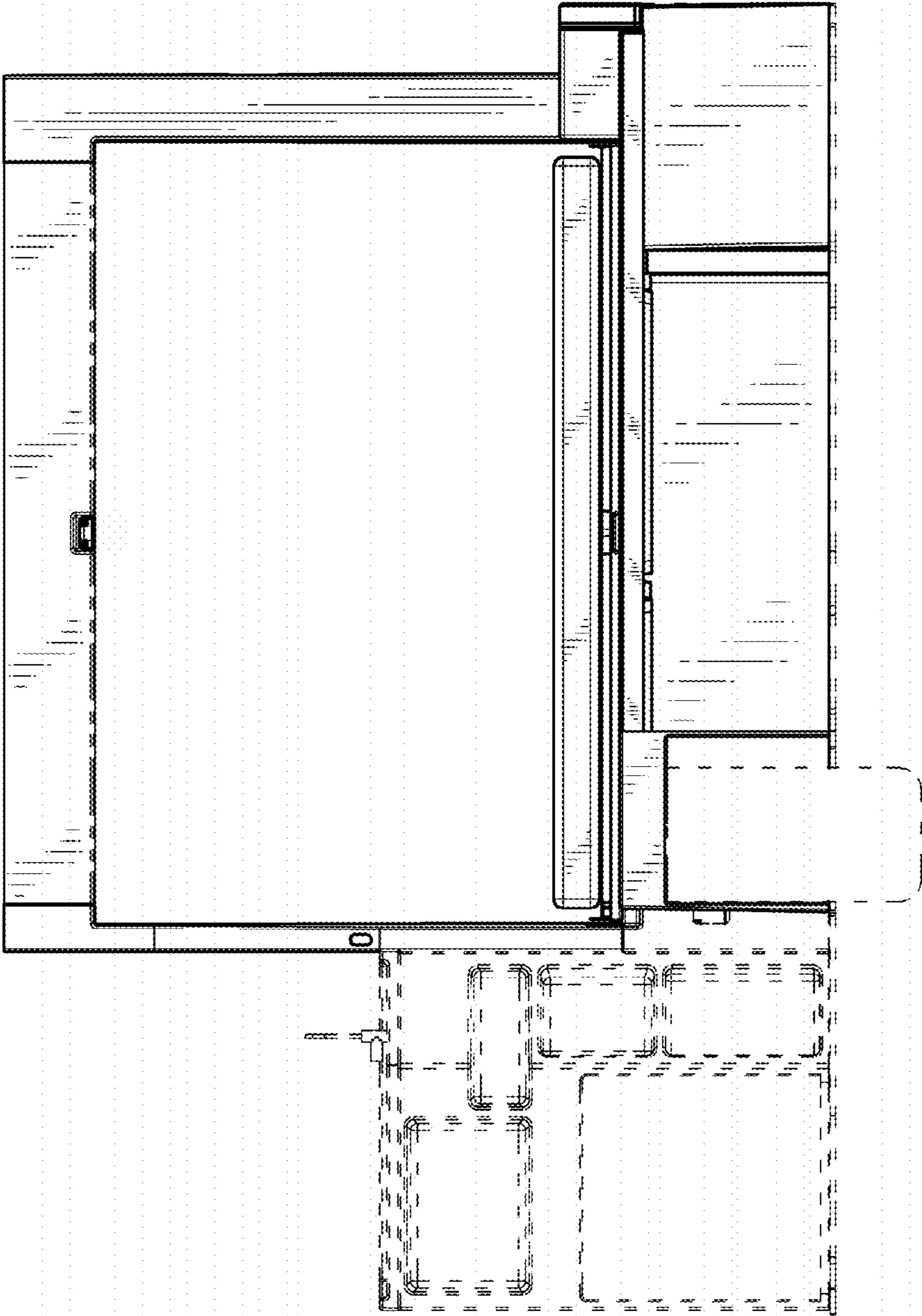

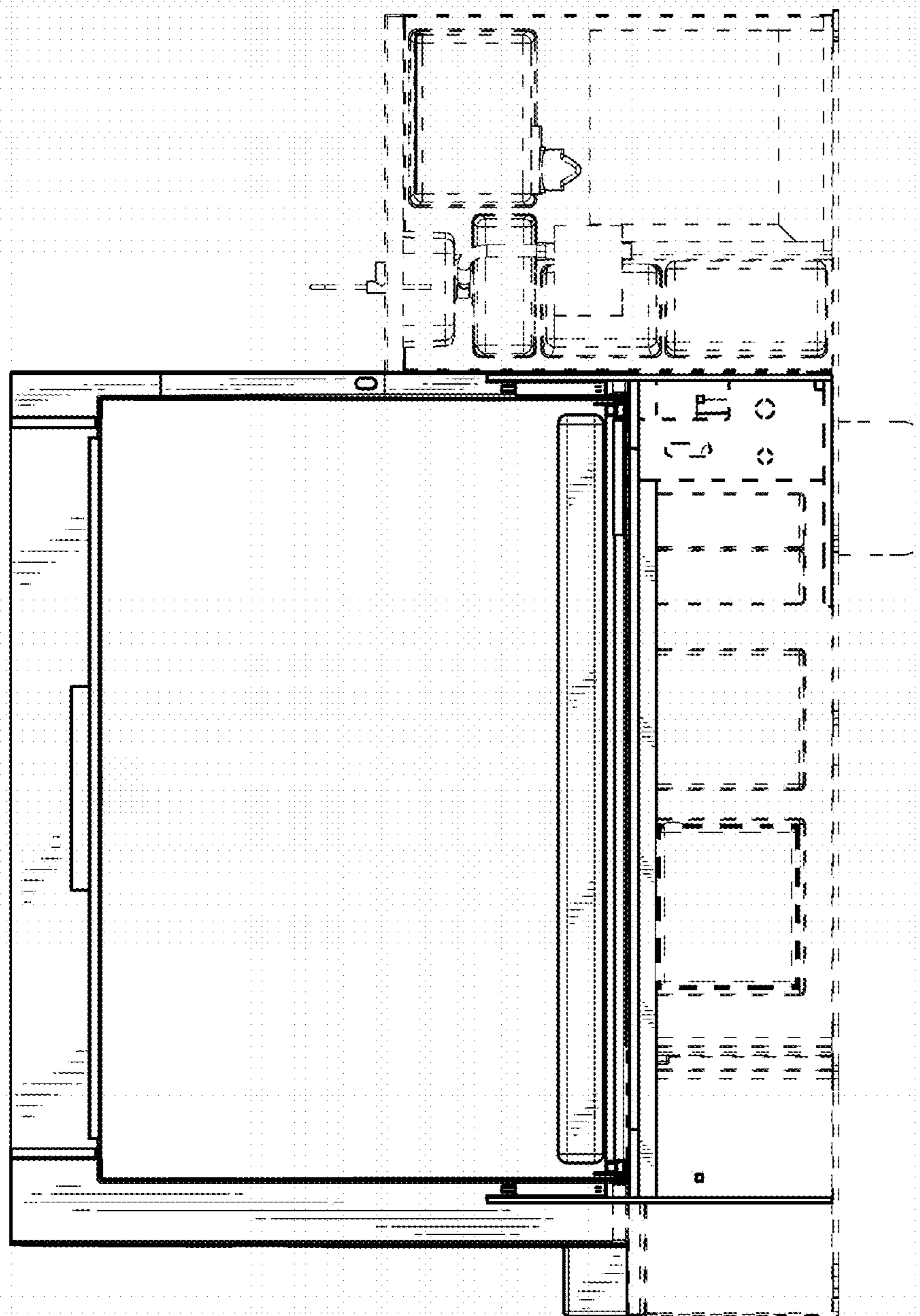

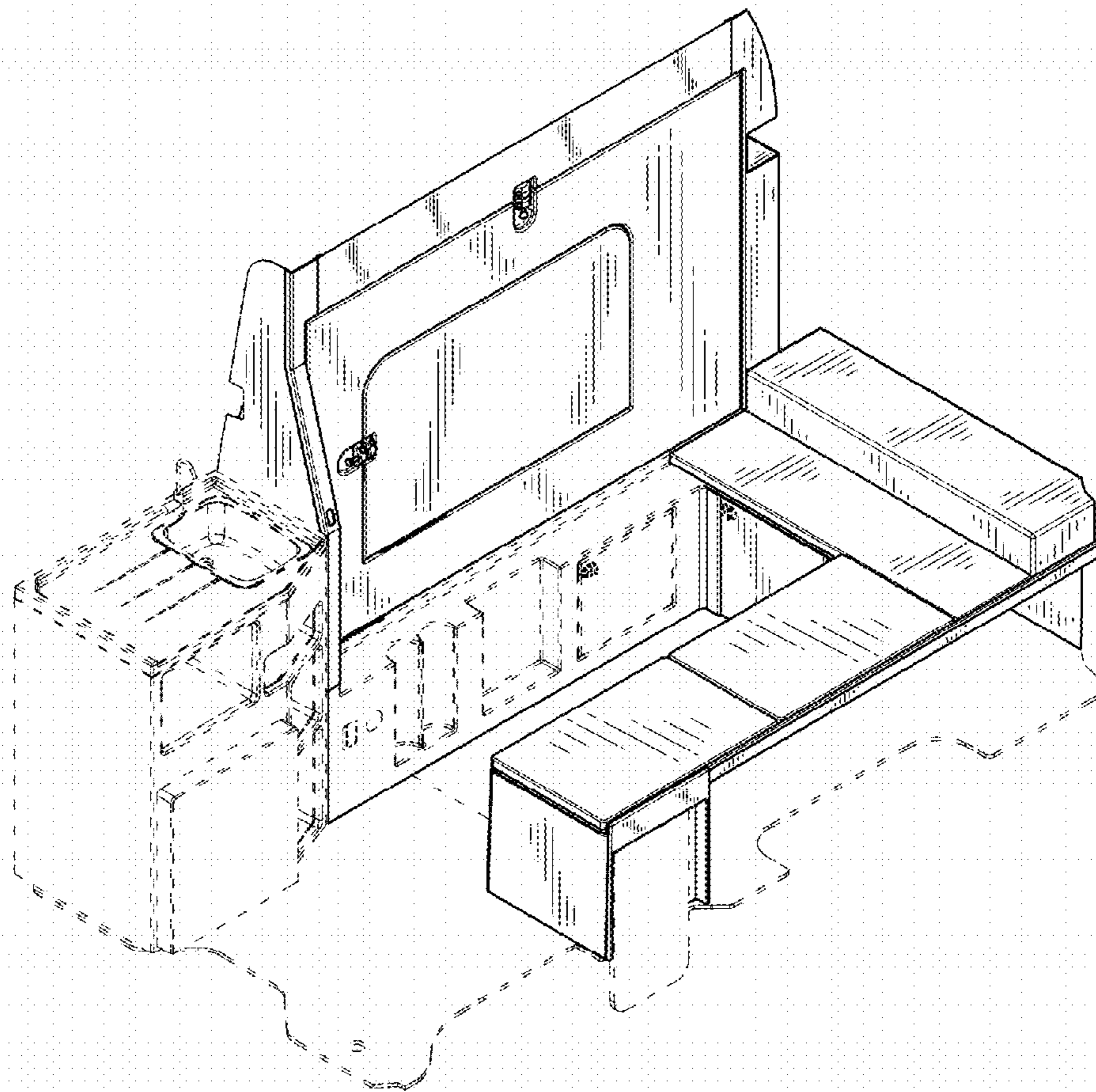

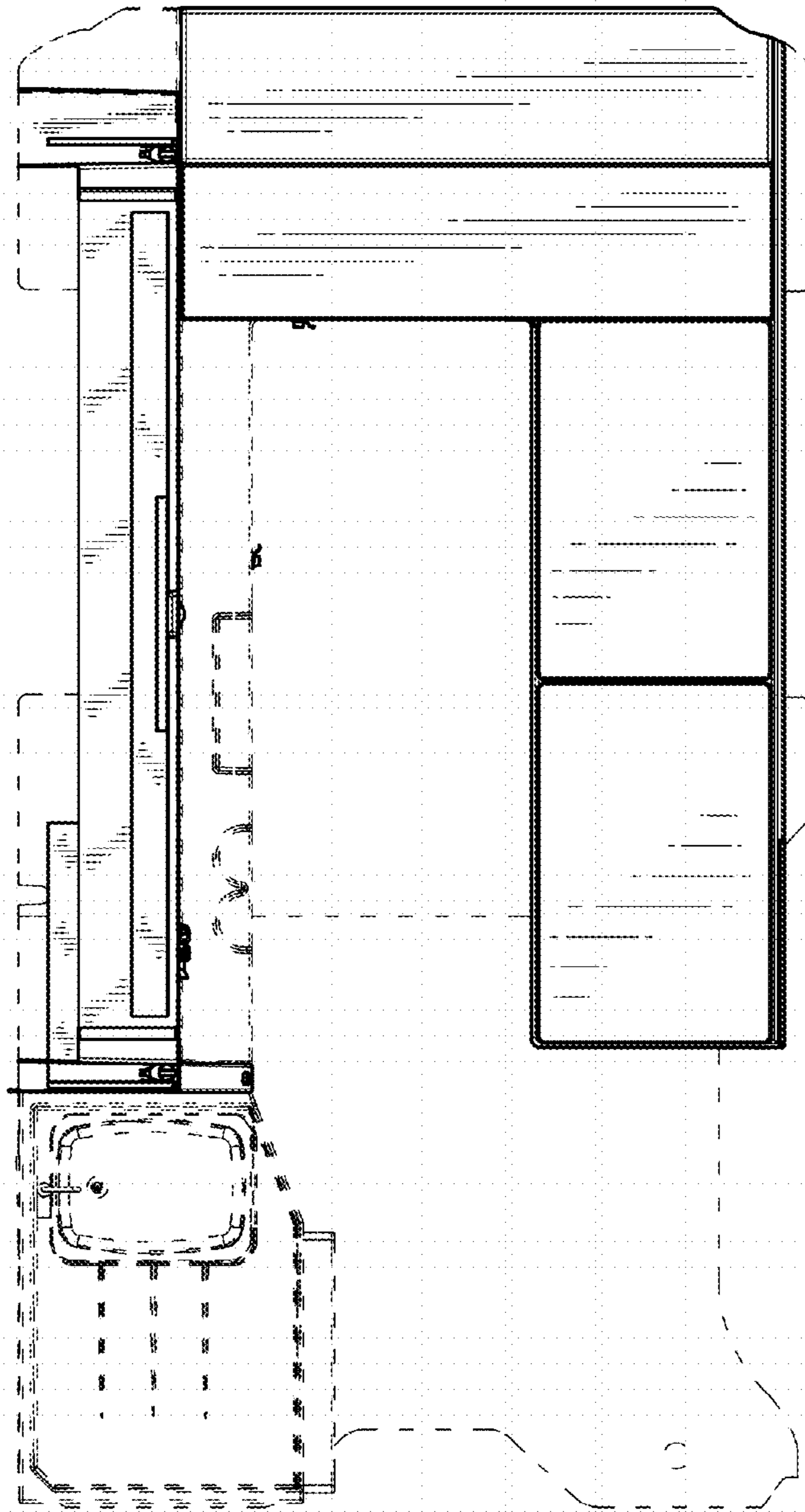

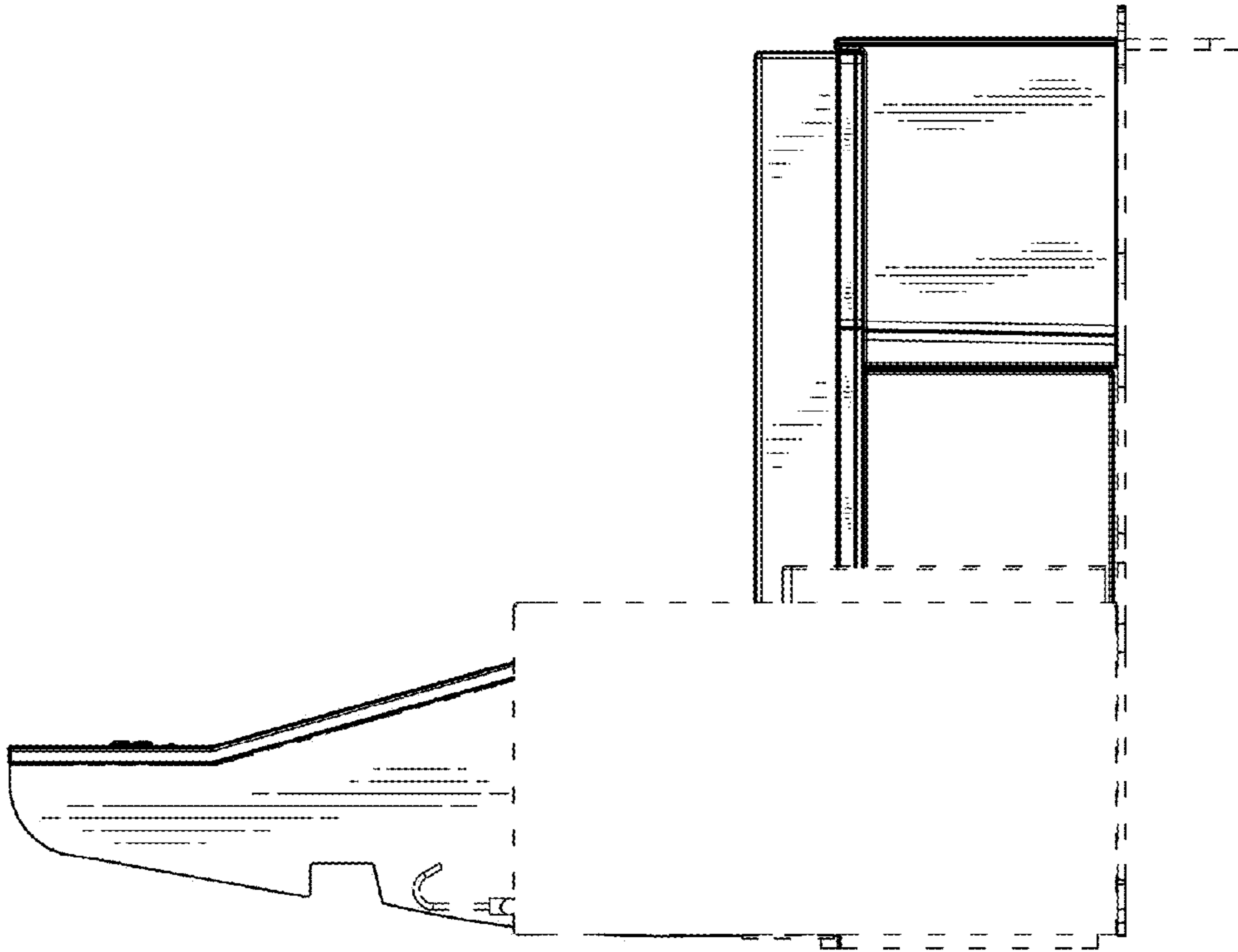

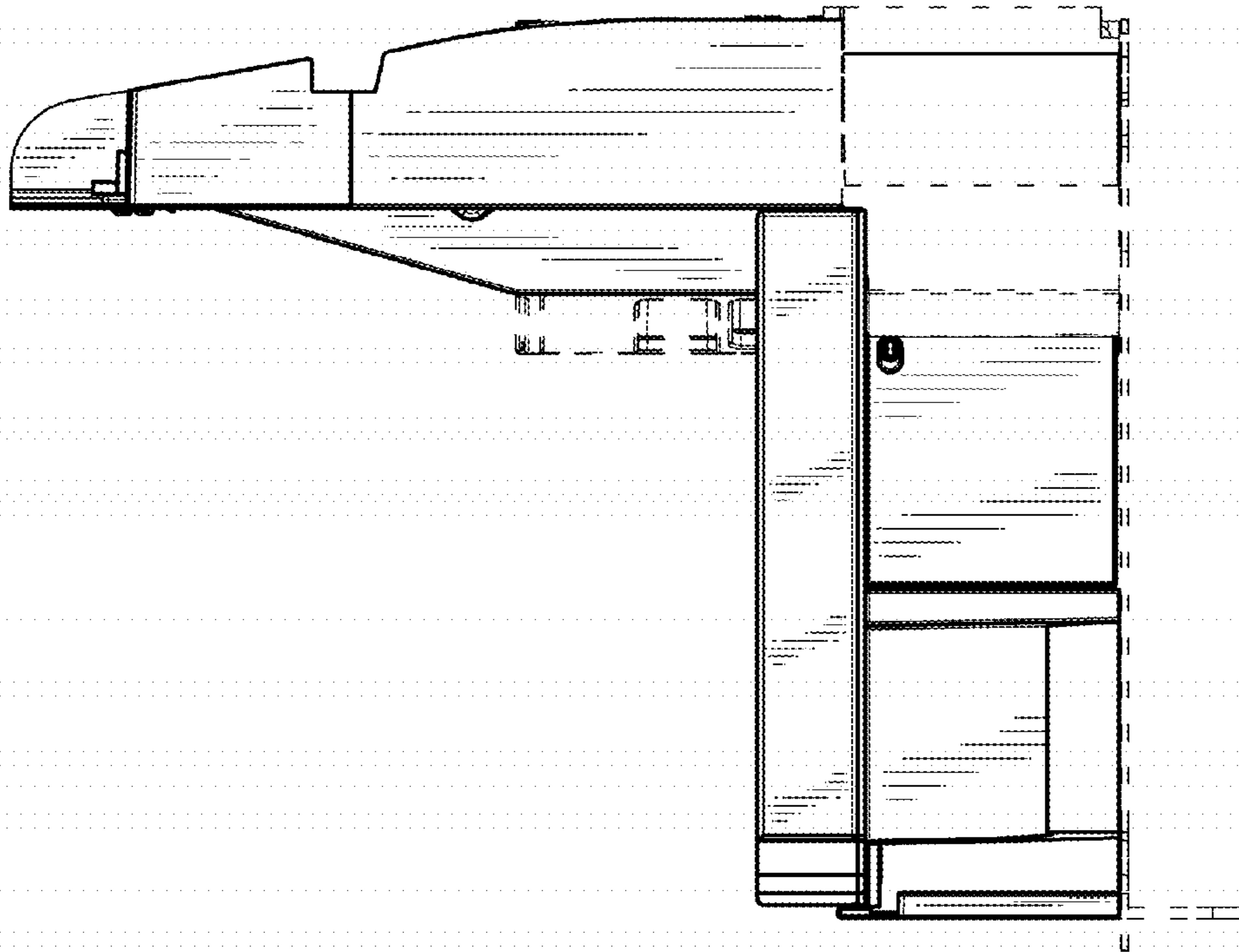

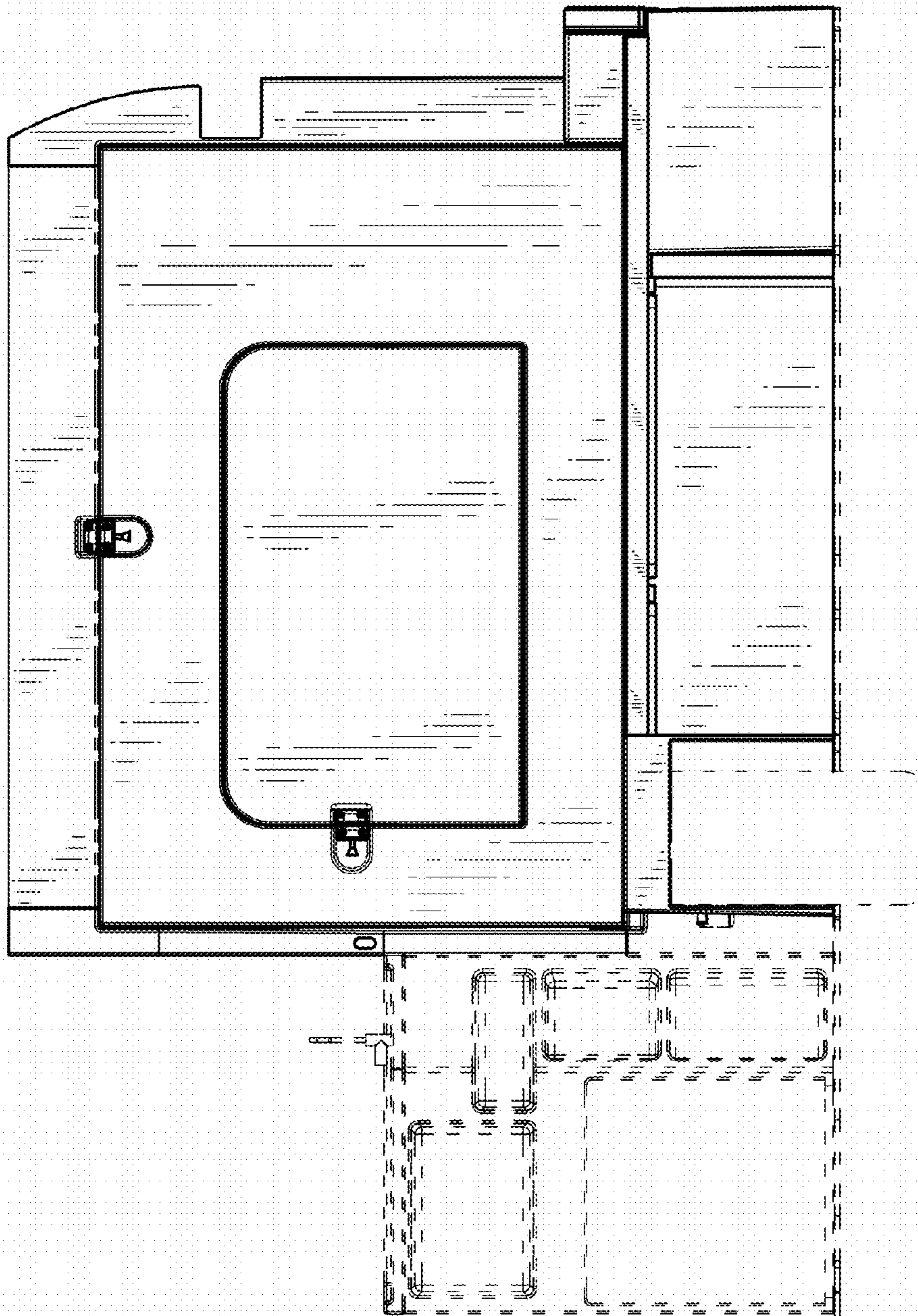

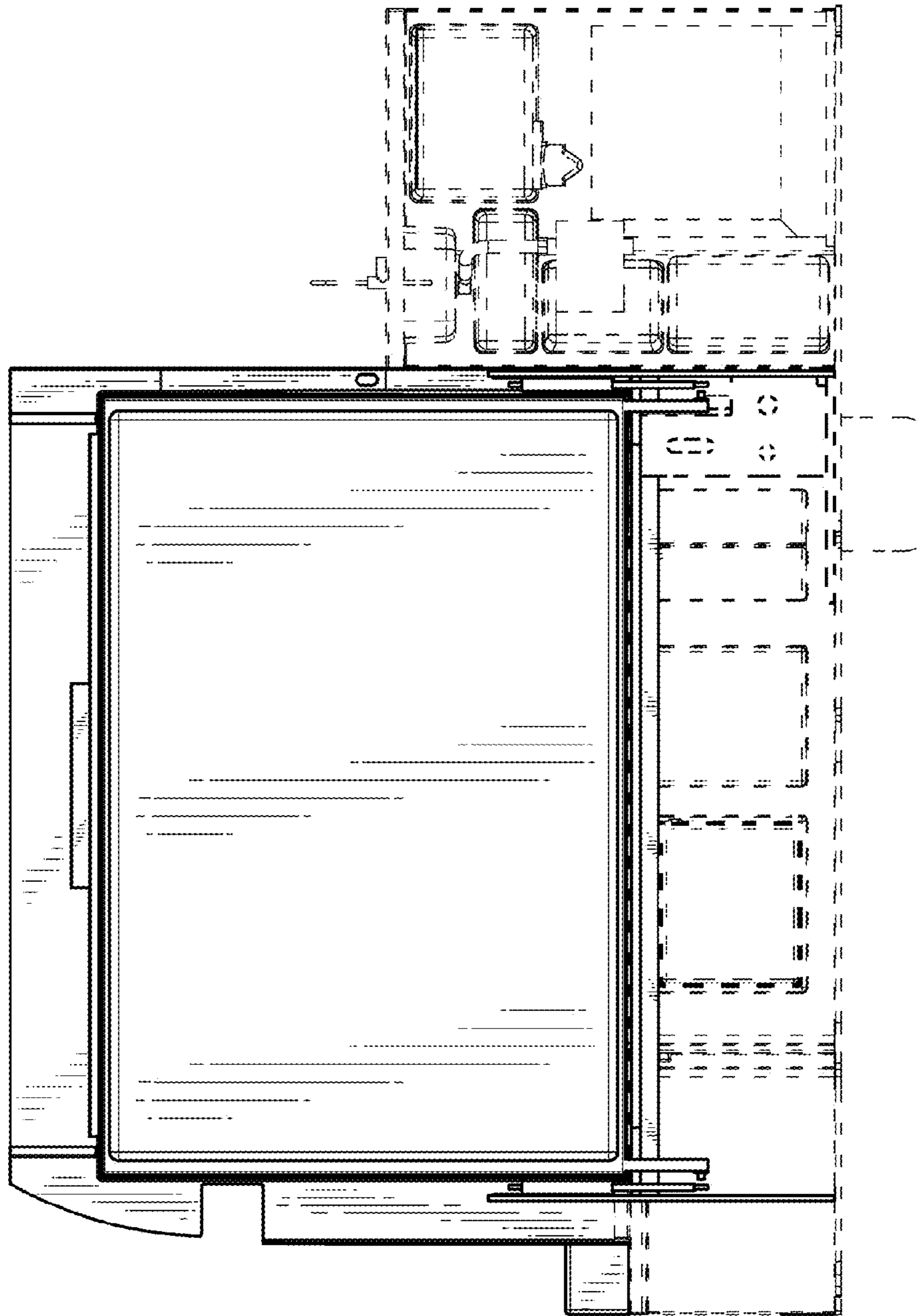

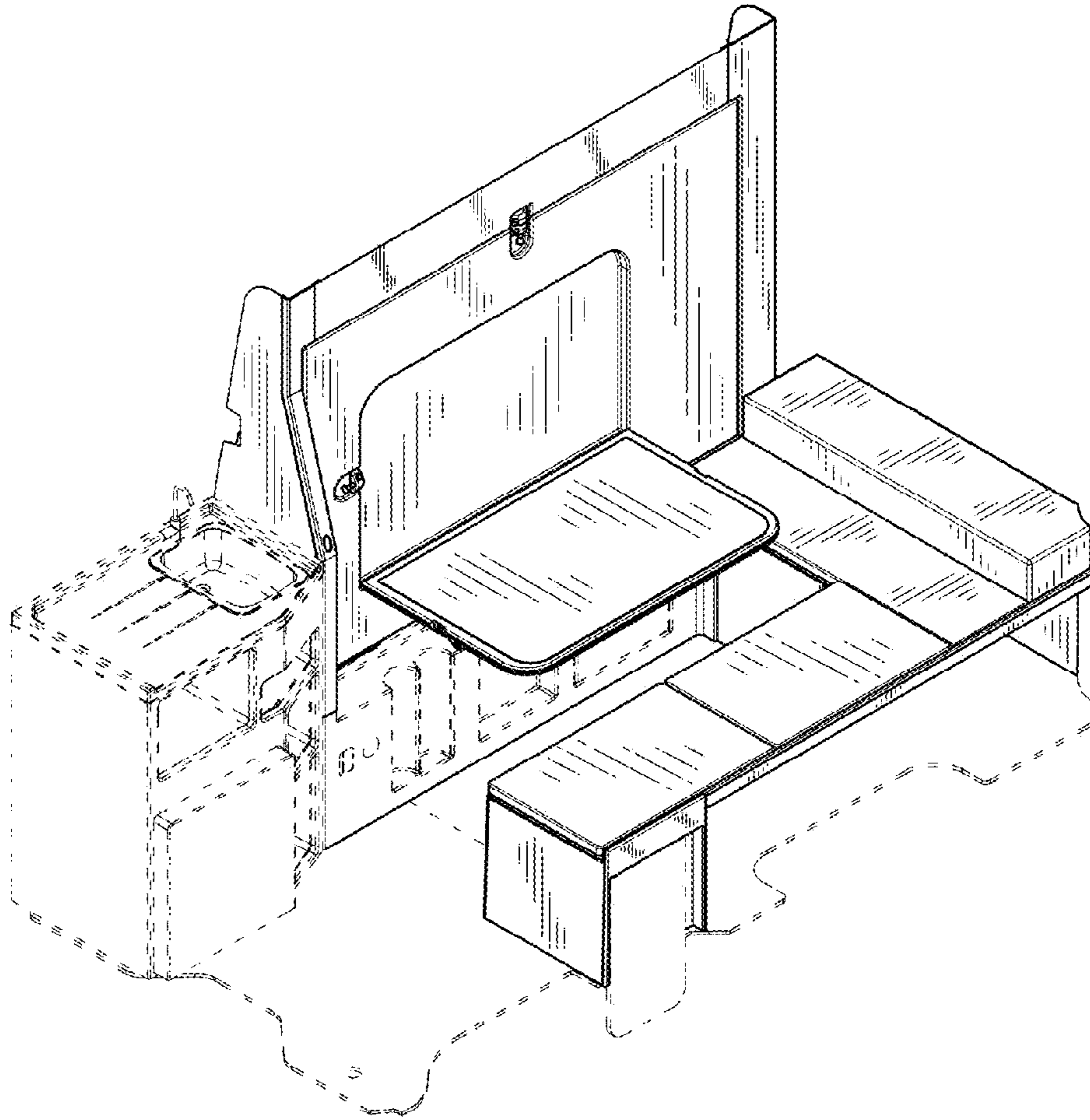

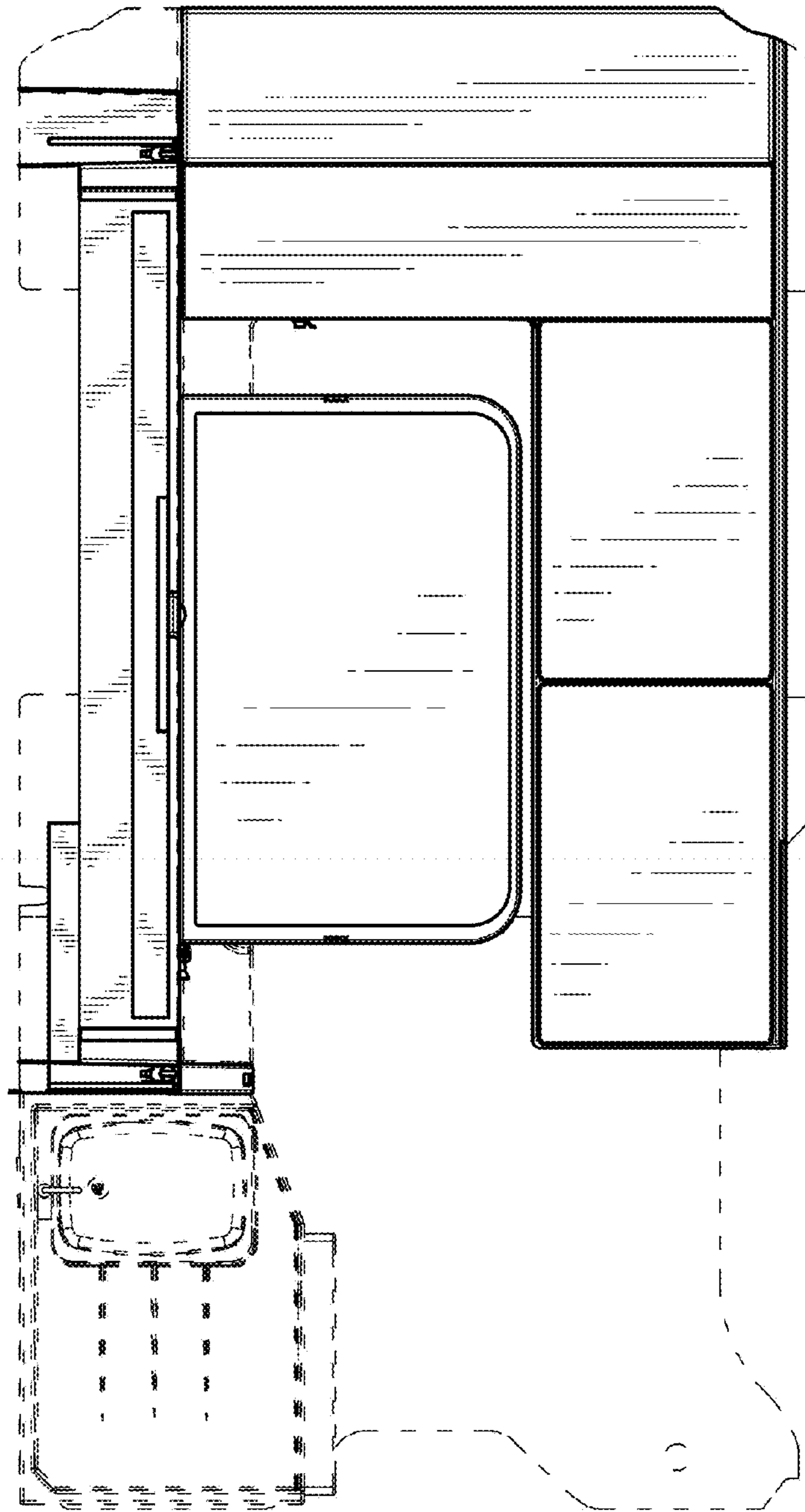

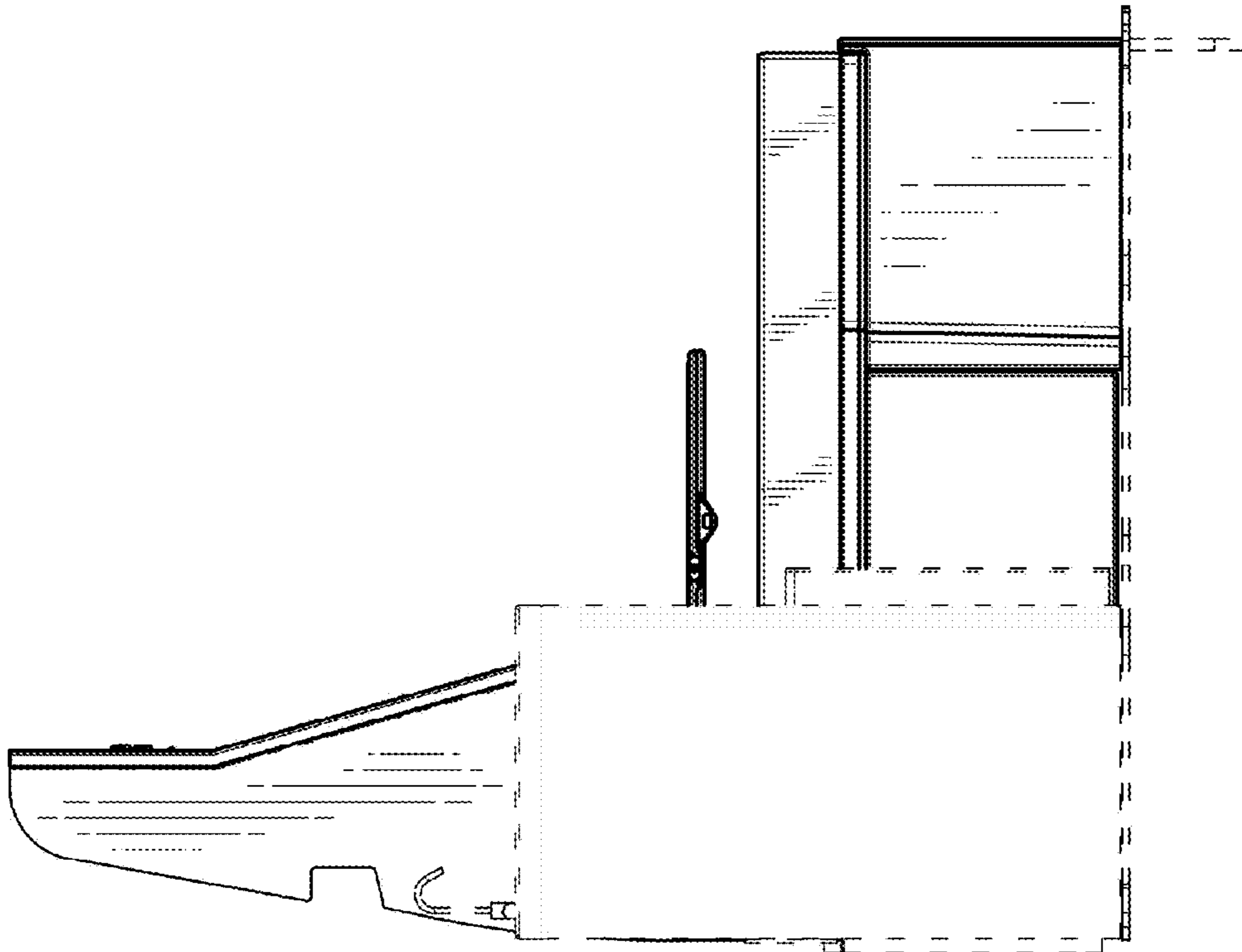

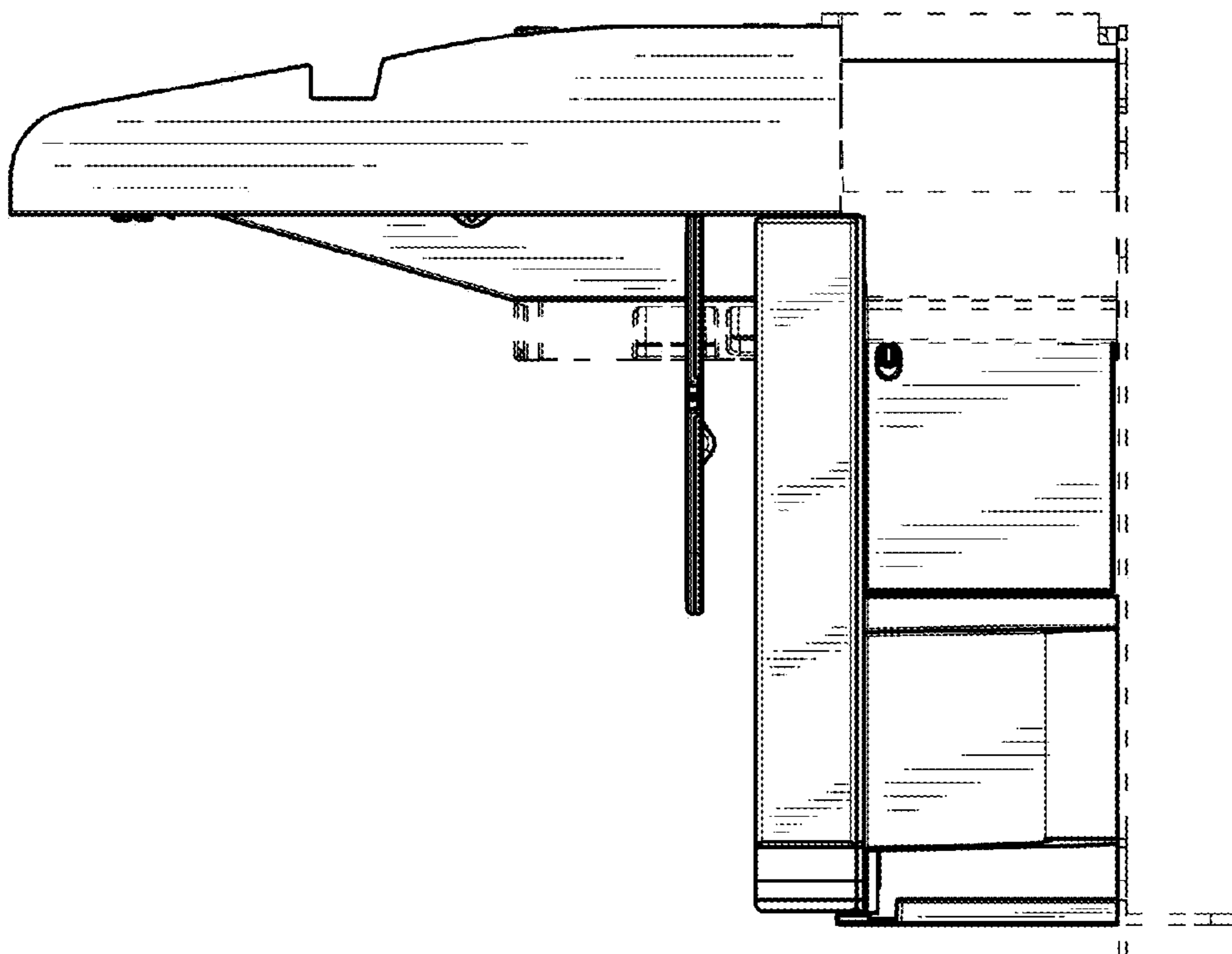

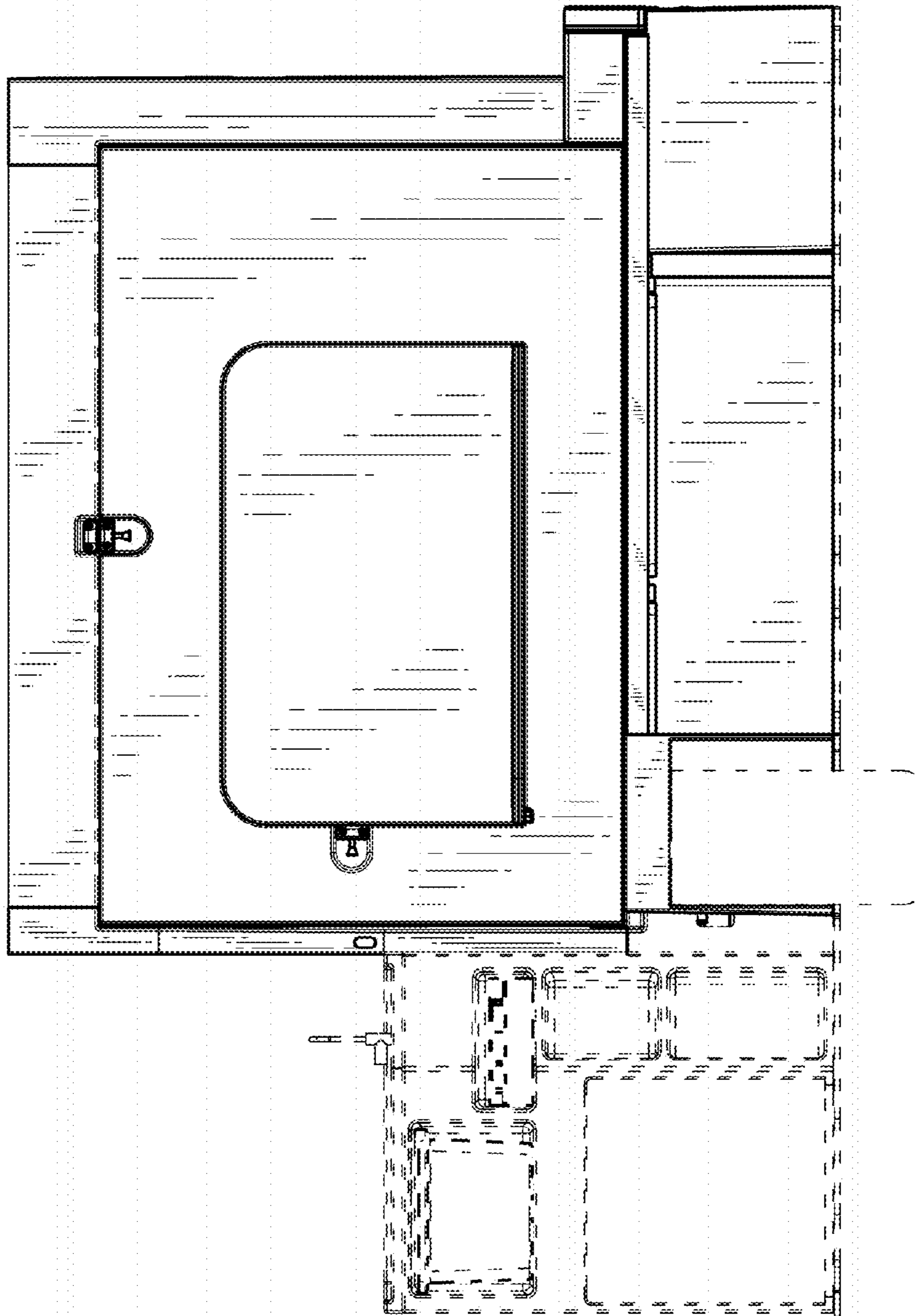

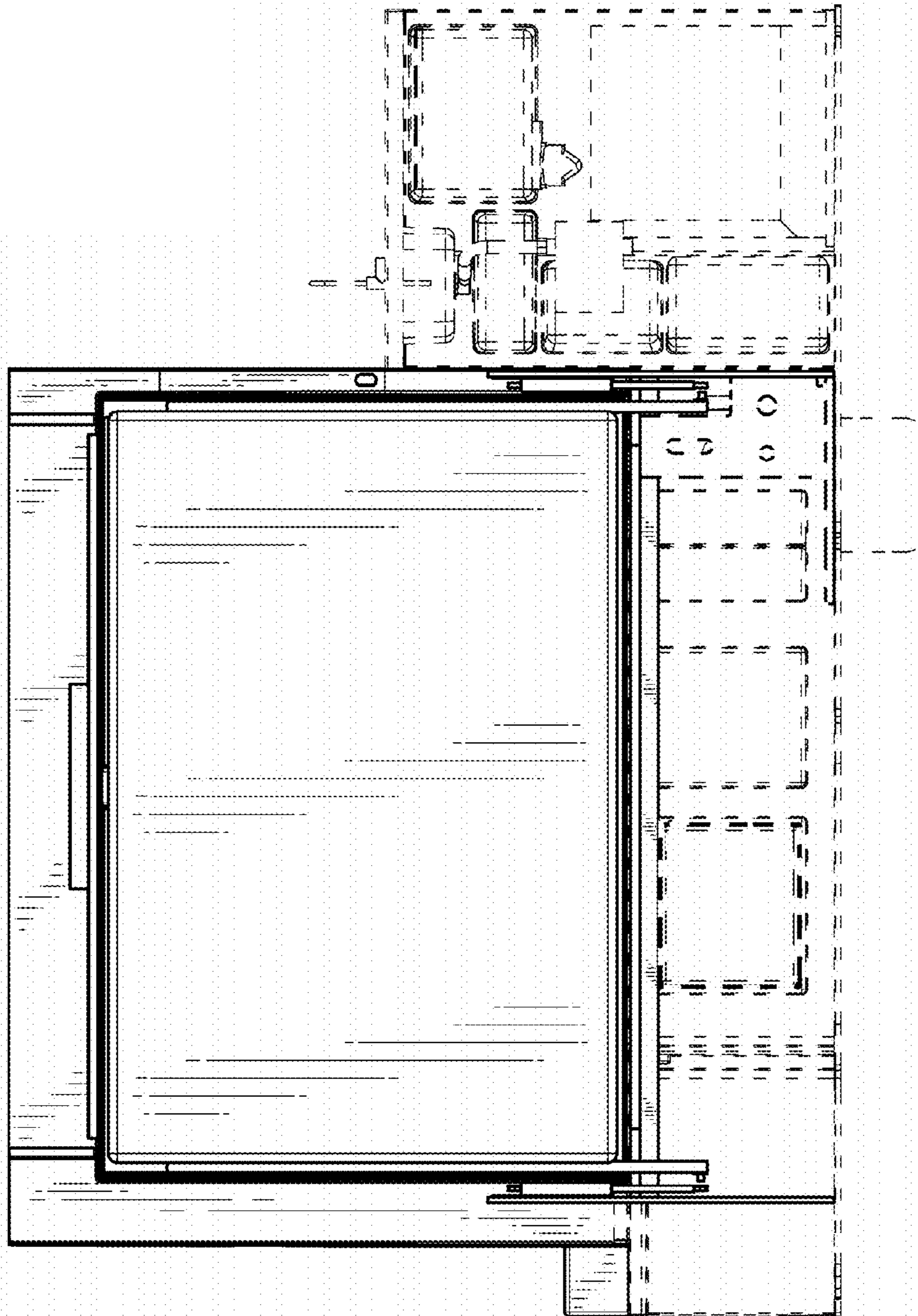
