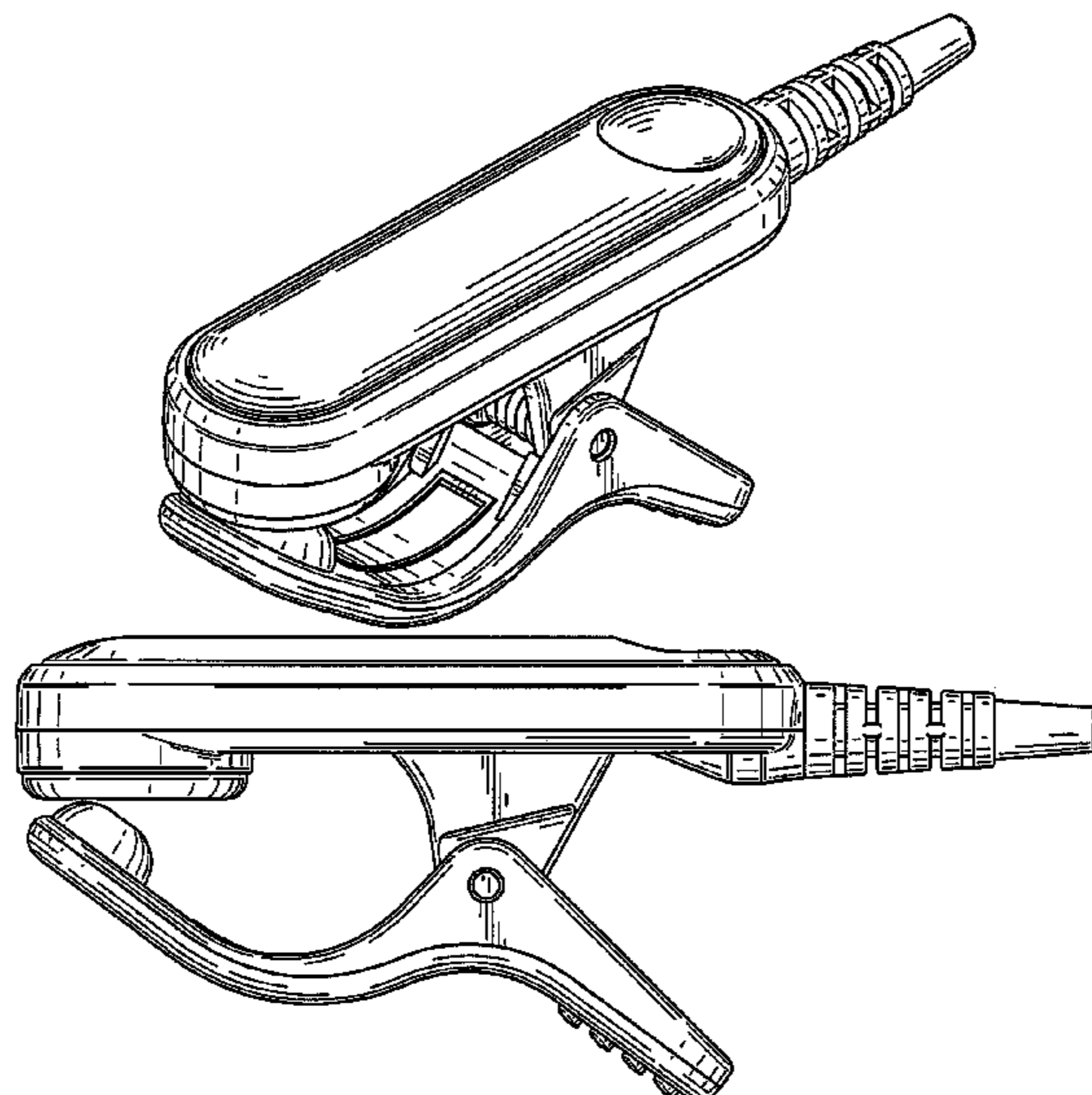

(57) **CLAIM**
The ornamental design for pickup microphone, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a pickup microphone showing my new design;
FIG. 2 is a front view thereof;
FIG. 3 is a rear view thereof;
FIG. 4 is a right side view thereof;
FIG. 5 is a top plan view thereof;
FIG. 6 is a bottom view thereof;
FIG. 7 is a front perspective view thereof in a state where a clip is open; and,
FIG. 8 is a front perspective view thereof showing a use state. The left side view is omitted as being symmetric with the right side view.
The broken lines in FIG. 3 represent the portions of the pickup microphone, while, in FIG. 8, the broken lines represent environment; all areas shown in broken line form no part of the claim.

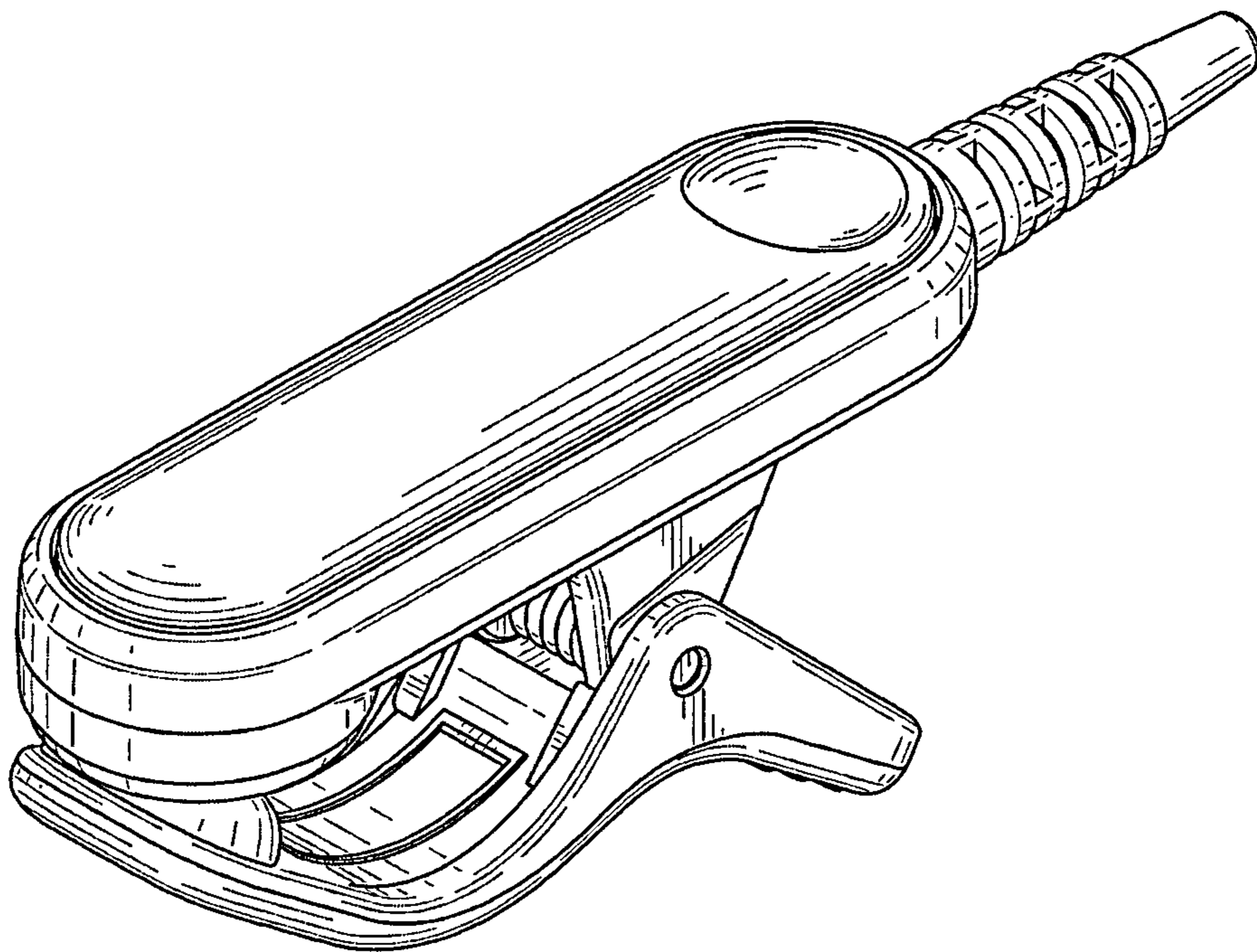

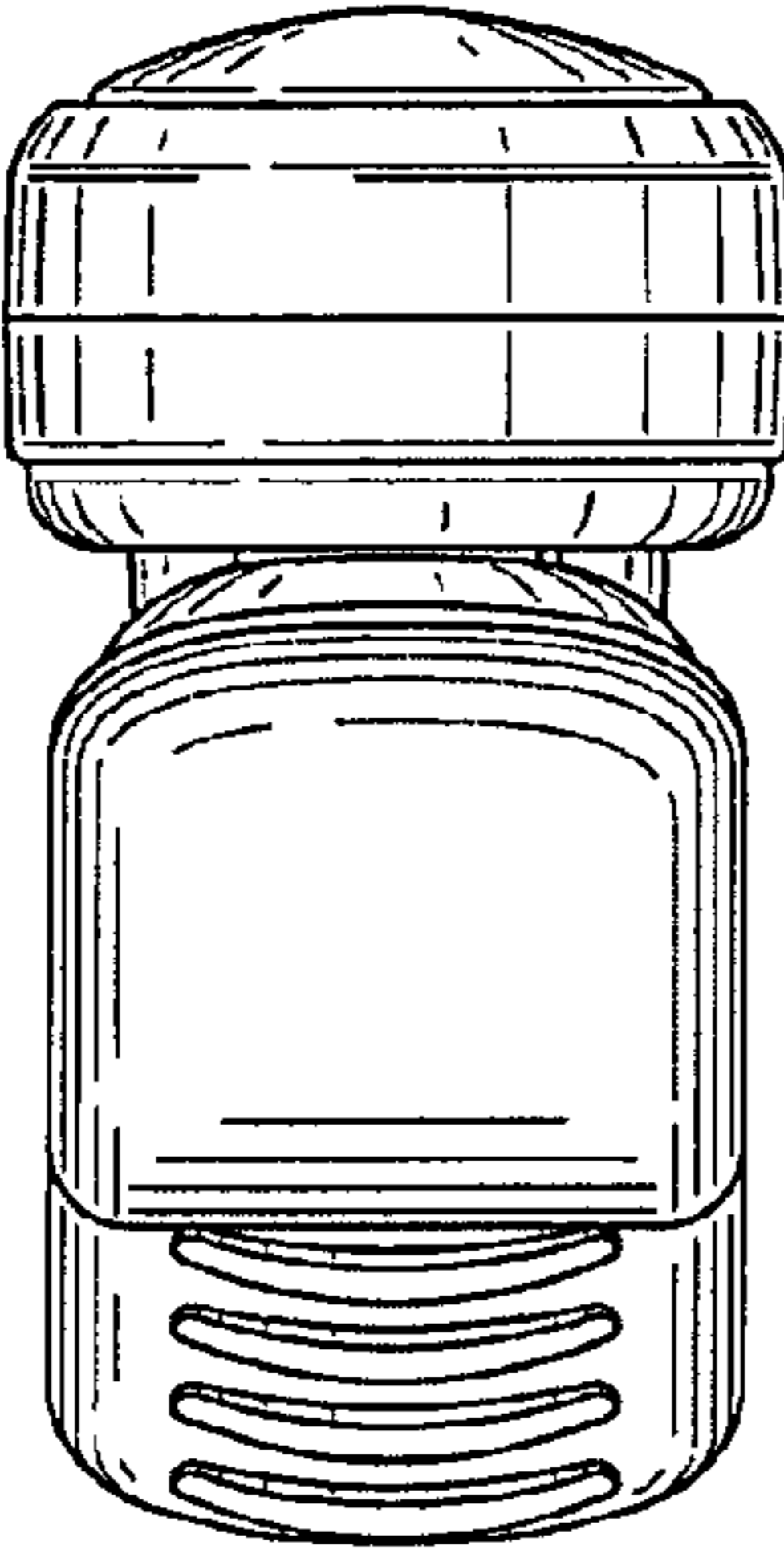

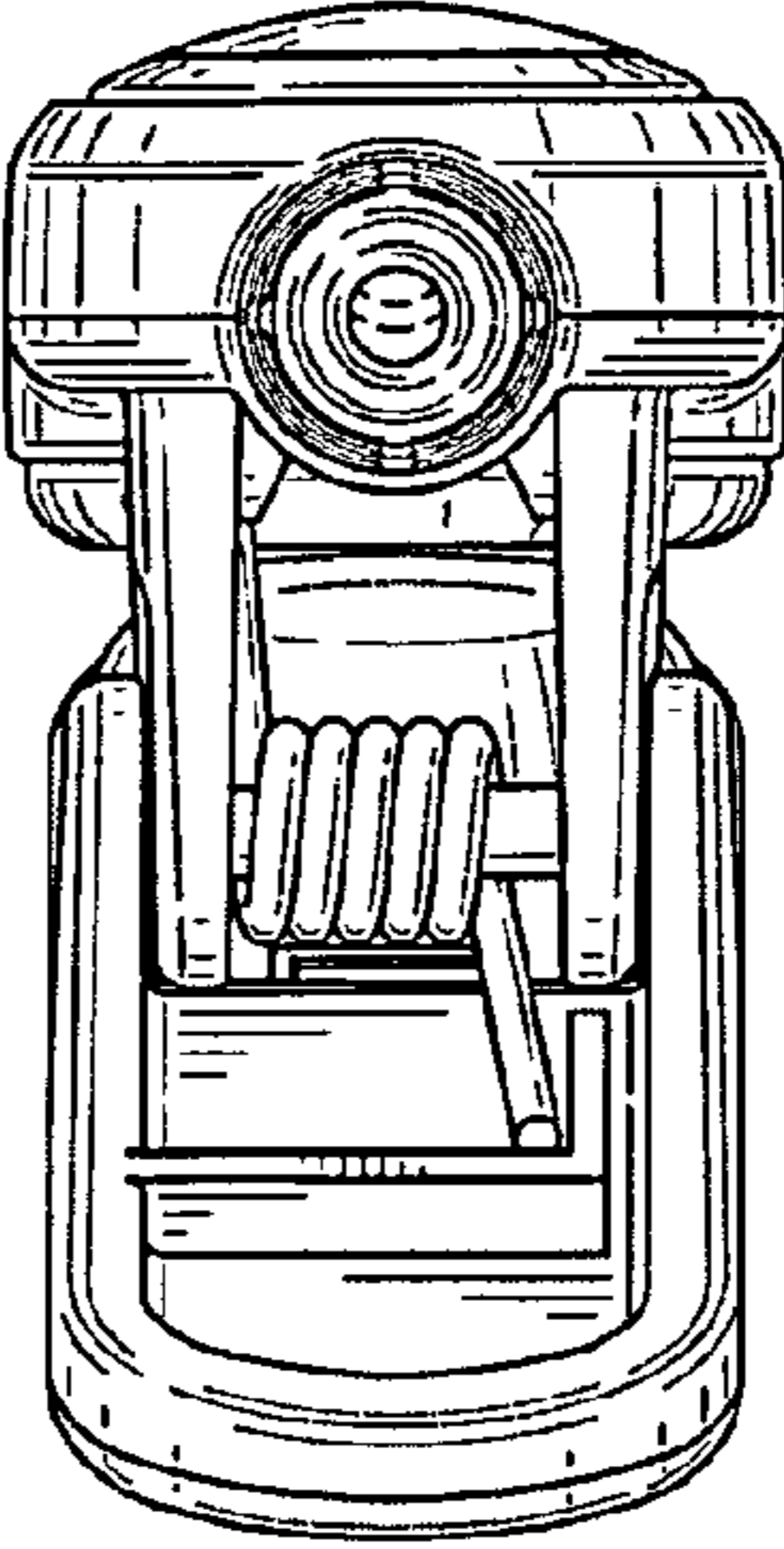

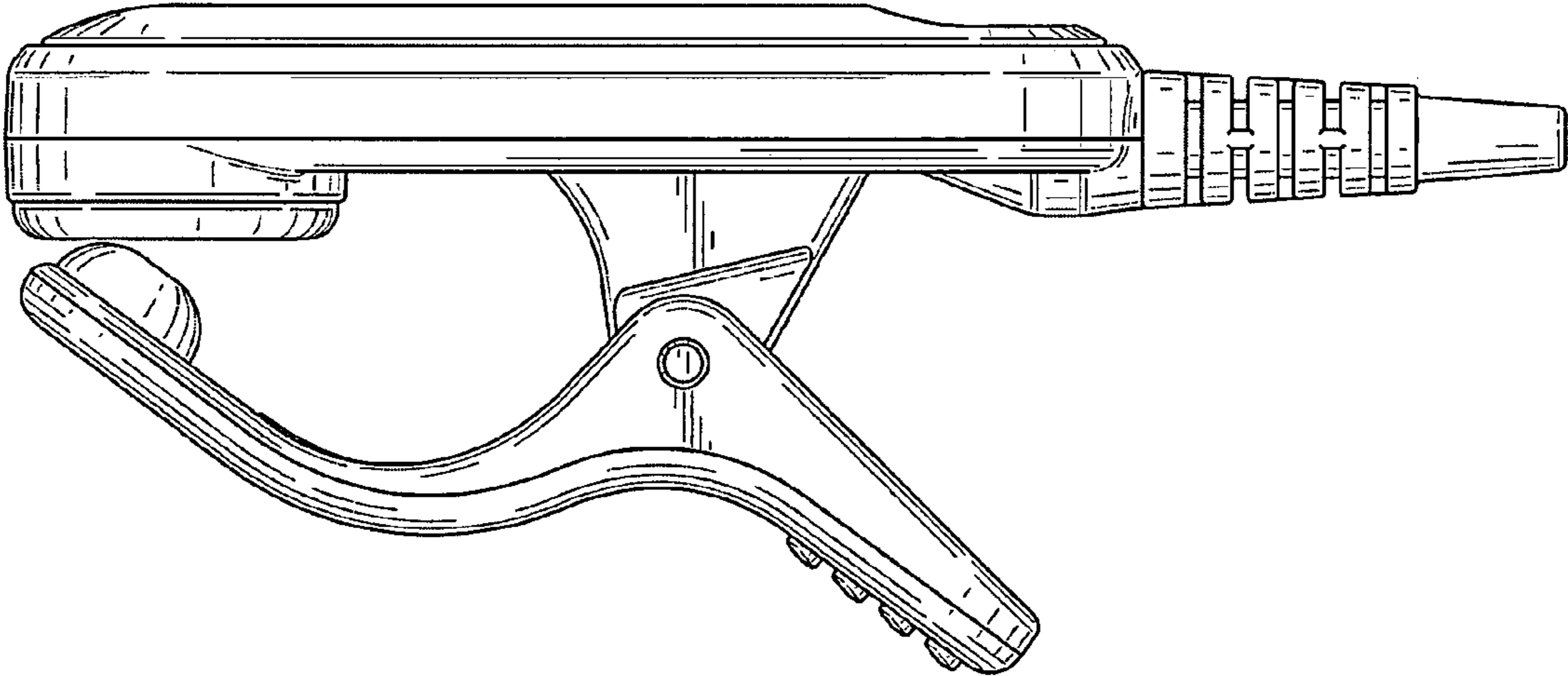

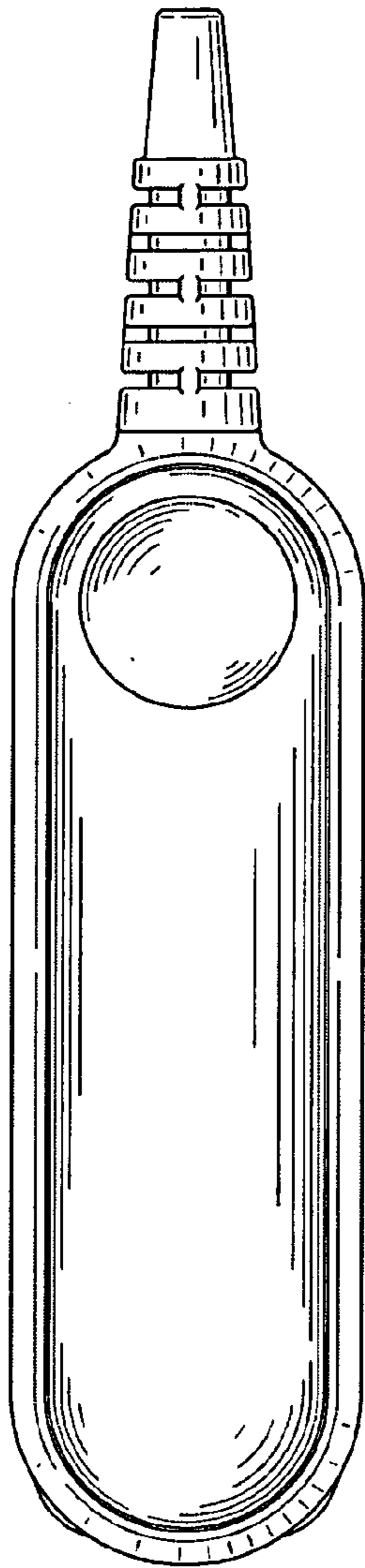

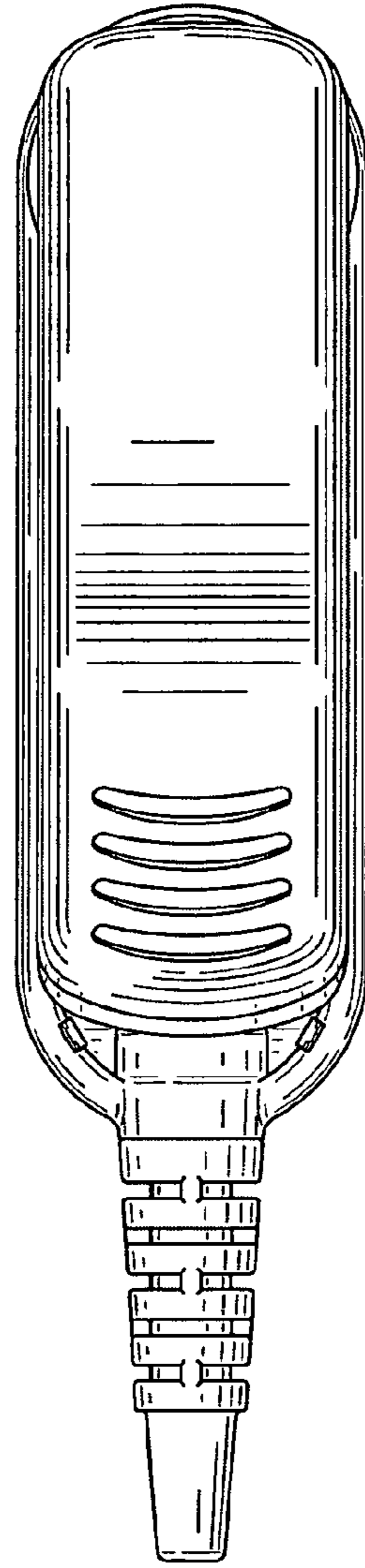

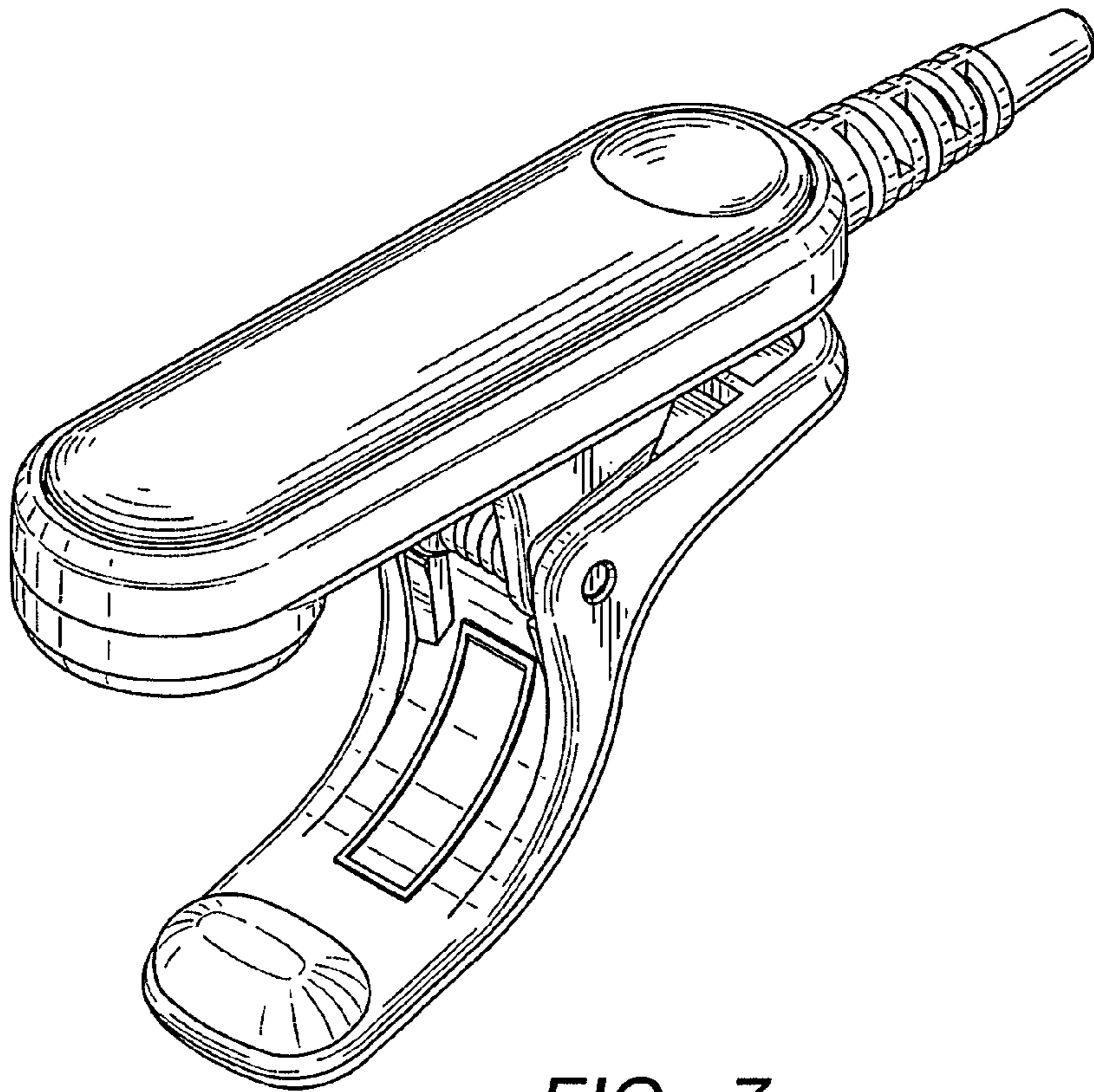

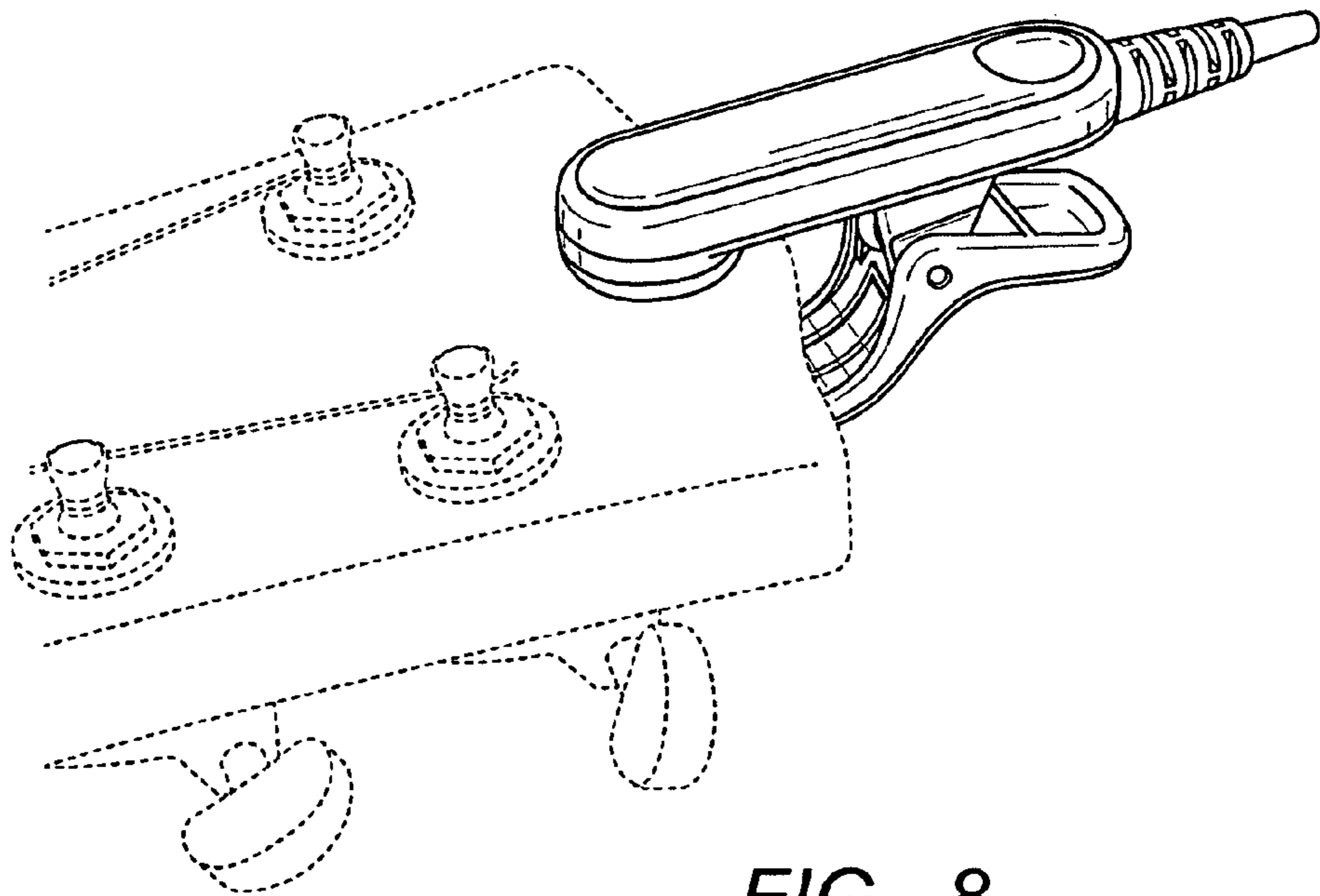
