(57) **CLAIM**

The ornamental design for a head mounted display device, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a head mounted display device showing our new design;
FIG. 2 is a front view thereof;
FIG. 3 is a rear view thereof;
FIG. 4 is a left side view thereof;
FIG. 5 is a right side view thereof;
FIG. 6 is a top plan view thereof;
FIG. 7 is a bottom plan view thereof;
FIG. 8 is a perspective view thereof, showing the display detached from the neckband;
FIG. 9 is a side view thereof, showing the article in a position of use but with the display detached from the neckband;
FIG. 10 is a side view thereof, showing the article in a position of use; and,
FIG. 11 is a front view thereof; but with a portion of the article shown as transparent.

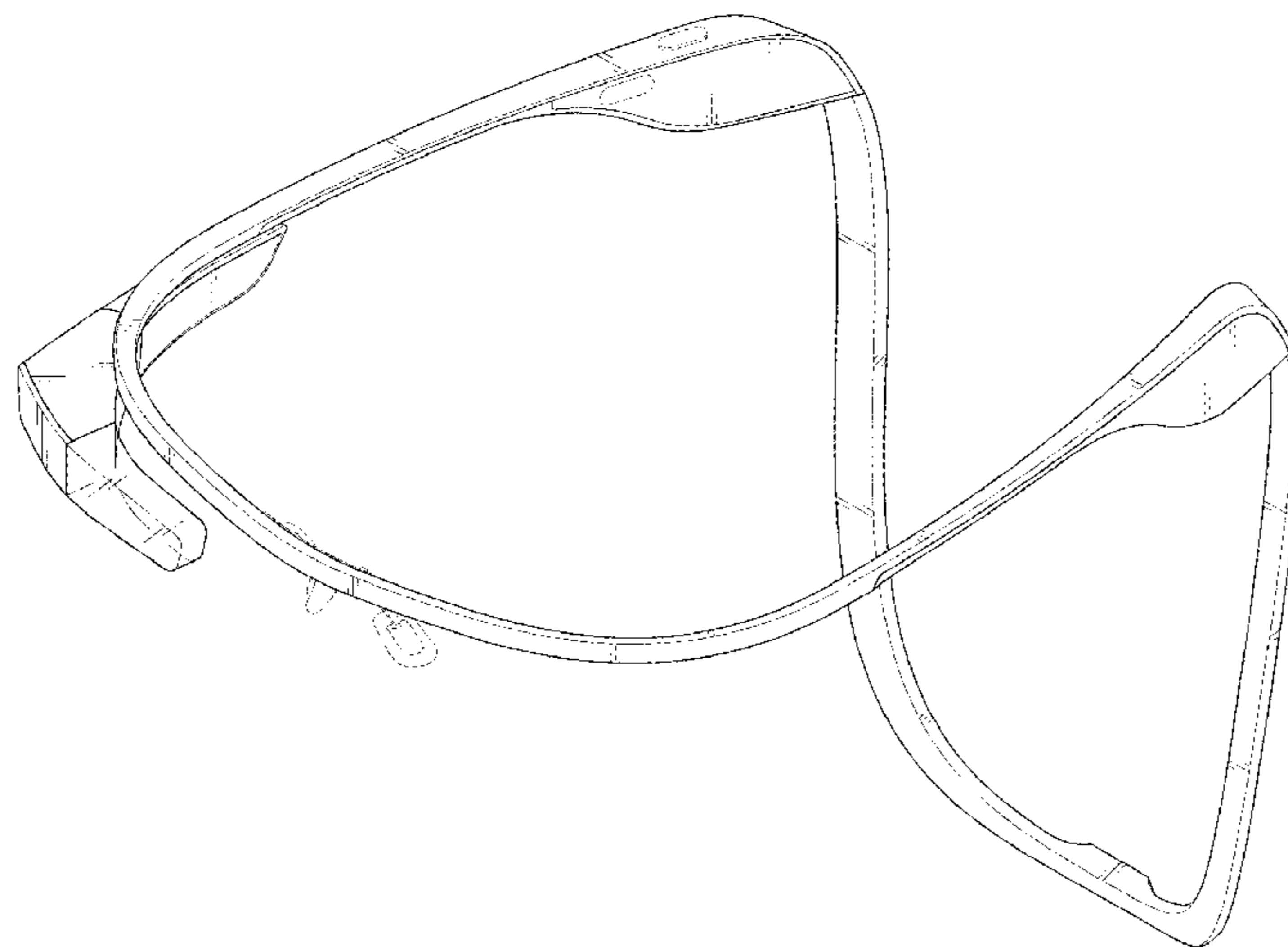

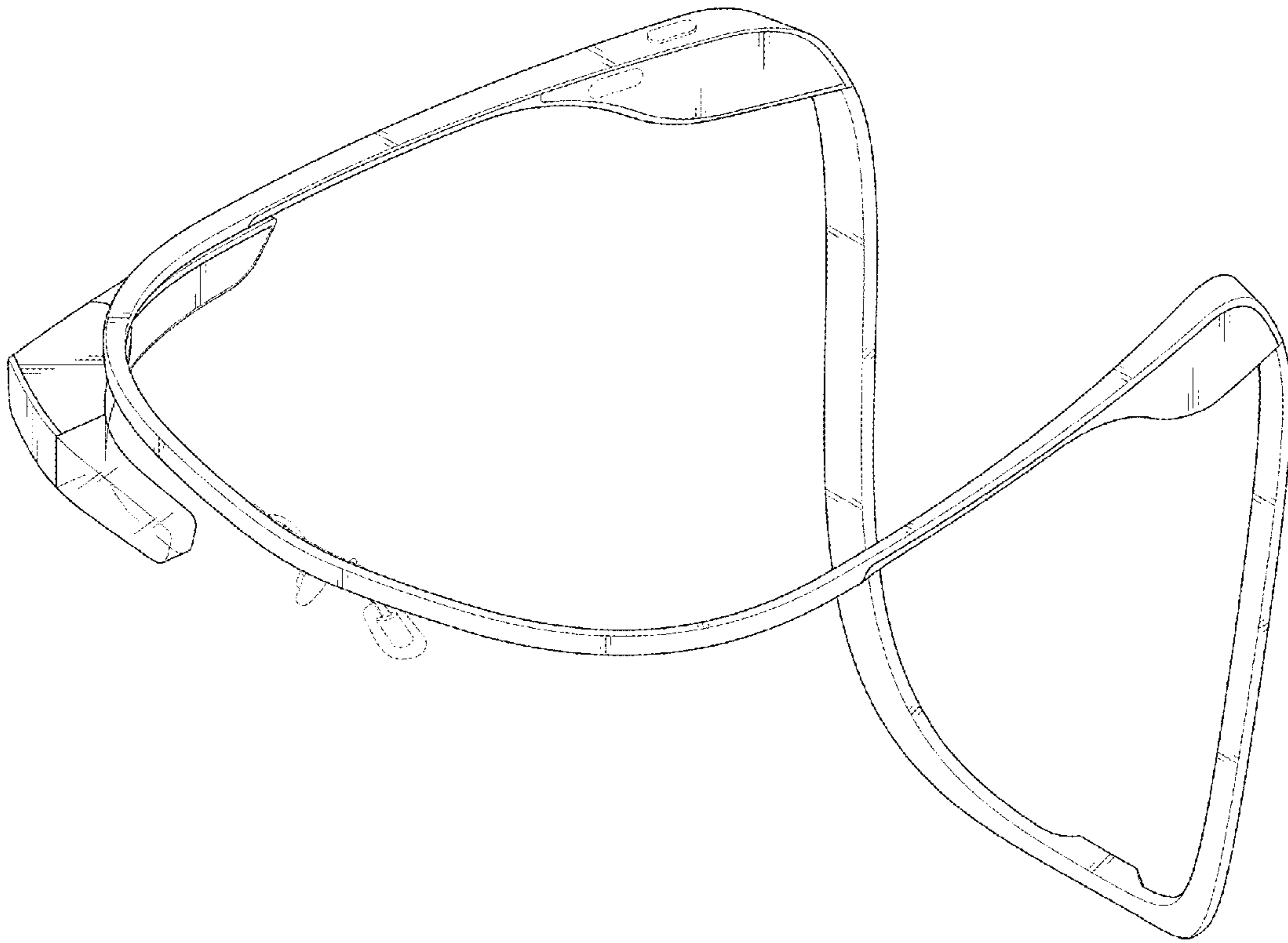

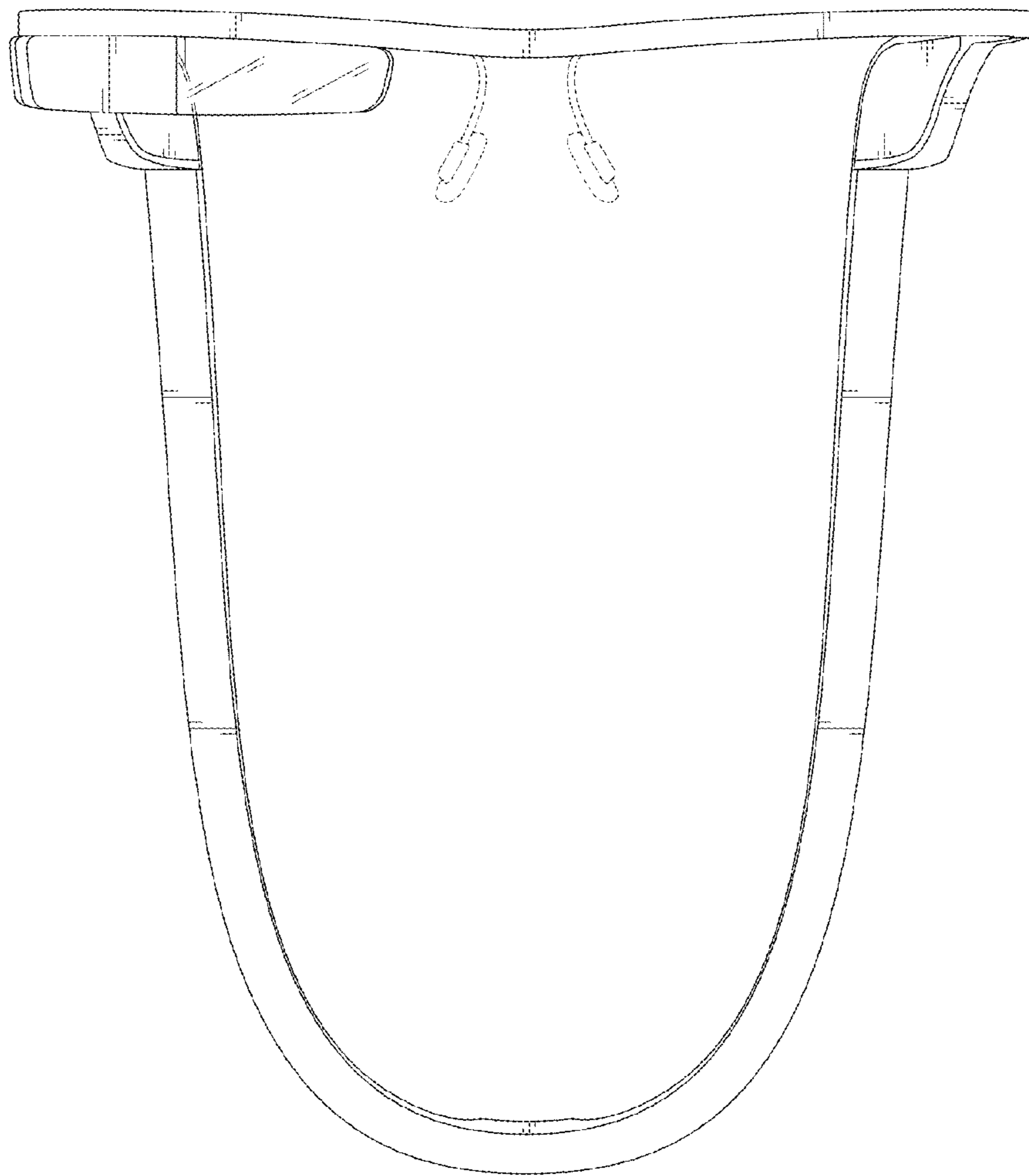

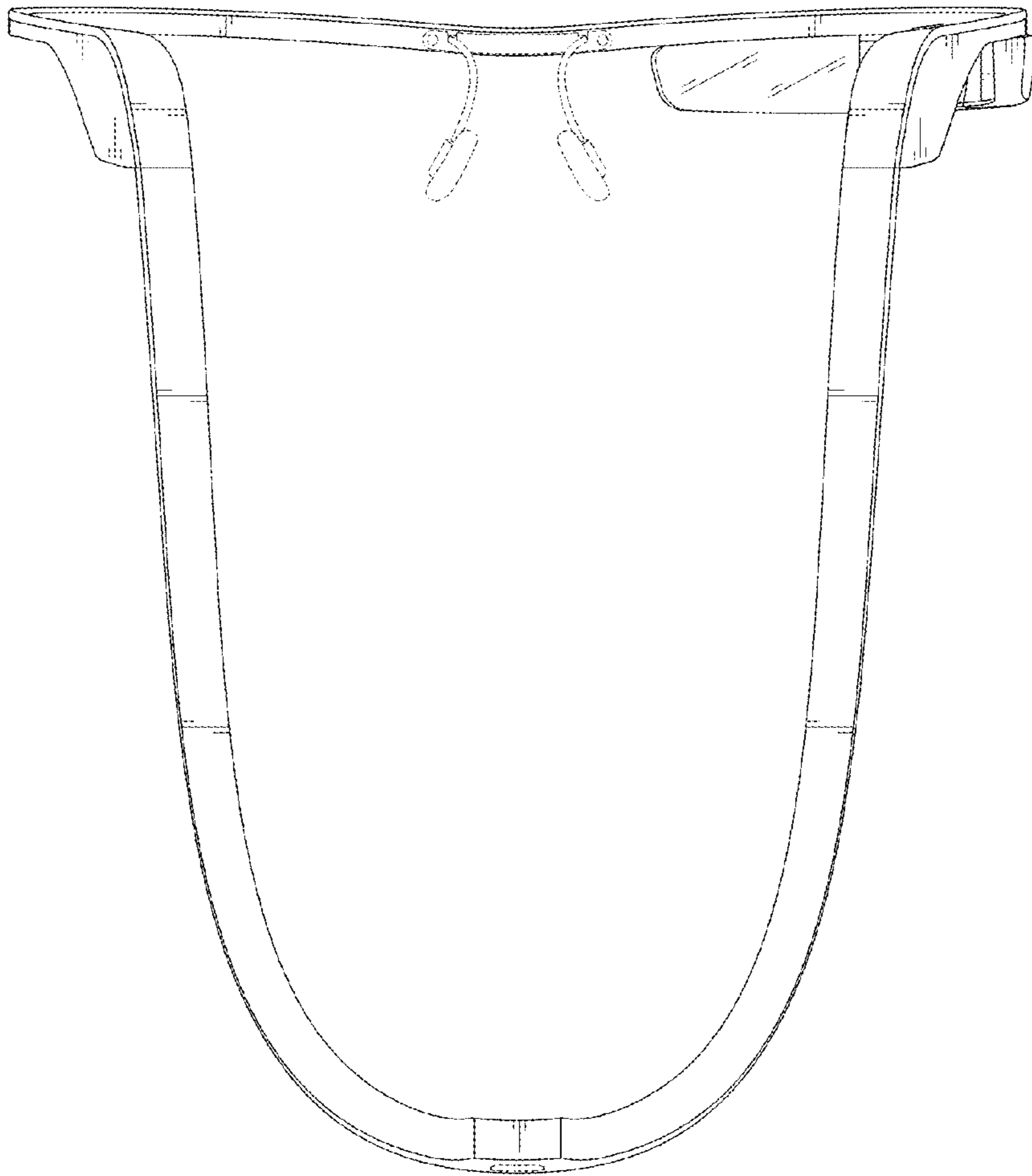

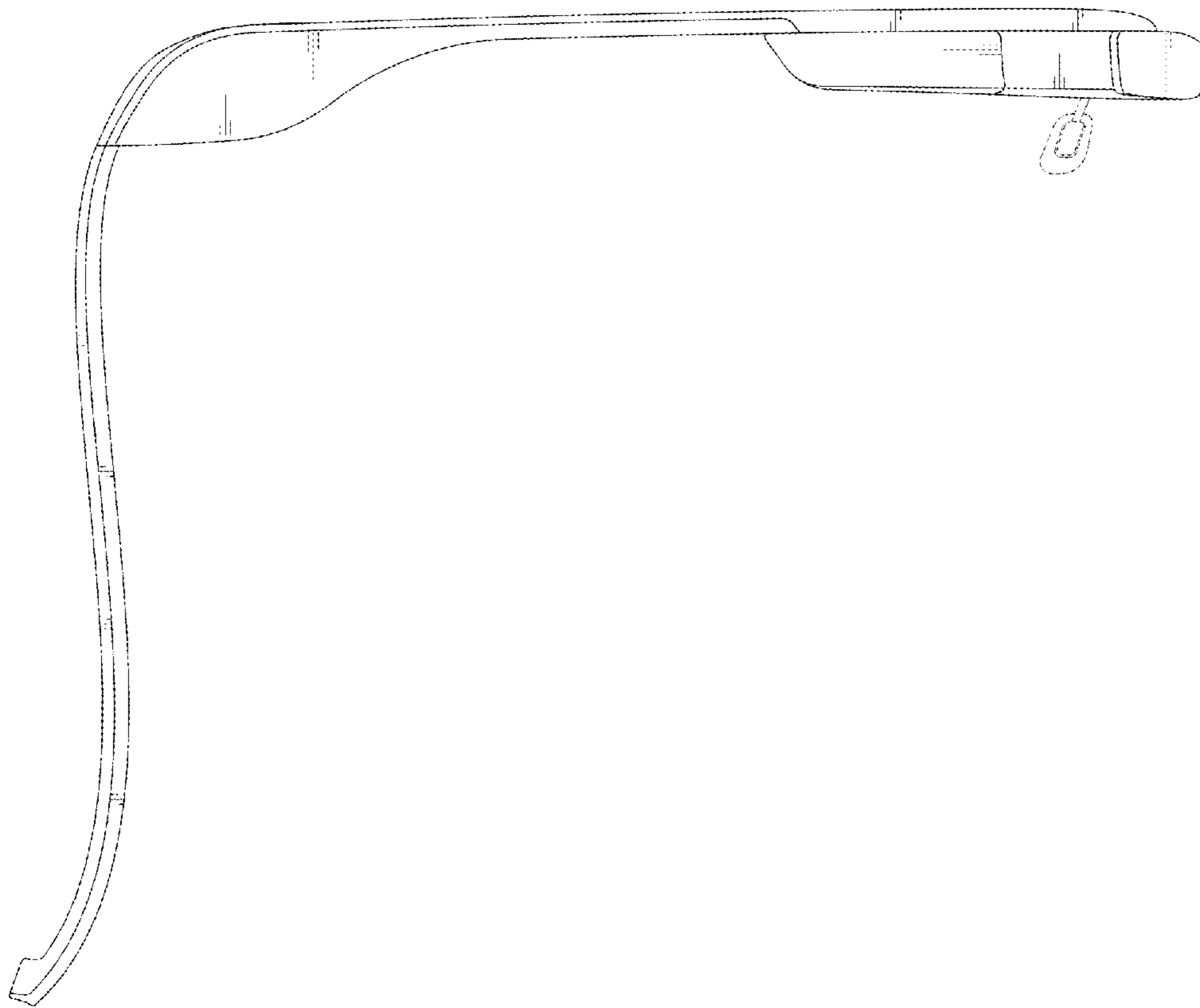

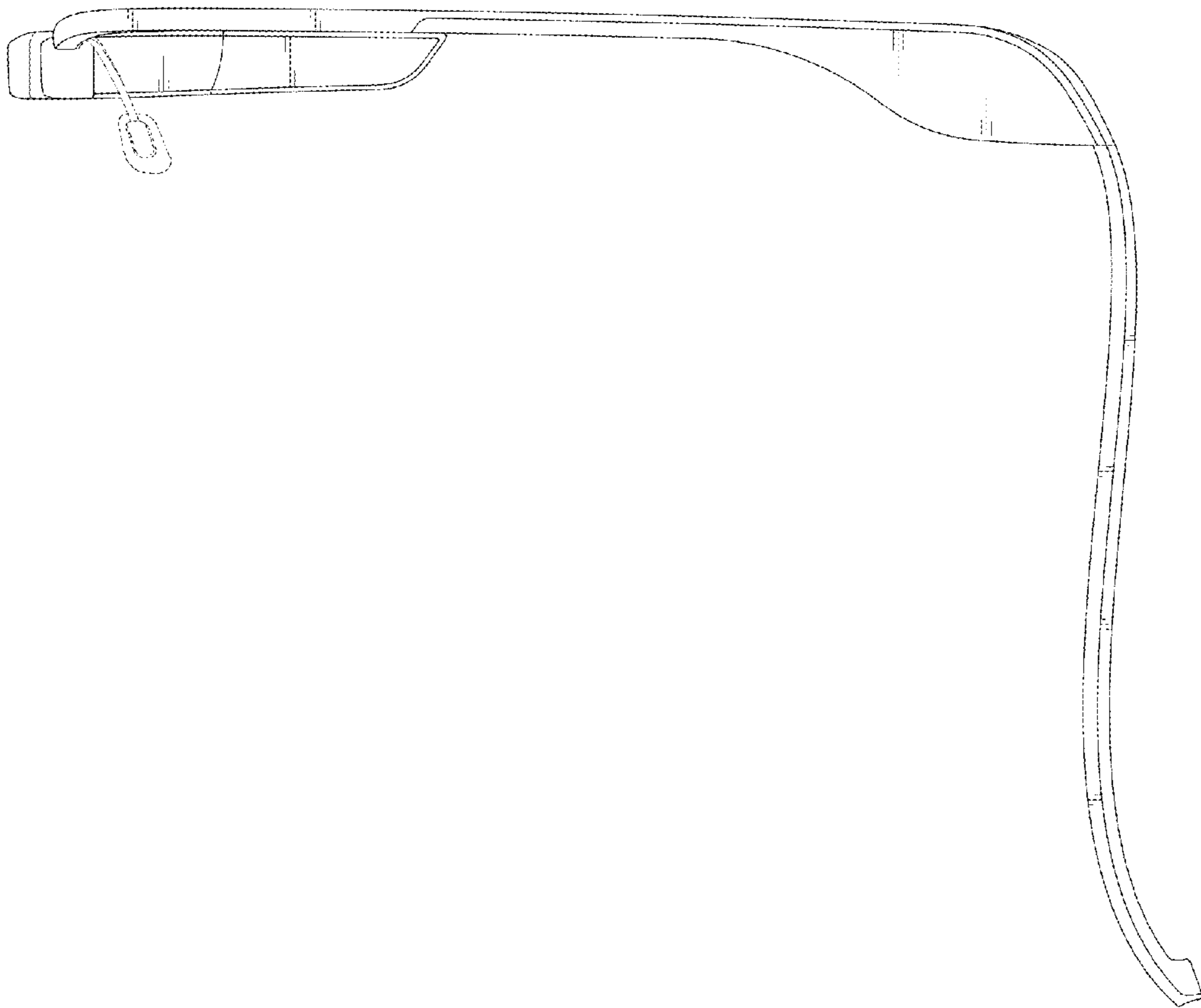

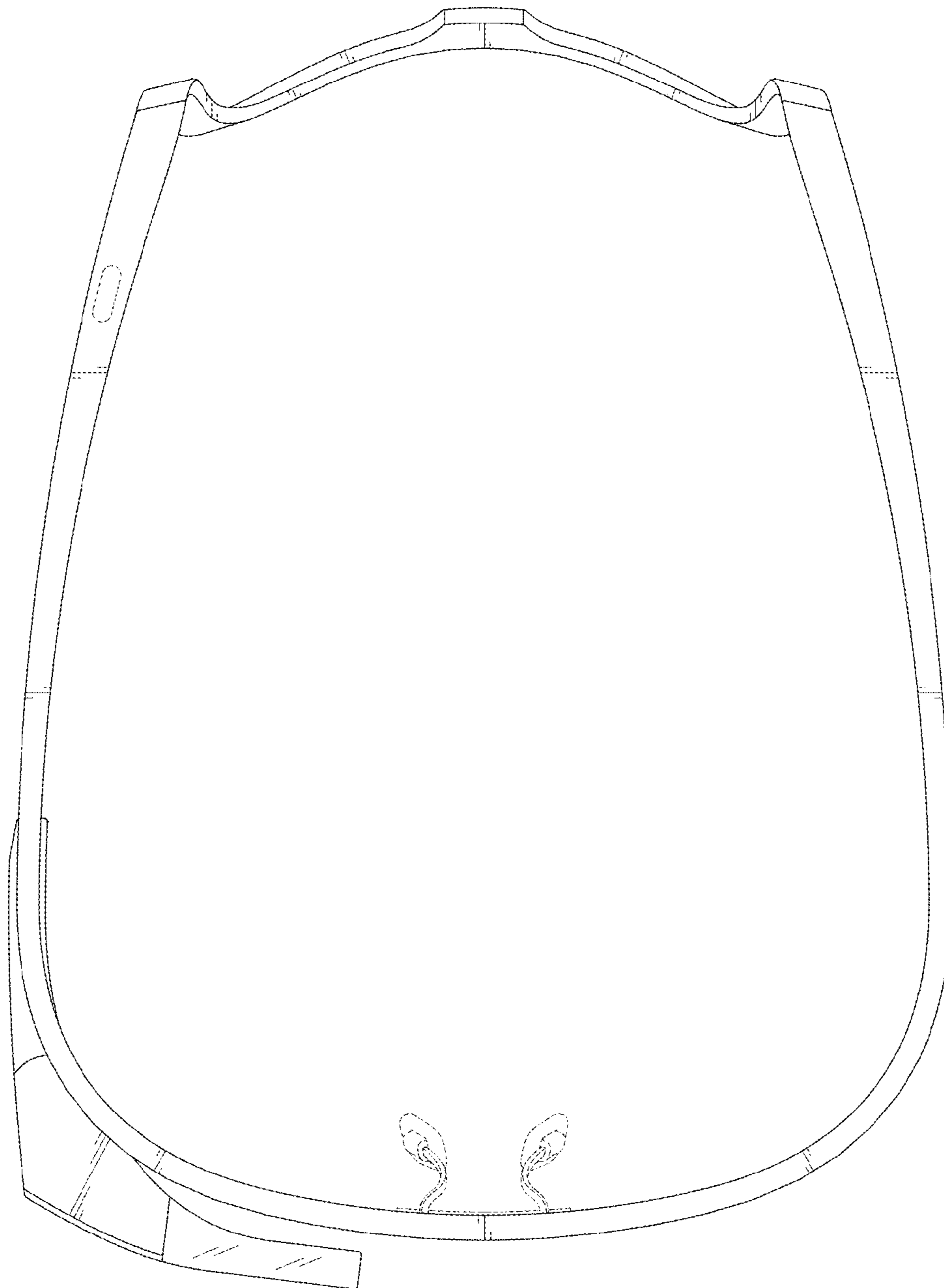

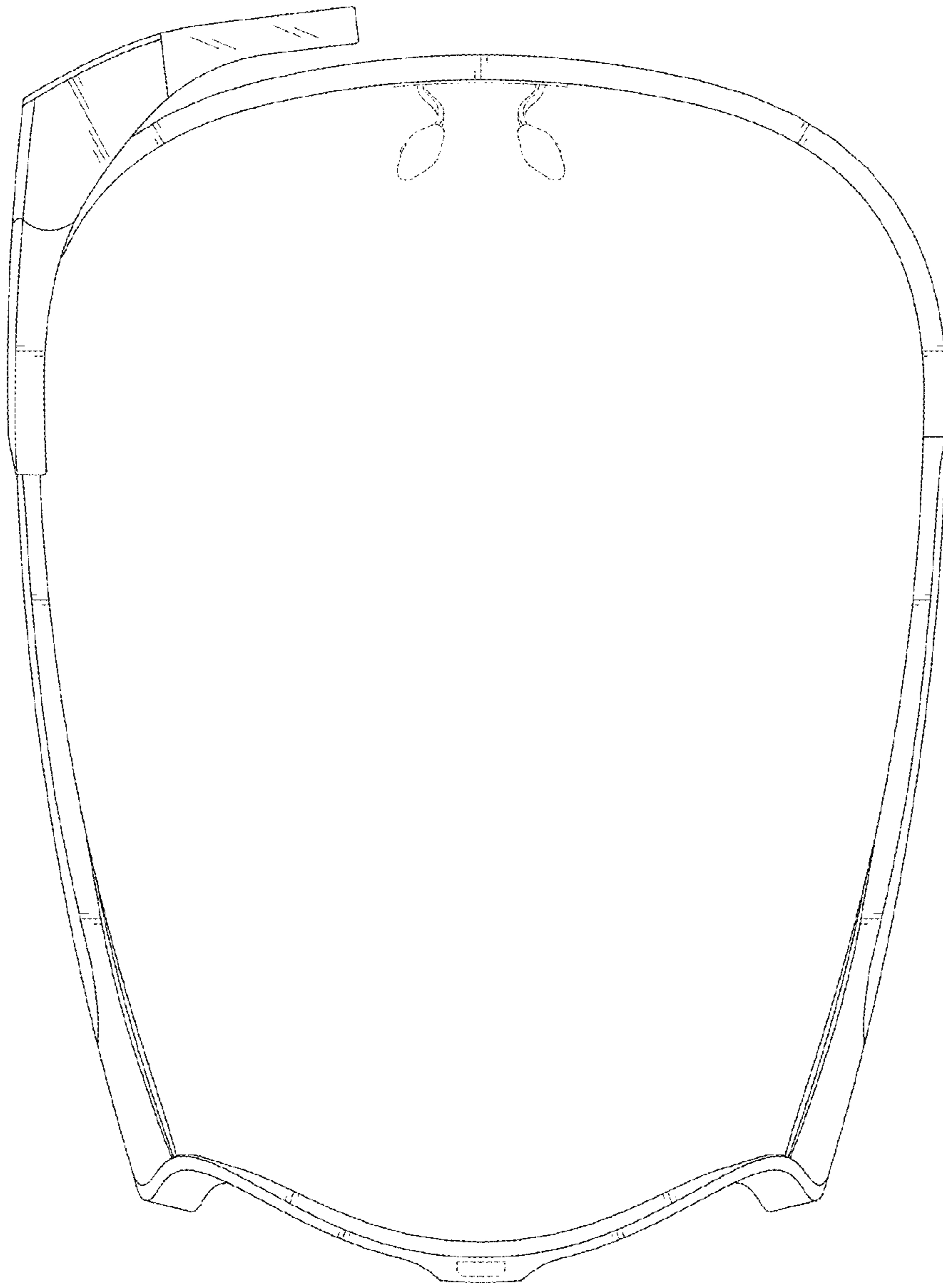

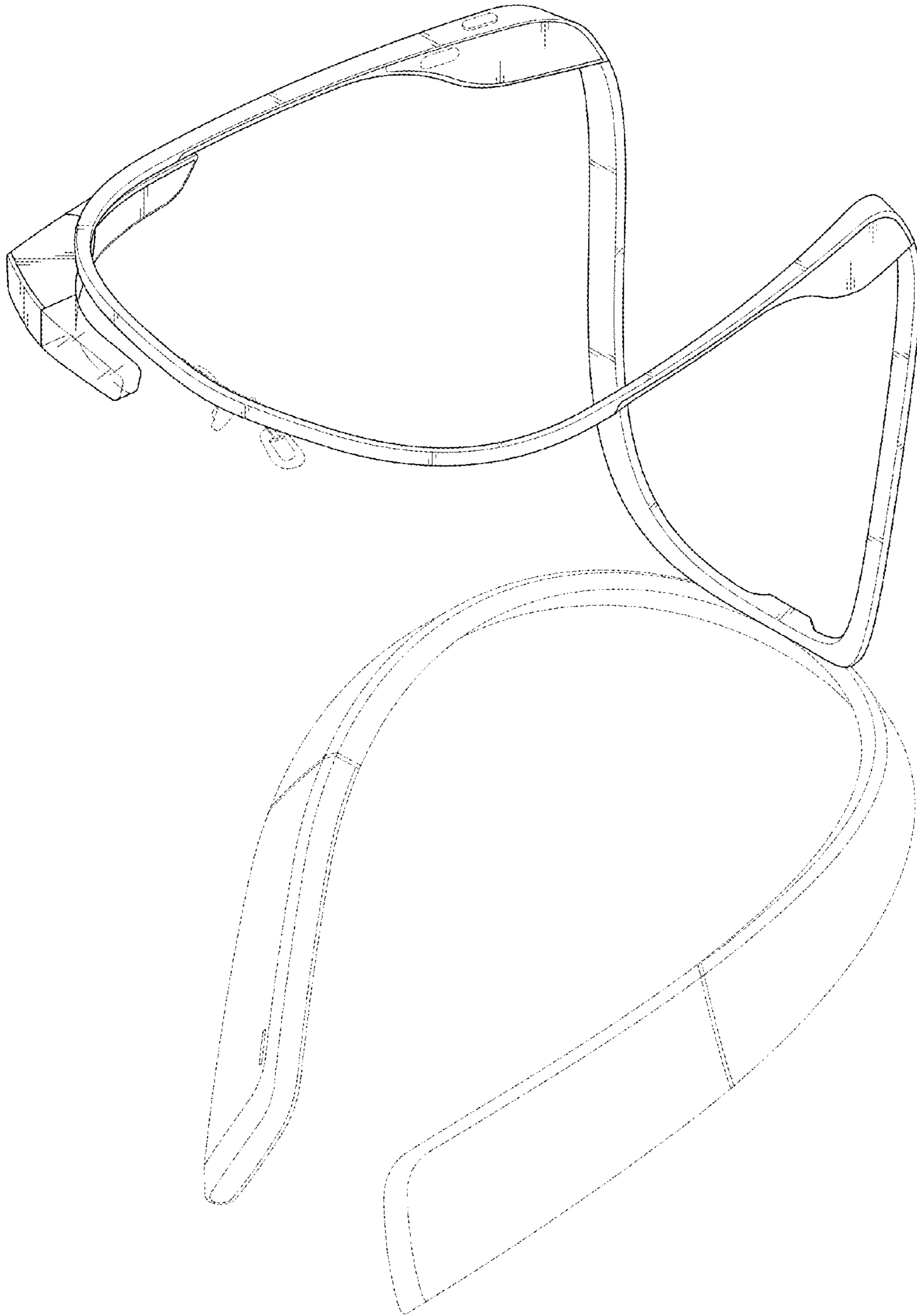

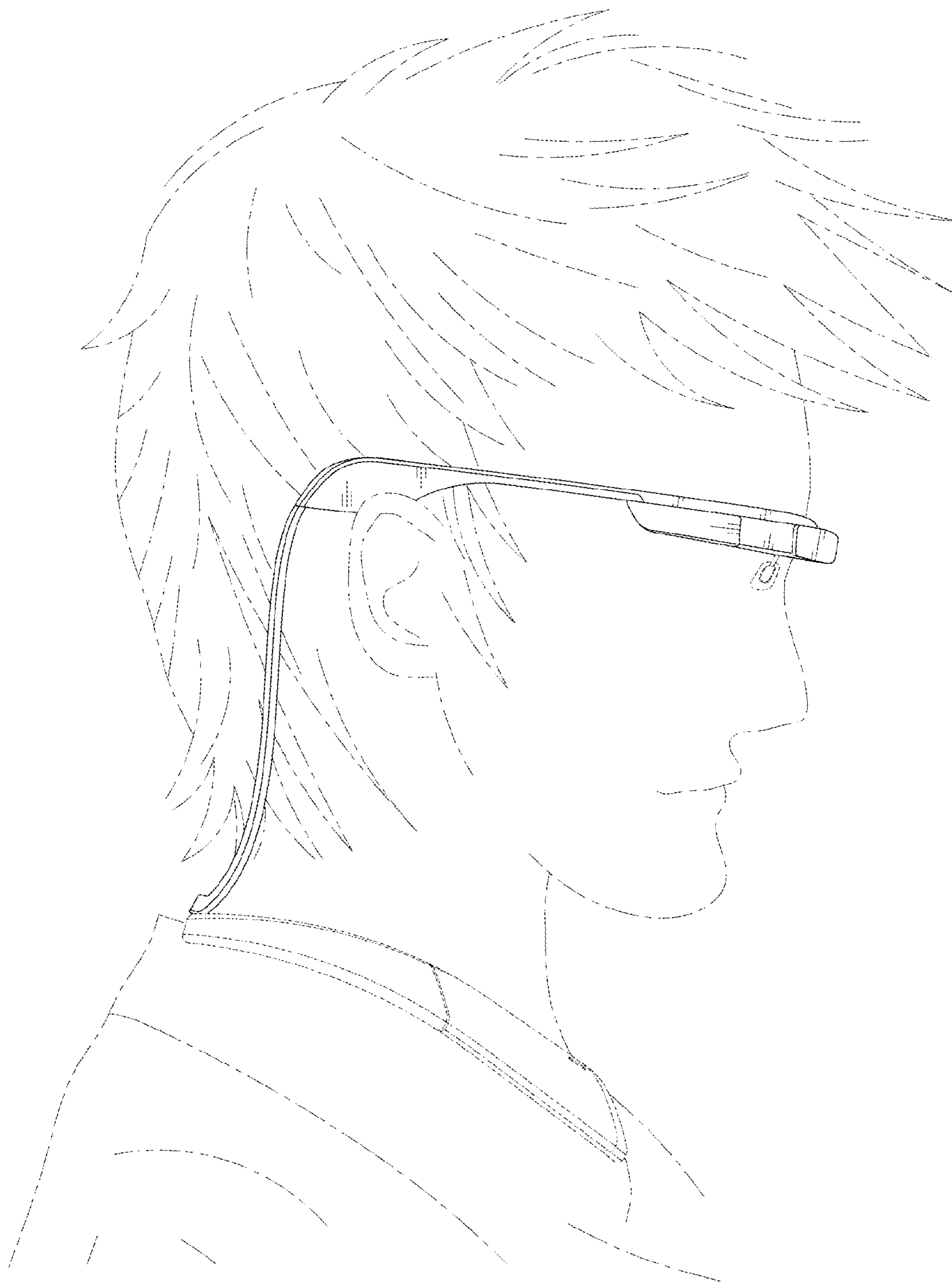

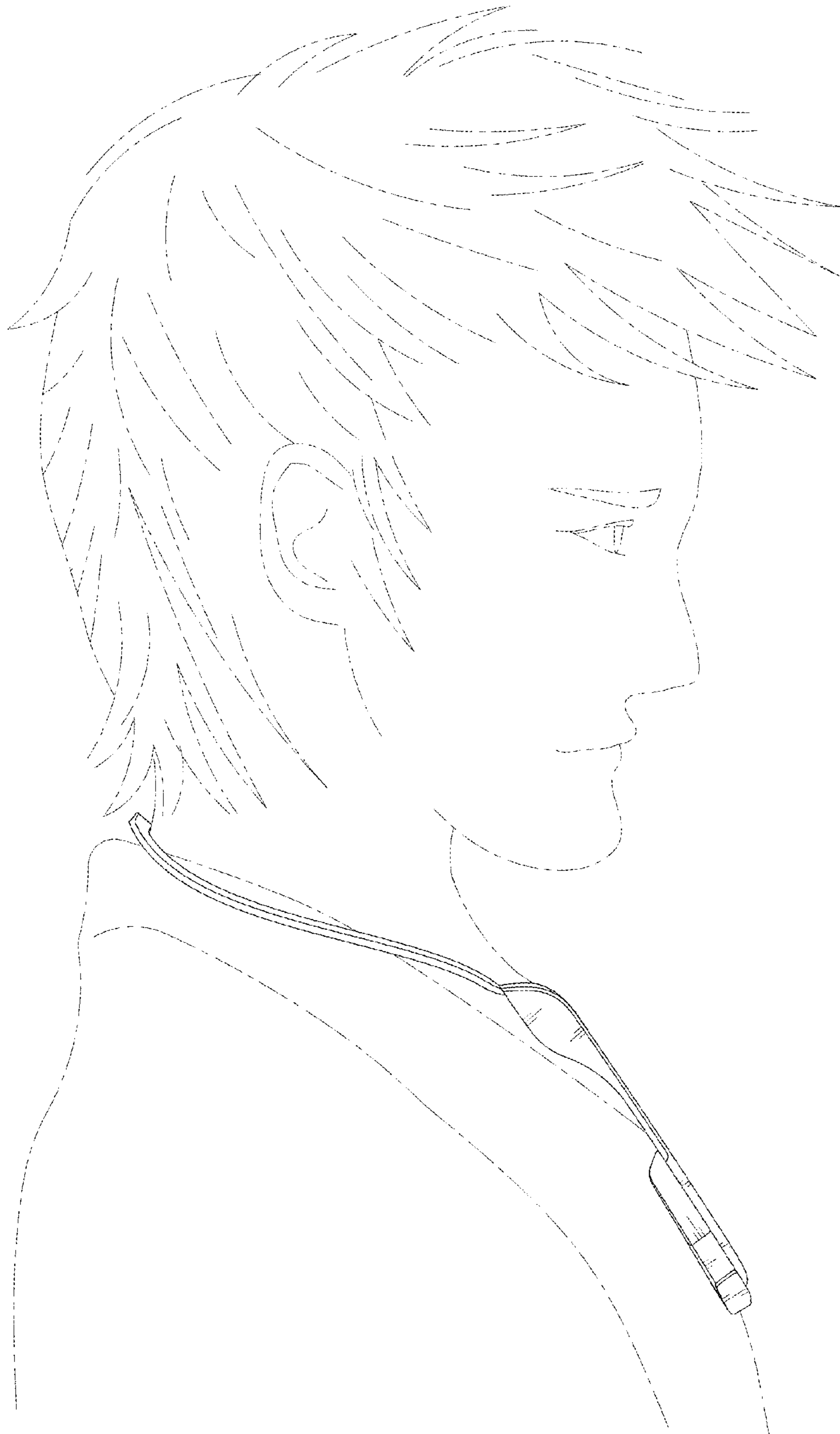
