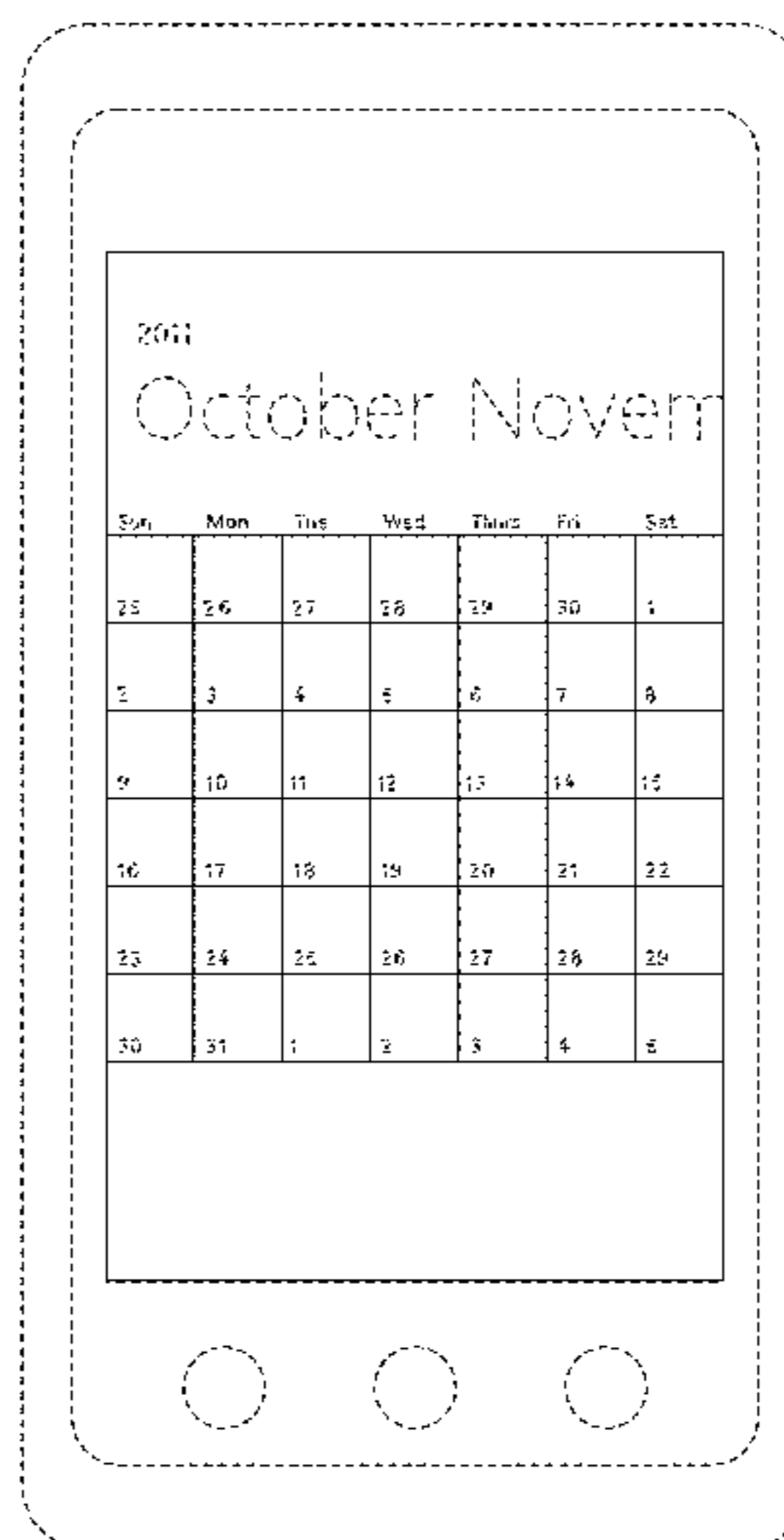
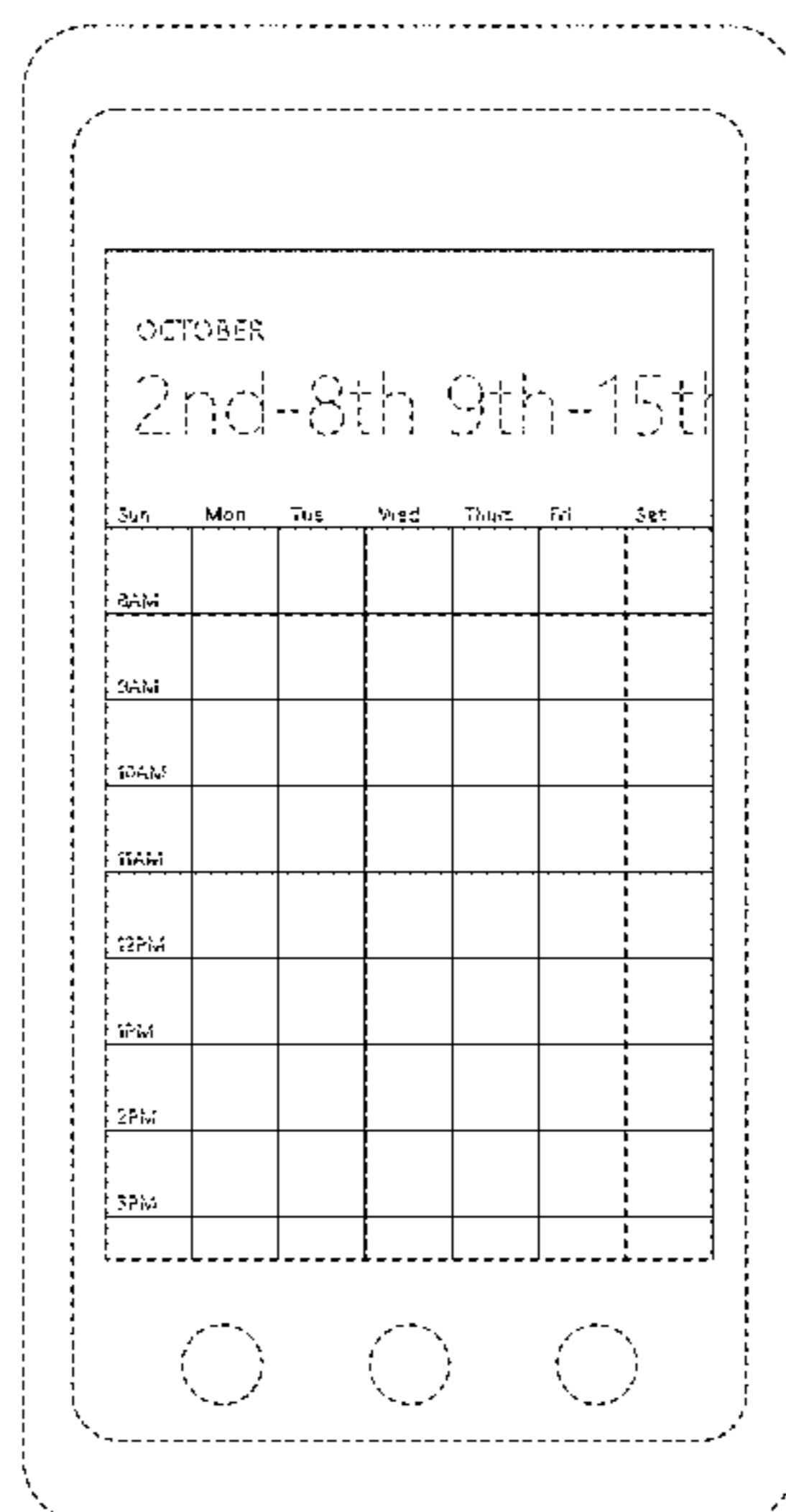
(57) **CLAIM**

The ornamental design for a display screen with animated graphical user interface, as shown and described.

DESCRIPTION

FIG. 1 is the first image in a sequence for a display screen with animated user interface showing a new design;
 FIG. 2 is the second image thereof;
 FIG. 3 is the third image thereof;
 FIG. 4 is the fourth image thereof;
 FIG. 5 is the fifth image thereof;
 FIG. 6 is the sixth image thereof; and,
 FIGS. 7-12 show the display screen with animated graphical user interface of FIGS. 1-6 on a device.
 The broken line showing of the text in all views and the device having the display screen in FIGS. 7-12 is for environmental purposes only and forms no part of the claimed design.
 The appearance of the animated graphical user interface sequentially transitions between the images shown in FIGS. 1-6 and in FIGS. 7-12. The process or period in which one image transitions to another forms no part of the claimed design.

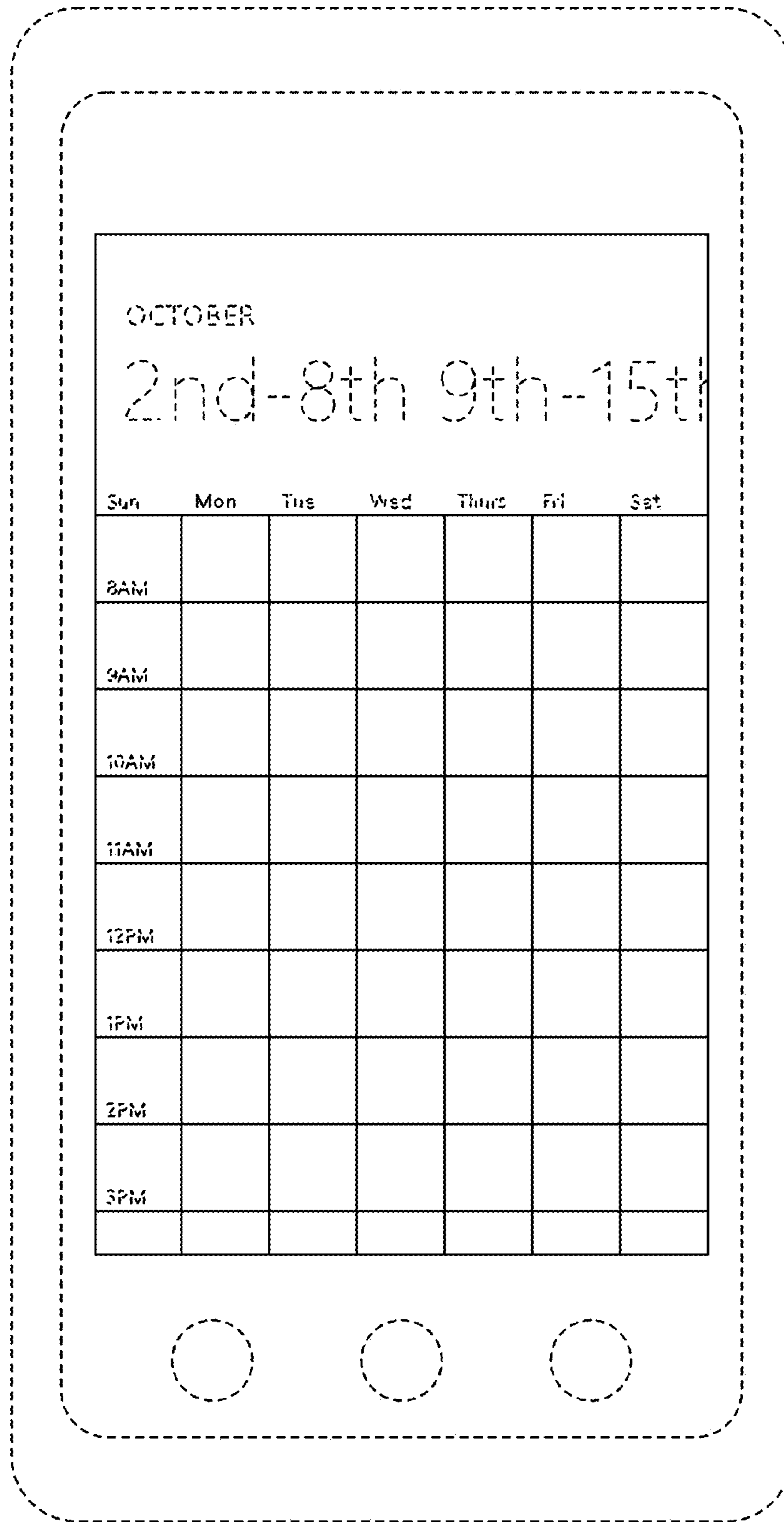

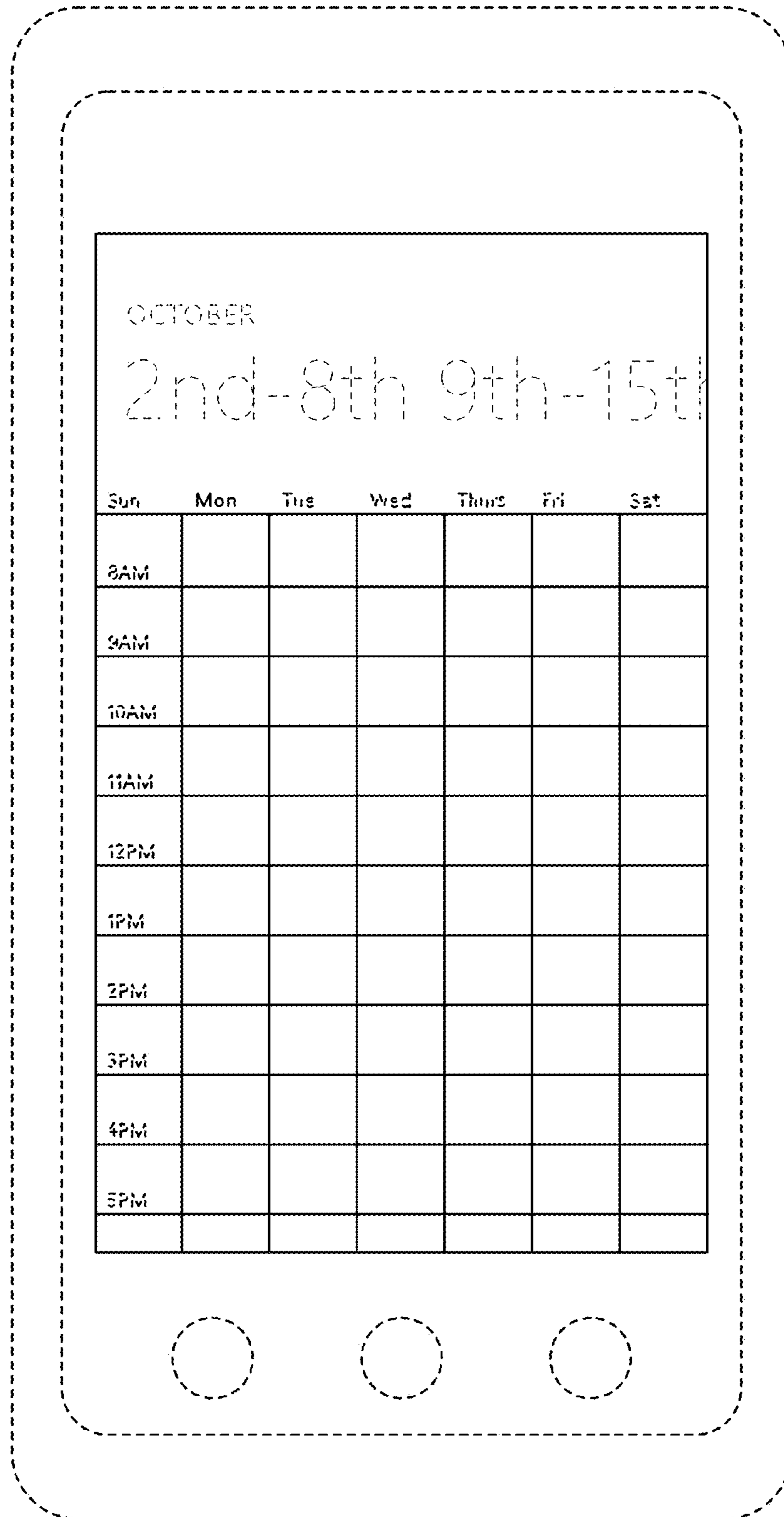

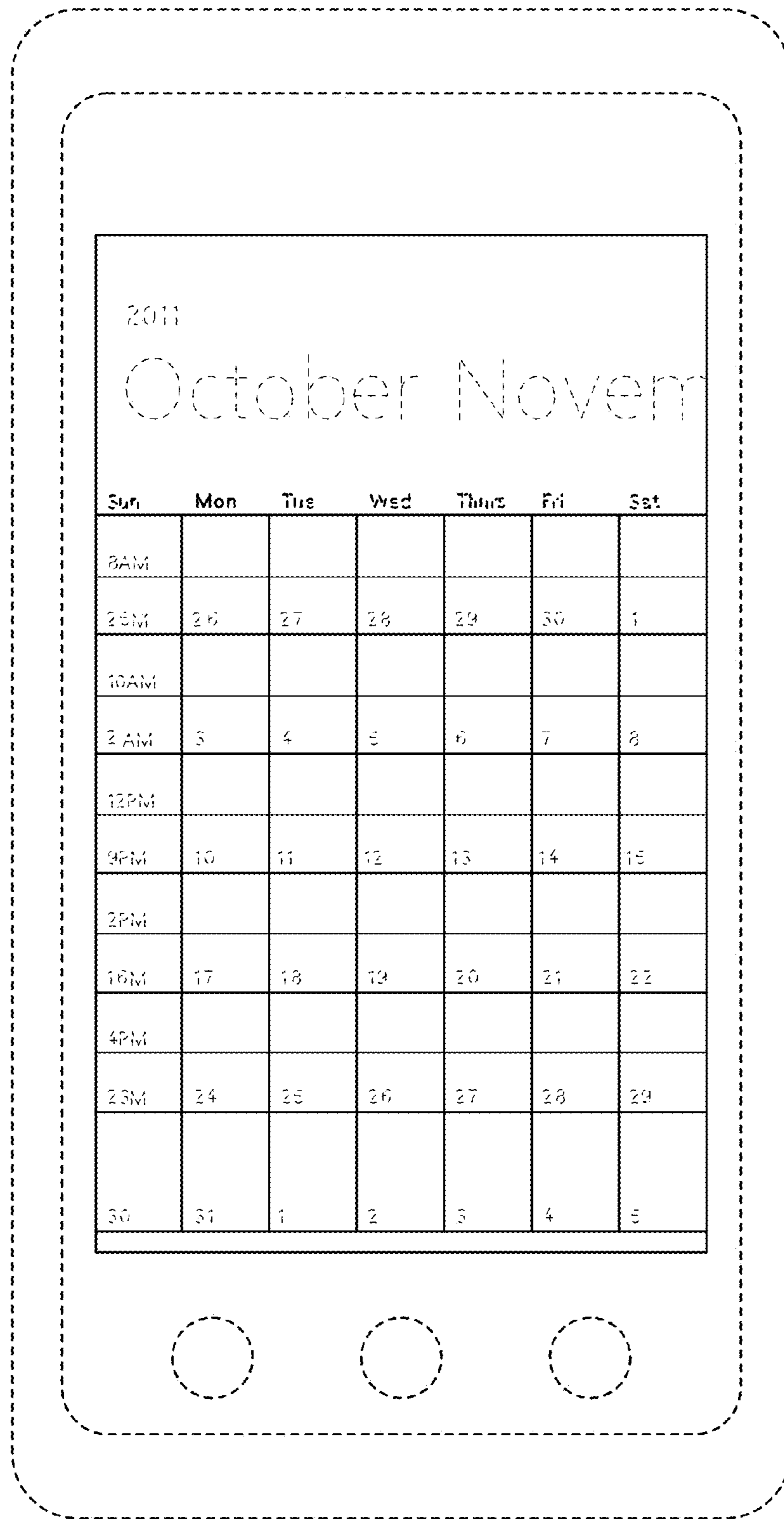

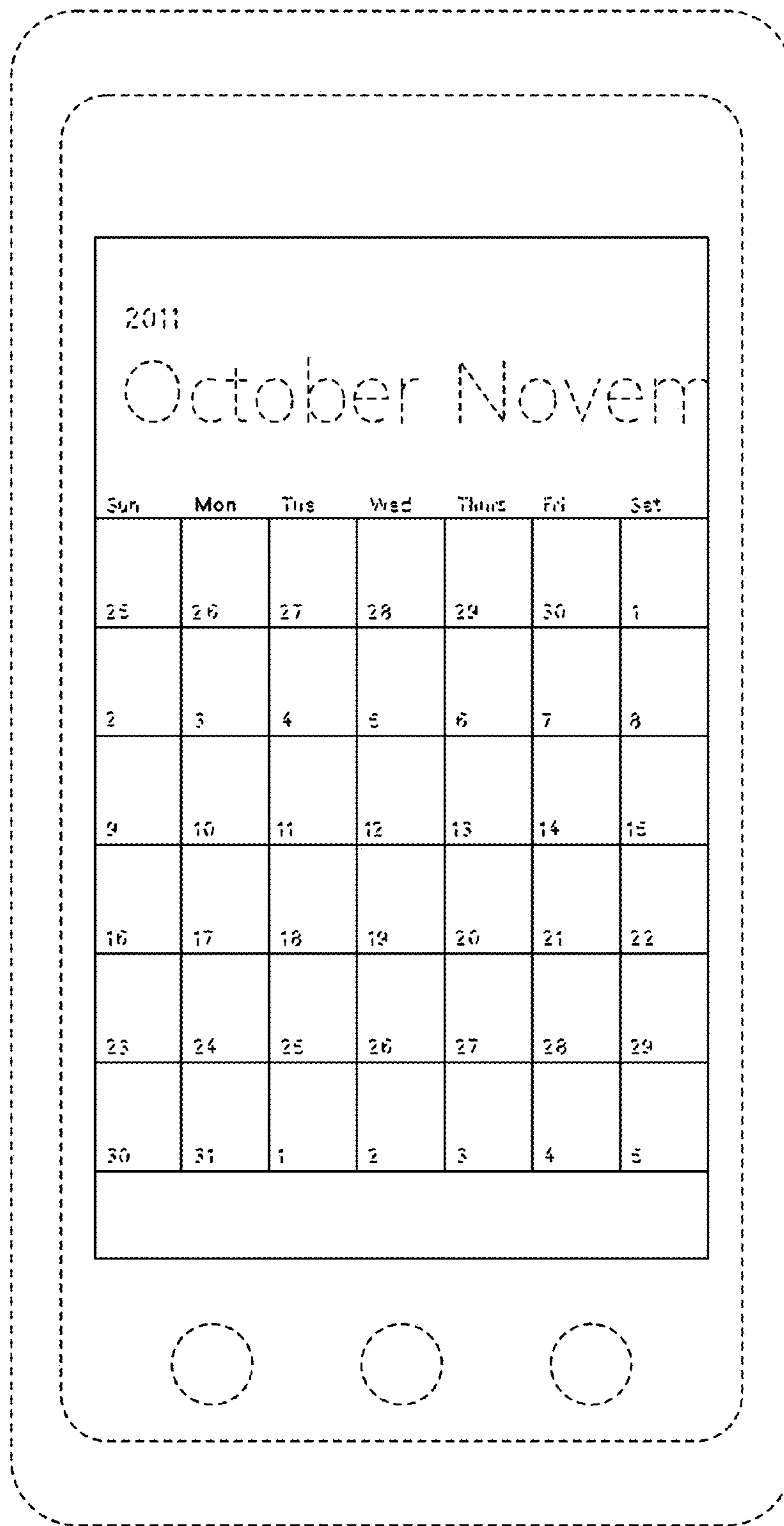

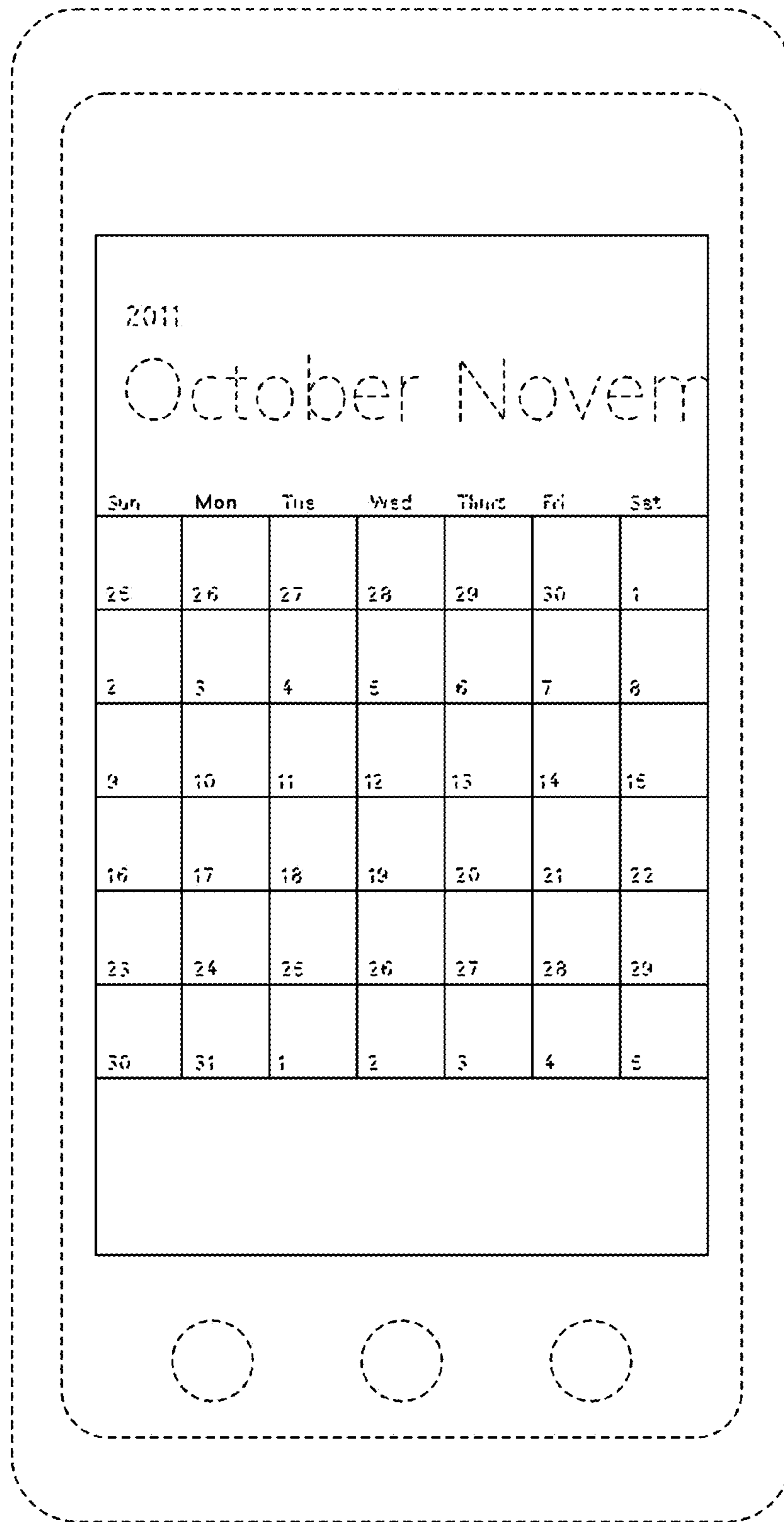

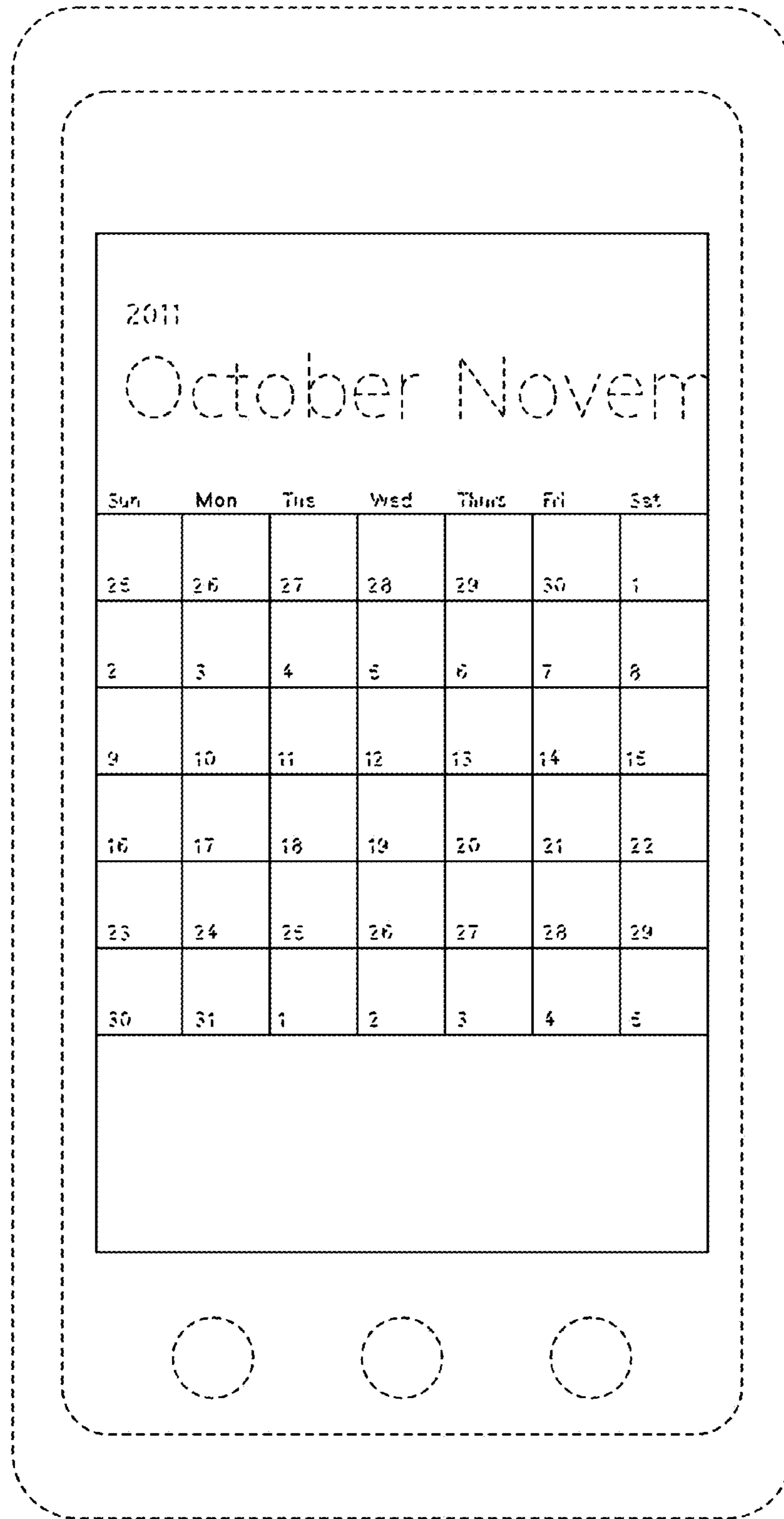
