(57) **CLAIM**

The ornamental design for the head of a dental elevator, as shown and described.

DESCRIPTION

FIG. 1 is an elevated isometric view of a first embodiment of a head of a dental elevator showing the new design;

FIG. 2 is a bottom isometric view of the head of a dental elevator as shown in FIG. 1;

FIG. 3 is a top isometric view of the head of a dental elevator in an open configuration;

FIG. 4 is a bottom isometric view of the head of a dental elevator shown in FIG. 3;

FIG. 5 is a top view of the head of a dental elevator in a closed configuration;

FIG. 6 is a bottom view of the head of a dental elevator as shown in FIG. 1;

FIG. 7 is a right side view of the head of a dental elevator as shown in FIG. 1;

FIG. 8 is a left side view of the head of a dental elevator as shown in FIG. 1;

FIG. 9 is a front side view of the head of a dental elevator as shown in FIG. 1;

FIG. 10 is a rear side view of the head of a dental elevator as shown in FIG. 1;

FIG. 11 is an elevated isometric view of a second embodiment of a head of a dental elevator showing the new design;

FIG. 17 is a right side view of the head of a dental elevator as shown in FIG. 11;

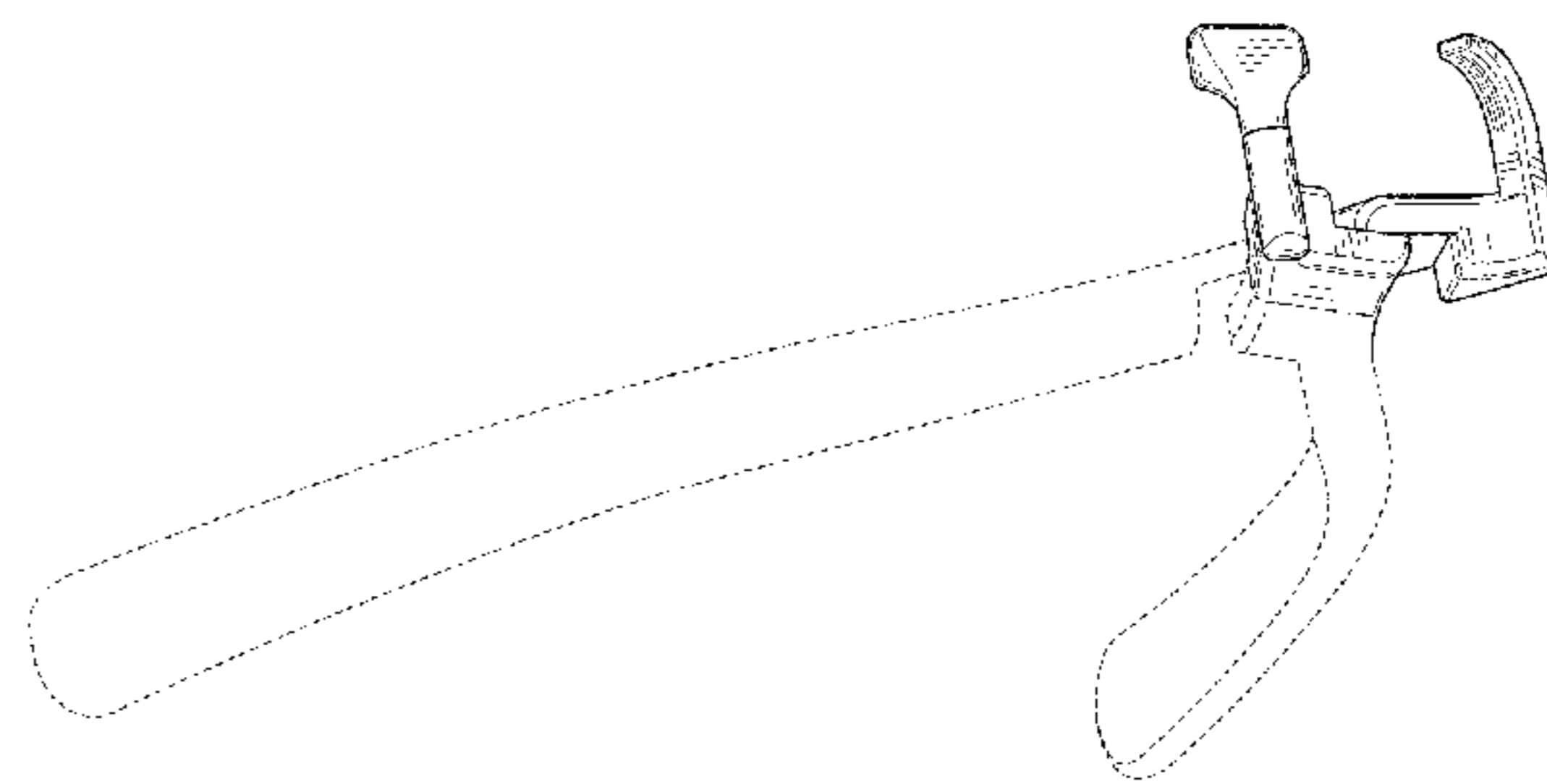
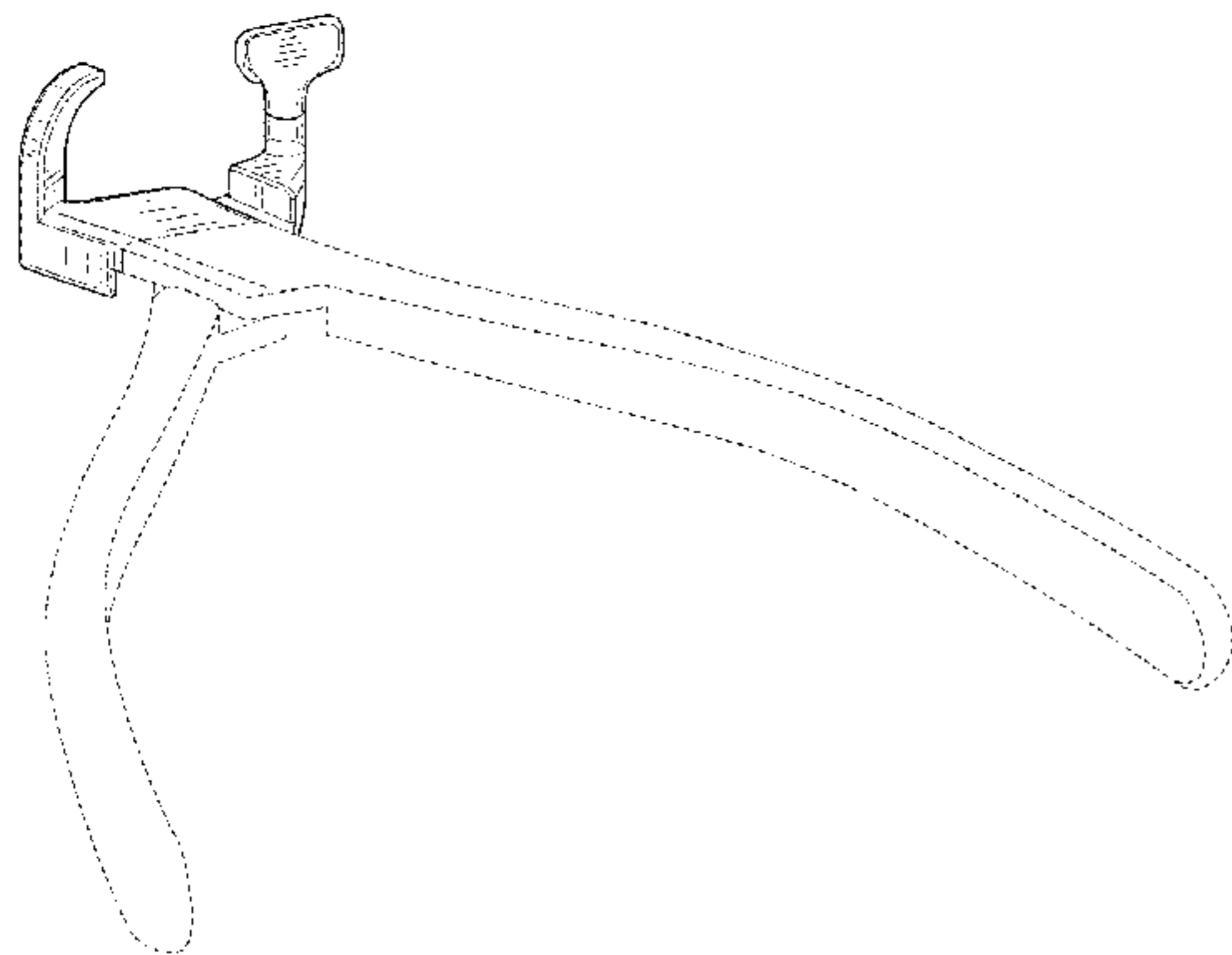
FIG. 18 is a left side view of the head of a dental elevator as shown in FIG. 11;

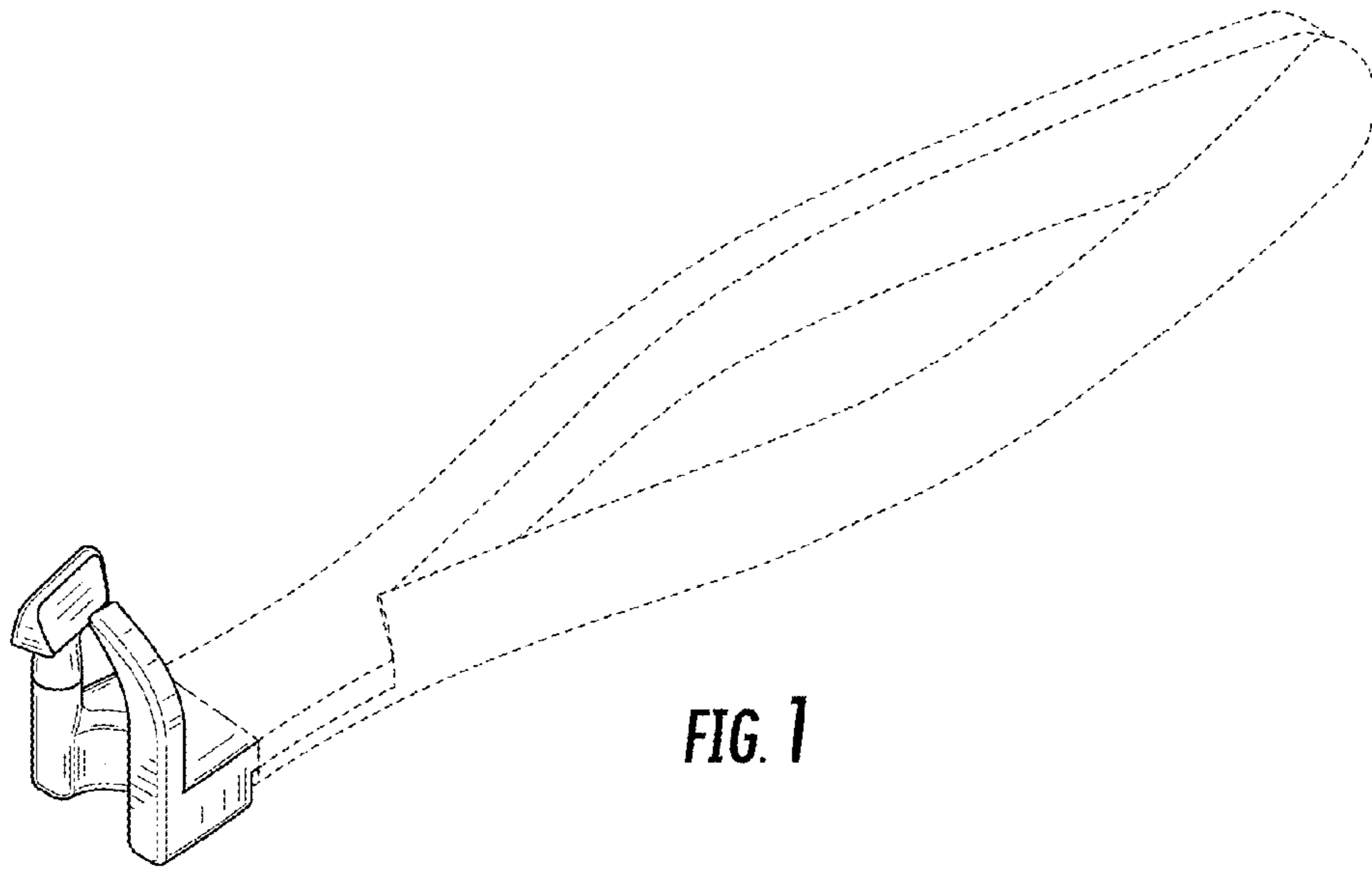

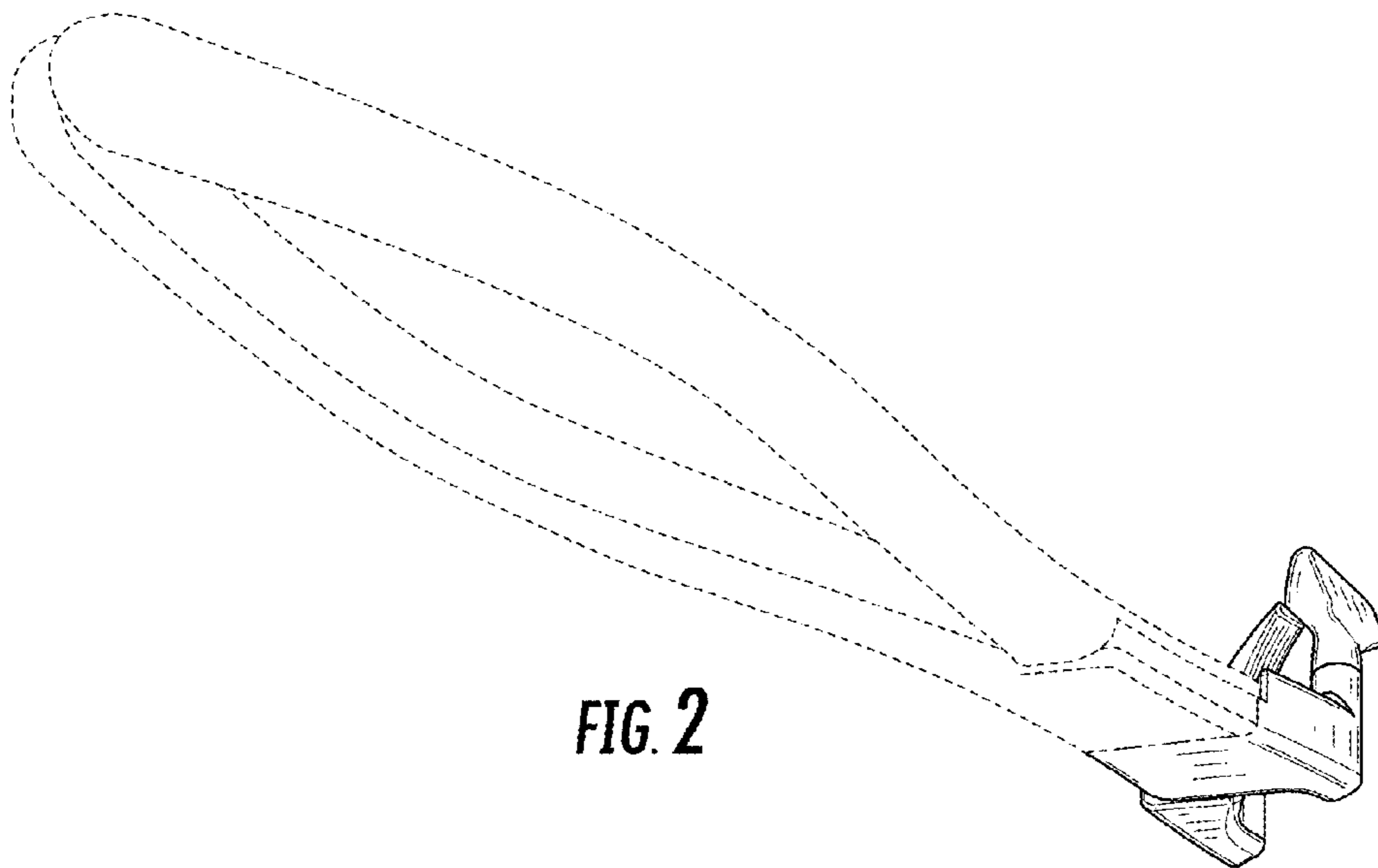

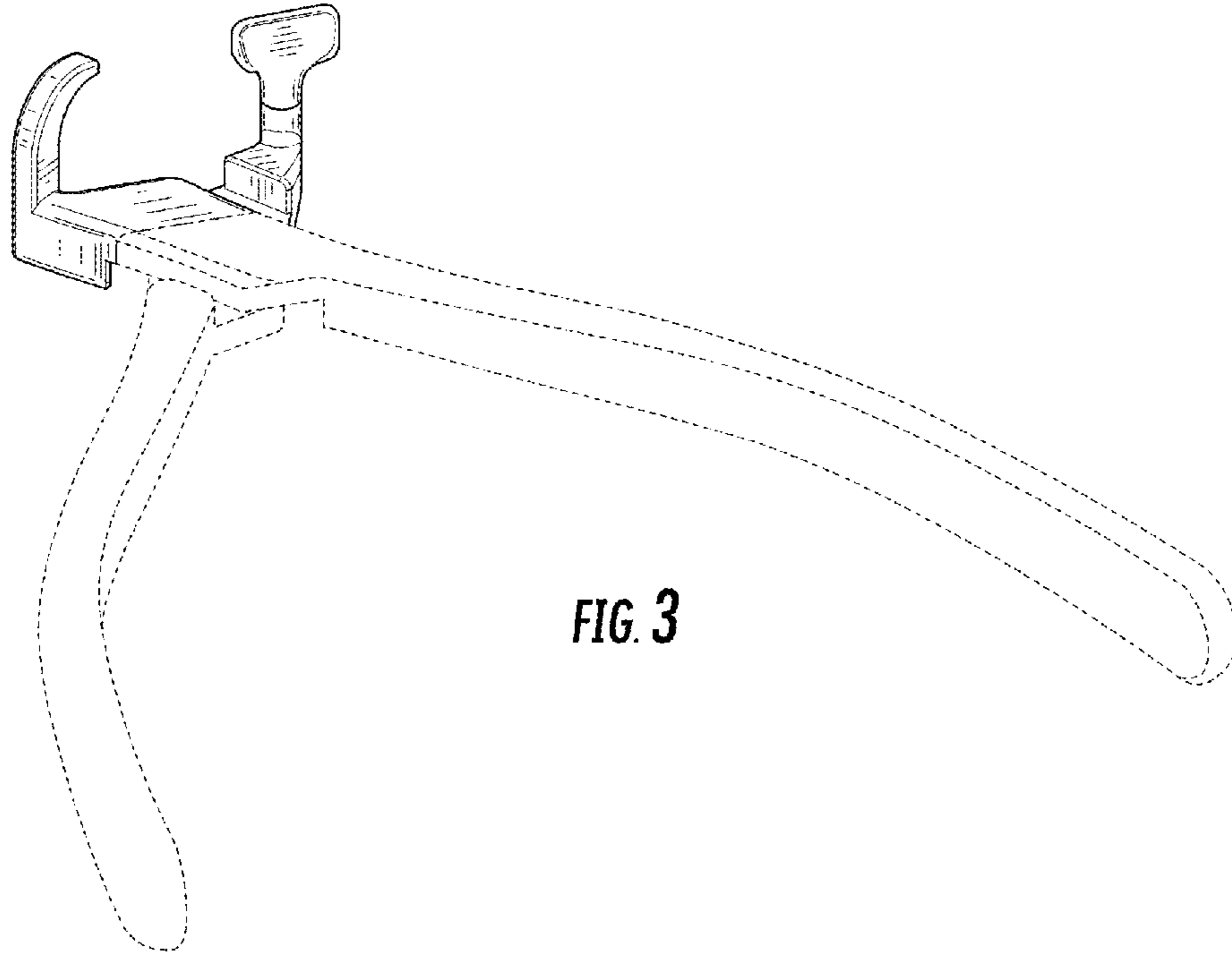

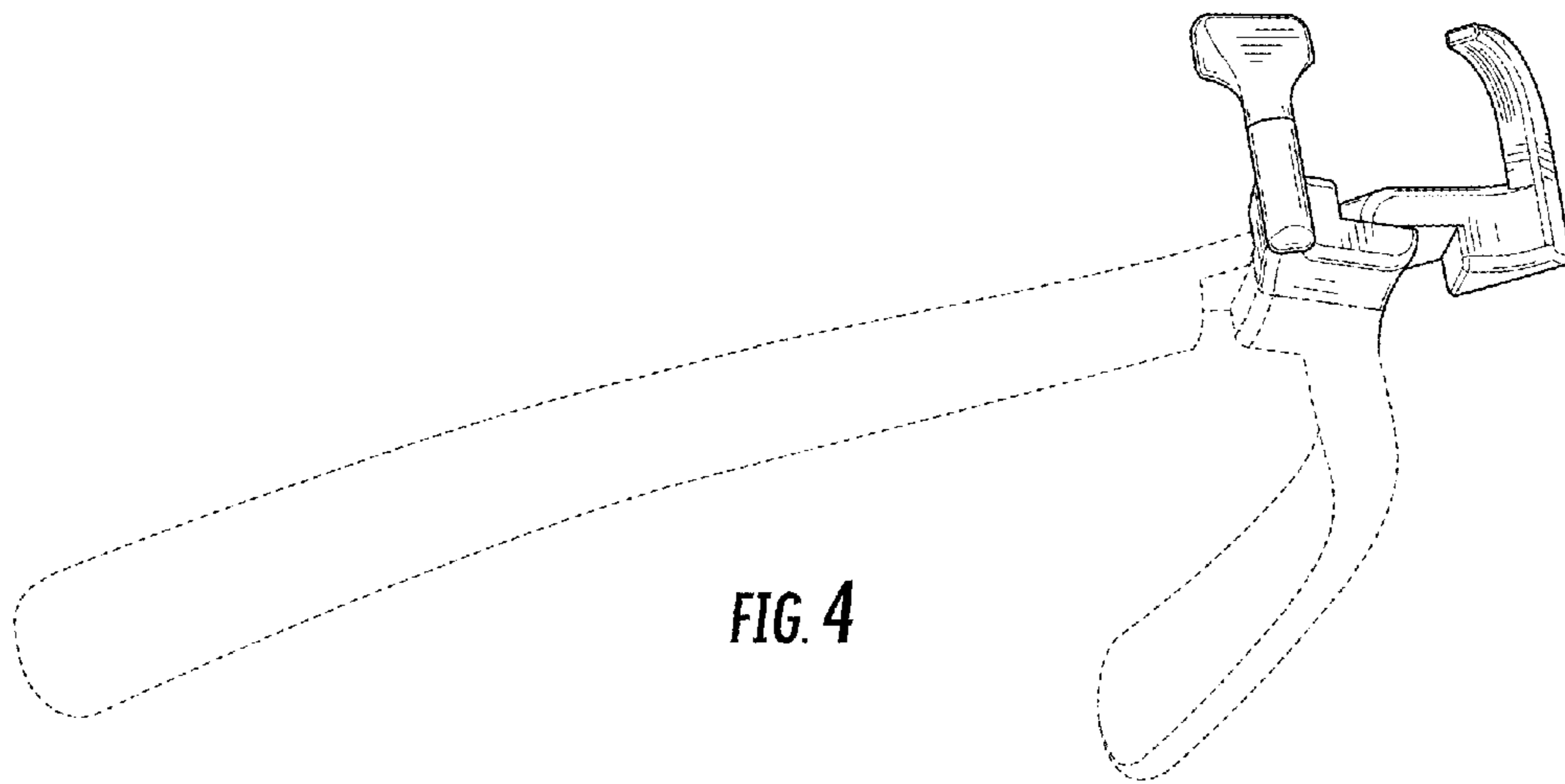

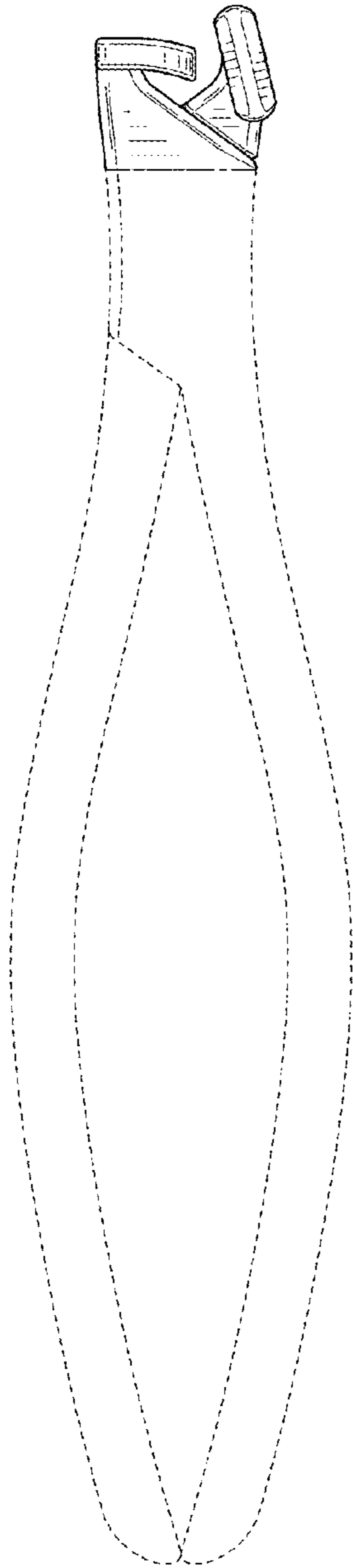

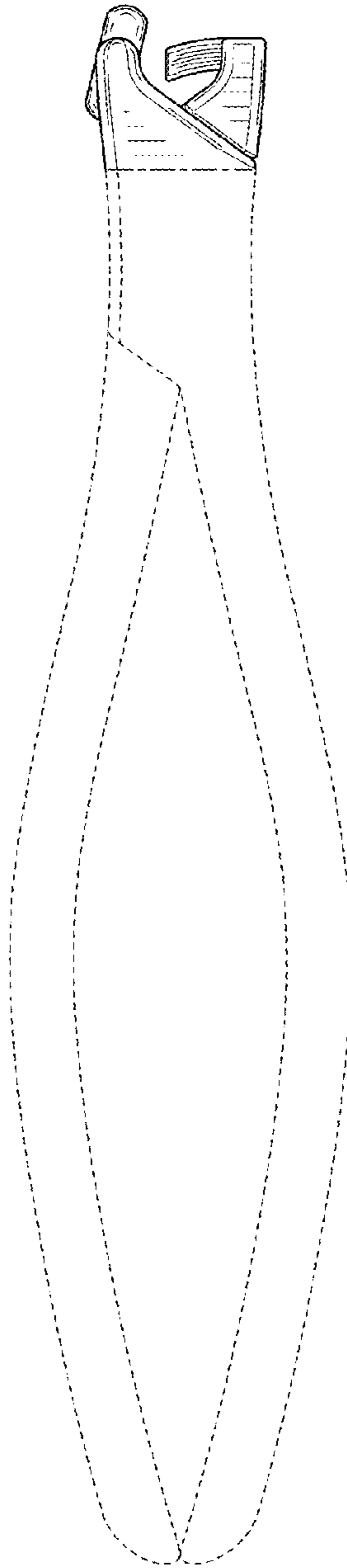

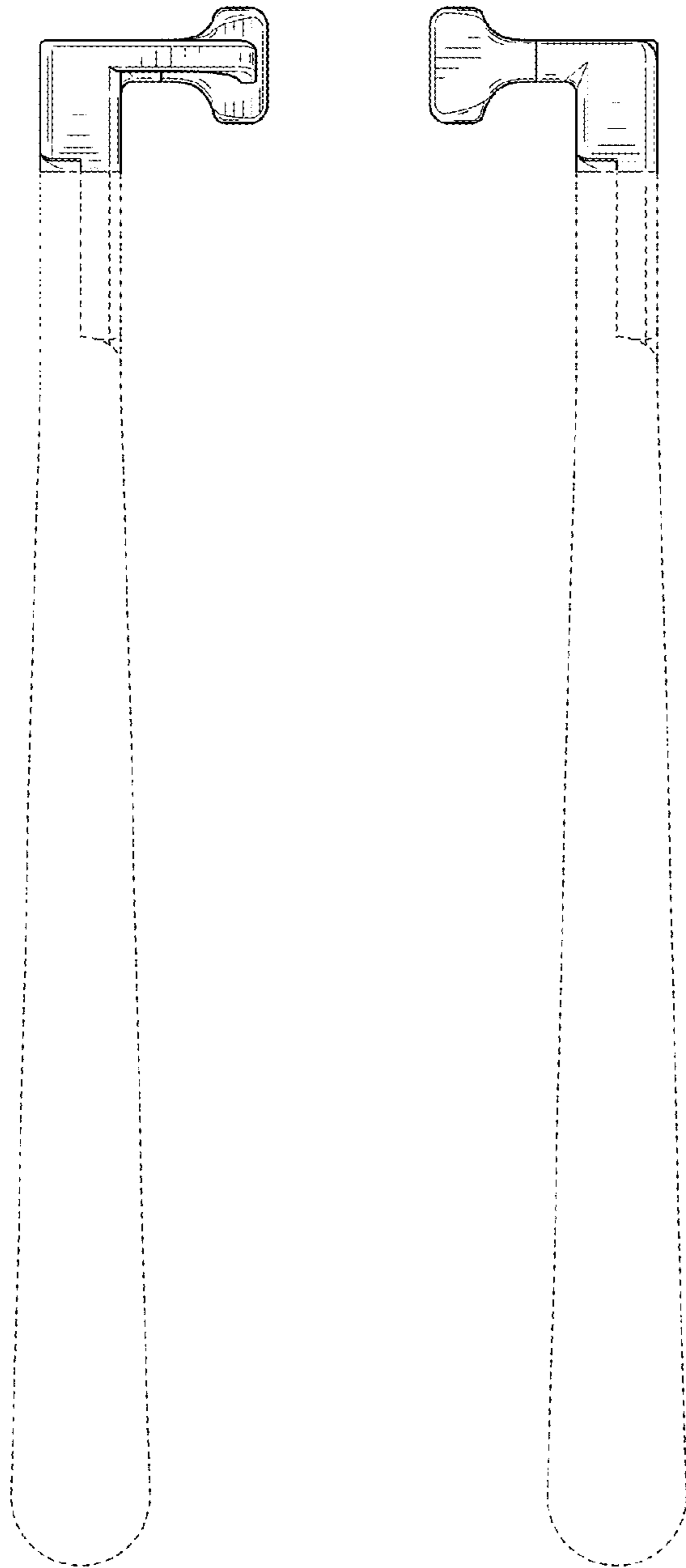

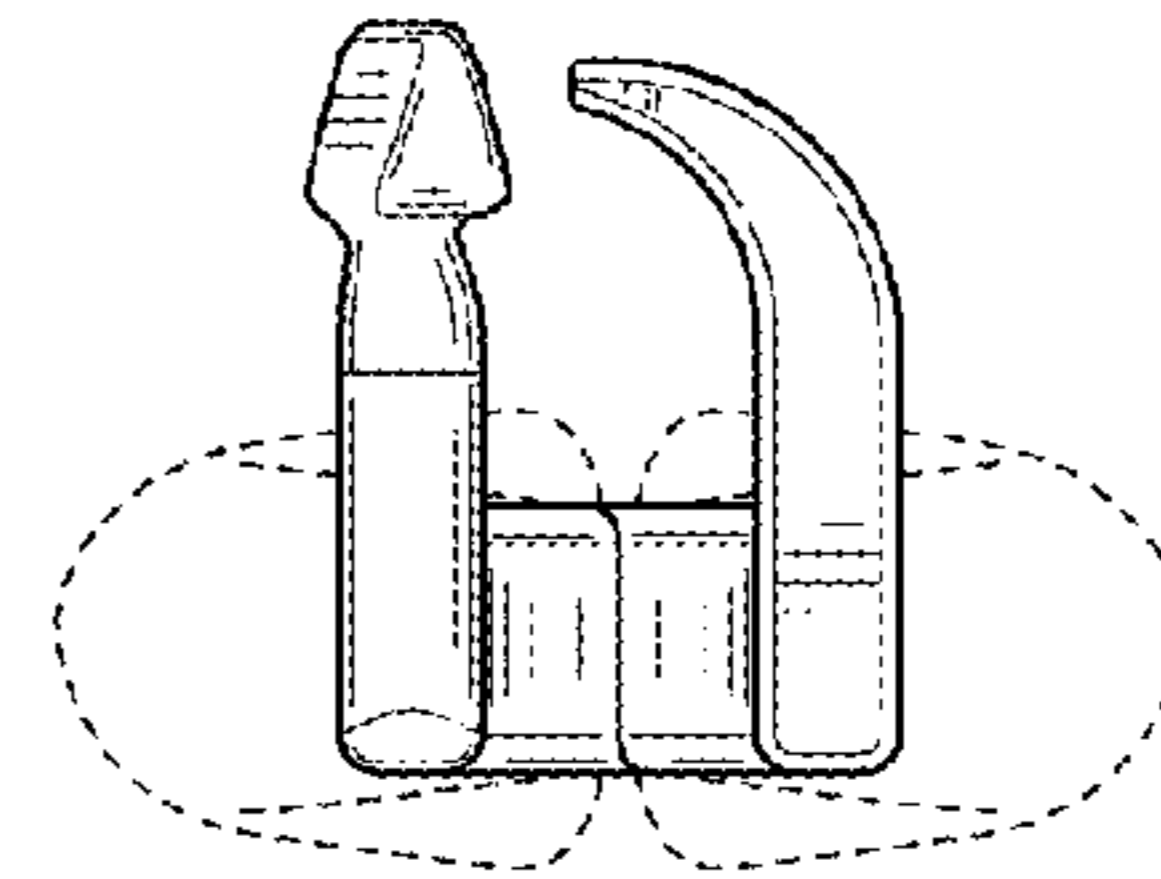

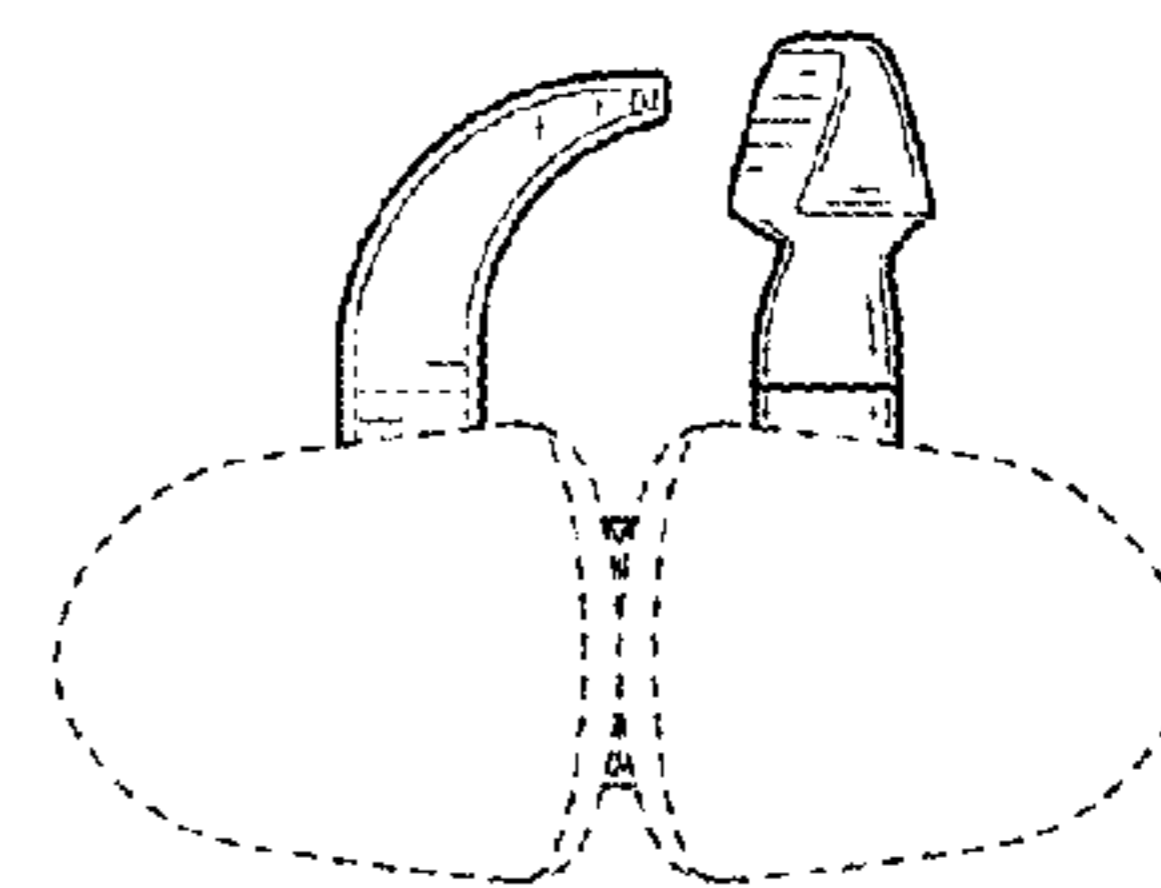

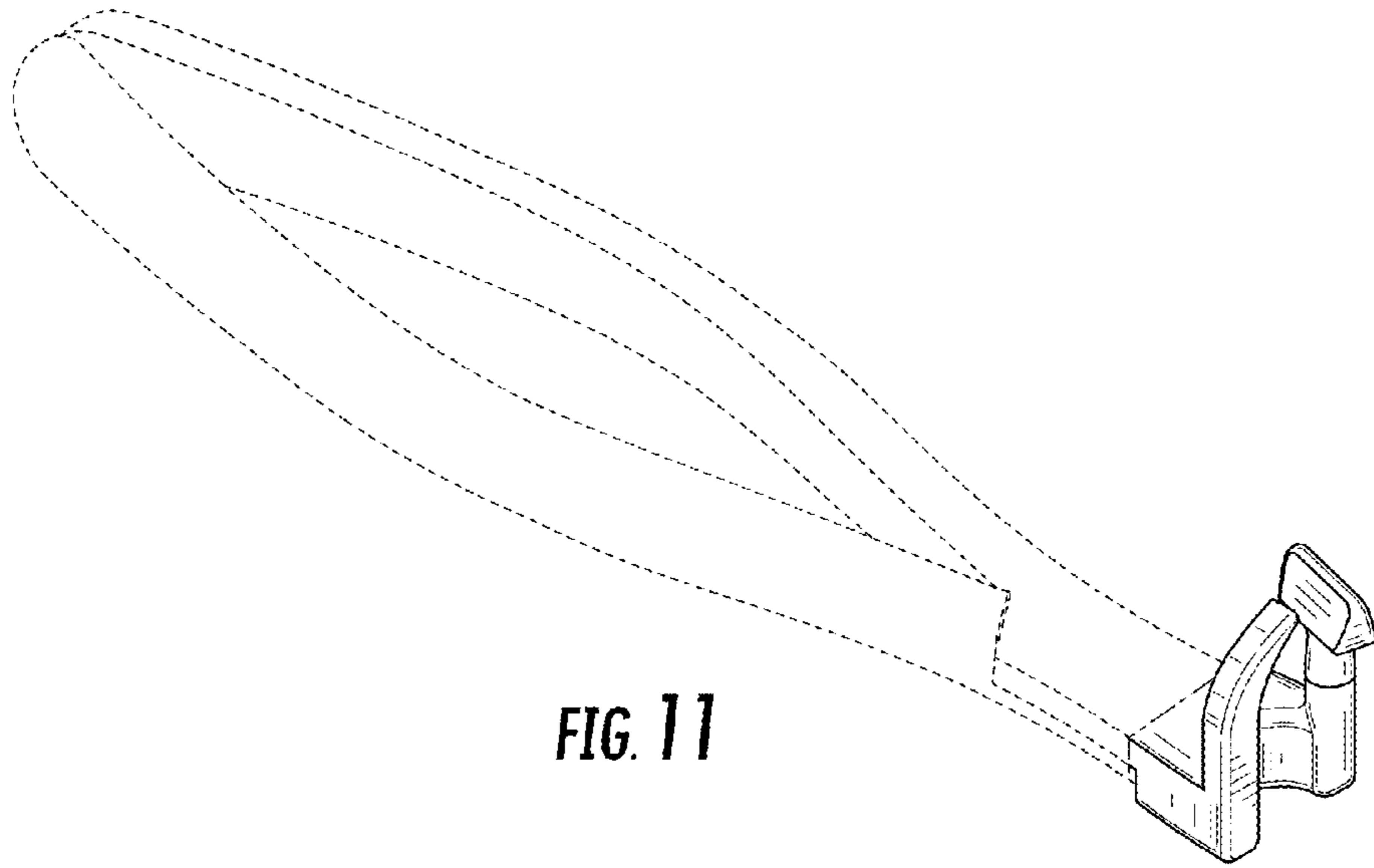

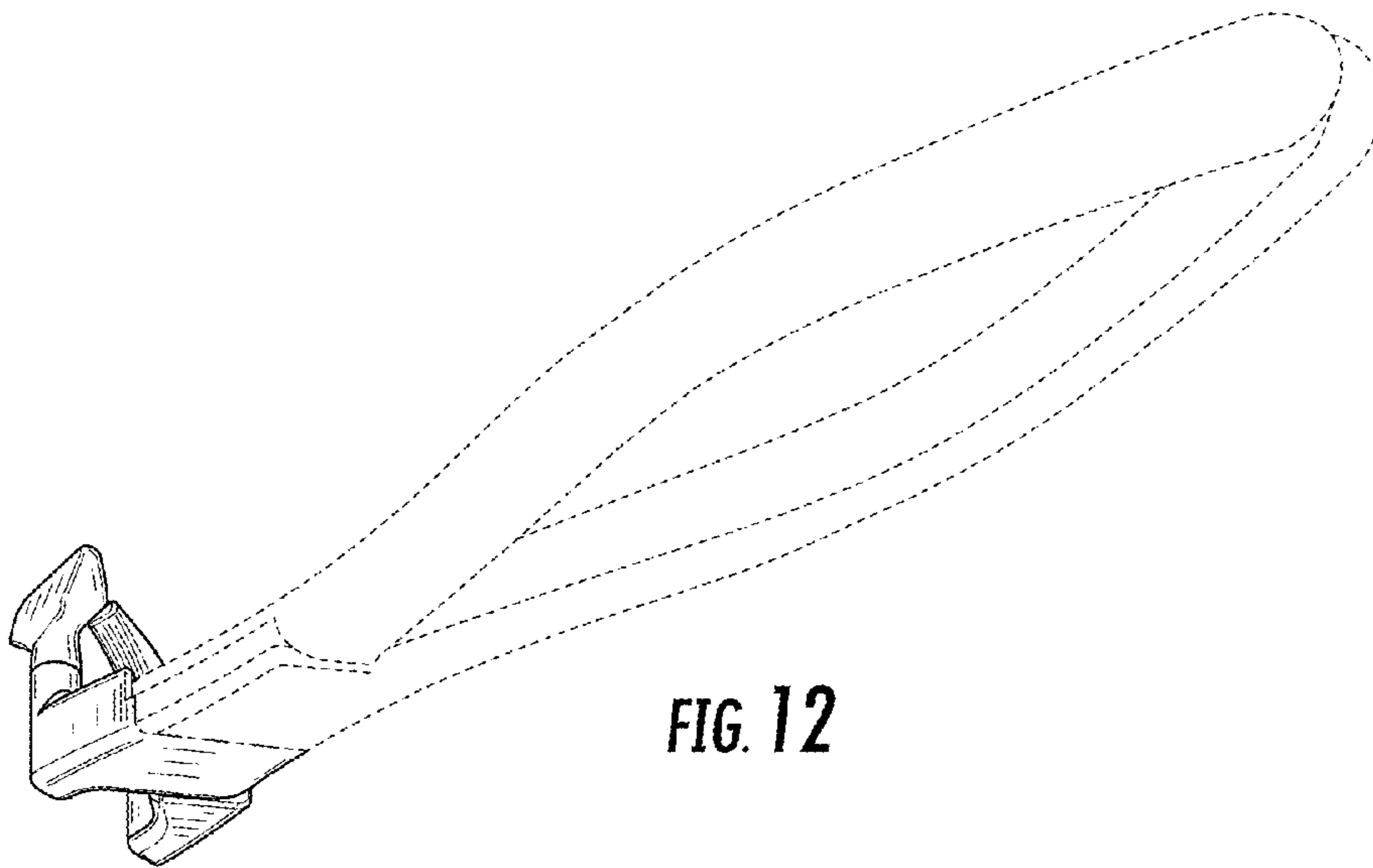

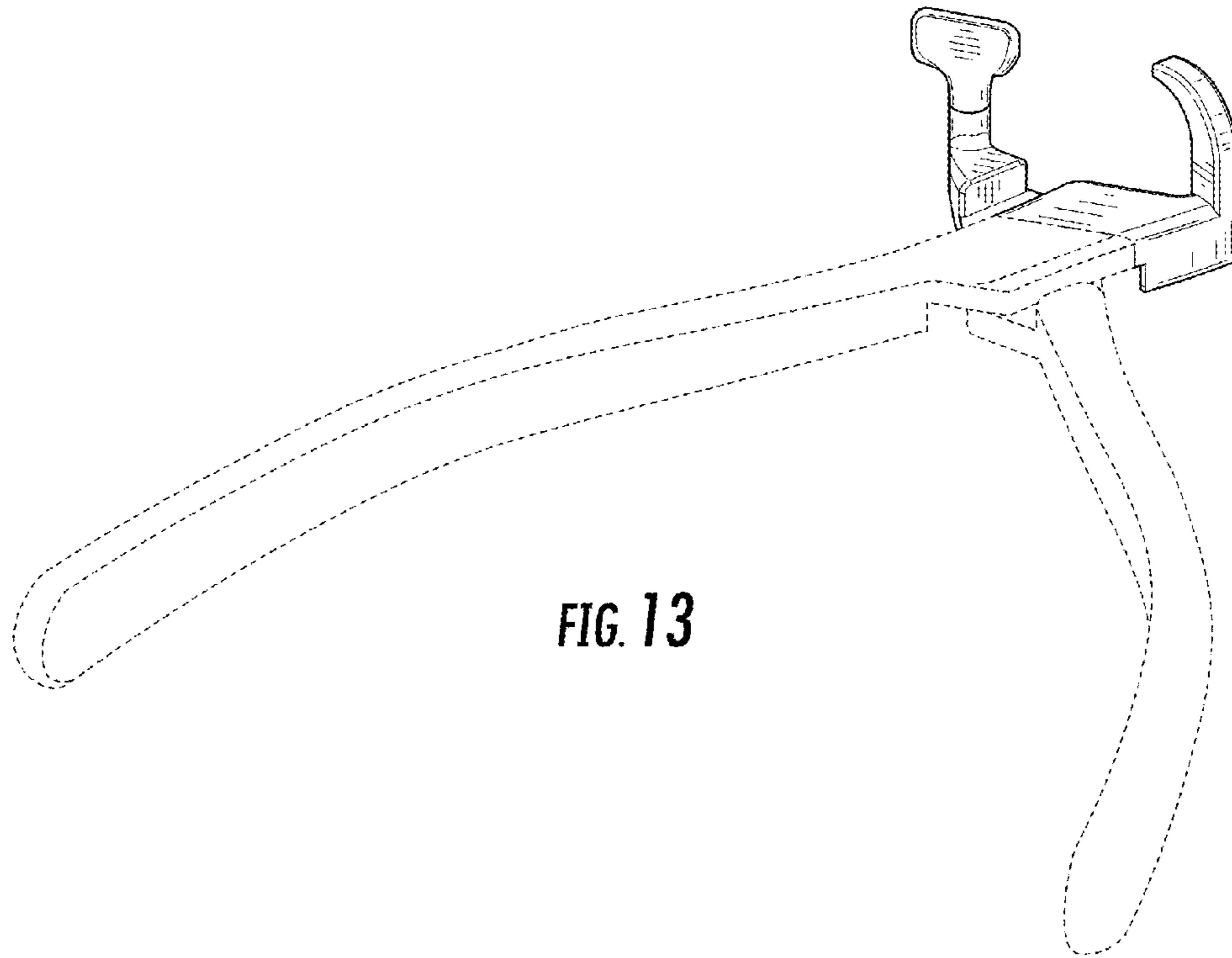

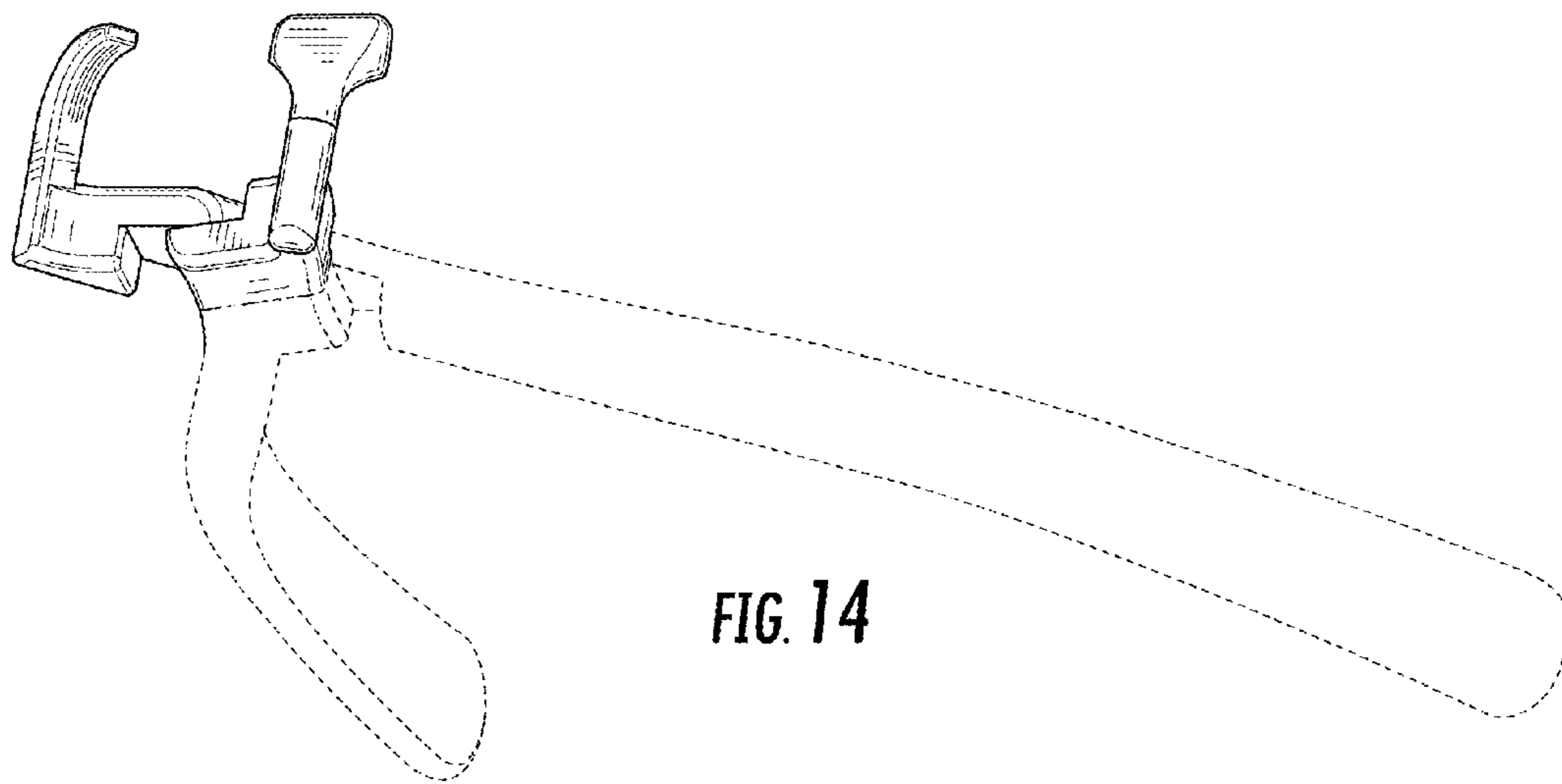

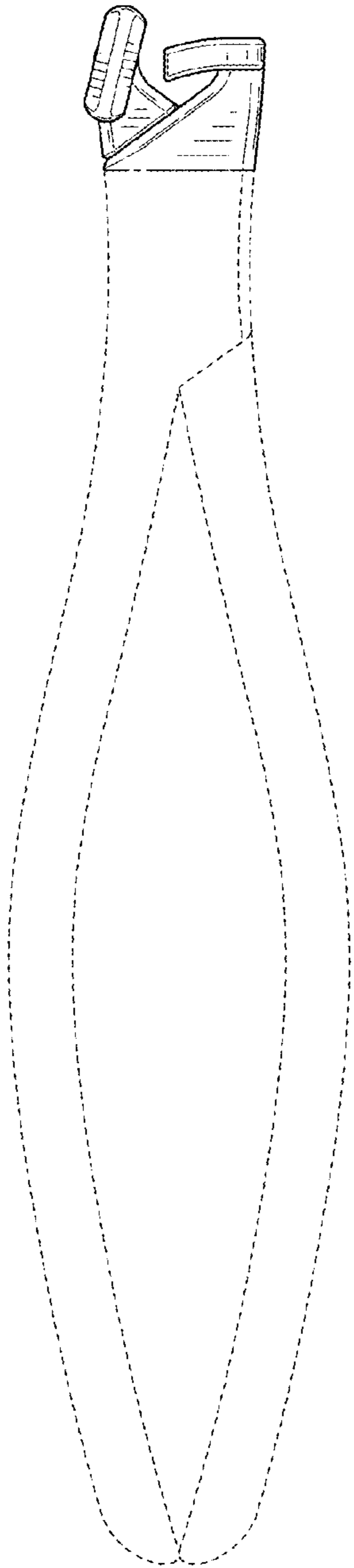

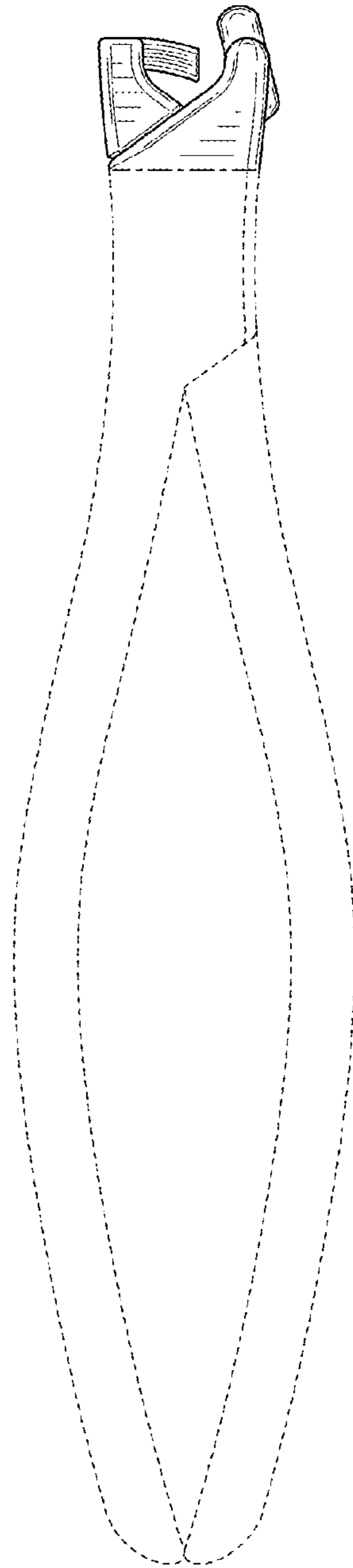

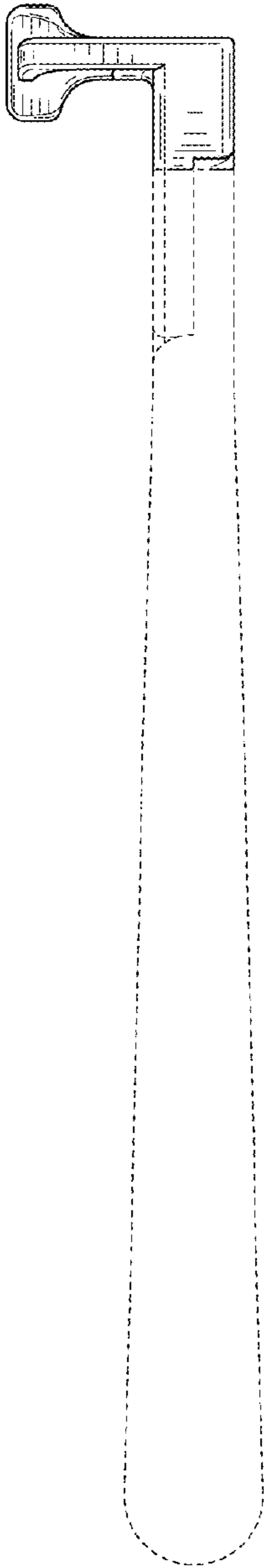

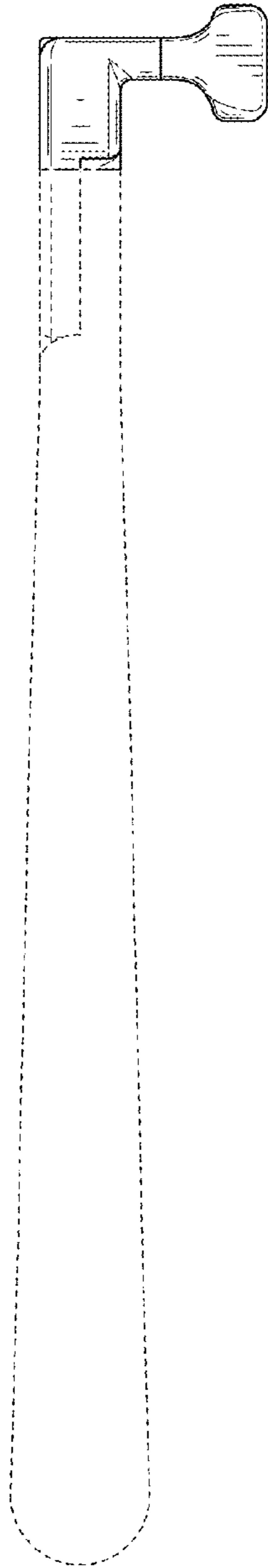

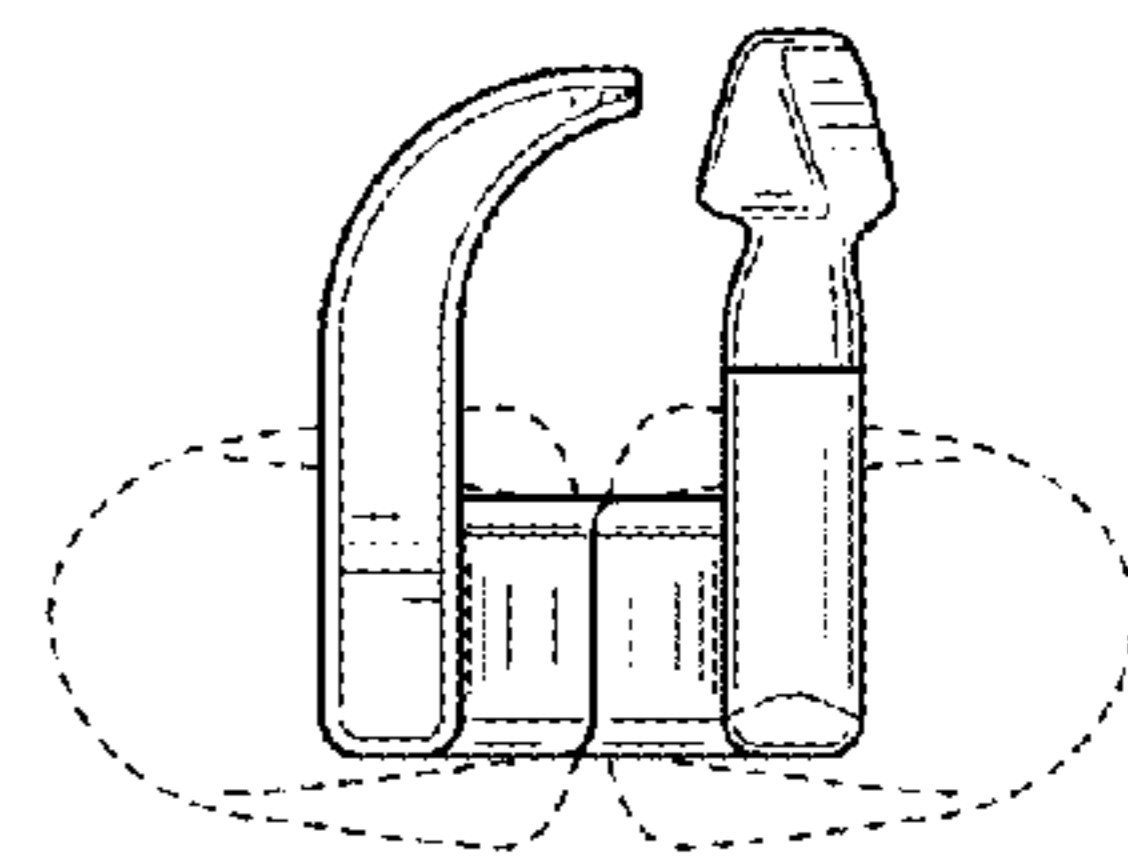

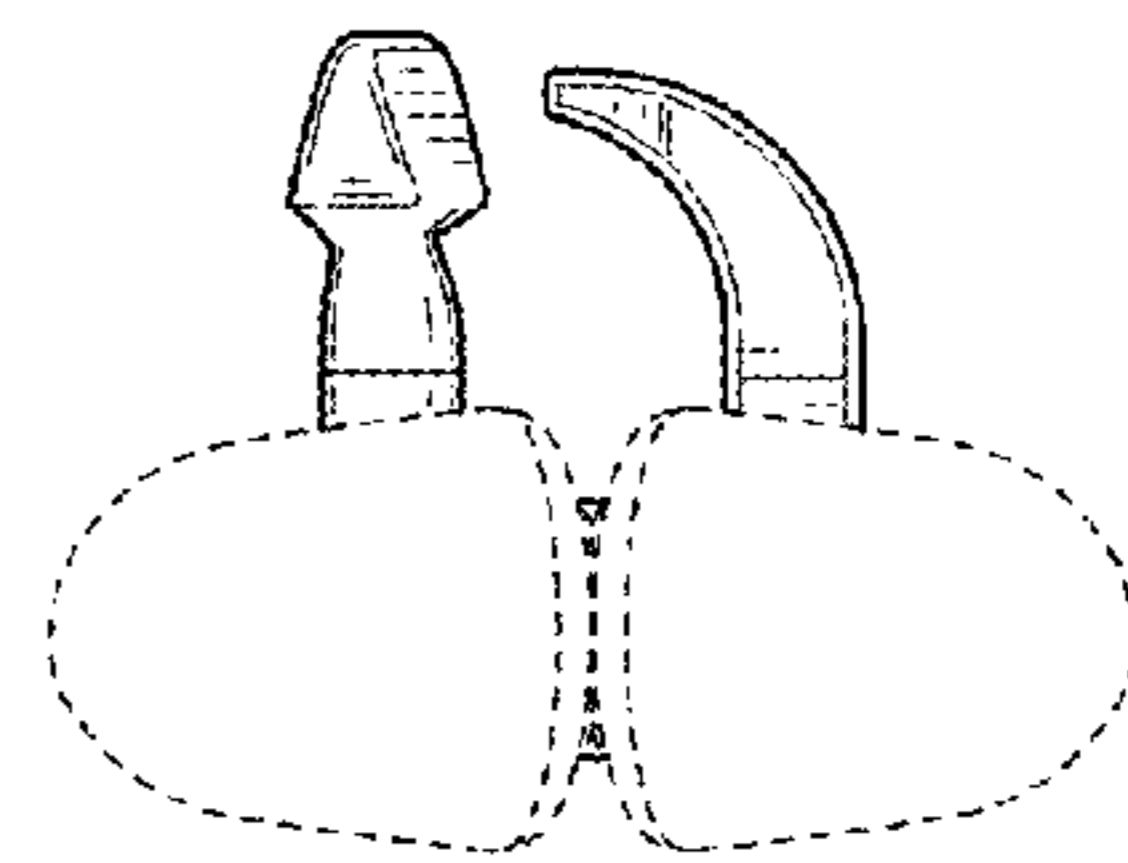
