(57) **CLAIM**

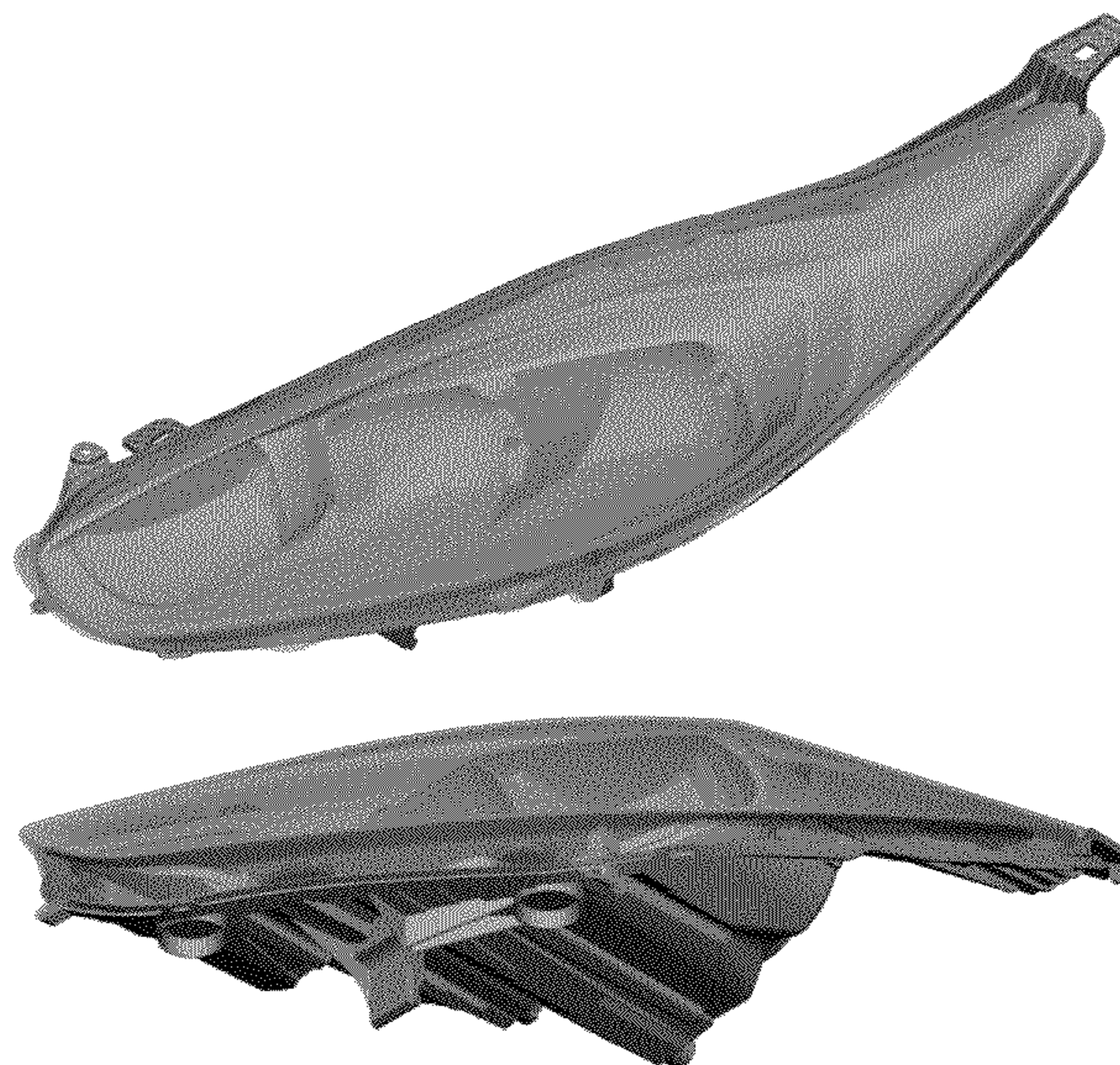
The ornamental design for a vehicle headlight, shown and described.

DESCRIPTION

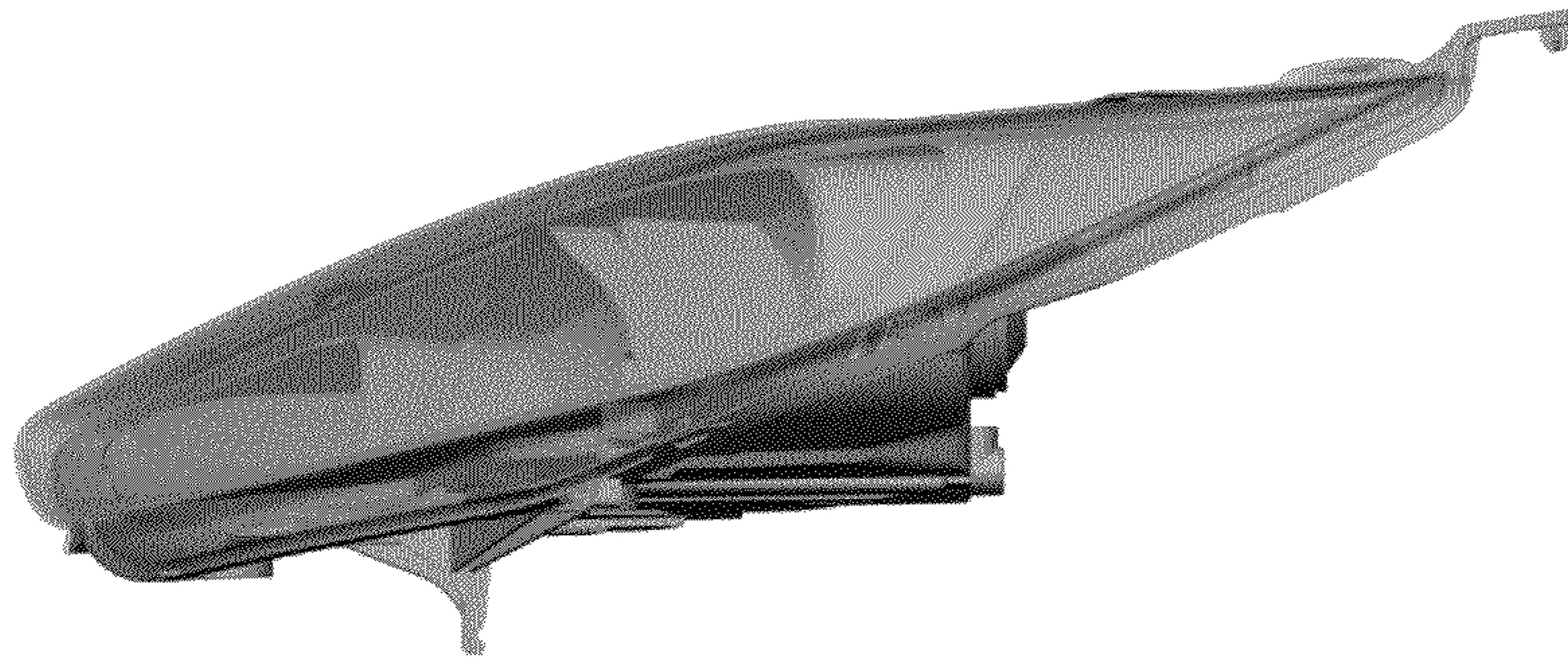

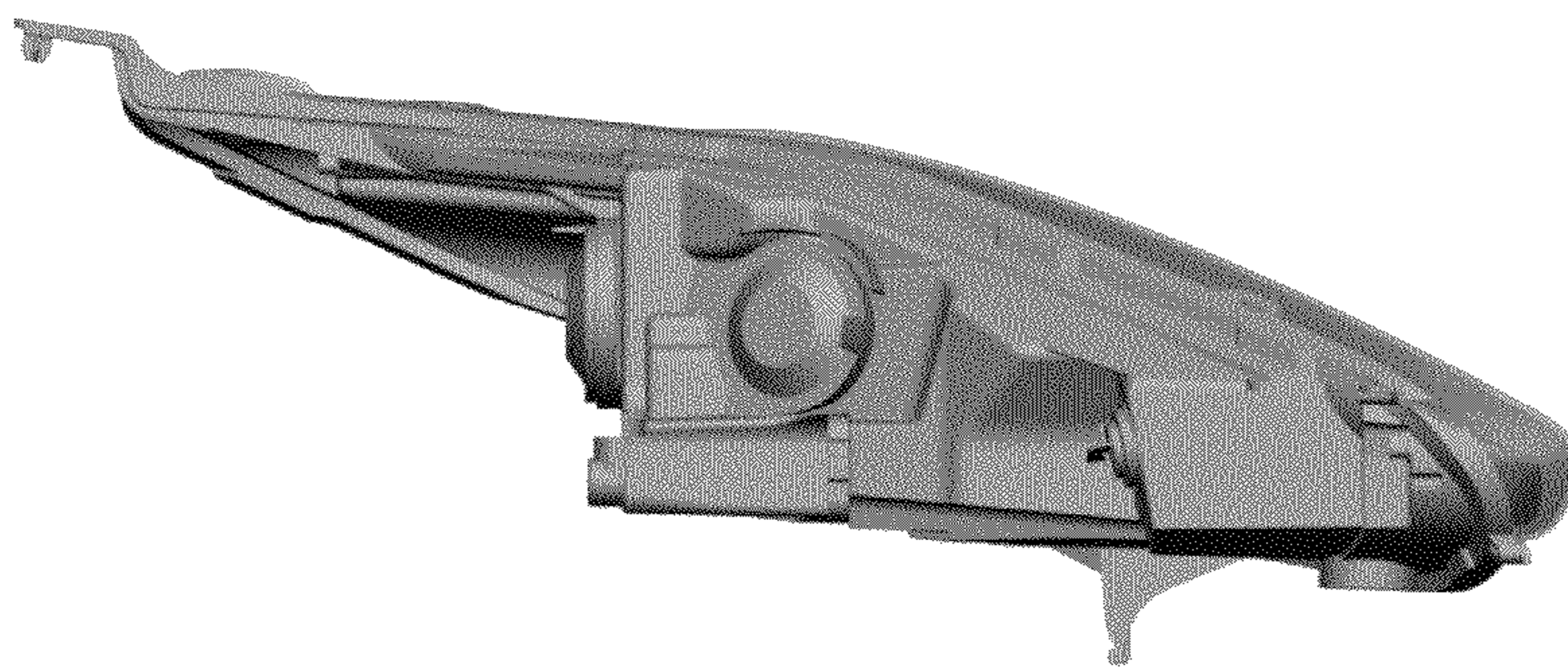

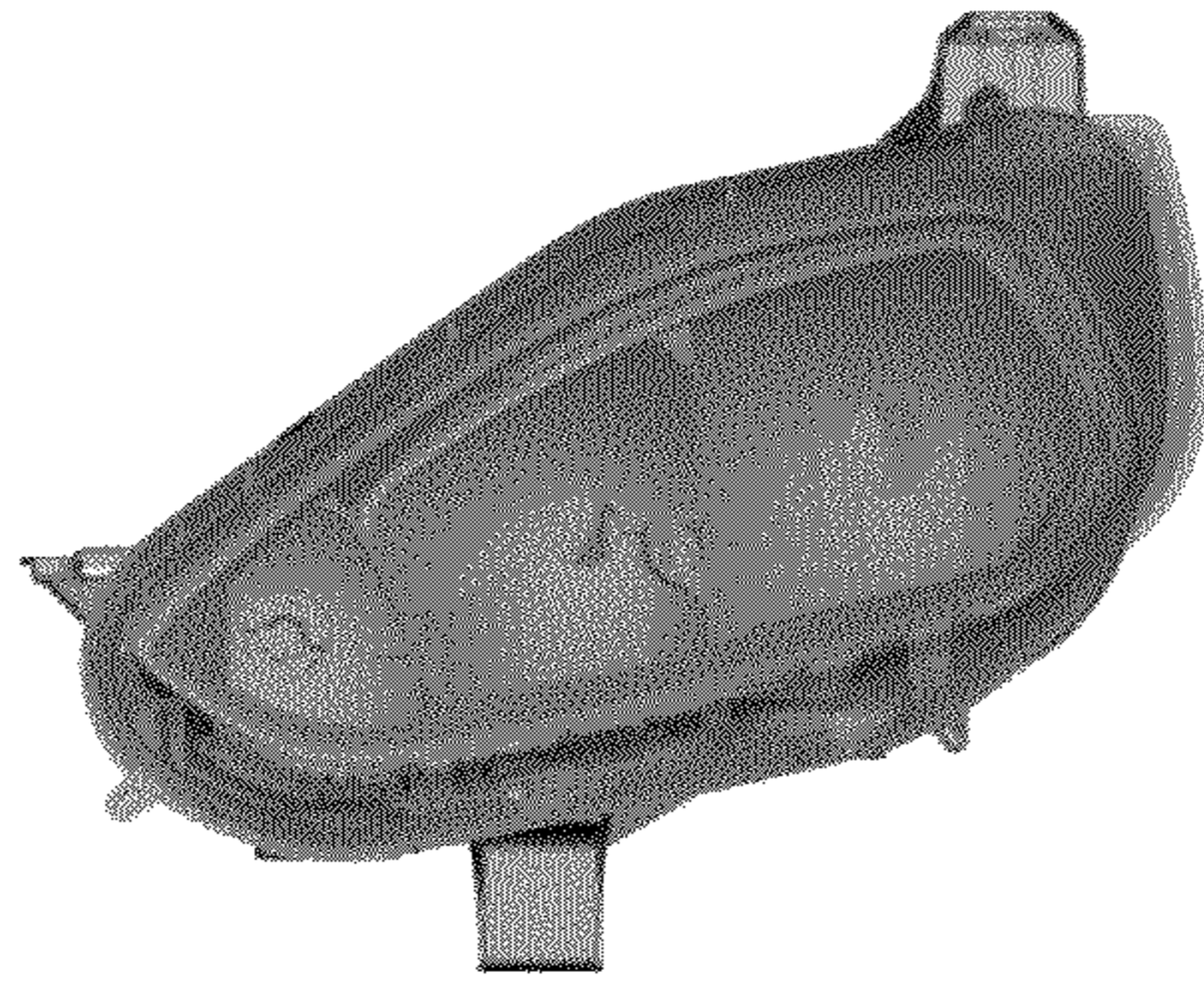

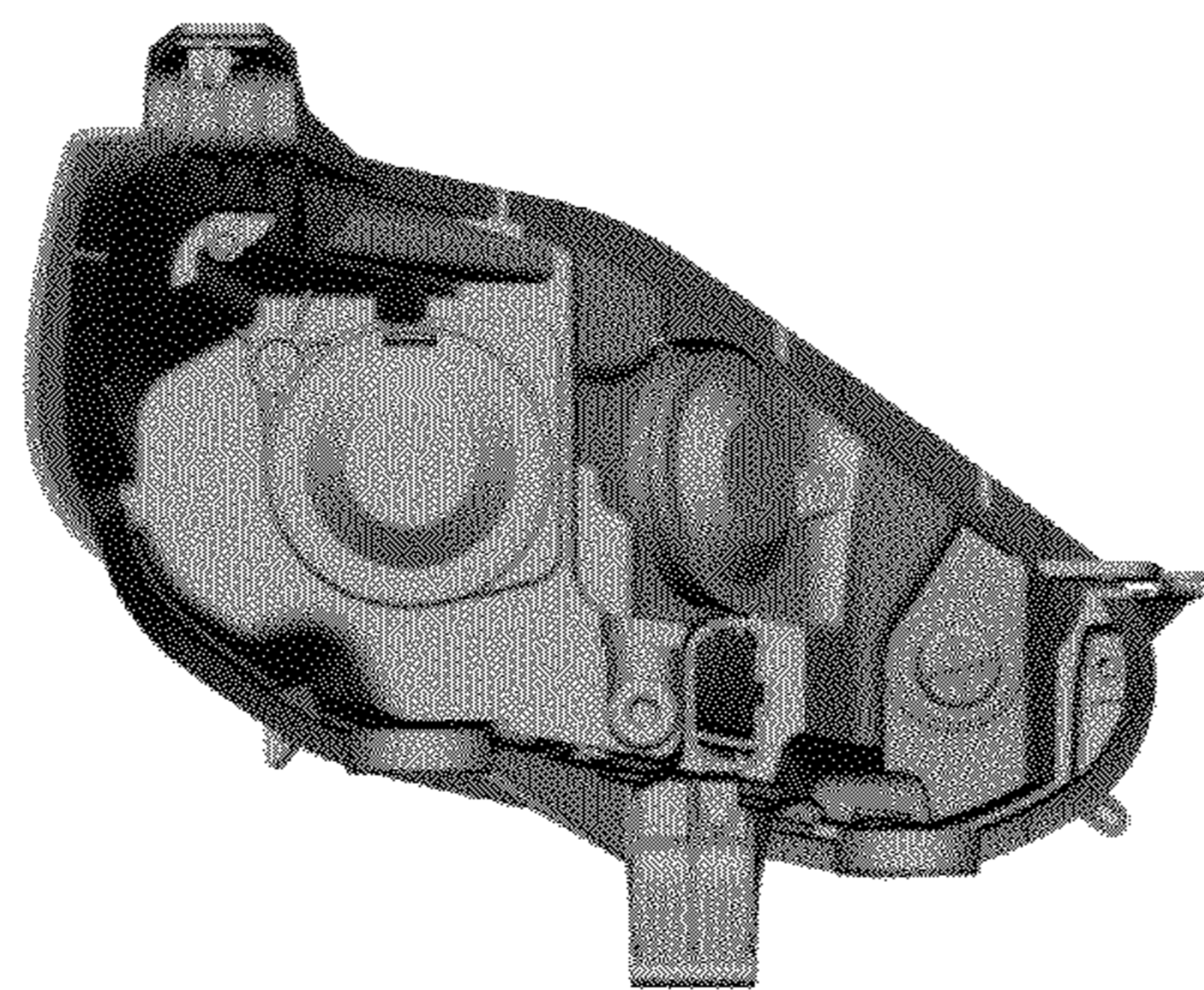

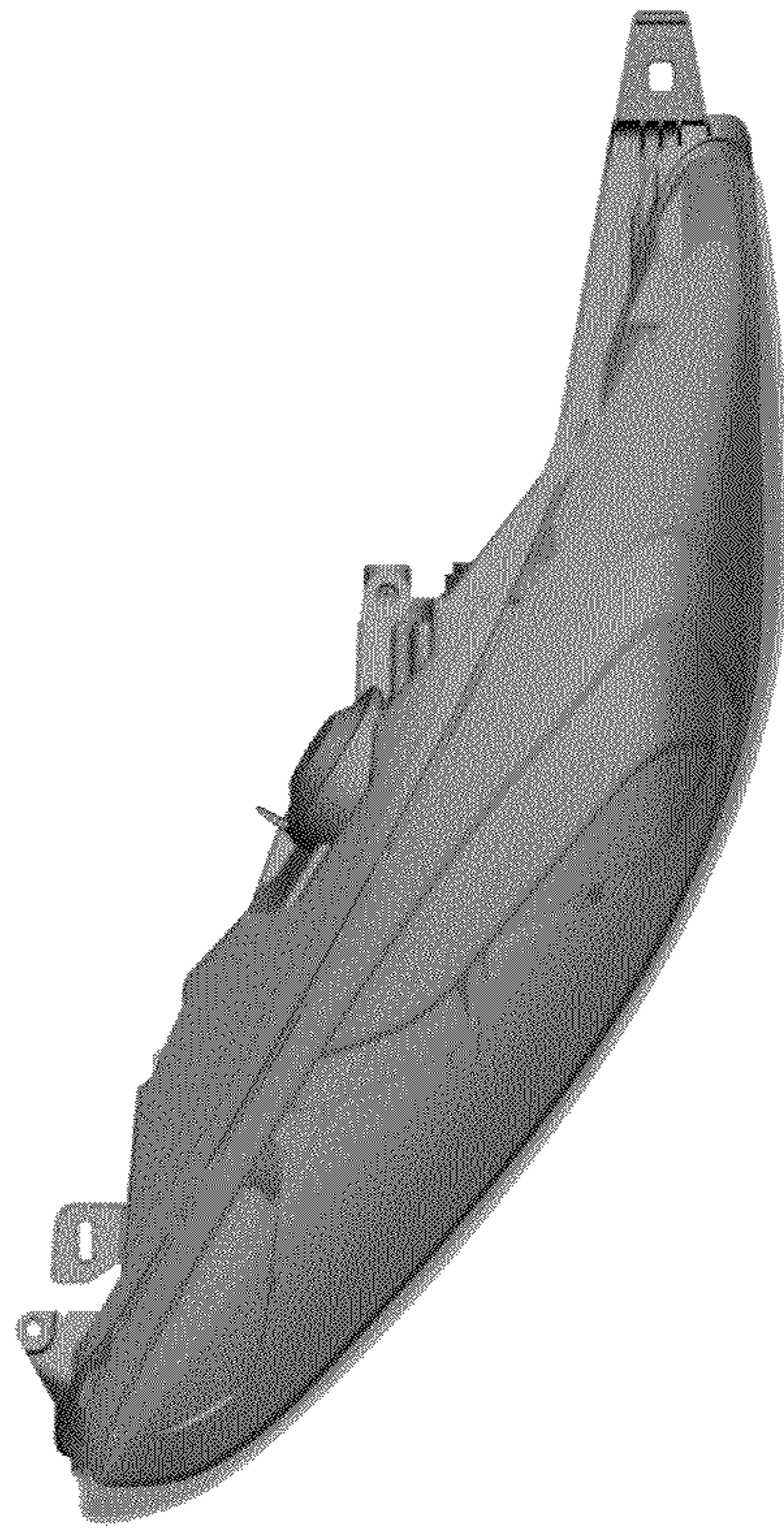

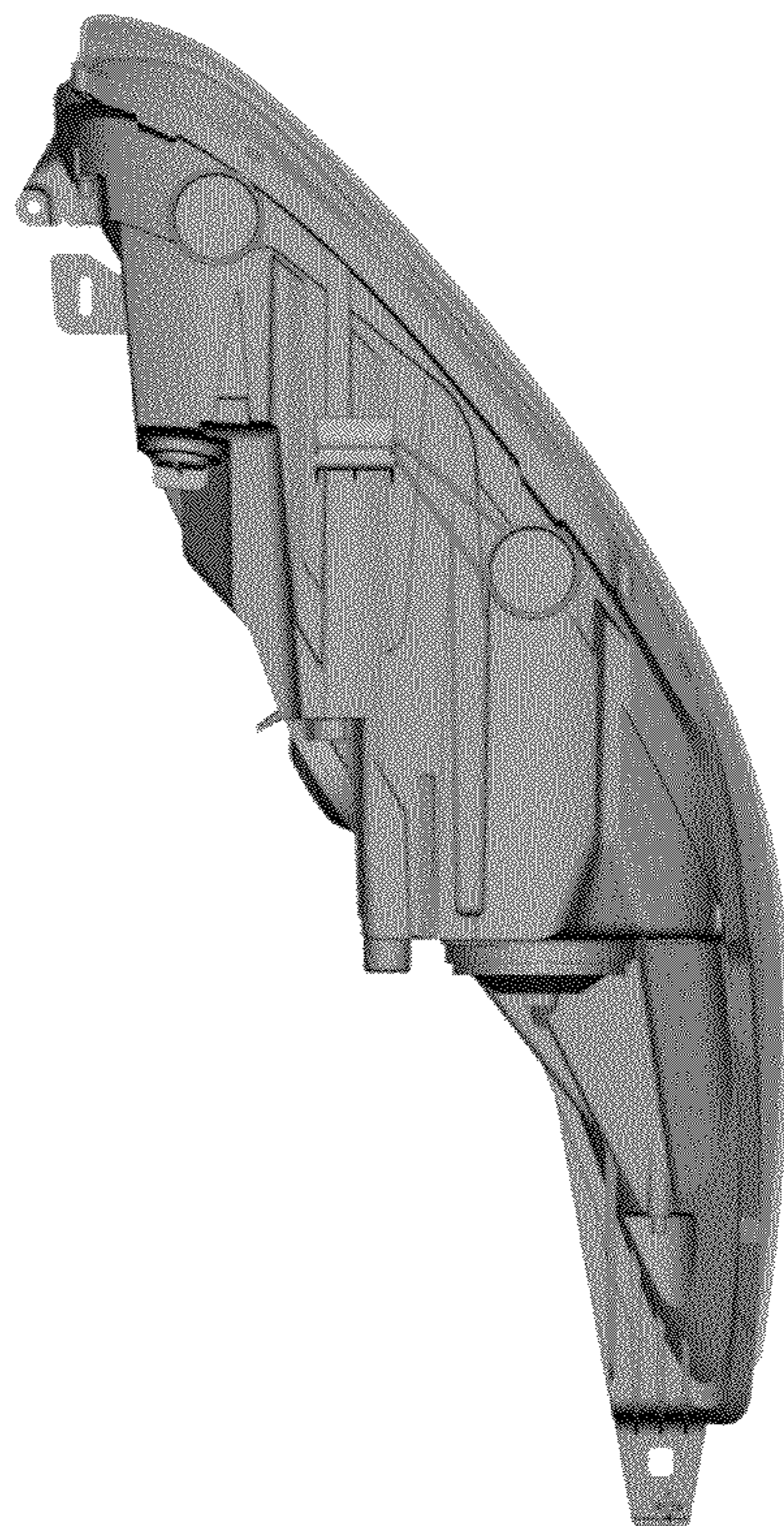

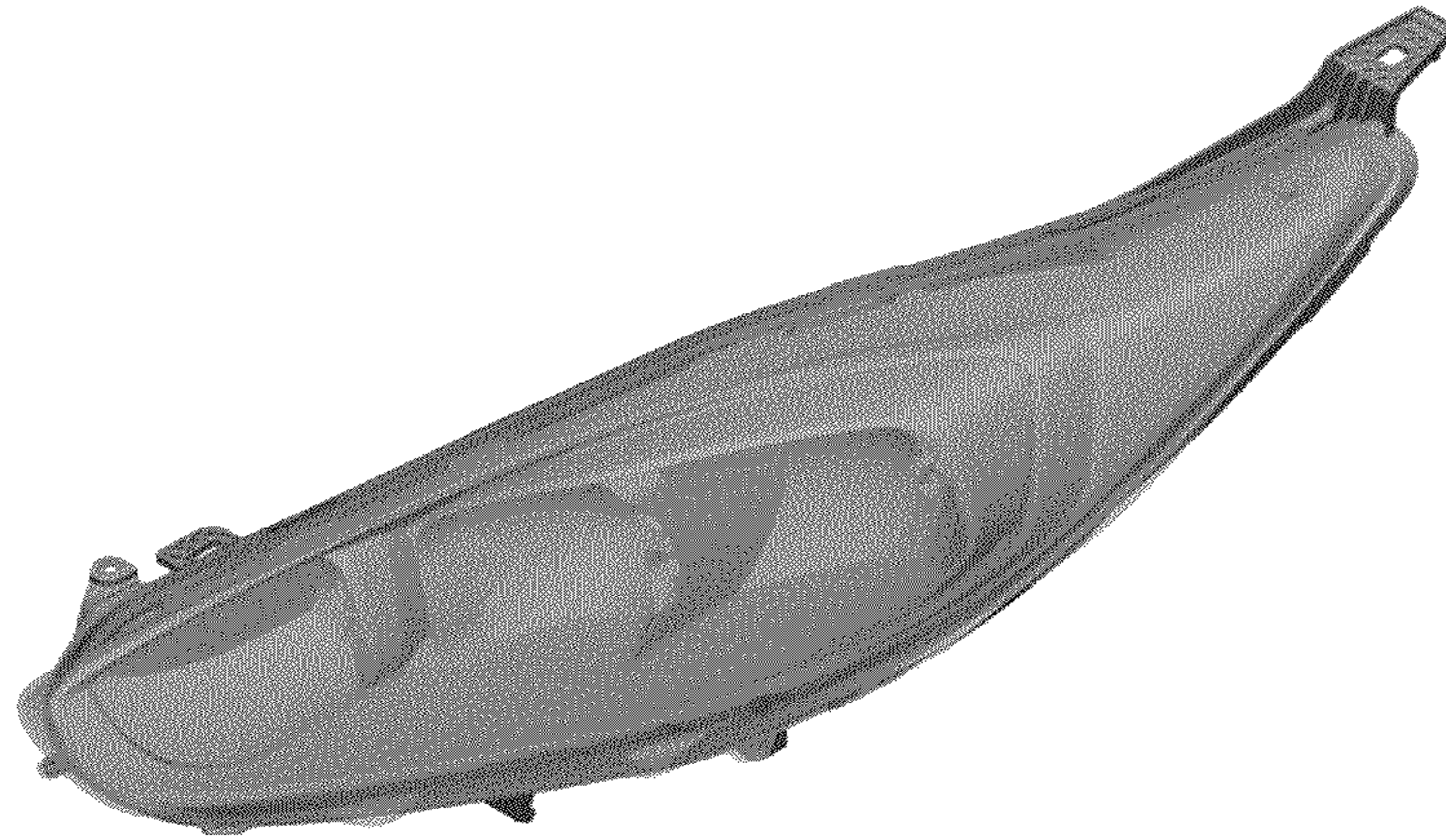

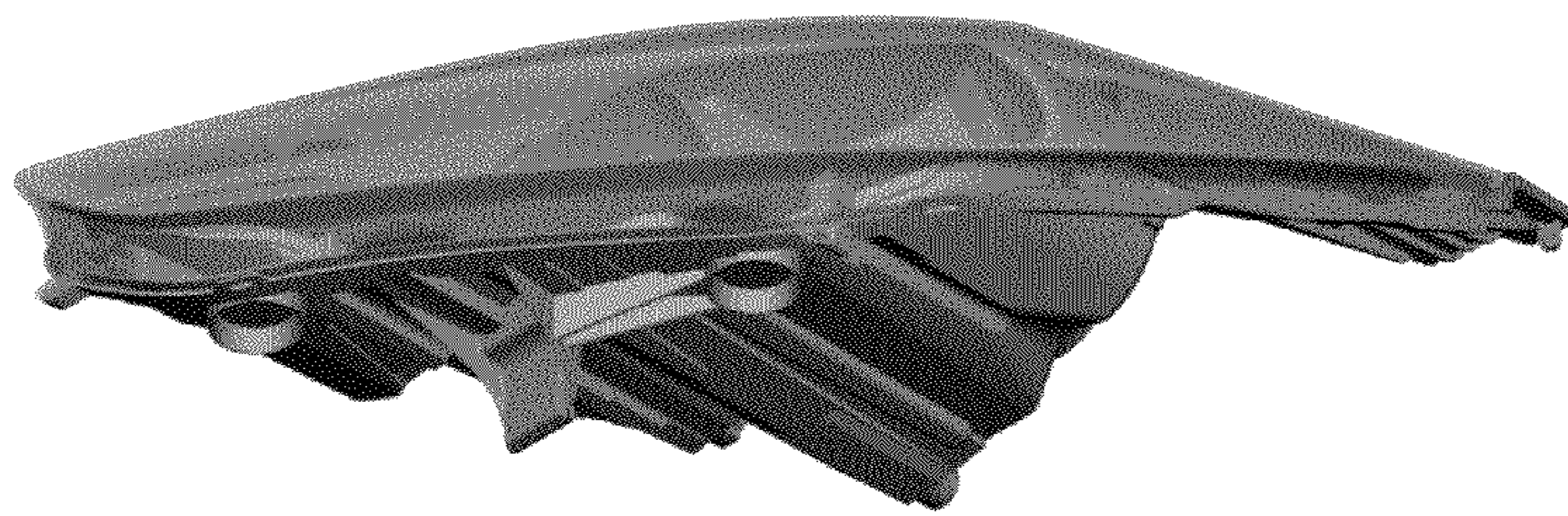

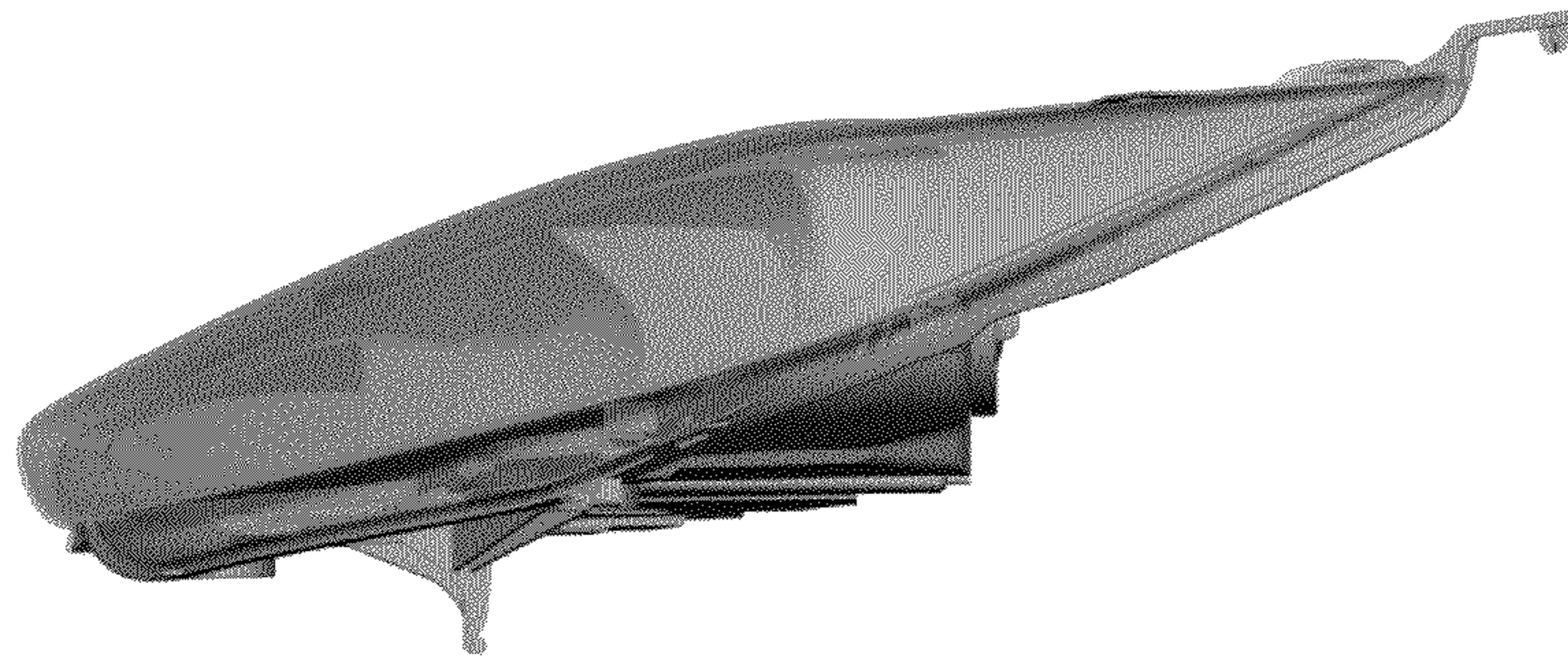

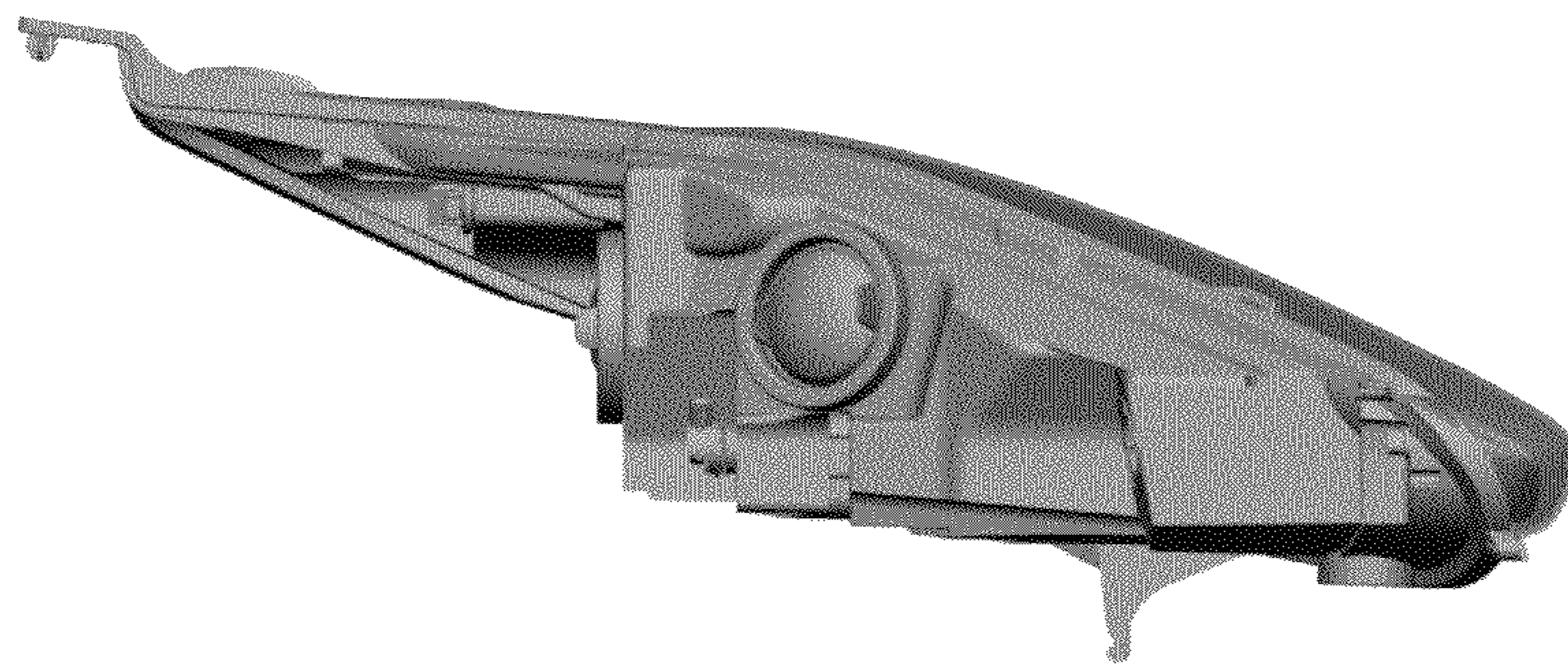

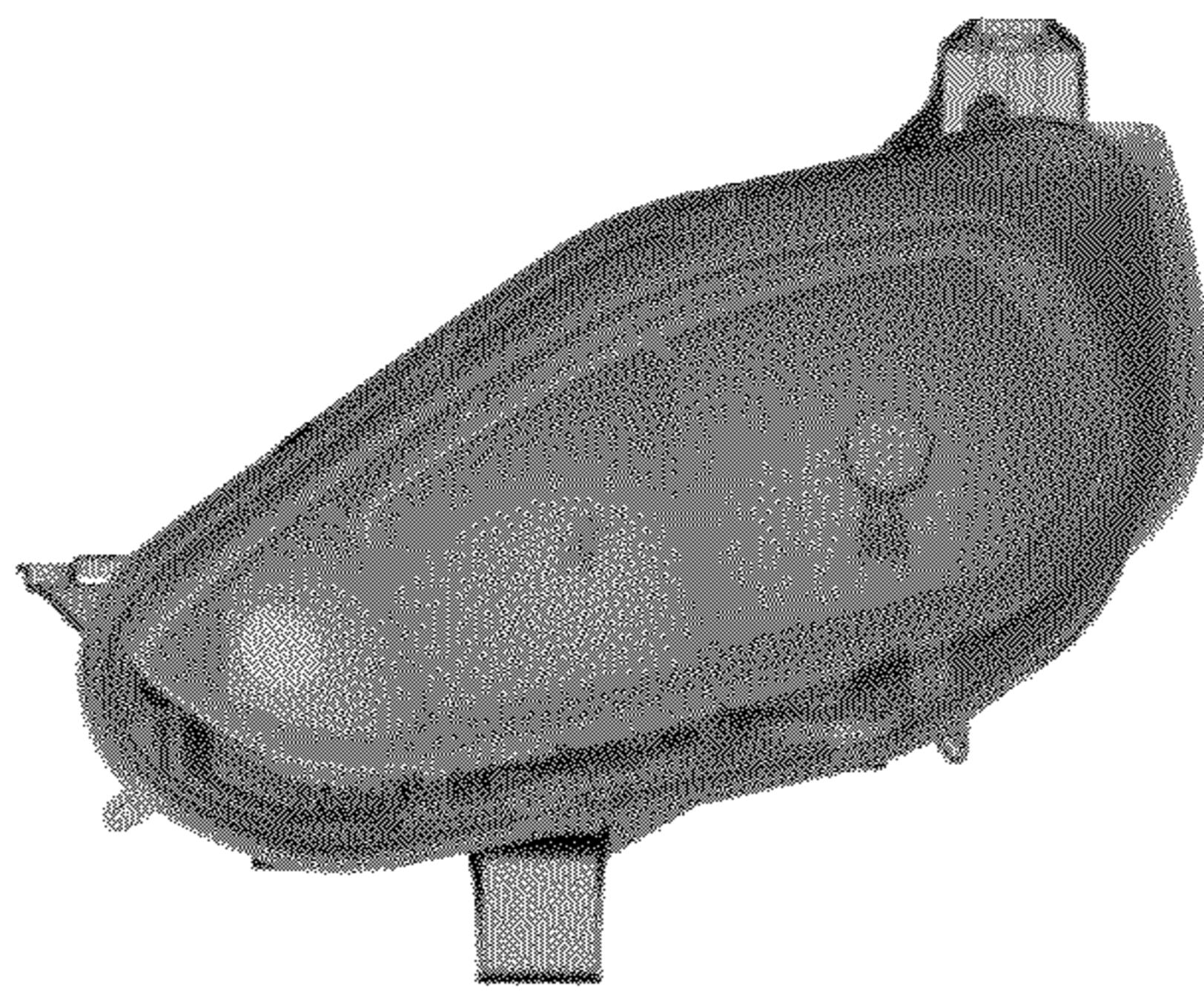

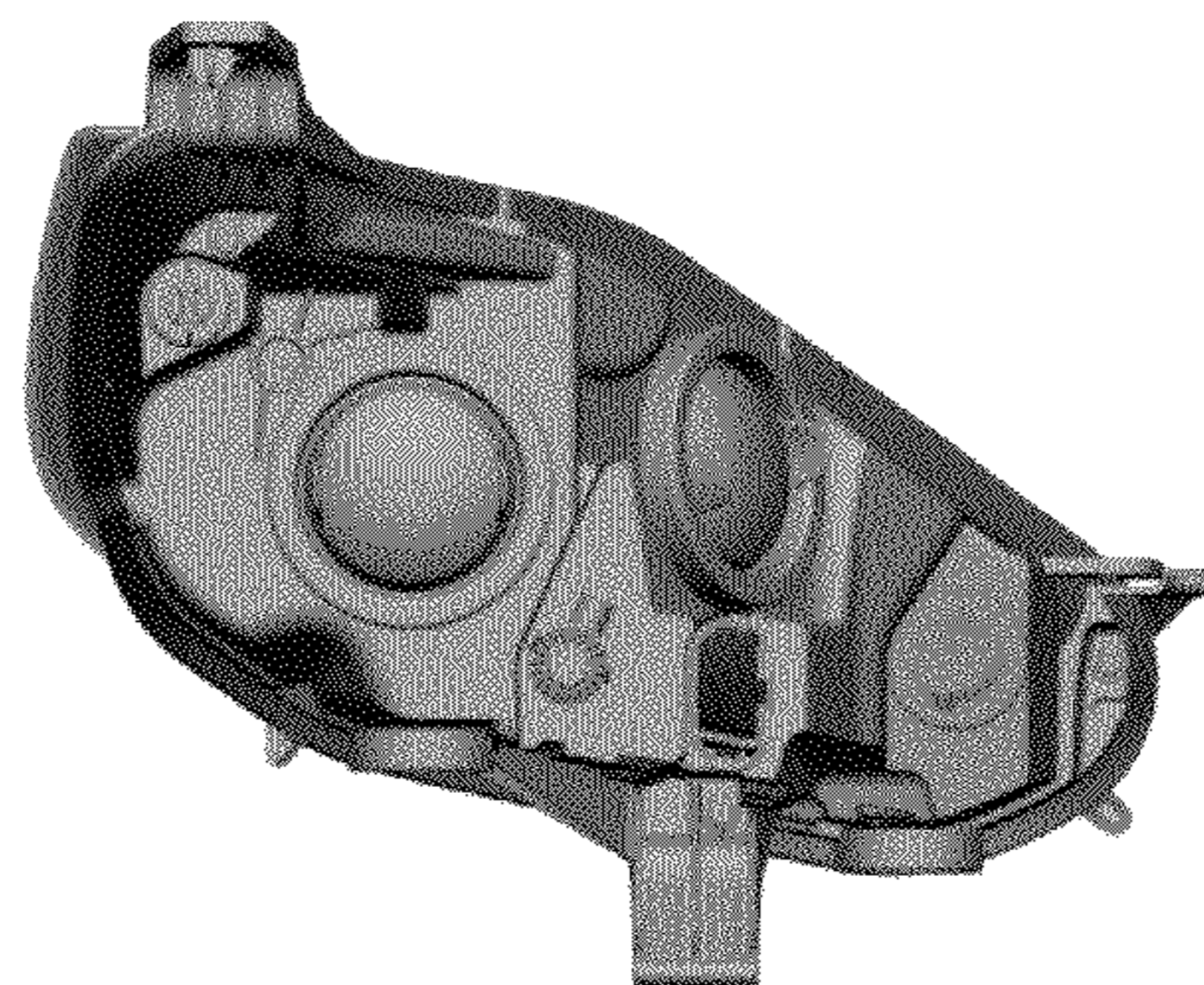

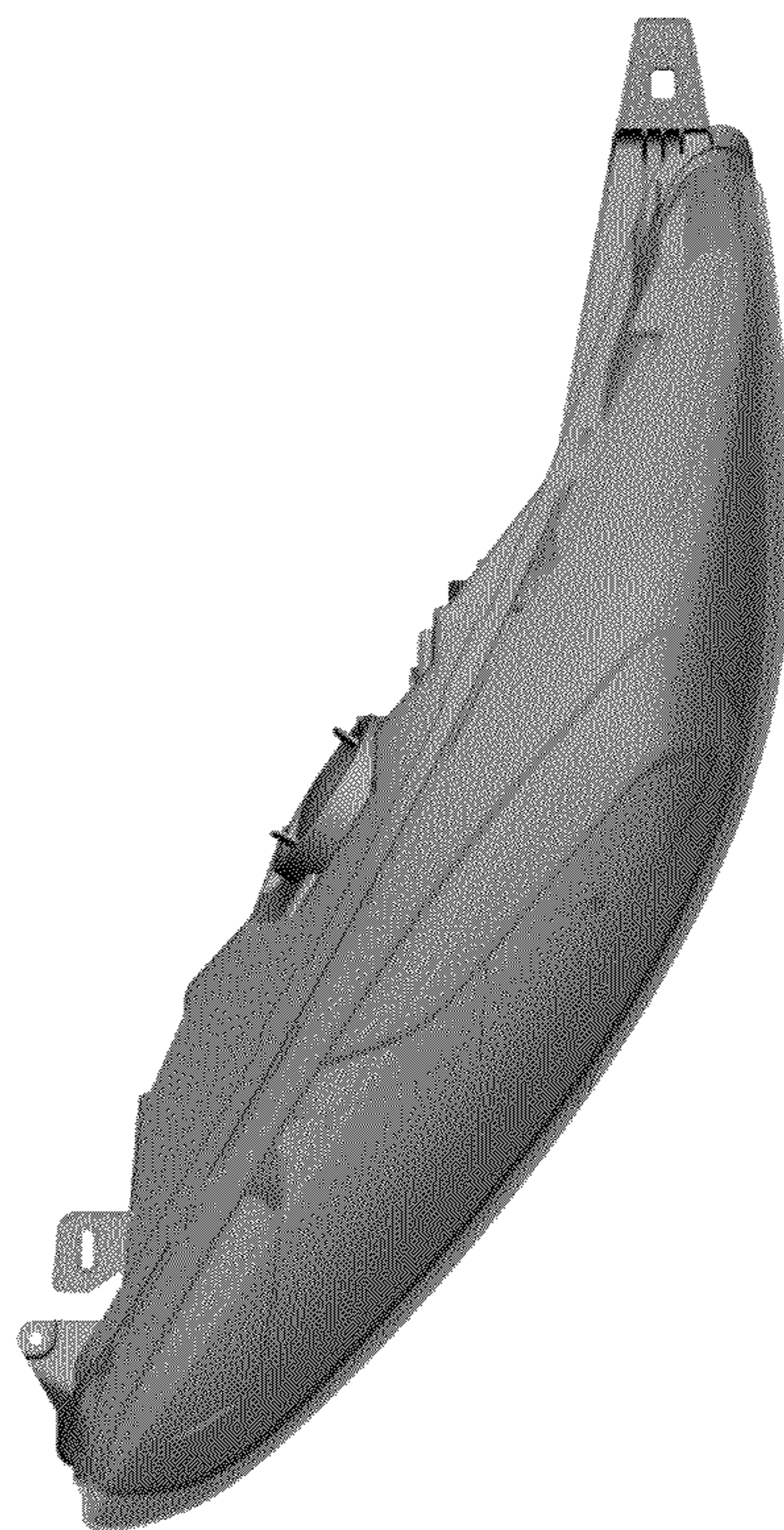

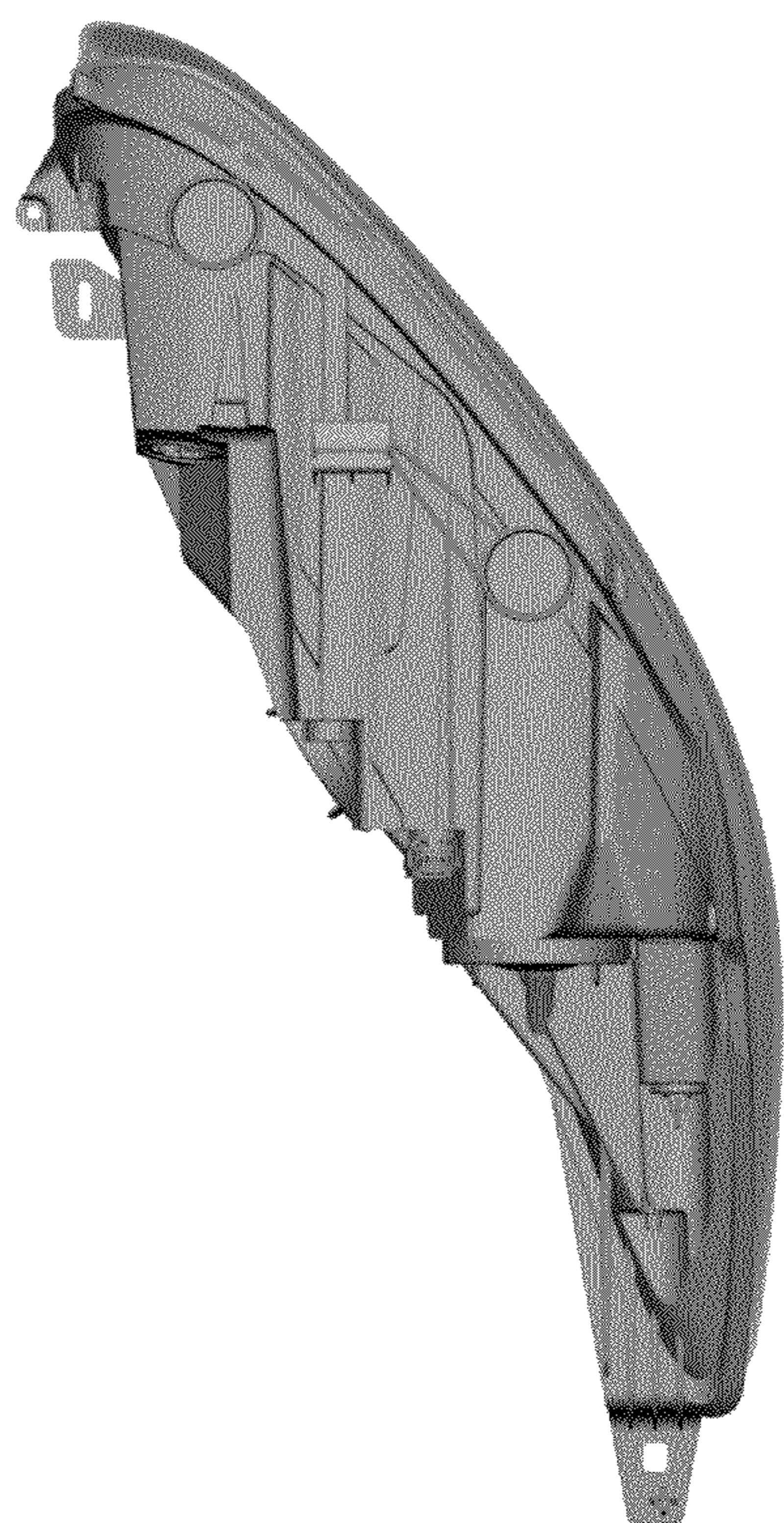

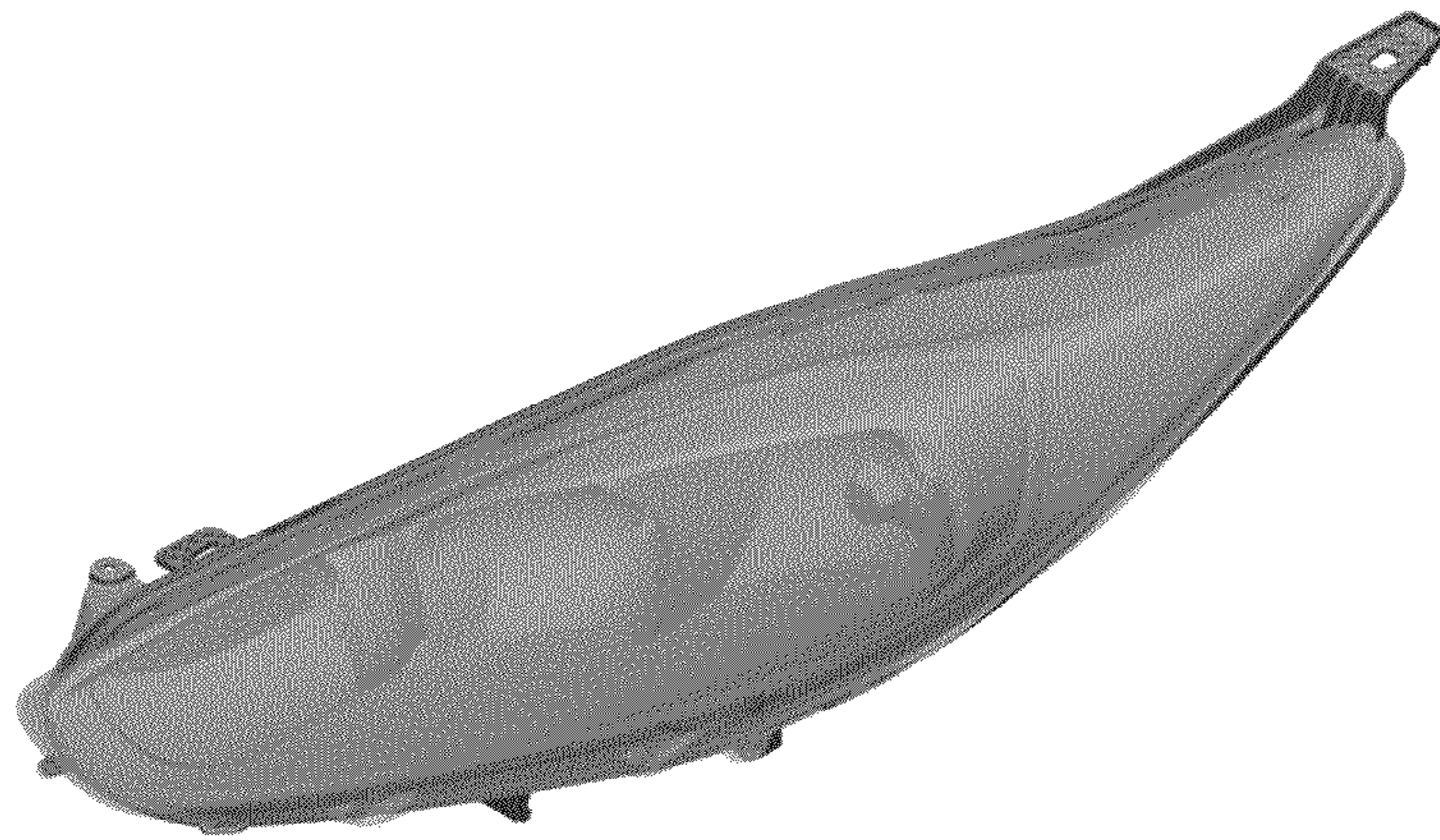

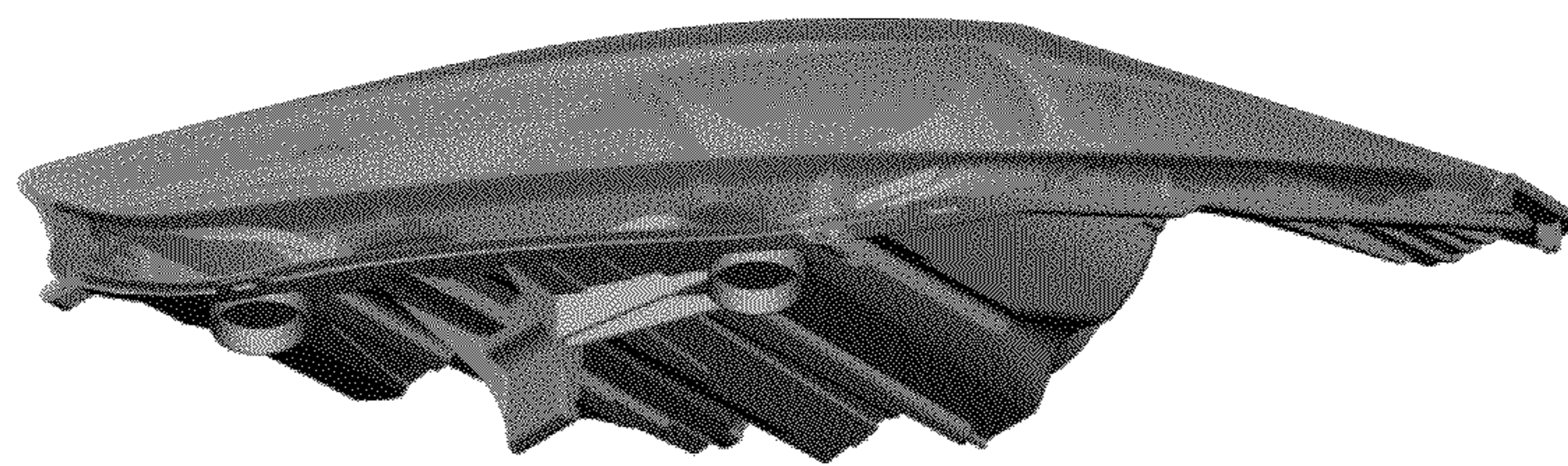

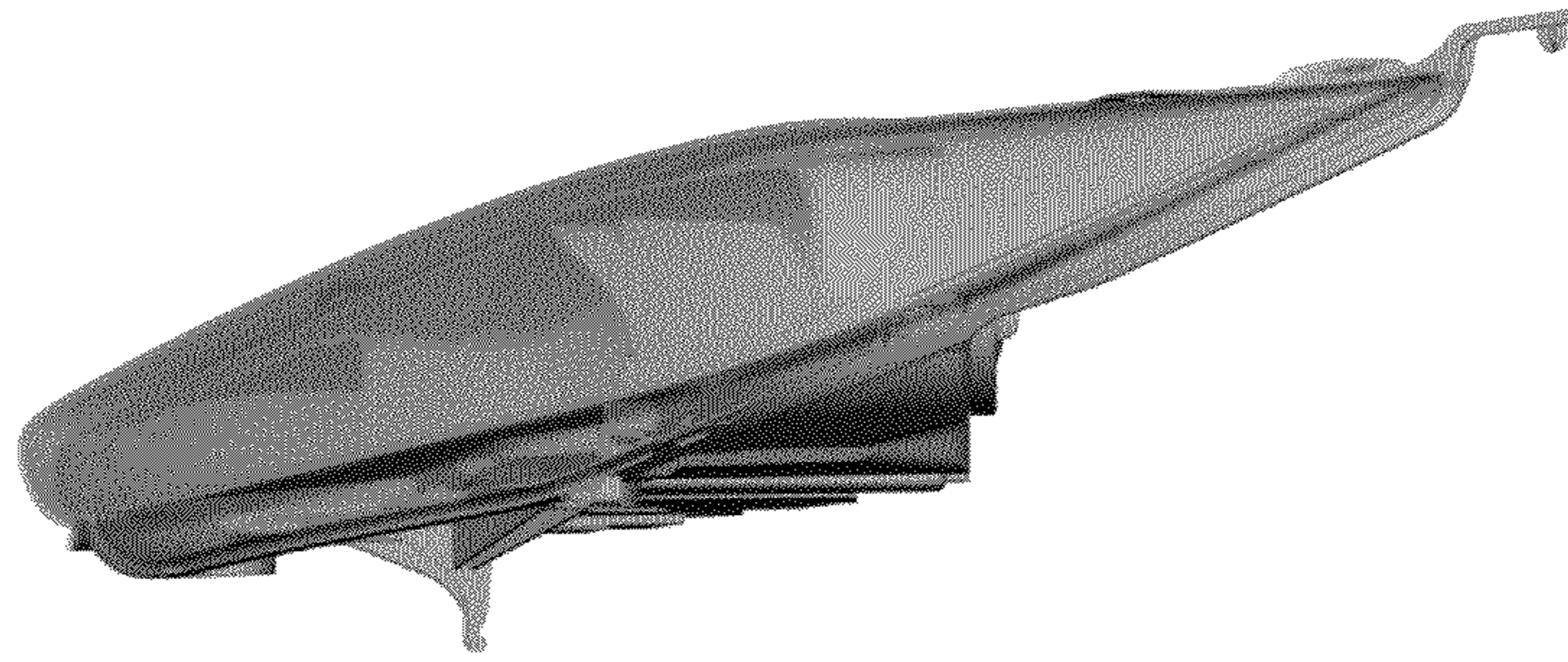

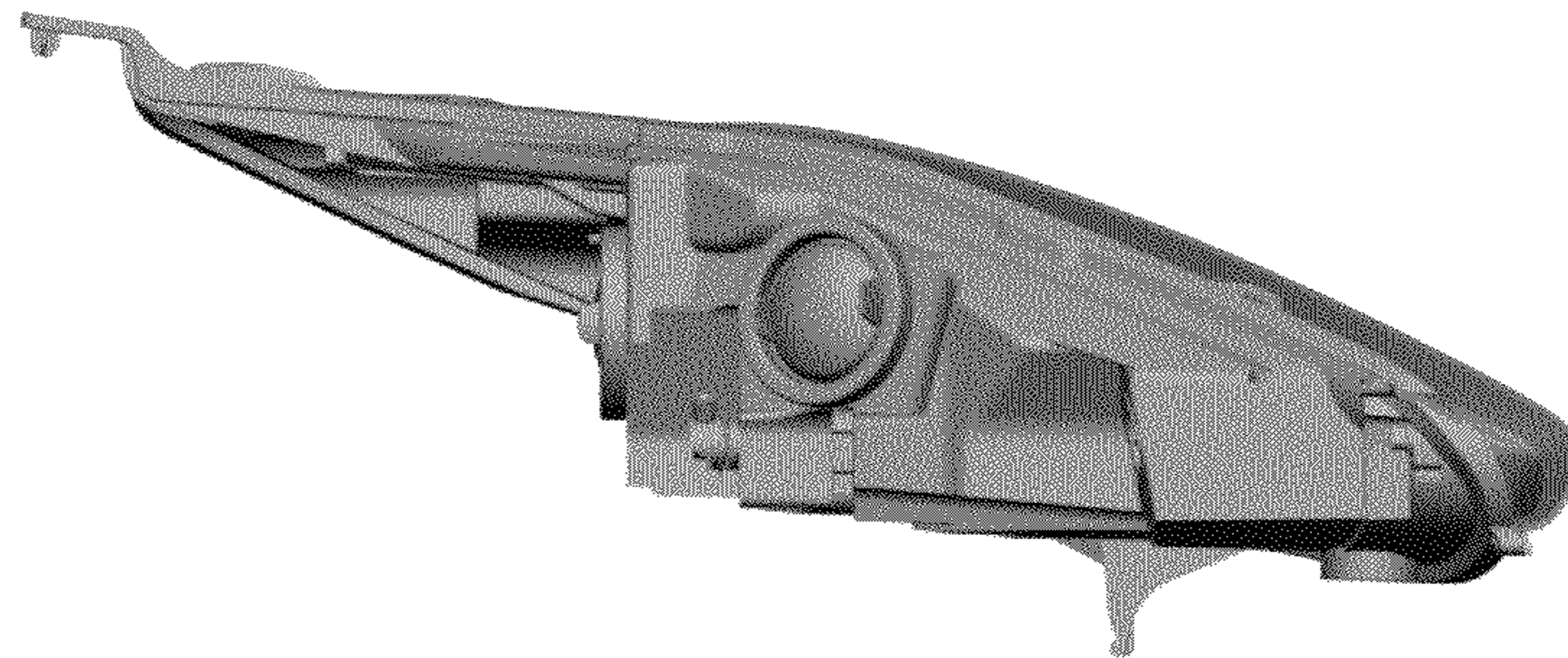

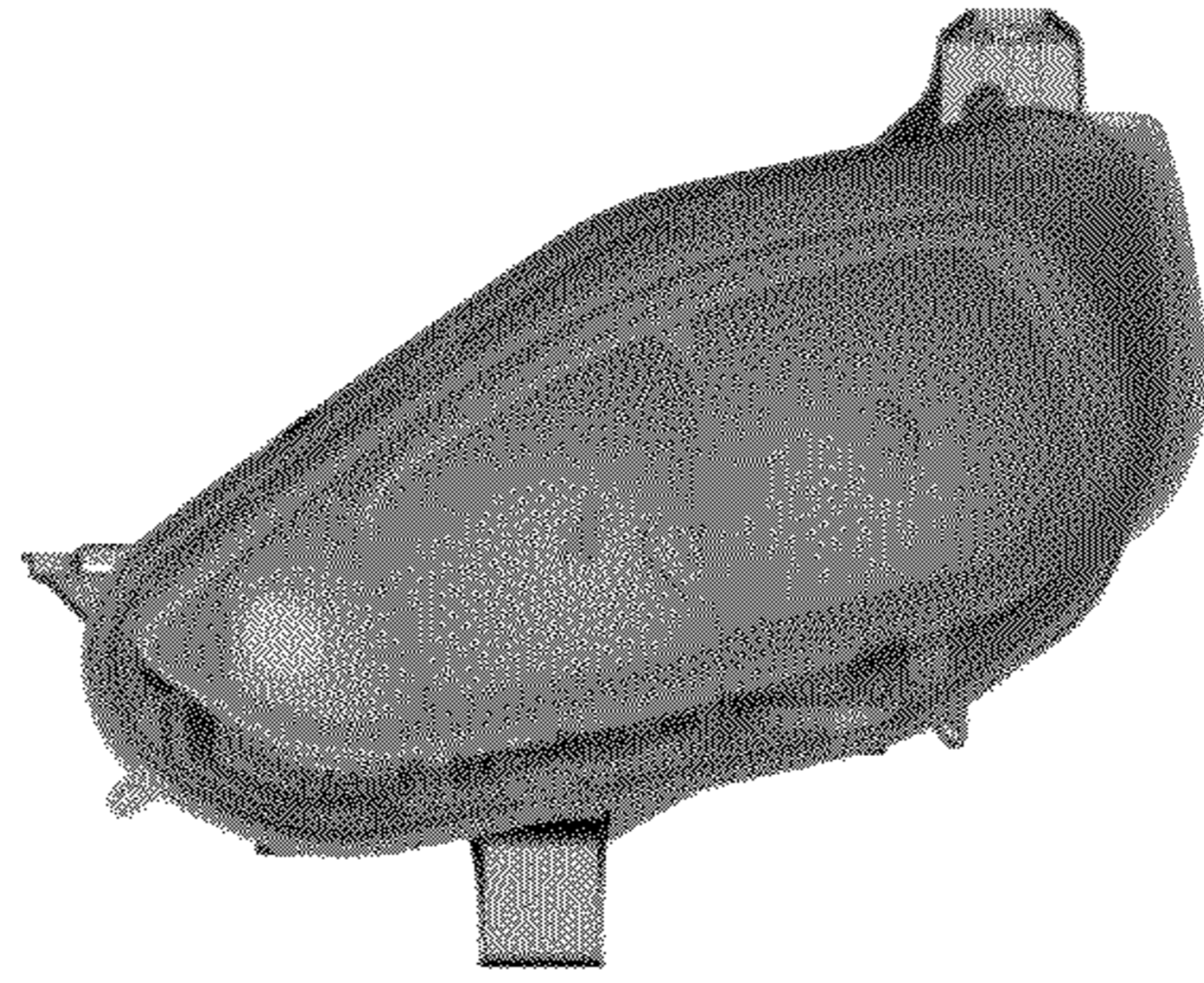

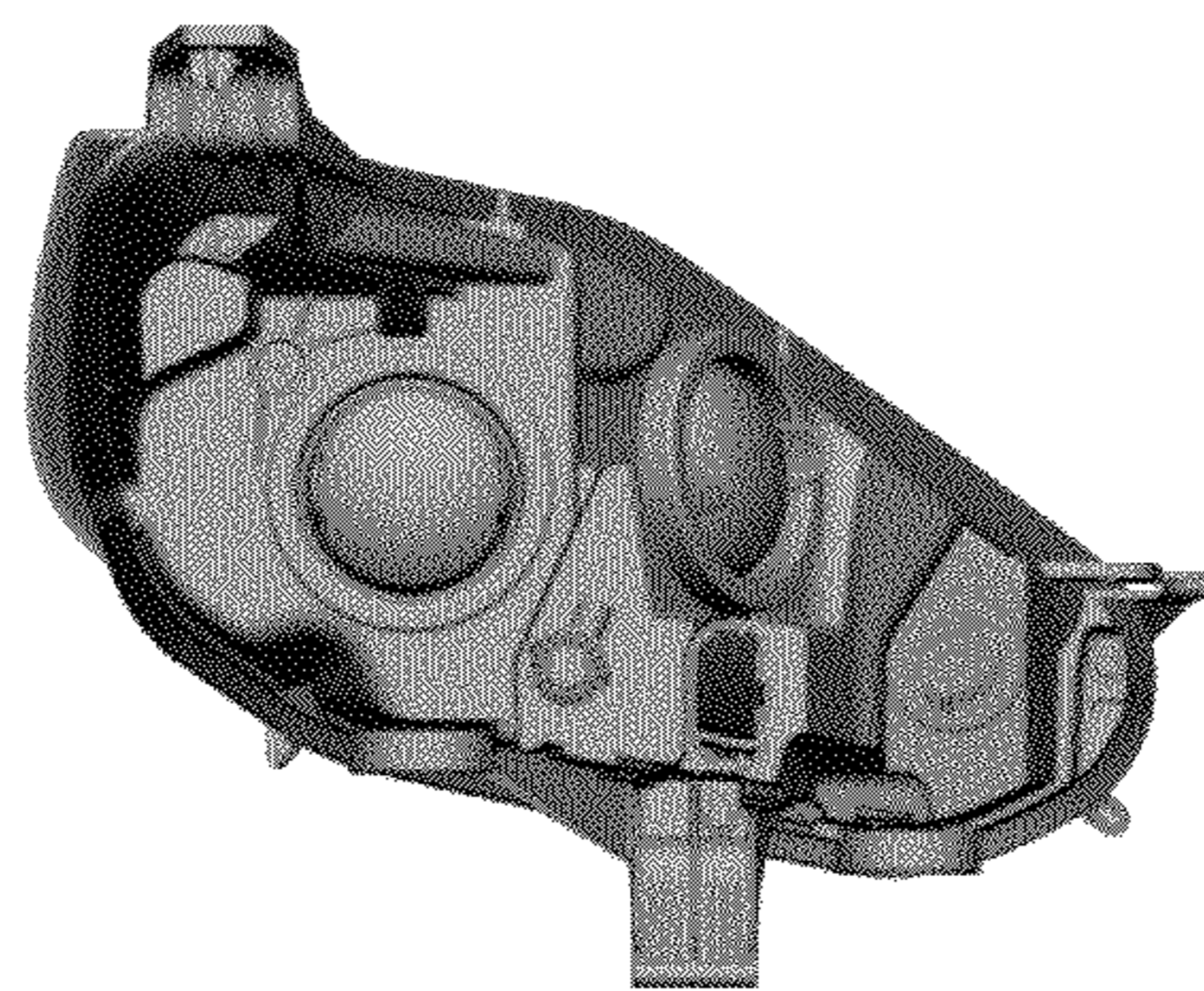

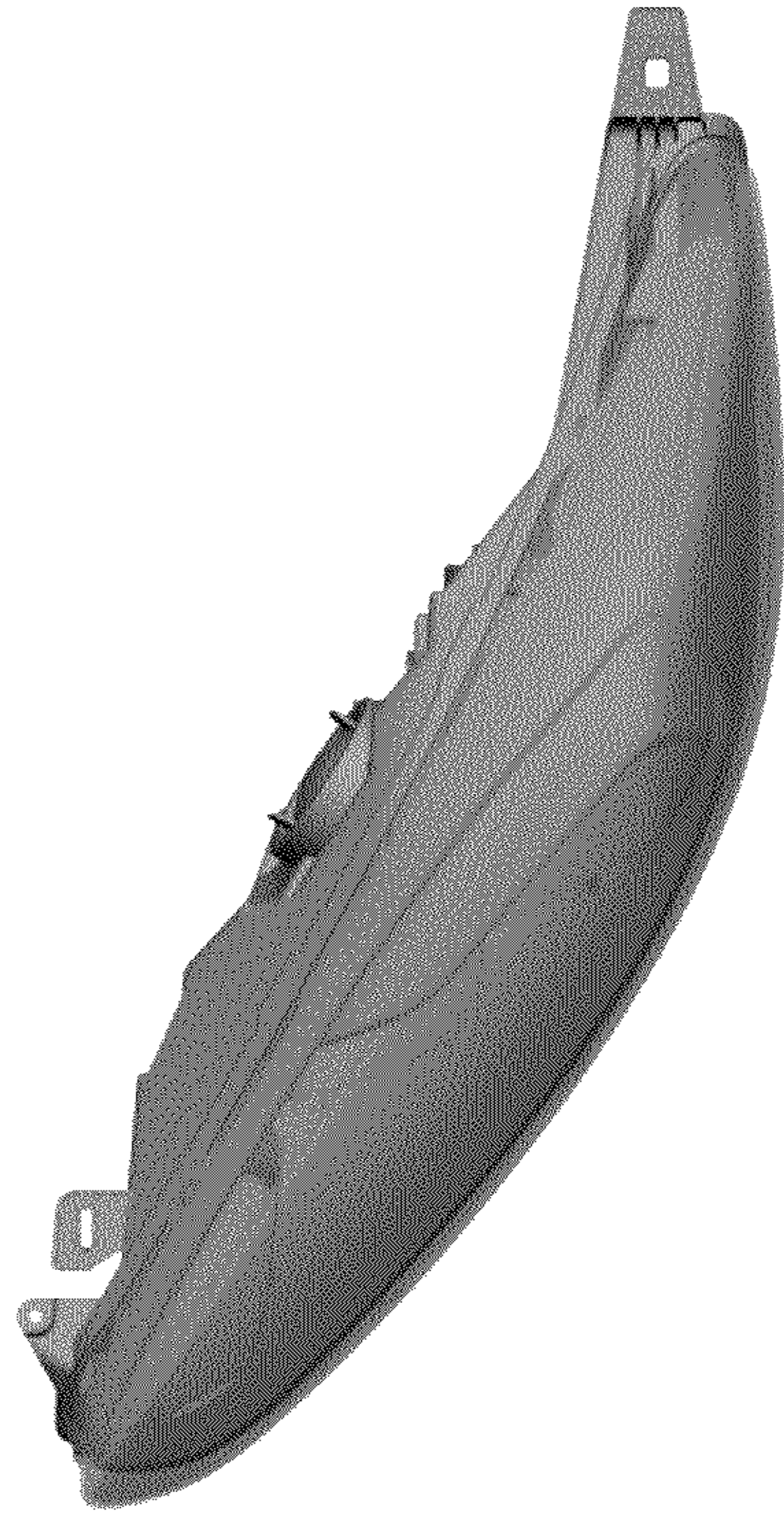

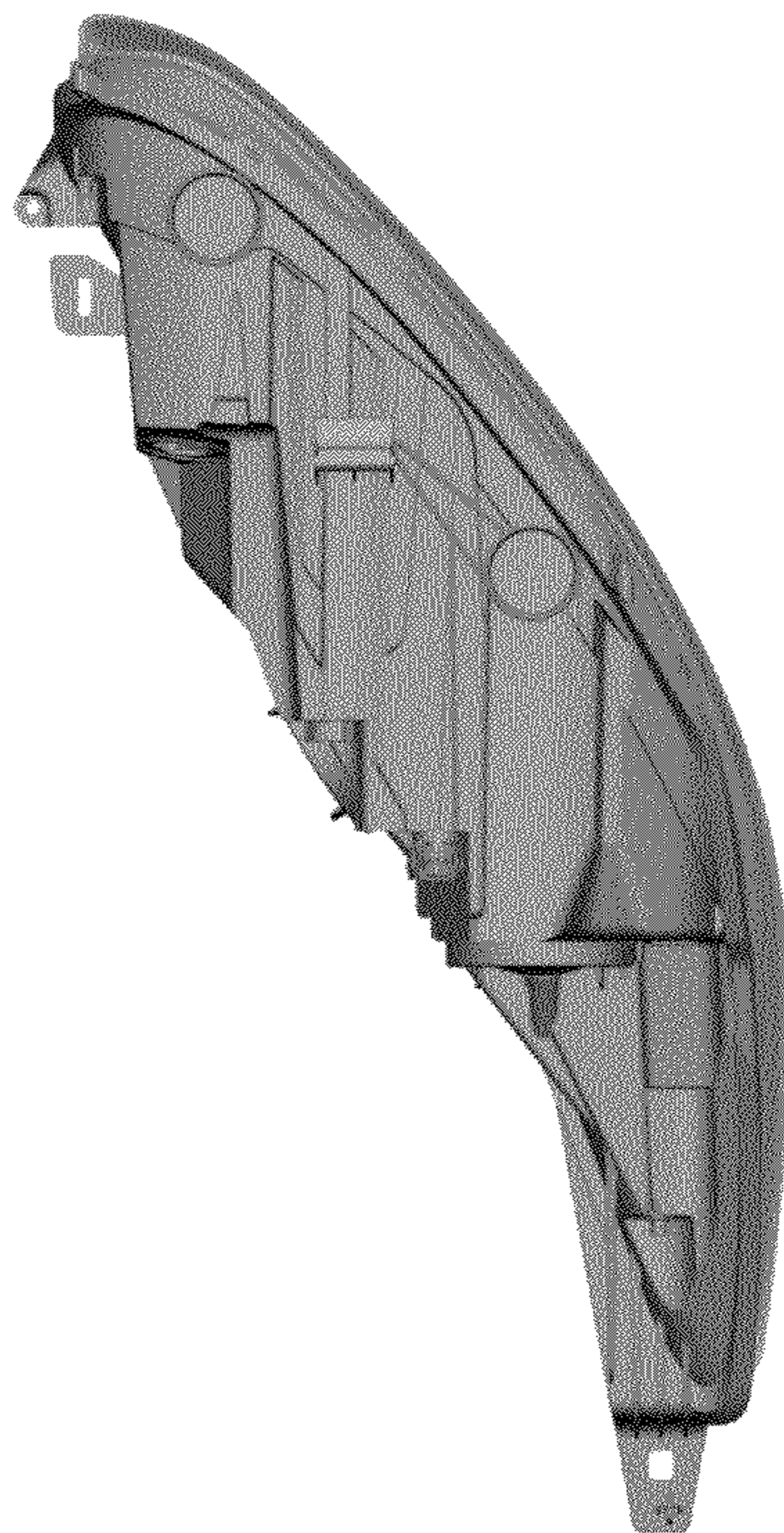

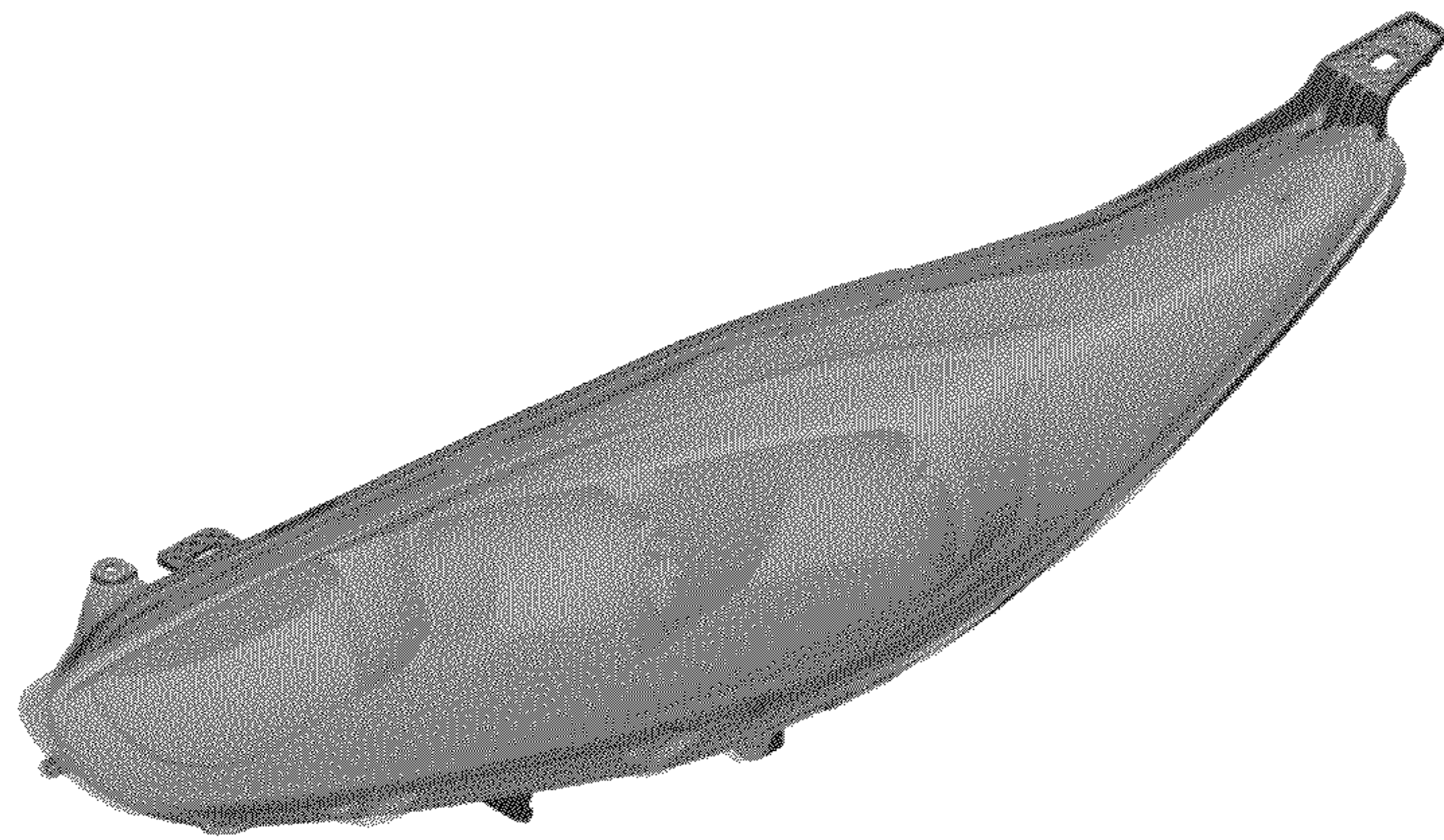

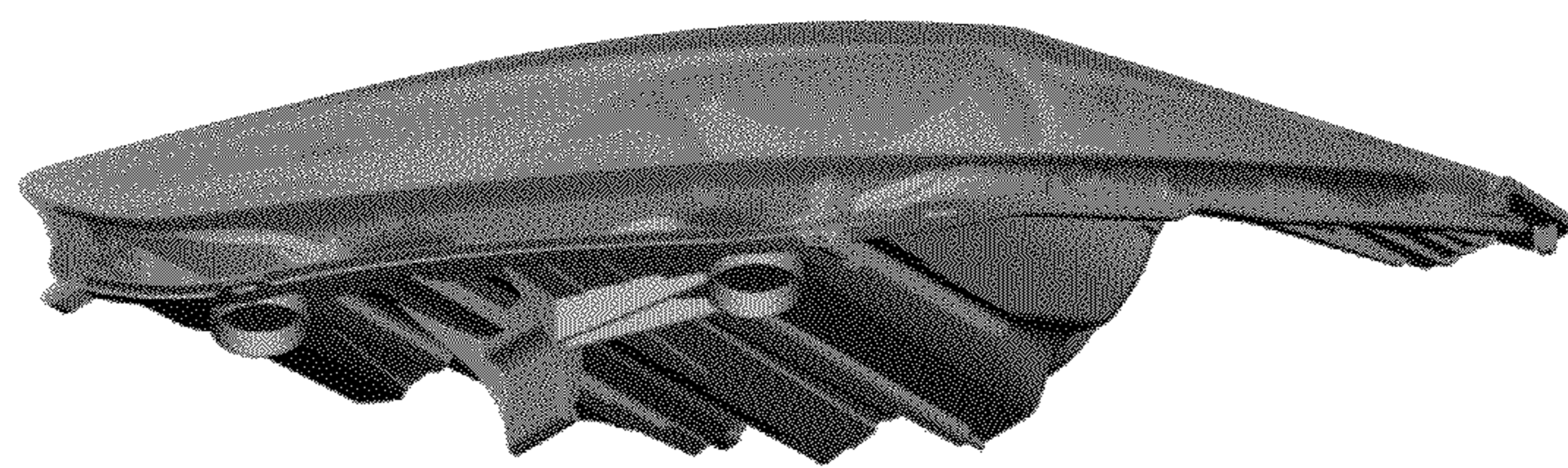

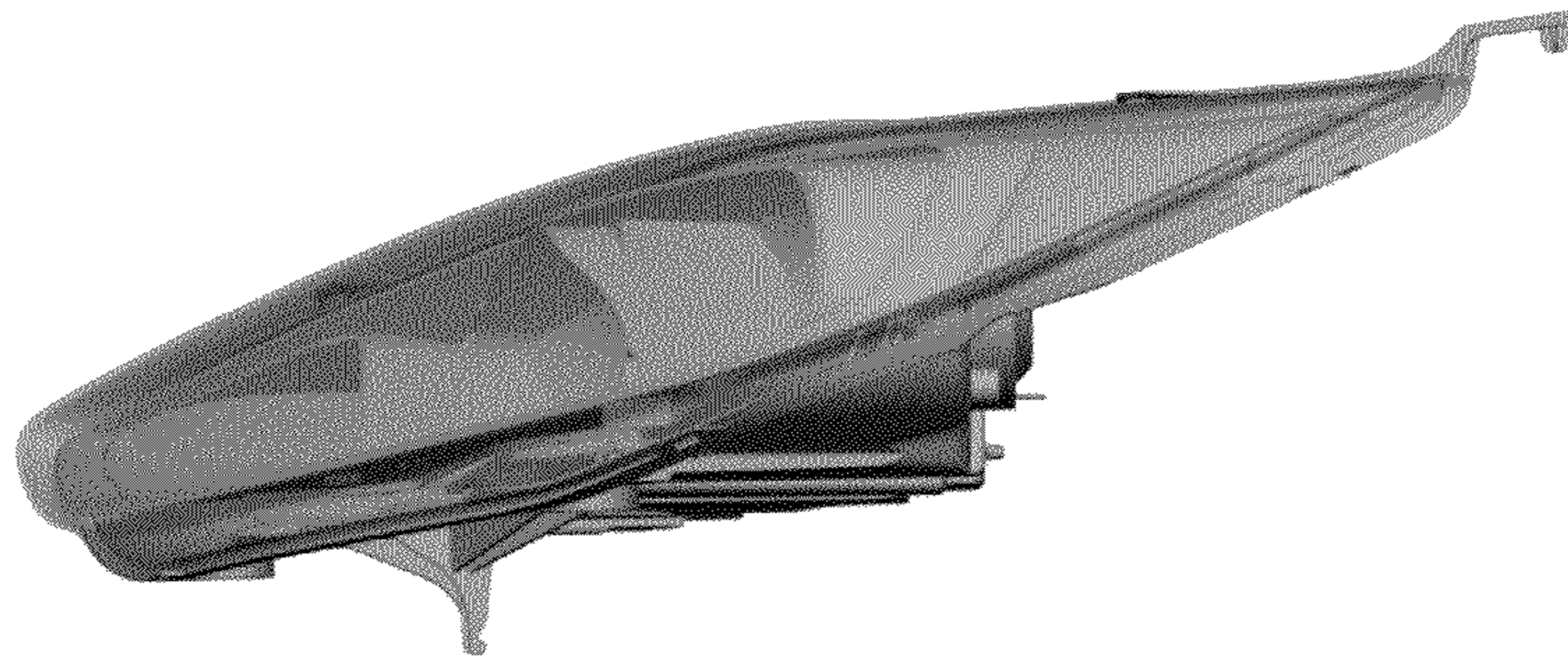

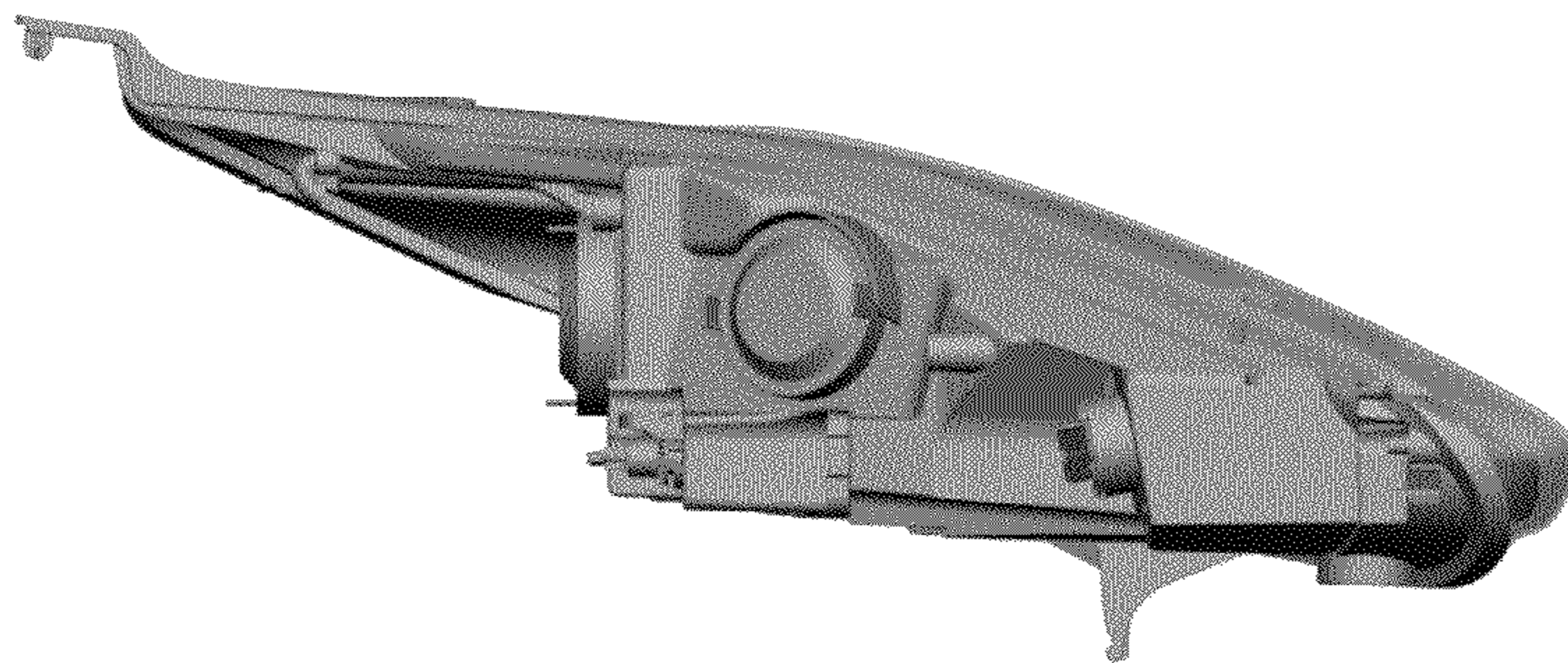

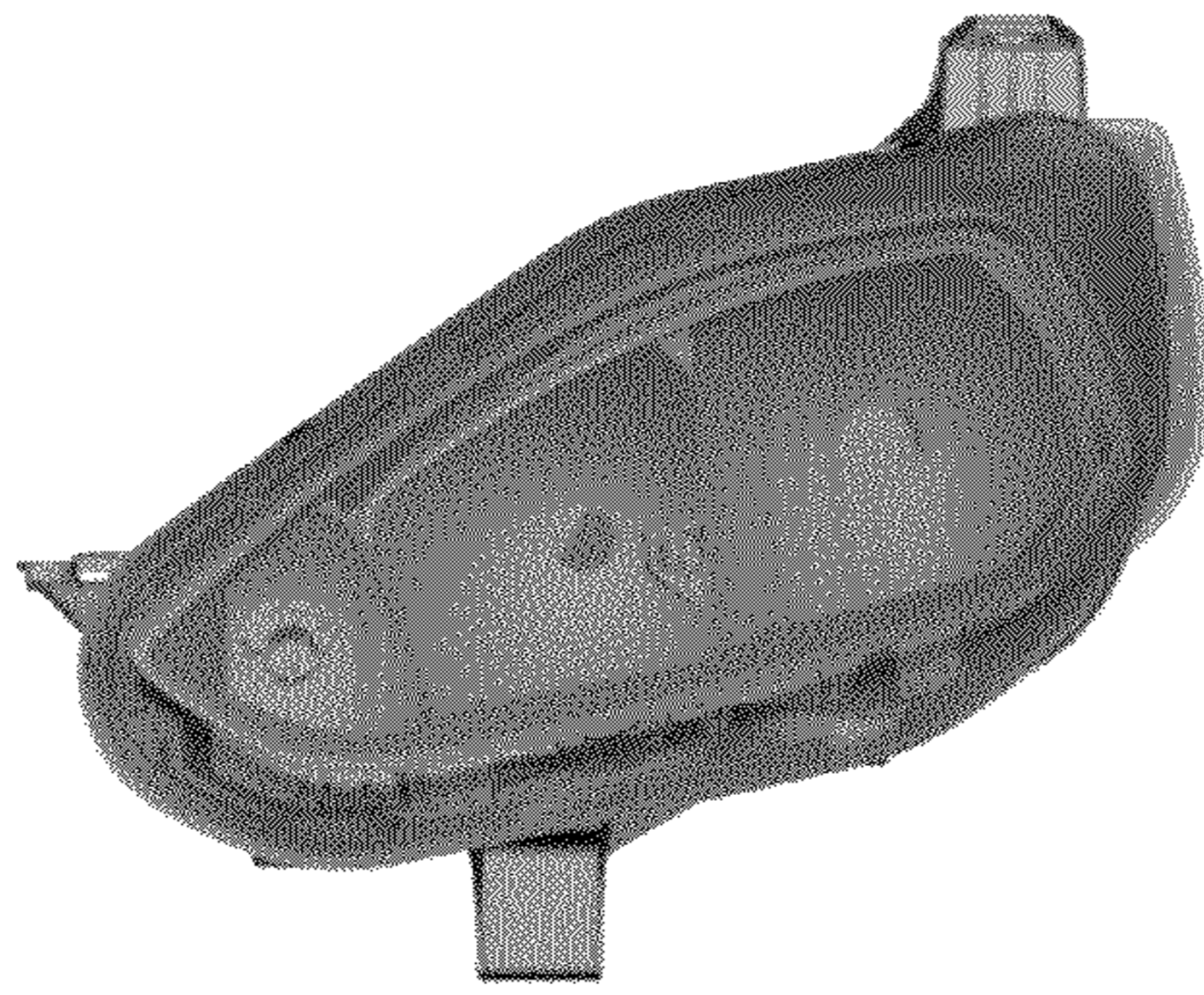

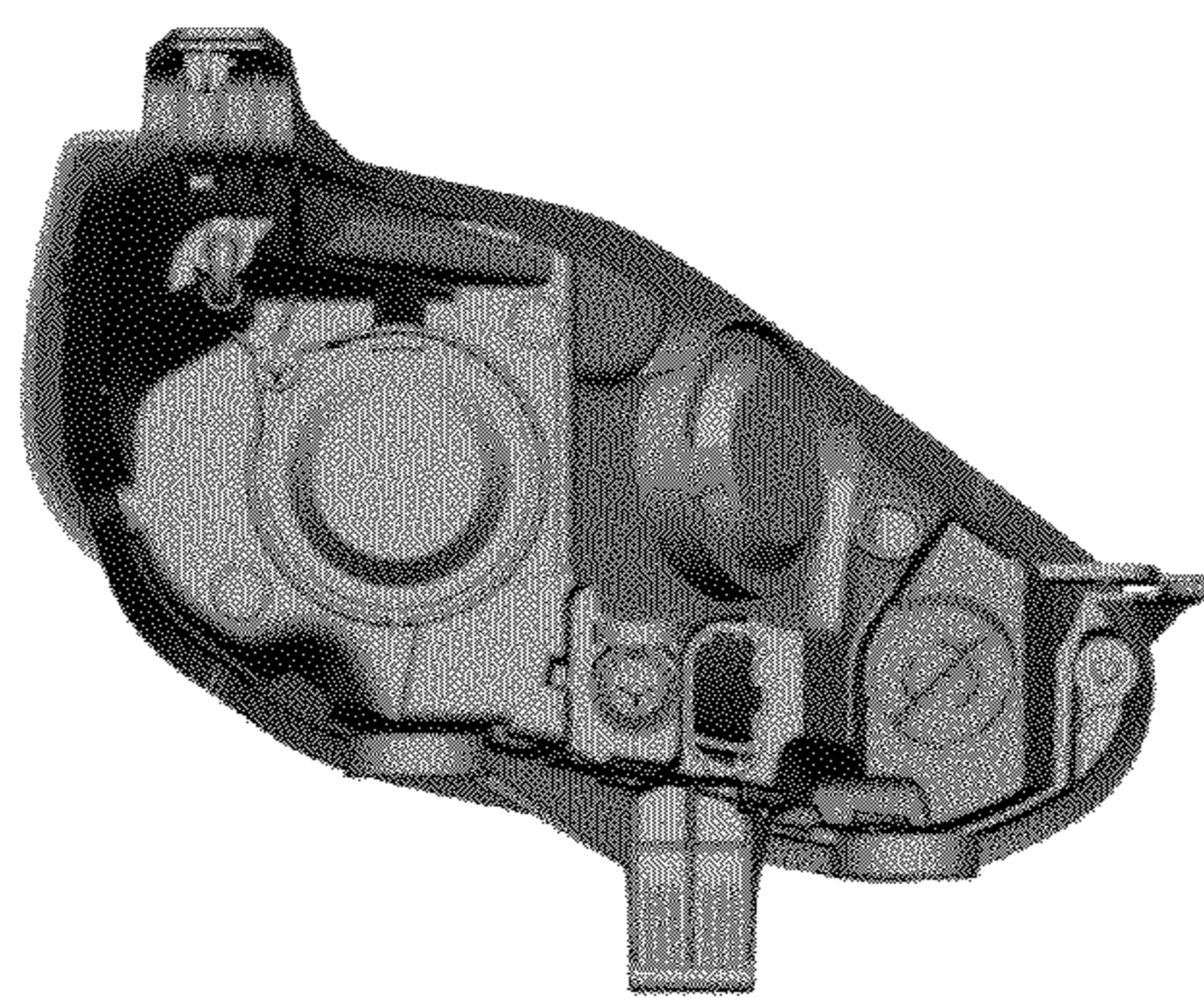

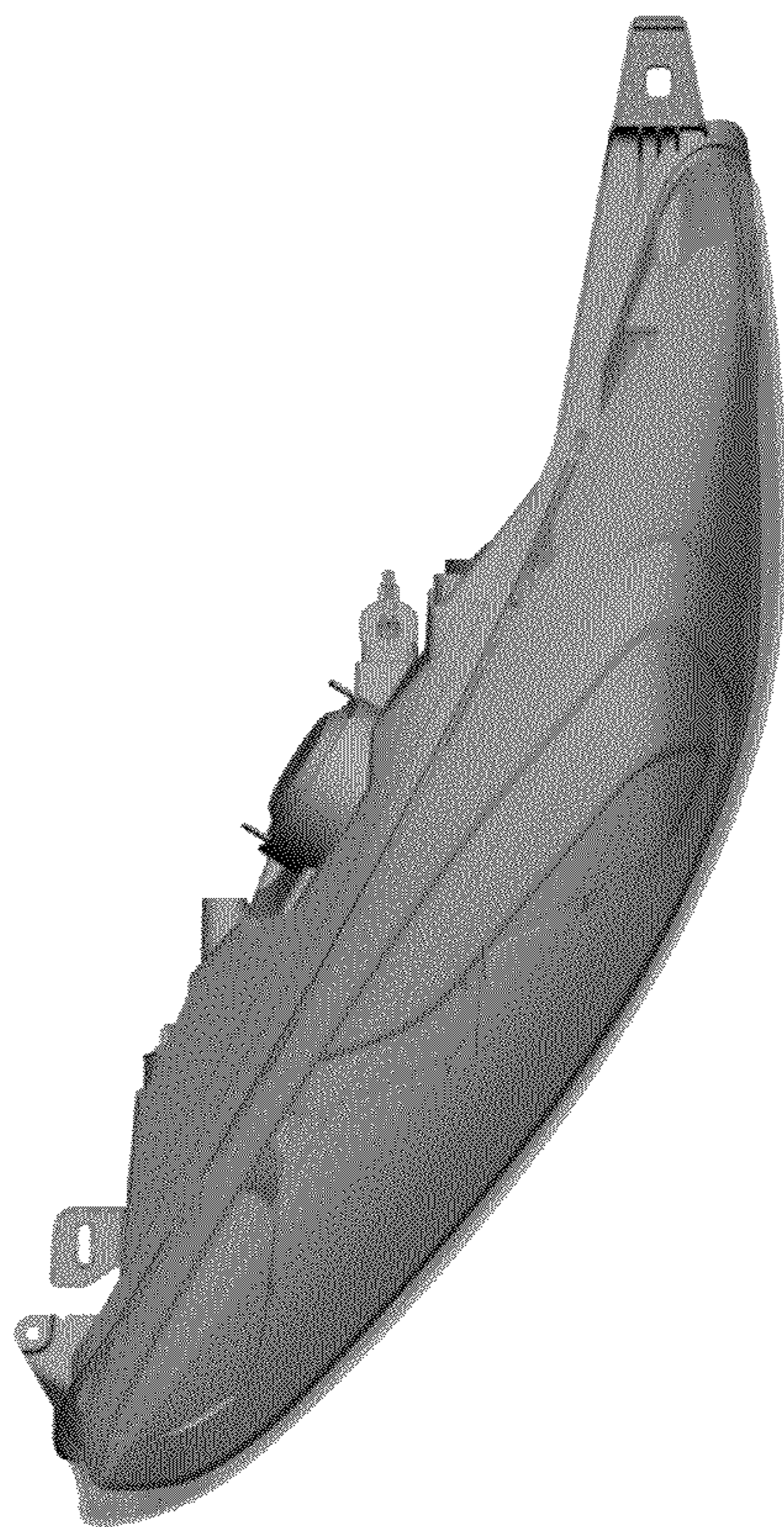

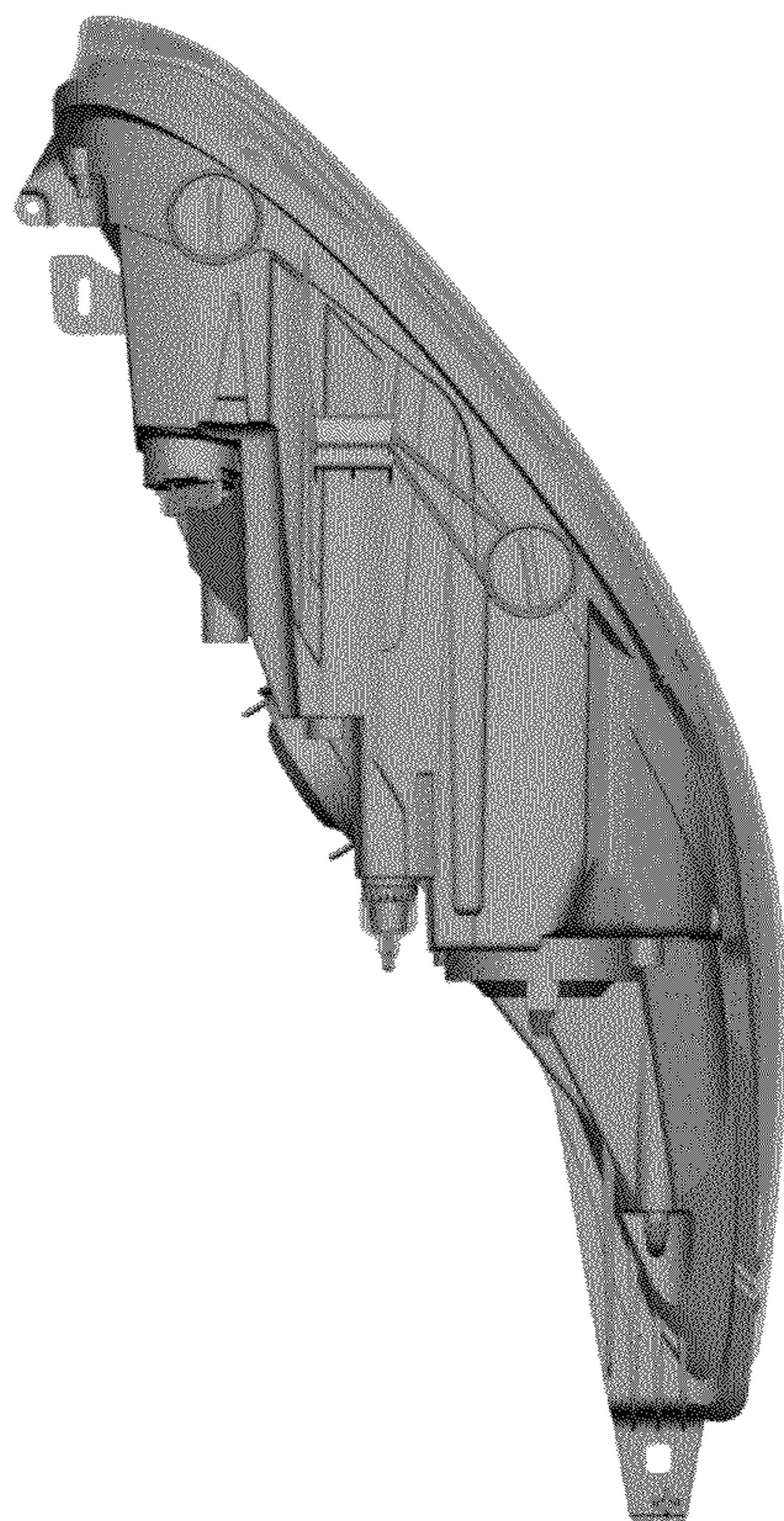

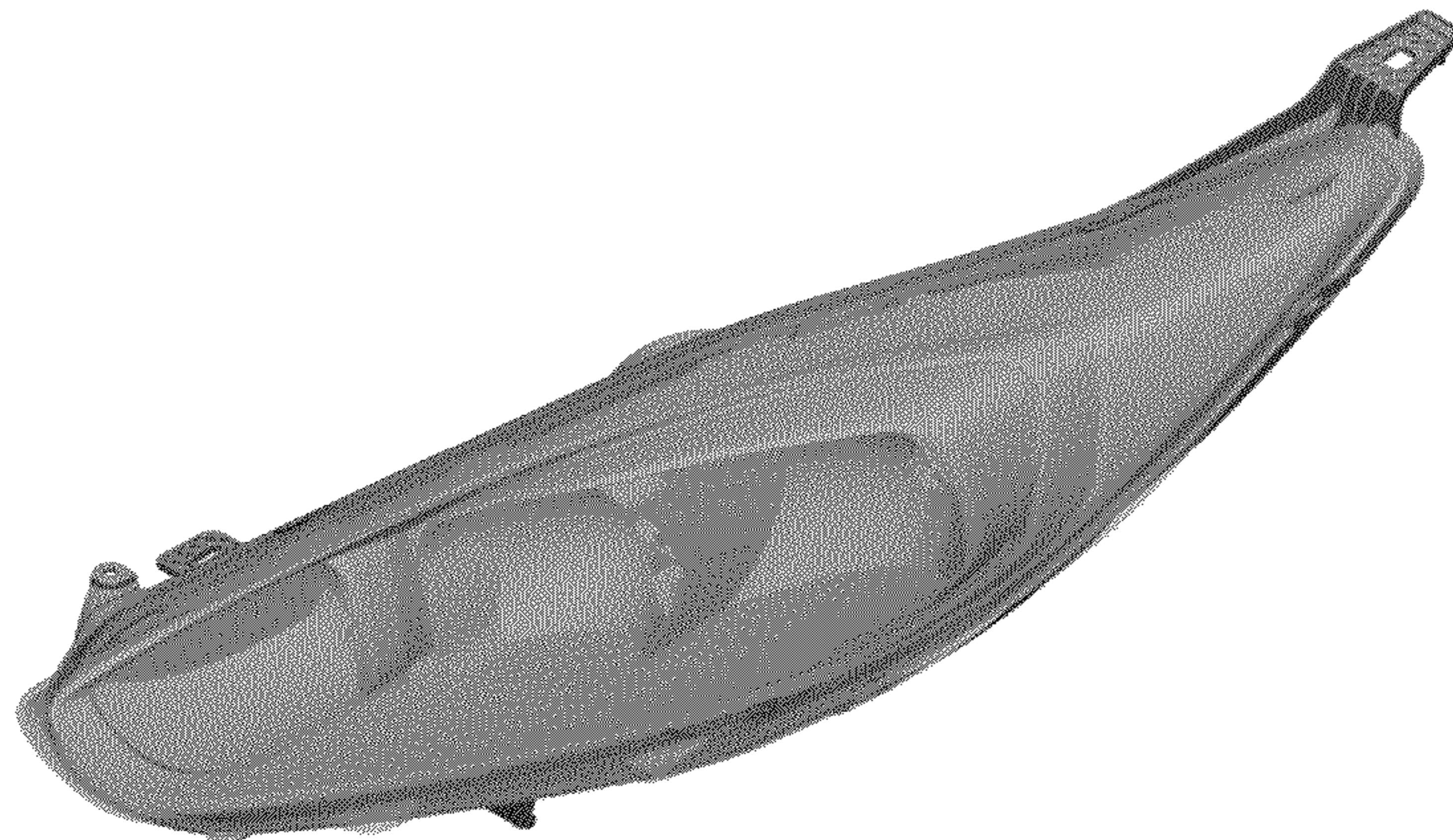

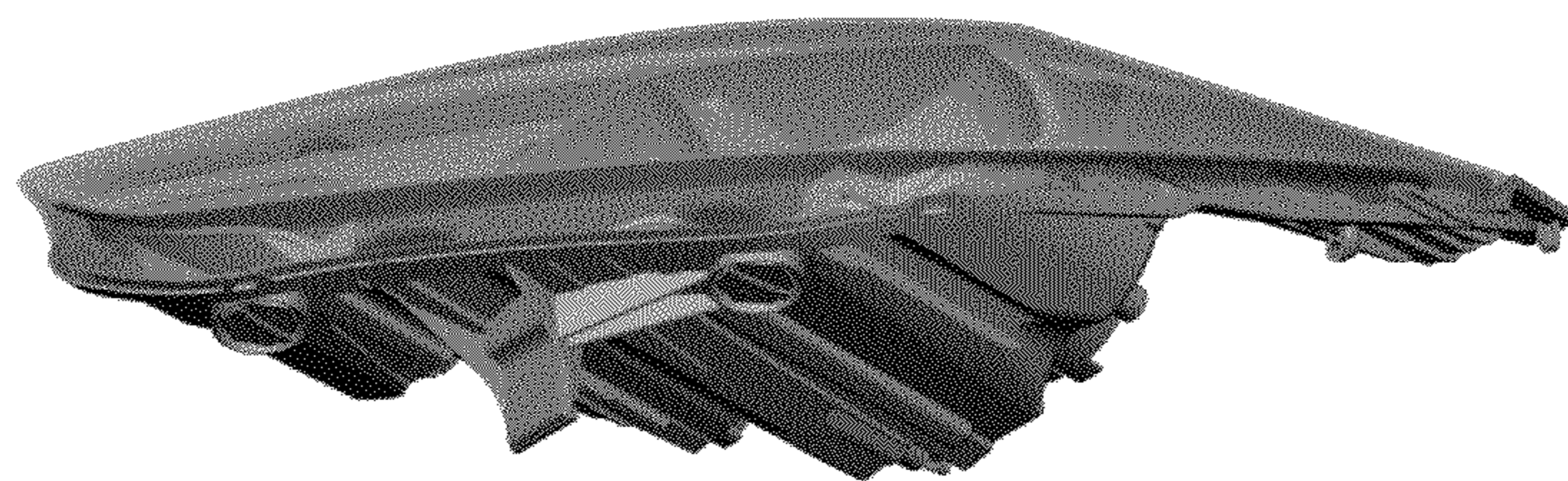
