FIG. 3 is a back end view of the axis pet chew of FIG. 1;

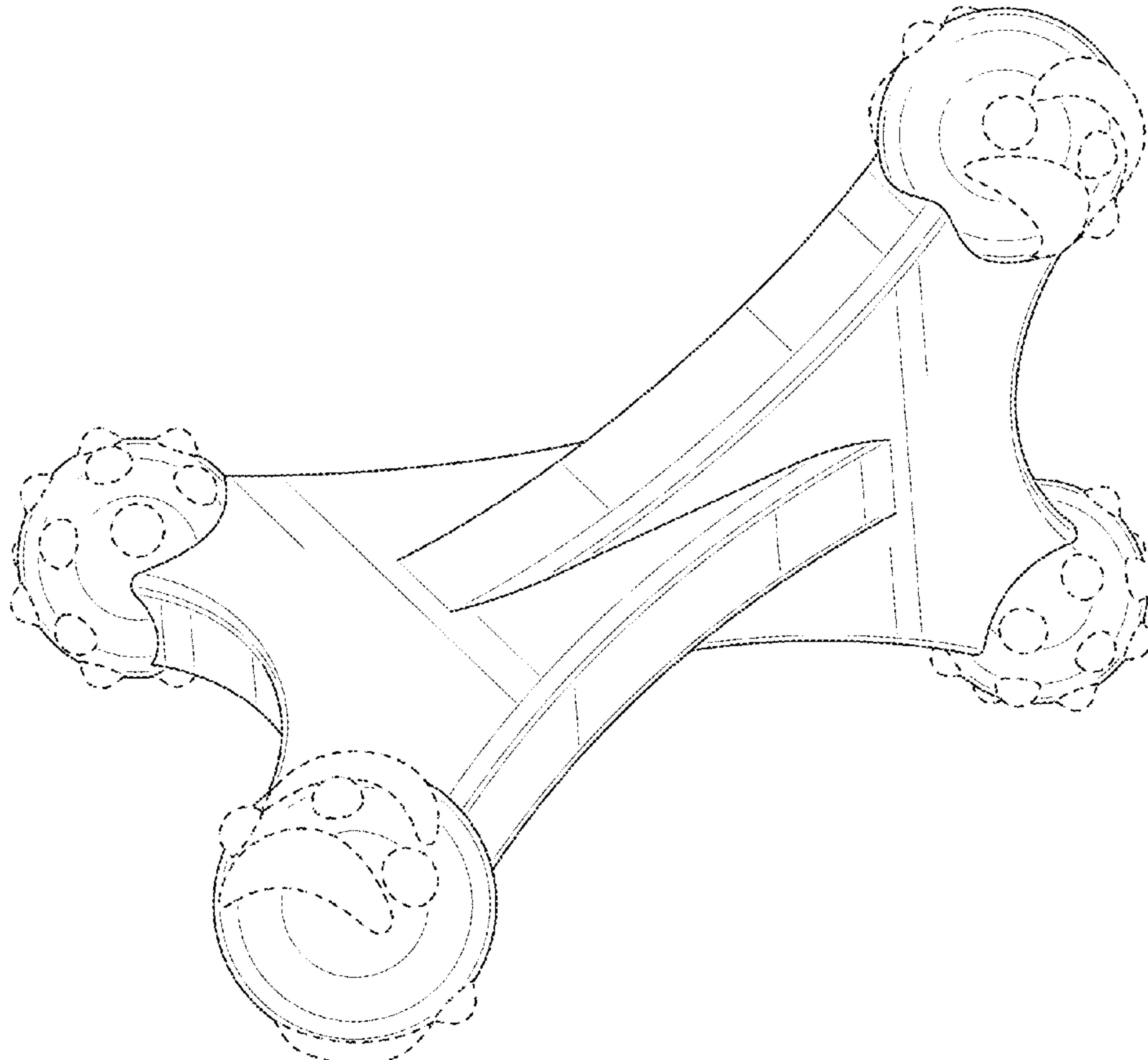
FIG. 4 is a left side view of the axis pet chew of FIG. 1;

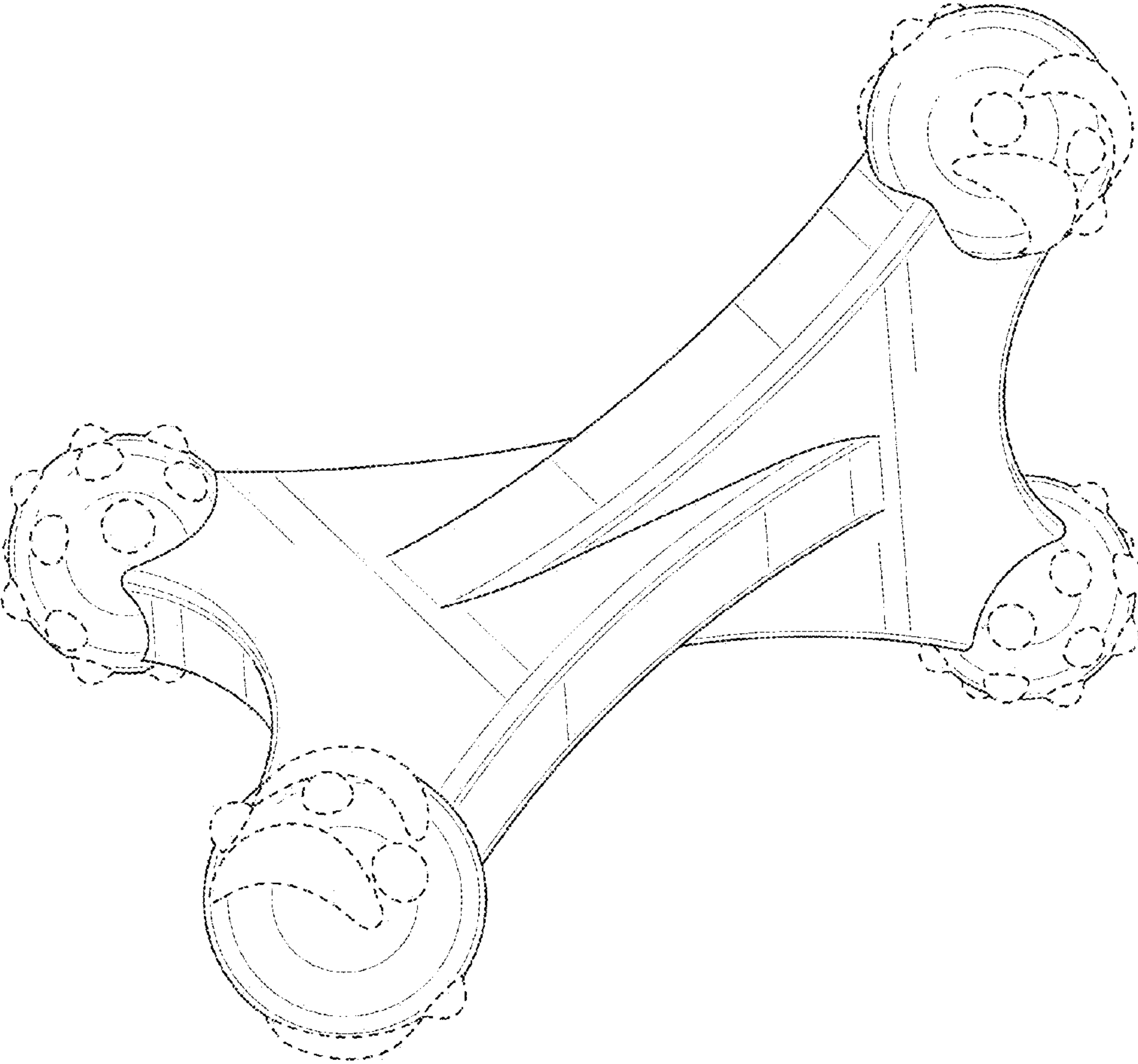

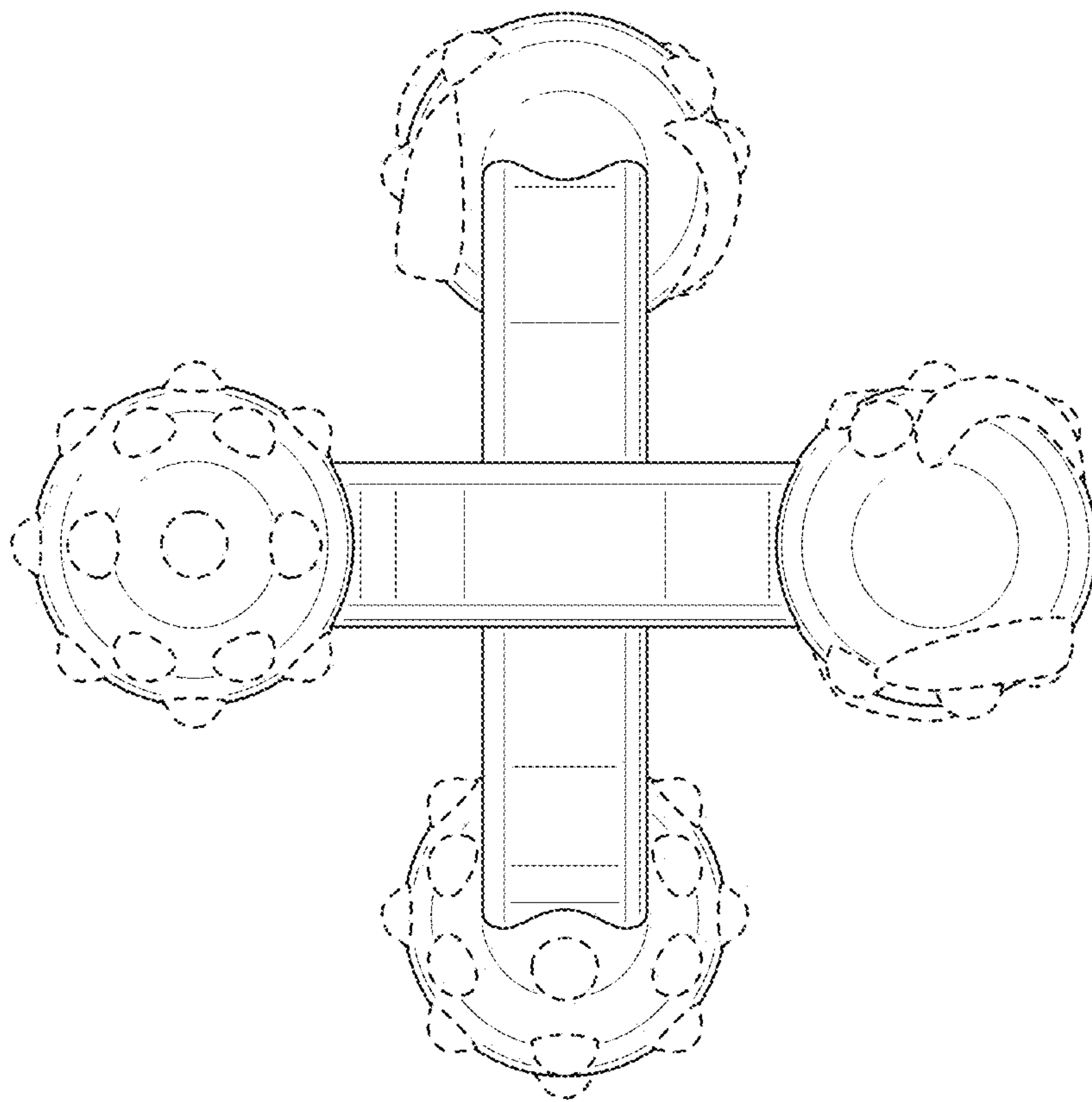

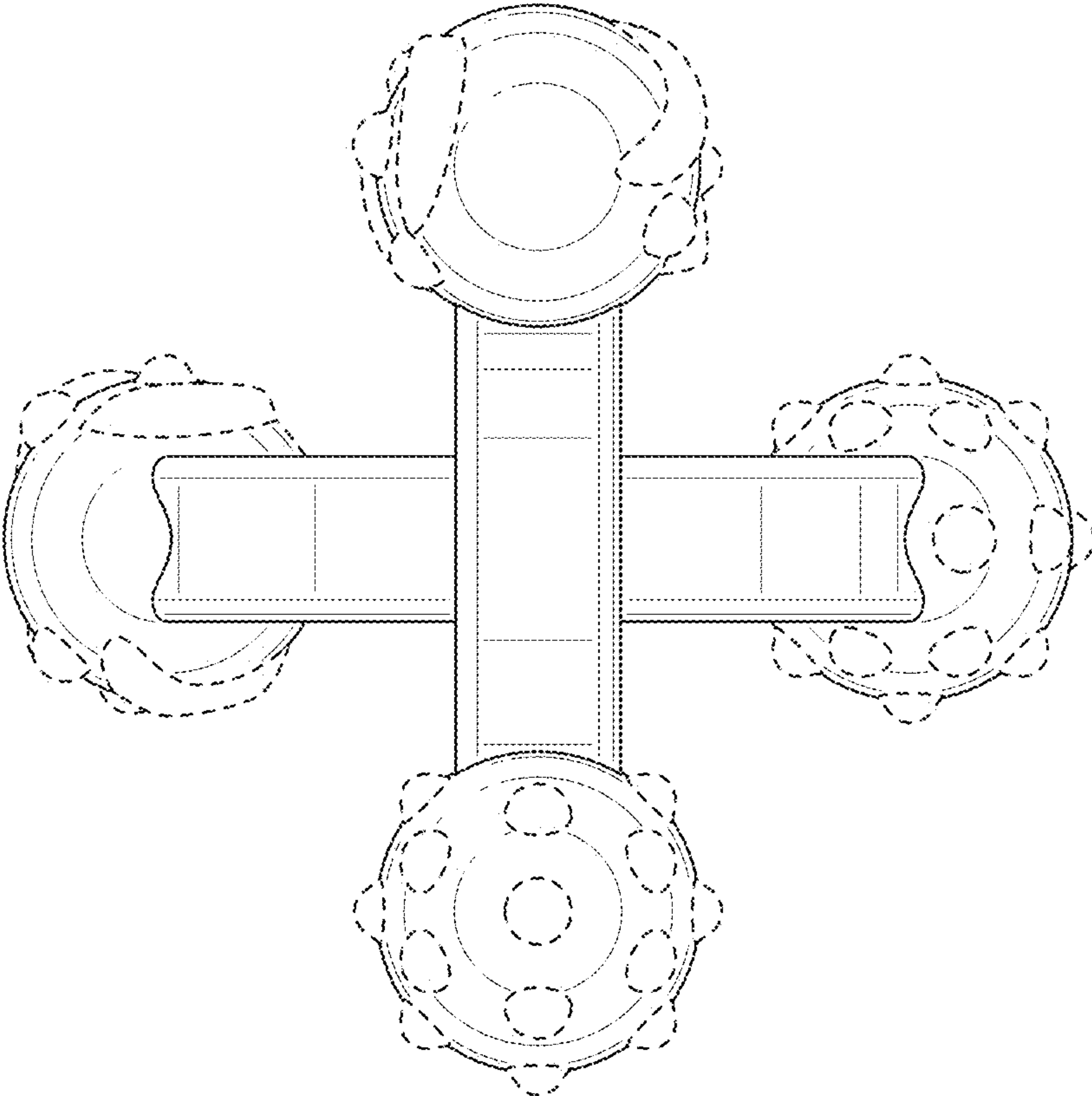

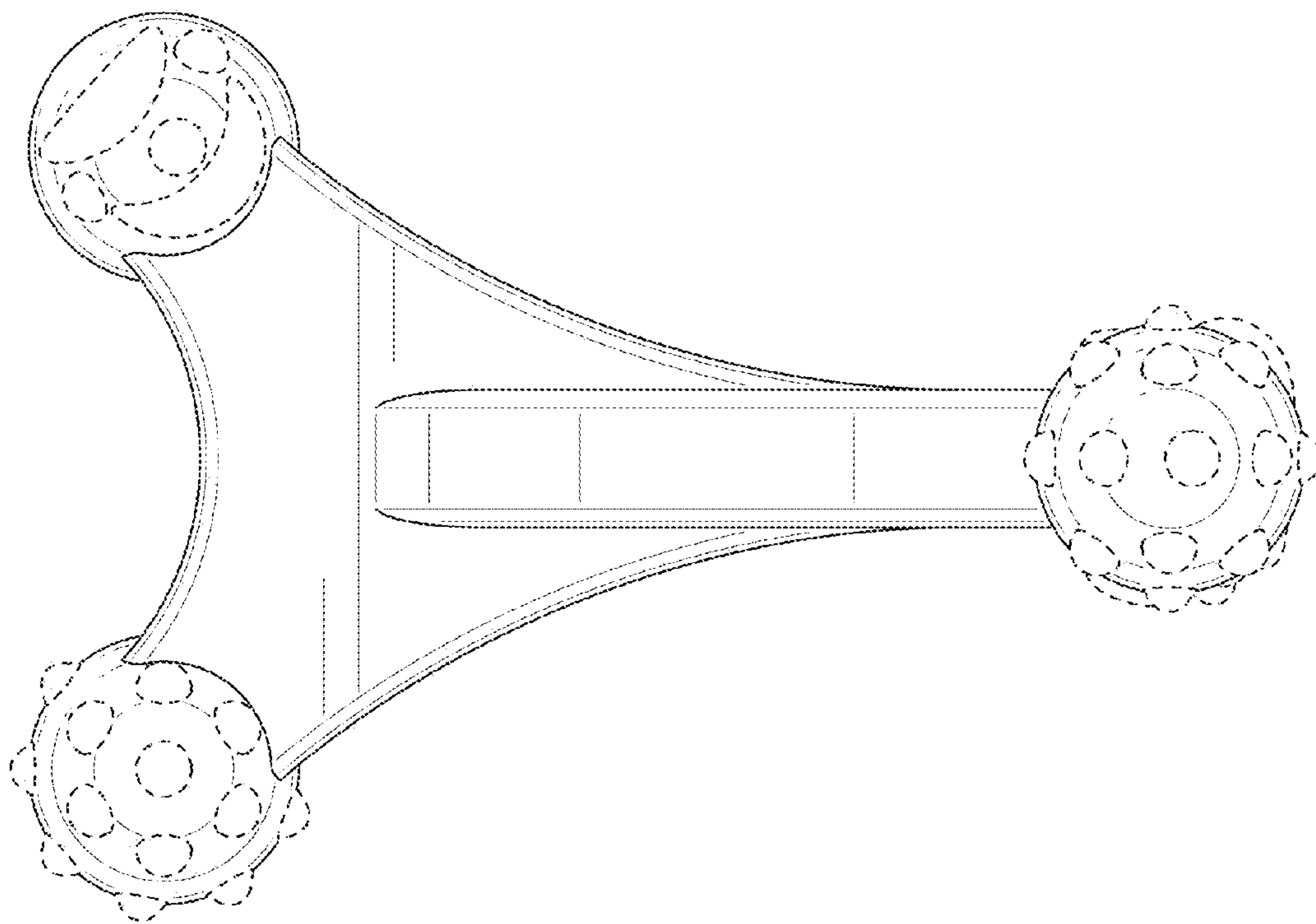

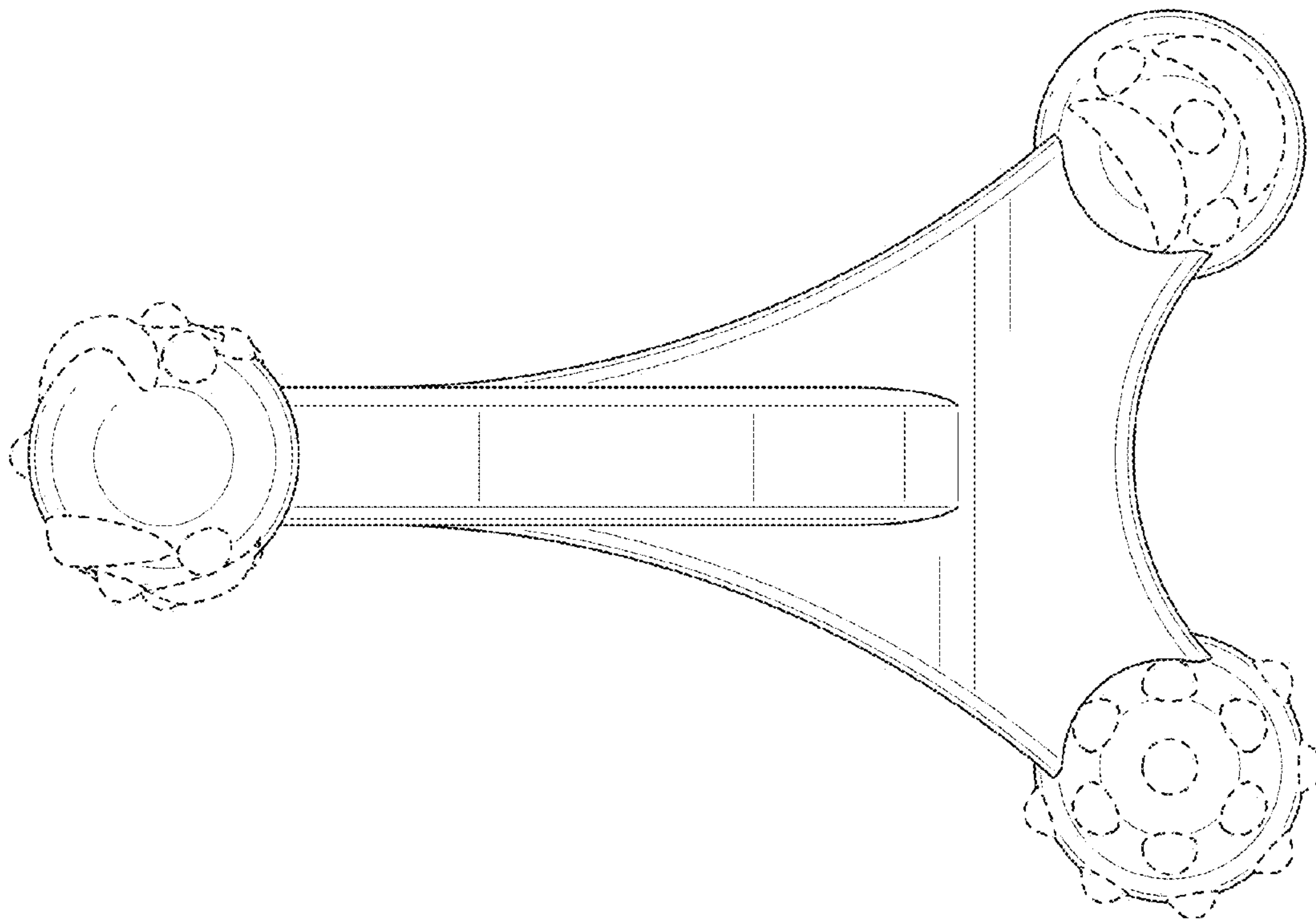

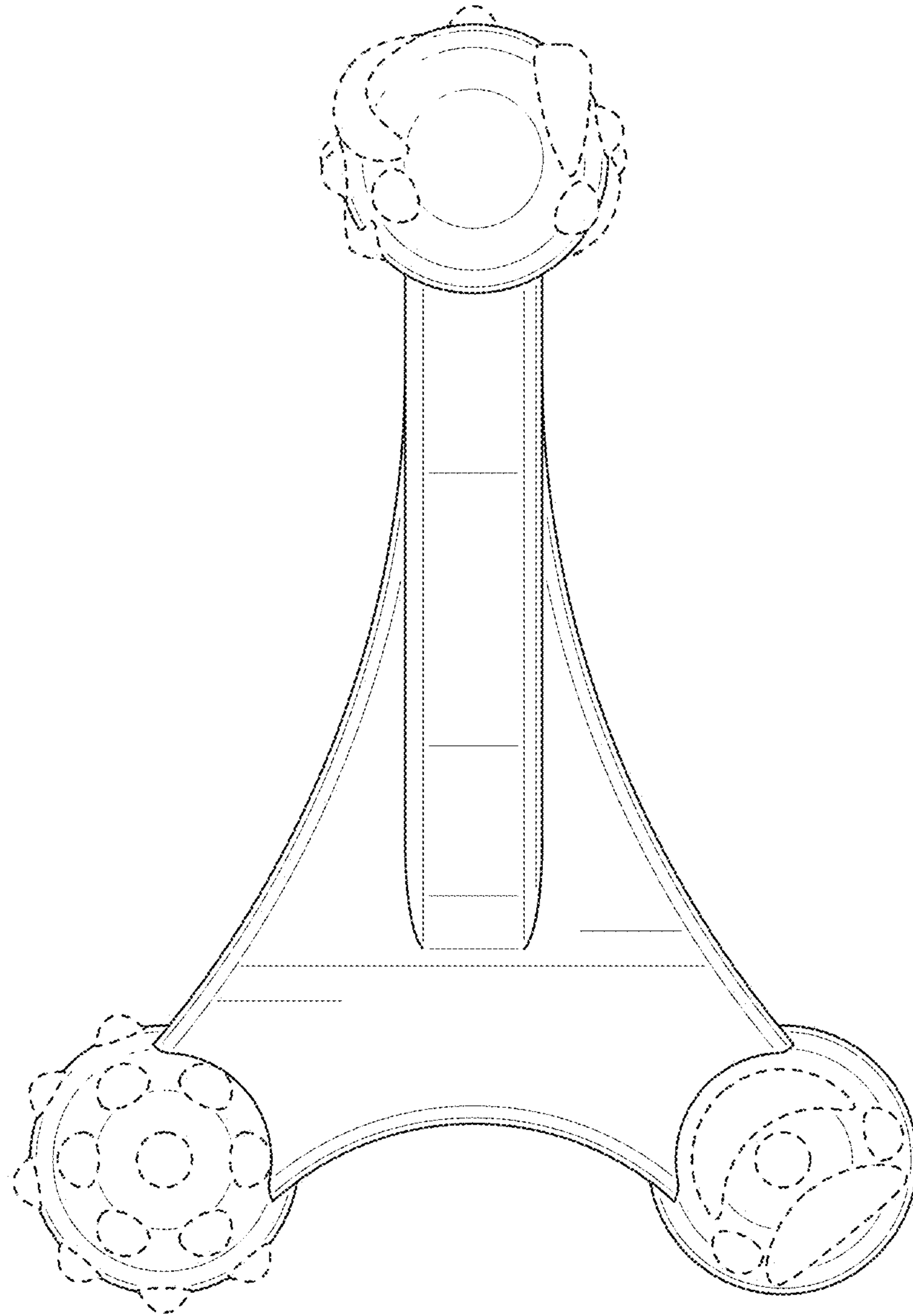

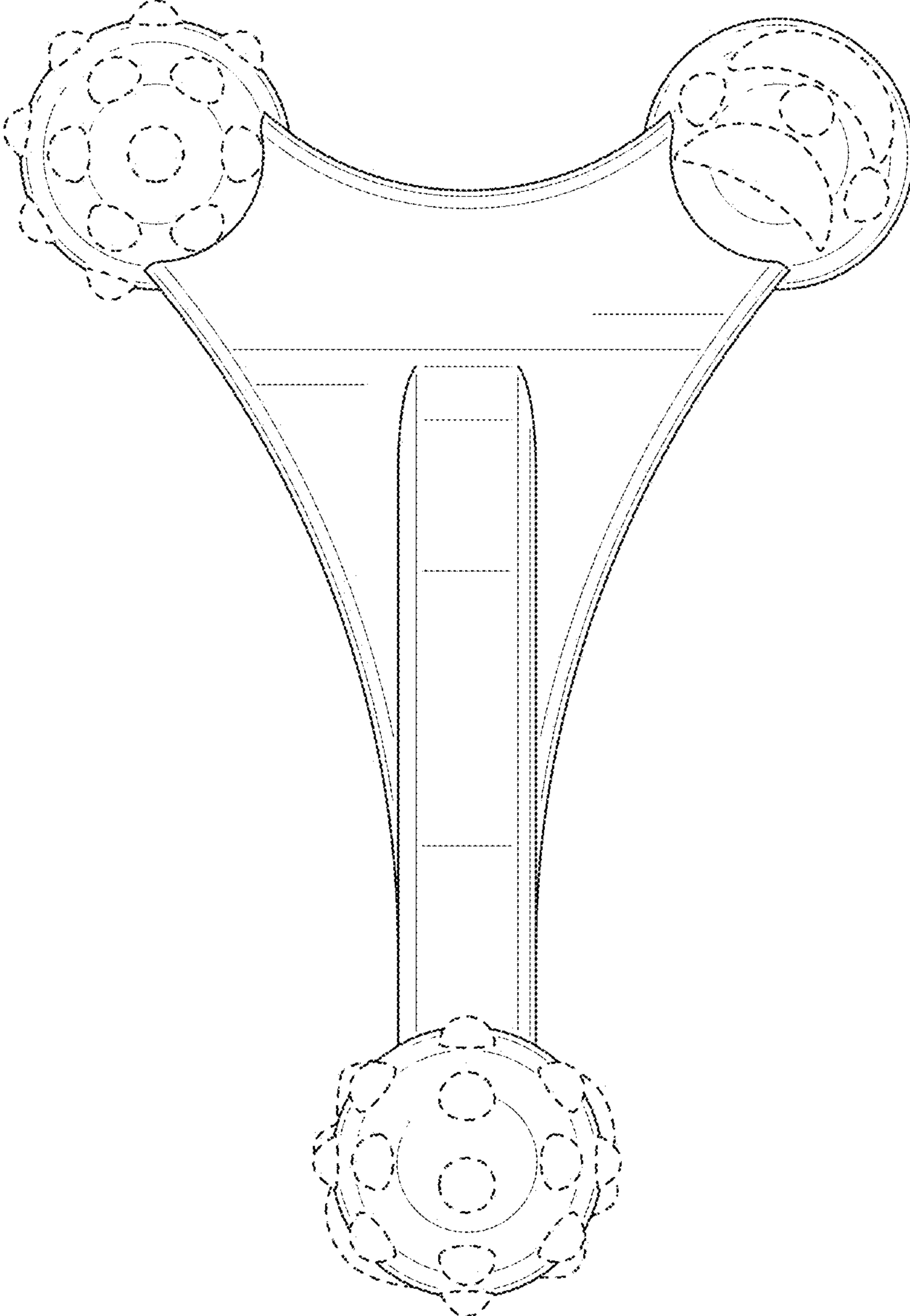
