DESCRIPTION

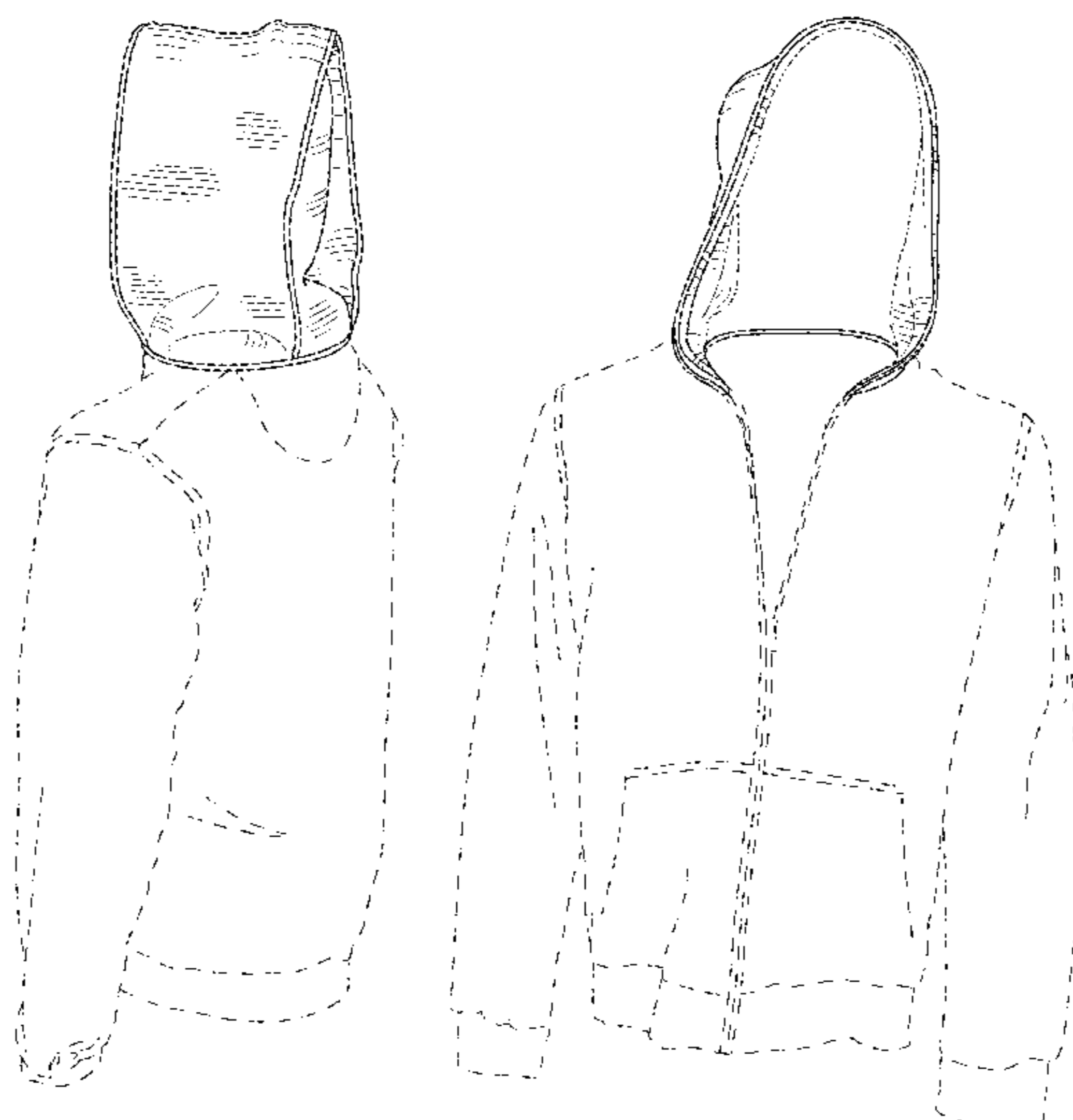
FIG. 1 is a right, rear perspective view of a garment showing my new design, the left rear perspective view being a mirror image thereof;

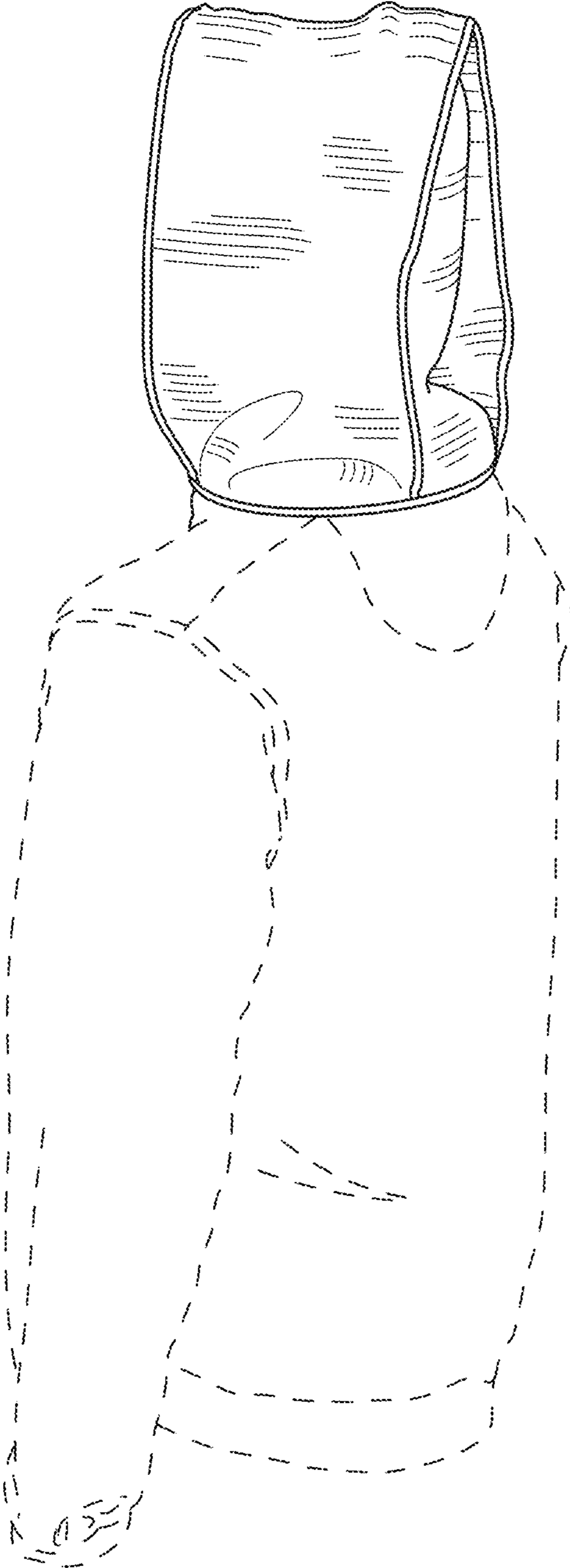

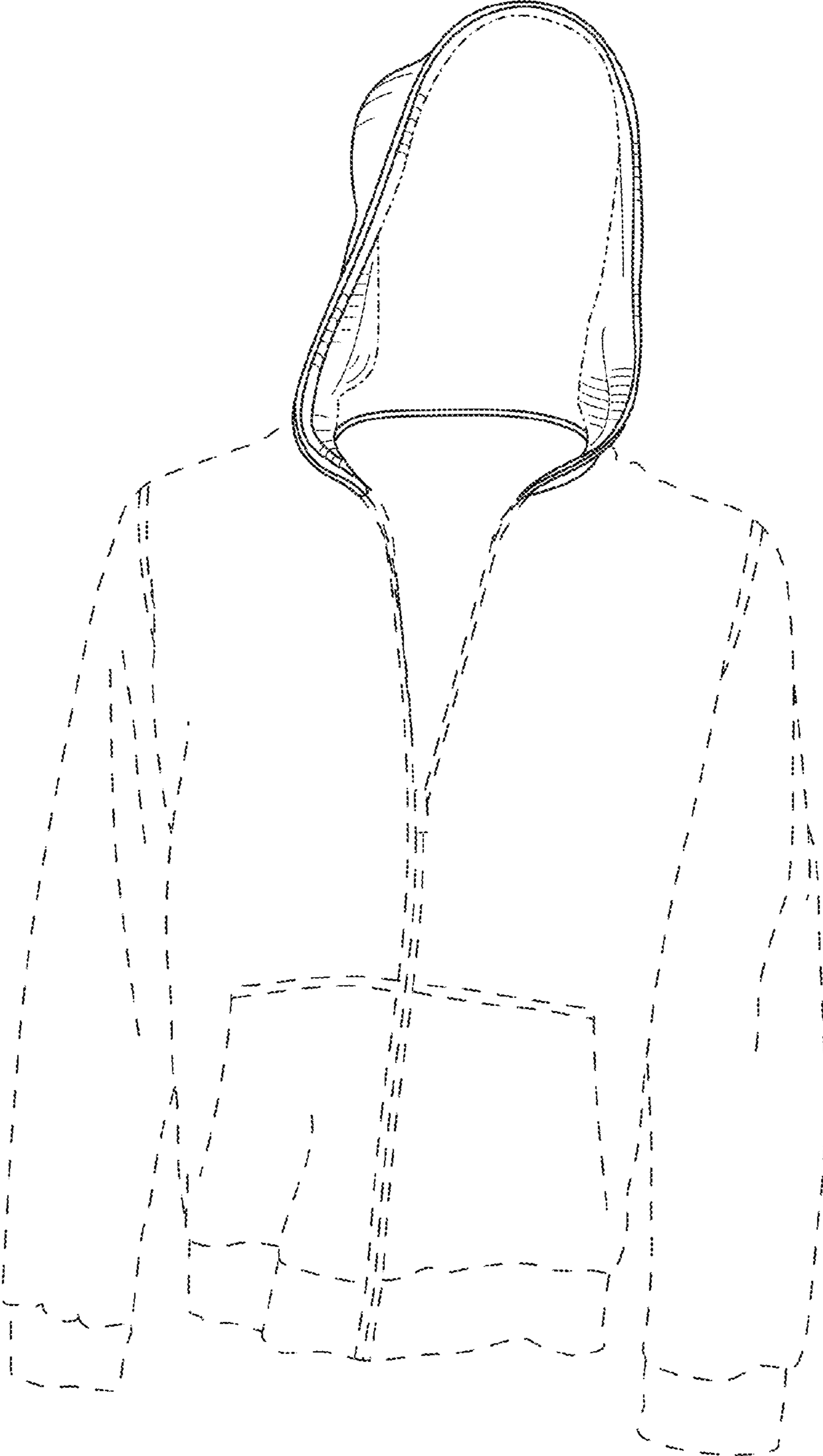

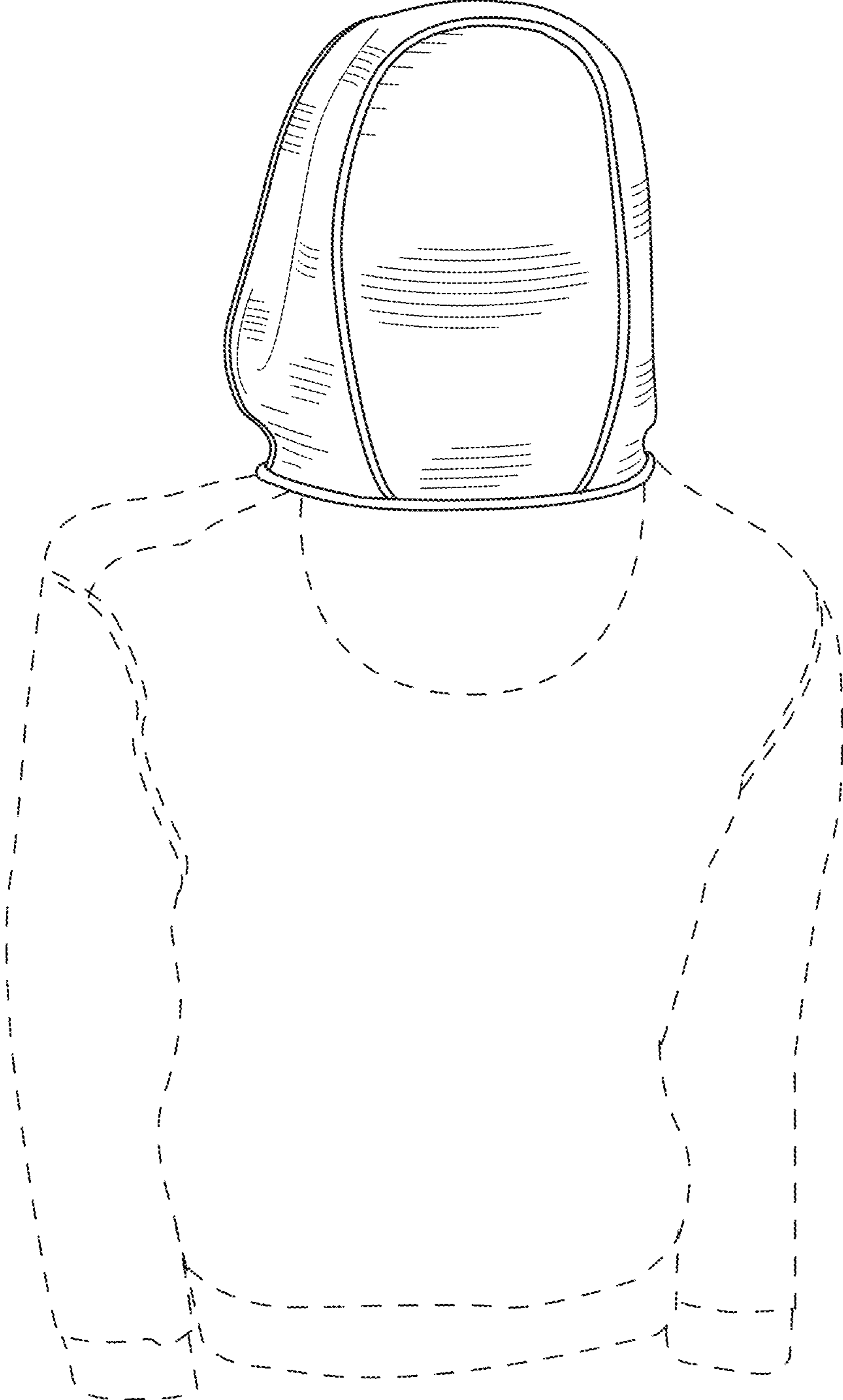
