DESCRIPTION

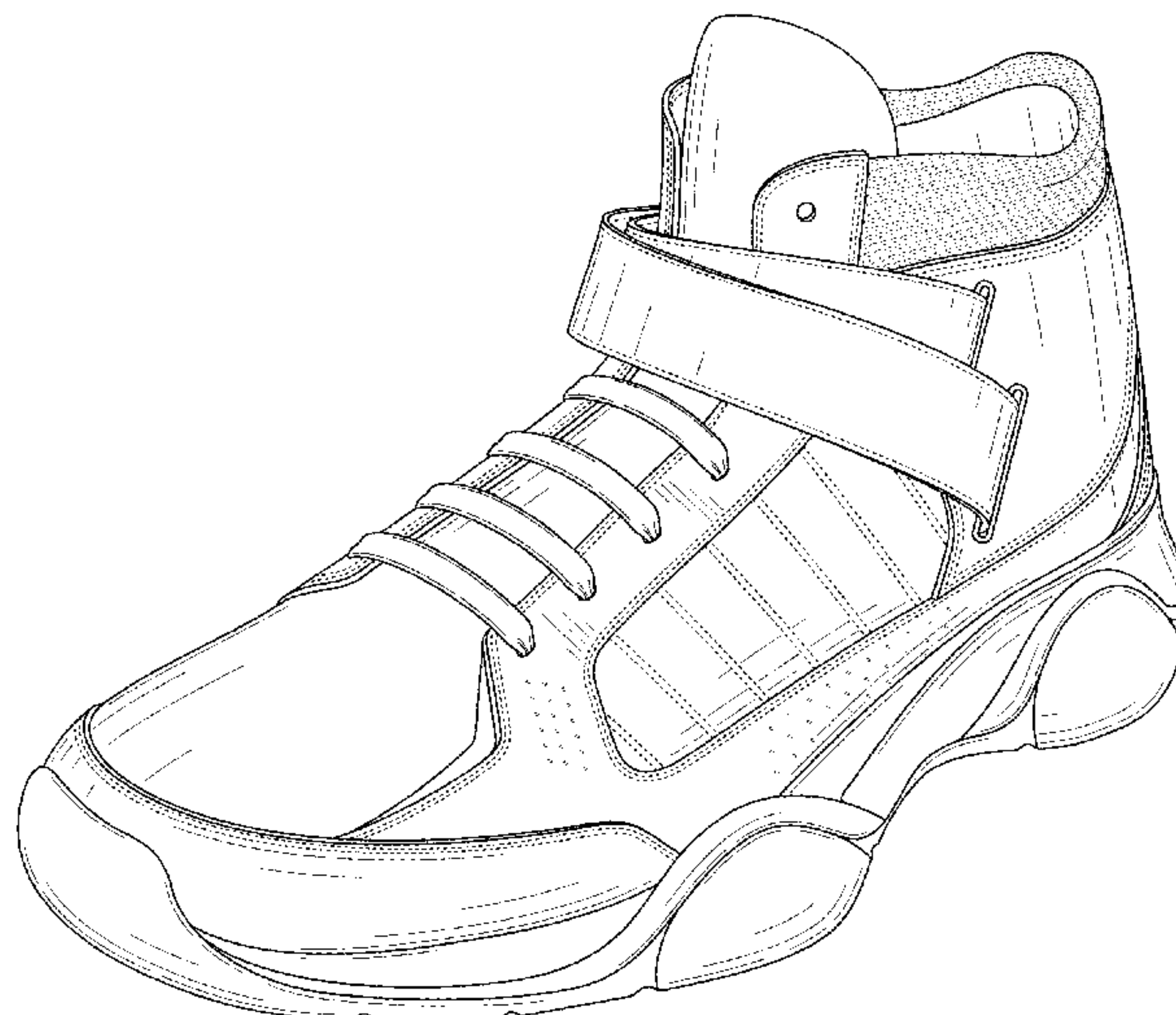
FIG. 1 is a perspective view of a shoe showing our new design;
 FIG. 2 is a front elevational view of the shoe shown in FIG. 1;
 FIG. 3 is a rear elevational view of the shoe shown in FIG. 1;
 FIG. 4 is a left side elevational view of the shoe shown in FIG. 1;
 FIG. 5 is a right side elevational view of the shoe shown in FIG. 1;
 FIG. 6 is a top plan view of the shoe shown in FIG. 1; and,
 FIG. 7 is a bottom plan view of the shoe shown in FIG. 1.
 The broken lines of the small circles on the cuff, sides and bottom of the shoe and the broken lines of the wavy lines on the bottom of the shoe represent unclaimed environment and form no part of the claimed design. All other broken lines represent thread stitching.

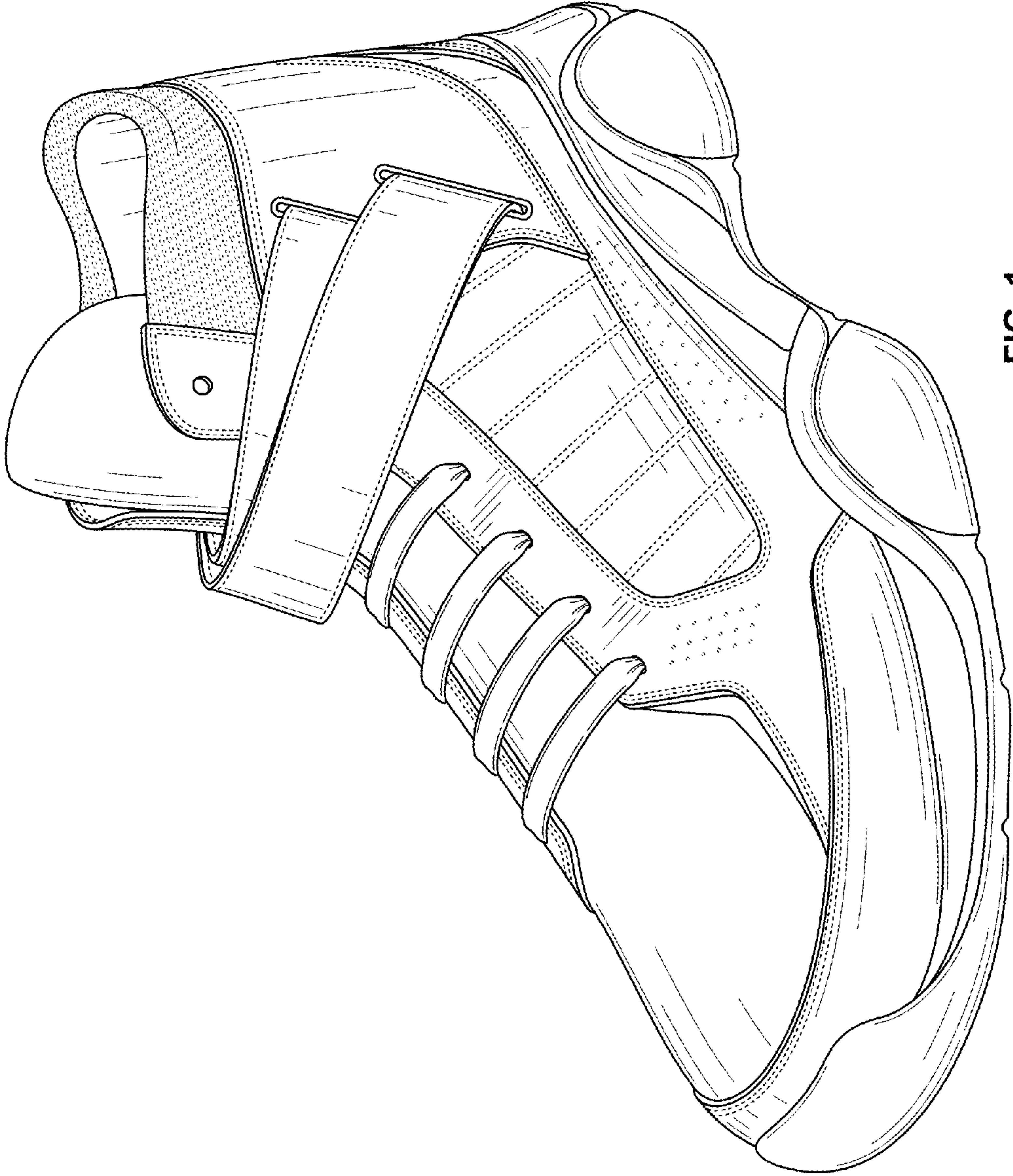

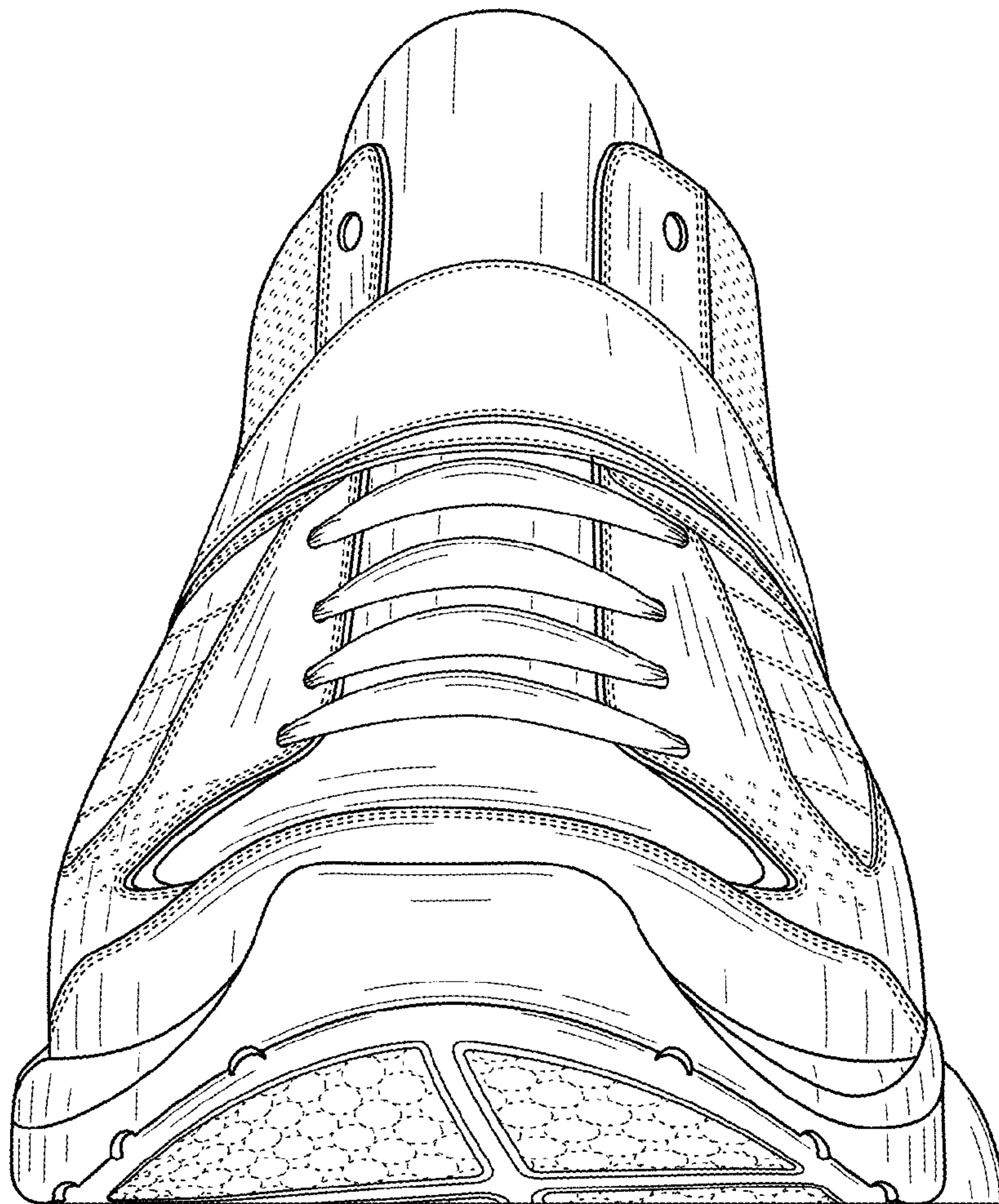

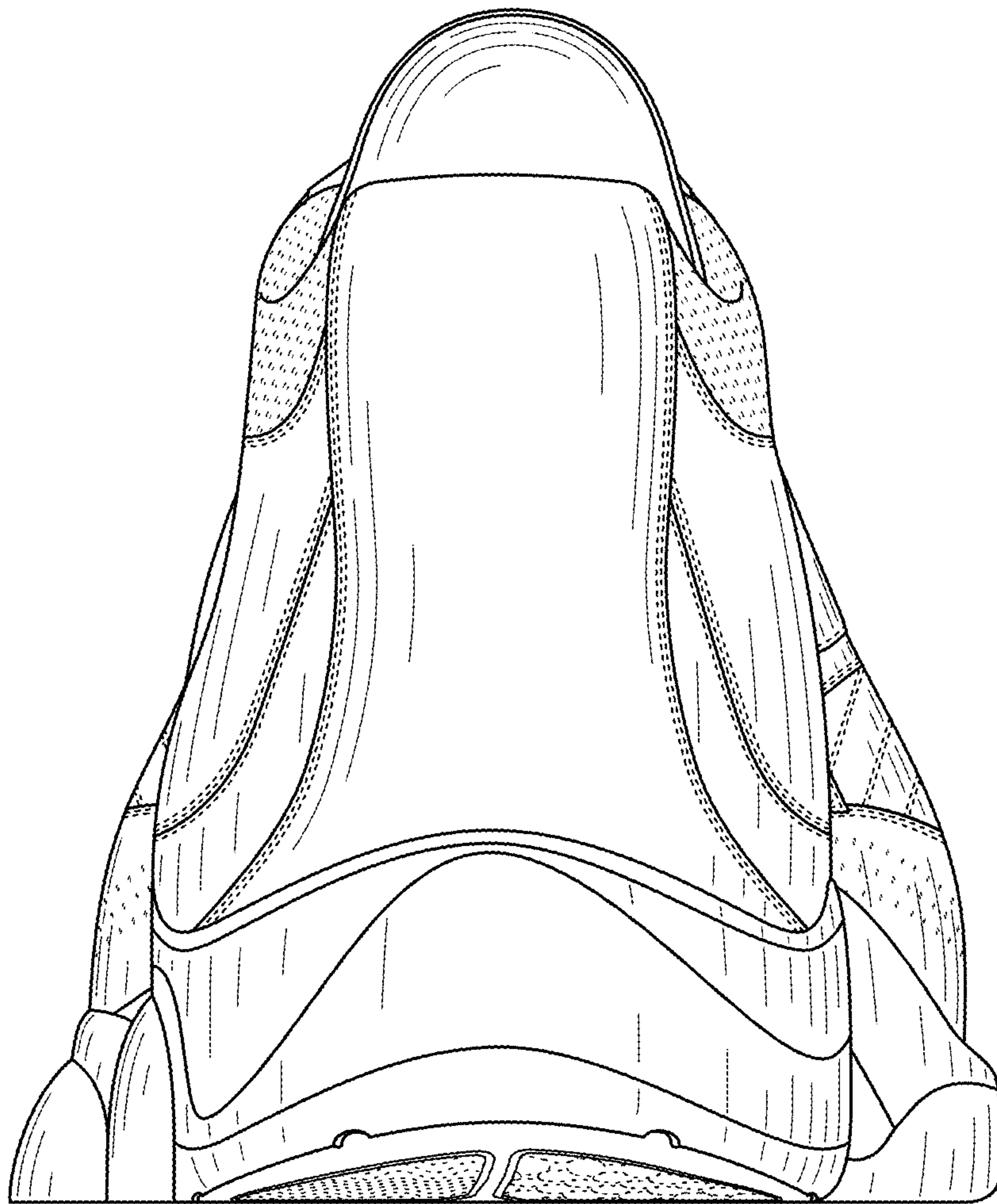

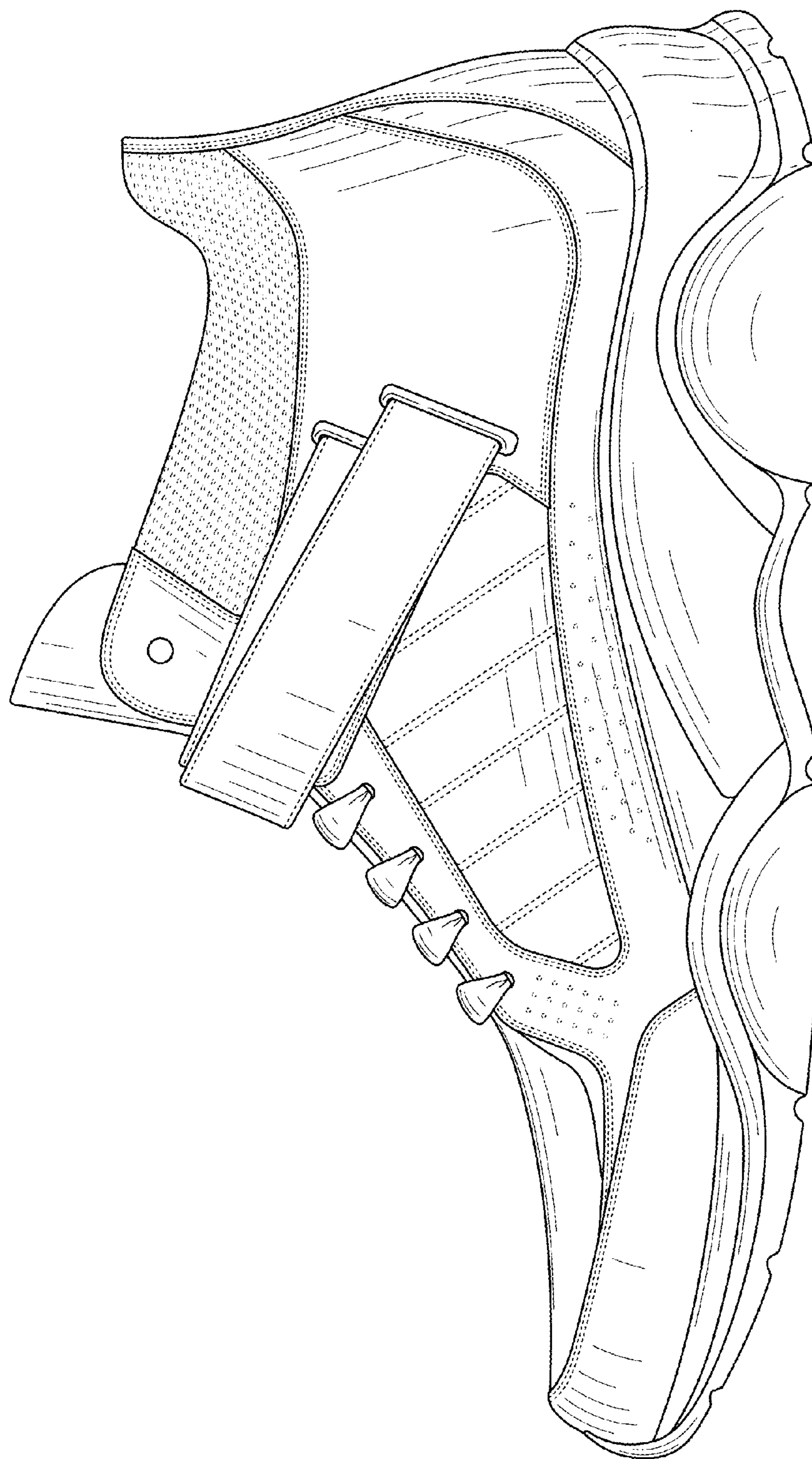

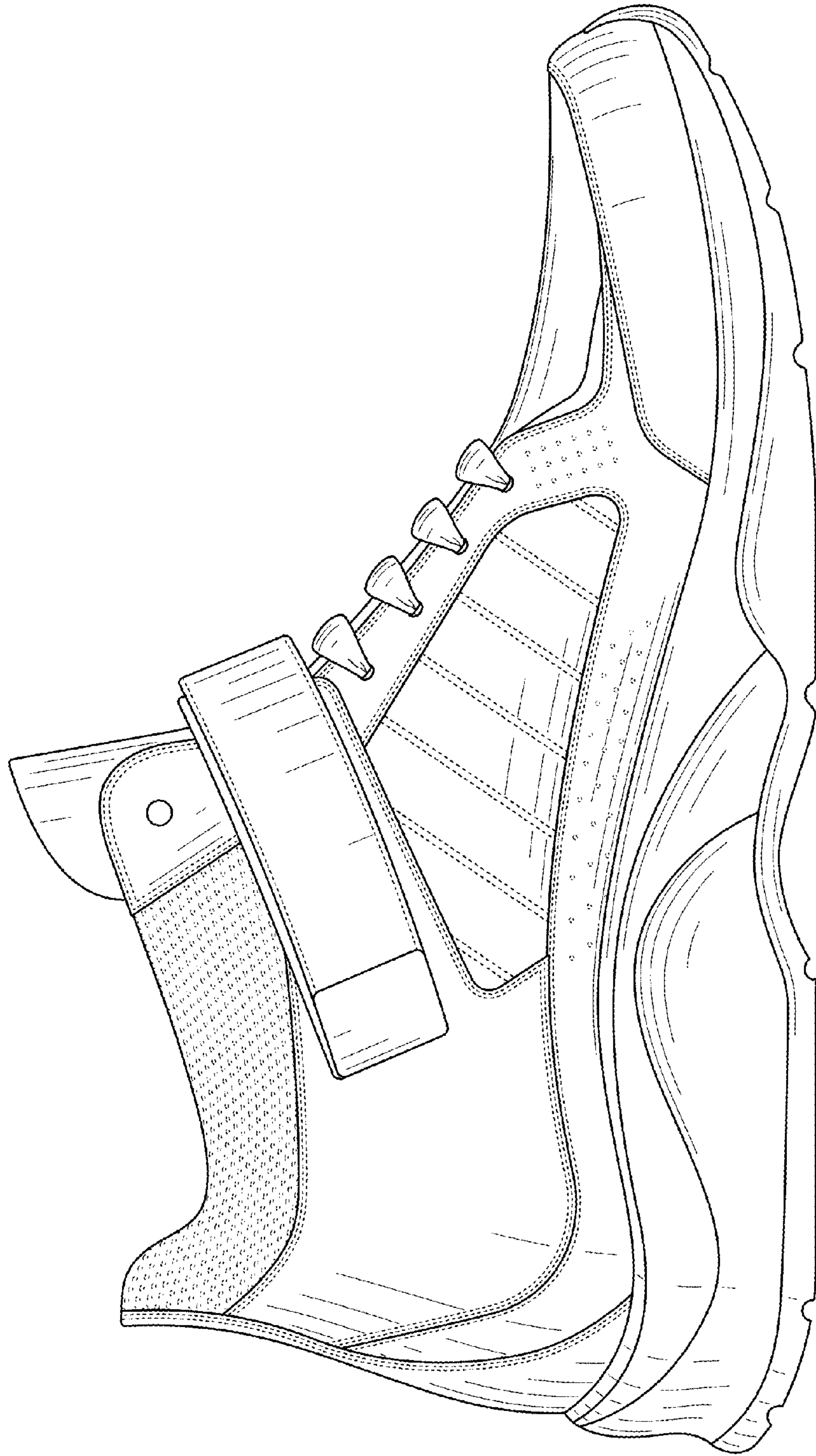

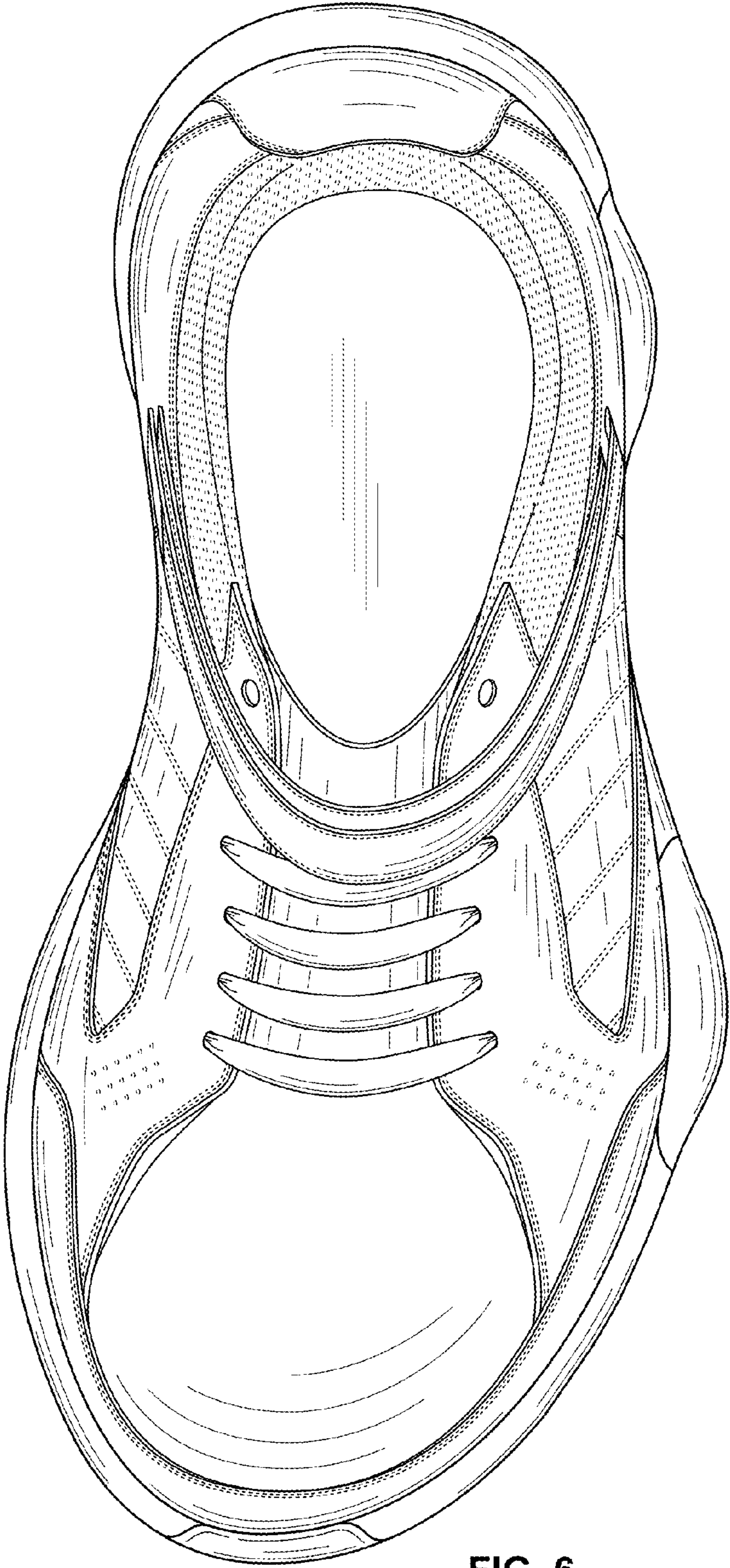

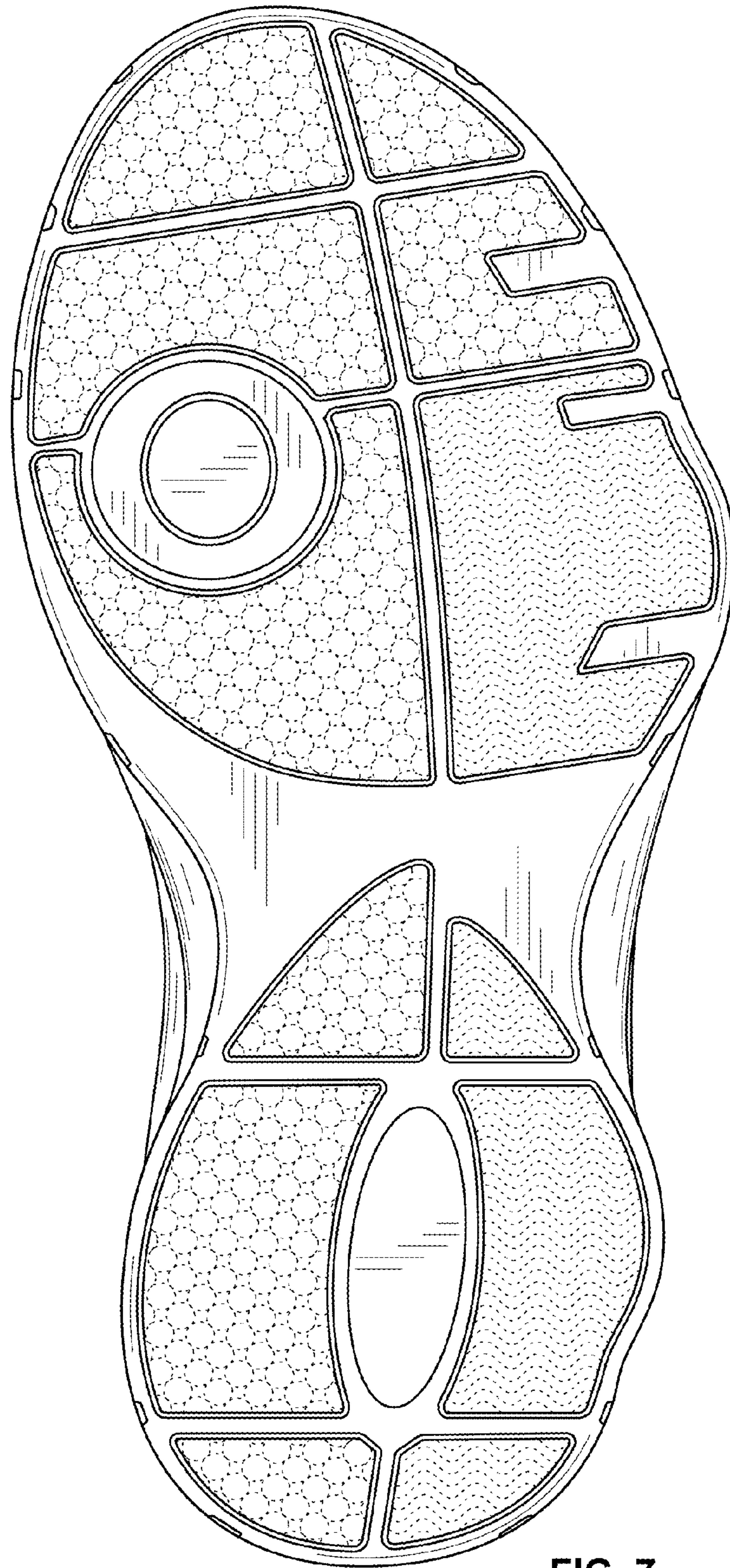
