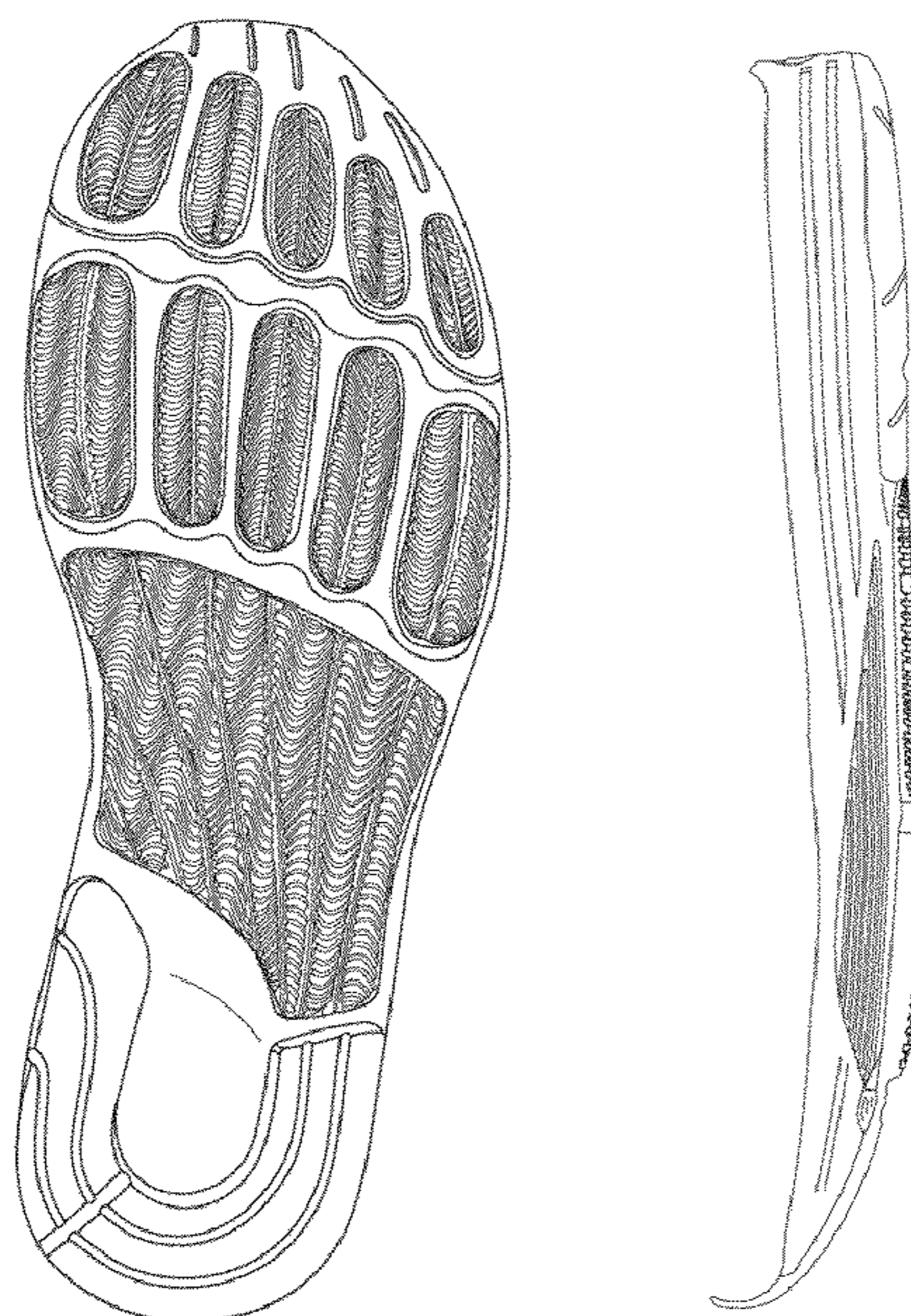
(57) **CLAIM**

The ornamental design for a trapezoidal mid-foot shoe sole, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a trapezoidal mid-foot shoe sole according to my new design.

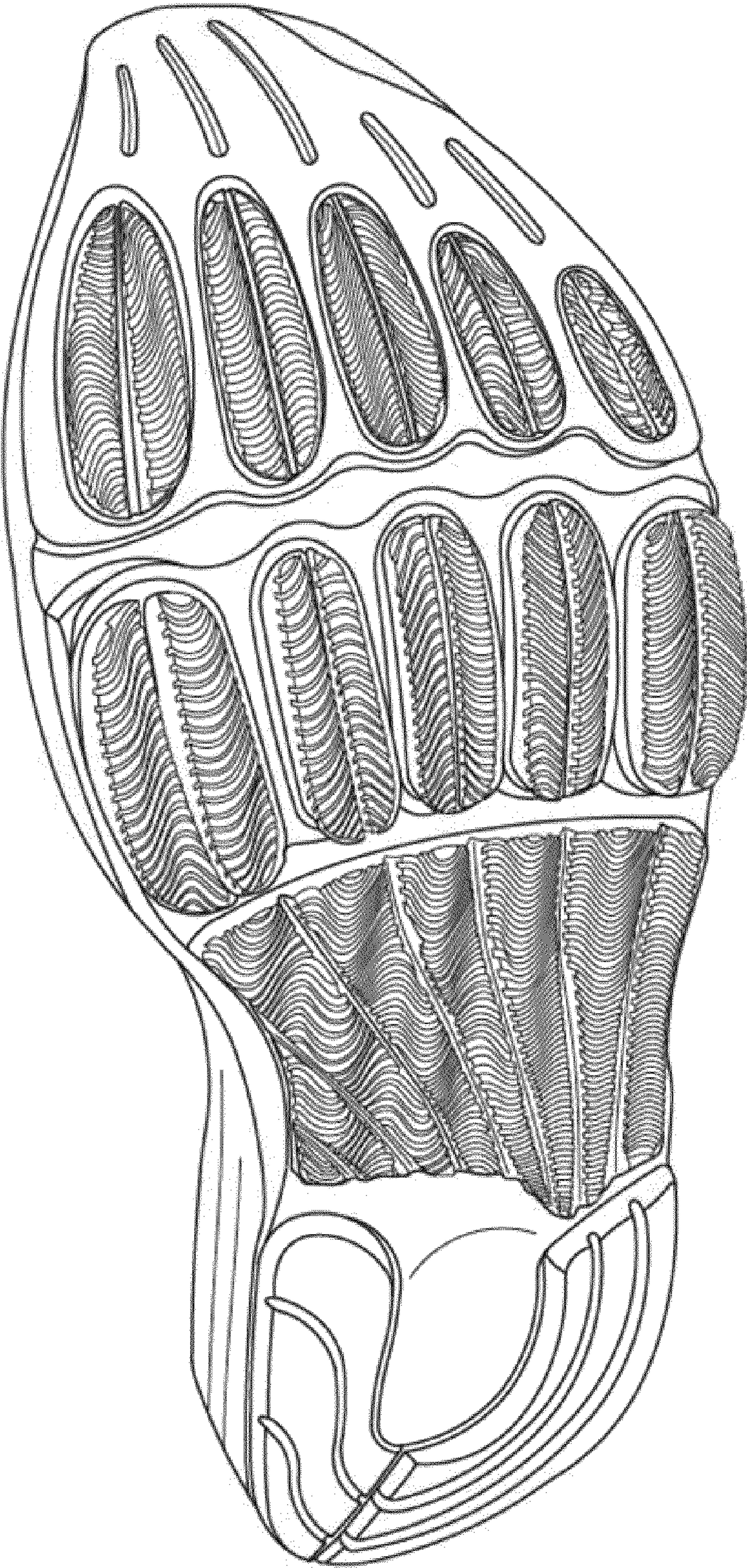

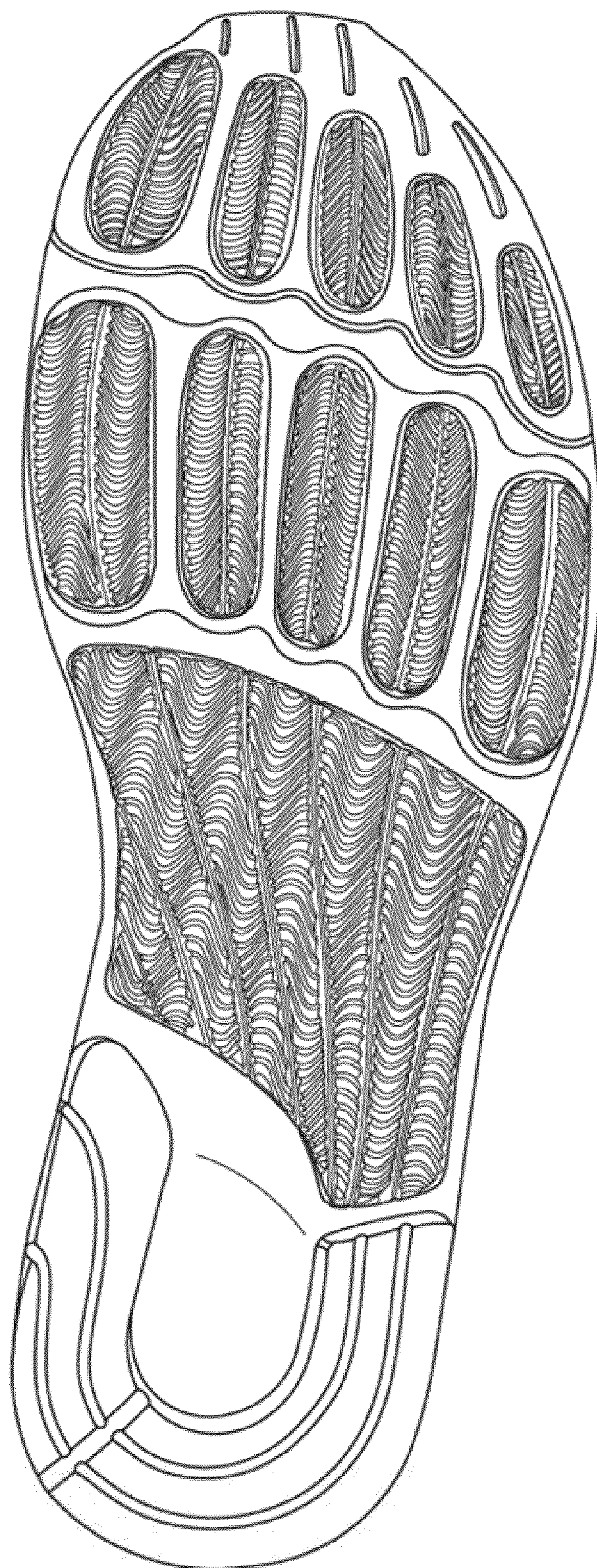

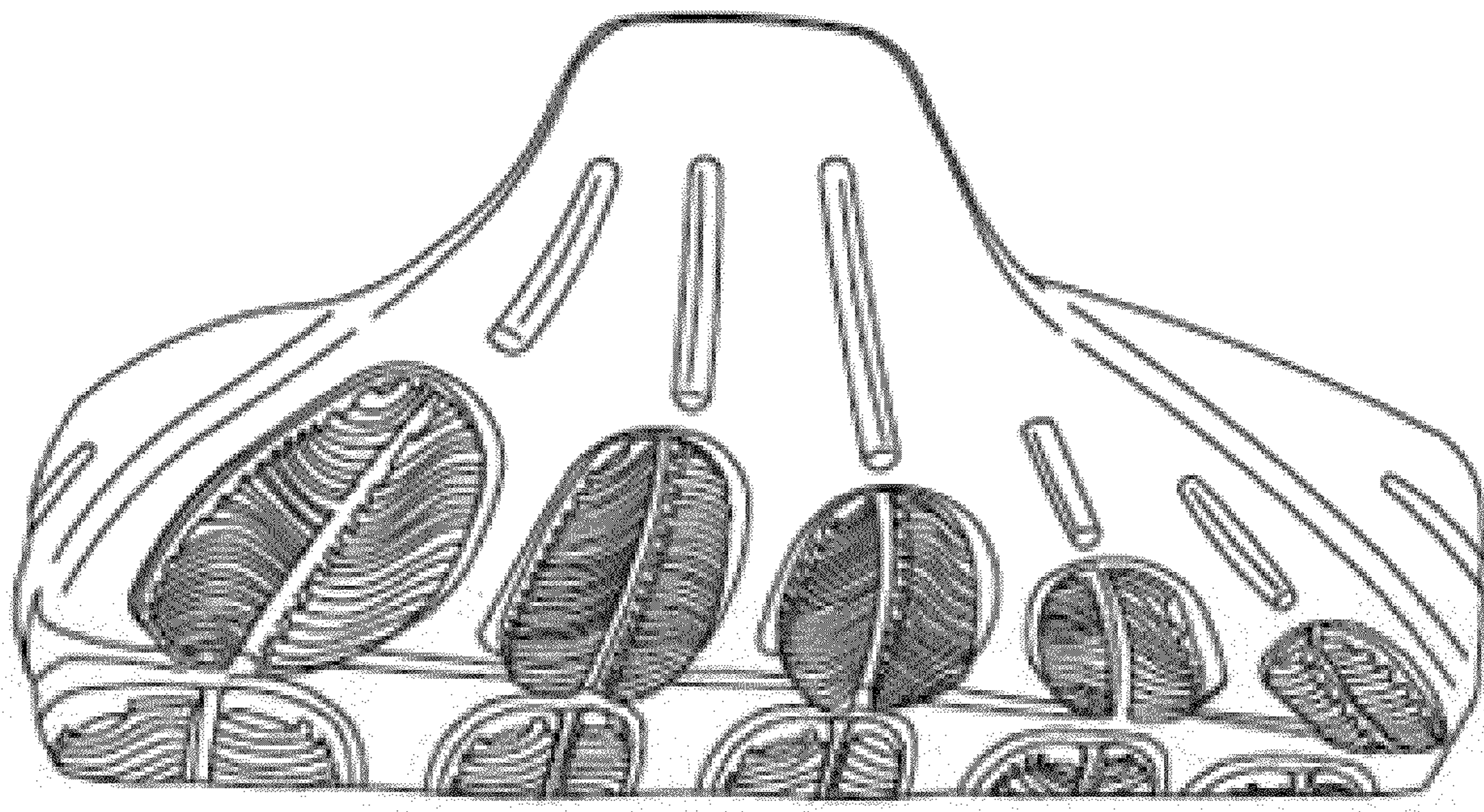

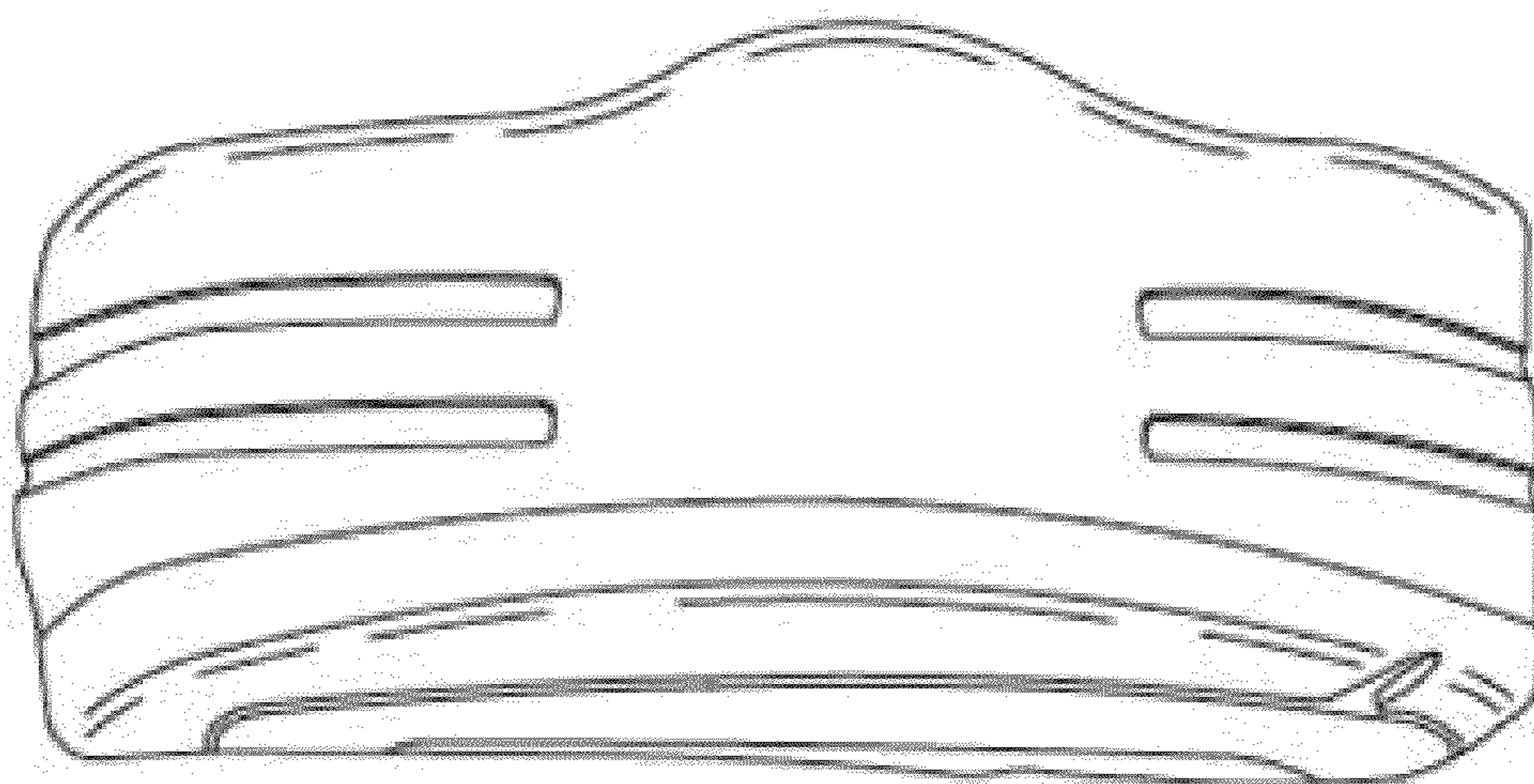

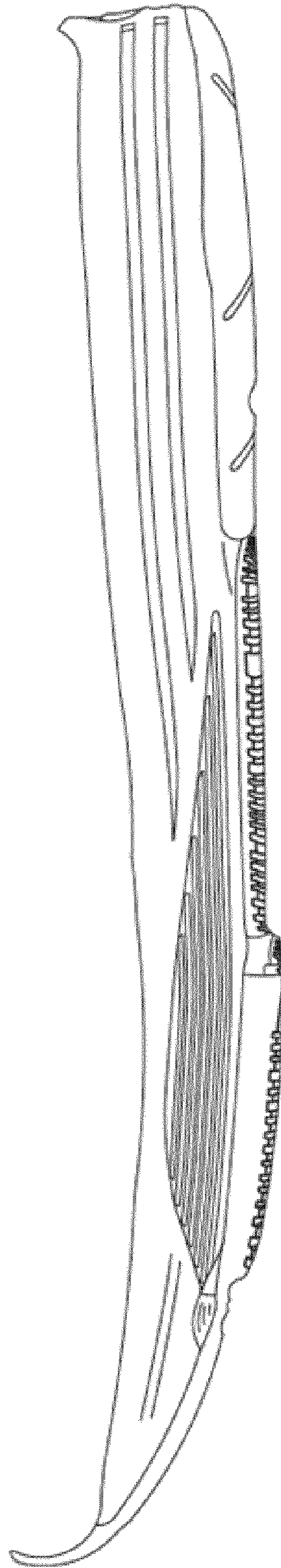

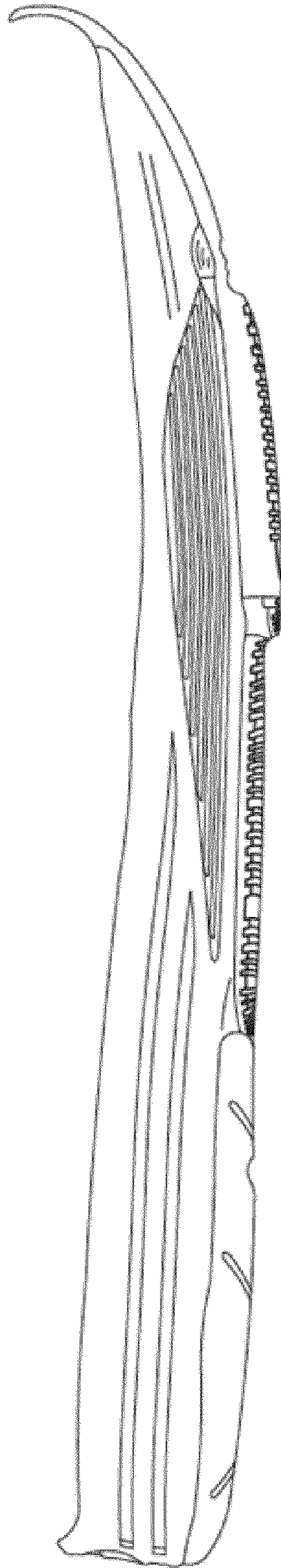
