(57) **CLAIM**

The ornamental design for a partially unwrapped picture frame with image, as shown and described.

DESCRIPTION

FIG. 1 is a front view of the partially unwrapped picture frame with image invention;

FIG. 2 is a back view of the partially unwrapped picture frame with image invention;

FIG. 3 is a left side elevation view of the partially unwrapped picture frame with image invention;

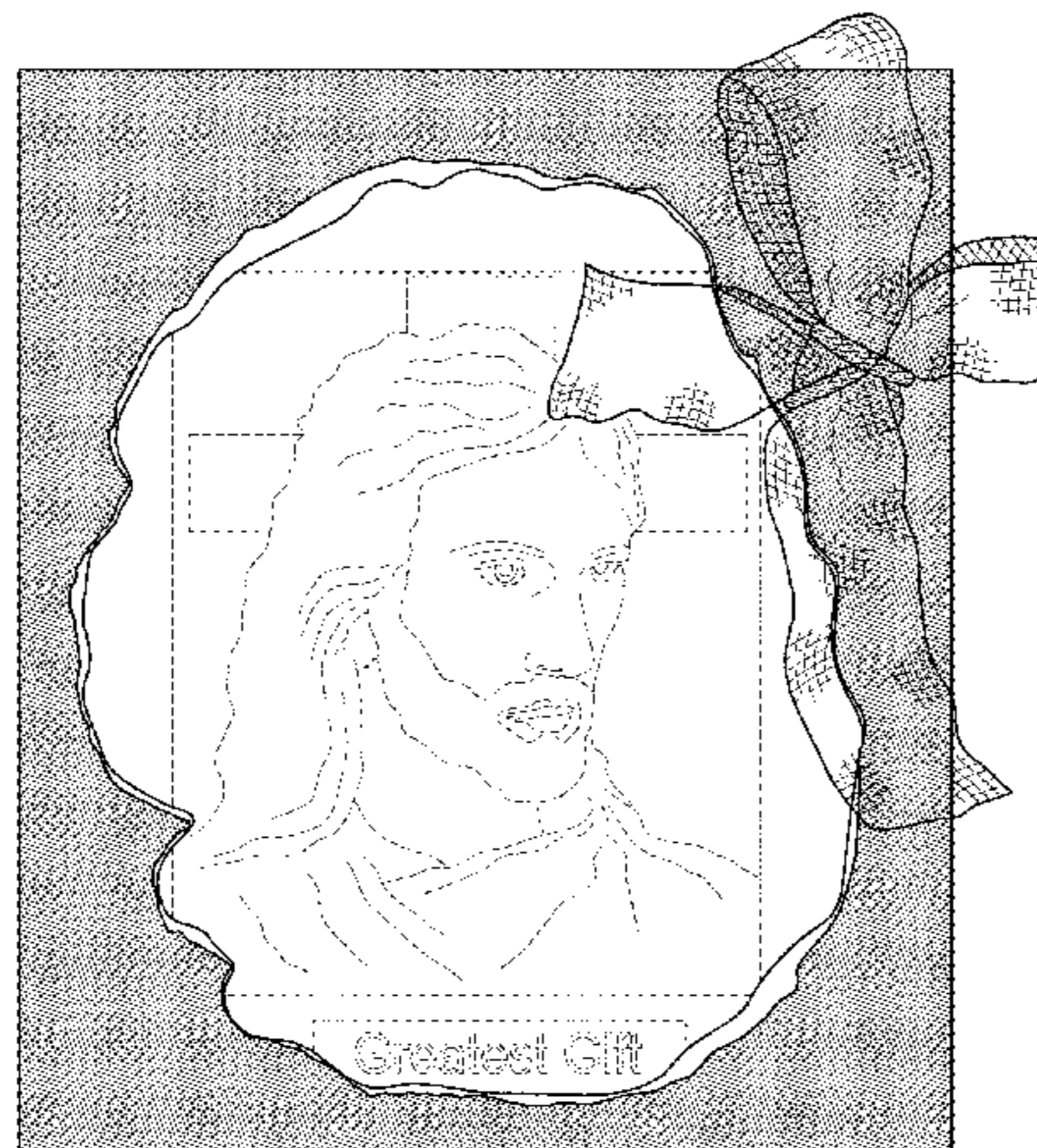
FIG. 4 is a right side elevation view of the partially unwrapped picture frame with image invention;

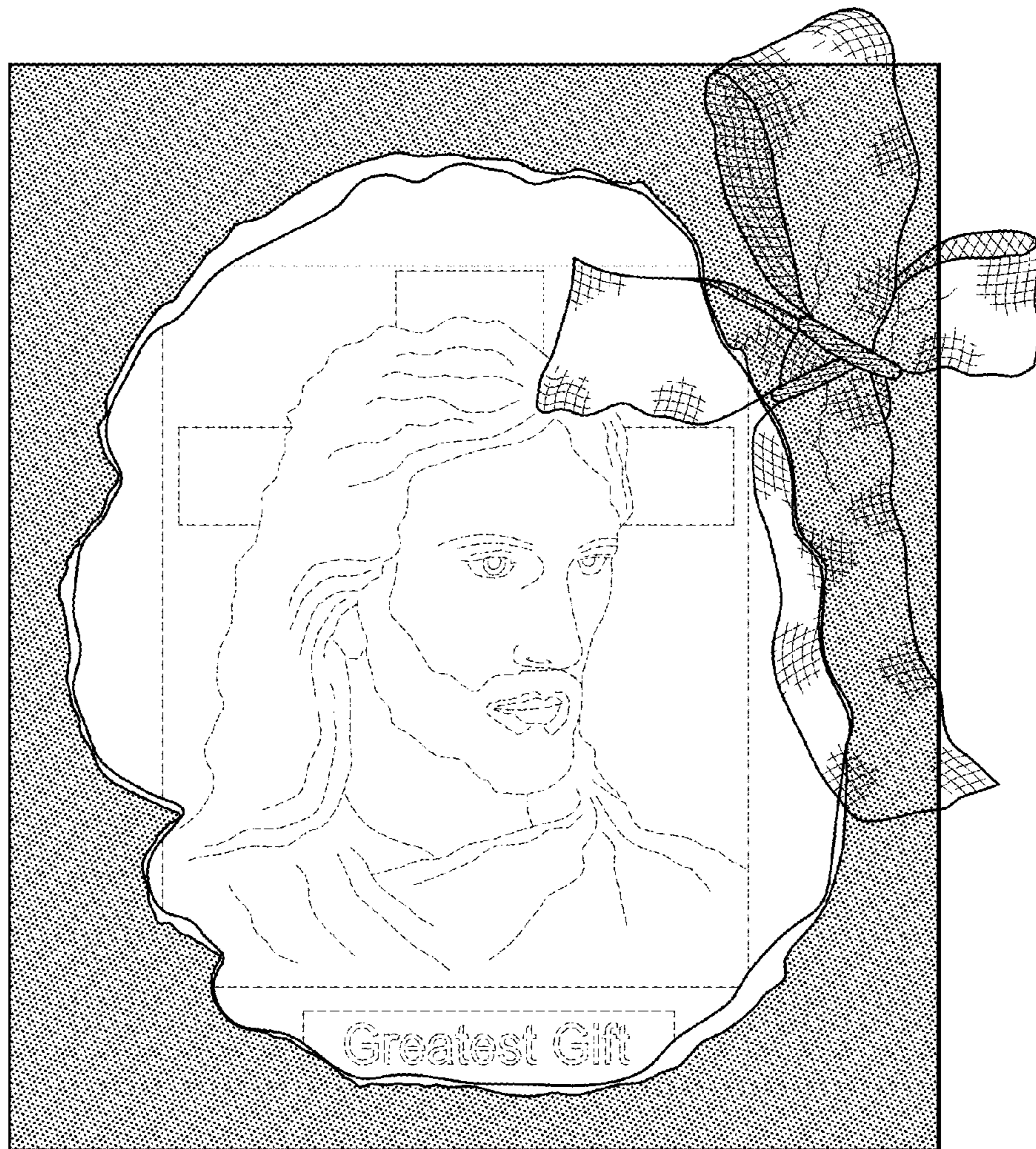

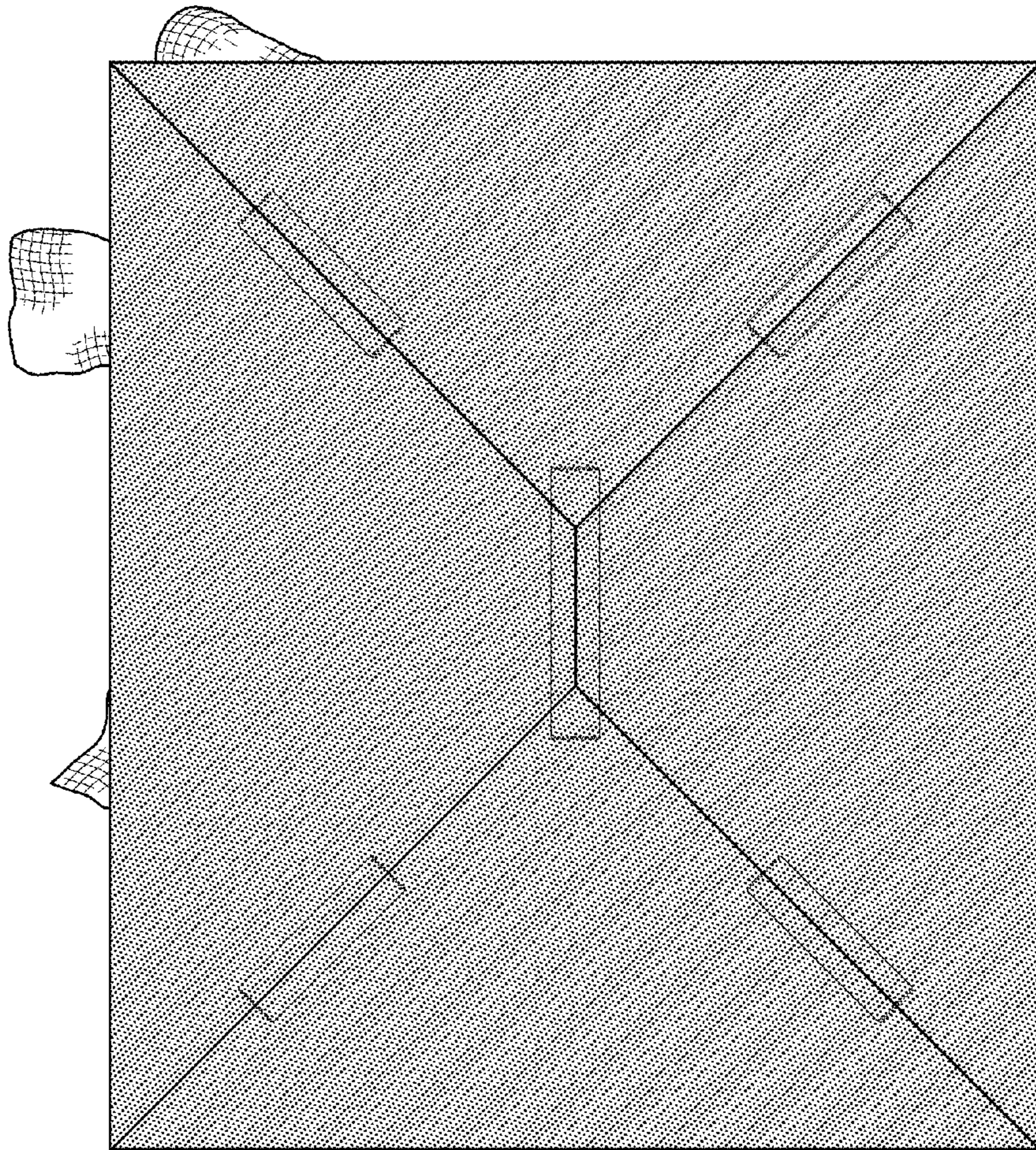

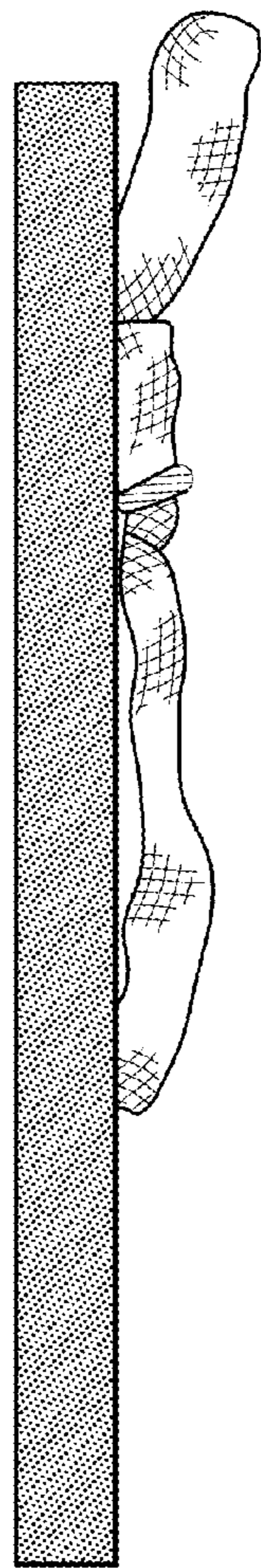

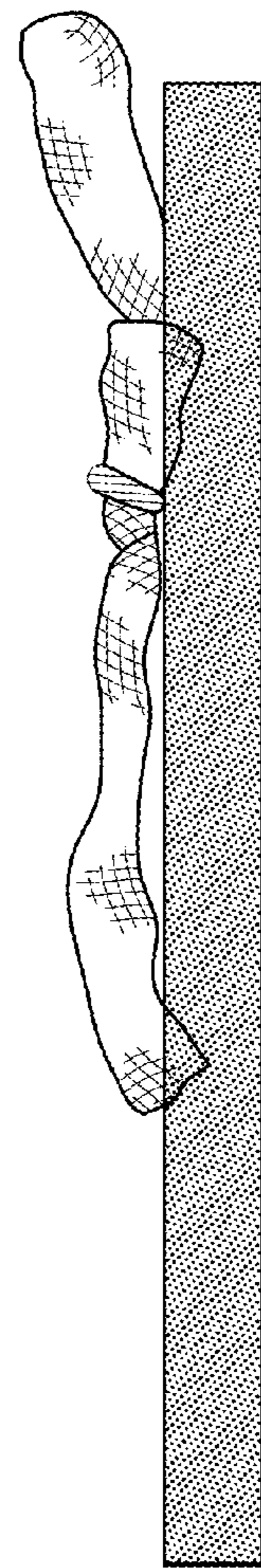

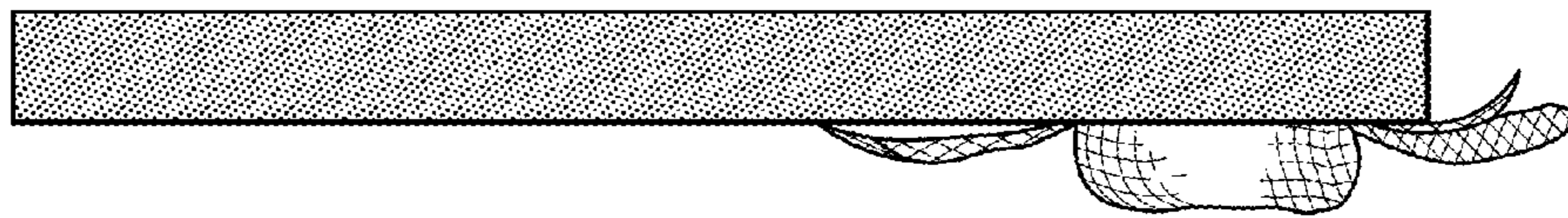

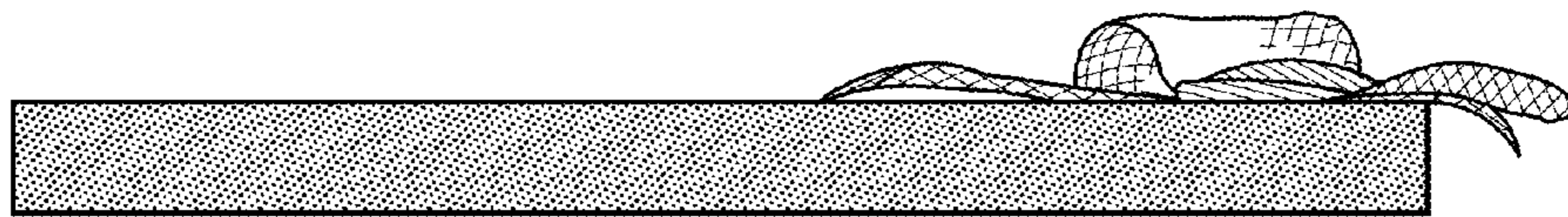
