(57) **CLAIM**

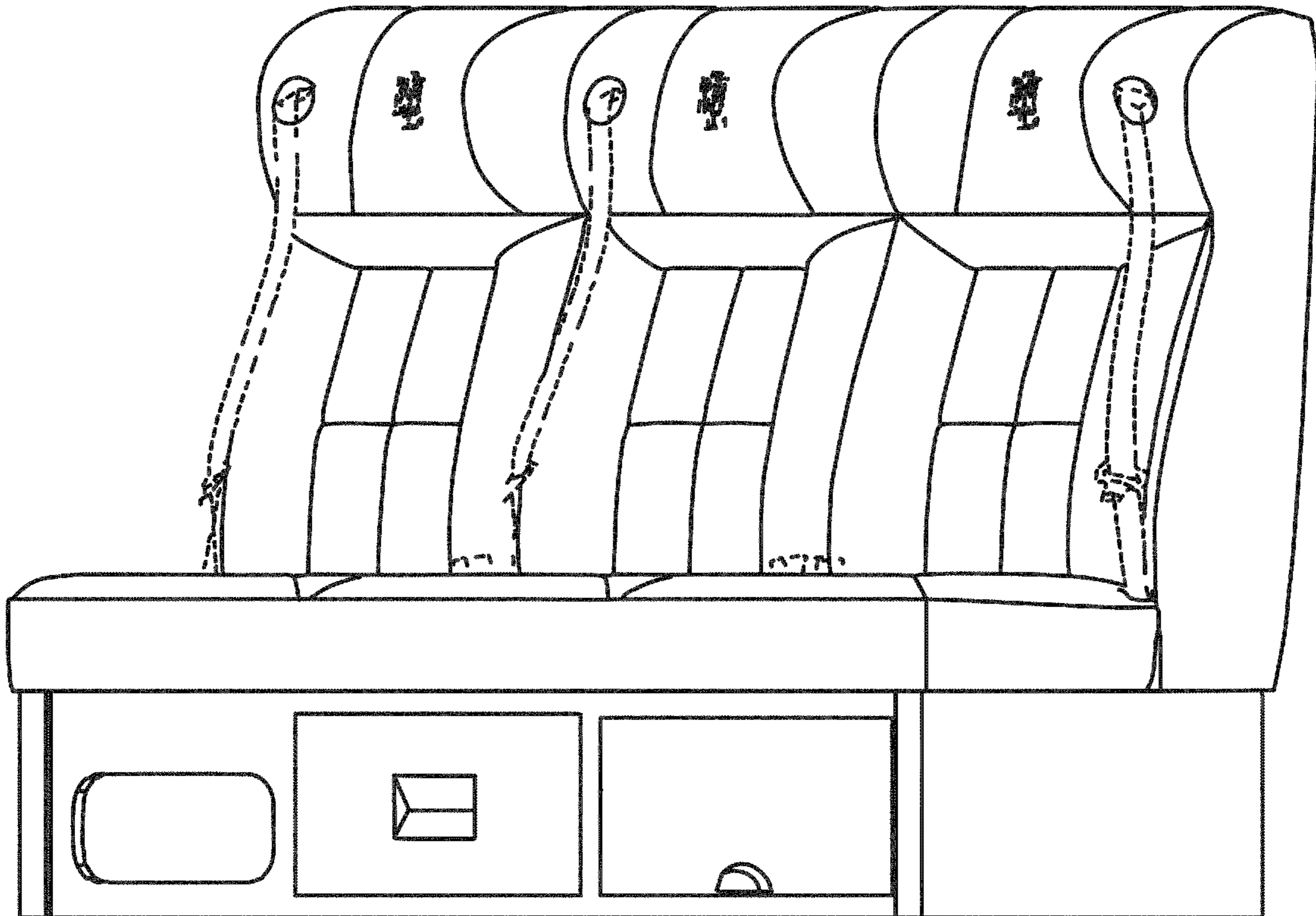
The ornamental design for a jumpseat, as shown and described.

DESCRIPTION

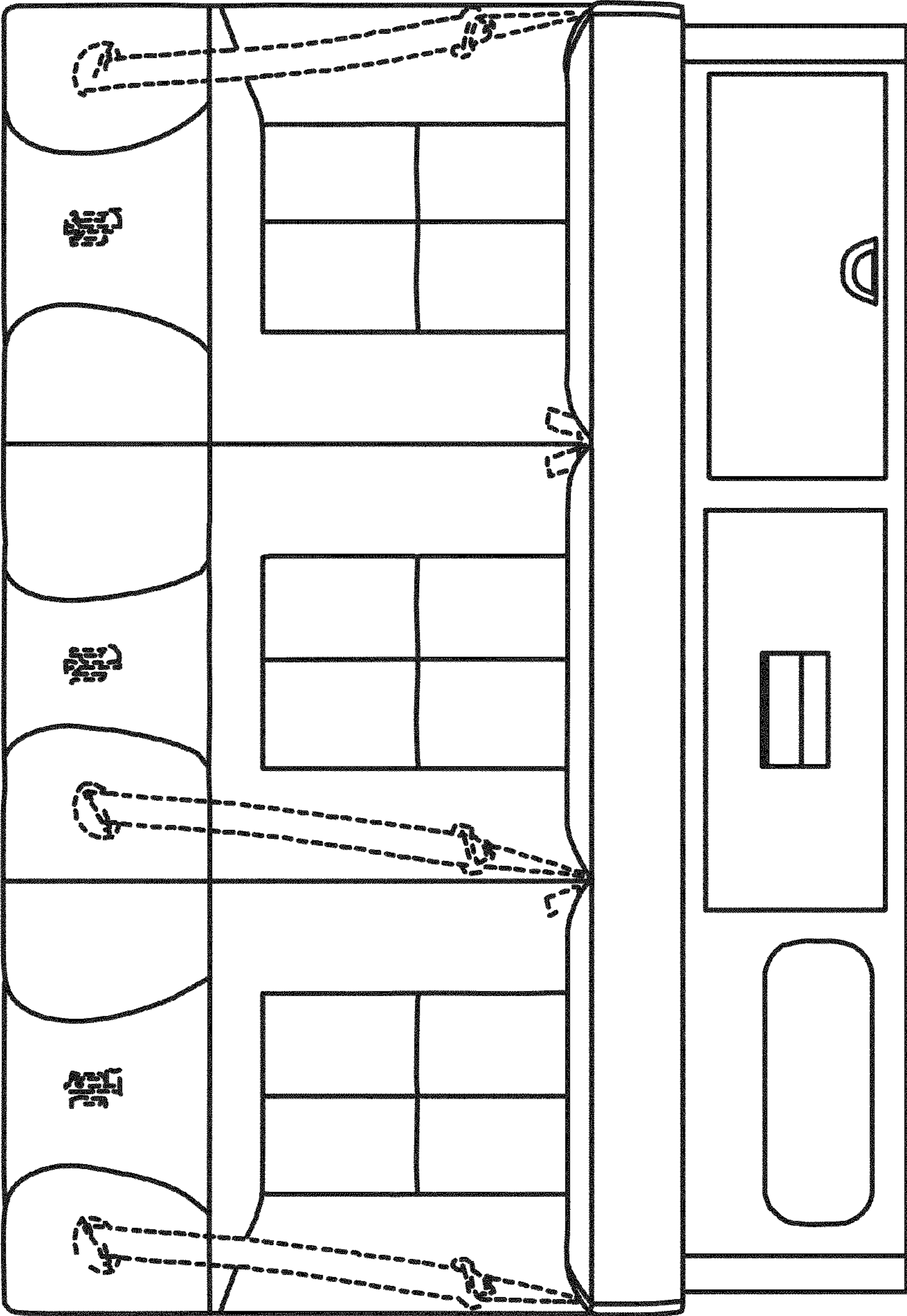

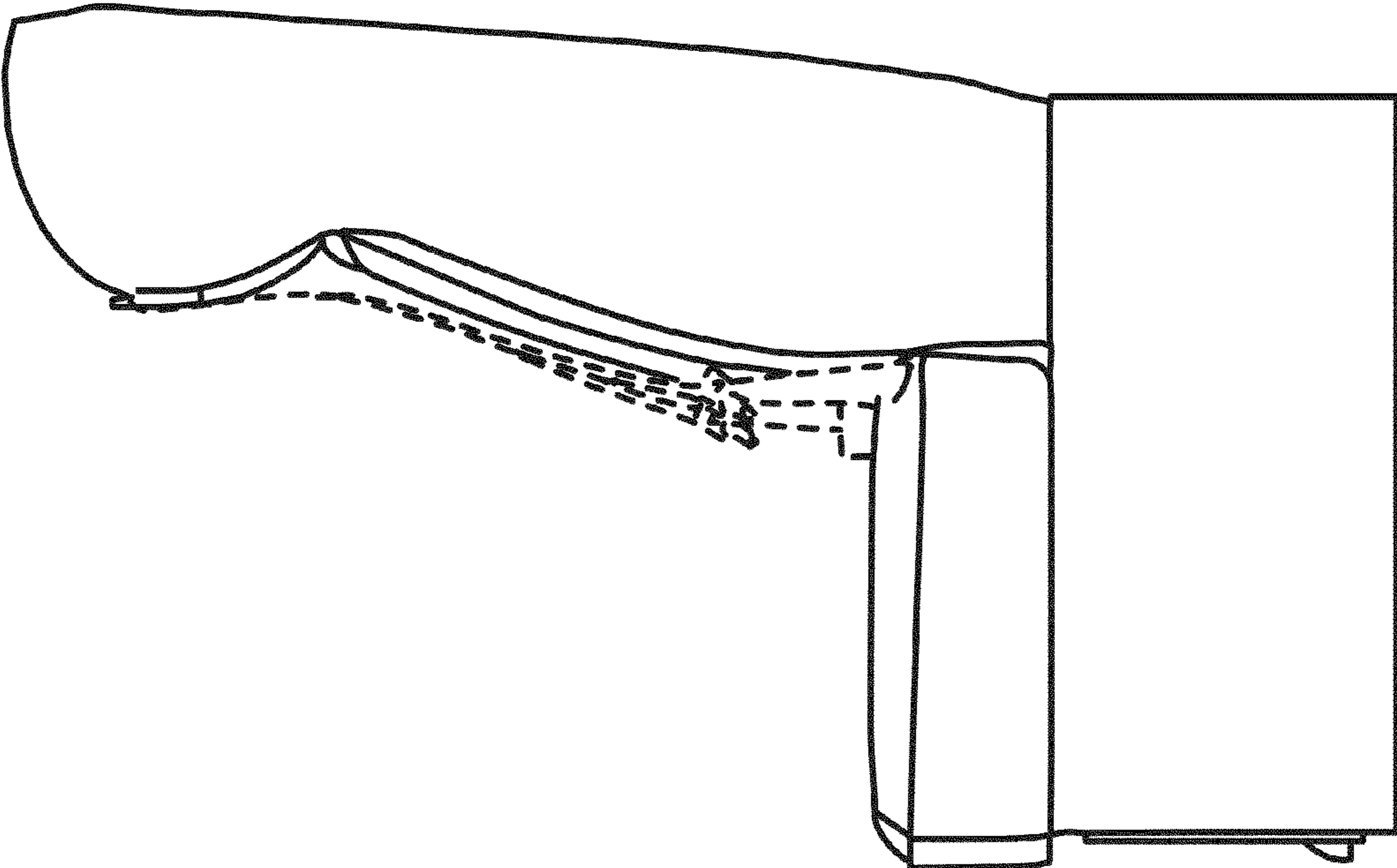

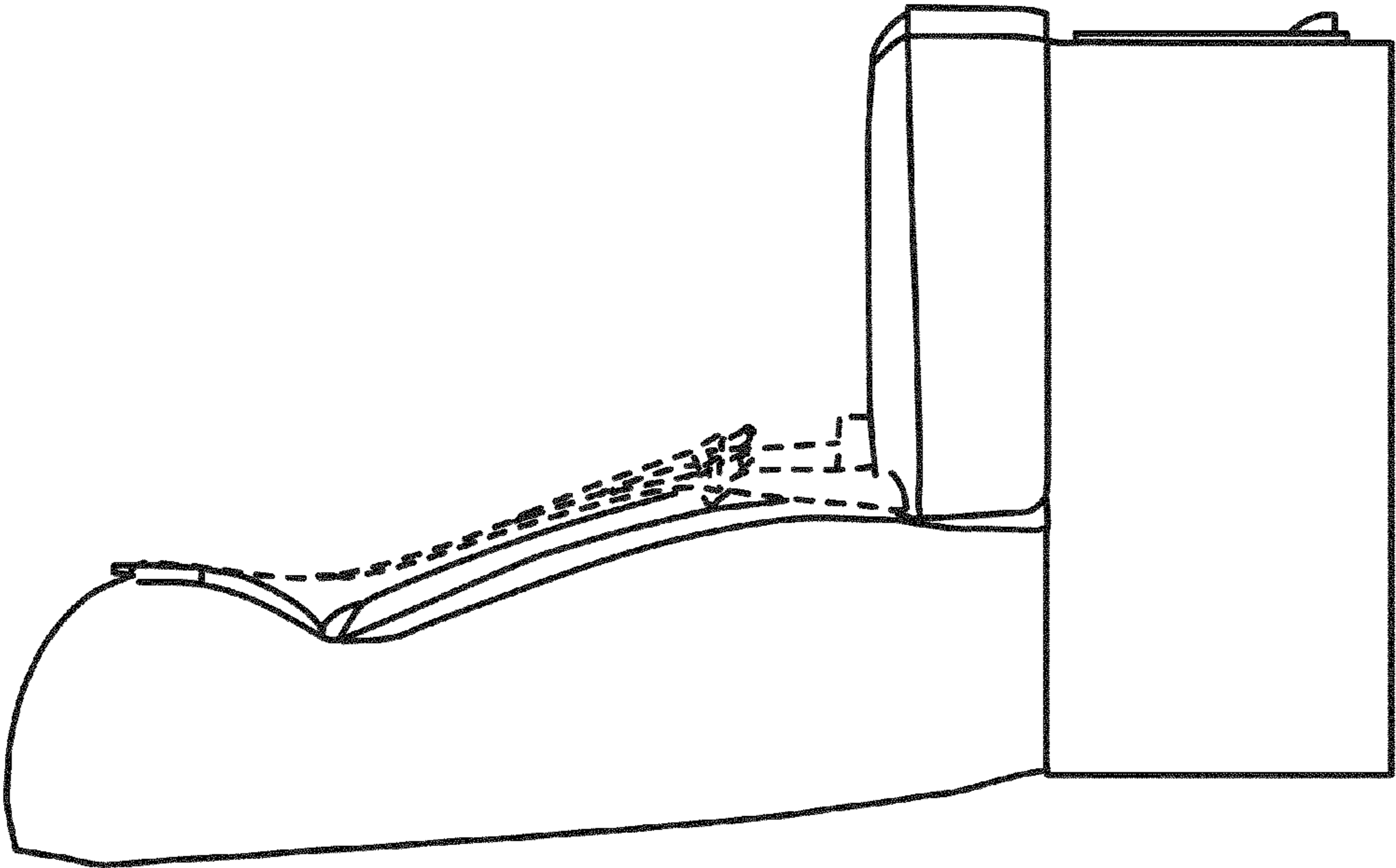

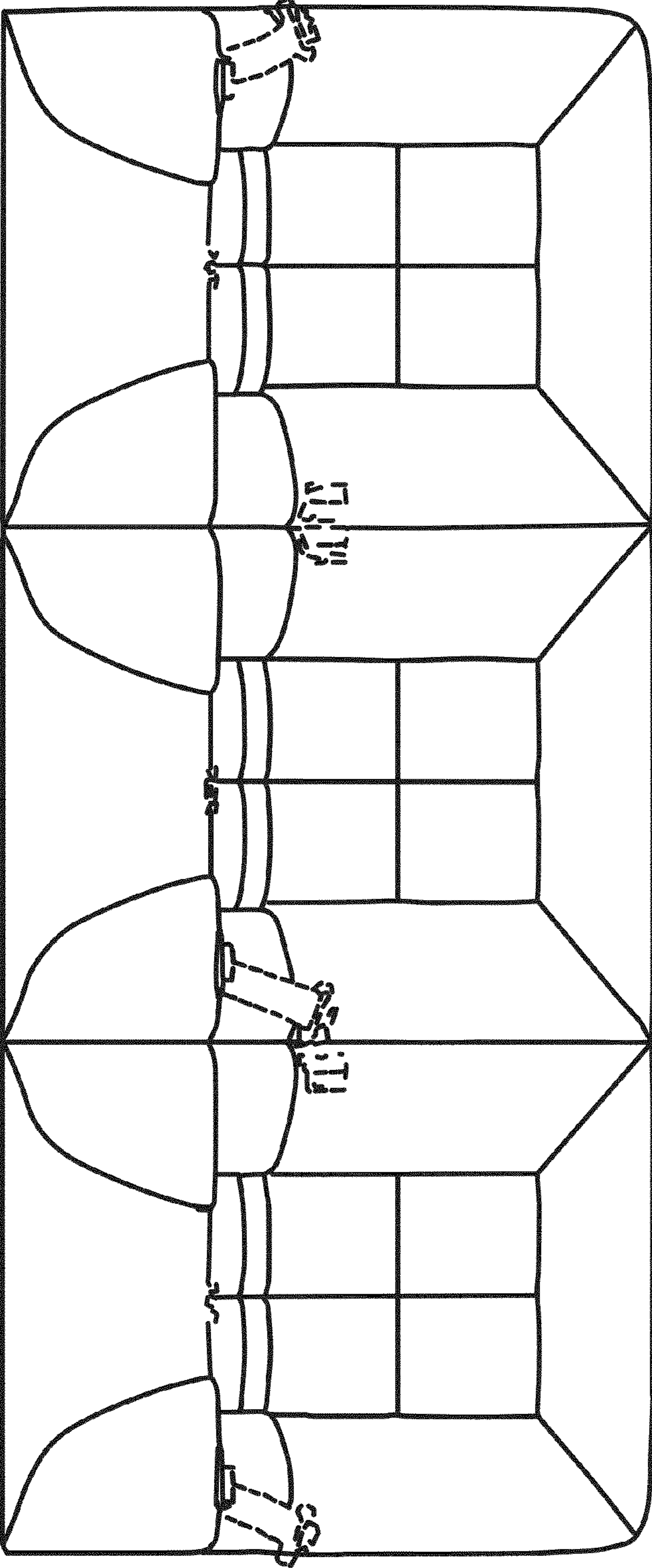

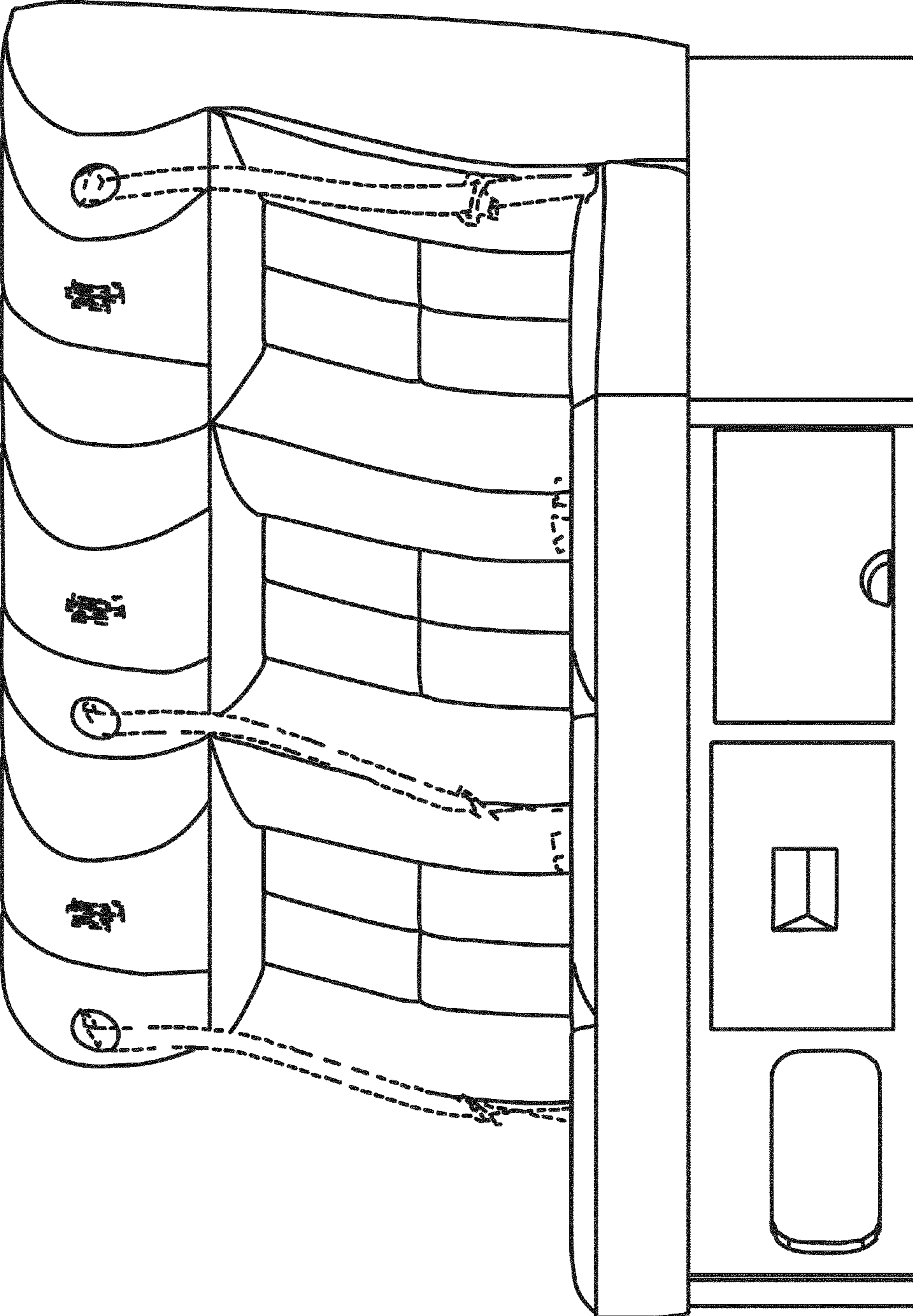
