DESCRIPTION

FIG. 1 is a perspective view of a furniture item of the present invention;

FIG. 2 is a perspective front view of the furniture item;

FIG. 3 is a perspective rear view of the furniture item;

FIG. 4 is a perspective right view of the furniture item;

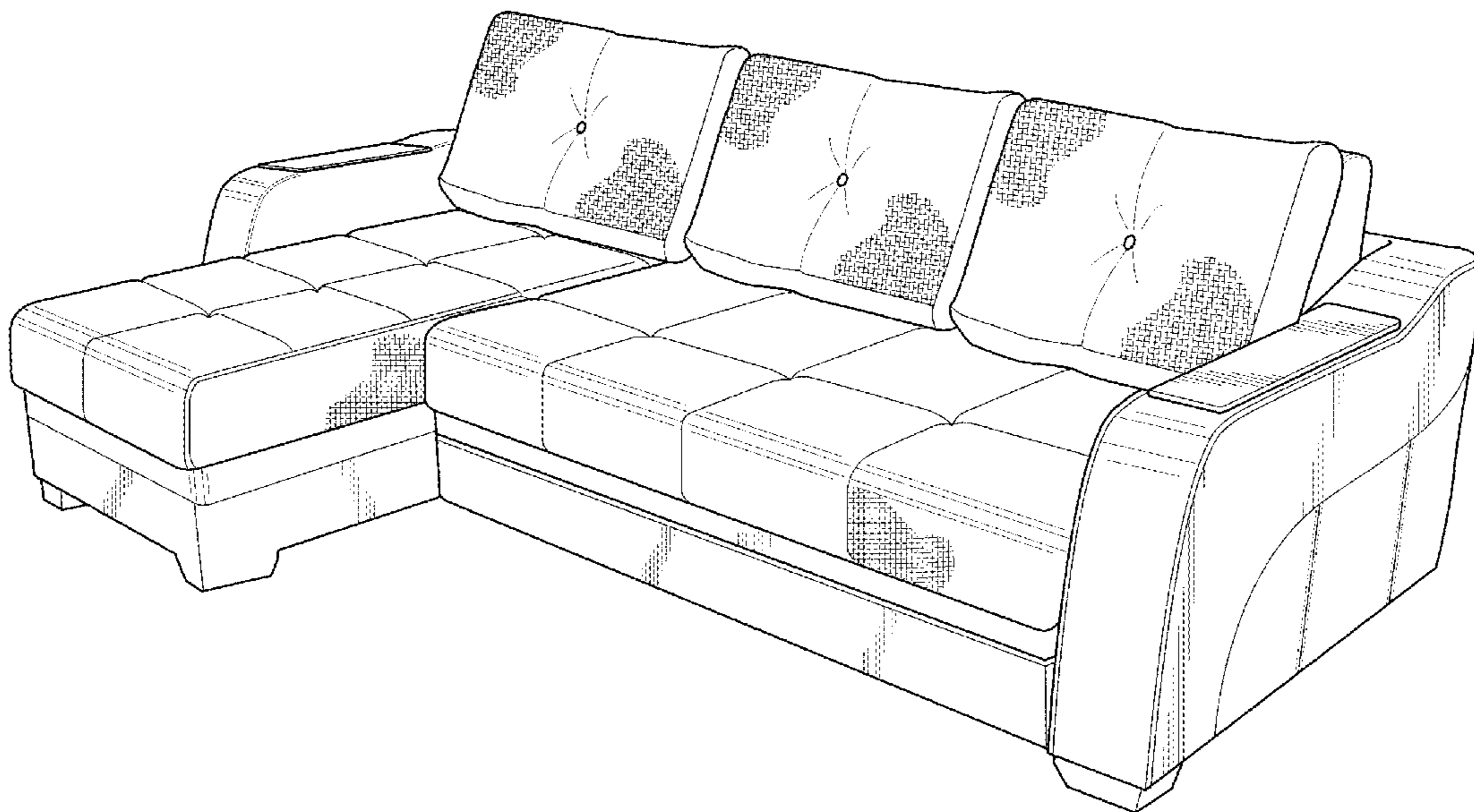
FIG. 5 is a perspective left side view of the furniture item;

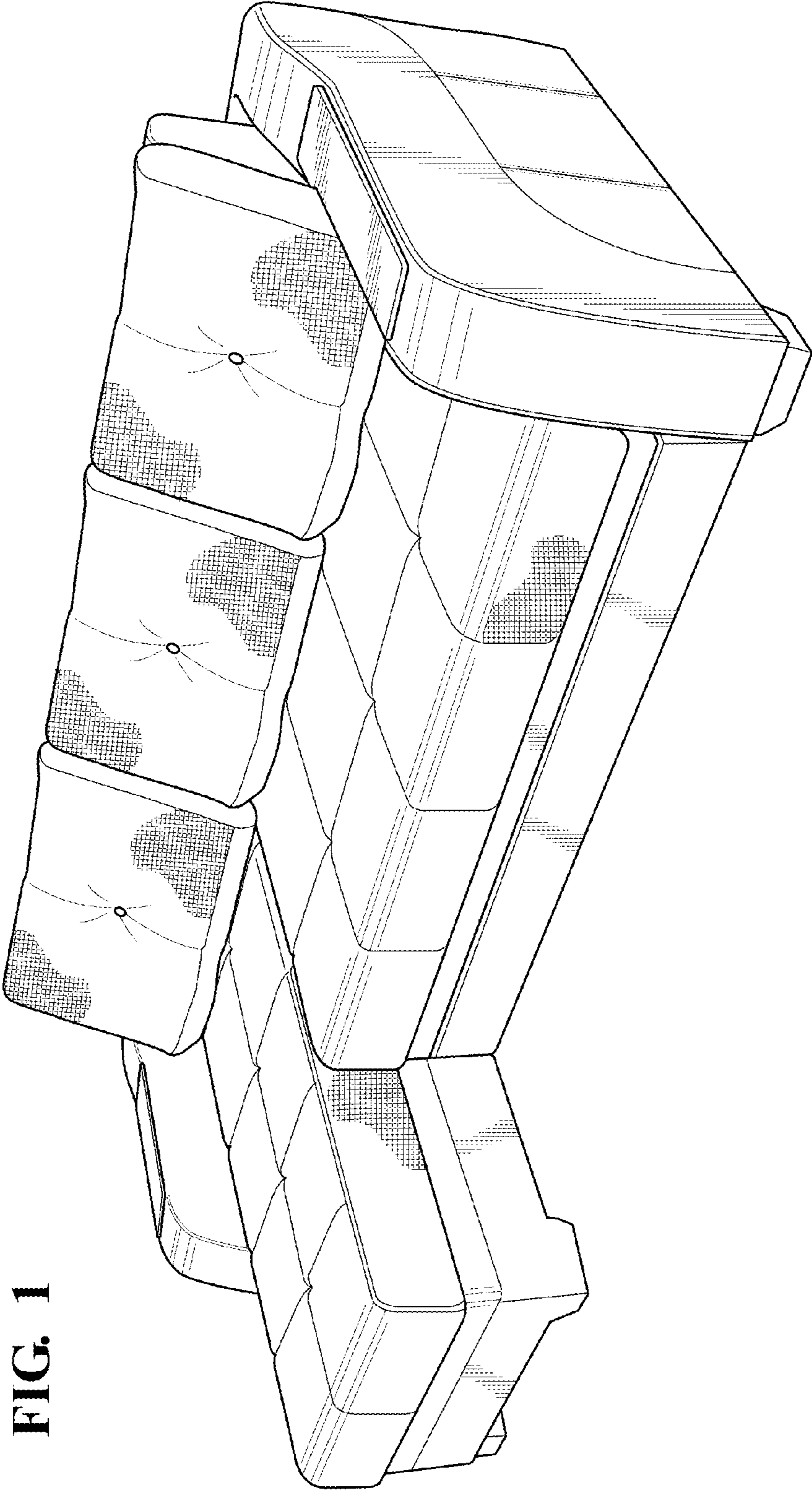

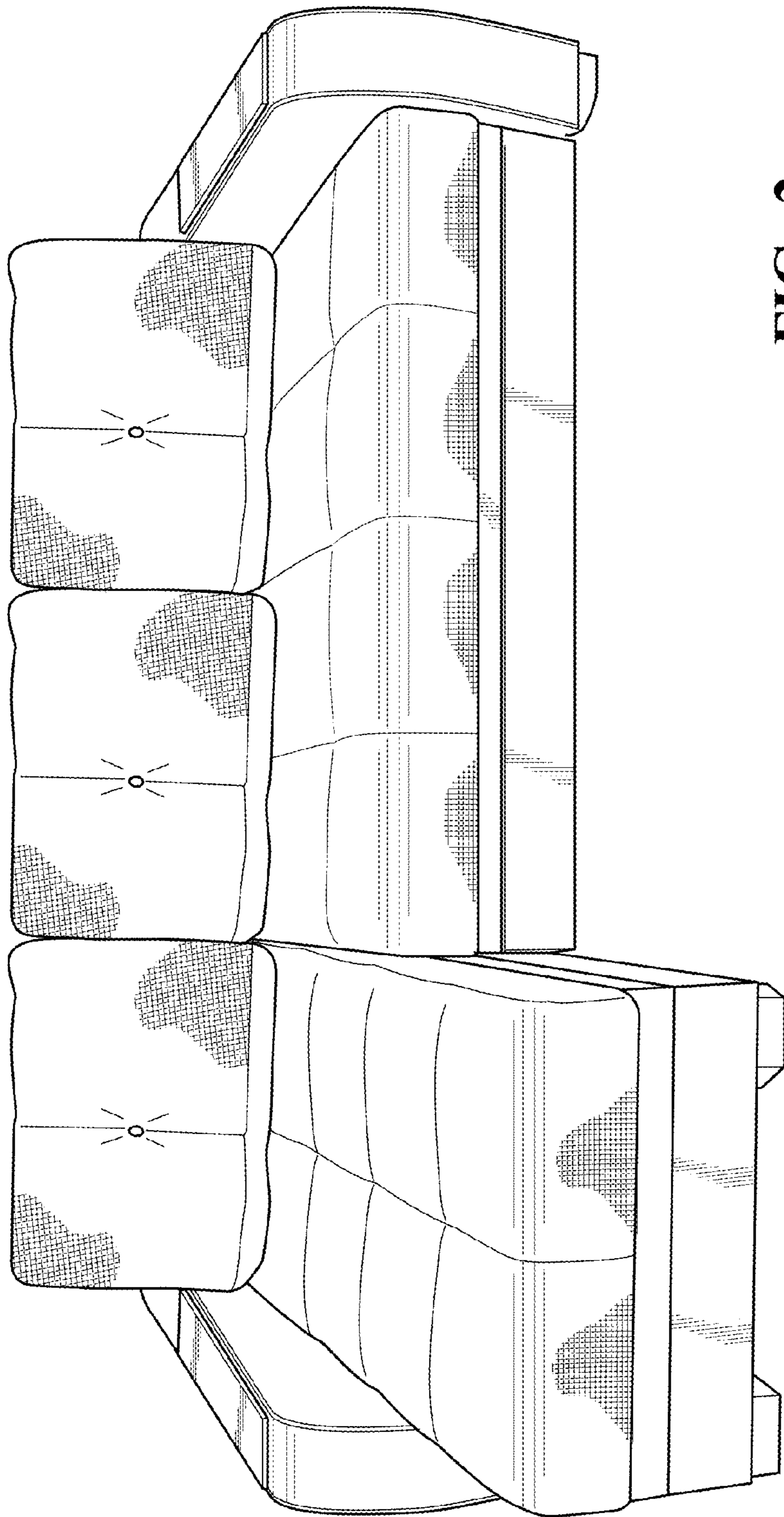

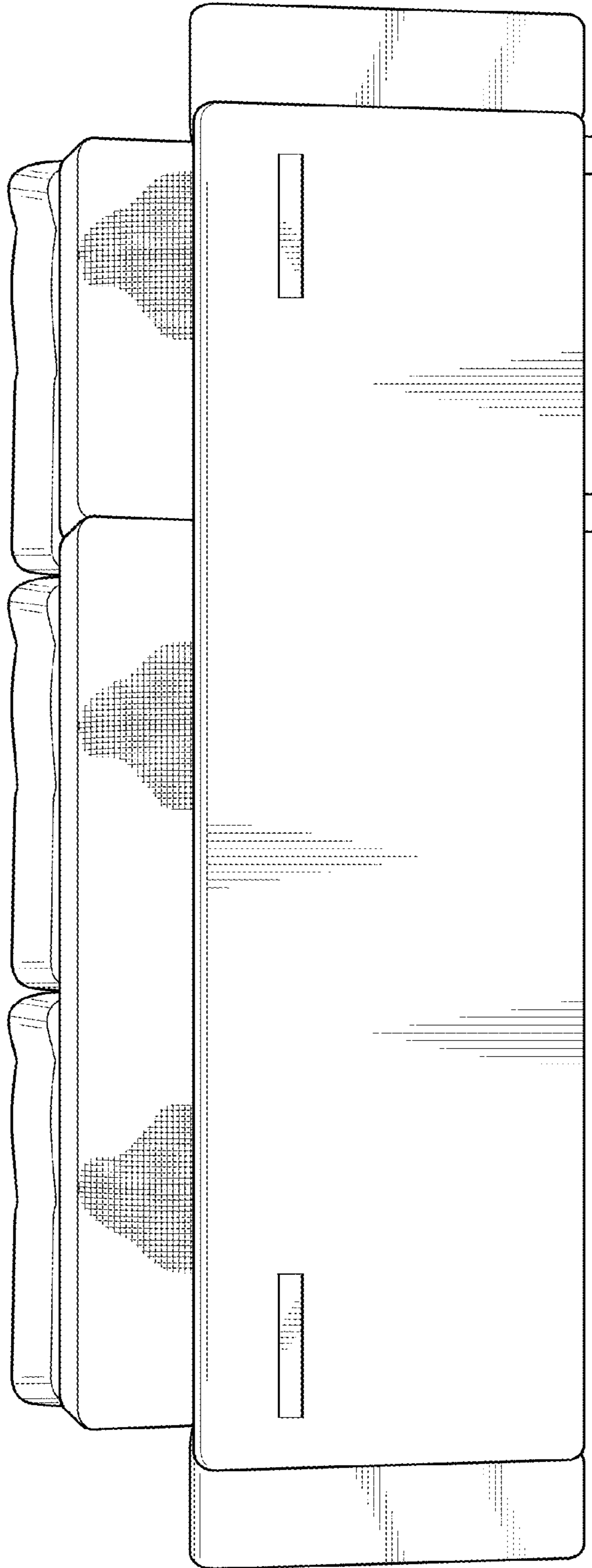

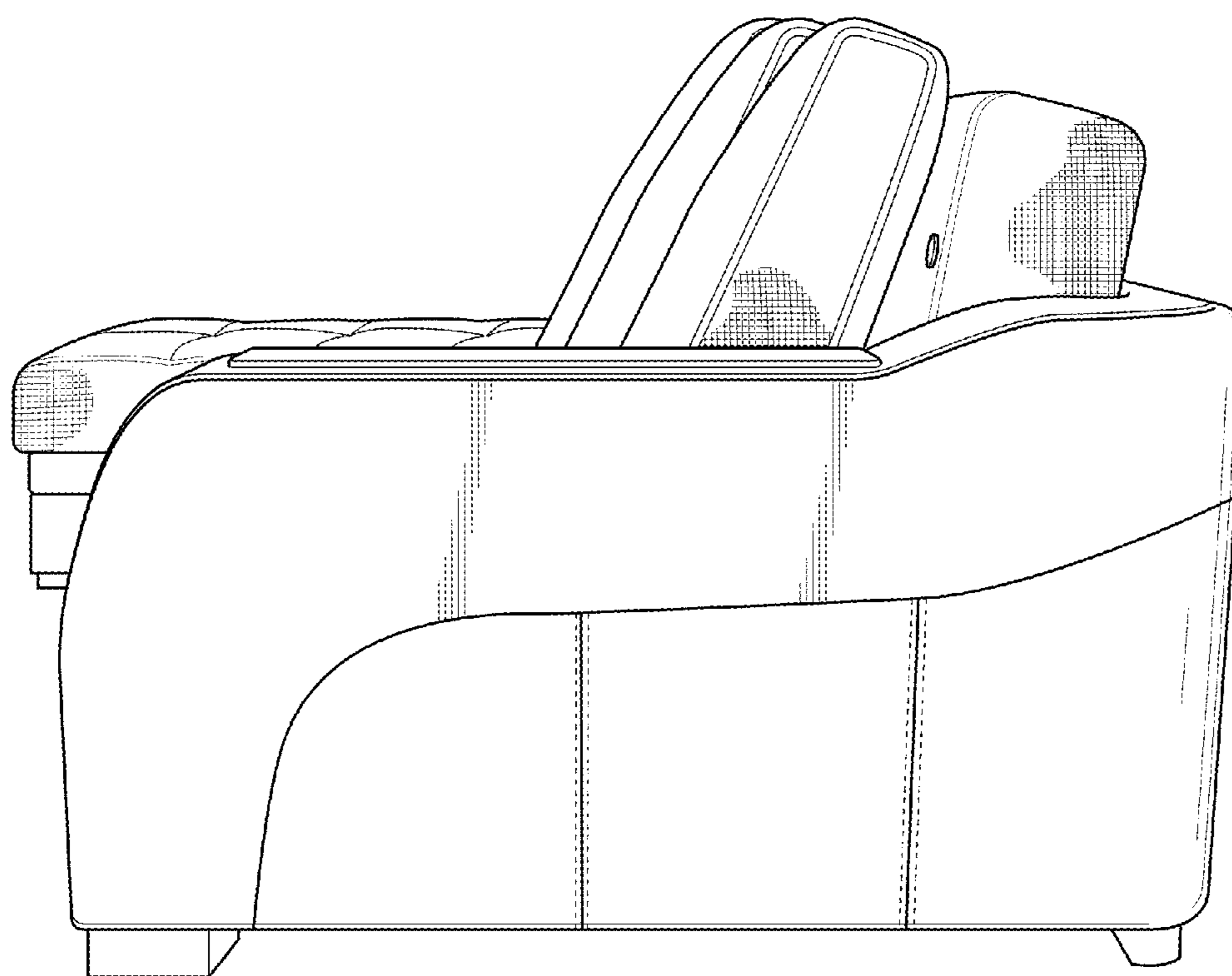
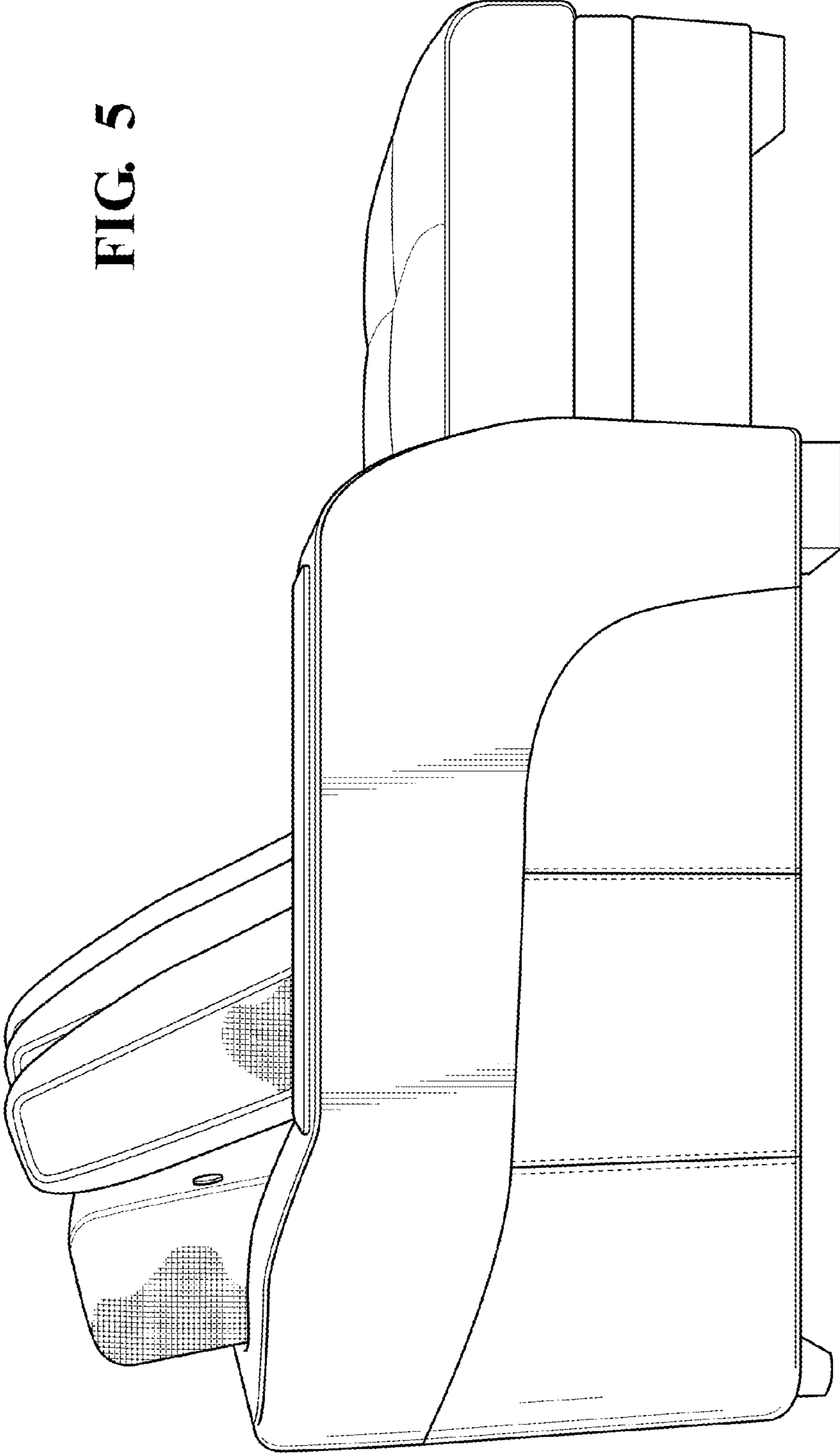

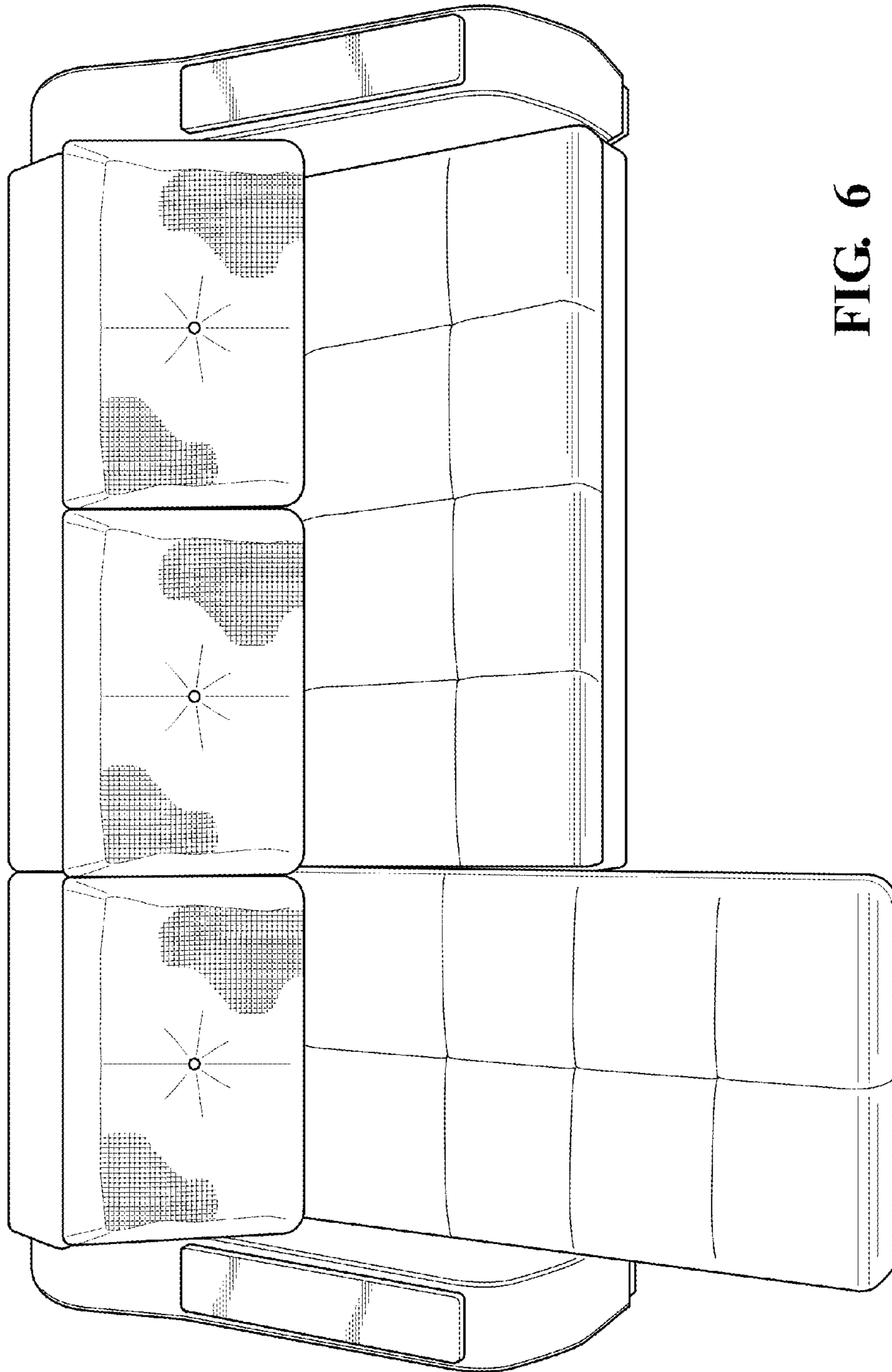
